### Food Price Inflation Getting Worse, Farming on Idle Land Disallowed Due to Climate Goals: USDA

Food price inflation is rising at an alarming rate, with the annual rate en route to becoming the highest in recent years, according to the U.S. Department of Agriculture (USDA).

The Consumer Price Index (CPI) for all food rose by 1 percent from February to March 2022. When compared to March 2021, food prices were higher by 8.8 percent in March 2022, data from the USDA shows. The agency predicts in 2022 all food CPI to rise by 5 to 6 percent, which is much higher than the 3.9 percent hike in 2021, 3.4 percent hike in 2020, and 1.9 percent hike in 2019. The 20-year historical average CPI stands at 2.4 percent.

Prices for restaurant purchases, designated as "food-away-from-home" in the CPI, increased 0.3 percent in March 2022, a 6.9 percent increase from March 2021, the USDA reported.

Prices for grocery store and supermarket food purchases, designated as "food-at-home" in the CPI, increased 1.5 percent from February to March 2022, and were 10 percent higher than in March 2021.

Food-at-home prices are expected to increase by 5 to 6 percent in 2022, with food-away-from-home rising by 5.5 to 6.5 percent. The 12-month prices of meat, poultry, and fish rose by 13.8 percent in March 2022; eggs rose by 11.2 percent; dairy products rose by 7 percent; fats and oils by 14.9 percent; fruits and vegetables



by 8.5 percent; sugar and sweets by 8 percent; cereals and bakery products by 9.4 percent; nonalcoholic beverages by 8 percent; and other foods by 10 percent.

The rise in food prices is due to multiple factors including a shortage of labor, an increase in trucking costs, the rise in the cost of fertilizers, and Russia's war in Ukraine. The war has disrupted the flow of food items from Ukrainian ports while also affecting the country's spring planting. Russia and Ukraine together make up about 20 percent of the world's corn sales and more than 25 percent of global wheat trade.

"Among the nearly 50 commodity-price series we study, wheat spot-price changes stand out as a bellwether for food price inflation," analysts at JPMorgan Chase said in a note, according to Bloomberg. "Given exceptionally tight labor markets and already-elevated inflationary pressure from

commodity prices prior to Russia's invasion of Ukraine, we suspect food inflation will remain firm in the months ahead," the analysts said.

In March, several agricultural groups—including the American Bakers Association, American Farm Bureau Federation, and Agricultural Retailers Association—wrote to the USDA, requesting that farming be allowed on idle land under the Conservation Reserve Program (CRP). About 26 percent of CRP acres are classified as prime farmland.

However, the USDA rejected the request, insisting that such a move would harm climate goals. "It is critical to point out that if we allow the tillage of CRP acres, the marginal at best benefit to crop production will be coupled with a significant and detrimental impact on producers' efforts to mitigate climate change and maintain the long-term health of their land," the agency said in its response.

## Political Shenanigans in Quartzsite

A very outspoken long-time resident of Quartzsite asked me to elaborate on the story that The Desert Messenger covered regarding the Disqualifications of town council candidates. So in my best Paul Harvey voice This is the Rest of the Story, more of it anyway at her request. We received a very well written letter to the editor that fills in many of the details not covered here. This letter is on the next page.

The candidates were all found ineligible to run on the basis of owing the town money. This town code was enacted because in 2008 Steve Bennett who owed the town in excess of \$170,000 in taxes ran for mayor as a write in, won and in no time his debt was eliminated and he resigned. There is speculation as to whether he paid the debt or if it just vanished... poof! Seems the town could easily prove if the funds were paid or not but none-the-less it makes sense to enact a code to ensure this never happens again, right? Well it is never that simple. Nothing ever is. As we have all seen lately, every right we give up - the government will take more, with more. This code leaves the door open for abuse of power by the sitting council members as we witnessed in the Town Council meeting recently. A sitting council member

who is up for election should NEVER be allowed to vote on the eligibility of a potential candidate. Talk about a conflict of interest!!! To not recuse oneself speaks volumes.

for Town Council. One of them created a letter to mail to the residents of Quartzsite as there were few opportunities (thank you Plandemic) for the citizens of Quartzsite to know anything

meet the requirements required to form a PAC. **Both** must be true:

- The entity is organized for the primary purpose of influencing the result of an election; and
- The entity knowingly receives contributions or makes expenditures (in any combination) in excess of the current threshold financial level. [\$1200]

The fine was \$100 but both Dennis and Sam declared they were not guilty of said crime, thus they would not pay the fine on principle alone, they would appeal! I completely respect that, far too many of us do not stand by or for our principles. The other two paid the fine and moved away from Quartzsite in disgust. Dennis went to fairly great lengths to try and appeal but was told that no such case existed in the court system, thus there was no ruling to appeal. So both men ignored the fine in great protest and pretty much forgot about the fine as did the town. The town never sent a follow up letter, a late fee, nothing was ever made of it until the guys tried to run for office again. Oh yeah, bring out the firing squad for these delinquents, especially that outspoken, mostly right but unrefined, Mike Roth! We can not have them, for they are unfit! What a bunch of... If you would like more information contact us and we will be happy to share with you all of the evidence that has been collected.

**§ 30.09 QUALIFICATION OF COUNCIL CANDIDATES**

(A) The Town Council shall judge the elections, qualifications and returns of its members pursuant to A.R.S. § 9-234. Such qualifications shall not include those contained within A.R.S. Title 16, but also any contained within this town code.

(B) The qualifications for eligibility of Mayor or Council candidates for election to these positions includes the requirement that no delinquent or fixed fines and penalties, user fees, permit fees and sales tax be owed to the town at the time of declaration of candidacy.

(C) Council members, candidates and appointees for town elected and appointed office shall be held to certain standards of conduct, which include compliance with all federal, state and local laws, rules and regulations (i.e., to include, but not exclusive of, state standards of conduct for public officials, conflict of interest, open meetings laws and the like).

(D) Failure to comply with this section shall result in ineligibility of the candidate or elected official seeking re-election to be qualified to run or be appointed to town office.

(E) Appointed officials to town offices of Manager, Attorney, Town Clerk and Magistrate shall be held to the same standards and shall not be qualified to hold appointed positions.

(Prior Code, § 2-1-10) (Ord. 09-15, passed -2009)

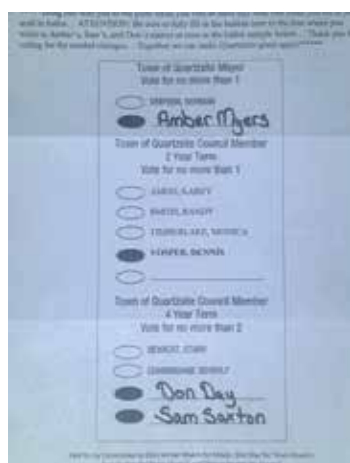
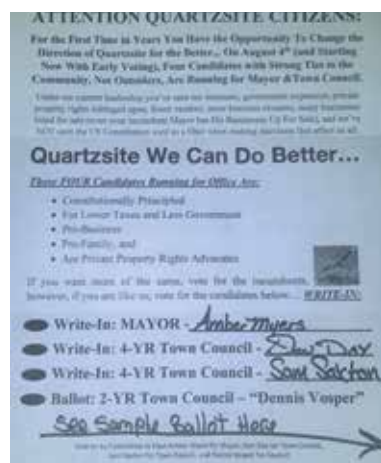
The judgments were incredibly petty on all three counts. First up was Mike Roth, found ineligible due to unpaid [potentially unfounded] fees for breaking a town code as well as a late water bill that he was unaware of. The bill was less than \$60 and less than two weeks late. Then it was Dennis Vosper's turn at the wheel of injustice. He was found ineligible for an unpaid [potentially unfounded] fine assessed by the Town Attorney and Town Manager upon investigation of allegedly forming a Political Action Committee (PAC) in the 2020 elections. Then Sam Saxton was on the firing line. He was found ineligible for the same reason Dennis Vosper was.

about them. That letter was shared with the others and each of them mailed the letter to constituents. ## An Open Letter to the Public

*Preface: As a concerned citizen, I am writing on this topic and am asking both local newspapers, the Desert Messenger and the Patriots Free Press to publish these remarks.*

On April 7, 2022 a Special Meeting of the Quartzsite Town Council was held to discuss qualifications of three candidates who filed to run for Town Council positions: Mike Roth, Sam Saxton and Dennis Vosper. Council members voted unanimously to disqualify all three candidates based on Town Code 30.09 Qualification of Town Council Candidates.

The Desert Messenger discussed this action in their April 20, 2022 issue, but there were some key points of

information that were missing in that report. I would like the citizens of Quartzsite to be aware of this additional information.

First and foremost, the bottom line is—and it is just common sense—that Town Council members should NOT be involved in this elimination process at all. Here you have several sitting Council members who are up for re-election and they are voting to disqualify their potential opponents in the coming election. No matter who the candidate is, this should not be taking place in our election process! I consider this action to be election interference and it should be stopped!

Additionally, if council members were held (according to the Code and our Town Attorney) to a responsibility to vote, then when it came to a vote, ethically they

should have recused themselves from voting stating a conflict of interest or they could have abstained from voting. You know, if it doesn't feel right, it probably isn't. To their credit, some council members did abstain from the vote because they were not comfortable with it.

More importantly, with just some basic internet research, I found that this process, using the same code mechanism, (then numbered 2-1-10) was also used in 2012 to oust a town leader from their duly elected position. The action was challenged in court and on October 15, 2012 LaPaz County Superior Court, Judge Michael



Burke, ruled that this action was “unlawful” and the individual was reinstated to their elected position. As part of Council discussion, it was explained by the Town Attorney that court ruling of “unlawful” was made as opposed to “unconstitutional” because at the Superior Court level items can only be ruled “unlawful”—anything deemed “unconstitutional” must be done at the Supreme Court level.

Regarding that case in 2012, the Parker Pioneer reported that, “Attorney, Julie LaBenz, who handled the case, argued in court that the town ordinance [code] was unconstitutional.” She also stated very aptly that with their action, Town Council was trying to turn democracy “upside down.”

After the disqualification of the three candidates on April 7th, fast forward to April 26, 2022 Regular

Meeting of the Town Council. Town Code 30.09 was on the agenda for review, discussion, and possible direction or action concerning an amendment or to repeal it in its entirety.

From citizen statements and questions during public comment, there was no response to the question of why the town attorney didn't acknowledge and disclose this “unlawful” ruling to the Council prior to their vote to disqualify on April 7. Actually, there are others who would have also been aware of this court ruling because those involved with the Desert Messenger wrote more than one article on the case and the court ruling. The Town Attorney also said that this particular case in 2012 was “different” because it involved an elected individual and these three individuals were candidates for election. Really?

I would like to know why we are still using this weapon? Why was this code pulled off the shelf, dusted off and used again against these candidates? We always hear about the shady dealings of earlier days here in Quartzsite. I thought perhaps we were getting better, but sadly it seems like we are going back to those dark days. It's disappointing.

During the meeting of April 26, Council Members got in the weeds with their discussion and wanted to travel down a rabbit hole of discussing details of how they might amend the code rather than fully repealing the code. The bottom line is still the same...this never should have happened in the first place. The Code was ruled as an unlawful action; it should never have been acted on at the April 7 meeting; and most definitely should now be REPEALED!

Again, no matter who the individuals are who are being

After weeks of failed advocacy on behalf of an Arizona Veteran

who has been denied his right of visits with family and friends by his court-appointed guardian/conservator, Real Change PAC announces its intent to file an amicus curiae brief with the La Paz County Superior Court that holds ultimate responsibility for the appointments made on behalf of adult citizens with rights.

Following up on a complaint to Real Change PAC that an Arizona veteran's property was being "sold out from underneath him," the situation was revealed to be a veteran adjudicated into a guardian conservatorship by La Paz County Superior Court. At issue is the denial of the veteran's placement right for private visits with friends and family, a denial made by La Paz County Fiduciary Vivian Hartless under the "not in his best interest" authority as the veteran's court-appointed guardian-conservator.

"This veteran with dementia was adjudicated into guardianship-conservatorship against his will, was placed into a Lake Havasu City long-term care facility against his will, and has had his property sold to pay for his care also against his will," said Morgaine, Real Change PAC Executive Director.

"Dementia and its behavioral symptoms do not negate this veteran's right to private visits with family and friends. In addition,



Rights violation complaints have been filed with the Arizona Ombudsman Office, Arizona State Attorney General's Office, Arizona Governor's Office, Congressman Paul Gosar, ACLU of Arizona, and La Paz County. Real Change PAC is aware of this non-traditional amicus curiae application, and is reaching out to other veterans advocacy organizations to join.

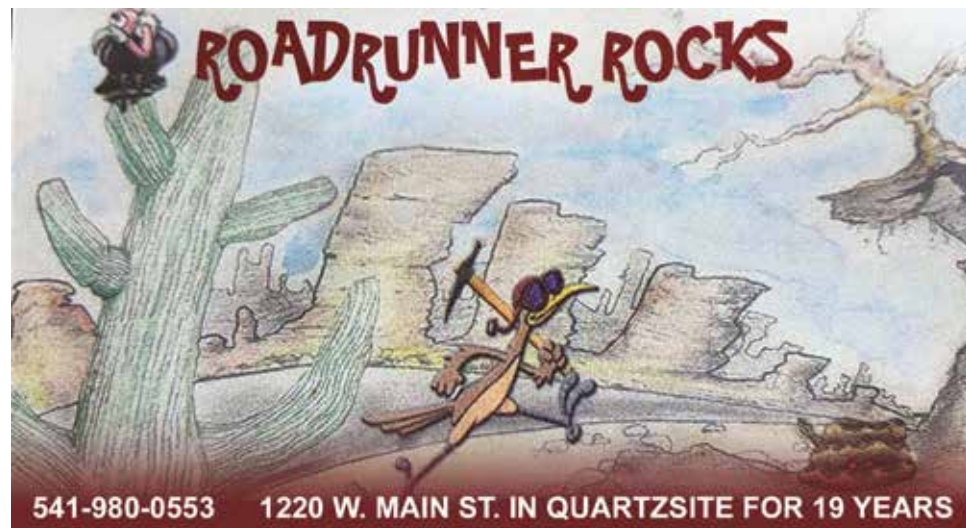
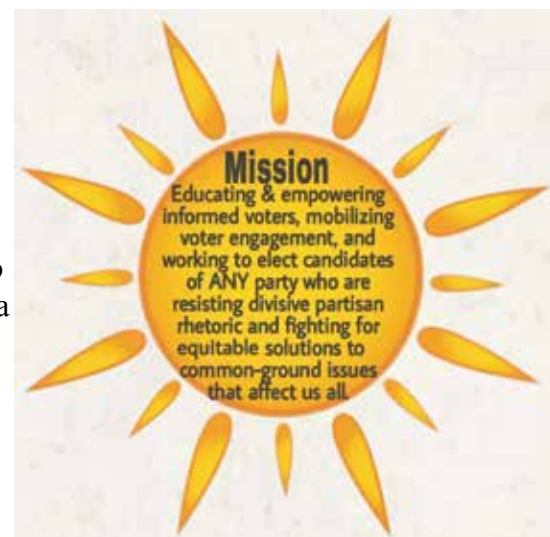

the veteran has no family, so this denial of his right to visit with his long-time friend leaves this veteran scared, confused, and isolated from his social network until he dies in the care facility, alone."

According to the Office of Long-term Care Placement Rights, a personal representative can exercise rights on behalf of a ward when they cannot exercise them on their own. The veteran in question has dementia, but he knows who his friends are, and communicated his request to visit with his friend directly to his attorney ad litem, Andraya Whitney, who has also failed to advocate for her client's right to be respected.

Real Change PAC has no direct authority in this case.

## The Law That Never Was: The Fraud of Income & Social Security Tax

### The Premise

The federal government rests its authority to collect income tax on the 16th Amendment to the U.S. Constitution—the federal income tax amendment—which was allegedly ratified in 1913.

“The Congress shall have power to lay and collect taxes on incomes, from whatever source derived, without apportionment among the several States, and without regard to any census or enumeration.”

### —The 16th Amendment to the Constitution of the United States of America

After an extensive year-long nationwide research project, William J. Benson discovered that the 16th Amendment was not ratified by the requisite three-fourths of the states and that nevertheless Secretary of State Philander Knox had fraudulently declared ratification.

It was a shocking revelation; it reached deep to the core of our American system of governance.

### The Discovery

Article V of the U.S. Constitution defines the ratification process and requires three-fourths of the states to ratify any amendment proposed by Congress. There were forty-eight states in the American Union in 1913, meaning that affirmative

action of thirty-six was necessary for ratification. In February 1913, Secretary of State Philander Knox proclaimed that thirty-eight had ratified the Amendment.

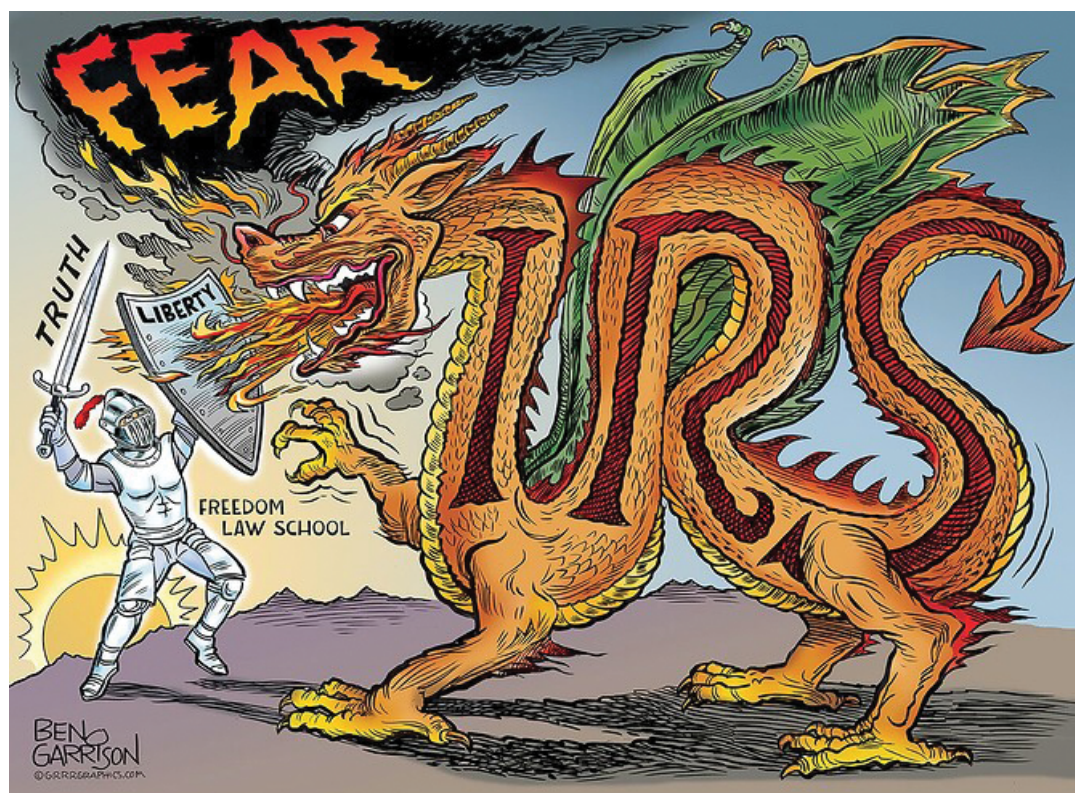

Bill would like to thank all those who've contributed or shown support in the fight against fraudulent taxation. When his project was finished at the end of 1984, Bill had visited the capital of every state from 1913 and knew that not a single one had actually and legally ratified the proposal to amend the U.S. Constitution. Thirty-three states engaged in the unauthorized activity of altering the language of an amendment proposed by Congress, a power that the states do not possess.

Since thirty-six states were needed for ratification, the failure of thirteen to ratify was fatal to the Amendment. This occurs within the major (first three) defects tabulated in Defects in Ratification of the 16th Amendment. Even if we were to ignore defects of spelling, capitalization and punctuation, we would still have only two states which successfully ratified.



In 1984 Bill Benson began a research project, never before performed, to investigate the process of ratification of the 16th Amendment. After traveling to the capitals of the New England states and reviewing the journals of the state legislative bodies, he saw that many states had not ratified. He continued his research at the National Archives in Washington, D.C.; it was here that Bill found his Golden Key.

This damning piece of evidence is

These four states are among the thirty-eight from which Philander Knox claimed ratification:

**California:** The legislature never recorded any vote on any proposal to adopt the amendment proposed by Congress.

## Using War to Assault Freedom

Most judges and lawyers agree that the war on drugs in the past 50 years has seriously diminished the right to privacy guaranteed by the Fourth Amendment.

Now a small group of legal academics is arguing that the war in Ukraine should be used to diminish property rights guaranteed by the Fifth Amendment.

### Here is the backstory.

The Fourth Amendment was written to guarantee that the government may only search and seize persons, houses, papers and effects pursuant to a search warrant issued by a judge after the presentation under oath of evidence demonstrating that the place to be searched more likely than not contains evidence of crime. And the warrant itself must specifically describe the place to be searched and the person or thing to be seized.

These requirements — the work of James Madison, who was the scrivener of the Constitution in 1787 and the author of the Bill of Rights in 1791 — were intended to have two effects.

The first effect was to uphold the quintessentially American right to be left alone. The second was to compel the government to focus its law enforcement personnel and assets on crimes for which there is probable cause, not fishing expeditions or hunches.

Madison's language prohibited absolutely the use of general warrants, a favorite tool of the British government against the colonists. General warrants were based on whatever the government wanted or claimed it needed.

The colonists were tormented by, and driven to revolution over, general warrants, as they authorized British agents to search wherever they wished and seize whatever they found. Surely, the dreadful colonial experience with general warrants was a driving force behind the wording and ratification of the Fourth Amendment.

Sadly, during the war on drugs, prosecutors and police persuaded

judges to craft "emergency" exceptions to the Fourth Amendment. These included allowing police to look for whatever they wanted in cars and homes, and using the CIA for warrantless surveillance, lest the drugs supposedly being sought be destroyed before capture.

The effect of this was to destroy a fundamental liberty in deference to easing police work; that's the definition of a police state. The courts effectively ruled that somehow the Constitution prefers liberty — rather than evidence of crimes — to be destroyed.

The Fifth Amendment protects the life, liberty and property of all persons from destruction or aggression by the government without due process of law. Due process requires a jury trial at which the government must prove fault.

Thus, property cannot be seized temporarily or taken permanently without either a search warrant or a jury trial.

### Now back to the war in Ukraine.

I have argued in this column and elsewhere that the Biden administration sanctions imposed on Russian and American persons and businesses are profoundly unconstitutional because they are imposed by executive fiat rather than by legislation and because the sanctions constitute either the seizure of property without a warrant or the taking of property without due process.

When the feds seize a yacht from a person whom they claim may have financed Russian President Vladimir Putin's rise to power, they are doing so in direct violation of the Due Process Clause of the Fifth Amendment.

Similarly, when they freeze Russian assets in American banks, they engage in a seizure, and seizures can only constitutionally be done with a search warrant based on probable cause of crime.

As well, when the feds interfere with contract rights by prohibiting compliance with lawful contracts, that, too, implicates due process and can only be done constitutionally after a jury verdict in the government's favor, at a trial at which the feds have proved fault.

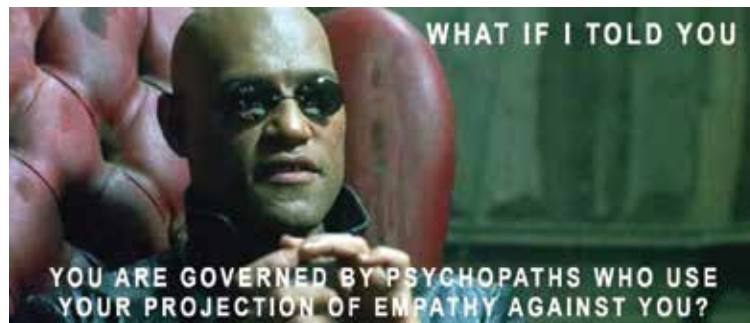
As if to anticipate these constitutional roadblocks to its interference with free commercial

choices, Congress enacted the International Emergency Economic Powers Act of 1977 and the Magnitsky Act of 2016. These constitutional monstrosities purport to give the president the power to declare persons and entities to be violators of human rights and, by that mere executive declaration alone, to punish them without trial.

These laws turn the Fourth and Fifth Amendments on their heads by punishing first and engaging in a perverse variant of due process later. How perverse? These laws require that if you want your seized property back, you must prove that you are not a human rights violator.

As if to run even further away from constitutional norms, a group of legal academics began arguing last week that the property seized from Russians is not really owned by human beings, but by the Russian government. And, this crazy argument goes, since the Russian government is not a person, there is no warrant or due process requirement; therefore, the feds can convert the assets they have seized and frozen to their own use.

To these academics — who reject property ownership as a moral right and exalt government aggression as a moral good — the argument



devolves around the meaning of the word "person." The Fourth and Fifth Amendments protect every "person" and all "people," not just Americans.

And in American jurisprudence, "person" means both human beings and artificial persons — corporations and governments capable of owning property. Property ownership is defined by the right to use, alienate and exclude. Only persons can exercise those rights.

Madison and his colleagues clearly sought to protect property rights from government aggression, no matter the legal status of the owner. We know this from the judicial opinions involving foreign property that preceded and followed the ratification of the Fifth Amendment. If this were not so, then nothing could prevent the feds from seizing and converting the property of states or local governments or international religious institutions to federal use.

War is the health of the state and the graveyard of liberty. The drug war was a disaster for freedom. The war in Ukraine will be so as well, only if we permit it.

## President of Russia Vladimir Putin:

*Citizens of Russia, friends,*  
I consider it necessary today to speak again about the tragic events in Donbass and the key aspects of ensuring the security of Russia.

I will begin with what I said in my address on February 21, 2022. I spoke about our biggest concerns and worries, and about the fundamental threats which irresponsible Western politicians created for Russia consistently, rudely and unceremoniously from year to year. I am referring to the eastward expansion of NATO, which is moving its military infrastructure ever closer to the Russian border.

It is a fact that over the past 30 years we have been patiently trying to come to an agreement with the leading NATO countries regarding the principles of equal and indivisible security in Europe. In response to our proposals, we invariably faced either cynical deception and lies or attempts at pressure and blackmail, while the North Atlantic alliance continued to expand despite our protests and concerns. Its military machine is moving and, as I said, is approaching our very border.

Why is this happening? Where did this insolent manner of talking down from the height of their exceptionalism, infallibility and all-permissiveness come from? What is the explanation for this contemptuous and disdainful attitude to our interests and absolutely legitimate demands?

The answer is simple. Everything is clear and obvious. In the late 1980s, the Soviet Union grew weaker and subsequently broke apart. That experience should serve as a good lesson for us, because it has shown us that the paralysis of power and will is the first step towards complete degradation and oblivion. We lost confidence for only one moment, but it was enough to disrupt the balance of forces in the world.

As a result, the old treaties and agreements are no longer effective. Entreaties and requests do not help. Anything that does not suit the dominant state, the powers that be, is denounced as archaic, obsolete and useless. At the same time, everything it regards as useful is presented as

the ultimate truth and forced on others regardless of the cost, abusively and by any means available. Those who refuse to comply are subjected to strong-arm tactics.



What I am saying now does not concern only Russia, and Russia is not the only country that is worried about this. This has to do with the entire system of international relations, and sometimes even US allies. The collapse of the Soviet Union led to a redivision of the world, and the norms of international law that developed by that time – and the most important of them, the fundamental norms that were adopted following WWII and largely formalized its outcome – came in the way of those who declared themselves the winners of the Cold War.

Of course, practice, international relations and the rules regulating them had to take into account the changes that took place in the world and in the balance of forces. However, this should have been done professionally, smoothly, patiently, and with due regard and respect for the interests of all states and one's own responsibility. Instead, we saw a state of euphoria created by the feeling of absolute superiority, a kind of modern absolutism, coupled with the low cultural standards and arrogance of those who formulated and pushed through decisions that suited only themselves. The situation took a different turn.

There are many examples of this. First a bloody military operation was waged

against Belgrade, without the UN Security Council's sanction but with combat aircraft and missiles used in the heart of Europe. The bombing of peaceful cities and vital infrastructure went on for several weeks. I have to recall these facts, because some Western colleagues prefer to forget them, and when we mentioned the event, they prefer to avoid speaking about international law, instead emphasizing the circumstances which they interpret as they think necessary.

Then came the turn of Iraq, Libya and Syria. The illegal use of military power against Libya and the distortion of all the UN Security Council decisions on Libya ruined the state, created a huge seat of international terrorism, and pushed the country towards a humanitarian catastrophe, into the vortex of a civil war, which has continued there for years. The tragedy, which was created for hundreds of thousands and even millions of people not only in Libya but in the whole region, has led to a large-scale exodus from the Middle East and North Africa to Europe.

A similar fate was also prepared for Syria. The combat operations conducted by the Western coalition in that country without the Syrian government's approval or UN Security Council's sanction can only be defined as aggression and intervention.

But the example that stands apart from the above events is, of course, the invasion of Iraq without any legal grounds. They used the pretext of allegedly reliable information available in the United States about the presence of weapons of mass destruction in Iraq. To prove that allegation, the US Secretary of State held up a vial with white powder, publicly, for the whole world to see, assuring the international community that it was a chemical warfare agent created in Iraq. It later turned out that all of that was a fake and a sham, and that Iraq did not have any chemical weapons. Incredible and shocking but true. We witnessed lies

made at the highest state level and voiced from the high UN rostrum. As a result we see a tremendous loss in human life, damage, destruction, and a colossal upsurge of terrorism.

Overall, it appears that nearly everywhere, in many regions of the world where the United States brought its law and order, this created bloody, non-healing wounds and the curse of international terrorism and extremism. I have only mentioned the most glaring but far from only examples of disregard for international law.

This array includes promises not to expand NATO eastwards even by an inch. To reiterate: they have deceived us, or, to put it simply, they have played us. Sure, one often hears that politics is a dirty business. It could be, but it shouldn't be as dirty as it is now, not to such an extent. This type of con-artist behavior is contrary not only to the principles of international relations but also and above all to the generally accepted norms of morality and ethics. Where is justice and truth here? Just lies and hypocrisy all around.

Incidentally, US politicians, political scientists and journalists write and say that a veritable "empire of lies" has been created inside the United States in recent years. It is hard to disagree with this – it is really so. But one should not be modest about it: the United States is still a great country and a system-forming power. All its satellites not

only humbly and obediently say yes to and parrot it at the slightest pretext but also imitate its behaviour and enthusiastically accept the rules it is offering them. Therefore, one can say with good reason and confidence that the whole so-called Western bloc formed by the United States in its own image and likeness is, in its entirety, the very same "empire of lies."

As for our country, after the disintegration of the USSR, given the entire unprecedented openness of the new, modern Russia, its readiness to work honestly with the United States and other Western partners, and its practically unilateral disarmament, they immediately tried to put the final squeeze on us, finish us off, and utterly destroy us. This is how it was in the 1990s and the early 2000s, when the

so-called collective West was actively supporting separatism and gangs of mercenaries in southern Russia. What victims, what losses we had to sustain and what trials we had to go through at that time before we broke the back of international terrorism in the Caucasus! We remember this and will never forget.

Properly speaking, the attempts to use us in their own interests never ceased until quite recently: they sought to destroy our traditional values and force on us their false values that would erode us, our people from within, the attitudes they have been aggressively imposing on their countries, attitudes that are directly leading to degradation and degeneration, because they are contrary to human nature. This is not going to happen. No one has ever succeeded in doing this, nor will they succeed now.

Despite all that, in December 2021, we made yet another attempt to reach agreement with the United States and its allies on the principles of European security and NATO's non-expansion. Our efforts were in vain. The United States has not changed its position. It does not believe it necessary to agree with Russia on a matter that is critical for us. The United States is pursuing its own objectives, while neglecting our interests.

Of course, this situation begs a question: what next, what are we to expect? If history is any guide, we know that in 1940 and early 1941 the Soviet Union went to great lengths to prevent war or at least delay its outbreak. To this end, the USSR sought not to provoke the potential aggressor until the very end by refraining or postponing the most urgent and obvious preparations it had to make to defend itself from an imminent attack. When it finally acted, it was too late.

As a result, the country was not prepared to counter the invasion by Nazi Germany, which attacked our Motherland on June 22, 1941, without declaring war. The country stopped the enemy and went on to defeat it, but this came at a tremendous cost. The attempt to appease the aggressor ahead of the Great Patriotic War proved to be a mistake which came at a high cost for our people. In the first months after the hostilities broke out, we lost vast territories of strategic importance, as well as millions of lives. We will not make this mistake the second time. We

have no right to do so.

Those who aspire to global dominance have publicly designated Russia as their enemy. They did so with impunity. Make no mistake, they had no reason to act this way. It is true that they have considerable financial, scientific, technological, and military capabilities. We are aware of this and have an objective view of the economic threats we have been hearing, just as our ability to counter this brash and never-ending blackmail. Let me reiterate that we have no illusions in this regard and are



extremely realistic in our assessments.

As for military affairs, even after the dissolution of the USSR and losing a considerable part of its capabilities, today's Russia remains one of the most powerful nuclear states. Moreover, it has a certain advantage in several cutting-edge weapons. In this context, there should be no doubt for anyone that any potential aggressor will face defeat and ominous consequences should it directly attack our country.

At the same time, technology, including in the defense sector, is changing rapidly. One day there is one leader, and tomorrow another, but a military presence in territories bordering on Russia, if we permit it to go ahead, will stay for decades to come or maybe forever, creating an ever mounting and totally unacceptable threat for Russia.

Even now, with NATO's eastward expansion the situation for Russia has been becoming worse and more dangerous by the year. Moreover, these past days NATO leadership has been

blunt in its statements that they need to accelerate and step up efforts to bring the alliance's infrastructure closer to Russia's borders. In other words, they have been toughening their position. We cannot stay idle and passively observe these developments. This would be an absolutely irresponsible thing to do for us.

Any further expansion of the North Atlantic alliance's infrastructure or the ongoing efforts to gain a military foothold of the Ukrainian territory are unacceptable for us. Of course, the

procedures and have abandoned the path of a peaceful conflict settlement. For eight years, for eight endless years we have been doing everything possible to settle the situation by peaceful political means. Everything was in vain.

As I said in my previous address, you cannot look without compassion at what is happening there. It became impossible to tolerate it. We had to stop that atrocity, that genocide of the millions of people who live there and who pinned their hopes on Russia, on all of us. It is their aspirations, the feelings and pain of these people that were the main motivating force behind our decision to recognise the independence of the Donbass people's republics.

I would like to additionally emphasize the following. Focused on their own goals, the leading NATO countries are supporting the far-right nationalists and neo-Nazis in Ukraine, those who will never forgive the people of Crimea and Sevastopol for freely making a choice to reunite with Russia.

They will undoubtedly try to bring war to Crimea just as they have done in Donbass, to kill innocent people just as members of the punitive units of Ukrainian nationalists and Hitler's accomplices did during the Great Patriotic War. They have also openly laid claim to several other Russian regions.

question is not about NATO itself. It merely serves as a tool of US foreign policy. The problem is that in territories adjacent to Russia, which I have to note is our historical land, a hostile "anti-Russia" is taking shape. Fully controlled from the outside, it is doing everything to attract NATO armed forces and obtain cutting-edge weapons.

For the United States and its allies, it is a policy of containing Russia, with obvious geopolitical dividends. For our country, it is a matter of life and death, a matter of our historical future as a nation. This is not an exaggeration; this is a fact. It is not only a very real threat to our interests but to the very existence of our state and to its sovereignty. It is the red line which we have spoken about on numerous occasions. They have crossed it.

This brings me to the situation in Donbass. We can see that the forces that staged the coup in Ukraine in 2014 have seized power, are keeping it with the help of ornamental election

If we look at the sequence of events and the incoming reports, the showdown between Russia and these forces cannot be avoided. It is only a matter of time. They are getting ready and waiting for the right moment. Moreover, they went as far as aspire to acquire nuclear weapons. We will not let this happen.

I have already said that Russia accepted the new geopolitical reality after the dissolution of the USSR. We have been treating all new post-Soviet states with respect and will continue to act this way. We respect and will respect their sovereignty, as proven by the assistance we provided to Kazakhstan when it faced tragic events and a challenge in terms of its statehood and integrity. However, Russia cannot feel safe, develop, and exist while facing a permanent threat from the territory of today's Ukraine.

Let me remind you that in 2000–2005 we used our military to push back against terrorists in the Caucasus and stood up for the integrity of our state.

We preserved Russia. In 2014, we supported the people of Crimea and Sevastopol. In 2015, we used our Armed Forces to create a reliable shield that prevented terrorists from Syria from penetrating Russia. This was a matter of defending ourselves. We had no other choice.

The same is happening today. They did not leave us any other option for defending Russia and our people, other than the one we are forced to use today. In these circumstances, we have to take bold and immediate action. The people's republics of Donbass have asked Russia for help.

In this context, in accordance with Article 51 (Chapter VII) of the UN Charter, with permission of Russia's Federation Council, and in execution of the treaties of friendship and mutual assistance with the Donetsk People's Republic and the Lugansk People's Republic, ratified by the Federal Assembly on February 22, I made a decision to carry out a special military operation.

The purpose of this operation is to protect people who, for eight years now, have been facing humiliation and genocide perpetrated by the Kiev regime. To this end, we will seek to demilitarize and denazify Ukraine, as well as bring to trial those who perpetrated numerous bloody crimes against civilians, including against citizens of the Russian Federation.

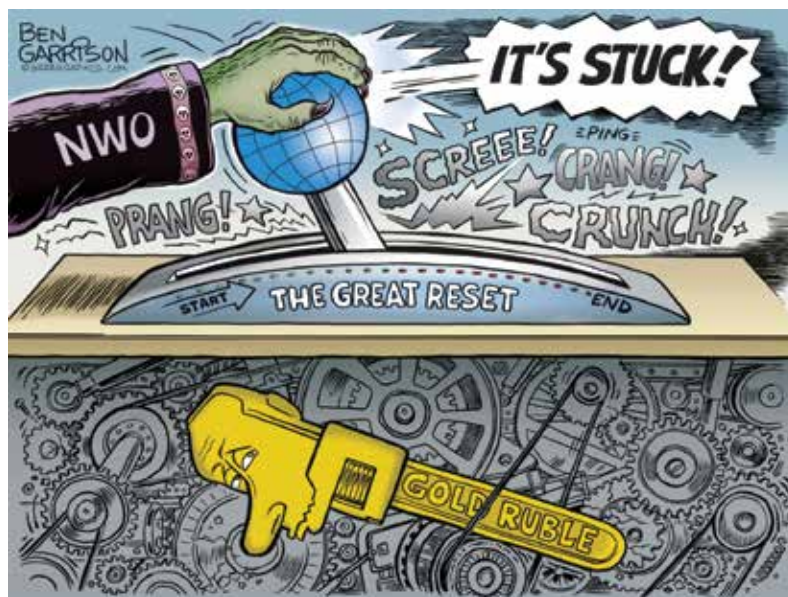
It is not our plan to occupy Ukrainian territory. We do not intend to impose anything on anyone by force. At the same time, we have been hearing an increasing number of statements coming from the West that there is no need any more to abide by the documents setting forth the outcomes of World War II, as signed by the totalitarian Soviet regime. How can we respond to that?

The outcomes of World War II and the sacrifices our people had to make to defeat Nazism are sacred. This does not contradict the high values of human rights and freedoms in the reality that emerged over the post-war decades. This does not mean that nations cannot enjoy the right to self-determination, which is enshrined in Article 1 of the

UN Charter.

Let me remind you that the people living in territories which are part of today's Ukraine were not asked how they want to build their lives when the USSR was created or after World War II. Freedom guides our policy, the freedom to choose independently our future and the future of our children. We believe that all the peoples living in today's Ukraine, anyone who wants to do this, must be able to enjoy this right to make a free choice.

In this context I would like to address the citizens of Ukraine. In 2014, Russia was obliged to protect the people of Crimea and Sevastopol from those who



you yourself call "nats." The people of Crimea and Sevastopol made their choice in favor of being with their historical homeland, Russia, and we supported their choice. As I said, we could not act otherwise.

The current events have nothing to do with a desire to infringe on the interests of Ukraine and the Ukrainian people. They are connected with defending Russia from those who have taken Ukraine hostage and are trying to use it against our country and our people.

I reiterate: we are acting to defend ourselves from the threats created for us and from a worse peril than what is happening now. I am asking you, however hard this may be, to understand this and to work together with us so as to turn this tragic page as soon as possible and to move forward together, without allowing anyone to interfere in our affairs and our relations but developing them independently, so as to create favorable conditions for overcoming all these problems and to strengthen us from within as a single

whole, despite the existence of state borders. I believe in this, in our common future.

I would also like to address the military personnel of the Ukrainian Armed Forces.

**Comrade officers,**

Your fathers, grandfathers and great-grandfathers did not fight the Nazi occupiers and did not defend our common Motherland to allow today's neo-Nazis to seize power in Ukraine. You swore the oath of allegiance to the Ukrainian people and not to the junta, the people's adversary which is plundering Ukraine and humiliating the Ukrainian people.

I urge you to refuse to carry out their criminal orders. I urge you to immediately lay down arms and go home. I will explain what this means: the military personnel of the Ukrainian army who do this will be able to freely leave the zone of hostilities and return to their families.

I want to emphasize again that all responsibility for the possible bloodshed will lie fully and wholly with the ruling Ukrainian regime.

I would now like to say something very important for those who may be tempted to interfere in these developments from the outside. No matter who tries to stand in our way or all the more so to create threats for our country and our people, they must know that Russia will respond immediately, and the consequences will be such as you have never seen in your entire history. No matter how the events unfold, we are ready. All the necessary decisions in this regard have been taken. I hope that my words will be heard.

**Citizens of Russia,**

## Western Medicine is Rockefeller Medicine – All the Way

Western medicine has some good points, for sure, and is great in an emergency, but it's high time people realized that today's mainstream medicine (western medicine or allopathy), with its focus on drugs, radiation and surgery, is at its foundation a Rockefeller creation. They have either majorly or fully created (and still dominate) the United Nations, the World Health Organization, the Council on Foreign Relations, the Trilateral Commission, Planned Parenthood and many, many other organizations that either rule the world or influence culture to a large extent. Despite the dominance of western medicine nowadays, even just 100 years ago the situation was very different, so it's worthwhile casting our minds back to how we got to this place.

How did western medicine and the giant conglomerate of multinational pharmaceutical corporations ("Big Pharma") become the mainstream medical system in the US and other first world nations? And what alternatives are there?

### **Petroleum Drugs**

Let's go back in time to the late 1800s. John D. Rockefeller, a man quoted to have said "competition is sin", is the head of the Rockefeller family and has just become very rich through extracting oil from the ground. Now he is looking for ways to capitalize even further with his oil, and he comes across the idea of using coal tar – a petroleum derivative – to make substances that affect the human mind, body and nervous system. These are called drugs, and they are excellent at masking or stopping symptoms, but overall do not cure the underlying cause of a disease.

Like other elite leaders of the New World Order who fit the description of an "evil genius" – those high on intellect and low on compassion – Rockefeller used his oil money to

buy out part of the massive German pharmaceutical cartel, I.G. Farben. This was the very same cartel that would later assist Hitler to implement his eugenics-based vision of a New World Order founded on racial supremacy, by manufacturing chemicals and poisons for war. With the control of drug manufacturing under his wings, Rockefeller then embarked on a decidedly wicked plan – wicked from the point of view of a free and healthy humanity, but brilliant from a business perspective.



### **Destroying any Competition to Western Medicine**

Rockefeller saw that there were many types of doctors and healing modalities in existence at that time, from chiropractic to naturopathy to homeopathy to holistic medicine to herbal medicine and more.

He wanted to eliminate the competitors of western medicine (the only modality which would propose drugs and radiation as treatment, thus enriching Rockefeller who owned the means to produce these treatments), so he hired a man called Abraham Flexner to submit a report to Congress in 1910.

This report "concluded" that there were too many doctors and medical schools in America, and that all the natural healing modalities which had existed for hundreds or thousands of years were unscientific quackery. It called for the standardization of medical education, whereby only the allopathic-based AMA be allowed to grant medical school licenses in the US.

Sadly, Congress acted upon the conclusions and made them law. Incredibly, allopathy became the standard mainstream modality, even

though its 3 main methods of treatment in the 1800s had been blood-letting, surgery and the injection of toxic heavy metals like lead and mercury to supposedly displace disease!

It should be noted that hemp was also demonized and criminalized not long after this, not because there is anything dangerous about it, but because it was a huge threat (as both medicine and fuel) to the Rockefeller drug and oil industries, respectively.

### **The Rockefeller and Carnegie Tax-Exempt Foundations for "Efficient" Philanthropy**

The story doesn't stop there. Rockefeller and another elite leader Carnegie used their tax-exempt Foundations, from 1913 on, to offer huge grants to the best medical schools all over America – on the proviso that only an allopathic-based curriculum be taught, and that some of their agents be allowed to sit on the Board of Directors. They called this "efficient" philanthropy, which, when through the Orwellian translation unit, means they wanted a return on their investment.

They systematically dismantled the curricula of these schools by removing any mention of the natural healing power of herbs and plants, or of the importance of diet to health.

The result is a system which to this day churns out doctors who are, almost always, utterly clueless about nutrition and disregard the idea that what you eat can actually heal or hurt you.

A couple



of decades after this, another law was passed that further entrenched western medicine in America. The Hill-Burton Act of 1946 gave hospitals grants for construction and modernization, on the condition they provide free healthcare to anyone in need, without discrimination of any kind.

Although there were good sides to this, the downside was that once people had become dependent on this system for their healthcare needs – especially those on pharmaceutical pills which need to be taken day after day without end – the system switched into a paid system, and the Rockefellers found themselves with new lifelong customers.

The bitter truth is that, in general, when you go to your Western doctor, you are seen as a potential market for the medical factory's products. For Big Pharma, there is no financial incentive to heal you, because a patient cured is a customer lost. Even if you are not sick, Big Pharma is still targeting you, trying to convince you that you are ill (e.g. with psychiatry's ridiculous list of

fictitious diseases, many of them fake) so that you will try its latest pill.

Pregnant women who go to the doctor are treated like this, and peddled intravenous fluid bags, fetal monitors, ultrasound (radiation for a vulnerable baby), a host of drugs, the totally unnecessary episiotomy, and – to top it all off – the Caesarean delivery!

## Bio-Piracy: The Business Model of Western Medicine's Big Pharma Cartel

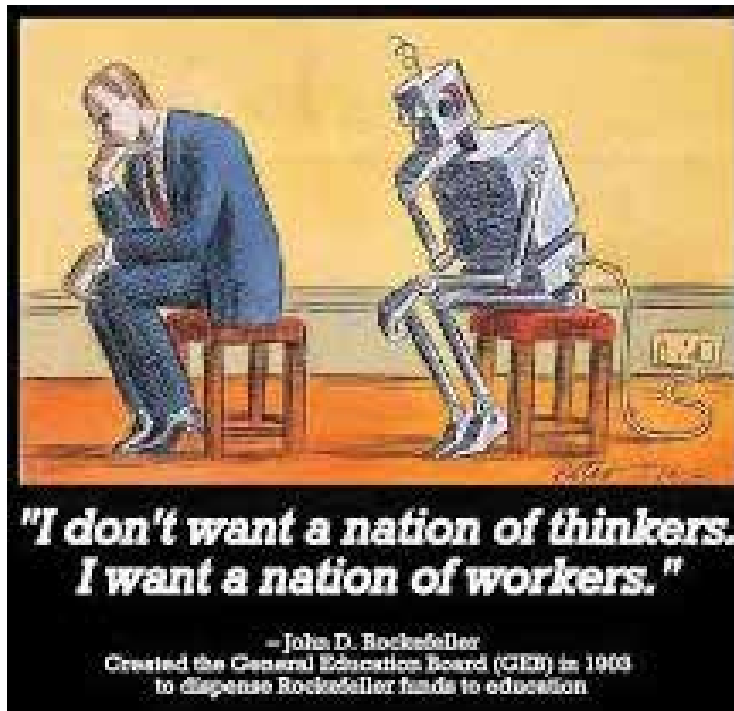
When you take plants and herbs as medicine, you normally take the whole food, not an isolate, because it is based on a holistic understanding.

the US every year. ## Questioning Statins' Efficacy

A meta-analysis [a statistical analysis that combines the results of multiple scientific studies] published recently in JAMA Internal Medicine raises questions about the efficacy of statin drugs with regard to reducing heart attack, stroke, and all-cause mortality. The findings are important because they may have implications for affecting shared decision-making between doctors and patients when it comes to using statin drugs to lower serum cholesterol levels.

The meta-analysis included twenty-one randomized controlled trials that compared statin drug treatment to placebo or usual care, reported absolute changes in LDL-C, and had a duration of at least two years. The main finding was that the relative risk reductions in all-cause mortality, heart attack and stroke, were misleading compared to the absolute risk reductions, and this may lead clinicians and patients

to believe that statins are more effective than they may be in some cases.

### Statin Drugs Drain the CoQ10 Out of Your Body

Cholesterol-lowering statin drugs block the production of cholesterol in the liver. In doing this, they also block the production of CoQ10. Not surprisingly, the side effects commonly associated with statin drugs are nearly identical to the symptoms of CoQ10 deficiency:

The relative risk reductions (RRR) were shown to be 9% (all-cause mortality), 29% (heart attack), and 14% (stroke). These sound impressive on the surface,

but looking at absolute risk reduction (ARR) paints a different picture. The absolute reductions were 0.8%, 1.3%, and 0.4%,

respectively. The paper's authors wrote: "Reporting the reduction in cardiovascular outcomes as RRR without reporting the corresponding absolute risk reduction (ARR) has the potential to inflate the clinical importance of an intervention and may exaggerate trivial

associations."

Related research has shown that reductions in LDL-C correspond poorly to reductions in cardiovascular risk, and it is

increasingly believed that the beneficial effects of statins come from pleiotropic actions rather than the lowering of LDL-C. The authors of the meta-analysis noted, "...when considering the ARR of statins, the benefits are quite modest, and most trial participants who took statins derived no clinical benefit."

According to the authors' calculations from the pooled trials included in the meta-analysis, 77 individuals would need to be taking a statin for approximately 4.4 years to prevent one heart attack. Depending on an individual patient's situation, statin therapy may be appropriate, but the risks and benefits should be clearly communicated so that an informed decision can be made, particularly in light of the undesirable side-effects these drugs may induce in some patients.

## Amazon is squeezing Arizona small businesses. Will Congress level the playing field?

Opinion: Amazon and other Big Tech companies are making it difficult for small retailers in Arizona to compete. Bipartisan federal legislation could help.

Entrepreneurship and innovation in Arizona will be hindered if lawmakers do not rein in Big Tech.

Over the last two decades, the tech giants have grown and used their power to control markets and thwart competition. But there is bipartisan legislation in Congress that would take significant steps toward leveling the playing field for Arizona's small businesses.

As the founder and CEO of Local First Arizona, a nonprofit committed to supporting Arizona's local enterprises and communities to build a vibrant and inclusive economy, I have spent two decades working to ensure that Arizona-grown businesses can compete and thrive.

I hear regularly from businesses in my community about the challenges they face, including Amazon, Apple, Facebook and Google, and their monopoly hold over the digital marketplace. If Arizona's most dynamic local economies and entrepreneurs are able to seize this moment, Arizona's policymakers must fight for legislation that will diminish Big Tech's monopolistic control of the online marketplace.

Amazon charges, then often competes with sellers then

penalizes businesses who try to sell for a lower price on other platforms and imposes ever-growing fees on its sellers. That is bad for competition and bad for business. And, if a seller's product becomes popular, Amazon is likely to clone it and sell the competing product under its own AmazonBasics brand – sometimes using the data it collects on seller's products to design and market a competing product.

Small sellers now report paying 34 cents out of every dollar they earn to Amazon. Small app designers must sell through Apple, and Apple takes a 30% cut of their revenue.

I've heard directly from an Amazon seller in Tempe. He asked not to be identified for fear that Amazon would retaliate against his company. He described the crushing weight of Amazon's fees, which is capsizing his and many businesses that sell on Amazon's marketplace.

When his startup began selling its unique sports apparel on Amazon in 2016, it was a viable business. But then Amazon increased its fee for clothing, from 15% to 17%. To sell \$10,000 worth of clothing, this seller pays Amazon \$1,700

in referral fees on top of another \$1,500 to \$2,000 on ads, not to mention a host of smaller fees.

"Amazon is now taking more of the pie than I am," he said. "And you cannot run a sustainable business like that."

Why sell there? They have no other choice. A recent survey

Tech will help restore competitive balance to the American tech sector, which is great for consumers and small businesses. The American Innovation and Choice Online Act, which targets the tech giants' immense power as gatekeepers, is an important and critical first step.

Legislation would offer a level playing field. It would prohibit dominant platforms from abusing their gatekeeper power by favoring their own products or services at the expense of competitors and prohibit specific conduct that harms small businesses and entrepreneurs.

The bill also would give enforcers strong, flexible tools to deter violations and hold dominant platforms accountable when they cross the line into illegal, anticompetitive behavior.

This is a must-pass bill, but we need more. Congress must pass legislation that gets at the heart of Big Tech power. This means passing the full package of legislation that passed by the House Judiciary Committee last summer, which would restrict Big Tech platforms from owning businesses that create a conflict of interest and prevent these platforms from unfairly disadvantaging their competitors.

The communities and businesses that Local First Arizona is fighting for are tough, creative and resilient. They're not asking for guarantees, just the level playing field that this legislation will give them. At this critical juncture in the legislative process, Arizona needs Congress to step up and vote on these bills for broader economic opportunity in the internet age.

from the Institute of Local Self-Reliance validates the experiences of the Arizona businesses. They asked more than 900 independent businesses across the country about the challenges they face, and found that more than 60% of businesses said Amazon's control over the online market was a very or extremely significant challenge.

The institute also surveyed 100 Amazon sellers and found 74% of respondents believe that Amazon's algorithms are unfair and favor Amazon's own products over those of sellers. When asked why they sell on Amazon, 63% of respondents said there was no viable alternative, and 55% of Marketplace sellers said they would not feel comfortable speaking out about Amazon's treatment of sellers. "Amazon can be extremely punitive in its dealings with its independent sellers," one seller told the institute.

Congress's efforts to rein in Big

But Judge Jackson disagreed and ruled that distributing images of infants and toddlers being raped is not especially egregious.

\* Wesley Keith Hawkins posted videos of 11 year old boys being raped by men. Jackson only gave him three months, sent him to a low security prison, arranged for special protections and apologized to him, telling him that she feels so sorry for him and his family, and for the anguish that this has caused all of them. In explaining her light sentence, Judge Jackson argued for the child pornographer's future potential. Six years later, he was arrested again for distributing child rape porn, and Jackson re-sentenced him to only six months in a residential re-entry center.

\* Neil Alexander Stewart was arrested with hundreds of images and videos of child rape while trying to procure children between the ages of five and

11 to rape them. Judge Jackson admitted that the felon was likely to reoffend but still gave him a light sentence arguing that the current recommendations for child sex offenders is outdated and substantially flawed. Three years later, Stewart re-offended.

This is how Judge Jackson got her start. In 2009, President Obama nominated her to vice chair the US Sentencing Commission where she helped weaken Federal sentencing policy for child pornographers by arguing that child pornographers are

not pedophiles, which is similar to how Hillary Clinton got her start when she defended a group of men who violently gang raped a child and later joked how she knew they were guilty. It's also very interesting that when the biggest pedophile scandal in

history broke, Judge Jackson was there. After WikiLeaks released the Podesta emails, millions of people were asking questions about a strange coded language being used between President Obama, Hillary Clinton and their friends. A code that seemed to reflect what the FBI says is secret code for pedophiles! The whole sordid mess became known as pizza gate. And when the Feds clean up operation ended up in the courts, Judge Katanji Jackson was there to help tidy it all up.

I'm sure this is all just a coincidence. Just like it was a coincidence that the world's most infamous pedophile blackmail artist killed himself in jail while the guards were surfing the internet. And just like it's a coincidence that Congress has paid out millions of dollars in court settlements that involve sexual assault. ## Food Shortage Crisis? Dozens of Food Processing Plants Destroyed In Fires & Accidents

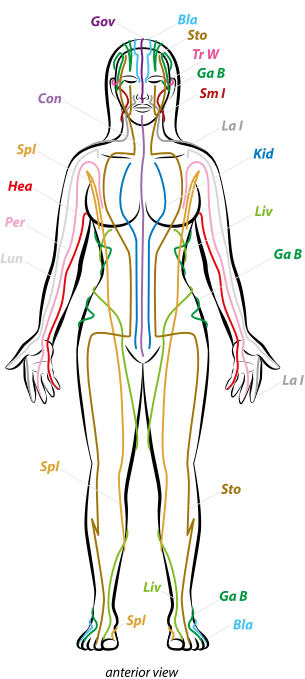

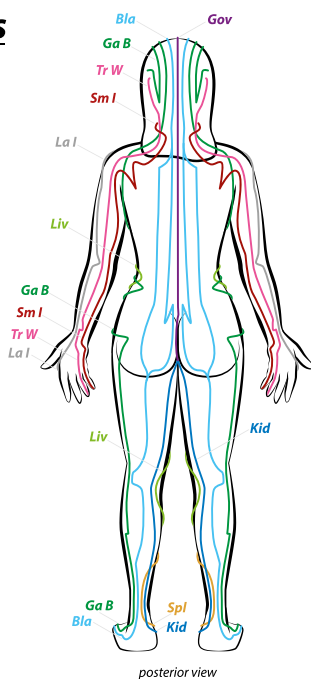
