More Political Shenanigans in Quartzsite

Well the Quartzsite Town Council continues to show their true colors even brighter every moment closer to the election. These actions would not surprise me in a large city, one almost expects corruption and election interference in large cities, but not in small communities, yet here we are!

We have witnessed that Quartzsite has no shortage of political hacks who would do anything to stay in power.

If you haven't been following the Shenanigans in the past two issues, here is a short recap. If you want to read the entire story, you can view past issues of the paper at TFPnews.com for FREE.

In April, three potential candidates submitted all of the paperwork required to run for Town Council. Someone on the current council, the Mayor or the Town Manager really didn't want to have at least one of the candidates on the ballot bad enough to pull out an outdated Town Code 30.09(b) and began the inquiry into monies owed to the town and effectively eliminating their competition. This code, in years past, was ruled unlawful in a court of law and the town not only lost but was made to pay all legal fees.

Mike Roth was found to have a 13 day late water bill that was >\$60. Sam Saxton and Dennis Vosper had outstanding fees

of \$100 owed to the town based upon a judgment nearly two years prior when the town lawyer and the town manger being judge, jury and executioner in an investigation initiated by Starr Bearscat, who coincidentally [as if there is such a thing] was/is a sitting council member who was at the time up for re-election and running against the two candidates. Interesting. Soon thereafter, sitting councilman Steve Schue was also disqualified due to failure to renew one of the business

licenses he has in town, a \$75 fee.

Now we come to the past few weeks. Mike paid his water bill, Sam and Dennis decided to pay the fines in protest and continue with paperwork as write-in candidates. Allegedly the town manager ordered all the department heads to look into these potential candidates. I am curious if the incumbents were also investigated?

Mike was immediately audited back 14 years and was issued a total bill in excess of \$7000 for fines owed to the town, case numbers 2008-0001 and 2008-0002. Interesting case numbers. This was all new to Mike and the town had never tried to collect said charges. Odd. Again judge, jury and executioner. Mike did not succumb to the town and pay the exorbitant fines, he will fight the alleged fines (as anyone would do who had no due process) he has been forced out of the race altogether. The current town government will never allow Mike Roth to be on the ballot, this is clear. It is not your choice despite being a responsible taxpayer who should be allowed to vote for whomever you choose.



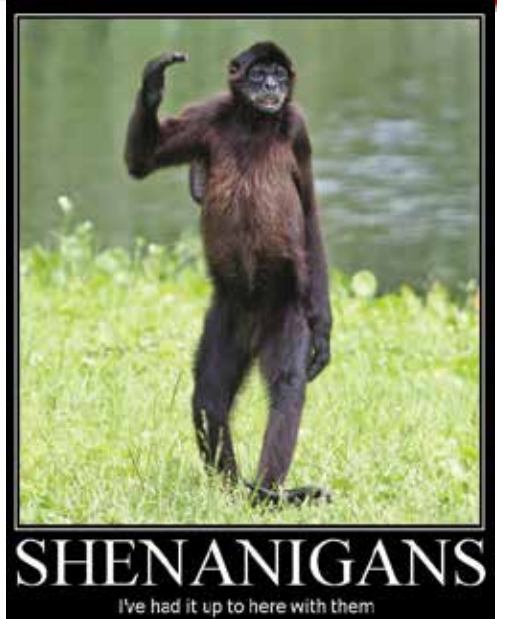
They didn't stop there. The town then began the audit of Dennis Vosper, he is the manager of his deceased father's radio stations, KBUX 96.5FM Classic Oldies and 105.9FM Classic Rock. His father died in a fiery car crash in October. His mother, now a widow after nearly 57 years of marriage, is being threatened with code violations of not being connected to the town services. The cost of compliance could far exceed \$8000. Again your town government is threatening to

play judge, jury and executioner on a recent widow. Fortunately for the residents of Quartzsite this did not prevent Dennis, the manager of now his mom's radio station, from becoming an official write-in candidate.

Now a new candidate comes into view, Devyn Rosner, owner of Pattie's RV and Propane. He is running on the campaign of donating his Town Council salary back to the town for something (to be determined) in the future that the residents really need, because "town council should be a volunteer position." This same person is being accused of embezzlement of funds given to Devyn during a time that he was working on the special projects board. He received a check from VOTS real estate, whom he used to purchase the property, for a mere \$250 that was made out to Devyn and not part of the event funds of which he personally donated \$500 to said event. Months later this comes up, really? He was asked to step down from the special projects board. Interesting timing! Allegedly a sitting town council member sent strong arm emails to the secretary

of VOTS but not to the broker, who wrote the check! [we are awaiting proof of the emails before publicizing the name] The Town Attorney should have advised of the absurdity of the allegations but didn't! Devyn has had no less than ten inspectors, with body cams, come to his place of business

in the past two weeks. They would answer none of his questions. The ONLY thing they got him on was he was made to move a decorative propane tank 12 feet from the road because Larry Lord, who sits on the planning and zoning board as well as the board now accusing Devyn of embezzlement, thought this looked like street advertising. Coincidence? I think not! Devyn is a great young man with a love for Quartzsite and his reputation should never be tarnished by such an



absurd accusation! Shame on you all, especially you sitting council members and Larry Lord, you are attempting to ruin this man, he has his entire life ahead of him and defamation of character is a really big deal!

What the Heck is a Republic?

You are being fooled. Fooled by the media, fooled by most of the politicians and fooled by many of the educators. Their constant drone tells us that we are a Democracy, but we are not a Democracy of any kind. We are a Republic. "Hence it is that such democracies have ever been spectacles of turbulence and contention; have ever been found incompatible with personal security or the rights of property; and have in general been as short in their lives as they have been violent in their deaths."

Our Constitutional Republic is different. We have a foundation of government set by our Constitution. All laws created by the government must be in consonance with its

constitutional design. The Constitution is purposefully difficult to change, because an amendment requires the approval of two-thirds vote of both the Senate and House of Representatives, plus the ratification of three-fourths of the state legislatures to succeed.

maintained that the state-appointed senators were the guardians of the Tenth Amendment) But those senators disappeared when the 17th Amendment was ratified in 1913, which changed the senators to ones who were elected by a popular vote.

Now we have political party senators instead of state-appointed senators.

of government: The Electoral College. That system was designed to have our States decide the president, not the popular vote. Again, this was to avoid the power of the mob. But the leftist masses have been eroding that foundation as well.

If we lose the Electoral College, it will empower the SWAMP, which is composed of the current government bureaus across the nation, the politicians, attorneys, educators and other "services" that have prospered with the incredible growth of our government, to become more powerful.

When doing the research for my book ("The Real Constitution and its real enemies" - available on Amazon) I found a quote by Richard Hofstadter that best describes the designs of the men who wrote our Constitution:

"The men who drew up the Constitution in Philadelphia during the summer of 1787 had a vivid Calvinistic sense of human evil and damnation and believed with Hobbes that men are selfish and contentious. They [the delegates] were men of affairs, merchants, lawyers, planter-businessmen, speculators, investors. Having seen human nature on display in the marketplace, the courtroom, the legislative chamber, and in every secret path and alleyway where wealth and power are courted, they felt they knew it in all its frailty. To them a human being was an atom of self-interest. They did not believe in man, but they

did believe in the power of a good political Constitution to guide him."

So that brings us to the bottom line: the Founding Fathers designed a republic that makes it difficult to change and difficult for corruption to take hold. But, as their government takes on more features of a democracy and submits itself to the power by the mob, it encourages change and encourages corruption.

Now you can understand why their political faction pushes for a democracy and how the politicians and their partners in big government become wealthy as they work us into that system. We must stop that push to a democracy if our nation is to survive.

The philosophy of our Constitution was to bind the states together in a very limited measure, with the federal government having little control over the internal operations of each state, but it would represent them in a national scope and international affairs.

Within our original Constitution we do find an area of popular input: the House of Representatives. Its members are elected to short, two-year terms to reflect the popular pressures of the people. But the Senate was far different in its design. Its members were originally appointed by the State Legislatures, so the States officially had influence in the legislative and the appointment processes of the Federal Government. (I have long

That change set some forces in motion which took a while before they gained enough power to vandalize our republic. All presidential appointments, all nominations for the judiciary, all treaties and all legislation must receive Senate approval. With the new amendment, party politics had become more important than our Constitution. Because of this, we now have SCOTUS justices who ignore the Tenth Amendment, despite their swearing an oath to "preserve, protect and defend" our Constitution.

The 17th Amendment was a strong hit against our republican form of government.

US Veteran Denied Basic Human Rights “It’s in His Best Interest”

Back in May we covered the story of a veteran who had been deemed unable to care for himself and was now in the care of the county fiduciary, Vivian Hartless. He was taken to a small private assisted living facility and all of his belongings were sold (I was told, off the record, at a cash only - no receipt, not well publicized sale) was being denied visitation with a long time friend, whom he really wants to see. Possibly because this person would be a strong advocate for him. I reached out to Mrs. Hartless via email, her phone number is strangely not available. I got no response in May so I reached out again in June and she still refused to respond and instead had the County Attorney send the following statement:

“To Whom it May Concern:
As you know, John Pitt is the subject of a conservator and guardianship action in La Paz County Superior Court case number GC2021-00009.

Fiduciary Hartless has taken Mr. Pitt’s wishes into consideration regarding visitation by any and all family members, friends, or other third parties. Fiduciary Hartless has determined that it is not in Mr. Pitt’s best interest to have contact with certain individuals. Fiduciary Hartless is aware of information that is confidential between her and her ward that family, friends

and third parties are not privy to. While I understand that you or your readers might not like this result, Fiduciary Hartless cannot be cajoled into doing something, here allowing a visit, that she believes is not in the best interest of her ward. Fiduciary Hartless will continue to fulfill her statutory obligations and duties until such time that the court terminates her letters of authority. Please contact me if I can be of any further assistance.

Upon receipt of this letter, I contacted J’aime Morgaine,

Executive Director of Real Change. This is her response:

“La Paz County Attorney Mr. Dooley’s response is the same response that he has made from the beginning of this advocacy campaign. What Vivian

Hartless is doing is all “within the law,” but the problem is that there is ZERO accountability for her “judgment.” The veteran at the center of this work has rights that he has EARNED as an adult American citizen, that he RETAINS even when placed into a conservator/guardianship. And, Arizona law clearly states that a guardian can only make decisions

on a “ward’s” behalf when they are unable to make those decisions for themselves.

The bottom line: Vivian Hartless is violating this veteran’s RIGHT to visitation with his friends and family under the guise of “in his best interest.”



La Paz County is supporting their fiduciary’s legal authority, which is to be expected. The judge who appointed her is the only accountability, but there is no clear path for requesting the judge’s review. This is the problem in these conservative/guardianship cases. Without a separate court-appointed advocate to ensure that a person’s civil rights are being protected and preserved when and where they can be, the court-appointed guardian has complete and unaccountable “legal” authority to usurp civil liberties.

And, let me make this point perfectly clear: Just because what Vivian Hartless is doing is within her “legal” authority does not mean that what she’s doing isn’t morally reprehensible and wrong on every other level.

I have received multiple calls from La Paz County residents who have witnessed questionable acts by Vivian Hartless. And, the consistent “perception” of these La Paz community members is that Vivian Hartless has “the judge in her back pocket,” that the person who makes the initial diagnosis “rubber stamps” Ms. Hartless applications, and that “everyone is afraid to hold her accountable because her husband is on the Parker Town Council.” This is a problem.

In addition, it is clear that Vivian Hartless (and her husband) are both motivated by the “conspiracy theory” that those who are fighting in this case are motivated by

“ulterior motives.” Her husband made this theory known publicly in a Facebook post. I had to laugh, because my only motive is (and has been) fighting for this veteran’s rights to be respected.

Real Change PAC is a third party entity with absolutely no authority or legal standing in this case, but we continue to fight to protect this veteran’s rights in whatever way possible. If you have knowledge of apparent inappropriate actions taken by Vivian Hartless, please file a complaint directly with La Paz County. I understand that there may be a “personal cost” to make a formal complaint, but this is the only way that Vivian Hartless will be held accountable.

Hallelujah - A New School in Quartzsite

The Southern Christian Academy is opening their doors this fall to provide a much-needed service to the children in Quartzsite.

When Pastor Jeff Saxton arrived in Quartzsite four years ago, he went to the public school and tried to volunteer to help them anyway he could. He talked to them and found out that they were not interested in his help because they felt like they were doing fine on their own.

Then came Covid and our little school here got closed down. The learning went online and as the lockdowns lifted the little kids got bussed over to the Ehrenberg school. If that arrangement was adequate, we would have been happy with it. But if you google our local schools, they are not rated as high as most would want to take their children. The Ehrenberg school is kindergarten through eighth grade with 141 to 180 students. But their testing results show that only 24% of the students tested at grade level or above for reading. So that is a 76% failure rate. Then in Math, only 12% of their students tested at grade level or above. The Saxton's looked at the stats and at the ratings of our local schools and they were a little bit concerned about that. Plus, our children do not need to be bussed to another town to attend school.

That was part of the equation for why they started the academy but there was another part of the equation that got them where they are today. In the last eighteen months they evaluated where their church was. That is, what is the strength of their church and the



people who minister in the church. One of the sweet spots of their ministry is teaching. They love teaching and feel like God's gifted them to be teachers. That is their sweet spot for what they like to do and what they are passionate about. They looked at the community and asked if there was any application of that passion and giftedness in the local community. When they meshed the need of education for the children and passion for teaching, they came up with the idea of a private school.

Then they started to look at schools to see if there was any kind of school that they could do on a small-scale basis and they came up with the ACE program. It's been used all over the world and it has been in existence for over fifty years. Gina and Sam Saxton taught in a Christian school using this program when they lived in Florida. It was a very successful school.

They talked to several private Christian schools in the surrounding area, which helped mentor them through the process of opening a school. The Yuma Christian Academy has 150 kids in their ACE school and are very successful. The Parker program has

been going on for 18 years and the Lord has blessed them.

This ACE program doesn't use teachers except for Kindergarten. The students are self-taught and there are supervisors and monitors that help them when they get stuck. The school is not computer based although some of the advanced high school subjects will use computers.

The objective of the Quartzsite Southern Christian Academy is the development of our children. They want to see the kids in our community get a shot at being productive in our community in the years ahead. If you don't have education, there is usually only a certain level of productivity that you can achieve. The better your

education, the more opportunities you have available. Broadly speaking, if someone is going to be a farmer, they are going to be a better farmer if they are an educated farmer. If someone is going to be a brain surgeon, they ought to know a little bit about science. The smaller amount of education they have or the weaker their education is, limits them on what their opportunities and options are when you go out in the world.

There is no excuse for children growing up in a small community to have their future options limited. Any community can produce doctors and other high education occupations if they focus on educating their children.

The academy wants to see the students develop mentally, spiritually, socially, physically, and emotionally. The three goals for each student are training in their subjects, critical thinking skills and their relationship with God. They are a Christian school. They will be introduced to the concepts of God, and they will be introduced to the Bible. The curriculum is from a Biblical World View. They will teach the fundamental skills of reading, math, etc. as well as life skills and extracurricular activities will be added to their program. Hallelujah!

Supreme Court Overturns Roe v. Wade

Pro-life advocates are celebrating today's U.S. Supreme Court ruling that removes federal protections for abortion. Friday's announcement overturns the 1973 case Roe v. Wade, and opens the door for states to ban infanticide of the unborn.

The draft decision for Dobbs v. Jackson Women's Health Organization, originally leaked in May, is now final. This case challenged the state of Mississippi's Gestational Age Act, banning abortions on babies who are beyond 15 weeks in the womb. Jackson Women's Health Organization charged that Mississippi was in violation of "precedents establishing a constitutional right to abortion" set by Roe v. Wade and Planned



Parenthood of Southeastern Pennsylvania v. Casey.

In response, the SCOTUS decision declares, "The Constitution does not confer a right to abortion; Roe and Casey are overruled; and the authority to regulate abortion is returned to the people and their elected representatives."

Justice Samuel Alito delivered the opinion of the court, stating that prior to 1973, the federal government respected the right of states to address this "profound moral issue" in "accordance with the views of its citizens."

Justices Breyer, Sotomayor, and Kagan issued the dissenting opinion,

claiming that Roe and Casey "have protected the liberty and equality of women" for nearly 50 years.

Since the draft leak in May, President Joe Biden has been calling on Congress to protect women's so-called right to kill their unborn children.

Pro-life groups have endured increasing persecution, largely unreported in media, and are bracing for new waves of violence from groups such as Jane's Revenge, which has blanketed Washington, D.C., with flyers announcing their intent to foment a "Night of Rage" against their "oppressors" when "SCOTUS overturns Roe v. Wade."



Though the SCOTUS ruling removes federal protections for abortion, it hardly sounds a death knell for America's holocaust. Fifteen states and the District of Columbia have enshrined abortion as a fundamental right in state law (city law in the case of D.C.). On the list are California, Connecticut, Delaware, Hawaii, Illinois, Maryland, Massachusetts,

Nevada, New Jersey, New York, Oregon, Rhode Island, Vermont and Washington, and even a red state, Maine, makes the shameful cut. Planned Parenthood's research arm, the Guttmacher Institute, expects

to soon add Colorado and New Mexico to the roll as radical pro-aborts in those states bristle at the (for now) pro-life majority on the high court's bench.

Statement by the Arizona Senate

Phoenix, Arizona — Violent pro-abortion protestors attempts of an insurrection at the Arizona State Senate were thwarted Friday night, thanks to the swift action from local and state law enforcement. While Arizona State Senate members were wrapping up passing important legislation for the session, extremist demonstrators made their way to the entrance of the Senate building and began forcibly trying to make entry by breaking windows and pushing down doors.

Law enforcement monitoring this situation called for backup and were able to disperse the crowd with tear gas before entry was made. As this terrifying situation unfolded, Senate President Karen Fann called a recess so that Senators, staff and the public in attendance could evacuate to a secure location. Once the premises were secured, those inside the building were able to return to the

Senate chambers. Unfortunately, the system that circulates the air through the facility pulled some of the smoke or tear gas into the Senate chambers, making the air quality unhealthy for anyone to return.

In response, Senate proceedings were moved to another room of the building so that Senators could continue carrying out the people's work. "We are incredibly thankful for our local law enforcement who quickly intervened during what could have been a destructive and dangerous situation for our members, staff and public inside the Senate," said Senate President Karen Fann. "Violence is never the answer, and we will not camouflage what was a blatant attempt at an insurrection as a 'rally' or 'peaceful protest.' We are calling on all state lawmakers to condemn these acts. There is a way to make your voice heard and violence is never the answer."

The Ugly Truth About Planned Parenthood

Lately, Planned Parenthood has been getting a lot of criticism, and rightfully so, due to the undercover videos being released that show some of the barbarous things they have done to the babies they have aborted. Six videos, and now a seventh one, have been put out for the world to see from the anti-abortion organization, The Center for Medical Progress located in California, and they're not pretty.

The first video was released over a month ago and caught Planned Parenthood's senior director of medical services, Dr. Deborah Nucatola, saying that abortionists will often "change the presentation" of the body to enlarge the number of organs that they can preserve to keep them intact. Over some nice red wine and a salad, Nucatola casually mentions about her looking at the organs the biotech company wants and decides during the abortion what parts to crush to kill the baby, but still keep the limbs and organs that the biotech company wants unscathed.

The fifth video shows Melissa Farrell, the director of research for Planned Parenthood Gulf Coast, admitting that they do deviate from their standard

protocol so that "we are able to obtain intact fetal cadavers." Farrell also added that she found cutting up aborted babies is "sickening on some level, but it's fun."

The most recent video is just as shocking and disturbing as all of the others. The video takes place at Mar Monte clinic in San Jose, and it shows doctors harvesting the brain of an aborted baby while its heart was still beating.

Holly O'Donnell, a former procurement technician at StemExpress, was brought to the aborted baby by a co-worker named Jessica saying, "I want you to see something kind of cool." O'Donnell sees the baby and says, "This is the most gestated fetus and closest thing to a baby I've ever seen. I'm sitting here looking at this fetus and its heart is beating, and I don't know what to do."

The co-worker named Jessica tells O'Donnell, after showing her the

child's beating heart, "This is a really good fetus, and it looks like we can procure a lot from it." She then asked O'Donnell to remove



the baby's brain with scissors through the baby's face, while the heart was still beating.

O'Donnell talks about what she did saying, "I can't even describe what that feels like. That was the moment I knew I couldn't work for the company anymore ... even if it was the cure for some disease."

Planned Parenthood is defending their company by saying that the fetal tissue donation is a "humanitarian undertaking." They say they are not guilty of any crime whatsoever. But,

others claim that they are in fact guilty of the federal law, Born Alive Infants Protection Act. This law demands that abortion clinics, hospitals and other places that provide abortions to issue appropriate medical care for a baby born alive after a failed abortion or purposefully birthed to "let die." It is also a federal felony to buy or sell human body parts. The punishment for this is up to 10 years in prison and/or a fine of up to \$500,000.

An abortion is supposed to put the mother first, but it seems that Planned Parenthood has it the opposite way by altering their methods of abortion to help them attain as many body parts and organs as they can from the fetus to then sell them.

O'Donnell brings up in the video how after an abortion she will hold the baby in her arms wondering, "could this baby have been our next president? At age 3, would this baby have liked to color and draw?"

I wonder that too, but I guess we'll never know.

Ghislaine Maxwell Sentenced To 20 Years In Prison

Update : Judge Nathan has sentenced Ghislaine Maxwell to 20 years in prison. "A sentence of 240 months is sufficient and no graver than necessary."

While preparing to deliver the sentence, Nathan said that "Ms Maxwell directly and repeatedly and over the course of many years participated in a horrific scheme" to traffic and abuse girls, and that "Ms Maxwell worked with Epstein to select young victims who were vulnerable." As such, a "substantial sentence" is warranted, which - if not released early, means Maxwell will be 80-years-old when she gets out.

And somehow not a single Epstein client was named...

Judge Alison J. Nathan said on Tuesday that Ghislaine Maxwell's

criminal activity was "extensive," and that she's enhancing her sentence due to the fact that she was at least 10 years older than her victims, and exercised "undue influence" on them.

The 60-year-old former socialite, who was arrested two years ago at a New Hampshire hideaway, was convicted in December in what accusers have called long-overdue justice for Epstein's victims.

Prosecutors have recommended 30 to 55 years behind bars - likely a life sentence, while Maxwell has asked for less than six years - arguing that she and her siblings were mentally and physically abused by their father, UK publishing tycoon and suspected Israeli spy, Robert Maxwell. She also



argued that she shouldn't bear the brunt of the punishment for Epstein's crimes, since he's dead.

Several victims who weren't part of Maxwell's trial will be allowed to

speak during Tuesday's sentencing in a Manhattan courtroom in front of US Circuit Judge Alison Nathan. Maxwell will also be afforded the opportunity to speak, should she so choose.

One of the victims expected to appear is Virginia Giuffre, who accused Prince Andrew of sexually abusing her. Giuffre and Andrew reached a settlement in a civil suit earlier this year, after she claimed Epstein "lent" her out for sexual abuse, a claim Andrew has denied.

"She made the choice to conspire with Epstein for years, working as partners

in crime and causing devastating harm to vulnerable victims," argued prosecutor Maurene Comey in the government's sentencing memo. "She should be held accountable for her disturbing role in an extensive child exploitation scheme

According to former UBS AG banker Justin Paperny, who served 18 months for securities fraud, Maxwell's arguments for leniency will likely fall on deaf ears, especially with several accusers testifying on Tuesday.

"The first thing judges want to know if you plead guilty is if you identify with your victims," he said, adding "In this case, Maxwell said 'Yeah, there are victims but I didn't create it. I didn't do anything wrong. It's just because I was friends with Epstein. If anything, I'm the victim,'" Paperny said. That attitude "doesn't sit well with a sentencing judge when there are victims whose lives have been torn and ripped apart by her pedophile friend."

Ten Senate RINOs Poised to Sell Out 4th & 5th Amendments to Get to the 2nd

Senate Majority Leader Chuck Schumer (D-N.Y.) could hardly contain himself. On Wednesday he rejoiced: "I am pleased Congress is on the path to take meaningful action to address gun violence for the first time in nearly 30 years. This bill is real progress. It will save lives." He has the support of 10 Republicans (In Name Only): Senators John Cornyn of Texas, Thom Tillis and Richard Burr of North Carolina, Roy Blunt of Missouri, Bill Cassidy of Louisiana, Susan Collins of Maine, Lindsey Graham of South Carolina, Rob Portman of Ohio, Mitt Romney of Utah, and Pat Toomey of Pennsylvania.

They all will violate their oaths of office in order to pass what is laughingly called the Bipartisan Safe Communities Act. It should be, and more accurately would be, called "The Bipartisan Fourth and Fifth Amendment Sellout Act to Destroy the Second Amendment."

For its primary purpose is to bribe states not already inflicting unconstitutional red flag laws on its innocent citizens with federal money — \$750 million to start with — so that eventually all of them will accept the bribe — the money along with the strings attached — so that there will soon be in place a de facto federal red flag law. Such laws, wrote Michelle Malkin at The New American, empower disgruntled strangers, duplicitous family members, biased police, and ideologically driven judges to disarm [innocent] citizens by labeling them mental health threats to themselves and others.

The unconstitutional nature of red flag laws was made clear by Nikki Goesser, executive director of the Crime Prevention Research Center. In an article co-authored by a Republican congressman who hasn't sold out



his constituents, Kentucky's Thomas Massie, Goesser said: "These laws allow judges to seize a person's guns without a trial, based solely on a written complaint that the person might be a danger to themselves or others. All a judge needs is "reasonable suspicion."

This contrasts with the provisions the Founders of our Republic put in place to prevent such violations of precious rights. The Fourth Amendment requires the much higher standard of "probable cause" instead of the much weaker "reasonable suspicion":

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Fifth Amendment requires "due process" against such illegal seizures: No person shall ... be deprived of

life, liberty, or property, without due process of law. Red flag laws, freed from those constitutional constraints, pose a direct and immediate threat to everyone who owns a firearm. As Malkin explained: "If you stray from the politically correct position on VA incompetence, guns, masks, vaccines, transgenders in sports, Drag Queen Story Hour, election fraud, demographic transformation, Black Lives Matter, or abortion, you and your children can be tagged, flagged and bagged for life. She understates the threat. The "reasonable suspicion" standard is so low that ultimately anyone owning a firearm could be "tagged, flagged and bagged" for that reason alone.

The "bipartisan" act is an indirect but effective attack on the Second Amendment. It has nothing to do with stemming gun violence. It has everything to do with confiscating, under the color of law, every firearm from every gun owner in the country, thus paving the way for the imposition of a communist dictatorship on the once-free United States of America.

There's obviously a lot of controversy at the end of last week between your administration and the White House. What do you make of the White House saying that the state reversed on child vaccines?

De Santis:

So the White House is lying about it. Haha, surprise! Not surprised that the White House would lie and definitely not surprised that legacy media would amplify the lie because that's what they do. say when you look at the trial, one of the things they did was they did not have babies or very young kids who had recovered from COVID in the trial. So we don't know what this will do for people that have recovered, but in their recommendation they are recommending giving the mRNA shot to people, young babies and kids that have already recovered from COVID. They don't have any clinical data on that.

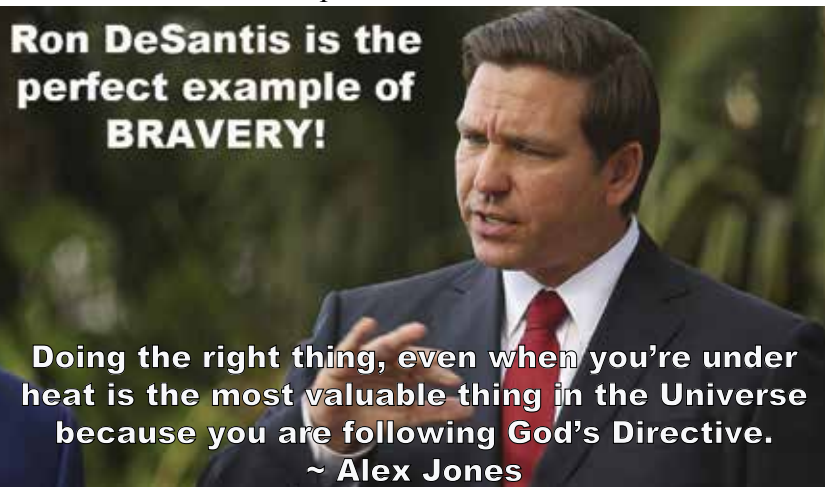

put a baby with an mRNA so that's why our recommendation is against it. That's different than prohibiting the use in Florida which we don't have the authority to do and quite frankly, you know, we're confident people can make their own judgments on it. But I would

And people have looked at some of this stuff and have recognized how that and you know what the White House is bragging that we're the only country that is trying to do mRNA shots for infants, and I'm just thinking to myself, well, wait a minute. Taking Sides: The Christian's Responsibility in Civic Affairs II

This is the second in a series of essays on the duty of Christians in civic affairs, adapted from Kevin Kookogey's weekly radio address and podcasts at AdvancingChurch.com

This week we begin our examination of questions from listeners.

Christians should be informed about politics, but should they really determine which political side is correct?

How can one claim that it is important for Christians to be informed about politics if the conclusion one draws from the information is deemed irrelevant or off limits? It is, after all, conclusions that lead one to act, and to act is to take sides.

We are not just watching a movie or playing a game here. It defies human reason to suggest that we inform ourselves about political matters without taking sides. It would be like telling someone it is important to read recipes but not make meals; to look at menus without ordering food; or to chew but not swallow.

The belief that our deepest convictions should not inform our political views is a manifestation of the endless effort to separate consequences from ideas. Yet politics are merely a practical means of implementing a body of beliefs about the human condition. And since our views about the human condition are informed by our religious beliefs, it is entirely appropriate for our Christian faith to inform our political views and lead us to decisions.

The suggestion that we not advise which side is correct presupposes the possibility of neutrality. But claiming neutrality on political issues is akin to saying one has no worldview – no beliefs – on political issues. Isn't the demand that we discuss the importance of politics while insisting on neutrality really just an attempt to silence opinions that differ from our own, or to avoid being put in the uncomfortable position of having to make one's views known?

Neutrality is a myth. If I claim moral relativism, for example, that there is no absolute truth, my claim presupposes that what I believe to be true (i.e., no objective moral standard) is more true, or closer to the real truth, than what you might believe (absolute truth). In doing so, I am not neutral. I am taking sides, attempting to distinguish my beliefs from yours, which only makes sense if

there is a standard beyond or outside of your beliefs and mine against which we can measure or compare the truth of our beliefs.

Scripture does not celebrate neutrality. Indeed, Jesus had some harsh words for the lukewarm. We're unlikely to be excused by failing or refusing to take a stand on issues, including political ones.

Is America a Christian Nation? Did our Founding Fathers intend to establish a Christian nation?

This line of inquiry is often used to suck unsuspecting Christians into a debate regarding Thomas Jefferson's Bible, what George Washington or Ben Franklin meant between the lines of their writings, or the various proofs of which founders were Christians, which were deists, and who might have been an atheist.

Indeed, scholars have devoted volumes to those details. The question, however, is not so much whether America was founded as a Christian nation. Christian, after all, is a personal rather than a national identifier, associated with one's beliefs about Jesus Christ. And while many of our founders were Christians, and while it is an undisputed historical fact that the American colonies were established, nurtured, and governed according to a moral order that was unapologetically rooted in Biblical principles for 150 years prior to our political separation from England in 1776, to focus on those particulars misses the point.

The subject hinges on understanding what our founders – those who drafted our founding documents and implemented our governing philosophy – believed about the nature of man and the duty of government. It is without question that our founders understood that absent a moral order – that is, order in the soul – there could be no order in the community. It was the permanent problems of the human condition that led our founders to structure an enduring Constitution, whereby men's tendencies to fraud, violence, ambition, and avarice could be restrained, without unduly limiting the liberties of the people.

These views were informed by the religious beliefs of our founders, many of whom were Christians, and all of whom acknowledged that Rights come from God, and that the role of government is limited to securing those God-given rights, as so plainly described in our Declaration of Independence.

How can Politics serve the Kingdom of God?

The answer lies not so much in explaining how politics can serve the Kingdom of God as in demonstrating that political power unchecked by the Church will always devolve into tyranny.

Regrettably, the American Church is in retreat, conforming to the culture and cooperating with the State, sometimes unwittingly, at the expense of our liberties and to the detriment of the entire social civil order.

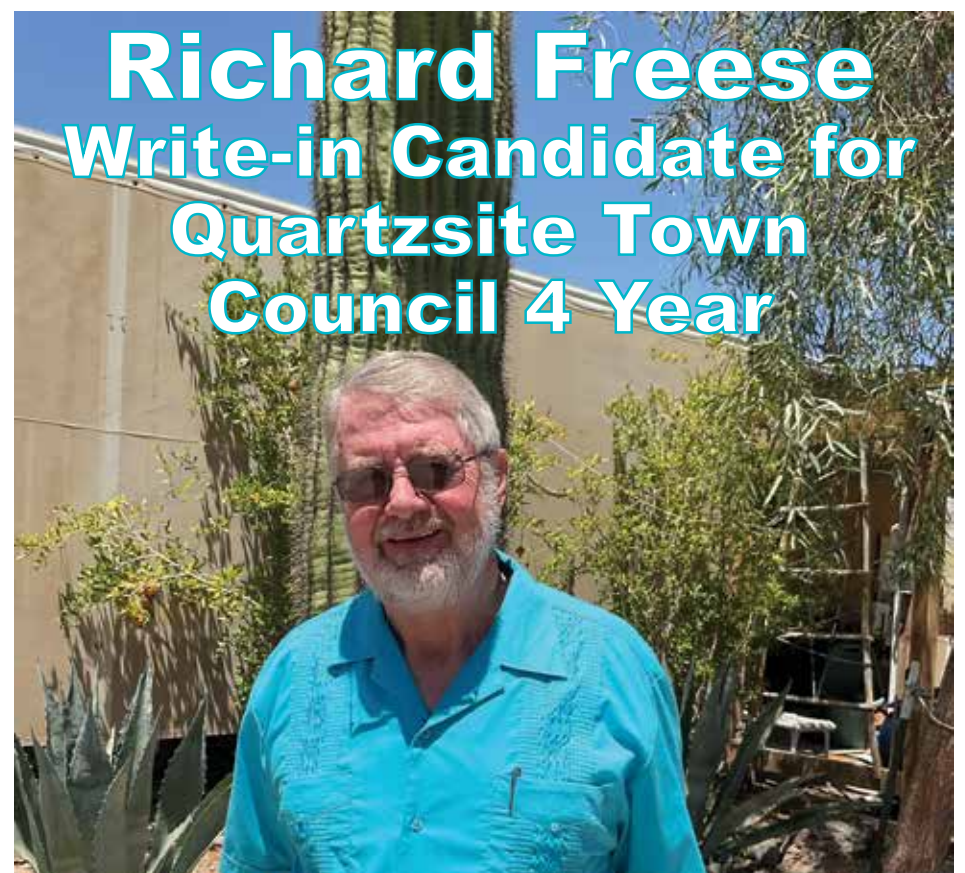
While some of this can be explained by ignorance, most of it is driven by fear. Fear of conflict. Fear of discomfort. Fear of persecution. Yet succumbing to fear is the surest way for the enemies of truth to prevail. And if we refuse to debate eternal truths in the political arena, is there any question whose agenda will be imposed?

Our duty is to preserve knowledge of God, a charge that necessarily puts us at odds with the world. Yet Jesus promised

that we would encounter conflict, opposition, and even death as we seek to fulfill the Great Commission. This is why Christ told his disciples that He was sending them like sheep among wolves, and that they would be persecuted and hated by everyone because of Him.

There is no avoiding it. The entire Bible is an account of God's people confronting kings, powers, rulers, and governments. Jesus promises that we will be brought before governors and kings, on His account, as witnesses to them and to other unbelievers.

Yet retreat is not an option. Jesus told Peter that He would build His church, and that the gates of Hell would not prevail against it. Because gates are defensive mechanisms, the implications of Christ's words are clear: The kingdom of God is on the advance, invading all of life, including the political arena. It is not, then, a question of whether one should engage in politics. Politics, as we have explained, touches everyone. **The only question is whose side are we on?**

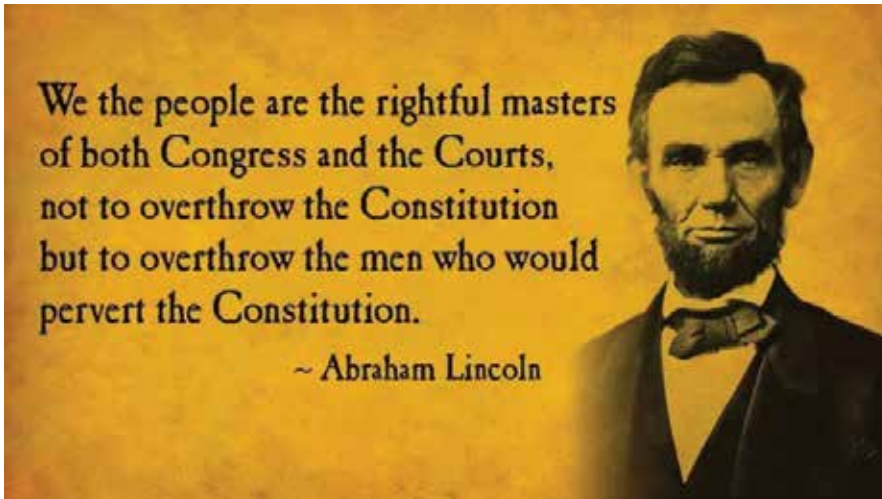

Global Warming: The Sacrifice of Sanity

News Item: Poll shows 65% of Americans favor action on Global Warming. This is hardly surprising, given the daily news reports vividly describing the various “sky is falling” scenarios threatening global devastation if we continue to maintain our standard of living through the use of fossil fuels. With story after story predicting doom, and next to nothing being said about the reality of the threat or the cost of the cure, it is understandable that people are demanding some kind of action.

The global warming “crisis” is a classic example of the Problem-Reaction-Solution principle employed by our rulers for countless generations to build popular support for the power they intend to misuse. The process is simple and foolproof: A problem is invented and dire predictions are widely and repeatedly publicized about its catastrophic consequences. The people are whipped into a frenzy of fear until they cry out: “Something must be done!” And just when all seems lost, the resolution appears, being provided, not entirely through coincidence, by inventors of the problem. Naturally, the solution is always effective because no problem can be more easily solved than one which never existed.

Nine hundred years ago the Altomec Indians of Central Mexico were grappling with a similarly grave predicament. Starting in mid summer, the days were becoming noticeably shorter, until in December, it seemed as though they would vanish altogether, hurling the people into perpetual darkness and cold. The brilliant solution to this dire situation was proposed by the Priesthood. Eager to elevate their prestige and power, they decreed that a ceremony wherein living hearts would be ripped out of the chests of captured enemy warriors as a

sacrifice to the sun god, would bring about a reversal of the sun’s decline. When implemented, this ceremony was 100% effective. It always produced the desired result, and the sacrifice of captured enemies did not seem like a high price to insure the tribes’ survival.

Unfortunately, the time came when no captured enemy warriors were available for sacrifice. The ritual,



now so important, could not be abandoned. It began to consume the tribes’ own people in growing numbers until it became a blood feast of unparalleled proportions. It is estimated that the lives of one million people were ultimately sacrificed to insure the return of summer.

Since we live in a more enlightened time, in which it is not politically correct to rip out people’s hearts on an altar dripping with blood, our handlers must content themselves by merely ripping the heart out of our economy. Nothing other than fossil fuels can lay claim as the “heart” of our civilization; as they propel all of our production, commerce, and growth. The ripping will start slowly at first, just a little tax here and some minor limits there, but as people become conditioned to sacrifice, more and more will be consumed to appease the “God of Global Warming”.

We have devoted tremendous effort and billions of dollars to the computer modeling of long range climate variation. Despite years of empirical data and banks of super computers, our ability to predict weather even 10 days out is only marginally better than chance. With this disappointing level of success it is absurd to think that we can predict trends never before seen hundreds of years into the future. This is hardly a rational basis for the formulation of

global economic policy.

There are plenty of real challenges to life on this planet if we want to address phenomena that have a proven existence outside of cyberspace. Meteor impacts, for example, have regularly wrecked environmental devastation on a massive scale, destroying over half of existing life forms in a single event. We have some technology to minimize this demonstrated danger, but it is ignored for the most part, perhaps because it does not offer the prospect of a massive bureaucracy with a global reach. Sadly, global warming restrictions will squander our wealth and drain our productivity without any return on investment, thus decreasing our ability to cope when a real crisis threatens.

We need to recognize global warming for what it is; a trumped up crisis manufactured by a virulent secular quasi-religious movement for the purpose of imposing its beliefs on the worldwide population by force of law. Global warming will never come, but the devastation it promises is knocking at our door.

What In The World Are They Spraying?

What would you say if you were told that airplanes were regularly spraying toxic aerosols in the skies above every major region of the world? That is exactly what a group of protestors were claiming outside of the annual American Association for the Advancement of Science (AAAS) meeting that was held in San Diego from February 18-22. However, inside the convention center was a different story. The scientists gathered to discuss the "plausibility" of implementing various Geo-engineering campaigns throughout the world, all under the guise that the Earth has a man-made global warming problem that can be solved in-part by spraying aerosol aluminum and other particles into the sky to block the sun. When these scientists were asked about the possibility of existing aerosol programs; they stated that no aerosol spraying programs have been implemented to date. A little confused? Why would protestors gather outside of a meeting making claims that world-wide aerosol programs were underway if scientists were only now discussing the possibility of implementing these programs? Could it be that one of these groups is being deceived?

Mauro Oliveira, the Webmaster of Geoengineeringwatch.org, was one of the protestors. He claimed that the program for Stratospheric Aerosol Geo-engineering (SAG), AKA chemtrails, has been well under way around the world. As a matter of fact, Oliveira stated that witnesses from around the globe claim that heavy aerosol spraying is occurring almost every day over just about every city. He went on to explain the difference between a contrail and a chemtrail. He stated that when a jet airplane flies at a certain altitude, a visible trail of streaks of condensed water vapor sometimes form in the wake of the aircraft. This is called a contrail. Contrails are normal and usually dissipate in a few seconds. They are very similar to when we breathe in cold weather. According to Oliveira, what occurs behind a SAG plane spraying aerosols is quite

different. What can be seen is a thick white line also called a chemtrail that lingers in the sky for several hours. The SAG lines are sprayed into the upper atmosphere and then spread out forming what then appear to be clouds. The particles from these aerosols then fall to the ground where they enter our soil and water and can also be inhaled.

Another group of protestors had traveled over 10 hours from a small



Shasta County community in Northern California. They became concerned about SAG when many from this community began to see dramatic changes not only in the sky, but also on the ground. Trees were dying, grass was not growing and many farmers were having difficulty getting any crops to grow on their farms. The crisis prompted biologists from the community to take action by testing the soil. The results were shocking. Aluminum, barium and other elements were found to be up to thousands of times higher than normal limits. Such high quantities lead to unhealthy PH levels in the soil which can be deadly to ecological life systems. These shocking results led to additional testing of Lake Shasta with samples from the Pit River arm tributary that tested over 4,610 times the maximum contamination level of aluminum allowed in drinking water in the state of California. Also, peer reviewed scientific studies conclude that bio-

available aluminum, now found in huge quantities in rain world-wide, is very harmful to flora and thus the eco-system. Ironically, these are the same substances the scientists are considering implementing in the various potential "future" aerosol spraying campaigns that were being discussed at the meeting.

A large number of other protestors became interested in SAG after experiencing burning eyes, migraine

headaches, anxiety, irregular heartbeat, high blood pressure and other health problems on days that airplanes were allegedly witnessed spraying aerosols in the sky. Deborah Whitman, Founder and President of the non-profit environmental organization Environmental Voices and also Producer of the documentary "Sky Lines" is no stranger to these symptoms. She has been hospitalized over 51 times on what she calls "heavy spraying days". Whitman has committed her life to helping people who claim to be experiencing similar problems resulting from aerosol spraying and gets calls from all over the U.S. in response to her website and documentary. Her recommended health tips can be found at www.environmentalvoices.org. Other indicators that possibly validate the claim that SAG is connected to health problems are the respiratory mortality rate, which has risen from eight on the list of mortality to third in the past five

years, and the fact that Alzheimer's and other illnesses linked to aluminum have continued to rise around the globe at astronomical rates since the inception of the alleged spraying.

The AAAS meeting hosted some of the world's leading geo-engineering scientists. With years of education and even more experience in their respective fields, the scientists looked at geo-engineering issues from many angles. Workshop subjects ranged from the effectiveness of geo-engineering to potential problems and even touched upon the issue of ethics. According to independent reporter Stewart Howe of Los Angeles, all of the scientists seemed to be looking for solutions to what they believe is the problem of global warming. Howe stated that the scientists appeared to be carefully weighing both the pros and cons of SAG when presenting potential campaigns to address the man-made global warming theory.

Many were actually advocating alternative methods to combat this issue due to the potential risks of SAG that include droughts, ozone depletion, less solar power, decimated weather patterns, military use of technology and other various environmental impacts. Howe said, "after witnessing the aerosol spraying for years, I was surprised by the discourse among scientists." As a matter of fact when asked about current SAG operations, leading geo-engineering scientist Ken Caldiera replied that he was unaware of any current aerosol spraying operations and when prompted to explain the long lingering trails left behind planes, he stated that they are simply normal contrails from jets.

David Keith, another leading scientist and expert in the field of geo-engineering, discussed the well-funded studies that have been conducted to predict potential future risks as well as benefits associated with geo-engineering. Some of the potential benefits include a cooler planet, and the reduction of melting sea ice and rising sea levels. Keith discussed what aerosol particles would be most effective in achieving the stated goals of the SAG program. He

Arizona School Superintendent Given a \$1.7 Million Bonus

A school superintendent in Maricopa County, Arizona made \$1.7 million in extra compensation from 2016 to 2021 on top of her \$189,000 annual salary, according to a report from the Arizona Auditor’s Office. This sum was hidden from taxpayers, parents, and district employees.



The money was not listed on the employment records of Dr. Kristi Wilson, superintendent of the Buckeye Elementary School District, made up of eight schools and nearly 5,500 students.

Parents and teachers are angry that this lavish compensation package was hidden from them while the school district claimed to be in rough financial shape, according to

Maria Moreno, a first-grade teacher and President of the Buckeye Education Association, said, “I think we all just felt very betrayed in a sense because we believed there was no money for raises, yet she was getting a very good compensation package, compared to teachers and staff in the district,” according to AZ Family.

The Buckeye Education Association petition calling for Dr. Wilson’s resignation has over 500 signatures.

The school board defended the extravagant additional compensation, claiming that these were payroll deductions sent to the Arizona State Retirement System. They also claim the level of compensation is necessary to attract and retain top talent.

COVID Vaccine Harms: Hearing Problems, Central Nervous System Disorders, Blistering Diseases Possibly Linked to COVID Shots

Last week on The HighWire, we discussed a whole slew of ‘next generation’ vaccine harms showing up in the medical literature now being associated with COVID shots.

While much of the corporate media reporting and public health agencies have only allowed basic adverse events [mild harms] like fever, chills and a sore arm to be communicated to the public, presumably in order to not harm efforts at vaccine compliance, a much larger breadth of possible, more serious harms are perhaps a more accurate depiction of reality.

Pfizer CEO Albert Bourla, in a recent interview admitted that mRNA technology was essentially a failed, unproven technology “that never delivered a single product.” He continued by saying he “was surprised when they suggested to me that this was the way to go [as the choice for his company’s COVID vaccine candidate]”.

Now here we are, nearly a year and a half after Pfizer’s mRNA shot was EUA-approved and the medical literature is beginning to state passages like this: Up to now, more than 1000 peer-reviewed studies evidence a multitude of adverse events in COVID-19 vaccine recipients. Such studies report severe adverse reactions following vaccination, including thrombosis, thrombocytopenia, myocarditis, pericarditis, cardiac arrhythmias, nervous system disorders and other alterations.

This letter to the editor in The Scandinavian Journal of Immunology on March 17, 2022 has come at a time when several other medical journals around the world are allowing new findings of serious COVID vaccines harms to be published.

An article in Neurological

Sciences has arranged a ‘spectrum of neurological disorders’ flow diagram to catalog and track “a wide spectrum of neurological complications is continuously being reported following COVID-19 vaccination” the article states.

Coming into focus is a next generation of possible COVID harms given developing signals focusing on autoimmune activation particularly around the central nervous system

(CNS) and various body membranes and linings. In April 2022’s Pathology - Research and Practice a case report titled Autoimmune mucocutaneous blistering diseases after SARS-Cov-2 vaccination states “Cases of severe autoimmune blistering diseases (AIBDs) have recently been reported in association with the severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) vaccination.”

This week, in The WHO Pharmaceuticals Newsletter, the organization has announced that monitoring from Sweden’s Uppsala Monitoring Centre (UMC) identified hearing loss (including sudden cases) and tinnitus following COVID-19 vaccination. “...there were 164 unique individual case safety reports (ICSRs) which reported ‘hearing losses’ (MedDRA High Level Term, HLT), and 367 ICSRs which reported ‘tinnitus.’” The reports came from 27 countries, including Italy, the United Kingdom and

the United States. More than a third were reported among those working in the healthcare industry.

In early March 2022, longtime vaccine researcher Gregory Poland, MD opened up about his struggle with ‘life-altering’ tinnitus after both his second and booster COVID shot.

Poland believes there may be tens of thousands of people affected in the U.S. and potentially millions worldwide.

He feels strongly that more research should be done to determine what caused these symptoms and what can be done to help people desperate for relief. writes Medpage Today.

“What has been heartbreaking about this, as a seasoned physician, are the emails I get from people that this has affected their life so badly, they have told me they are going to take their own life,” Poland said.

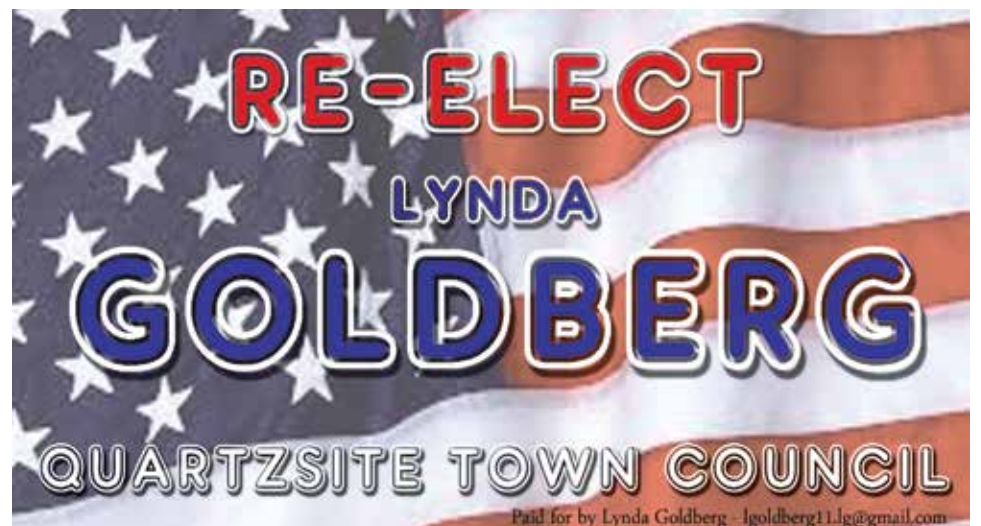
So far in the U.K., their yellow card vaccine safety monitoring

for COVID shots have tallied a total of 7,287 tinnitus reports after vaccination.

In the U.S., more than 13,000 reports of tinnitus have been reported to the passive VAERS data monitoring.

Meanwhile, in this new chapter of vaccine-associated changes, previous fact-checked and debunked issues are now being overturned as relevant. Take for instance changes in menstrual cycles, a safety endpoint that was not tracked during COVID clinical trial phases. It took massive grassroots pushback from the public to get independent individuals to take it seriously enough to begin data monitoring without the help or recognition of regulatory bodies.

In January 2022, nearly 5 months after it was widely reported as a possible safety signal, the National Institutes of Health’s website now reports on findings from a new study of nearly 4,000 women using a fertility tracking app, that women may have a slightly longer menstrual cycle after COVID-19 vaccination while receiving two vaccine doses within the same menstrual cycle increased the cycle length further—about two days on average. The NIH states, “the longer menstrual cycles after vaccination decreased in subsequent cycles, suggesting they are likely temporary.”



Vaccine Shedding Finally Proven!

Do vaccinated people shed their vaccine byproducts to us? We definitely, for sure, knew that vaccine shedding was not a thing, because “health experts and fact checkers” told us so. And we “believe science” and our “health experts”. Right?

Except that it is **WRONG** and vaccine shedding has just been proven by science!

Even I believed that there was no plausible mechanism for vaccine shedding. I thought that it was a baseless conspiracy theory. Stupid me. It turned out that I **WAS WRONG** and vaccine shedding is real and can be measured. A study “Evidence for Aerosol Transfer of SARS-CoV2-specific Humoral Immunity” was just released.

Evaluation of samples in this fashion revealed that high intranasal IgG in vaccinated parents was significantly associated (p-value = 0.01) with a 0.38 increase in the log transformed intranasal IgG gMFIs within a child from the same household (Fig 1F). Let me try to explain it. First,

these scientists from the University of Colorado looked at face masks, worn by vaccinated health care workers. They found that those workers shed antibodies generated by vaccination, and some antibodies got trapped in the masks and could be detected. This means that vaccinated people are literally “shedding” vaccine-caused antibodies.

Interested in that, scientists looked further: they compared unvaccinated children living with unvaccinated parents, to similarly unvaccinated children, but living with vaccinated parents.

It turned out that vaxxed parents actively shed vaccine-produced particles onto their children so that the kids acquired “humoral immunity” following shedding from their parents! Not only was this finding evident in the data, it actually was **STRONGLY** statistically significant with a

p-value of 0.01! This means that this was not a chance finding.

It remains to be explained **WHY** children have intranasal IgG. The authors seem to think that it is

because of antibody shedding via droplets. In other words, they seem to propose that what is transferred is IgG itself in saliva droplets. They may

be right. That said, there is a possibility that children **DEVELOP** intranasal IgG because other vaccine byproducts or exosomes are being shed.

It could even be due to lipid mRNA nanoparticles themselves shed and being transferred via saliva, like a virus. In fact, considering two replies to this article that I quoted at the bottom, mRNA lipid nanoparticle shedding is most likely. Why? Because the responders report experiencing **STRONG IMMUNE REACTIONS**.

Such byproducts would be **CAUSING** intranasal IgG in

children as an immune reaction in children, rather than those IgGs being essentially mechanically spat from parents onto their children. The article, while very interesting, is only the first step in researching vaccine shedding and I hope that further light will be shed (pun intended) on this phenomenon!

The authors, possibly in hopes of getting their article approved by science censors, call it a good thing: Our results suggest that aerosol transmission of antibodies may also contribute to host protection and represent an entirely unrecognized mechanism by which passive immune protection may be communicated. Whether antibody transfer mediates host protection will be a function of exposure, but it seems reasonable to suggest, all things being equal, that any amount of antibody transfer would prove useful to the recipient host.

I am not sure if I can call it a good thing myself. Antibodies or mRNA nanoparticles from vaccines **NOT** approved by the FDA for children are being shed from parents to children, without consent or knowledge of either parents, or children. All of this is followed by denials by authorities.

Most Endangered River Provides Water to 40 Million People ‘We are 150 feet from 25 million Americans losing access to the Colorado River’

At a June 14 Senate Energy and Natural Resources Committee meeting, environmentalists warned that the Colorado River’s reservoir level drop might bring dramatic cuts to water deliveries provided to the seven states dependent on the river.

Those states are Colorado, California, New Mexico, Utah, Wyoming, Arizona and Nevada. Alarming, given its importance, the conservation group American Rivers ranked the Colorado as No. 1 on its list of the nation’s most endangered rivers.

Bureau of Reclamation Commissioner Camille Calimlim Touton told the committee that maintaining “critical levels” at the largest reservoirs in the U.S. – Lake Mead and Lake Powell – will require large reductions in water deliveries. Touton advised the committee that, in the next two months, her agency is negotiating with the seven states that count on the Colorado River to develop a plan for apportioning the water supply reductions. The Reclamation Bureau is the federal agency charged with assisting the western states, Native American tribes and others to meet water needs. An estimated 40 million residents throughout the region rely on the Colorado River for water.

The committee’s witnesses were unanimous in their predictions that



acute water shortages are in the near-term future. John Entsminger, the Southern Nevada Water Authority’s general manager, said that the slow-motion train wreck that’s been accelerating for 20 years has created “the moment of reckoning.” Said Entsminger, “We are 150 feet from 25 million Americans losing access to the Colorado River, and the rate of decline is accelerating.”

Because the Western United States is suffering through a relentless drought, analysts predict that next year the affected states will cope with a decrease of between 2 million and 4 million acre-feet of water. Scientific American reported that 2021’s exceptionally dry year created a record-breaking drought, or mega-drought. The last 20 years have been the driest two decades in the last 1,200 years. To date, 2022 is the driest year on record in California. Researchers predict with a 94 percent degree of certainty that California’s drought will continue for at least one

more year.

University of Colorado, Boulder climate scientist Imtiaz Rangwala has observed drought conditions increasingly worse in the western and central U.S. “The last two years have been more than 2 degrees Fahrenheit (1.1 Celsius) warmer

than normal in these regions. Large swaths of the Southwest have been even hotter, with temperatures more than 3 F (1.7 C) higher.” But neither during the hearing nor in the media write ups was population growth in the seven western states mentioned. The 2000 populations for Colorado, California, New Mexico, Utah, Wyoming, Arizona and Nevada

were 4.3 million, 33.9 million, 1.8 million, 2.2 million, 494,000, 5.1 million and 2 million, respectively. And in 2022, the states’ populations are, respectively, 5.8 million, 39.5 million, 2.1 million, 3.3 million, 579,000, 7.6 million and 3.2 million. In slightly more than two decades, about 12 million more people have become dependent on the Colorado River for water.

The link between more people and more water consumption is undeniable. Yet Congress, the White House, the media and academia refuse to have a rational discussion about reducing the flow of 1 million-plus legal immigrants which, with their offspring, drive population increases. Knowing that the nation’s western states are in a water crisis, opening the border to millions, as the Biden administration is doing, is ecological suicide. Nevertheless, the status quo on adding population continues on autopilot, consequences be damned.

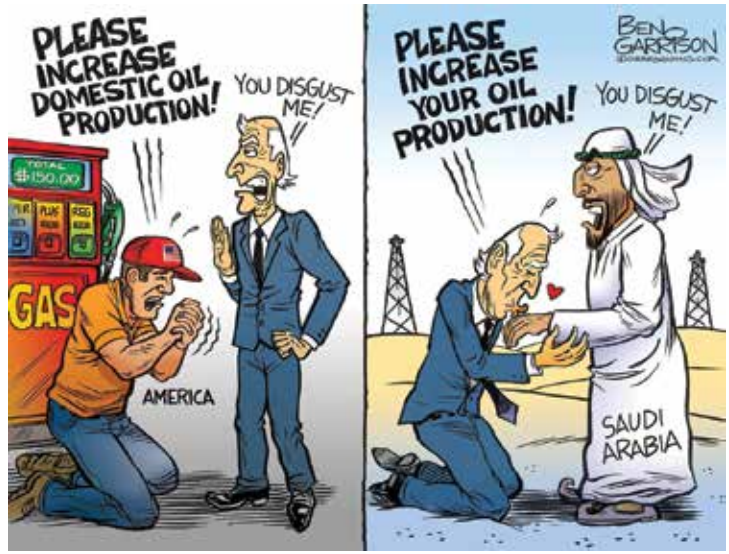

Centers for Disease Control Paid \$420,000 to Track Tens of Thousands of Citizens During Lockdowns

The Centers for Disease Control and Prevention spent \$420,000 to buy location data from tens of millions of Americans' phones to track them, Vice (vice.com) reported.

The CDC bought the location data to "perform analysis of compliance with curfews, track patterns of people visiting K-12 schools, and specifically monitor the effectiveness of policy in the Navajo Nation," according to Vice. The government agency also used the data bought because of Covid-19 for general CDC purposes.

SafeGraph, a controversial data broker, sold the data to the CDC. The information was aggregated location data, but some researchers

claim that data can be de-anonymized and used to track specific people.

Motherboard, a Vice division, obtained documents regarding the



use of this data from a Freedom of Information request to the CDC. The CDC claimed it used the data for monitoring curfews and tracked visits to pharmacies for vaccine

monitoring.

In truth, documents revealed that it established 21 "potential CDC use cases for data," Vice reported. These use cases include tracking

visits to K-12 schools, the correlation between mobility patterns data and Covid-19 cases, and the effectiveness of public policy on the Navajo Nation, according to Vice.

The CDC requested the expedited purchase of this data because of Covid-19. However, many cases that the CDC

created have nothing to do with covid, like "Research points of interest for physical activity and chronic disease prevention such as visits to parks, gyms, or weight management businesses."
