More on the Political Shenanigans in Qz!

Let's revisit town code 30.09(b) that eliminated residents: Dennis Vosper, Sam Saxton, Mike Roth and later Steve Schue from being on the ballot for the Primary election. Not only was this code found to be unlawful in the Ed Foster case, it was used again 11 years ago and the Parker Pioneer had this to say about it.

Christina Kohn, an attorney with the Scharf-Norton Center for Constitutional Litigation, has written a scathing critique of the Town of Quartzsite for the Goldwater Institute Daily. In the piece, she calls the town's election rules "unlawful." Here is the piece in full.

The Town of Quartzsite, Arizona, recently used unlawful restrictions to limit the choices of voters in a town council recall election. Quartzsite Ordinance 09-15 prohibits otherwise qualified candidates from running for council if they owe the town money. This might sound like a good idea – who would oppose a ban on debtors

running their town? But in reality, this ordinance has been used to insulate the seats of current council members and prevent potential opponents from running for office.

The March 8 recall election was no different. Voters were asked whether they wished to recall five of Quartzsite's six council members, but the council limited the options for replacement council members. At least three potential candidates were prevented from campaigning for seats under the ordinance. In at least one case, evidence establishing a candidate's debts to the town is questionable. But the ordinance hasn't harmed a current council member, initially appointed to fill a vacancy and a target of the recall, who appears to owe the town a substantial amount of tax money.

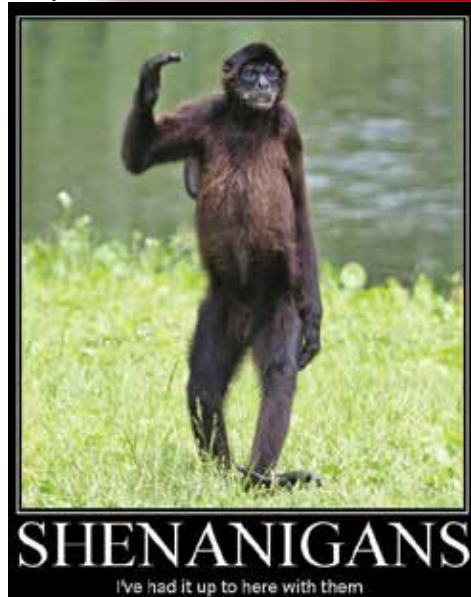
This is why limitations on who may run for local office are set at **the state level**. Allowing current politicians to limit their potential competition is the proverbial fox guarding the henhouse. An Arizona statute, A.R.S. § 9-232, establishes the qualifications for council candidates. A council member must be at least 18 years old and a qualified elector living in the

town for at least a year. State courts have recognized that **towns cannot set qualifications beyond those established by this statute.**

If Quartzsite thinks it is a good idea to place additional limits on who may run for town council, it should persuade the Legislature to pass a new law with those limits. Otherwise, it should **repeal the unlawful ordinance** and in the next election let the voters decide who among any of the qualified candidates they believe will best represent them."

Back to current day, 2022. The election results show that removal from the ballot was indeed successful. The candidates who were booted and forced to run as write-in candidates would have received far more votes if they would have been on the ballot.

The town government in Quartzsite is reflecting the problem we have federally. Sheriff Mack in another interview reminds us that the Federal Government only has 5 delegated powers.

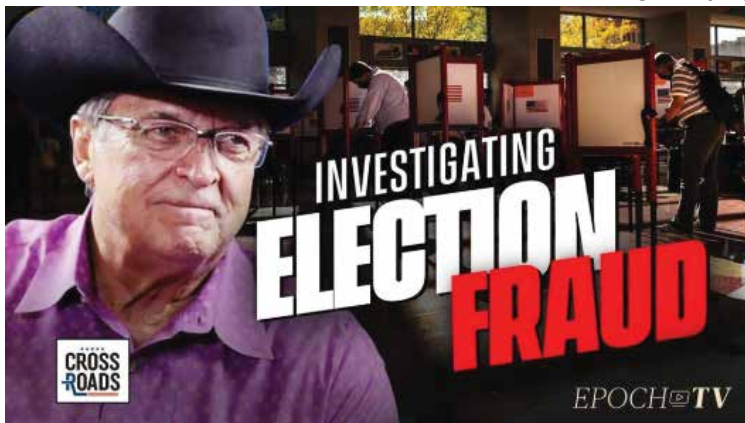
- 1) Treason - Don't you wish the FBI would investigate and prosecute Treason?

Amendment I: Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.

Amendment II: A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear arms, shall not be infringed.

Amendment III: No soldier shall, in time of peace be quartered in any house, without the consent of the owner, nor in time of war, but in a manner to be prescribed by law.

Amendment IV: The right of the people to be secure in their persons, houses, papers and effects against unreasonable searches and seizures,

shall not be violated and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched and the persons or things to be seized.

Amendment V: No person shall be held to answer for a capital or otherwise infamous crime, unless on a presentment or indictment of a grand jury, except in cases arising in the land or naval forces or in the Militia, when in actual service in time of war or public danger, nor shall any person be subject for the same offense to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, not be deprived of life, liberty or property, without

due process of law; nor shall private property be taken for public use, without just compensation.

Amendment VI: In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the state and district wherein the crime shall have been committed, which district to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the assistance of counsel for his defense.

Amendment VII: In suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise re-examined in any court of the United State, than according to the rules of the common law.

Amendment VIII: Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted.

Amendment IX: The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.

Amendment X: The powers not delegated to the United States by the Constitution, nor prohibited by it to the states, are reserved to the states respectively, or to the people.

Connecting the Dots on the Rockefeller Medical Tyranny

How Rockefeller medicine and the medical tyranny of current day created the vaccine cabal and the medical criminality surrounding Covid.

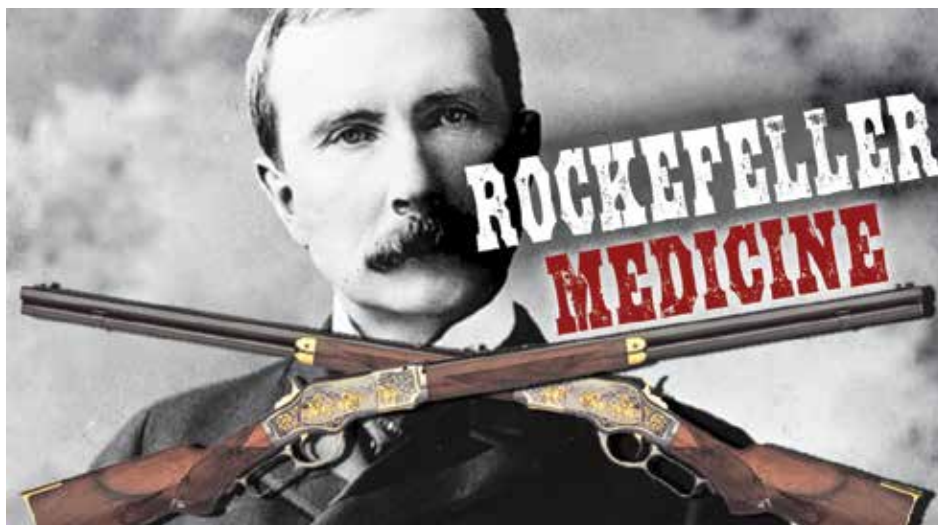
The medical profession was vanquished 112 years ago by John D. Rockefeller, who became the world's first billionaire by founding Standard Oil in 1870.

In 1902, Rockefeller funded the establishment of the General Education Board, through which he intended to control public education. Other oil-backed schemes to mold and reshape the American education system followed, including a scheme to alter the teaching of American history to promote a view of collectivism, as well as a program culminating in the transformation of the practice of medicine.

Naturopathic-based herbal medicine was the norm at that time, and Rockefeller set out to shift the medical industry toward using oil-derived pharmaceuticals. To this end, the Rockefeller Institute for Medical Research was established in 1901, headed up by Simon Flexner.

Simon's brother, Abraham Flexner, a teacher who had no medical background, was contracted to write a report on the state of the American medical education system. This study, The Flexner Report, published in 1910, paved the way for Rockefeller to completely overhaul the American medical system.

The Flexner Report laid the foundations of the modern medical system, dubbed "Rockefeller medicine". Flexner visited all 155



schools of the healing arts that existed at that time and issued a detailed report in 1910 — Medical Education in the United States and Canada. This called for major reforms to medical education, including higher admissions standards for students, adherence to their perspective of scientific method in research, practice, and oversight by state licensure boards." Thus, Flexner proposed a total restructuring of American medical education, and he specifically mentioned that the eradication of "dissidents" is a positive thing. He framed the need to restructure and standardize medical education as a "public need" with the Carnegie and Rockefeller interests being the implied guardians of the public needs.

As a result of the Report — that incidentally perfectly served the financial interests of the Rockefellers — new requirements were introduced, and a very large number of existing medical schools had to get out of the way and close. The reform especially impacted the schools graduating predominantly African American doctors and the schools teaching what is known today as "alternative medicine", even though they are the original/traditional methods of "doctoring."

According to Wikipedia, "Flexner clearly doubted the scientific validity of all forms of medicine other than that based on scientific

research, deeming any approach to medicine that did not advocate the use of treatments such as vaccines to prevent and cure illness as tantamount to quackery and charlatanism."

Naturopathic and homeopathic medicine — anything that couldn't be patented — was abolished. Natural remedies and known cures were dismissed as quackery. The only medicines deemed and promoted as reputable were patentable synthetic drugs, invented in the oil cartel's own research centers.

Medical schools that offered training in various disciplines including electromagnetic field therapy, phototherapy, eclectic medicine, physiomedicalism, naturopathy, and homeopathy, were told either to drop these courses from their curriculum or lose their accreditation and underwriting support. A few schools resisted for a time, but eventually most complied with the Report or shut their doors."

Abraham Flexner is considered the 'father' of modern medical education.

In the spirit of eliminating competition, the fields of holistic medicine that were previously regarded as "normal" in society, became artificially discredited — which cleared the markets for the Rockefeller interests through the promotion of oil-derived medications and Rockefeller education-shaped doctors who felt that they were "smarter" than the so called "quacks" because their professors told them so.

In the case of Rockefeller's empire, oil development, much like every other method of modern energy production, old or new, is very destructive. The Rockefeller Legacy of Monopolized Control

Around the same time, the oil cartel also found a way to take over and control the U.S. financial system, through the creation of the Federal Reserve, established in 1913. The Rockefeller's have been powerbrokers in the banking industry ever since. In the 1950s, James Stillman Rockefeller, the grandson of John D.'s brother, became the head of National City Bank, while David Rockefeller, John D.'s grandson, took over Chase Manhattan Bank.

They also sought to consolidate control over the global food supply, using philanthropy as their cover for the takeover. The Rockefeller Foundation funded

The Serotonin-Depression Myth & Facing the Culture That Promoted It

The headlines have rung like a bell through popular culture and a public with fleeting trust in a medical-industrial-complex. A once sacred cow, settled science in the industry was that depression's cause was a brain chemical imbalance problem. The chemical?.... Serotonin – and Big Pharma's decades long answer was a class of chemicals called Selective Serotonin Reuptake Inhibitors (SSRIs).

During the 1950's, and more intensively in the 1960s, a serious search for 'the molecule' behind depression was ongoing. Despite no consensus on the antidepressant-like effects of the serotonergic theory, based on a deficit of serotonin in certain brain regions, several drugs were introduced on the market after 1957.

One supercharging effect happened when the pharmaceutical company Eli Lilly, eventually of Prozac fame and fortune, created their 'serotonin-depression study team' in the early 1970s. The results were predictable with the eventual creation of Prozac leading the world on a wild goose chase for the elusive serotonergic phantom.

A popular selling point of these newer classes of drugs was a lower adverse event profile. However, since its approval, a laundry list of harms are now associated with SSRI drugs and particularly, Prozac.

The US Food and Drug Administration approved Prozac in 1987. With Prozac becoming the first approved SSRI, it quickly became one of the most prescribed antidepressants in the world. Raising Eli Lilly's worldwide annual sales to the \$2 to \$3 billion range. Its patent expired in 2001 and the rise of competition from other pharmaceutical companies hit like a hungry wave to chomp away at a red hot SSRI market share.

Edward Shorter writes in the British Journal of Psychiatry in 2014, "The uptake of Prozac became almost a cultural phenomenon, comparable with the fashion for high protein and low-carbohydrate diets to lose weight: 'Washington City full of Prozac', headlined the New York Times in 1994 City full of Prozac. Just imagine. I am not aware of comparable historical claims for any other pharmaceutical agent, penicillin included." Shorter explains the reasoning for this meteoric rise writing, "How do we account for

this success? It was partially a result of relentless marketing, undertaken with an intensity not hitherto seen in pharmaceuticals. By 1993, Lilly had 1600 sales representatives in the field in the USA, surpassed only by SmithKline Beecham's 1800 reps for Paxil..."

Pump the brakes...hard.

Just published in the Journal Molecular Psychiatry, The serotonin theory of depression: a systematic umbrella review of the evidence looks at the principal relevant areas of research on the still influential serotonin hypothesis of depression. The researchers write, "The main areas of serotonin research provide no consistent evidence of there being an association between serotonin and depression, and no support for the hypothesis that depression is caused by lowered serotonin activity or concentrations. Some evidence was consistent with the possibility that long-term antidepressant use reduces serotonin concentration."

The authors conclude: "Our comprehensive review of the major strands of research on serotonin shows there is no convincing evidence that depression is associated with, or caused by, lower serotonin concentrations or activity." The researchers leave readers with this final paragraph in their analysis: "This review suggests that the huge research effort based on the serotonin hypothesis has not produced convincing evidence of a biochemical basis to depression. This is consistent with research on many other biological markers. We suggest it is time to acknowledge that the serotonin theory of depression is not empirically substantiated."

It is important to note that their study did not look at the effectiveness of antidepressants directly. Meanwhile, a companion article written by two of the study's authors and published in The Conversation states, "It is important that people know that the idea that depression results from a 'chemical imbalance' is hypothetical. And we do not understand what temporarily

elevating serotonin or other biochemical changes produced by antidepressants do to the brain. We conclude that it is impossible to say that taking SSRI antidepressants is worthwhile, or even completely safe."

The statement sent shockwaves through the egos and pocketbooks of SSRI cheerleaders everywhere causing The Conversation to take swift action publishing the article titled Depression: low serotonin may not be the cause – but antidepressants still work the very next day.

Despite grabbing worldwide headlines, many in the scientific community came out after the research was published to claim they already knew about the debunked serotonin hypothesis. Meanwhile, the public has been left to still believe the leftover 'chemical imbalance' propaganda never fully corrected or atoned to by the collective professional body of psychiatrists. To

add more confusion to the mix, psychiatrists still regularly dole out large numbers of SSRI prescriptions and promote their use.

A patient's informed consent in this pharmaceutical fog of war, not possible.

Research put the global antidepressants market size at \$11.67B in 2019 – before the mental health crisis fallout

from the lockdown pandemic response. 27.4% of that market share is from SSRI drugs while another 22.6% comes from serotonin and norepinephrine reuptake inhibitors (SNRIs).

One lesson here is when it comes to public health or mental health interventions, the public, to their detriment, will be the last to know of any true harms related to them. Perhaps the biggest lesson from the findings and public release of this recent systematic umbrella review essentially debunking the serotonin hypothesis serves to show how so many have failed to understand the chokehold pharmaceutical money and influence has on the media, government regulators, medicine, research and journals. For example, in 2000 Dr. David Healy was on his way to a faculty and clinical position at the University of Toronto's Centre for Addiction and

Mental Health (CAMH) when he gave a lecture "criticized pharmaceutical companies for avoiding experiments that could demonstrate problems with their drugs, and for not publishing unfavorable results. He said the data show that Prozac and other popular antidepressants in the same chemical family may have been responsible for one suicide for every day they have been on the market." wrote Science Reporter in 2001.

A week later, his position offer was rescinded by the University's Centre. Eli Lilly was "lead" donor according to the CAMH website at the time, contributing more than \$1-million to the centre's \$10-million capital-fundraising campaign.

Back then, destroying careers and pulling funding from professionals for giving well-deserved bad press to their product lines was still something the public thought was a conspiracy theory. A slow drip of truth was allowed to reach the public over the last decade yet its effects were slow to change both the prevailing consciousness around the serotonin theory myth still influential – until now.

"Mild to severe depression might be better treated with alternatives to antidepressant drugs, which do not help patients much more than an inactive placebo, researchers said Tuesday" Reuters.com

"Is depression caused by a chemical imbalance? There's actually little evidence supporting this widespread belief, which was heavily promoted by the drug companies." TheWeek.com

"...depression isn't caused by a chemical imbalance, we don't know how Prozac works, and we don't even know for sure if it's an effective treatment for the majority of people with depression." Qz.com

****WARNING:** Coming off your medication can cause antidepressant withdrawal – and could set you up for a relapse of depression. In a Harvard Medical School study, nearly 400 patients (two-thirds of them women) were followed for more than a year after they stopped taking antidepressants prescribed for mood and anxiety disorders. Participants who discontinued rapidly (over one to seven days) were more likely to relapse within a few months than those who reduced the dose gradually over two or more weeks.

Bombshell: Russia Accuses Democrat Party Globalists of Creating, Unleashing COVID-19

Russia's Ministry of Defense accused the U.S. of creating and unleashing COVID-19 upon the world to benefit the Democratic Party and Big Pharma. "The Ministry of Defense of the Russian Federation continues to analyze the military and biological activities of the US and its allies in Ukraine and elsewhere in the world in the light of new information obtained in the liberated territories," Russia's Chief of Radiation, Chemical and

Russia suggested COVID was also a product of biological research due to the pandemic appearing to be "artificially fueled" by new variants in different parts of the world.

According to our experts, this is evidenced by the uncharacteristic variability of the genovariants that cause different peaks in the incidence of coronaviruses, significant differences in lethality and contagiousness, uneven geographical distribution, and the unpredictable nature of the epidemic process as a whole. It appears that despite efforts to

contain and isolate the disease, the pandemic is being artificially fuelled by the introduction of new variants of the virus in a particular region.

Russia claimed

the U.S. Agency of International Development's (USAID) emergency response measures to the pandemic and the 2019 coronavirus simulation exercise called Event 201 bolster its argument that the U.S. intentionally created COVID-19. Characteristically, in 2019 – before the first COVID-19 cases appeared – the US Johns Hopkins Institute hosted an exercise called 'Event-201', which practiced dealing with an epidemic of a previously unknown coronavirus, which, according to the legend of the exercise, was transmitted from bats to humans via an intermediate host, pigs. This is how the 'Spanish flu' virus, which has killed tens of millions of people, became pandemic.

The implementation of the COVID-19 scenario and USAID's emergency wind-down of the Predict programme in 2019

suggest the deliberate nature of the pandemic and US involvement in its emergence.

Additionally, Russia claimed it seized documents during its special military operation in Ukraine revealing USAID contractor Labyrinth Ukraine was conducting biological weapons research in the country — specifically related to coronavirus and monkeypox.

During the special military operation, documents were seized indicating that USAID and its main contractor, Labyrinth Ukraine, have been participating in the US military bioweapons programme since 2019.

Labyrinth Ukraine took part in UP-9 and UP-10 projects, which studied the spread of African swine fever in Ukraine and Eastern Europe.

I would like to point out that as part of the US Department of Defense's biological threat reduction programme, one of Labyrinth Global Health's research areas has been the study of coronaviruses and monkeypox virus.

Not only that, Russia claimed Ukrainian soldiers were involuntary subjects of that research, citing blood samples from captured soldiers revealing narcotic drugs and "high concentrations of antibiotics were

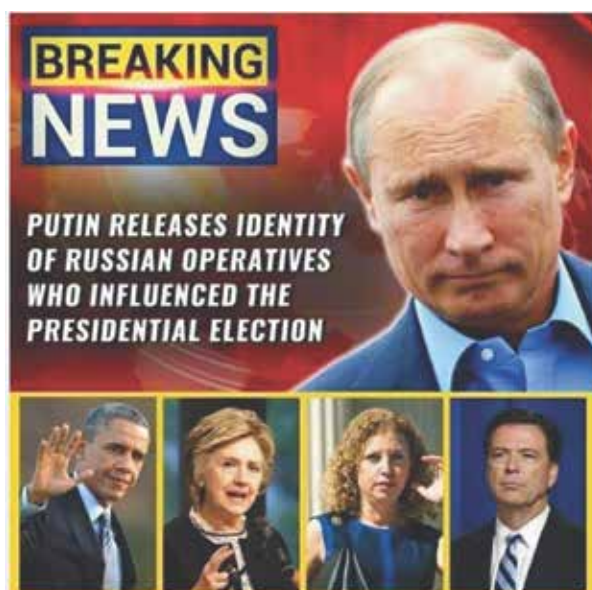
found in their blood, as well as immunological markers indicative of exposure to the renal syndrome and West Nile pathogens."

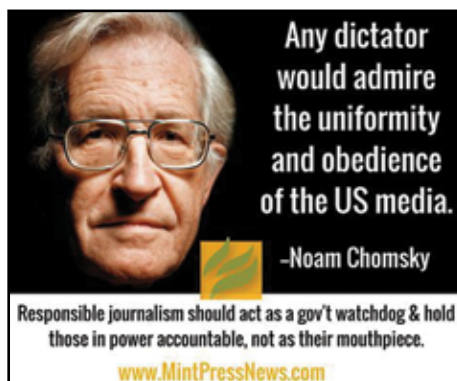

The FBI has Raided President Trump's Home

According to the New York Times, the search has to do with materials taken home by President Trump after he left the White House.

The search, according to two people familiar with the investigation, appeared to be focused on material that Mr. Trump had brought with him to Mar-a-Lago, his private club and residence, after he left the White House. Those boxes contained many pages of classified documents, according to a person familiar with their contents.

Mr. Trump delayed returning 15 boxes of material requested by officials with the National Archives for many months, only doing so when there became a threat of action being taken to retrieve them.

The politics of the search can't be ignored. If the New York Times is to be believed, Trump's purported crime - the delay of returning materials that may be classified - could have been resolved in another manner that didn't involve raiding his home and breaking open a personal safe. No doubt the search is an escalation by a desperate Regime confronted by their own failures at home and abroad.

What about the relation of the search to January 6? I've gone back and forth as I've written this, but it's

certainly possible they were also after documents related to January 6. There are no guarantees, considering the politicization of Biden's DOJ, which has thus far protected friends in politics, the killer of Ashley Babbitt, supporters in academia, and President Biden's own corrupt son.



One can be certain, however, that if the Biden Administration will carry out this raid, then it will also be aggressive to pursue charges against Trump related to January 6. As if there were any doubt. After all, last week there was reporting that a federal grand jury investigating January 6 had issued subpoenas to the Trump White House Counsel, Pat Cipollone, and his top deputy, Patrick Philbin.

Perhaps the roadmap for the DOJ comes from the January 6 Committee, which has poured out the thin gruel of purported criminal charges against Trump, alleging he and others, including attorney John Eastman, could be charged with:

1. Obstruction of an Official

Proceeding (18 USC 1512(c)(2)); and 2. Conspiracy to Defraud the United States (18 USC 371).

Each of these counts, and really the DOJ's pursuit of Trump and his attorneys and advisors, amounts to the criminalization of politics.

Arguments of law that might fail in the courts are now prosecutable offenses. Attempts to delay a vote count based on novel, and not corrupt, interpretations of the law can put you in prison.

Issues surrounding the counting of state results or whether the Vice President can refuse to count electoral votes is a matter to be decided through the civil or political process, not through charges brought by vindictive political opponents.

This must have been approved by AG Garland; not certain it got green light from POTUS or WH, contrary to Kilmeade claim below. But he does shed light on the purpose of the search.

Kelly O'Donnell @KellyO NEW: The FBI notified the Secret Service that a warrant would be executed and Secret Service facilitated access to the Florida Trump property as fellow federal agents but did not take part in investigation or search.

To shed further light on the purpose of the search, it's no other than DNC/ Clinton Campaign attorney Marc Elias. The criminal law at issue is 18 USC 2071. Those convicted of this offense will be "disqualified from holding any office under the United States."

For the purposes of our inquiry, does it matter if this law wouldn't technically foreclose Trump from being elected to the presidency in 2024? Yes and no. Section 2071 was debated back in 2015 regarding Hillary Clinton and the general consensus was that the law's disqualification clause does not apply to the presidency: "if Congress has no power to add to the standing qualifications of its own members, it cannot add to the standing qualifications for the other elected constitutional positions, i.e., the President and Vice President."

But the disqualification clause would certainly be used as a weapon both in the courts and with the public, consistent with the Regime's strategy to damage Trump politically.

Dutch Farmers Igniting Global Resistance Against Climate Push

Dutch farmers are standing up against crippling, top-down government climate regulations. Scores of images and videos showing farmers, in their tractors, blocking roads, airports, distribution plants and now the German border as part of an ongoing protest against government attempts to reduce their livestock numbers and cut fertilizer allowances.

How did it get to this point? In 2017, the European Union announced nature directives for the purpose of achieving Agenda 2030 goals, for 'conservation and sustainable management' of Europe's most vulnerable species and natural habitats. Directives were to be achieved through designation and protection of areas of 'high biodiversity value' which form the Natura 2000 network. The Netherlands has 162 Natura 2000 areas/sites.

Landmark ruling that Holland must cut emissions to protect citizens from climate change upheld by supreme court was the 2019 headline ran by The Independent in which the highest court in the Netherlands upheld a landmark ruling that defines protection from the devastation of climate change as a human right and requires the government aggressively to set more ambitious targets to cut

greenhouse gas emissions as a result.

With those two data points, the small, local family farmers were put firmly in the crosshairs of the climate reductionist combine to face the drastic cuts to greenhouse gasses and huge reductions of nitrogen in the soil.



In June, The Associated Press reported on the Netherlands writing: Calling it an "unavoidable transition," the government mandated reductions in emissions of up to 70% in many places close to protected nature areas and as high as 95% in other places. The ruling coalition earmarked an extra 24.3 billion euros (\$25.6 billion) to finance changes that will likely make many farmers drastically reduce their number of livestock or to get rid of them altogether."

In 2021 World Economic Forum 'agenda contributor' and Prime

Minister of the Netherlands Mark Rutte committed his country to house the 'Global Coordinating Secretariat' of the WEF's 'Food Innovation Hubs.'

THE MONEY MATRIX - PART 1: The Private Money System

Private commercial banks create what we all use as 'money'. This fundamental fact is not taught in our schools. Why? Because it is the power supply to the ruling elites of our American society.

U.S. history can be viewed as a power struggle between public control and private control of money. Beginning with the signing into law of the U.S. Constitution, the Congress used its constitutional power to issue money, but, at the same time, states chartered private commercial banks to issue bank credit ('bankmoney'). Congress created the money for public needs. Banks created bankmoney for private profit and power.

Sovereign money: Money issued by a government through its legal authority is called sovereign money. The legal power of Congress to issue money is found in our U.S. Constitution: Article I, Section 8 -- "Congress shall have Power...to coin Money, regulate the Value thereof, and of foreign Coin." Back in 1789, the word 'coin' meant any form of money, such as metal coins, paper money, written ledger entries, etc. There was no debt associated with sovereign money. Nobody paid interest on its use. The government spent it

into circulation, and it passed from person to person until collected back as national taxes. Today, coins are the only sovereign money issued by the government -- a miniscule part of our money supply.

Bankmoney: By contrast,

be paid on it to the bank! Bankmoney is usury! Today, 97% of our money supply is bankmoney.

For example, I am a borrower of JPMorgan Chase. I sign a loan contract with JPMorgan Chase, and the bank CREATES a deposit in my JPMorgan Chase bank account for the loan amount, say \$10,000. Of course, the loan contract says that I will repay \$11,000 -- the additional \$1,000 being the interest to the bank. Note: the bankmoney for the interest is never created by the bank. This means there is never enough money to pay off all the bank debts. Some borrowers will have to default, and the bank will get their collateral. Today, the 1% has used the

Reserve Act, dollar bills are the DEBT of the U.S. government.

We Americans have grown up in a matrix created by our manipulators, the financiers of the Federal Reserve and Wall Street. We are led to believe the battle is between the Democrats and the Republicans, but this is part of the matrix cinema on TV. There is no difference between the two parties -- both protect the secrets of the money power and do its bidding.

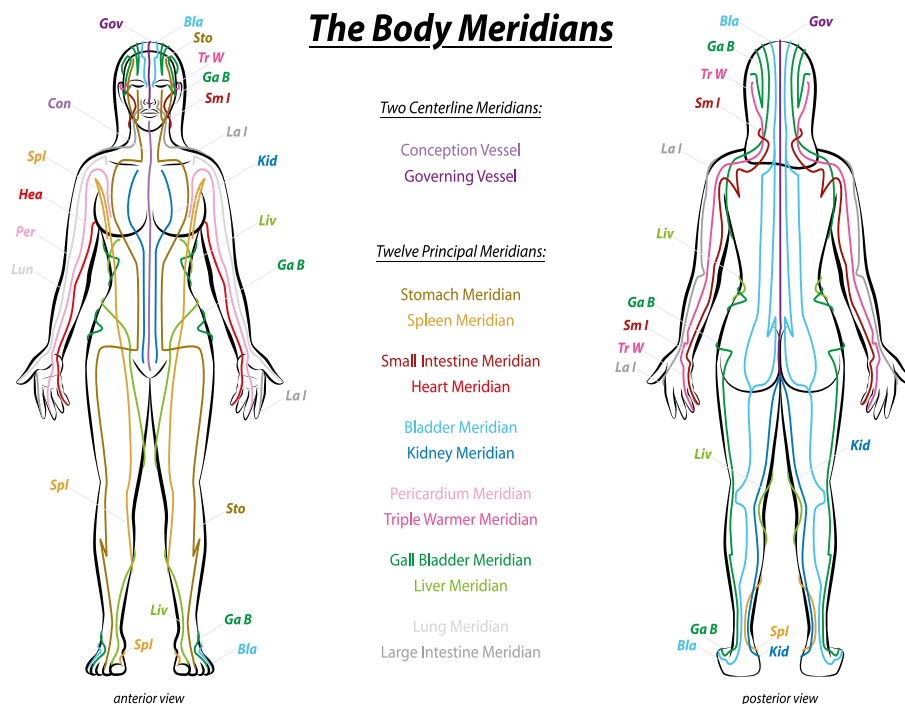
