Nikita Khrushchev's Warning to the West

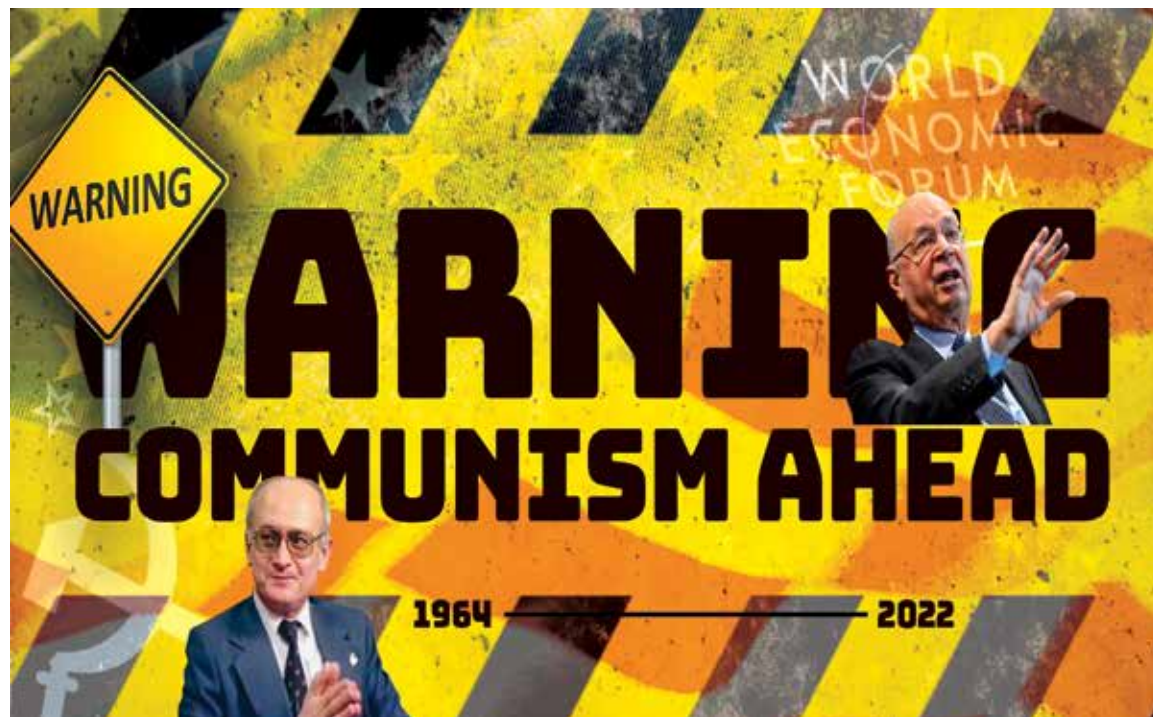

This is a reminder of Russia's Prime Minister Nikita Khrushchev comments made on September 29, 1959:

"Your children's children will live under communism. You Americans are so gullible. No, you won't accept communism outright; but we will keep feeding you small doses of socialism until you will finally wake up and find you already have Communism. We will not have to fight you; We will so weaken your economy, until you will fall like overripe fruit into our hands... The [western] democracy will cease to exist when you take away from those who are willing to work and give to those who would not."

In 1959 Khrushchev also spoke about how to control the people to embed the creation of a permanent socialist/communist state. Here are the levels of control that need to be set in place:

- 1) **Healthcare** – Control healthcare and you control the people.
- 2) **Poverty** – Increase the poverty level as high as possible, poor people are easier to control and will not fight back if you are providing everything for them.
- 3) **Debt** – Increase the debt to an unsustainable level. That way you are able to increase taxes, and this will produce more poverty.
- 4) **Gun Control** – Remove the ability to defend themselves from the Government. That way you are



able to create a police state.

5) **Welfare** – Take control of every aspect (food, housing, income) of their lives because that will make them fully dependent on the government.

6) **Education** – Take control of what people read and listen to and take control of what children learn in school.

7) **Religion** – Remove the belief in God from the Government and schools because the people need to believe in ONLY the government knowing what is best for the people.

8) **Class Warfare** – Divide the people into the wealthy and the poor. Eliminate the middle class. This will cause more discontent and it will be easier to tax the wealthy with the support of the poor.

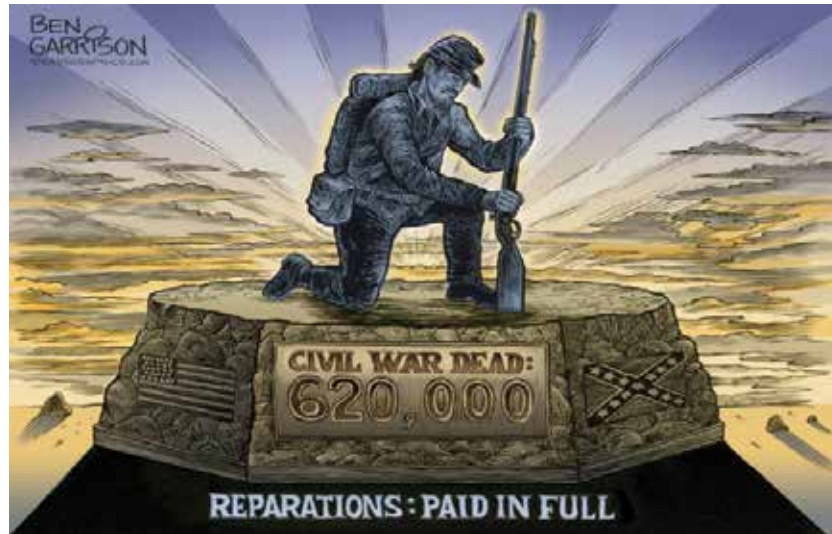
The World's Greatest Anti-Slavery and Racism Movement in History

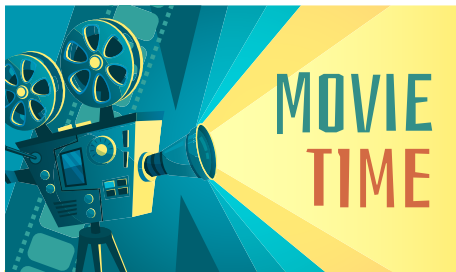

Local Veteran Howard Baker Turned 100 Years Young

Local resident and WWII, Korea and Vietnam Veteran Howard Baker, turned 100 years young on August 21st, 2022. A party was held in his honor at the local VFW. It was a lovely celebration of a man who sacrificed so much of himself for this country. He was joined by his son, Spec 5 Kenyon Baker who served during the Vietnam War and his grandson FC(2)SW Peter Baker who served in the Gulf War. A good



man raised a good man who raised a good man. The World needs more good men, thank you Howard. Many other family members and neighbors joined in celebrating this man, it was beautiful to witness.

to sit with this man and listen to his story. This is my take on that interview. Howard Baker was born 8/21/1922 in Oklahoma. He was raised on an apple farm and was the middle son of five boys. His mother died when Howard was 14 and this must have impacted him quite deeply, he repeated this several times throughout the interview and still to this day it is easy to see his pain when he speaks of her. His father was a WWI Veteran and his oldest brother was killed



in WWII, his plane was taken down by a kamikaze pilot.

Growing up during The Great Depression, he really didn't think often about what dreams he might have had prior to the

war, he worked hard and he went to school. At 19 he joined the Airforce. Soon after his basic training with the B17, the US got involved in WWII. He went into combat in the B17.



despite the fact that he had every right to be. His medals are impressive. He humbly down played his Purple Heart and Silver Star and says he was never injured but his son told us he was on a few occasions. He had to jump out of a plane, released his parachute 100

I was fortunate to sit in on an interview of Howard done by John "Preacher" McFarland for Legacy. I am so honored to have been invited

Quickly he moved up into the B29. He loved to talk about flying the B29 as a Gunner and Engineer. He became a Top Gunner and moved into shooting missiles in the Korean and Vietnam Wars. He later flew the B52 as a senior gunner. Howard served a total of 26 years in the Airforce and retired as a Warrant Officer W4, which is the highest rank one can achieve.



He enjoyed discussing his medals but he was very humble about them all. He was in no way boastful

feet above water and ended up in the hospital. I can not understand how anyone would live through that but he did. His younger brother Jasper was later in Air Sea Rescue.

He says he had a good life and the wars were no big deal really, oh but they were. His advice for future generations is to live a good life, relax and enjoy it.

Preacher: Howard, the whole World owes you a debt of gratitude for the sacrifice and price you personally made for our freedom. We could never repay you for your service but your legacy will live on. Thank you.

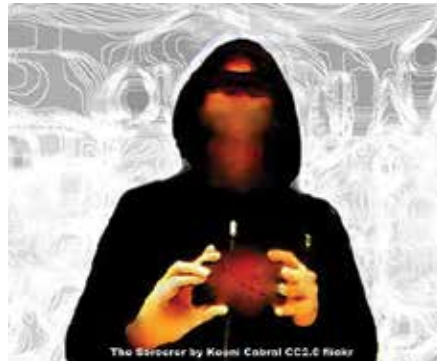

Kennedy was assassinated by a lone gunman named Lee Harvey Oswald, who himself was assassinated while in police custody before he could be questioned. The CIA used its

friends in the media to launch a campaign to make suspicion of the Warren Commission report a target of ridicule and hostility. This campaign

was “one of the most successful propaganda initiatives of all time.”

So writes political science professor Lance deHaven-Smith, who in his peer-reviewed book, *Conspiracy Theory in America*, published by the University of Texas Press, tells the story of how the CIA succeeded in creating in the public mind reflexive, automatic, stigmatization of those who challenge government explanations. This is an extremely important and readable book, one of those rare books with the power to break you out of *The Matrix*.

Professor deHaven-Smith is able



to write this book because the original CIA Dispatch #1035-960, which sets out the CIA plot, was obtained through a Freedom of Information Act request. Apparently, the bureaucracy did

not regard a document this old as being of any importance. The document is marked “Destroy when no longer needed,” but somehow wasn’t. CIA Dispatch #1035-960 is reproduced in the book.

The success that the CIA has had in stigmatizing skepticism of government explanations has made it difficult to investigate State Crimes Against Democracy (SCAD) such as 9/11. With the public mind programmed to ridicule “conspiracy kooks,” even in the case of suspicious events such as 9/11 the government can destroy evidence, ignore prescribed procedures, delay an investigation, and then form a political committee to put its imprimatur on the official story. Professor deHaven-Smith notes that in such events as Kennedy’s assassination and 9/11 official police and prosecutorial investigations are never employed.

The event is handed off to a political commission.

Professor deHaven-Smith’s book supports what I have told my readers: the government controls the story from the beginning by having the official explanation ready the moment a SCAD occurs. This makes any other explanation a “conspiracy theory.” This is the way Professor deHaven-Smith puts it:

“A SCAD approach to memes assumes further that the CIA and other possibly participating agencies are formulating memes well in advance of operations, and therefore SCAD memes appear and are popularized very quickly before any competing concepts are on the scene.”

The CIA’s success in controlling public perception of what our Founding Fathers would have regarded as suspicious events involving the government enables those in power positions within government to orchestrate events that serve hidden agendas. The events of September 11 created the new paradigm of endless war on behalf of a Washington-dominated world. The CIA’s success in controlling public perceptions has made it impossible to investigate elite political crimes. Consequently, it is now possible for treason to be official US government policy.

Professor deHaven-Smith’s book will tell you the story of the assassination of President Kennedy

by elements of the US military, CIA, and Secret Service. Just as the Warren Commission covered up the State Crime Against Democracy, Professor deHaven-Smith shows why we should doubt the official 9/11 story. And anything else that the government tells us.

Read this book. It is short. It is affordable.

It is reality preparation. It will inoculate you against being a dumbshit, insouciant, brainwashed American. I am surprised that the CIA has not purchased the entire print run and burned the books. Perhaps the CIA feels secure from its success in brainwashing the public and does not believe that American democracy and accountable government can be restored.

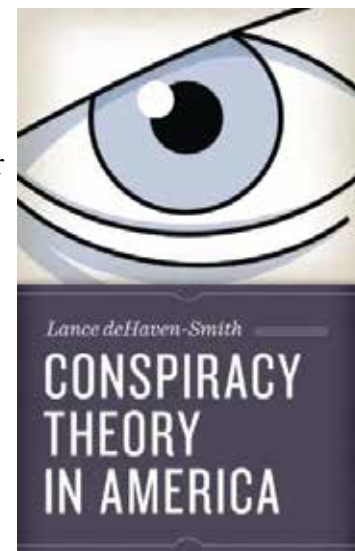

Love Letter to America

WASHINGTON – The Drug Enforcement Administration is advising the public of an alarming emerging trend of colorful fentanyl available across the United States. In August 2022, DEA and our law enforcement partners seized brightly-colored fentanyl and fentanyl pills in 18 states.

“Rainbow fentanyl - fentanyl pills and powder that come in a variety of bright colors, shapes, and sizes—is a deliberate effort by drug traffickers to drive addiction amongst kids and young adults,”



said DEA Administrator Anne Milgram. “The men and women of the DEA are relentlessly working to stop the trafficking of rainbow fentanyl and defeat the Mexican



drug cartels that are responsible for the vast majority of the fentanyl that is being trafficked in the United States.”

Brightly-colored fentanyl is being

seized in multiple forms, including pills, powder, and blocks that resemble sidewalk chalk. Despite claims that certain colors may be more potent than others, there is no indication through DEA’s laboratory testing that this is the case. Every color, shape, and size of fentanyl should be considered extremely dangerous.

Fentanyl is a synthetic opioid that is 50 times more potent than heroin and 100 times more potent than morphine. Just two milligrams of fentanyl, which is equal to 10-15 grains of table salt, is considered a lethal dose. Without laboratory testing, there is no way to know how much fentanyl is concentrated in a pill or powder.

Fentanyl remains the deadliest

drug threat facing this country. According to the CDC, 107,622 Americans died of drug overdoses in 2021, with 66 percent of those deaths related to synthetic opioids like fentanyl. Drug poisonings are the leading killer of Americans between the ages of 18 and 45. Fentanyl available in the United States is primarily supplied by two criminal drug networks, the Sinaloa Cartel and the Jalisco New Generation Cartel (CJNG).

In September 2021, DEA launched the One Pill Can Kill Public Awareness Campaign to educate Americans about the dangers of fake pills. Additional resources for parents and the community can be found on DEA’s Fentanyl Awareness page at DEA.gov.

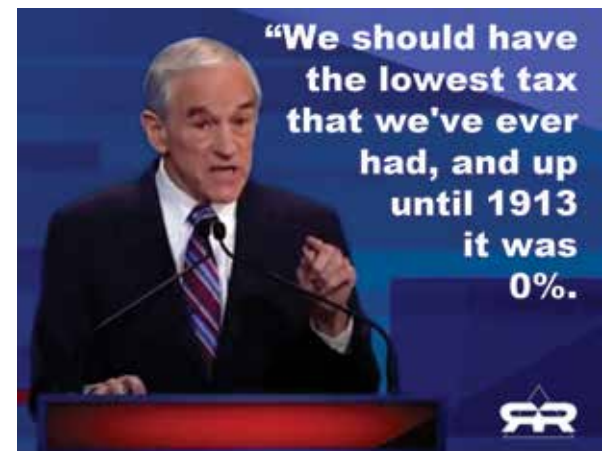

Connecting the Dots: 5G – The Ultimate Weapon of Mass Destruction

As an electrical engineer who has designed computer systems and communication equipment, I have been very interested in the issue of the impact of 5G on our world.

5G deployment is underway by governments across the world in all cities and towns without any of the obligatory prior environmental impact analysis or public insurance for instruments of harm, rendering the whole network deployment an illegal and unlawful act by authorities. The telecommunications industry responsible for deployment have confirmed that they have not carried out any scientific research and therefore have no current published scientific research data on the actual impact of the networks on the environment.

be able to monitor everything we do, everywhere we go, the internet sites we visit, our phone conversations, what we eat, what

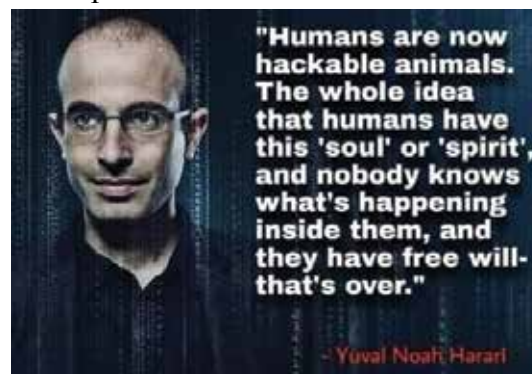

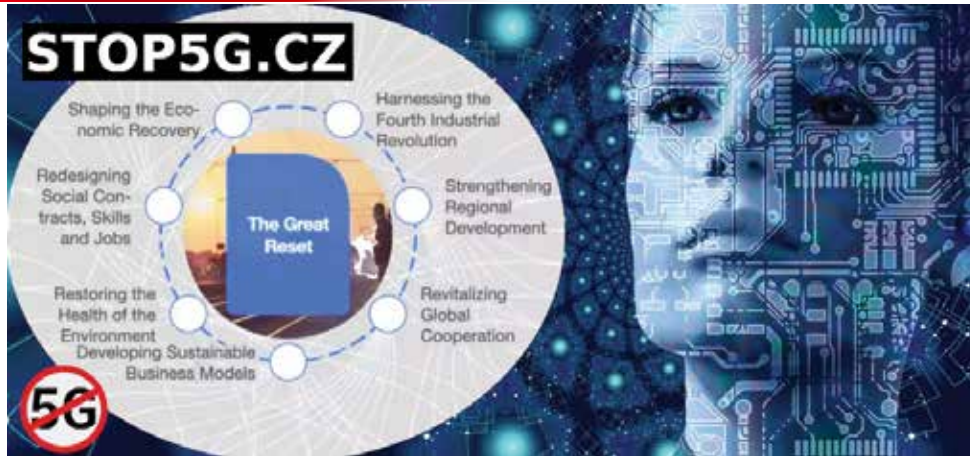

Other biomarkers include SM-102, which is a toxic phospholipid present in the Moderna Covid-19 shot, a synthetic Luciferin that improves bioluminescence-imaging Luciferase. Just the name sounds evil. Luciferins can be activated using electromagnetic radiation to create a bioluminescence of the subject. Facial recognition technologies, all part of the 5G technology AI toolbox, can then be used to track and trace the contaminated subject across the environmental space.

Energy Weapons (DEW), disable you or kill you individually in the middle of a crowd.

6) 5G is a Directed Energy Weapon (DEW)

5G radio frequency (RF) radiation uses a 'cocktail' of three types of radiation, ranging from relatively low energy radio waves, microwave radiation with far more energy and millimeter waves with vastly more energy.

Weapons expert Mark Steele has said "5G is a weapon to be used on the people." The 5G network uses the same frequencies as military weapons. DEW is a military version of a 5G frequency generator in the 6 GHz to 100 GHz and beyond range. This is termed an Active Denial System (ADS) that focuses a beam of 95 GHz waves of radiation on an individual or a crowd. This causes an unpleasant burning sensation that feels like your body is on fire. The sensation is intense enough to cause a nearly instantaneous reflex action to flee the beam. The sensation dissipates when the target moves out of the beam.

Recent studies by a team of Israeli physicists have found that when the millimeter wavelength of 5G energy approaches the dimensions of our biological structures our sweat ducts act like little antennas and absorb more of the energy into our bodies, causing heating of the surrounding tissue. The action is like being inside a microwave oven. The launch of 5G will be like turning on your microwave, opening its door, and leaving it on for the rest of your life.

Directional microwave radiation weapons were used on the US Embassies in Cuba, China and Russia, known as the Havana Syndrome. The attacks have left victims suffering significant and irreparable neurological damage. By coordinating the timing of pulses, the 5G frequency output and the signal intensity the 5G system can be programmed as a Directed Energy Weapon (DEW) to impact all life on earth. As 5G is deployed, there will be no place on earth that is safe for humans, insects, birds, animals and plants.

7) 5G Radiation Health Hazards can kill ALL life on Earth

While some studies on wireless radiation exposure paid for by the telecom industry found no effects, hundreds of independent studies did find biological effects occurring at levels at or below current U.S. standards. This has prompted more than 240 scientists with published peer-reviewed research on wireless radiation and health to sign an appeal to the World Health Organization and the United Nations, calling for precautionary health warnings and stronger regulation of wireless radiation. As the wireless industry ramps up its hype for the 5G generation of wireless communication, billions of new cellular antennas will be deployed worldwide on the ground and in space, resulting in an increase in the complexity of Electromagnetic Radiation (EMR) frequencies, pulsations and density which have been proven hazardous for humans. Respected researchers have given us a much better foundation from which we can extrapolate that this increased EMR exposure is an undeniable independent risk to our health and the environment.

memory deficits, neurological disorders, and negative impacts on general wellbeing in humans. Damage goes well beyond the human race as there is growing evidence of harmful effects to both plant and animal life.

8) 5G Threatens Weather prediction

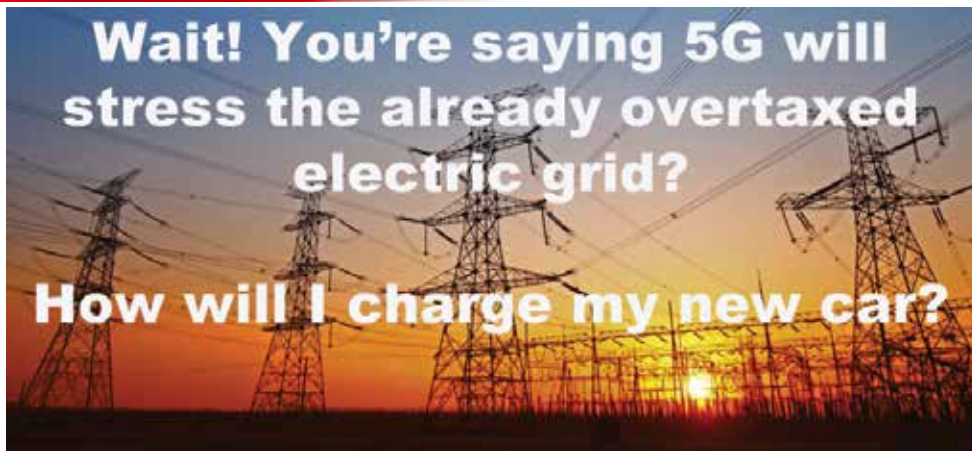
A global 5G network will also threaten our ability to predict weather which, in addition to putting civilians at risk of severe storms, will also jeopardize commercial aviation, military aviation, naval operations and nautical shipping safety. Widespread 5G coverage will prevent satellites from detecting changes in water vapor, which is how meteorologists predict weather changes and storms.

9) 5G Threatens Aviation Safety

The 5G radiation spectrum overlaps that of the aviation radar and communications. 5G threatens aviation radar, the aircraft radar altimeter, the airport landing guidance and the airborne collision warning and avoidance systems. The airlines and the airports are very concerned about the interference and safety impact of the interference on takeoffs, inflight safety and landing safety. Airlines have raised alarms that 5G will create “catastrophic” interference with flight navigation systems and pilot safety during takeoff and landing. The risks will be greater during bad weather due to the loss of weather forecast accuracy.

10) 5G Impact on Power Grid

The 5G grid will require tens of millions of new antennas placed every 300 feet or so. The higher frequency 5G signals are attenuated faster and require more power than 4G. 5G base stations bump up the power requirements over 4G LTE, in part because of the ‘multiple in / multiple out’ (MIMO) antenna arrays used for the 5G generation technology. 5G needs many more times



the number of base stations for the same coverage as 4G LTE due to attenuation of the higher frequencies.

The energy consumption will rise sharply due to the ever-increasing IOT energy demands at every stage of the lifecycle of 5G equipment, from device manufacture to data centers to data transmissions, and networks.

* 70.2 million “small cell” tower bases to be installed by 2025.

* 40,000 satellites by 2025

* 500 billion devices are expected to be connected to the Internet by 2030.

* 8.9 billion mobile phone subscriptions worldwide by 2024.

* 60% growth a year in production of wireless peripherals (Wi-Fi/ Bluetooth speakers, appliances, wearables, etc.).

* 7-fold increase in mobile data traffic globally projected between 2017 and 2022.

The power grid in the US is overloaded and brownouts are already occurring throughout the country. The increased power demand of tens of millions of 5G antennas will dramatically increase the stress on the power grid causing more brownouts and power failures. Power consumption of a 5G base station is 3 times the 4G LTE. One 5G antenna uses as much electricity as 12 average U.S. homes. Tens of Millions of 5G antenna arrays are being planned. Where is all the additional power going to come from?

In 2021, the total generation of electricity from utility-scale generators in the United States was

about 4.12 trillion kWh. Just ten million 5G antennas in the U.S. will require a total of 1.314 trillion kWh or about 30% of the entire current generating capacity in the U.S. The Energy Information Administration (EIA) estimates that approximately 1.2% was generated with solar photovoltaic (PV) systems. The amount of electricity generated by renewable wind energy was approximately 9.2%. Renewable energy will not be able to solve the energy crisis and 5G is making it worse.

11) 5G creates temperature increases in larger cities

The planned and currently deployed 5G mass antennas installations all add to an ever-increasing requirement for more energy to produce the data transfer through radiation emissions across cities and towns. Microwave radiation emissions are known to increase thermal temperatures, contributing to life threatening effects of raising temperatures in cities. Heat Island impacts are defined as large urban areas that are affected by increases in city temperatures that have been recognized by the EPA as causing detrimental health impacts and increases in energy consumption due to increasing air conditioning power increases. Brownouts and power failures are coming your way.

12) 5G can increase risk of building fires and create electrical sparks
Microwaves

will also affect many molecular structures in materials, which increases building fire risk. This is caused by elements in the building breaking down due to the microwave radiation causing localized heating and breakdown of materials. Microwave radiation at certain frequencies will excite water molecules (as in your microwave oven) and if there is no water, other less volatile molecules will absorb the radiation and start to heat. Therefore, any material that has dried out can overheat and ignite more easily in a microwave energy field.

Any metal objects inside a microwave electrical field can exhibit dielectric properties that can cause sparking which could lead to a fire. Several pieces of metal close to one another can generate sparks sufficient to start a fire. Buildings can catch fire spontaneously.

13) 5G can cause buildings to collapse

5G creates the fatigue of materials molecular structures due to the modulated microwave energy fields. Specific frequencies cause the dissociation of molecular structures of solid building materials, priceless artworks, and wine collections, among other things. This radiation can cause critical infrastructure fatigue failure, including the power grid. Current critical infrastructure was never assessed or engineered with this pulse-vibration, energy-in-air value added to the materials’ fatigue calculation and ultimate life expectancy of the established infrastructure.

14) 5G Satellite network can be Hacked

Starlink is a satellite internet constellation operated by Elon Musk's SpaceX, providing satellite Internet access coverage to 36 countries. It aims for global coverage. The race to put satellites into orbit is on, with Amazon, U.K. based OneWeb and other companies chomping at the bit to place tens of thousands of satellites in orbit. SpaceX started launching Starlink satellites in 2019.

On 15 October 2019, the United States Federal Communications Commission (FCC) submitted filings to the International Telecommunication Union (ITU) on SpaceX's behalf to arrange spectrum for 30,000 additional Starlink satellites to supplement the 12,000 Starlink satellites already approved by the FCC.

Amid all the promotion and propaganda, a critical danger has been ignored: the lack of cybersecurity standards and regulations for commercial satellites in the U.S and internationally. Common commercial electronic off-the-shelf parts are provided for all the satellite manufacturers and in the ground stations for communicating to keep the parts costs low. The wide availability means hackers can analyze them for vulnerabilities. The danger here is that hackers could insert backdoors and other vulnerabilities into satellites and ground station software.

If hackers were to take control of the satellites the consequences could be catastrophic. Satellites could simply be shut down, denying access to their services. Hackers could also jam or take control of the 5G satellites, reprogram the software and create

havoc for critical infrastructure. This includes but is not limited to sabotaging the electric power grid, electric power plants, fresh water and wastewater plants, and transportation systems for road, sea and air traffic.



15) 5G can generate EMP pulses to destroy all electronics

NCLA Suit Uncovers Army of Federal Bureaucrats Coercing Social-Media Companies to Censor Speech

Washington, DC (September 1, 2022) – The Attorney General of Missouri, and the Attorney General of Louisiana, have filed a lawsuit that blows the lid off a sprawling federal censorship regime that will shock the conscience of Americans. The joint statement on discovery disputes in the lawsuit, *State of Missouri ex rel. Schmitt, et al. v. Joseph R. Biden, Jr., et al.*, reveals scores of federal officials across at least eleven federal agencies have secretly communicated with social-media platforms to censor and suppress private speech federal officials disfavor. This unlawful enterprise has been wildly successful.

Under the First Amendment, the federal government may not police private speech nor pick winners and losers in the marketplace of ideas. But that is precisely what the government has done—and is still doing—on a massive scale not previously divulged. Multiple agencies’ communications demonstrate that the federal government has exerted tremendous pressure on social-media companies—pressure to which companies have repeatedly bowed.

Discovery has unveiled an army of federal censorship bureaucrats,

including officials arrayed at the White House, HHS, DHS, CISA, the CDC, NIAID, the Office of the Surgeon General, the Census Bureau, the FDA, the FBI, the State Department, the Treasury Department, and the U.S.



Election Assistance Commission. Communications show these federal officials are fully aware that the pressure they exert is an effective and necessary way to induce social-media platforms to increase censorship. The head of the Cybersecurity and Infrastructure Security Agency even griped about the need to overcome social-media companies’ “hesitation” to work with the government.

These actions have precipitated an unprecedented rise in censorship and suppression of free speech—including core political speech—on social-media platforms. Many viewpoints and speakers have been unlawfully and unconstitutionally

silenced or suppressed in the modern public square. This unlawful government interference violates the fundamental right of free speech for all Americans, whether or not they are on social media. More discovery is needed

to uncover the full extent of this regime—i.e., the identities of other White House and agency officials involved and the nature and content of their communications with social-media companies.

The government has been uncooperative and has resisted complying with the discovery order every step of the way—especially with regard to Anthony Fauci’s communications. Defendants claim, for example, that White House communications are privileged, even though such privilege does not apply to external communications. The U.S. District Court for the Western District of Louisiana should overrule the government defendants’ objections and order them to supply this highly relevant, responsive, and probative information immediately. NCLA released the following statements:

“If there was ever any doubt the federal government was behind censorship of Americans who

dared to dissent from official Covid messaging, that doubt has been erased. The shocking extent of the government’s involvement in silencing Americans, through coercing social-media companies, has now been revealed. These bureaucrats continue to resist efforts to expose the degree of their unconstitutional actions every step of the way.” - Jenin Younes, Litigation Counsel, NCLA

“The incredible extent of government interference with the speech rights of Americans must be seen to be believed. Yet, even with all that this case has revealed, the government defendants are still resisting their obligation to disclose the names of all the public servants who were involved in this unlawful scheme.” - John J. His work on human decision making and cognitive biases was groundbreaking and, in part, helped governments worldwide to hypnotize most people into taking “Covid Vaccines”. Richard Thaler, around 1999, also taught my favorite class “Decision Making”. He was my favorite professor at the University of Chicago, where I was an MBA student. He taught us a lot about ways that exist to hijack our decision making and how our adversaries use our subconscious biases to make us make wrong decisions — as well as how we can use these manipulations to our own advantage in business.

What I learned in that class was helpful throughout my entire life, affected many investment and business decisions, helped me convert prospects to paying customers, avoided several stock market crashes, and much more. This same decision making class possibly saved my life, because it made me able to recognize and resist Covid vaccine propaganda and manipulation. Prof. Thaler ended up on the wrong side of history, supporting Covid vaccine propaganda and the nudge units, but his teachings made me able to recognize manipulation, and resist it. Thinking about that made me appreciative of people who never took any such class, often had no formal education, and yet they made the right choice instinctively. These people, many of whom are my readers, are worthy of admiration, if for no other reason than remarkable independence of thinking and a clear mind in a very

confusing, dangerous, and rapidly shifting situation.

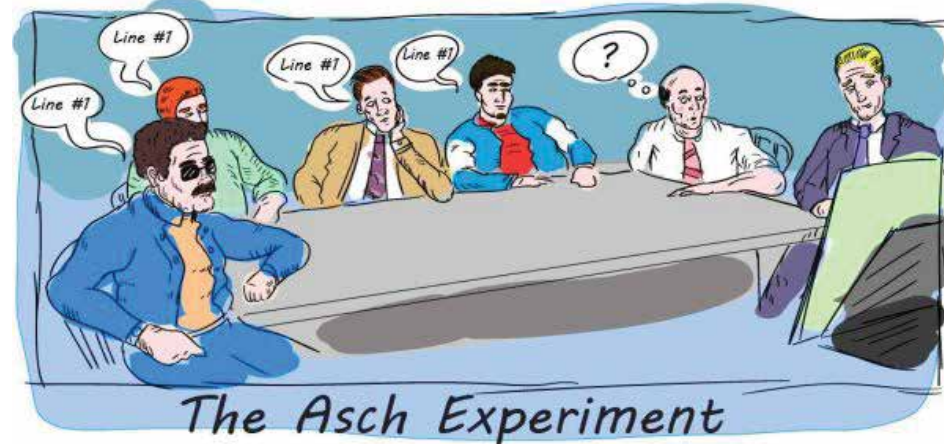
My future posts will go through various psychological manipulation concepts and how they were applied, by shady actors and co-opted governments, and how they affected each of us.

The Asch Experiment

“All experts agree that the vaccine is safe and effective.” That was enough to get most people vaccinated. Except that anyone could ask two questions:

- 1) How can I know that all experts agree, if those disagreeing are not allowed to speak up?
- 2) How can anyone know that “Covid vaccine” is safe and effective, if no time actually passed to ensure that?

Finally, someone with just a bit of knowledge could also ask a question, “are you sure that it is safe and effective, if no coronavirus vaccine

ever worked, and no mRNA product was ever approved”?

The Asch Experiment, conducted by Solomon Asch, found out that most people, when seeing a “consensus” of participants agreeing on something that is fairly obviously false, actually ends up agreeing with those false opinions just because everyone else seems to think so.

The experiment was originally set up with eight persons, only one of whom was an experimental subject, and the rest were actors. These stooges, who the subject thought were other subjects, were all asked the same question, to which they gave an obviously wrong answer. The subject, who did not know he was the only real subject, was to speak up last.

It turned out that subjects of this experiment (it was repeated multiple times), seeing a consensus of seven smartly dressed men, would end up giving the same (obviously incorrect) answer as the stooges. This conformance experiment literally was a clever way to make people hold and express obviously false opinions.

This experiment was repeated many times, and in the most skillfully conducted experiments, they got 62.5% of subjects to agree with obvious nonsense at least once.

Oddly enough, the vaccination rate in the US on Sep 1, right before federal vaccine mandates started, was 62.3%. Vaccination was running out of steam, just as Delta was showing that vaccines were not really “effective”.

It is at this time, on September 2, Richard Thaler concluded that “a nudge is not enough”.

Seeing a slowdown and a dip in confidence, vaccinators realized that they need to do more than mere manipulation with fake “expert opinion”. Vaccine mandates and hate propaganda supplanted “nudges” to drive vaccination forward. That will be discussed in other posts.

We literally lived through a worldwide Asch experiment. Every newspaper, TV station, every YouTube recommended video, kept telling us how the vaccine was “safe and effective” and how “all experts agree”. We were constantly force fed these “expert opinions” nonstop.

Enormous efforts were spent to silence “misinformation”. Why? Because Solomon Asch found out that any expression of disagreement

— lack of consensus — immediately kills compliance: Regarding mRNA “Covid vaccines”: anyone who would think for a minute, would realize that there was not a way to know for sure that vaccines were safe and effective, simply because not enough time has passed. Similarly, anyone could see that the masterminds behind the lockdowns and vaccinations, the billionaires behind the scenes, and the corrupt governments, all ensured that any dissent would be silenced. Thus, the purported consensus did not, in fact, exist at all.

The minority of people saw through that, decided accordingly, and refused vaccination. Who was that? You, my readers. What made you decide this? I am sure that there were just as many reasons as people here. The main factor is that you all took a few minutes to think about it critically. You were independently minded and decided to think for yourselves. Was it your general distrust of the government?

Was it your deep knowledge of virology and molecular biology? Was it your experience with wheeling and dealing, exposure to scams and knowing how con men operate? Was it your ability to think independently without needing people to agree with you?

Even those who took the shots, and saw the light later, are critical thinkers. What is important is seeing the light — not necessarily the timing of when you saw the light.

To those who survived The Global Asch Experiment, congratulations.

P.S. Richard Thaler, a brilliant professor, author, and theoretician in the cognitive bias field, is not an evil mastermind of vaccination. He was merely one of many players, minutely related to me, and the author of concepts that played out in the pandemic. I do NOT want to create a wrong impression of my favorite college professor being someone like “Dr Evil of Covid-19”. He was not Dr. Evil. But his theories are incredibly important to the story.

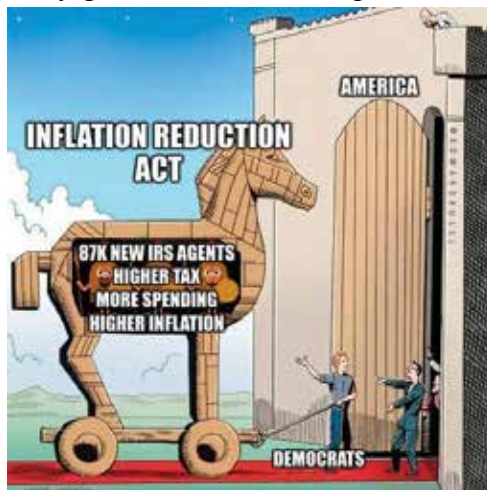

The Money Matrix Part 2: War

“When a commercial bank makes a loan contract with a borrower, the bank CREATES the deposit in the borrower’s account.” This is the “money power.” Have you repeated this fact 15,000 times yet? Whoever controls this ‘money power,’ decides if the nation

will go to war. Here is a case study from World War I.

INVESTMENT BANKS By 1912, the large New York and Chicago commercial banks were controlled by a cartel of powerful investment banks. Investment banks are private businesses and do not have authority to issue banknotes or create deposits, but their control of the large commercial banks allowed them to wield the ‘money power’ and gain control over the large industrial corporations of the time. The most powerful of investment banker was J.P. Morgan.

U.S. ‘NEUTRALITY’ War broke out in Europe in August, 1914. The U.S. was neutral, but in January, 1915, the firm of J.P. Morgan signed a Commercial Agency Agreement with the British government to enter “into a wide range of purchasing and contracting arrangements with American firms in behalf of the United Kingdom.” In May, 1915, France did the same. J.P. Morgan organized the financing of war purchases, decided which American companies would be suppliers, and set the prices of the final products. “Not surprisingly, corporations directly in the Morgan and Rockefeller groups of companies were the prime beneficiaries of Morgan’s astute purchasing.”



England and France shipped their gold to Morgan to help finance the purchases. On December 4, 1916, the U.S Secretary of the Treasury reported that the U.S. stock of gold was the largest ever in our history, and indeed ever in the history of the world! The gold had found its way into the reserves of the private Fed Banks and their commercial bank owners.

England and France sent Morgan their citizens’ confiscated U.S. stocks and bonds to sell to American citizens on the U.S. exchanges. England and France also borrowed about \$2.4 billion from the U.S. bond markets. All these securities were sold by Morgan, using the cartels’ control over the large commercial banks, members of the new Federal Reserve System. U.S. citizens bought the securities, many taking out bank loans to do so. The commercial banks themselves also bought the securities. The bank loans created bankmoney, but in addition the banks’ purchases of these securities also created bankmoney. Surprise! Note well: legally, when a commercial bank buys a stock or bond, they can CREATE the deposit in the seller’s account!

By the eve of the U.S. entry into the war, Morgan had shipped \$5 billion worth of war materials, the economy was booming, and

the U.S. had become the leader of world finance. Morgan himself loaned a half billion dollars to the Allies. But still the Allies needed more credit to keep waging the war.

U.S. ENTERS WWI By the beginning of 1917, the Allies were desperate for more loans, but Morgan had reached his limit. The U.S. Ambassador to

Great Britain informed President Wilson that the Allies would lose the war unless they got more loans. If the U.S declared war on Germany, our government could extend such loans and the U.S. could continue to supply war materials. Our prosperity and trade would continue.

On April 2, 1917, President Wilson asked congress for a declaration of war since “The world must be made safe for democracy.” **POWER OF THE CARTEL’S FEDERAL RESERVE SYSTEM** The 1913 Federal Reserve Law had been pushed through Congress by the banking cartel. The 1913 Law gave the Fed Banks the power to issue a new private currency called Federal Reserve Notes (Fed Notes), as the debt of the government, not an asset like the money issued directly by the Treasury. The U.S. Congress had

handed this incredible power to the private banking cartel with the 1913 Law!

As the U.S. declared war on Germany, the Fed Law was amended to empower even more bankmoney creation by the member commercial banks – with massive death and destruction to a whole generation. From April, 1917, to April, 1919, the U.S. Treasury offered the U.S. public five issues of ‘Liberty Bonds,’ totaling \$21.5 billion. The Fed Banks supported their member banks buying Liberty Bonds directly from the Treasury (CREATING bankmoney in the account of the Treasury) and signing loan contracts with customers buying Liberty Bonds directly from the Treasury (CREATING bankmoney in the customers’ bank accounts). The Treasury was able to sell all the Liberty Bonds.

From June 20, 1917, to December 31, 1917, the Fed member banks increased their investments in government securities by 65%, and in commercial loans by 31%. During the entire war, two-thirds of the industrial profits were taken by enterprises under the control of the investment banking cartel. The public debt increased from less than \$1 billion when the Fed was created to \$27 billion at the end of the war. The banking cartel had massive control of the nation, which has only grown exponentially to the present day.

The “Smoking Gun of 9/11” is the Implosion of World Trade Center Building 7

It is what awakens most to the terrible truths - and thus where we need to start.

World Trade Center Building 7 (WTC 7) was a 47-story steel-framed fire-protected high-rise near the North Tower and the third high-rise to be destroyed on 9/11. It was not hit by an airplane, yet it collapsed anyway at 5:20pm in the afternoon, rapidly, evenly, and completely. The official narrative as presented by NIST is that WTC7 collapsed due to “normal office fires.” But office fires have never brought down a steel-framed fire-protected high-rise building, ever; and there have been several dozen much larger, hotter, and longer lasting fires in these buildings.

WTC 7’s “Collapse” displayed features never seen outside of explosive controlled demolition. In fact, its destruction was indistinguishable from a classic controlled demolition. Let’s review the facts as documented in my Republic Magazine article: Speed of Collapse: Immediately after numerous witnesses heard explosions, Building 7 descended

at free-fall acceleration for more than a third of its 7-second fall – as acknowledged by NIST (the agency tasked with the explanation of the collapse).

Free-fall means that the 40,000 tons of structural steel provided absolutely no resistance to the 7 second fall. What happened to the 80 columns on each floor? We’re they removed? In a fraction of a second? By fire?!

Symmetry of Collapse: The overall building mass fell uniformly and with almost perfect symmetry through what should have been the path of greatest resistance – 40,000 tons of structural steel framing. This requires a precisely timed patterned removal of columns – which office fires, a gradual organic process, is not capable of.

University Study finds “Not Fire.” One of the top forensic structural engineers in the country, Professor Leroy Hulsey conducted a 4-year study of WTC 7’s collapse at the University of Alaska Fairbanks and

concluded in 2019 that “fire did not cause the collapse of WTC 7 on 9/11, contrary to the conclusions of NIST,” and that “the collapse of WTC 7 was a global failure involving the near-simultaneous failure of every column in the building.”

“High Temperature Corrosion Attack on the Steel” was documented in the FEMA’s 2002 BPAT final report. Their metallurgical examination in Appendix C described steel samples from Building 7 that were turned “into Swiss cheese.” They found “evidence of a severe high temperature corrosion attack on the steel.” The New York Times called this “perhaps the deepest mystery uncovered in the investigation.”

Molten Iron Droplets in the WTC Dust: The USGS published their 2006 “Particle Atlas of the WTC Dust” in which they performed chemical analysis finding the presence of billions of iron “microspheres” in all the samples of the dust, indicating that they were previously molten, elemental iron, that were pulled into spherical form by surface tension and solidified before hitting the ground. They are direct evidence that

temperatures exceeding the melting point (2800°F) of iron were present during the buildings’ destruction.

Aluminothermic Nanocomposites: Unignited nano-thermite in the form of several tons of red-gray chips in the WTC Dust provides an even more definitive discovery in the dust by an international team of chemists and physicists. They published Active Thermic Materials in the WTC Dust in the Bentham Open Chemical Physics Journal in 2009.

None of the above scientific forensic findings can possibly be accounted for in the official narrative of the WTC 7 collapse.

On the other hand, each of them point to the use of thermite—an incendiary used by the military to cut through steel like a hot knife through butter.

Only the controlled demolition hypothesis accounts for above evidence.

Stopping the Democrat's March to Fascism

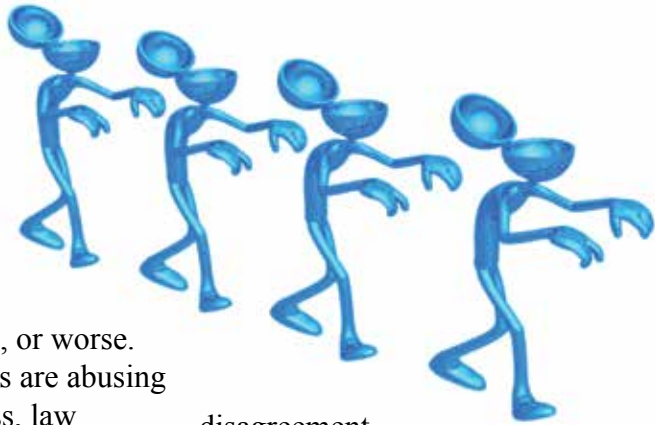

If they are for the Constitution, measure their knowledge. Ask: What is the only guarantee in the Constitution?

Usually they blather on about "life, liberty and the pursuit of happiness," which is in the Declaration of Independence, not the Constitution. Ask them for the only guarantee in the Constitution. Few know it.

Memorize this: Article IV, Section 4 of the Constitution reads that the "United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion;..."

This section is important to any political conversation. The guarantee requires that all state governments be republican in form; they cannot be principalities, nor democracies (California is close to that), nor fascist governments.

Then ask if President Biden should be impeached for blatantly disobeying the order against invasion - - then ask why he hasn't. His opening the border shows political corruption at its worst. Do they support that corruption?

This difference also shows that the democrats are anti-constitutionalists; that they lie in their oaths of office. Does that matter to them?

Our republican government was designed for the States to be

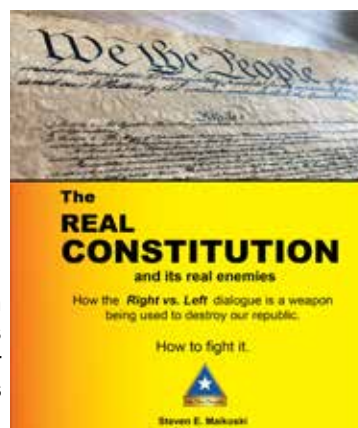

What An Article V Convention Might Mean. Is this country ready to open Pandora's box?

While I was speaking at the John Birch Society (JBS) annual meeting in August 2022, the issue of an Article V Convention came up. Because their views on this topic are different than many other conservatives, I asked if they would write up their analysis of what calling such a convention might mean for the country. I offered to publish such an essay here on this substack, so that many would have an opportunity to consider a different point of view on this important topic.

From the JBS website:

John Birch was a courageous Baptist missionary who went to China in 1940. When Colonel Jimmy Doolittle led the famous World War II bombing raid on Tokyo, John was brought to the survivors and he helped them to safety, then volunteered, creating an intelligence network that saved countless American lives.

He earned the rank of Captain in the 14th Air Force, as well as numerous commendations, including the Legion of Merit. Ten days after the war officially ended, Captain Birch was brutally killed by Chinese Communists.

Mr. Welch (founder of the JBS) discovered that the U.S. government had covered up Birch's death and was so impressed by his ideals and his character that he requested permission from George and Ethel Birch (John's parents) to place John's name on the organization he was going to create. They agreed



and immediately became Life members.

This is an organization founded to (among other things) resist communism. According to Wikipedia: The John Birch Society from its start opposed collectivism as a "cancer" and, by extension communism and big government. The organization and its founder Robert Welch, promoted Americanism as "the philosophical antithesis of communism." It contended that the United States is a republic, not a democracy, and argued that states' rights should supersede those of the federal government. Welch infused constitutionalist and classical liberal principles, in addition to his conspiracy theories (emphasis mine - note how these "theories" aren't specifically named), into the JBS's ideology and rhetoric. In 1983, Congressman Larry McDonald, then the society's newly appointed chairman, characterized the JBS as belonging to the Old Right rather than the New Right.

The society opposes "one world government", the United Nations, the North American Free Trade Agreement (NAFTA), the Central America Free Trade Agreement (CAFTA), the Free Trade Area of the Americas (FTAA), and other free trade agreements. It argues the U.S. Constitution has been

devalued in favor of political and economic globalization. It has cited the existence of the former Security and Prosperity Partnership

as evidence of a push towards a North American Union. The JBS has sought to reduce immigration.

The JBS supports auditing and eventually dismantling the Federal Reserve System. The JBS holds that the United States Constitution gives only Congress the ability to coin money, and does not permit it to delegate this power, or to transform the dollar into a fiat currency not backed by gold or silver.

I gently suggest that, in the interests of intellectual integrity (if nothing else) that it is worth approaching today's JBS with an open mind, as I have. The organization has been repeatedly maligned (as in the Wikipedia quote above) as conspiracy theorists, and even as "racists", although the weaponization of both of these terms for political purposes has destroyed any objective meaning. Even WEF young leader graduate Dr. Lena Wen is now accused of being "racist" and "ableist" for advocating more sensible COVID public health policies. However, from what I can tell, the JBS organization has actually been at the vanguard of political perspectives that many now accept as mainstream, and has consistently advocated anti-racist positions.

In hindsight, it is clear that the JBS has successfully opened the Overton window of acceptable political discourse. After what I have personally experienced since January 2020, I now have a lot of empathy for those who have taken controversial stands based on independent thought and analysis, and who have been attacked and stereotyped by corporate media.

In my opinion, it is time to recognize that JBS members have been American thought leaders for many decades now. Like all of us out on the bleeding edge, they have not been right about everything. That is a risk that comes with leading rather than following. But at a minimum I believe

that their opinion and insights on US Constitutional matters deserve to be considered with an open mind. With his historic speech of September 01 2022, even Joe Biden now claims to be a constitutionalist and a nationalist. Whether his comments were sincere or not, it is clear that constitutionalism and nationalism have become accepted mainstream US political positions.

Article V of the U.S. Constitution gives states the power to call a Convention of States to propose amendments. It takes 34 states to call the convention and 38 to ratify any amendments that are proposed. Article V, in its entirety reads: The Congress, whenever two thirds of both houses shall deem it necessary, shall propose amendments to this Constitution, or, on the application of the legislatures of two thirds of the several states, shall call a convention for proposing amendments, which, in either case, shall be valid to all intents and purposes, as part of this Constitution, when ratified by the legislatures of three fourths of the several states, or by conventions in three fourths thereof, as the one or the other mode of ratification may be proposed by the Congress; provided that no amendment which may be made prior to the year one thousand eight hundred and eight shall in any manner affect the first and fourth clauses in the ninth section of the first article; and that no state, without its consent, shall be deprived of its equal suffrage in the Senate.

Please read Article V Convention Threatens Liberty By Christian Gomez for the John Birch Society carefully. I know the author spent a lot of time carefully crafting his analysis, and the positions held by the John Birch Society are not to be taken lightly.

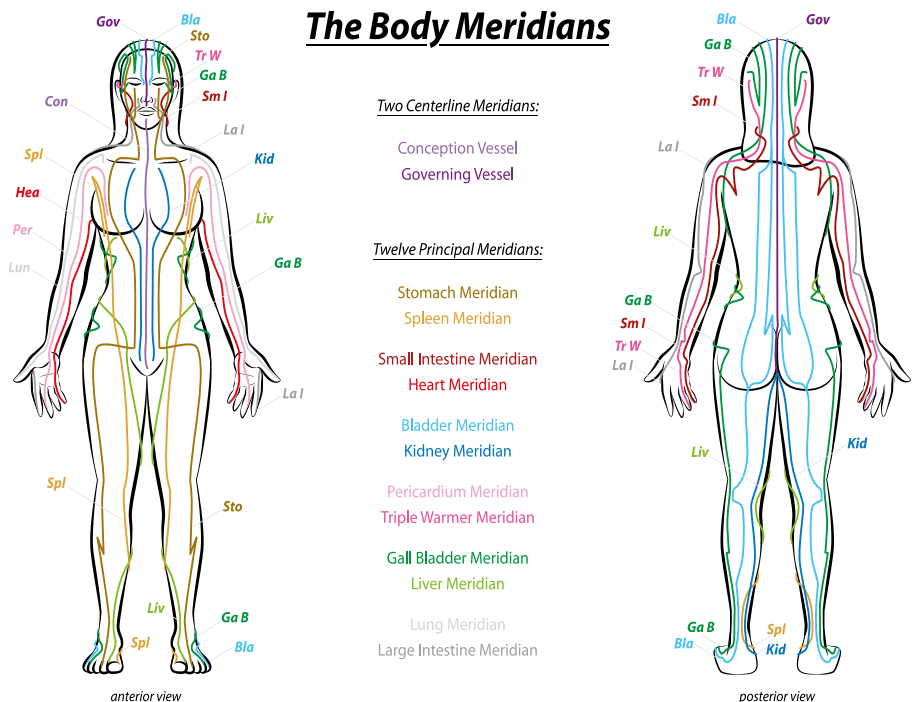
