### Who is the Real Puppet **Master in LaPaz County?**

Who's holding the strings for how our county grows? What is their motivation? And what do we need to do about it?

Answering those questions gets more convoluted the deeper I dive into it. Every voter knows who is supposed to hold the strings. Laws are in place to ensure that our elected officials conduct themselves appropriately. Yet some still think the power is theirs to weild.

This story is about how land is used in this county. When operated correctly county officials would turn to the County Comprehensive Plan as well as written procedures in order to move the county forward.

We have a Comprehensive Plan that is written beautifully and can be found with a simple google search or with a little more effort on the La Paz County Website. If our county supervisors were following the plain language of our comprehensive plan then each social demographic would continue to be represented: from those that are retired and enjoy a simpler life to those that thrive on progress. Everyone from residents to businesses would be able to count on that plan to make smart decisions on where to

Two of our county supervisors are behaving like they are the puppet masters. That their vast education in County Planning and minimal social awareness is far superior to the wide demographics and actual expertise that was involved in the building of our Comprehensive Plan. The brazen audacity is astounding. Both have gone so far as to suggest that we

put their money.

count ourselves lucky that we have people who know better and will do the "right" thing for this county. Even when their "right" thing goes against Arizona laws. But let's keep it real. They are not the puppet masters either. They have sold their strings higher up the proverbial food chain. I'm not here to speculate on the price. That will be better left to the AZ Attorney General's office.

The current "unlawful" and "unofficial" plan is to spot zone a nice respectable manufacturing plant into a residential area which will set a precedent. That paves the way for the rest of Highway 72 frontage becoming an unregulated and uncontrolled industrial/commercial corridor. One of the supervisors, in front of their attorney, told me that "light industry" is the residential buffer to heavy industry. He then proceeded to point to my map and ask me where a smelter goes and where a rare earth mineral refinery would go. Add to that, one of the land investors had the arrogance to lay the plan out for me in writing.

Anyone that followed the smelter debacle in Salome/Wenden knows how hard the District 2 Supervisor will push to introduce toxic companies into our neighborhoods (and that was not



even his district). His conduct and words have shown a zero social understanding of the demographics of rural residents and a single minded focus on money. Once the land is developed it is very hard to undo just look at the mess that the county and state are in with the Fondemonte deal.

As usual we were underestimated. They did not account for the collective knowledge, education, tenacity, and commitment to each other that has come out of this neighborhood. To be honest, for a brief moment we almost fell for it. That was until our county representative opened his mouth. We can spot a shyster from a county mile. So, that got me investigating.

I don't want you to take my word on any of this. I am asking each of you to do your own research. This "spot zoning" goes before the Planning and Zoning Commission on October 6th at 4pm and before the Board of Supervisors on October 17th at 10am in Parker at the county offices. Please download the agendas and the attached documents, come, listen, and ask questions. And once you see that my research is sound then I ask you to stand up with us as we hold our county officials accountable.

Knowing what we know now, this neighborhood can not allow their plan to go through. Best case scenario the citizens are able to gain control of the strings again before a final vote is made. Worst case we will have to ask a judge to hand them back over.

# Court-Appointed Guardian/Conservator, Vivian Hartless

An Arizona veteran who had been denied visits with his long time friend by the La Paz County Fiduciary appointed by La Paz Superior Court as his guardianconservator was granted unrestricted visitation by Judge Duber at the veteran's annual hearing earlier today.

Real Change PAC has been advocating on behalf of the veteran's placement right for visits with family and friends since February of this year. La Paz County supported their Fiduciary with public statements that their Fiduciary's decision to deny the visits was within her court-appointed authority. Real Change PAC's unrelenting advocacy pressed for the issue to be addressed by the Court that had appointed the veteran's guardianconservator.

"Today's ruling by Judge Duber to not restrict Anna Camacho's visits with her long time friend is a great success for

this veteran who had been denied his placement rights," said Real Change PAC's executive director. "It didn't matter that the judge ruled that the PAC had no standing and moved to strike the PAC's filed motions, because the information was still brought before the court. And we were fortunate to have found Otilia Diaz, the pro bono attorney who successfully represented Anna Camacho's request for contact."

# Brief History of Poker

There is a good chance that the word "poker" originated from the French word "poque," which was derived from the German word "pochen," which means "to knock." However, there are historians who are skeptical that the origins of poker are the same as those of other games with names that are very similar. The Persian card game known as "as nas" is very similar to the American game of poker. It's possible that Persian sailors brought the game all the way to New Orleans and taught it to the French colonists there. In addition to this, there is a theory that poker evolved from the card game known as "primero," which was common during the Renaissance. The English card game known as "brag" included elements of bluffing.

According to a statement made by an English actor named Joseph Corwell, the card game was first played in the city of New Orleans in the year 1829 using a deck that contained twenty

cards. The game became popular throughout the rest of the United States as a result of the riverboats on the Mississippi River, which frequently navigated both directions of the river. Gambling was a very common activity for passengers on riverboat trips.

After poker's popularity spread, a standard English deck of 52 cards was eventually incorporated into the game. The flush was a new feature that was introduced after the deck was changed. #### **Proposition 128 Vote YES**

A "yes" vote supports this constitutional amendment to allow the Arizona State Legislature to amend or repeal voter-approved ballot initiatives if any portion has been declared unconstitutional or illegal by the Arizona Supreme Court or U.S. Supreme Court.

My Thoughts: This is to our benefit as it prevents funds and the state legislators from acting on any proposition that is in direct violation of the State Constitution. This would make sure that even if a proposition is passed by the voters, it must comply with the State Constitution. This one gets a clear yes from me.

#### **Proposition 129 Vote YES**

A "yes" vote supports this constitutional amendment to require that citizen-initiated ballot measures embrace a single subject.

My thoughts: I wish all bills both in the State as well as Federal were single item. That way no "pork" or any other items could be added to a bill that is not on the single subject. It would be easier for the voter to understand and prevents "favors". The only downside is it may prevent support for bills and amendments. Abraham Lincoln ran into this issue when he was attempting to get the 13th Amendment, The **Emancipation Proclamation to end** slavery. In order to get support, he had to promise in the amendment certain "favors" such as aid to the legislators' constituents or to include a farm aid bill. Without the "pork" or "favors" this amendment would not have passed. Just a history lesson. All that said this Prop gets a yes from me.

#### **Proposition 130 Vote YES**

A "yes" vote supports allowing the legislature to set certain property tax exemption amounts and qualifications (including property tax exemptions for widows and widowers; those with total and permanent disabilities; disabled veterans; and property used for trade, business, or agriculture) and consolidating the constitution's property tax exemption provisions into a single article.

My Thoughts: This would consolidate

the tax exemption to a single article and allow legislators to determine exemptions to those who need it most: widows, widowers, those with permanent disabilities as well as disabled veterans. The downside is that it also includes exemptions for property used for trade, business, or agriculture. This could increase the tax burden for the rest of us who do not qualify from the above. Note none of the above are automatic, it just gives the power to the legislature to consider and act upon it. This proposition gets a yes from me.

#### **Proposition 131 Vote YES**

A "yes" vote supports this constitutional amendment to create the position of lieutenant governor, who would be elected on a joint ticket with the governor, and who would succeed the governor in case of a vacancy.

My Thoughts: I see two advantages on this proposition. First, in the event which happens a Governor decides to run for another office. This would allow the Lieutenant Governor to continue on in their place leaving no gaps in the operation of the Governors office. Second, both the Governor and Lieutenant Governor would be on the same ticket. Just like President and Vice President. This would keep the same party in place until the election. This one gets a yes from me.

#### **Proposition 132 Vote YES**

A "yes" vote supports this constitutional amendment to require a 60% vote for voters to pass ballot measures to approve taxes.

My Thoughts: This will change the vote for ballot measures and taxes from a simple majority of 51% to 60% I am all for making it tougher to increase taxes. The down side it will be harder to get Propositions to pass. This one still gets a yes from me.

#### **Proposition 209 Vote YES**

A "yes" vote supports setting a limit on interest rates for debt accrued from receiving healthcare services equal to either the weekly average one-year constant maturity treasury yield or 3%, as well as increasing the amount of value for certain property and earnings exempt from attachment, execution, forced sale, and any other debt collection processes.

My thoughts: The key is reduction of

interest rates on medical debt from 10% down to 3%. It would also increase the dollar amount on exceptions for debit collectors, as well as reduce the amount that can be garnish from wages. With rampant inflation, those with lower incomes will especially benefit. La Paz County average household income is at just over 30,000 a year. With the rising costs - medical is often ignored. The lower interest rates would help. This one gets a yes from me.

#### **Proposition 211**

A "yes" vote supports requiring that persons or entities that make an independent expenditure of \$50,000 or more on a statewide campaign or \$25,000 or more on a local campaign must disclose the names of the money's original sources, which would be defined as the persons or businesses that earned the money being spent.

A "no" vote opposes requiring that persons or entities that make an independent expenditure of \$50,000 or more on a statewide campaign or \$25,000 or more on a local campaign must disclose the names of the money's original sources.

My Thoughts: This would allow us to see where the money is coming from. At the same time, it requires any accumulated donations meeting the above amount to be reporting your info. This would also give info for the IRS, FBI for those of us who are MAGAS. This one I know people whom I respect on both sides of this issue. #### **Proposition 308 Vote NO**

#### **Proposition 310**

## How to Protect Yourself from EMF Exposure

This is a follow up of my article in the September issue of "The Patriot Free Press" titled "Connecting the Dots: 5G – The Ultimate Weapon of Mass Destruction" on pages 11-14.

Due to the substantial body of credible science documenting harm from exposure to various levels and frequencies of wireless radiation, a precautionary approach to the widespread deployment of wireless technologies must be a top priority to reduce potential harm to the public and the environment. Electromagnetic Fields (EMFs) are toxic to humans, all animal life and all plant life. EMF affects the function of cell membranes and can lead to DNA dysfunction: they have an impact on anything with DNA. And that includes plants, animals, insects and even microbes.

Extensive, peer reviewed testing has demonstrated that all EMF radiation. especially 4G and 5G frequencies, interfere with the electrical functioning of the human body, can cause the symptoms exhibited by Covid-19 and the many flus, cause cancer and other debilitating reactions.

The single most powerful way to protect yourself is to reduce your exposure to EMF in the first place.

Dr. Joseph Mercola has written a book titled "EMF\*D – 5G, Wi-Fi, & Cell Phones: Hidden Harms and How to Protect Yourself". This article is a short summary of a forty page chapter in his book of three hundred pages. This is by nature a very technical subject. I highly recommend his book. www.mercola.com.

Part of the reason why EMFs are so dangerous is that, like X-rays, they are invisible, silent and odorless. Unless you are EMF hypersensitive, you won't see, feel or hear your EMF exposures. This is why it is crucial to invest in devices that can locate and measure all hidden sources accurately.

Before you do anything to reduce



your physical exposure to EMFs, it is vital for you to know your physical exposure to EMFs by measuring radiation levels already present. Measuring first provides you with a baseline and dramatically helps you to fine tune your mitigation efforts so they can be as effective as possible. The ability to see and hear current readings detected by EMF measuring devices will motivate you to take immediate action to address them.

There are four types of meters that measure four different types of EMF radiation. Max = Maximum EMF Safety Threshold 1) Alternating Current Magnetic Fields (MF) Max 5 milliGauss or 100 nanoTesla

2) Alternating Current Electric Fields (EF) Max 50 Volts per meter 3) Radio Frequency Radiation Fields (RF) Max 0.20 milliWatts per square meter

4) Dirty Electricity Max Threshold varies depending on the meter you use; check manual

The Magnetic Fields are generated by motors in refrigerators, air conditioners and fans. They are the M in EMF.

The Electric Fields are created by the electrical 110/220 volt alternating current (A/C) in your house wiring and the overhead power lines. They are the E in EMF.

The Radio Frequencies are generated by all of the electronic devices in your home, e.g. cell phones, TV, stereo equipment, computers, video games, cell phone chargers, etc. They are the F in EMF.

Dirty Electricity, also known as dirty power or electrical pollution, are high voltage transient spikes riding along on the 50 Hz (Europe) or 60 Hz (USA) power lines provided by the electric company. The interference is created by electrical devices as they operate, primarily in your home and include cordless phones, video game systems, fluorescent lights, dimmer switches, pool pumps, heat pumps, air conditioners, inverters on solar panels, hair dryers, washers. dryers, electric heaters and stoves, dishwashers, furnaces, and battery charging power supplies for electronic devices (such as TVs, phones, monitors, and computers).

You can purchase the meters yourself or hire an EMF professional. Dr. Mercola's book has a chapter on Resources which provides information on meters for measuring all four of the types of radiation that is hazardous to your health. The types of meters, functionality, and cost can be researched on the internet. There are many meters and you will need more than one to measure the 4 types of fields. There is no best meter. You can search for the meters on the internet under EMF meters.

I purchased a Trifield Model TF2 EMF meter for \$180 which measures Magnetic, Electric and RF fields. I have taken readings on every electrical appliance in the house from varying distances with the power off and on. The further away you are from the source the less the field strength. If you double the distance from the source, say from one foot to two feet, the field

the power. Moving from one foot to ten feet reduces the intensity to one hundredth or 1%. Move sources further away to reduce your exposure. www.trifield.com

I also purchased a Greenwave Dirty Electrical Test Kit with a broadband Electromagnetic Interference (EMI) meter and three Dirty Electricity plug-in filters for \$186. I tested electrical outlets throughout the house. The highest dirty electricity reading was the plug at the head of our bed with 258 millivolts. The maximum recommended level is 25 millivolts so we were receiving 10 times the maximum dirty electricity radiation. When I plugged in the Greenwave filter, the reading dropped to 23 millivolts. We are sleeping much better now. The filters are available separately for \$35 each. www.greenwavefilters.com

Dr. Mercola also has suggestions on various types of protective devices such as: shielded cables, RF shielding, wire mesh boxes, Faraday bags, protective clothing, shielding paint and an EMF shielding sleeping tent. Faraday was an English scientist, who died in1867. He contributed to the study of electromagnetic fields (EMF), electromagnetism and electrolysis. His work formed the foundation of the electric motor. He was one of the premier scientists of his day.

EMF remediation four basic principles;

1) Avoid unnecessary exposure to EMF's, especially inside your own home and from your personal devices (such as your cell phone), where you have the most control.

2) Put as much distance as you can between you and the EMF's you can't avoid.

3) Decrease the amount of EMF exposure coming into your home from external sources.

4) When all else fails, shield vourself.

#### **General Household Remediation**

If you still use a microwave oven, consider replacing it with a steam convection oven, which will heat



**\*\*\*Continued from Page 12\*\*\*** your food as quickly and far more safely. Don't stand in front of the microwave oven when it is on.

Avoid using "smart" appliances and thermostats that depend on wireless signaling. This would include all new "smart" TVs. They are called smart because they emit a Wi-Fi signal and, unlike your computer, you cannot shut the Wi-Fi signal off! Consider using a large computer monitor as your TV instead as they don't emit Wi-Fi.

The personal assistant electronic devices such as Alexa and Siri are continually listening to every sound and communicating with the cloud via Wi-Fi EMF radiation. Don't use them or at least unplug them at night.

Replace Compact Fluorescent Light (CFL) bulbs with incandescent bulbs. Ideally, remove all fluorescent lights from your house. Not only do they emit unhealthy light, but more importantly, they will actually transfer current to your body just by being close to the bulbs. While LED bulbs are more efficient, they do produce an EMF field because of the electronics that convert the 120 volt A/C voltage into the low voltage direct D/C current that is needed for the LEDs.

Modern Dimmer switches are another source of dirty electricity. So consider installing regular on/ off switches rather than electronic dimmer switches.

Refuse smart meters as long as you can, or add a smart meter guard to an existing smart electric, water and gas meter, some of which have been shown to reduce radiation by 98%. They are available from smartmetercovers.com and https://

smartmeterguard. com/?afmc=1uf

#### Daytime strategies to reduce necessary EMF exposure

To reduce EMF exposure during the daytime, consider using Stetzer or Greenwave filters which plug into the outlets, to decrease the level of dirty electricity or electromagnetic

interference being generated in your wiring. You can also take these with you to work or when you travel. This may be the single best strategy to reduce damage from EMF exposure. It appears that most of the



toxic effects are generated by the frequencies that the filters remove. www.stetzerelectric.com or www.greenwavefilters.com.

Connect your desktop computer to the internet via a wired Ethernet connection and be sure to put your cell phone in airplane mode. Also avoid wireless keyboards, trackballs, mice, game systems, printers and

portable house phones. Opt for the wired versions.

Avoid carrying your cellphone on your body unless in airplane mode and never sleep with it in your bedroom unless it is off

or in airplane mode. Airplane mode turns off all Bluetooth, Wi-Fi, cellular and data connections on your mobile device which might otherwise interfere with the electronic equipment on a commercial airplane. Even in airplane mode, it can emit signals, which is why it is actually best to put your phone in a Faraday bag. They are highly effective at blocking radiation. They are really inexpensive and only \$10 to \$20 for two of them. www.faradaybag.com When using your cellphone, use the speakerphone and hold the phone at least 2 feet away from you. Seek to radically decrease your time on your cell phone, computer and other electronic equipment.

Rather than using a cellphone, use Voice over Internet Protocol (VoIP).

VoIP software is a telephone service that you can use while connected to a computer. It converts voice signals into digital data and sends them across the internet via a router. Search for VoIP phone systems on the internet.

#### **Nighttime Remediation**

Use Stetzer filters that plug into the electrical outlet in the bedroom to remove the dirty electricity voltage transients from your electricity. Use meters to confirm that they are in a safe range. www.stetzerelectric.com

Avoid using electric blankets or mattress pads. You are sleeping in a huge electric field that does not allow for deep, rejuvenating sleep.

Use a battery-powered alarm clock, ideally one without any light. Use a talking clock for the visually impaired. When I measured the fields broadcast by my plug-in LED alarm clock in the bedroom,



I was surprised at the high level of radiation emitted by the electronics and unplugged the clock. We are now using a battery clock.

Consider moving your baby's bed into your bedroom instead of using a wireless baby monitor. The EMF radiation from the monitor is very harmful on the small body of a baby,

from organ damage to brain damage. Alternatively, use a hard wired monitor.

If you must use Wi-Fi, shut it off when not in use, especially at night when you are sleeping. Ideally, work toward hardwiring your house with Ethernet cable connection so you can eliminate Wi-Fi altogether. It's important to realize that if you have a Wi-Fi router, you have a cellphone tower inside your home! Ideally, eliminate your Wi-Fi and simply use a wired Ethernet connection. If you absolutely must have a router, vou can place it inside a shielded Faraday bag when not in use. You can find shielded items online or make your own using Swiss Shield fabric. If you have a notebook without any Ethernet ports, a USB Ethernet adaptor will allow you to connect to the internet with a wired connection. www.faradaybag.com, www.swiss-shield.de/en

For more extensive shielding, you can consider painting your bedroom walls and ceiling with special shielding paint, which will block RF from outside sources, such as cell towers, smart meters and radio/TV towers. Windows can be covered with metal window screens or film. For your bed, consider a shielding bed canopy. www.mercola.com

After all the reading I have done on EMFs hazards, the testing using the meters and the articles I have written on its harmful effects on all life, I now take EMF's very seriously. 5G is being "deployed" throughout the world, which is military terminology. ### Jan 6th Prisoners – Detained & Forgotten

More than 800 Americans, among tens of thousands who protested irregularities in the 2020 election cycle, stormed the Capitol on January 6, 2021 – and were arrested. That event is now 15 months behind us. Why, in our land of

"liberty and justice," are many still detained?

The point of this piece is not to relitigate the protest, election, charges, or anything to do with politics. It is to focus on a simple idea – due process and rule of law. As a former US Court of Appeals clerk, New York, and DC litigator, and - rather ironically, former Assistant Secretary of State to Colin Powell for global issues, including law enforcement - the conditions and state of these cases, many unresolved, is a concern. Reports flow in – through family, friends, official and credible channels – that these detainees are isolated, living in poor conditions, cannot meet with reporters, are increasingly invisible, just forgotten people. That is not how America works.

The Department of Justice has an incomplete, frighteningly suggestive reporting system, that indicates one case was dismissed, some resolved by plea,



70 adjudicated – but many in perdition, facing seemingly eternal punishment and damnation, no resolution on the horizon. Whether hundreds or "just 40" as one article argues, one is too many.

How can this be, in a nation with a Bill of Rights, which promises "no person shall be ... deprived of life, liberty, or property, without due process of law" (5thAmendment)? The Bill of Rights notwithstanding, many charged individuals remain untried, still mysteriously detained?

Consider the 6th Amendment. "In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial..." Has that occurred? "...by an impartial jury of the State and district wherein the crime shall have been committed..." Has that occurred? Continuing: "...confronted with the witnesses against him; to have a compulsory process for obtaining witnesses in his favor..." Has that occurred? "...Assistance of Counsel" Occurring? The answer? Who knows? The record is strangely incomplete, access restricted, word barely getting out, and what we know is not reassuring.

What we know, based on official reports of DC

jails where many are held, is just conditions are incorrigible, in some cases objectively inhumane and indefensible. Specifically, many seem to be isolated, facing poor health, living conditions, treated as if undeserving of the kind of constitutional standards they

deserve. Members of Congress, notably Republicans, have decried conditions as intolerable. One noted: "What's happening to these people being held in custody is wrong, it's unconstitutional - a violation of their rights. Even mainstream media

and judicial authorities have begun to acknowledge things are not right." So, what can be done to assure that America – unlike Russia, China, and half the politicized legal systems of the world – does NOT hold, detain indefinitely, mistreat, forget, or otherwise leave an impression that political prisoners exist, part of a nefarious "two-tiered system?"

#### A lot.

First, the exact status of all cases should be made public now, and every succeeding day. That should not be hard. Every American is owed that clarity.

Second, reporters, family, friends, and concerned citizens should be able to meet with these indefinitely detained individuals. Not to do so raises serious suspicions, suggesting those in charge can do as they wish, are unaccountable. That is not good for the detained or any of us.

Third, counsel by name – for all detained individuals – should be made public. Like Fifth Amendment assurances of due process, Sixth Amendment guarantees are not negotiable. Fourth, with the consent of the detained, televisions cameras, congressional investigators, members of Congress, relevant State officials should be permitted to see these individuals and conditions.

Fifth, especially in these cases, justice should return to being swift and fair, since the question now arises whether a Democratcontrolled federal and DC

government, where anti-Trump feeling runs strong, could be intentionally disregarding these Americans, letting them languish.

Many years ago, as an Assistant Secretary of State, one of my priorities was assuring any influence America

had to seed and preserve rule of law around the world, fair treatment, and generic respect for those arrested, charged and detained was understood by foreign officials.

Many times, these officials had a political agenda tied to holding prisoners. Aware, we stood against politics in the legal process. We must now hold ourselves and those in power to that standard.

Bottom line: The January 6 defendants deserve protection against the perception and fact of political punishment. Only that assures rule of law. Absence violates rule of law. They cannot be detained and forgotten, not in America. The time is now to insist on that standard and proof of it.



# **Peer-reviewed Paper - Curing the pandemic of misinformation** on COVID-19 mRNA vaccines through real evidence-based medicine. A look at the true benefits and harms of mRNA.

A British doctor, Aseem Malhotra, has just had a two part, peerreviewed paper published in the Journal of Insulin Resistance. The aim of the paper was to gain a better understanding of the true benefits and potential harms of the mRNA Covid vaccines. Dr Malhotra. a cardiologist by trade, was originally a strong Covid vaccine advocate. He volunteered in a vaccine center, was one of the first people to be double dosed and appeared

on morning television to encourage everyone to get vaccinated. He was surprised and concerned at vaccinehesitant patients when they asked about 'anti-vax' propaganda.

That was until, sadly, in July 2021, his father suffered a cardiac arrest and died. His father had been the former deputy chair of the British Medical Association (BMA) and honorary vice president. The 73 year old gentleman was extremely fit and active and heart scans from a few years earlier had revealed no significant problems. Dr Malhotra was shocked to read his father's post mortem which found that two out of three of his major arteries had severe blockages.

Aseem couldn't explain the post mortem findings and became more concerned in November 2021 after reading a peer-reviewed abstract in Circulation Journal. In the study, the mRNA vaccine was associated with significantly increasing the risk of a coronary event within five years from 11% pre-mRNA vaccine to 25% 2-10 weeks post vaccine.

He began to question his father's death and wondered whether the Pfizer vaccination he had received six months earlier could have contributed in some way. After six months of critically appraising the data and speaking to eminent scientists, he reluctantly concluded that, contrary to his own dogmatic beliefs, Pfizer's vaccine was far from being as safe and effective as first thought.

#### Questioning the data

During his reassessment of the Covid vaccine he recalled a conversation with a cardiologist colleague who decided against vaccination due to his low personal



risk and concerns about short and long term harms. His colleague was particularly alarmed that, during the trials, there had been four cardiac arrests in the vaccine group but only one in the placebo group.

Next, Dr Malhotra assessed the 95% efficacy claims. Whilst this relative risk reduction made good sales material, the true value of a treatment can only be established by looking at the absolute individual risk reduction. This turned out to be 0.84%, in other words, in a trial of 20,000 people (10,000 in the vaccine group and 10,000 in the placebo group), 4 people in the vaccine group and 88 people in the unvaccinated group would end up testing positive for Covid. Another way to express that is that you would need to vaccinate 119 people to prevent one positive test.

This absolute risk reduction figure (0.84%) is extremely important for doctors and patients to know but how many of them were told this when they received the shot? Transparent communication of risk and benefit of any intervention is a core principle of ethical evidence-based medical practice and informed consent.

The trials did not show statistically significant reductions in serious illness or mortality and in fact there were actually more deaths (19) in the vaccine group versus the placebo group (17). Furthermore, there were only nine severe cases of Covid in the placebo group, representing 0.04%. And this was in regions specifically chosen for their high prevalence of infection.

To find protection against death, then the 119 figure above (people vaccinated to prevent one positive test) must be multiplied by the number of infections that would lead to a single death in each age group. So, Dr Malhotra calculates his rate of death from Delta was 1 in 3,000 meaning the absolute risk reduction of the vaccine protecting



him from death is (1 x 3000 x 119) 1 in 357,000.

Aseem also pointed out in a recent editorial by John Loannidis in BMJ evidence-based medicine the inferred efficacy of the vaccine from non-randomised studies may be 'spurious', with bias being generated by 'pre-existing immunity, vaccination misclassification, exposure differences, testing, disease risk factor confounding, hospital admission decision, treatment use differences and death attribution'. What should be part of the shared decision-making informed consent discussion when any member of the public is considering taking the shot is something along these lines: Depending on your age, several hundreds or thousands of people like you would need to be injected in order to prevent one person from dying from the Delta variant of COVID-19 over a period of around three months. For those over 80s, this figure is at least 230, but it rises the younger you are, reaching at least 2,600 for people in their 50s, 10,000 for those in their 40s, and 93,000 for those between 18 and 29 years. For omicron, which has been shown to be 30% - 50% less lethal, meaning significantly more people would need to be vaccinated to prevent one death. How long any protection actually lasts for is unknown; boosters are currently being recommended after as short a period as 4 months in some countries.

But how many people have had a conversation that even approaches an explanation similar to that? This is before we get into the known,

#### Harms

Concerns have been raised about trial participants being limited as to the type of adverse event they could report. Furthermore, hospitalized participants were withdrawn from the trial and not reported in the final results. To make matters even worse, after two months, the FDA allowed the placebo group to be unblinded and get vaccinated, completely removing any control group with which to assess adverse events. Dr Malhotra sticks with his field of expertise, cardiology and discusses one of the most common vaccineinduced harms, myocarditis. Whilst authorities say that myocarditis is more likely after infection than vaccination, other studies have shown the opposite. There is no evidence of myocarditis until vaccination began in 2021, a full year after millions of youngsters naturally caught Covid.

Although vaccine-induced myocarditis is not often fatal in young adults, MRI scans reveal that, of the ones admitted to hospital, approximately 80% have some degree of myocardial damage. It is like suffering a small heart attack and sustaining some – likely permanent – heart muscle injury. It is uncertain how this will play out in the longer-term, including if, and to what degree, it will increase the risk of poor quality of life or potentially more serious heart rhythm disturbances in the future.

The UK's Yellow Card reporting system is addressed and determined to be far from adequate to cope with a rapid roll out of a brand new product. 9.7 million doses were administered before the clotting



problems with AstraZeneca were detected. In Denmark, they detected the problem after only 150,000 doses.

Since the beginning of the vaccine roll-out, there have been almost 500,000 adverse events reported involving over 150,000 individuals. This shows around 1 in 120 suffer an adverse event that is beyond mild. This number is unprecedented and represents the same as the total number of reports received in the first 40 years of the Yellow Card system being active. The MMR vaccine reports around 1 in 4000 suffer an adverse event.

The paper also looks at VAERS in the US which has recorded over 24,000 deaths, 29% occurring within 48 hours of vaccination and 50% within two weeks. Before 2020 there were approximately 300 deaths recorded per year.

Of most concern is that these reporting systems are actually likely to be underestimated with one paper suggesting that only 1% of serious adverse events are ever reported to the FDA. Another analysis estimated that only 10% of serious adverse events were ever reported on the Yellow Card system. Moreover, these reporting systems will generally miss medium and long term harms as it is more difficult to attribute to vaccination.

According to ambulance service data, in 2021 there were an extra 20,000 (20% increase) cardiac arrest calls compared to 2019 and 14,000 more than 2020 in the UK. Similarly, a recent paper in Nature revealed a 25% increase in both acute coronary syndrome and cardiac arrest calls in the 16- to 39-year-old age groups significantly associated with administration with the first and

> second doses of the mRNA vaccines but no association with COVID-19 infection.

#### More harm than

*good?* One has to raise the possibility that the excess cardiac arrests and continuing pressures on hospitals in

2021/2022 from non-COVID-19 admissions may all be signaling a non-COVID-19 health crisis exacerbated by interventions, which would of course also include lockdowns and/ or vaccines. Given these observations, and reappraisal of the randomized controlled

trial data of mRNA products, it seems difficult to argue that the vaccine roll-out has been net beneficial in all age groups.

Dr Malhotra concludes the first part by saying that whilst risks from vaccination remain constant, the benefits reduce over time as the virus becomes less virulent and variants are not targeted by outdated products. He recommends a pause and reappraisal of vaccination policies.

#### Pandemic of misinformation

In part 2, Dr Malhotra explores the pandemic of misinformed doctors and a misinformed and unwittingly harmed public.

Before I was de-platformed by Twitter for posting the famously accurate Canadian COVID Care Alliance video, before I was deplatformed by LinkedIn for the same reason, before the infamous Joe Rogan hit #1757 where I said the three little words "mass formation psychosis" that caused the Silicon Valley overlords to lose bladder control, many feared that I was "controlled opposition". "When a commercial bank makes a loan contract with a borrower, the bank CREATES the deposit in the borrower's account." This is the "money power." Have you repeated this fact 15,000 times yet? **Banks CREATE** 

what we use as money! Those who control this 'money power,' have slowly changed the education of our children. This article will be the first of three on "The Money Matrix and Education" to trace the change chronologically from 1892 to today. The financial powers such as Rockefeller and Carnegie, through such legal vehicles as tax-exempt foundations, would slowly redefine American education. The goal? Control our society by controlling American education.

#### The Nature of the Human and Education

Back then, education was understood to mean "the drawing out of a person's innate talents and abilities by imparting the knowledge of languages, scientific reasoning, history, literature, rhetoric, etc." The true nature of humans was (and is) the uniqueness of the individual, represented by their unique life experiences. Humans seek to grow through creativity, satisfaction of genuine needs, feelings of curiosity, etc.

Contrast the above definition of humanness with the "new, dehumanizing definition used by the experimental psychologists" and slowly implemented into American education by the Rockefeller and Carnegie foundations. Learning is the result of modifiability in the paths of neural conduction. The situation/stimulus-response formula is adequate to cover learning of any sort, the individual will learn to respond to any given situation/ stimulus, with the "correct' response.



A human is a stimulus-response mechanism – that's all.

#### 1892 Removing Understanding of the Money System

The Working Men's party of New York, formed in 1829, published: "That more than one hundred broken banks within a few years admonish the community to destroy banks altogether." Lincoln's Congress issued Greenbacks in the Civil War and led to more debate of the money question: who was to issue the nation's money – the Congress or the private banks? Numerous third parties supported government issued money, such as the Greenback Party and Populist Party.

In 1892, the National Education Association (NEA) held conferences to decide what subjects should be taught in the increasing number of public secondary schools. The conference on 'History, Civil Government, and Political Economy' resolved unanimously the following, which was accepted by the NEA: Resolved, That formal instruction in political economy be omitted from the school program. The proposal was presented by Professor Woodrow Wilson of Princeton University. Wilson went on to become U.S. President and sign the Federal Reserve Bill, showing how ignorant (or manipulable) he himself was about the monetary system. As Edward Krug wrote in 1964: "This explains why public high schools in the United States raised generations of students who know and think nothing about money and monetary systems."

1895-1904 The Corporate Trusts Throughout the 20th century, When McKinley took office... the middle class looked on impotently while factories, railroads, gas and electric plants, street railway lines, telephone systems and mines were converted from a state of individual or mere corporate ownership into the trust form, owned by great single corporations. The amalgamations were helped, and in some cases instigated, by Wall Street investment banks. The

investment banks worked together in syndicates (networks) offering stocks and bonds on the exchanges. They bought the securities from the corporations at a low price, paying with bankmoney CREATED easily and cheaply from the banks they controlled. Then they sold these financial securities at a higher price, pocketing the profits between the syndicate members. The companies and individuals comprising this network were primarily agents of the Morgan and Rockefeller banking empires.

#### **Creation of Tax-Exempt Foundations**

The massing of so much control and wealth by these financial oligarchs was challenged by the plans for a federal income tax - finally, passed by Congress in 1913. The oligarchs' solution was the creation of taxexempt 'charitable' foundations, with no end to their corporate existence. Using these funds, the oligarchs could ensure permanent control of the society, such as permanent 'charitable' control over educational policies.

there have been Congressional investigations highly critical of these tax-exempt foundations, but no solution of how to control them has ever been accepted. In 2010, a master's thesis by Ryan Kapchinsky ended with these words: "This preservation of their wealth and power has enabled these families to become a ruling plutocracy within society." In the first years of the 20th century, three private foundations were given charters by Congress, granting a selfperpetuating board of trustees and exemption from federal taxation:

\* 1903 Rockefeller's General Education Board - "the promotion of education within the United States of America"

\* 1904 Carnegie Institute of Washington - "to encourage, in the broadest and most liberal manner, investigation, research, and discovery, and the application of knowledge to the improvement of mankind"

\* **1906** Carnegie Foundation for the Advancement of Teaching - "do and perform all things necessary to encourage, uphold, and dignify the profession of the teacher and the cause of higher education"

\* 1913 Rockefeller Foundation - "to promote the well-being of mankind throughout the world" -The Rockefeller Foundation was not successful in seeking a federal charter, due to increasing hostility from Congress, but got a New York State charter in 1913.
