## Voter Fraud and the Illusion of Freedom

According to recorded history, the first democratic election began around 500 BC in ancient Greece when the tyrannical government was able to avoid a people's revolution by allowing them a choice, usually between two people, an illusion of freedom for an awakening populace. In 1868 hundreds of black men were killed in Louisiana for being registered to vote Republican.

These are just a few examples of voter fraud, but the entire two party system is a fraud. No matter who you vote for, the policy never changes because the system is not interested in personal freedom and so, they will always cheat.

Starting in 1948, with the infamous box 13 scandal, LBJ introduced a new form of voter fraud to be embraced for years to come by both parties. The simple technique of waiting until the end and then stuffing the ballot box with whatever you need. Electronic voting has only made this easier,

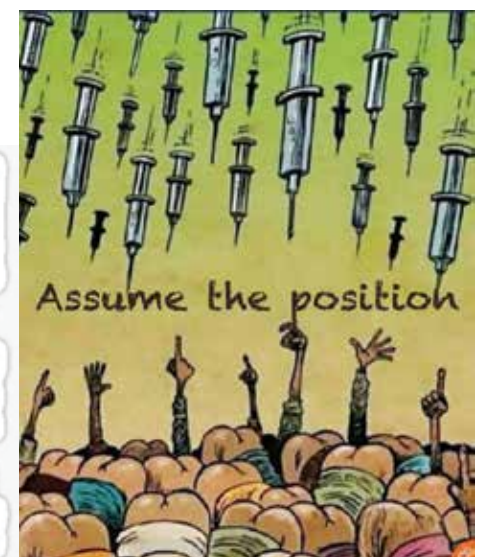

## California Is Now Castrating Children From All 50 States

This summer Chloe Cole spoke out against California's passing of SB 107. Testifying that both her and her parents were manipulated and bullied by the state to undergo destructive life changing surgeries. And while Florida bans puberty blockers and so called sexual reassignment surgeries for minors, California Governor Gavin Newsom signs a bill allowing children from any state in the country to go to California for transgender medical procedures without parental consent.

California is being hailed by the death cult as a transgender surgery sanctuary state, now providing chemical and surgical castrations for all of America's children. According to this new law, California can take emergency jurisdiction over any child from anywhere if there's a disagreement between the parent and the state of California over how to treat a child's gender

distress. SB 107 states that taking a child away from the child's parents is justifiable if it is done to pursue gender transition procedures in California and allows for the state to wage child custody claims against out of state parents. SB 107 forbids health care providers from providing medical information related to gender identity procedures to a child's parent, even if sought under a subpoena.

After permanently mutilating her own adopted child, Kathy Mulig has been working full time for California nonprofit Trans Family Support Services where she reaches out to hundreds of children all across the country, luring them to California to castrate themselves.



She often does so without the parents' knowledge, "I work with a lot of youth before they tell their families and helping them in shaping what that looks like." Her work focuses on conservative communities where parents may not approve of having their children castrated. "We have kids coming from all over the country for our virtual groups. We also opened a chapter in Huntsville, Alabama, because the people in red states really need as much support as they can get from US allies in particular, in states like California and Oregon and Washington."

For whatever reason people are allowing this incredibly evil attack against their own children. And

recently, Laura Logan interviewed a UN insider who explained to her why children are the biggest target. [Laura Logan:] "I get it but I don't get it, the children. I still have such a problem with this. You got to explain this one to me. And he said, well, first of all, you're looking at it the wrong way. I said what do you mean? ## Teaching the ABC's & Not XXX: Why What Kids Are Exposed to Matters

**Warning: this article addresses themes of sexual abuse.**

In today's world many parents face the battle of trying to help maintain childhood innocence for as long as possible against the odds of outside forces. Protecting children was never easy but with the advent of the internet, smartphones, and social media it can sometimes seem downright impossible. There are some that would welcome this shift: why shouldn't kids be fully aware of what is out there? It is the "real world" after all, and they are going to encounter it eventually. Why not just get conversations about sex, violence, and politics out of the way now so kids can become comfortable with these topics and it can all become normalized?

Children are not simply little adults. In brain development we have our amygdala, which are two almond shaped structures at the lower back sides of the brain. The amygdala are our emotional centers and operational from a very young age. What children do not have is a fully formed prefrontal cortex. In general, the prefrontal cortex is where executive function takes place – the ability to weigh and understand consequences to our actions. The prefrontal cortex forms over the course of time and in part through life experience. In a healthy, regulated brain the prefrontal cortex and the

amygdala work in concert with each other; the amygdala allows us to recognize and feel our emotions



while the prefrontal cortex helps temper the flame of strong emotions with rational thought. Without a functioning, formed prefrontal cortex we are more apt to make decisions based on impulse without regard to what may

come after our actions. When this interchange between the amygdala and prefrontal cortex occurs we can choose a course of action that validates our feelings while also allowing ourselves (and not just our emotions) to remain in the driver's seat.

Think of the toddler who wants to eat a box full of cookies before dinner. Their amygdala tells them the cookies will make them happy and they desire the cookies NOW, and so they will do anything to get the cookies. Toddlers, in not having a fully formed prefrontal cortex and not having much life experience, are not yet able to think of what comes after getting the cookies – they may feel sick after eating as many cookies as their heart desires, or they may feel too full and now have no room for the healthy foods that will provide proper nutrition. If we fast forward a few years to adolescence we may encounter a conflict that every parent dreads – an angry and frustrated child screaming at them

"I hate you!" An adolescent/teen is further along in their brain development and has more life experience than a toddler; still, because their prefrontal cortex is not yet fully developed they struggle more with the ability to "put on the brakes." They struggle

to temper the emotion to be able to communicate it in a less hurtful or confrontational way. The frustration of the situation takes precedence and the amygdala takes control; the prefrontal cortex is not yet strong enough to counteract.

When you present adult content such as sexually explicit materials to children and adolescents this becomes part of their life experience and how they see the world. Some may argue this is a good thing as sex should be normalized and not taboo for humans. While having a healthy perspective on sex can be important and is not a bad thing for adults, it does not work this way with children and adolescents as their worldview is limited. Sexual acts and sexually explicit materials can generate big emotions that can be hard to handle, even in adults. When sexual acts or exposure to sexually explicit materials is coerced, manipulated, or forced it can generate feelings of extreme confusion, shame, hypervigilance, anger, and depression. It can result in dysfunctional patterns and self-destructive behaviors that can last a lifetime if not addressed.

Children who have been sexually abused or consistently exposed to sexually explicit materials can develop a plethora of emotional issues that can continue into adulthood. Perhaps the most pervasive and insidious of these is shame. This shame often is internal rather than external. Some may say that exposure to sexually explicit materials helps to alleviate shame as it normalizes sex; this view is misguided at best. Many report feelings of confusion and self-blame. A child's

natural reaction is often to blame themselves when something goes wrong, and these (false) beliefs can become ingrained in how they view themselves and their worth. Further, this can lead to acting out sexually to seek attention and validation. Conversely, those with early sexual exposure may become completely sexually avoidant or impotent, unable to process and move past the feelings of shame and anxiety. Primary emotions such as confusion, shame and vulnerability can manifest as anger and rage toward self and others, not only in sexual situations but in a generalized worldview.

Experiencing forced vulnerability through early sexual experiences can lead to trust issues and can increase the likelihood that the cycle of victimhood will continue. Boundaries and self-worth can be eroded, and some may try to rationalize, normalize, and minimize what happened to them as that is easier than to deal with the pain and sense of violation. Early exposure to sex and sexually



explicit materials can lead to identity confusion and dissociation; this in turn can stem from feelings of shame and avoidance, as one may feel if they can become

someone "new" they can simply shed the pain and trauma.

We cannot eliminate adult content from the world or try to completely avoid it as it is a fact of life. Adults should be able to have their own realms of entertainment, release, and self-expression. The key is in keeping adult things for adults and not inviting or allowing children into experiences they are not mentally or emotionally equipped to handle.



## The Government, Race, & an Upcoming SCOTUS Decision

This week, the Supreme Court of the United States is confronting yet again an issue that has bedeviled it for the past thirty years: the use of racial quotas by government-owned universities and private universities that accept government funding.

The last time the court looked at this issue, it punted. As is always the case when the court punts, the issue returns. This time around, the issue comes in an environment hot with racial anxiety and lack of constitutional fidelity.

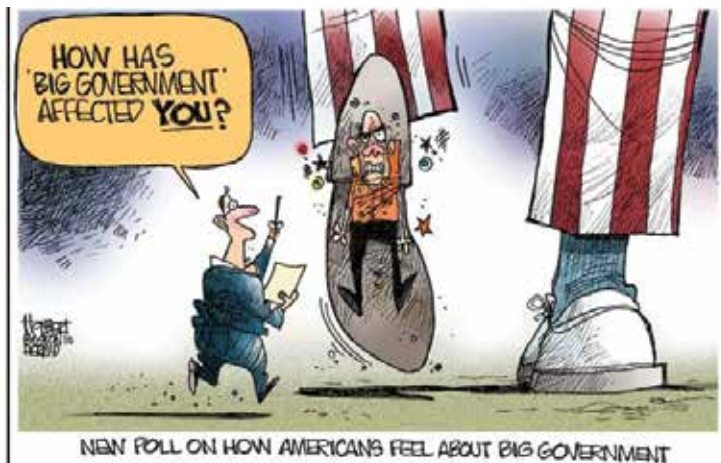
### Here is the backstory.

The Fourteenth Amendment was enacted after the conclusion of the War Between the States. The radical Republicans who controlled the Congress and most Northern state legislatures wanted to punish the Southern states severely. Yet, their debates on the floors of Congress and state legislatures are unilluminating, as they offer contradictory purposes.

But the language of the Amendment—in the Equal Protection Clause—makes it clear that by requiring the laws to be applied equally, the mandate of the amendment is to remove race from the armament of states' tools of governance.

Yet, the Supreme Court ruled in *Plessy v. Ferguson* in 1896 that states could use race as a basis to govern, so long as they did so equally. This is the separate-but-equal jurisprudence. In 1954, in *Brown v. Board of Education*, that jurisprudence was reversed when the court ruled that separate is inherently unequal.

Without saying so directly, the post-Brown federal jurisprudence has assumed as an underlying principle that the mandate of the amendment is to eradicate race from the states' armaments of governance.



There is no federal Equal Protection Clause. Yet, the Civil Rights Act of 1964 purported to abolish all use of race in government, public accommodations, housing, and workplaces, on public and on private property; the latter, a massive assault on property rights, the former, a rational understanding of the Fourteenth Amendment.

Since 1964, most states have enacted their own laws against racial discrimination, which basically mimic the federal laws and continue to prohibit government from using race as a basis for any decisions and continuing the assault on private property rights.

Today, nearly all colleges and universities use race as an admissions factor. According to their own public statements, they believe that they are serving a societal good and advancing the public policy of the United States by assuring a racially diverse makeup of all incoming classes and by compensating for past egregious racial wrongs.

To their point, the Supreme Court, in an absurdly reasoned 2003 opinion, generally accepted these goals and employed them to trump the Fourteenth Amendment, but only until 2028. Why 2028? Because Justice Sandra Day O'Connor, who

wrote the opinion, opined that in the twenty-five years following her opinion, race relations in the United States will have so improved that racial quotas in college admissions will not be a public issue. How wrong she was!

In Supreme Court history, this is the only case in which the court put a time limit on the duration of its ruling. Yet, it is a basic principle of constitutional law that if something was unconstitutional yesterday, it will be unconstitutional tomorrow and thereafter.

Notwithstanding this lamentable history and the contorted judicial lens through which it all comes to us, a group of libertarian-leaning college students and professors have challenged the use of racial quotas in university admission policies by suing Harvard University,



the nation's oldest private university, and the University of North Carolina, the nation's oldest public university.

Harvard, though private, accepts federal aid directly and indirectly and thereby has agreed to comply with federal nondiscrimination standards. UNC is owned by the state of North Carolina and thus is directly bound by the Fourteenth Amendment.

Earlier this past week, the Supreme Court devoted five hours to oral argument on these two cases, but not before the feds jumped in. Surprisingly, the Biden Department of Justice entered the case on behalf of the plaintiffs, arguing for the purest view of the Fourteenth Amendment—that it prohibits all state-owned or federally assisted institutions from racial discrimination.

One embarrassing moment emerged during the oral argument when the solicitor general, who had just attacked Harvard and UNC, tried to justify the use of racial quotas by West Point, Annapolis, the Air Force Academy and the Coast Guard Academy. She resorted to the feds' favorite shibboleth and claimed that military racial quotas were a matter of national security. The court—even its liberal membership—was unimpressed.

After 150 years of slavery and 150 years of Jim Crow, America can't shake its racial demons. All these problems were caused by governments that treated persons as chattel and enslaved and suppressed the African race. Then the problems were exacerbated when the feds

## Third World Elections - The 2022 Midterms How can America's Elections be this mismanaged?

The 2022 Midterm Elections were held four days ago in what seems to be the most chaotic election ever conducted, and we still do not even have the results in some states. What happened to Election day, where all ballots were counted on Election night? The Nation continues to patiently wait and pray for clarity to see if their candidate pulls the win out or if the radical left will somehow find the votes to 'win.'

On Election day this year, I spent most of my time collecting and aggregating news to document election-day irregularities. I will cover the anomalies that took place during the Midterm Elections on November 8, 2022.

As the polls opened around the United States, issues with voting machines and tabulators happened almost immediately.

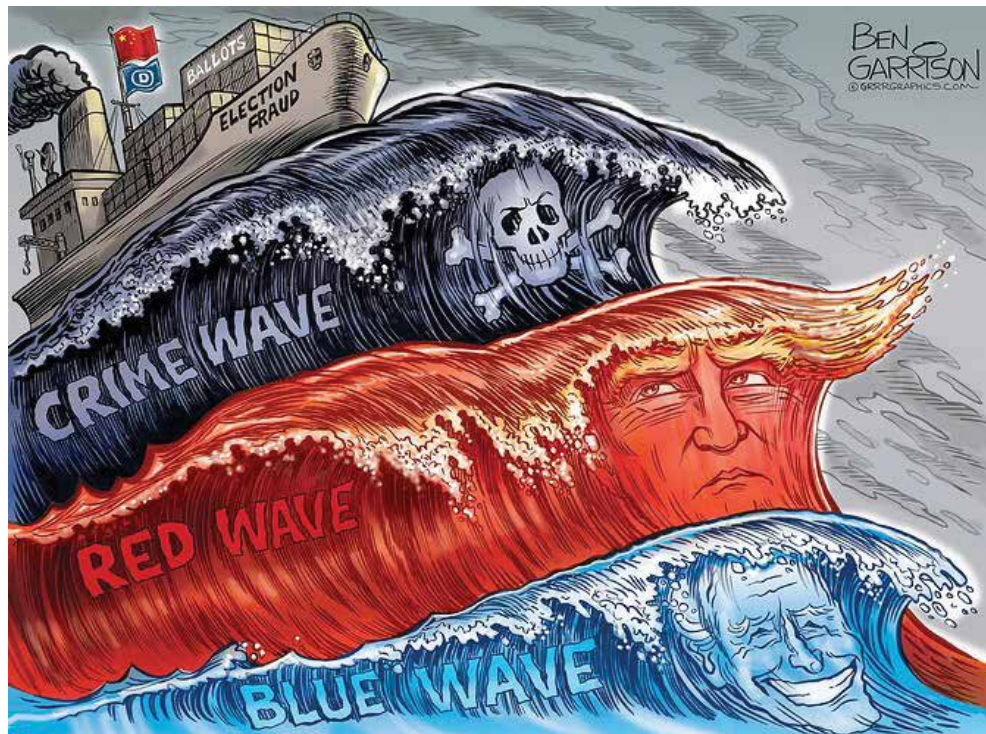
In Lexington County, South Carolina, two voting machines went down at 7:40 am after opening to start Election day.

Bell County, Texas, experienced technical glitches in its voting systems; eight polling locations were affected. However, Bell County was not the only one experiencing technical glitches that morning.

Mercer County, New Jersey, was off on election day to a horrible start. Their voting machines were reported to have had issues where all voting machines were not working "due to a printing and scanning issue with the ballots." Around noon, Mercer County Clerk Paula Sollami Covello said all votes would be correctly counted despite a "glitch with the Dominion scanners." As of 12:30 p.m., ballots were still being "manually slotted," Mercer County Superintendent of Elections Nathaniel Walker said. "There are no reports of Mercer

County voting machine tabulators in operation."

You can also add Albany County, New York, and Blount County, Tennessee, to the list of counties with voting system malfunctions early in the morning of Election day.



Randolph County, Alabama, had issues with two of the ES&S machines, which included a ballot jam and a scanner head outage, causing some voters to have to turn in their ballots by hand.

Burleigh County, North Dakota, experienced check-in issues affecting 18 polling locations.

Rockford, Illinois, also had similar check-in issues as well. Springfield, Massachusetts, had issues with faulty batteries and jammed ballots.

Cross Plains, Wisconsin, had issues with ballot scanners. The affected machine is a DS200 that scans ballots and tabulates results, according to Dane County Clerk Scott McDonell.

Floyd County, Indiana, also had problems with ballot scanners at three of their polling locations.

Reports of machines jamming at polling locations in Westerly, Rhode Island, also occurred.

Suffolk County, Nottoway County, Chesterfield County, and The City of Richmond, Virginia, reported technical issues with newly installed electronic poll books at

their polling locations. They were forced to switch to paper poll books temporarily.

In Chesterfield County, Virginia, the electronic poll books were down for a considerable period, and citizens complained about receiving the wrong ballots. One voter states, "When I went to register under my name, they said I had already voted, and I had not," he said. "The director suggested that they search my last name county-wide in Chesterfield and what came up was that everyone with my last name had already voted." The Director of Elections in Chesterfield, Missy Vera, said this was a software issue, and the problem was resolved.

Detroit, Michigan, had similar problems with its poll books and reporting glitches across the city. Some voters received in-person ballots with numbers that appeared

in an electronic poll book to have already been assigned to absentee ballots for different people, according to FOX 2, which reported that affected voters were instructed to complete a provisional ballot to be counted later. The City of Detroit, Michigan, was collecting thousands of ballots significantly after the legal deadline at 11:30 pm, which was caught on video.

Virginia also said voter machines had issues in Prince George's County, VA.

In Tulsa, Oklahoma, an investigation was launched by The Tulsa County Sheriff's Office and the Tulsa County Election Board after reports of poll workers not handing out ballots to some of the Tulsa voters surfaced on Tuesday.

North Carolina poll workers were locked out without access to the building code. In some counties, elections were delayed because of issue printing Authorization to Vote forms.

In Maricopa County, Arizona, officials say they have identified a solution after about 20% of their polling sites were experiencing issues with tabulation machines in 60 different vote centers, according to Maricopa County. According to Fox News, many tabulators had problems with the ink not showing up on the ballot correctly when printed, affecting roughly 17,000 ballots. Citizens voiced their concerns about their votes being counted here, stating, "Their voting machines are not working properly... Every single person in there is getting a misread ballot."

Voters were told to leave.

Katie Hobbs, Secretary of State in Arizona, is in charge of Elections for the State of Arizona. Katie Hobbs is also running for Governor, which appears to be a massive conflict of interest as she oversees her own election. The results of the Arizona Elections still have not been reported, and it has been four days since the elections were held.

A meltdown occurred in Allegheny County, Pennsylvania. Problems ranged from polls opening late to scanners not working to some voters being turned away when their names didn't appear on the voter rolls. The judge of elections for the polling place at Reformed Presbyterian Home on Perrysville Avenue in Allegheny County never showed up. Democratic Committee Member Jon Hanrahan stated, "She was not able to transfer the book that has all the names, addresses, and signatures to anybody else, the other poll workers. So they weren't able to open with that book. They weren't able to open with the voter roll." This created chaos in Allegheny County, Pennsylvania.

Not all the issues in the 2022 Midterms had to do with the machines. Wyandotte County, Kansas, reported that paper ballots were too large to be scanned and ballots needed to be folded to be scanned. According to Wyandotte County Election Commissioner Michael Abbott, tabulation machines at the polls could not read some of the folded ballots. "It was an issue with a crease made in the actual ballot because it's so long," and "On some of the ballots, wherever they creased them if it's in the middle of a race or a write-in line, the scanner was rejecting them," Abbott said. "We told our workers to try to flatten out the ballots, and nine times out of 10, the machine takes them."

In Lexington County, South Carolina, a man tried to steal a polling device used to sign in voters.

In Luzerne County, Pennsylvania, voters reported some machines ran out of paper, and voters were filling out provisional ballots while a poll worker drove to Wilkes-Barre to

get more paper.

Pueblo County, Colorado officials have happened upon one such instance, a poll worker named Richard Patton, who has been charged with a class 5 felony after attempting to interfere with a voting machine.



Reports of a man being electrocuted surfaced from Harris County, Texas; the unidentified man was killed in the incident, which shut down the polling location.

A polling location in New Orleans, Louisiana, was shut down because of a bomb threat.

Another bomb threat was identified in New York City the day before the Elections to discourage voters from voting on Election day.

Champaign County, Illinois, reported Cyber attacks on the network and servers during the Midterms Elections.

Poll Workers in Fulton County, Georgia, removed two poll workers for social media posts for mentioning January 6th.

In Wisconsin, an armed 38-year-old man was arrested; reports he was armed with a knife and threatening staff at a Wisconsin polling location to "stop the voting," according to the authorities.

An untold number of counties across the Nation had open Wi-Fi connections at polling locations,

and many counties offered sharpie markers instead of ballpoint pens. This information is widely available on the internet.

Not one, but two deceased candidates won their elections: Anthony DeLuca, Pennsylvania died on October 9th, 2022 but still won his race. Barbara Cooper, Tennessee, died on October 25th, 2022 but still won her race.

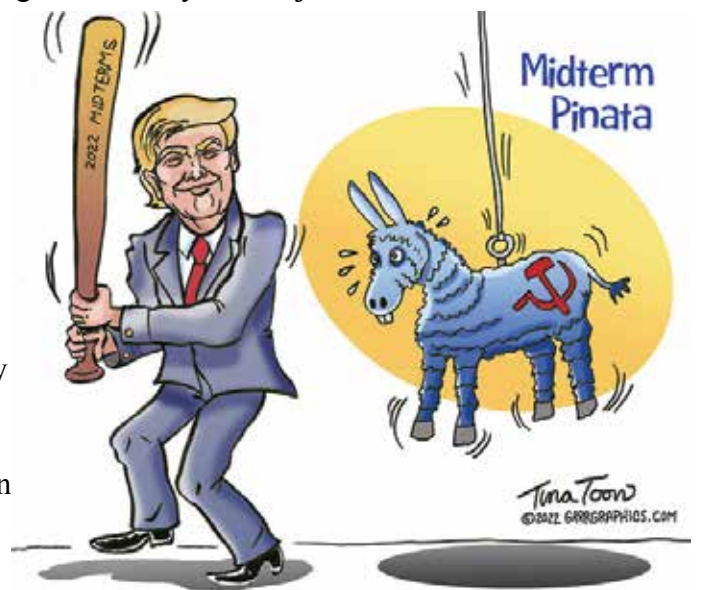
To top it all off, Microsoft issued a patch the morning of the Elections. It is illegal to update voting equipment on the same day as an election. I wonder how many counties decided to update their systems anyway.

Counties across the Nation extended polling times well past the average, and ballots still have yet to be counted. Election day has turned into Election week and this election was anything but ordinary.

## Laws governing recall in Arizona

Laws governing recall in Arizona are defined in Article 8 of the Arizona Constitution.

The authority to conduct a recall election in Arizona applies to "Every public officer in the state of Arizona, holding an elective office, either by election or appointment."

### Filing the recall petition

A recall can be filed against any public officer on any grounds. The recall may not be filed until

after the elected official has been in office in his or her first term for at least six months. This six-month limit does not apply to state legislators. In the case of state legislators, a recall petition may commence five days after the start of their first legislative session after their election. In the case of other elected officials, there is no six-month limit for subsequent terms in office.

A recall petition must be filed

at the office in which the officer being recalled files for nomination. The petition must contain a general statement explain the recall and not exceed 200 words. This petition must be signed by the sponsors who swear an oath that all signatures collected will be valid signatures.

The number of signatures required to qualify a recall attempt for the ballot is 25 percent of the number of votes cast in the last election for that office.

### Recall election

If enough signatures are gathered, a recall election will be held. All qualified candidates can run against the incumbent. Whoever gets the most votes wins the office. If the incumbent wins he/she remains in office and no other recall can take place during that term unless the proponents pay the cost of the prior recall election.

## The Money Matrix Part 4 Education (1914 - 1954)

“When a commercial bank makes a loan contract with a borrower, the bank CREATES the deposit in the borrower’s account.” Have you repeated this fact 15,000 times yet? Banks CREATE what we use as money. Those who control this ‘money power,’ have slowly changed the education of our children.

### 1913-1916 Federal Commission on Industrial Relations (The Walsh Committee)

This commission, created by the U.S. Congress, was composed of nine commissioners, all nominated by the U.S. President and confirmed by the U.S. Senate. Its chairman was Frank P. Walsh, Missouri. Congress directed it to “seek to discover the underlying causes of dissatisfaction in the industrial situation and report its conclusions thereon.”

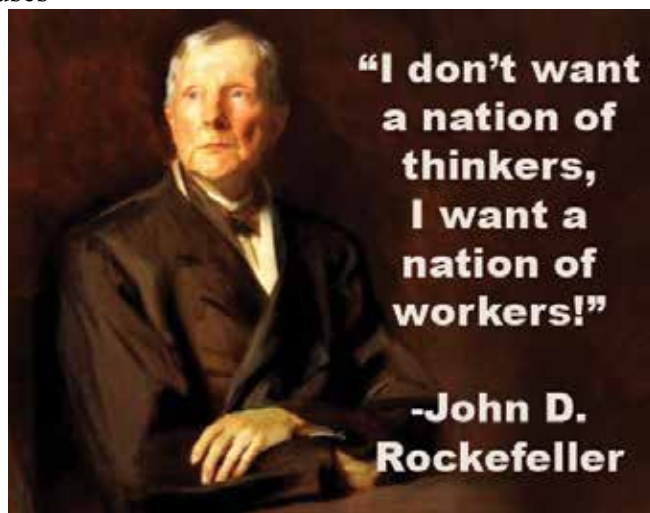
One of the conclusions reached by the Commission was: “a handful of wealthy individuals, after gaining control over a large segment of the U.S. economy, and pushing for political control of the nation, were using nonprofit foundations to gain control over the nation’s educational system...”

### Some Conclusions of the Walsh Commission:

- \* “The final control of American industry rests...in the hands of a small number of wealthy and powerful financiers.
- \* The domination...is not limited to their employees, but is being rapidly extended to control the education... of the Nation.
- \* This control is being extended through the creation of enormous privately managed funds for indefinite purposes...“foundations,” by the endowment of colleges and universities...
- \* These foundations are subject to no public control...

\* The extent of the possible influence of these foundations... for education...is shown by...the abandonment by several colleges and universities of sectarian affiliations and charter clauses relating to religion in order to secure endowments from the Carnegie Corporation and pensions for professors from the Carnegie Foundation for the Advancement of Teaching.”

Three commissioners (including the chairman Walsh) recommended the following regarding the Rockefeller Foundation: “...that appropriate legislation be passed by Congress, putting an end to the activities of this foundation... and that the charter granted by the State be revoked...” No such recommendation was legislated by Congress.



Carnegie and Rockefeller Fund a ‘New’ American Education  
The University of Chicago was founded in 1890 with Rockefeller funds. In 1902, Rockefeller funded a new School of Education, where John Dewey was appointed its Director. In 1904 John Dewey moved to Columbia University’s Teachers College, also funded by Carnegie and Rockefeller. Who was John Dewey? What was his theory of education?

Dewey had been trained by a student of Wilhelm Wundt. Wundt is the father of experimental psychology and taught at the University of Leipzig, Germany,

from 1875-1920. Wundt believed man was an animal influenced solely by daily experiences. In 1875 he established the world’s first laboratory in experimental psychology to measure individual responses to stimuli. His U.S. students learned the new science, and the Hegelian view that the State is superior to the individual. Education was not a way to teach subject matter and encourage individual curiosity and questioning. “... for Wundt, man has no self will, no self determination. Man is in effect only the captive of his experiences, a pawn needing guidance.”

Wundt’s American students returned home to teach at American universities and were awarded more than 900 doctorates

up to 1948. From these seeds “grew the vast network of interlocking schools of education and departments of psychology that dominates education today.” Was this education meant to serve children or to serve the structure of society? John D. Rockefeller believed children ought to be educated for their occupational outcome, and funded vocational training for poor children. Dewey wrote in 1898: “The plea for the predominance of learning to read in early school life...seems to me a perversion.”

### Certain Ruling Elite Support the Bolsheviks

In the January 13, 1918 issue of the New York World, William Boyce Thompson, NY Federal Reserve Bank director stated: “Russia is pointing the way to great and sweeping world changes...” The Washington Post of February 2, 1918: “William B. Thompson...has made a personal contribution of \$1,000,000 to the Bolsheviki for the purpose of spreading their doctrine in Germany and Austria.” Why

would certain capitalists ally with communists? According to author Antony Sutton: “The financiers were power-motivated and therefore assisted any political vehicle...” In other words, the paradigm of ‘capitalist’ versus ‘communist, socialist’ is a fiction, generated by the top power elite. the AHA (American Historical Association). In 1934, AHA's Committee of History and Other Studies in the Schools published a book, Conclusions and Recommendations for the Social Studies. This committee was funded by a \$340,000 grant by the Carnegie Foundation of New York. Here are some of the conclusions and recommendations: "The Commission...was impelled to consider the conditions and prospects of the American people as a part of Western Civilization merging into a world order. (p.1)" "...American civilization...is modifying its traditional faith in economic individualism, and is embarking upon vast experiments in social planning and control which call for large-scale cooperation on the part of the people...(pp.1-2)" In 'Appendix A - Next Steps' can be found: "The American Historical Association, in cooperation with the National Council of the Social Studies, has arranged to take over The Historical Outlook (a journal for social science teachers)...The purpose of the Outlook...to furnish as rapidly as possible various programs of instruction organized within the frame of reference outlined by the commission."

\* 1954: The Reece Committee Investigates Tax-Exempt Foundations and Education  
 \* In 1953 the House of Representatives established a committee to investigate tax-exempt foundations and education,

chaired by Rep. Reece (Tenn.), with Norman Dodd as research director and Thomas McNiece his assistant.

McNiece issued a report documenting that, from 1915 through 1952, the Rockefeller foundations had given grants of 61 million dollars to eleven associations, including the NEA and AHA; from 1902-1951, Rockefeller foundations gave grants of 290 million dollars to universities; from 1911 to 1950, the Carnegie Corporation contributed 25 million dollars to educational purposes.

Dodd's report warned the Congress and American people of the interlock between the tax-exempt foundations and their educational associations, and ended with this: "CONCLUSION: It seems incredible that the trustees of typically American fortune created foundations should have permitted them to be used to finance ideas and practices incompatible with the fundamental concepts of our Constitution. Yet there seems evidence that this may have occurred."

The Dodd Report was immediately attacked from many quarters, and the investigation shut down.

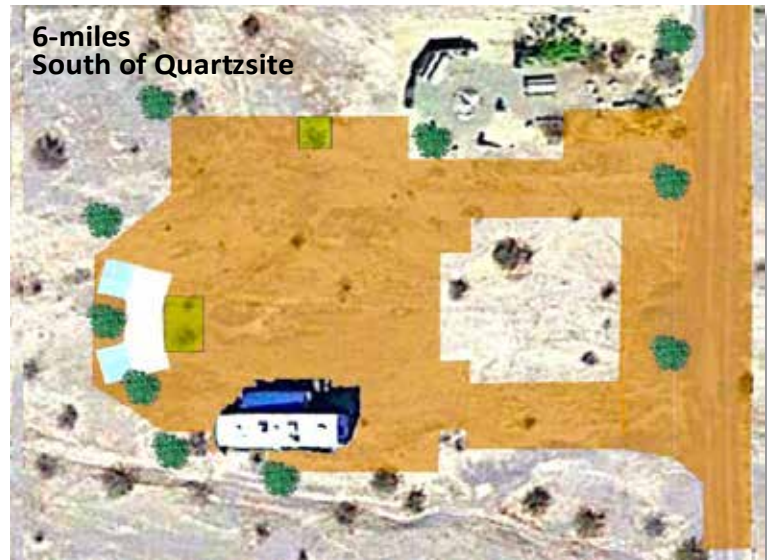

When we unitedly accept this responsibility and properly manage our employees, we can finally be free, not a minute sooner. We will accomplish this great work! Let's just hope that we can motivate ourselves to action, rather than being starved into action.

## Better Health: Organic Food The evidence is in.

I used to be somewhat skeptical on the importance of eating organic foods. Then in 2018, an important paper in JAMA came out. That study showed that eating a higher proportion of organic food is inversely associated with the overall risk of cancer (P for trend = .001). Inversely associated in this case means that the more organic foods in the diet, the less cancer. Since then, numerous other peer reviewed papers have been published documenting the benefits of eating organic food. Recently, some important studies have been done that show very strong correlations between pesticide and herbicide use and various diseases.

There are many reasons to eat organic, but reducing the residues of Roundup (glyphosate) and other chemicals on foods is a big one. Today, I am going to list the issues with commercially grown food and

then simply present some of the peer reviewed papers that show the importance of eating organic foods. Some of these articles are scientifically complex. However, the bulleted points should be clear enough -for those that don't feel like diving into the science.

If one can't afford to eat organically, the other big message is to read food labels for "country of origin." These days, that can be difficult to determine - due to the issuance of the USDA "Cool rules." Under these guidelines, processed foods do not need to require a country of origin labeling, if they are assembled or combined in the USA. But even still, read those food labels - they matter!

Cool rules do not require country of origin labeling for processed foods: Processed food exclusion is based on two guidelines:

1) Products that are changed in character. Examples include: orange juice, bacon, etc.

2) Products that are combined with other products to make a new product.

So what have studies shown about eating organically to avoid herbicides, such as Roundup and other pesticides?

- \* A higher frequency of organic food consumption is associated with a reduced risk of cancer.
- \* Roundup™ exposure has been associated with an increased risk of Parkinson's Disease and death of neurons in the substantia nigra.
- \* There is evidence implicating Roundup™ as a factor in the elevated risk of autism.
- \* Other studies have shown the effects of Roundup™ on synaptic transmission in animal and cellular studies. The major mechanism of action appears to be oxidative stress, accompanied by mitochondrial dysfunction.
- \* Some gut bacteria utilize the enzyme used by plants, and glyphosate and Roundup™ use has been shown to alter the gut microbiome. There is a large and growing body of evidence that the gut microbiome alters susceptibility to a great number of human diseases, including nervous system function.
- \* The weight of the evidence indicates that in addition to cancer and reproductive effects, glyphosate and Roundup™ have significant adverse effects on the brain and behavior and increase the risk of at least some serious neurological diseases.
- \* Increasing evidence shows that glyphosate and glyphosate-based herbicides exhibit cytotoxic and genotoxic effects, increase oxidative stress, disrupt the estrogen pathway, impair some cerebral functions, and allegedly correlate with some cancers.
- \* Glyphosate effects on the im-



mune system appear to alter the complement cascade, phagocytic function, and lymphocyte responses, and increase the production of pro-inflammatory cytokines in fish.

- \* In mammals, including humans, glyphosate mainly has cytotoxic and genotoxic effects, causes inflammation, and affects lymphocyte functions and the interactions between microorganisms and the immune system.
- \* There is evidence in support of the hypothesis that residential pesticide exposure from agricultural applications is associated with an increased risk of thyroid cancer.
- \* A large subset of the population has been exposed to glyphosate and there are studies showing the detrimental effects glyphosate exposure has on the brain and human health.
- \* Using roundup as a desiccant for crops "is a thing." Although farmers in the USA are somewhat sensitized to the issue, there are no controls on imported cereal grains and oil crops. In particular, corn, soy and oats harvesting often includes the use of a desiccant, such as Roundup.
- \* Unacceptable levels of glyphosate (Roundup) are found in commercially grown cereal grains, particularly breakfast oats and other foods. Organically grown cereal grains have very little Roundup residues when tested.

Delegates started gathering in Philadelphia for the convention in May, 1787. In the next five months the men argued over every point imaginable. The new Constitution wasn't perfect and they knew it. Benjamin Franklin's speech at the end of the convention wisely explained:

"...in these Sentiments, Sir, I agree to this Constitution, with all its

Faults, if they are such: because I think a General Government necessary for us, and there is no Form of Government but what may be a Blessing to the People if well administered; and I believe farther that this is likely to be well administered for a Course of Years, and can only end in Despotism as other Forms have done before it, when the People shall become so corrupted as to need Despotic Government, being incapable of any other."

He was correct. Any form of government depends on the management of its design to survive. Today, despite the beauty of our constitution's design, we have many violations by the managers, such as promoting various riots, defunding the police, opening the borders to invasion and printing too much paper money, all outside of the design of our founders and against all warnings. The respect for our Constitution is of no concern to our current leaders, along with their lack of respect for morality and life itself.

## The Illusion of Truth: How Pharmaceutical Interests Persuade Vaccine-Hesitant Parents

“If thought corrupts language, language can also corrupt thought”—George Orwell, On Politics and the English Language

*Say it enough times, they will believe it is true.*

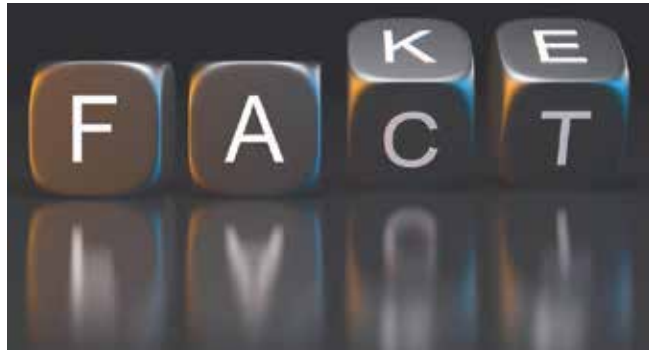
Safe and effective. It’s a phrase repeated ad nauseum in sponsored advertisements, on mainstream news, and by health agencies all over the world. It’s a phrase synonymous with pharmaceutical drugs, but particularly

with vaccines. Breathing the words safe and effective next to vaccines appeared as early as 1916 in The British Medical Journal in a study that attempted to make “a Safe and Effective Bacillus Dysenteriae (Shiga) Vaccine.” But it wasn’t really deployed in advertising until the last decade when researchers found that vaccine-hesitant people “are unlikely to be swayed by any amount of evidence” and the best tact would be to “refocus attention” on the positives of vaccines (Schwartz, 2012, pp 53). This basic mantra of safe and effective has been parroted so frequently, it has capitalized on a phenomenon known as the illusory truth effect, which establishes the illusion of truth—this studied phenomenon occurs when people are exposed to the same information repeatedly, and they believe it to be true, even

if the information is a lie (Hasher, Goldstein & Toppino, 1977).

**Use pushy tactics on parents and repeat... repeat what is good... good.**

A small study in Pediatrics evaluated the vaccine discussion with parents and found that providers who took a presumptive



approach, i.e., “Johnny needs three vaccines today” rather than inviting a participatory approach, i.e., “Would you like Johnny to have vaccines today?” were able to convince parents to vaccinate at 74 percent versus four percent acceptance (Opel et al., 2013). And when some vaccine-hesitant parents voiced initial resistance, providers incessant with their recommendation, i.e., “Johnny really needs his shots,” or “If he were my child, I would get them” were able to get acceptance from previous vaccine refusers 47 percent of the time. The authors comment in their discussion that “shared decision-making is typically not indicated when there is only one medically acceptable choice,” although they do admit that this is a value-laden decision and that

many pediatricians will have to balance this out. While this study evaluates linguistic opportunities for doctors recommending the vaccine schedule, it also promotes rail-roading parents into unwanted medical procedures, which is at best unethical, and at worst an abuse of power.

This kind of medical coercion is also recommended by the CDC on its YouTube channel, encouraging presumptive language and squawking vaccine mantras. Dr. Tolu Adebajo shows providers how she iterates to parents that “vaccines are safe and effective, and they’re held to high safety standards. [She] also tell[s] parents that there’s no evidence to suggest that vaccines have any long-term harm, and that the risk of getting the disease if [the child is] not vaccinated, far outweigh any risk of the vaccine itself” (CDC, 2019). And unfortunately, these blanket statements neglect evidence that suggests some vaccines do have serious long-term effects to some children, a plethora of which can be seen in the CDC’s own

Vaccine Adverse Event Reporting System (VAERS). The video continues with a chilling warning: “by not vaccinating their child,

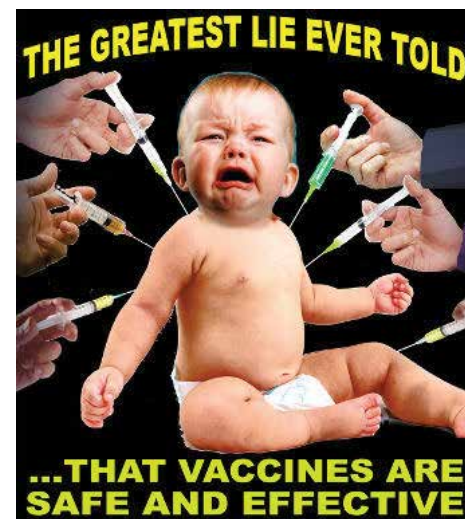
they actually put their child at risk for possible infection and long-term harm in the future.” Parents are all too familiar with these kinds of discussions with pediatricians and are often coerced to sign forms (template provided by the American Academy of Pediatrics) accepting responsibility for willfully endangering their child and others by not vaccinating.

**Hire specialists for language manipulation, repeat ad nauseum.**

The CDC isn’t the only one interested in what it takes to persuade vaccine-hesitant-consumers in December of 2020, Frank Luntz, well-known political pollster, assisted the Biden administration to find out what words would sell Covid vaccines to the American people (Dima, 2021). Luntz often uses focus groups to narrow down favored language, and is responsible for politicians changing key phrases like estate tax to death tax and global warming to climate change (Curran, 2019).

For the Covid vaccines, Luntz surveyed 1,400 registered voters and found they favored medical researchers over drug companies, and a transparent, rigorous process instead of

how much spent, and number of participants, and using and repeating “the word ‘every’ to explain the vaccine development process: for example, ‘every study, every phase, and every trial was reviewed by the FDA and a safety board’” (de Beaumont, 2020). Little tweaks here and there that seem pretty innocent, but have a profound impact on how the public perceives vaccines, and represent a stark contrast from reality. Do drug companies research their own products? Was it really a transparent process? It’s interesting to note that out of those polled in December of 2020, only 56 percent (de Beaumont, 2020) said they thought Covid vaccines were safe, and almost two years later, there has been a 79 percent uptake of one dose according to The New York Times. It would appear the messaging was successful. But it turns out Luntz isn’t entirely neutral in the vaccine game as Pfizer is listed among his clients on the Luntz Global website, which could impact survey questions, their premises and how they may or may not reflect truth in the final messaging.

Mix science and propaganda until everyone forgets what is what: The conflation of truth and persuasive messaging for vaccinations isn’t new; in an article published in The Lancet in 1938, Dr. Okell, an expert in infectious diseases, describes the state of vaccinology at the time as a marriage between science and propaganda: “The immunization of the masses has been undertaken with almost a religious fervor... Without

propaganda there can, of course, be no large-scale immunization, but how perilous it is to mix up propaganda with scientific fact. If we baldly [in plain or basic language] told the whole truth it is doubtful whether the public would submit to immunization” (qtd. in Humpries & Bystriany, 2015, pp. 450-451). And there lies the rub—if parents are given full informed consent, knowing all the potential risk as well as the coercive techniques employed to achieve vaccine compliance, would we have a childhood vaccine program?

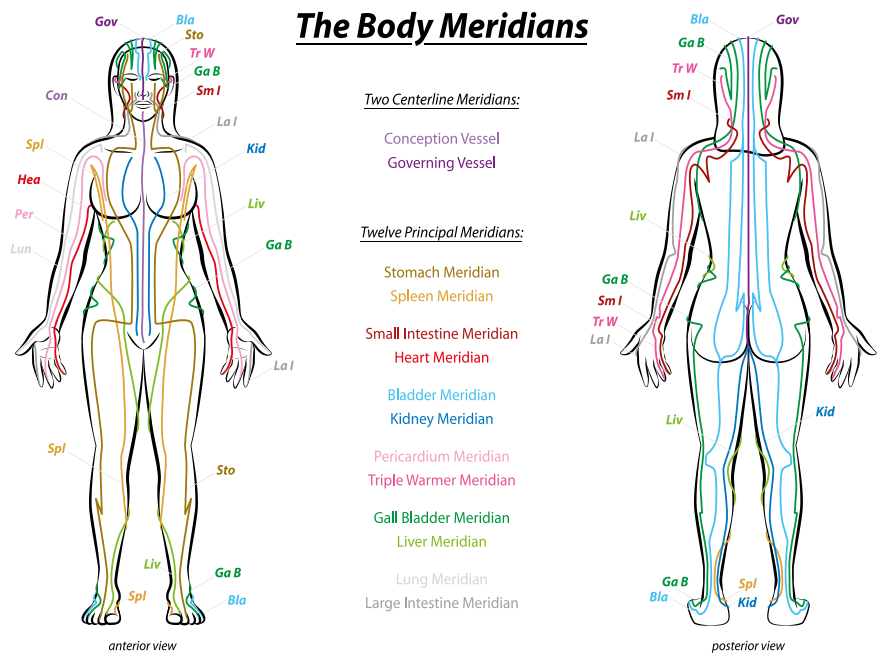
After all, in an interview on PBS Frontline, Luntz is asked about whether he is responsible for the messaging he gathers from his research to which Luntz replies, “No, because I’m a language guy; I’m not a policy guy. I know that my responsibility is to learn how to communicate, and I leave to others the decision of policy.”<sup>2</sup> But in order to make sound policy decisions, the truth (not just favored words) must be communicated. And if vaccines have risk, parents should be informed about those risks and they should be able to have honest, collaborative discussions with their doctors, not talked down to as if they are dolts worthy of a CPS call. The words we choose to talk about this, are everything. The masses are immersed in the trance of the illusory truth effect, and we must adapt our language to wake them.
