Supreme Court Considers Case Seeking to Overturn 2020 Presidential Election

While there has been much public attention on the U.S. Supreme Court's present consideration of the "independent state legislature" theory in Moore v. Harper involving North Carolina's redistricting, that case would not immediately upend the 2020 Presidential Election. In contrast, a little-known case that appeared recently on the Court docket could do just that. The case of Brunson v. Adams, not even reported in the mainstream media, was filed pro se by ordinary American citizens – four brothers from Utah — seeking the removal of President Biden and Vice President Harris, along with 291 U.S. Representatives and 94 U.S. Senators who voted to certify the Electors to the Electoral College on January 6, 2021 without first investigating serious allegations of election fraud in half a dozen states and foreign election interference and breach of national security in the 2020 Presidential Election. The outcome of such relief would presumably be to restore Donald Trump to the presidency.

The important national security interests implicated in this case allowed the Brunsons to bypass an appeal that was frozen at the U.S. Court of Appeals for the 10th Circuit and get the case to the Supreme Court which has now scheduled a hearing for January 6, 2023. The Brunson Petition for a Writ of Certiorari would require the votes of only four Justices to move the case forward.

It seems astounding that the Court would wade into such waters



two years to the day after the Congressional vote to install Joe Biden as President. But these are not normal times. Democrats may well push legislation in this month's lame duck session of Congress to impose term limits and a mandatory retirement age for Justices, and thereby open the door to packing the Court. Such a course would seem to be clear violations of Article III, Section 1 of the Constitution which provides that Justices "shall hold their Offices during good Behavior." In addition to such institutional threats to the Supreme Court, several Justices and their families have been living under constant threats to their personal security since the overturning of Roe v. Wade.

Perhaps these institutional and security threats have provided powerful incentives for the Court to put Brunson v. Adams on its dockets as a shield to deter any efforts by the lame duck Congress to infringe on the Court's independence. Or perhaps conservatives on the Court are serious about using the Brunson case as a sword to remove public officials who they believe have violated their constitutional Oaths of office by rubber-stamping

Electors on Jan. 6th without first conducting any investigation of serious allegations of election fraud and foreign election interference.

Moreover, recent weeks have brought a cascade of news suggesting the likelihood of an impending constitutional crisis that could be difficult to resolve without the Court's intervention. It is now clear that the Federal Bureau of Investigation (FBI) was colluding with social media giants Twitter and Facebook to censor news of Hunter Biden's laptop in the weeks leading up to the 2020 election – a most egregious First Amendment violation intended to rig the election outcome and perhaps to install an unaccountable and criminal puppet government. Meanwhile, the January 6th committee may soon send a criminal referral to the Justice Department to arrest President Trump even though his reinstated tweets are a reminder that he was not calling for insurrection but for peaceful protest on January 6th. More recently, the Department of Homeland Security's Cybersecurity and Infrastructure Security Agency (CISA) was reportedly working with Big Tech to censor election critics. ****Continues on Page 27****

Russian President's Statement On 'Increasing' Threat Of Nuclear War Sends Crypto Market Fumbling

The cryptocurrency industry is still bleeding from the implications of the epic collapse of the crypto empire FTX, and Bitcoin and Ethereum are just starting to climb back from a much higher price level. But it looks like a recent statement from Russian President Vladimir Putin about the "increasing" threat of nuclear war has once again sent waves of fear in the crypto market.

Putin provided an update on the ongoing war between Russia and Ukraine in a televised Human Rights Council meeting held Wednesday. The leader of the transnational country underlined that its own nuclear arsenal is purely the country's defensive measure, shooting down speculations that Russia has "gone mad."

"The threat of nuclear war is increasing, but Russia will not use the nuclear weapons first, however, it will not use the nuclear weapons second, because it will not be possible after [the] nuclear strike on Russia," Putin said, as per the translation provided by Liveuamap.

About the use of nuclear tactical weapons, the Russian president reportedly put the blame on the "Americans, who have nuclear weapons in other countries," noting that "Russia is not going to deploy tactical weapons in other countries."

Using his preferred term for the invasion of Ukraine that started in February, Putin mentioned that "as for the duration of the special military operation, well, of course, this can be a long process," Reuters reported.

"We haven't gone mad, we realize what nuclear weapons are," the Russian leader added, as per the outlet. "We have these means in more advanced and modern form than any other nuclear country ... But we aren't about to run around the world brandishing this weapon like a razor."

Following Putin's statement, Bitcoin traded at \$ 16,807, a meager 0.47% dip from its price of \$16,885 a few hours before the Human Rights meeting. Ethereum also saw a similar dip and traded down 0.53% at \$1230.49 from \$1,230.49.

Both crypto assets have slowly recovered from the fumble as of 4:20 a.m. ET on Thursday. Bitcoin was trading up 0.15% at \$16,833.54 with a 24-hour volume of \$17,260,642,258. Ethereum was also trading up 0.28% at \$1,233.20 with a 24-hour volume of \$4,645,329,414, based on the latest data from CoinMarketCap.

The crypto market has been forging under a bitter environment since May after Terra's implosion. The bear market later witnessed yet another crypto collapse, and it was triggered by FTX, which filed for bankruptcy of its over 100 affiliates.

Many countries in various parts of the world are currently facing recession, with some experiencing never-before-seen inflation levels, and nuclear war is NOT what anyone wants.

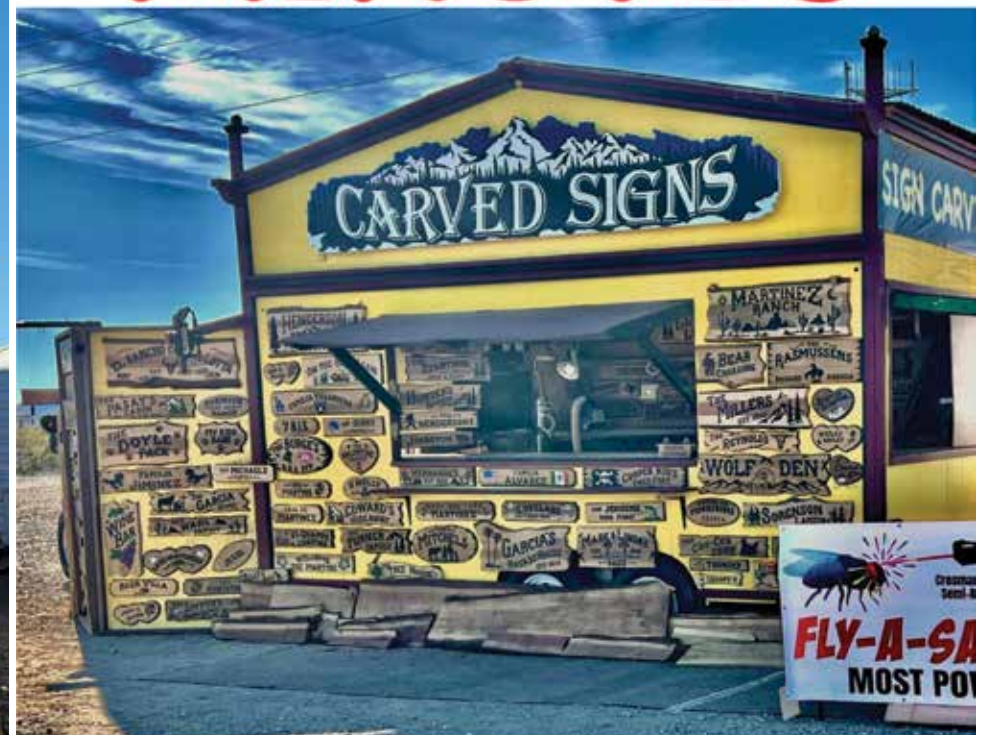

‘I Also Orchestrated It’: Uncharged J6 Witness Ray Epps Transcript Released

Ray Epps, the uncharged man identified as a key instigator behind the January 6, 2020 Capitol Breach for telling people to storm the Capitol, said in a text message to his nephew that he “orchestrated” things, according to newly released witness transcripts from the January 6th Committee.

“At that point, I didn’t know that they were breaking into the Capitol,” Epps told Congressional investigators, adding “I didn’t know anybody was in the Capitol. ... I was on my way back to the hotel room.” But the night before, Epps was seen going around to various groups of Trump supporters, telling them they need to storm the capitol.

In two interviews with the FBI in 2021, Epps explained his actions on Jan. 5 and Jan. 6. He admitted he was guilty of trespassing on

restricted Capitol grounds and confessed to urging protesters to go to and into the Capitol on Jan. 6.

Epps also told members of the Committee that he found himself playing peacekeeper between Trump supporter “Baked Alaska” and the police - who called Epps a Fed. “I was trying to find some common ground,” said Epps. “This guy was trying to turn people against me...he was calling me ‘boomer,’ and it’s his generation’s fault that we’re in the position we’re in.”

Despite the admissions, the FBI never arrested Epps and he was not charged by the U.S. Department of Justice with any Jan. 6 crimes.

Their non-action has fueled a crop of theories that he might have been working for the FBI or another agency.



Epps, 61, has repeatedly denied those suggestions through his attorney.

Speculation that Epps was a ‘fed’ intensified after a Revolver News reported with the headline: “Meet Ray Epps: The Fed-Protected Provocateur Who Appears To Have Led The Very First 1/6 Attack On The U.S. Capitol”

Revolver also determined, and will prove below, that the the FBI stealthily removed Ray Epps from its Capitol Violence Most Wanted List on July 1, just one day after Revolver exposed the inexplicable and puzzlesome FBI protection of known Epps associate and Oath Keepers leader Stewart Rhodes.

July 1 was also just one day after a separate New York Times report amplified a glaring, falsifiable lie about Epps’s role in the events of January 6.

Lastly, Ray Epps appears to have worked alongside several individuals — many of them suspiciously unindicted — to carry out a breach of the police barricades that induced a subsequent flood of unsuspecting MAGA protesters to unwittingly trespass on Capitol restricted grounds and place themselves in legal jeopardy. -Revolver News As speculation over Epps grew, Rep. Adam Kinzinger (R-IL) claimed that Epps had “cooperated with the Jan 6 committee,” and was removed from the FBI’s most wanted list “because apparently he broke no laws.”

We’re sure Epps, who claims he wasn’t working for the feds, ‘cooperated’ indeed.

Pinal County Officials Stayed Mum About Vote Count Discrepancies During Election Trials

The judge presiding over Abe Hamadeh's election challenge dismissed the case Dec. 23 without knowing that Pinal County would admit a few days later to mishandling hundreds of ballots that contained votes in the Attorney General race. Instead, numerous Pinal County officials—including the board of supervisors, County Attorney Kent Volkmer, and two elections directors—kept the substantive information from Mohave County Judge Lee Jantzen, the candidates, and voters across the state.

It is the latest in a series of questionable decisions related to Pinal County's elections. In August, then-Elections Director David Frisk lost his job after a botched Primary Election. Days later, County Recorder Virginia Ross resigned to temporarily take over the beleaguered and understaffed elections department. Her four-month contract the county approved for Ross included \$175,000 in salary and the potential for an additional \$25,000 if the General Election ran smoothly.

ELECTIONS DIRECTOR FIRED: Roll, an attorney who previously worked for Volkmer, recently became elections director when Ross departed. District 5 Supervisor Jeff Serdy takes over as Pinal County's board chairman on Sunday. He told Arizona Daily Independent he and others were "unsure of what we could and couldn't talk about" related to the county's election problems once a statutory recount for the AG and Superintendent of Public Instruction races was ordered in early December.

Serdy's first board meeting as chairman on Jan. 3 will include a discussion of the 2022 election cycle. The agenda notes this will include follow-up by staff about what happened as well as issues moving forward. "We're going to be an open book," Serdy said, adding it is very frustrating to see voters have doubt in the county's efforts. But a growing number of voters are calling on the board to issue subpoenas and take sworn testimony as to who knew what and when. It is an option District 1 Supervisor Kevin Cavanaugh says he could support. "I am advocating for a very trustworthy election

that our voters can count on," Cavanaugh said Saturday after acknowledging there appeared to be problems with the county's General Election before the canvass vote was held to certify the results.

Instead, those concerns were "kept in-house" while

a push was made by some staffers and officials to conduct the canvass sooner than later under Ross's leadership of the elections department. That canvass took place Nov. 21, even though the county had until Nov. 28 to complete the task. Cavanaugh recalls thinking at the time it felt rushed. "I didn't understand why we were doing it so soon," he says.

It is now known that multiple issues were identified with the tabulation of ballots prior to canvassing. Volkmer was notified, as was the county's election system vendor, ES&S. There were also concerns raised about the accuracy of the vote count when staff and volunteers conducted the mandatory post-election hand count audit.

"One factor underlying this disparity is that the canvass was filed prior to taking an adequate opportunity to investigate any possible anomalies we could discern from polling place returns," new Elections Director Geraldine Roll wrote to the Arizona Secretary of State's Office. "Unfortunately, before the analysis was completed, the canvass was downloaded and filed." Further errors with Pinal County's election were discovered during the statewide mandatory recount of the AG and Superintendent's races. As a result, the county issued a recount report to the secretary of state showing 392 more voters for Hamadeh and 115 more for Kris Mayes than what was included in the Nov.21 canvass.

RECOUNT REQUIRED:
Roll added in her Dec. 21 recount

memo that the county believes the recount vote report for the two statewide races "to be accurate and the discrepancies between the recount and the canvass were the results of human error." On Dec. 29, Maricopa County Judge Timothy Thomason announced the results of the recounts from all 15 counties. The judge declared Kris Mayes the new attorney general by a margin of only 280 votes out of more than 2.5 million counted in the race. Mayes entered the recount 511 votes up on Hamadeh.

Separate from the recount, Hamadeh filed an election challenge on Dec. 9 in Mohave County seeking to put forth evidence that ballot tabulation errors cheated him of votes. The Pinal County board as well as the county recorder were named as defendants along with the other counties. As a named defendant, Pinal County took a nominal position which meant they would not make arguments in the case but agreed to comply with any orders of the court. However, several attorneys who are not involved in the election challenge say nothing prevented Volkmer, the county attorney, from briefing Judge Lee Jantzen about the county's tabulation problems. If Volkmer was truly concerned about violating any confidentiality order in the recount case, he could have asked Judge Thomason for permission to brief Jantzen. Instead, Pinal County officials stayed quiet while Hamadeh's lawsuit was dismissed. Hamadeh has announced he is considering appeal options.

Kari Lake Trial: Surprise! Judge Finds No “Evidence” of Election Day Misconduct

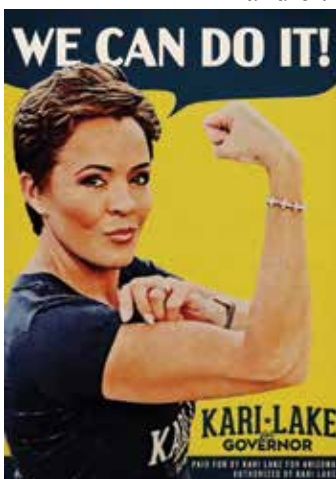

Maricopa County Superior Court Judge Peter Thompson issued a verdict Saturday ruling against the claims of GOP gubernatorial candidate Kari Lake’s lawsuit challenging the election results of the Arizona governor’s race and accusing her Democratic opponent Katie Hobbs and the Maricopa County Board of Supervisors of election misconduct.

In his ruling, Judge Thompson did not find any “clear and convincing” evidence of the two counts he was willing to consider in Lake’s ten-count filing: 1) that printer and tabulator malfunctions contributed to misconduct impacting the result of the election; and 2) ballot chain of custody violations were in violation of state law and that such misconduct impacted the results of the election.

The court’s ruling further ordered the “timely” confirmation of Hobbs as Arizona governor-elect on January 2nd.

The verdict comes on the heels of a fast-paced, two-day evidentiary trial held in Maricopa Superior Court to determine if the changes in printer settings and tabulator errors that occurred in roughly 59 percent of polling centers throughout Maricopa County — home to 60 percent of the state’s voters — on Election Day made it impossible for some voters to cast their ballots. The county says the “root cause” of the printer malfunctions is being investigated. But as Lake’s attorney Kurt Olsen, pointed out: “Why are we doing a root cause analysis now if the modification had arisen in three prior elections? It doesn’t make sense.”



Judge Thompson’s ruling acknowledged the “anger and frustration” of voters who were “inconvenienced” in the election. He noted that setting aside the results “has never been done in the history of the United States,” according to the Los Angeles Times.

“But this Court’s duty is not solely to incline an ear to public outcry,” the judge continued. “It is to subject Plaintiff’s claims and Defendants’ actions to the light of the courtroom and scrutiny of the law.”

Lake’s lawyers presented to the court hundreds of sworn affidavits as testimony to the chaos that ensued as a result of the printer/tabulator issues, which lasted in some polling centers from morning to evening. This created extraordinarily long lines and frustration among voters. They also provided reports from whistleblowers who swore under oath they witnessed chain of custody violations at Runbeck Election Services, the third-party company outsourced by Maricopa County to handle the counting of Election Day ballots.

A witness for Lake, Rich Baris, director of Big Poll Data, testified on Thursday that after more than six years of conducting exit voting polls, he had seen things in Arizona he had never seen before.

“Pre-election day polling is very different from Election Day polling.

Election Day voters go to their polling stations. What we saw this time was such a disparity between early voting and election day voters. There was no good reason why voters who had been voting for decades did not complete the exit poll,” he testified.

“The lines were too long,” he continued. “Many said they would return but many did not. These

thousands of people did not get to vote based on the issues that arose in Maricopa County. The tabulator and printer issues and long lines.” According to Baris’s research, more than 16 percent of voters and up to 20 percent did not cast their ballots on Election Day owing to the confusion and chaos. “I err on the side of believing the American voter when I hear from so many. Tens of thousands of voters were disenfranchised,” he said.

The defense team’s expert witness, University of Wisconsin Political Science professor Kenneth Mayer, called Baris’s research pure speculation that lacked statistical support. Yet as Baris repeated, “a range of issues occurred on Election Day, and that is enough to have changed the outcome of the election.”

Following the trial, Lake told reporters that “we proved without a shadow of a doubt that there was malicious intent that caused disruption so great it changed the result of the election.... Our elections in this country are a mess,

and I am glad to stand up and say no longer will we put up with this. We demand fair, honest, transparent elections and we will get them.” Lake announced on her Twitter account Saturday that she will appeal the decision, writing: “My Election Case provided the world with evidence that proves our elections are run outside of the law. This Judge did not rule in our favor. However, for the sake of restoring faith and honesty in our elections, I will appeal his ruling.”

“They didn’t follow the law and we have a manifestation that is still unexplained,” said Lake’s attorney Olsen. “On November 9, the reported count is still 29,000 ballots less than on November 10. On the day of the election, they put out what the count is and then the day after the election, magically 20,000 plus ballots appear? The law is there for a reason.”

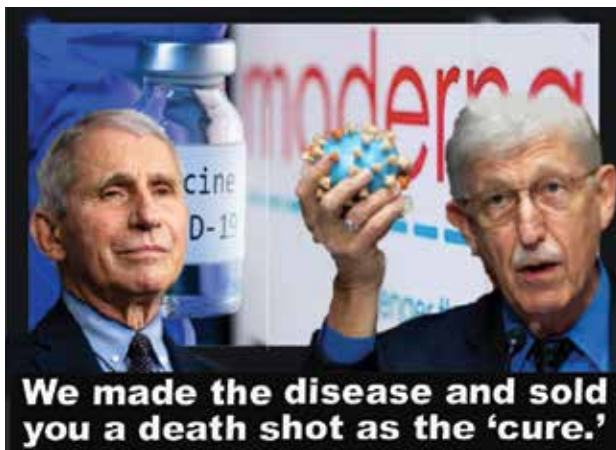

BlackRock Logo To Be Added To Ukrainian Flag

Kyiv has announced the addition of a fifth corporate logo to the Ukrainian flag following news that BlackRock will be playing a crucial role in the reconstruction of the nation. The world's largest investment management firm will join Raytheon Technologies, Northrop Grumman, Lockheed Martin, and McDonald's upon the now-omnipresent blue and yellow flag.

"I understand some Ukrainians may be frustrated at the continual additions

to our nation's glorious flag," Ukraine's President Zelensky said during a speech announcing the change. "Just last month we added the Raytheon logo, and now we're adding BlackRock. I am sure it was a bit awkward for our American friends as they were continually adding stars to their flag back when they were adding lots of new states to their republic, too."

"The only difference is instead of adding states, we're adding multinational megacorporations," the leader said. Zelensky then took a large bite of a McDonald's Big Mac™, saying, "Mmm mmm, I'm lovin' it!" in English, eliciting awkward applause throughout the Walt Disney Company Presidential

Press Hall.

Critics have complained that BlackRock's new role in Ukraine could draw accusations of corruption, with some noting that the company's managing director Eric Van Nostrand was hired straight into a senior advisory position in the Biden administration's Treasury Department just this past August, explicitly to shape US economic policy on Russia and Ukraine.

Others have noted that BlackRock is a top beneficial owner of shares in major arms

#2 It is propagated that the role of the government is to safeguard public health. The government’s job is not to protect your health. The role of the government is to protect your rights.

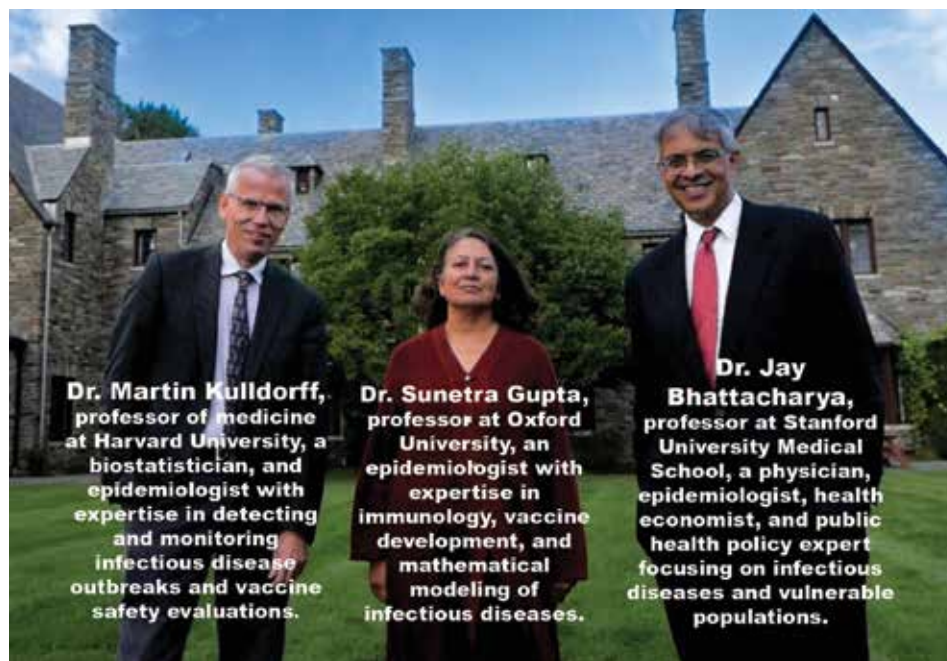

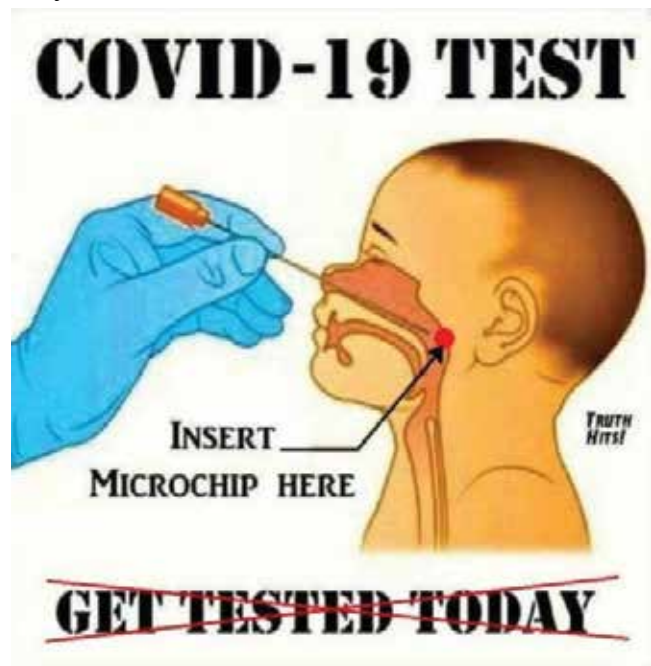
#8 Unchecked power.

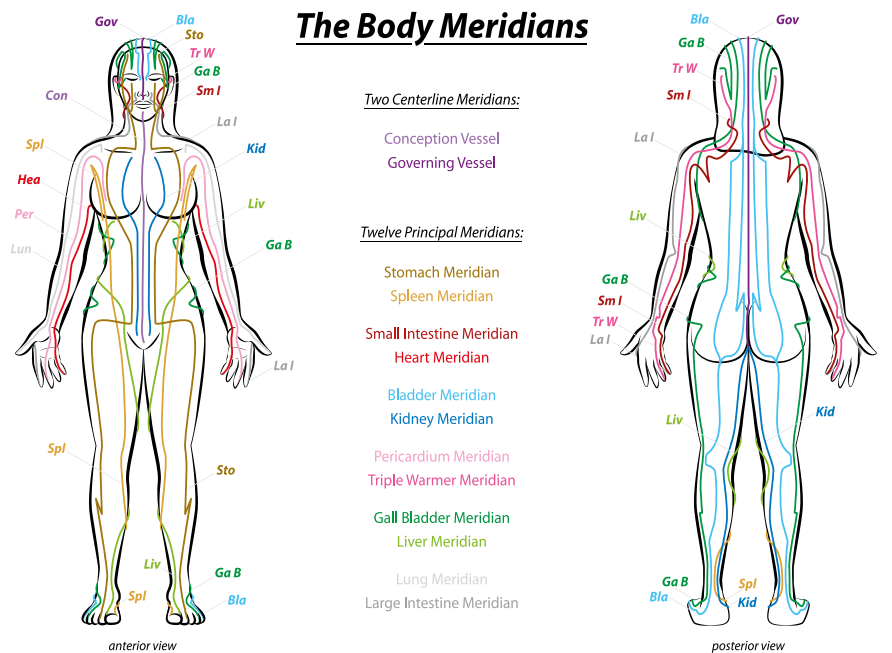

15 Best Things to Do in Quartzsite (AZ)

Quartzsite, Arizona is usually a tumbleweed town of nearly 4,000 people [closer to 3000 as of this publication] though at certain times of the year, its population swells to nearly a million, making it larger than cities like Baltimore and Tucson.

The summer weather in Quartzsite is similar to that inside a pizza oven, but in the fall, winter and spring, it's mild and sun-filled – and at night, can get surprisingly chilling.

For much of the year, it's little more than a curiosity, where most people stop for gas or a cup of coffee on their trips between Phoenix and Los Angeles.

Below are 15 things to do in Quartzsite that you won't want to miss.

1. Quartzsite Annual Mineral Shows and Swap-meets

Considered by many to be the largest rock and gem show in the world, Quartzsite's Annual Mineral Show and Swap Meet is held in January and February, a time when the usually scorching Arizona desert is mild and wonderful.

Full of rock-hounds, jewelers and crystal lovers from all over, the population of lonely Quartzsite increases exponentially during the show.

Even if rocks and cool crystals aren't your things, it's a great way to escape the harsh winter, rub elbows with some unique folks and just have

an all-around good time.

There are plenty of RV sites in the area too if you'll be bringing your house on wheels.

2. Castle Dome Museum

There aren't many places more fun and eerie to explore than real live ghost towns, and Arizona is full of them.

Most are old, pioneer-day mining towns that went bust, leaving empty and weathered assay offices, saloons and brothels standing like sentinels of a bygone era.

For much of its history dating back to the 1860s, Castle Dome was such a town, though it was a lively place for a few decades.

The town did a stint as a training facility for soldiers heading out to fight the Japanese and Germans during World War II too. *When you go, consider a guided tour.*

3. Tomb of Hi Jolly

If you've ever asked yourself, "Who in the world is Hi Jolly, and why is his tomb in Quartzsite, Arizona?" then get ready, because you're about to find out.

Hi Jolly was actually a Syrian immigrant who was hired by the federal government to introduce camels into the parched deserts of the American southwest.

Though the plan was scrapped,

Hadji Ali – also known as Hi Jolly – stayed on and lived out the rest of his days in Quartzsite.

He died in the early 20th century, and in the '30s, a bronze camel was placed at his tomb by townspeople who loved and admired him.

The tomb is in town and free, so don't miss it.

4. Dripping Springs Petroglyphs

Just east of Quartzsite on Interstate 10 is the town of Dripping Springs, which consists of historic and abandoned mines, a cabin made of stone, and Native American petroglyphs.

The sites will definitely take you back to another era when tough men eked a hard living out of the Arizona rock, and Native Americans who weren't thrilled with their presence lurked around every corner.

The last portion of the trail leading to the site will require some exertion, so if you go in the summer, wear appropriate shoes, a good hat and bring plenty of water.

The site is free, and there's even a cave near the cabin with dripping water inside. Enter at your own risk.

5. Petroglyphs and Grinding Holes

Located near Quartzsite, Tyson Wash is a dry wash that feeds into the Colorado River after rains, which usually occur in the spring.

The area is home to Native American petroglyphs, which are art and pictographs sketched into the rock, and purportedly tell bits

and pieces of a Native American creation story. They are signs of the thankfulness and respect the indigenous people have for the earth. The grinding holes are places where corn and seeds were ground over millennia, leaving large and distinct depressions in the rock.

The sites are just across the road from one another south of Quartzsite on a Bureau of Land Management road just off Highway 95.

6. Quartzsite Rock Alignment & Intaglios

Much of Quartzsite's history revolves around rocks; from the Native Americans who used them for grinding meal and creating petroglyphs to the prospectors who extracted the valuable metals contained within them. Now, rock and gem lovers come from all over for the annual show.

The Quartzsite Rock Alignment is a sign spelling 'Quartzsite' with an arrow, used as a guide for airmen who might have otherwise been lost in the desert.

The Intaglio is a large image of a fisherman also created out of rock by the area's Native Americans; an interesting depiction considering the desert environment in which it's found.

7. Celia's Rainbow Garden

Though this Quartzsite attraction is attached to a bit of a sad story, it's still worth a see.

The garden was constructed in



1996 and named after a little girl named Celia, who passed away a short time before.

Though it started out small, the humble but beautiful memorial garden blossomed into what is now eight acres of flowers, rocks, cactus, and even a tiny replica village – all of which are dedicated to other much loved and missed locals who've passed away.

It's free, and though it's a bit sad, it's uplifting as well.

8. Palm Canyon

Just about a half hour south of Quartzsite on Highway 95, Palm Canyon is one of those wonderfully



unique desert places that just may be one of the highlights of your Quartzsite adventure.

There's some confusion about whether or not the palm trees in this

magnificent canyon are native to the area, but it really doesn't matter because the canyon-lined oasis of which they're part of is beautiful and serene, and may just make you think you're in Egypt.

Keep an eye out for the sign for Palm Canyon on the highway. The trail in isn't very distinct, but follow the canyon and you'll find what you're looking for.

9. Quartzsite Historical Society Museum

Also known as the Quartzsite Museum and Tyson's Well Stage Station Museum, whatever you call it, the museum is one of the places you shouldn't miss if you're interested in learning about the



area's fascinating history. It's full of exhibits, equipment, and artifacts from Quartzsite's pioneer and mining days.

Back in the 1860s, Quartzsite was an important waypoint between California and Arizona, especially due to the water which still flowed from the Colorado River back then, which was necessary for the horses who were relied upon to make the trip.

Admission is free, though hours of operation are seasonal.

10. Skoolie Palooza

If meeting lots of free spirits who live in converted school buses with whacky paint jobs sounds like a great way to spend a few hours, then Quartzsite's Skoolie Palooza is just the place for you.

Though it's a relatively new tradition in Quartzsite, it'll probably gain traction quickly; the area is the seasonal home to many such people – most of whom are proud of their

homes on wheels that started their lives transporting children to and from schools all over the United States.

The event is held in January and you'll be able to get free tours from the enthusiastic owners who are more than happy to show off their mobile digs.

11. Quartzsite Roadrunners Gem and Mineral Club

For nearly 50 years, the Quartzsite Roadrunners Gem and Mineral Club has been teaching newbies and old-pros all there is to know about rocks, gems, minerals, and geodes, many of which are found in the surrounding desert. There may not be another place in the world so densely packed with so many rock enthusiasts.

Located in town, the cost for an entire season of classes – which lasts from November to April – is less than a decent steak dinner.

If you plan on being around for a while, you'll definitely get your



money's worth and you'll learn more than a few nifty skills.

12. Reader's Oasis Books

If you're at all like me, books are a necessity wherever you go. I've always found it frustrating to realize that a lack of planning has left me in an unfamiliar place with nothing to read.

If you find yourself in the same position in Quartzsite, don't despair, Reader's Oasis Books has just what you're looking for.

With tens of thousands of volumes and autographed photos of famous people who've stopped by, the place is part museum, part bookstore.

The owner is known for wearing the least amount of clothes permitted by law, so don't be surprised if you see more skin than expected. [Unfortunately he has passed but his wife continues to run the store]

13. Gunny's RV Park and Military Museum

In case you're not up on your Marine lingo, 'Gunny' means Gunnery Sergeant.



That being said, you won't be surprised to hear that Gunny's RV Park and Military Museum are owned by a former Marine, who's managed to put together an amazing museum full of photos, artifacts, and keepsakes, most of which relate to the military.

Stopping by is a great way to support the local economy, get a fascinating insight into the area's rich military history, and meeting an interesting guy who's largely dedicated his time to honoring veterans and their contributions to our country. 735 West Ocotillo Lane.



14. Quartzsite Sports, Vacation and RV Show

If you consider for a moment that Quartzsite's population – as far as the census is concerned – is just a few thousand, then you'll be astonished to hear that every year

The show started in 1984 rather humbly but quickly gained momentum as word spread among the tight-knit RV community. With swap meets and rock and gem shows happening, finding something to do won't be a problem.

15. Joanne's Gum Gallery

If you've ever lamented that someone hasn't created a museum dedicated to gum in all its many variations, then your prayers have been answered, because Quartzsite just happens to be the home of a gum gallery unlike any other you'll find.



Run by a sweet woman who knows more about gum than most executives at Wrigley's, she'll let you in and give you the dime tour no matter when you're passing through. Donations are appreciated, and you'll get to see one of the only surviving packages of the world famous, Cat-Butt Gum, which was a market flop despite its appetizing name.

Day Trips

The Desert Bar, a.k.a. Nellie E. Saloon is located in the Buckskin mountains north of Parker, AZ on land that was once an old mining camp. The "Nellie E" was completed in 1988. Unique features: windows that are old glass refrigerator doors, bar stools made of steel that sway from side to side, the top of the bar is brass, and the ceiling is made of stamped tin purchased from a factory in Missouri. The saloon is completely off grid and powered by solar energy. Live music every weekend thru April. The Desert Bar is located 5 miles down Cienega Springs Road off highway 95, approximately 5 miles north of Parker, AZ. Bring cash, no credit cards accepted. TheDesertBar.com



The real London Bridge is located in Lake Havasu City 74 miles from Quartzsite. The London Bridge over the Thames River was completed in 1831. It was dismantled and brought to Lake Havasu in 1968. You can drive or walk across the bridge.



Lake Havasu is one of the top-rated fishing destinations in the U.S. It is home to largemouth bass, striped bass, bluegill, channel catfish, crappies, and flathead catfish.

State records show that a 6.4-ounce smallmouth bass, a 42-pound carp and a 5-pound redear sunfish have come out of Lake Havasu.

Lake Havasu even has an Axe Throwing facility that uses logs from reclaimed trees; they are salvaged from timber that was lost due to drought, storm damage, wildfire, and/or bark beetle. The company's name is Yosemite Axe Throwing. Yosemiteaxe.com



Bouse, AZ is 26 miles from Quartzsite. Bouse has a M60 tank (Korean and Vietnam era) and other military vehicles on display along Highway 72 at Plomosa Road. General Patton conducted desert training here prior to going to Africa. There is also a museum in the historic Bouse Assay Office.

Wickenburg, AZ is 92 miles from Quartzsite. 70th Annual Gold Rush Days include a real-life rodeo, antique car show, parade, art show and tasty food. February 10-12, 2023.



For museum lovers there is a wonderful little museum called the Desert Caballeros Western Museum with interesting displays of what life was like when Arizona was still a territory. Upstairs they have paintings and sculptures of Native Americans, cowboys, and Arizona scenery. Downstairs is a recreation of life from the early 1900's which include a store, saloon, and a hotel. While you are in Wickenburg check



out Robson's Ranch. It also has a very extensive collection of mining equipment and

paraphernalia.

For nature lovers there is the Hassayampa River Preserve and the Vulture Peak Trail. Hassayampa River Preserve is gorgeous with 280 species of birds living, nesting or migrating along the riparian corridor.



The Preserve is open Wednesday through Sunday from 8 am to 5 pm. The trails close at 4:30. Vulture Peak Trail has beautiful views but keep in mind that the upper half of the trail is for experienced hikers only.

Shoppers will also love Wickenburg. Old Town Wickenburg has a large variety of shops and restaurants.

Explore Quartzsite until you find The Oval Office.

'Quartzsite Camel Tour' is a narrated tour of the sculptures in the Down-



town area, as well as an overview of Hi Jolly and Quartzsite history. Informative narrations play as you pass by the sites! The tour is \$5. The app is free to download www.Voicemap.me.

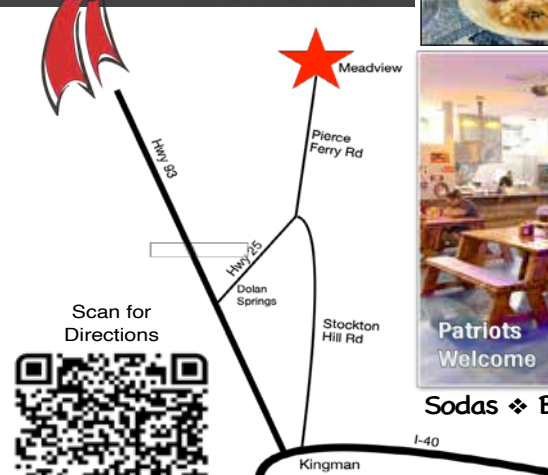

Far-left Lula da Silva sworn in as president of Brazil

CNN reports that in the lead up to Lula da Silva's inauguration, the left-leaning Supreme Court banned guns in the country's capital and suspended registered gun owners' licenses. On Sunday, 76-year-old Lula da Silva was sworn in as president of Brazil, as many in the country protested the far-left politician's third term as he again took office after serving two consecutive terms 12 years ago.

Yahoo Finance reports that Lula da Silva, of Brazil's Workers Party, said, "We do not carry any spirit of revenge against those who tried to subjugate the nation to their personal and ideological designs, but we will guarantee the rule of law," in regards to former president Jair Bolsonaro.

Lula da Silva won 50.83 percent



of the vote compared to incumbent Jair Bolsonaro, who won 49.17, in the country's October 2 vote. There was a runoff election afterwards on October 30 which Lula da Silva won, and that win was immediately ratified by the Superior Electoral Court. Bolsonaro launched a challenge to the presidential election in late November after the runoff and said there were "signs of irreparable... malfunction" in some

electronic voting machines. The head of Lula's Workers Party said the bid was mere "chicanery." Lula da Silva was convicted in 2017 for money laundering but a court threw out the conviction in March 2021.

Jack Posobiec, spoke of the conditions in Brazil in the December 4 Sunday Special episode of Human Events Daily. Posobiec said when he was in Mexico

City for Human Events, he saw celebrations for Lula's election and said, "It ain't like in the US where they've just got the Antifa flags. They've got full on hammer and sickle red flags, and what they're chanting is 'Viva Lula, Viva Lula,'" and later added "The communists are out in full force for him."

Lula da Silva formed the Sao Paulo Forum in 1990 which investigative journalist Matt Tyrmand said was where "Chavez and Maduro were incubated." "This is bigger than Bolsonaro. This is about the Brazilian constitution, and the people have a right to march. And if the judges could, they'd be arresting the protesters," Tyrmand said of the people in the streets of Brazil who are protesting and speaking up about Lula da Silva's corruption.

The Money Matrix Part 6 Medicine - Origins of the Current System

Introduction

“When a commercial bank makes a loan contract with a borrower, the bank CREATES the deposit in the borrower’s account.” Have you repeated this fact 15,000 times yet? Private banks CREATE what we use as money. This ‘money power’ can also be called Finance Capitalism or Wall Street, or just the Banks. Those who control this ‘money power,’ have powerfully influenced our entire society. This article will focus specifically on the medical profession.

This control of the banks by wealthy elites goes back to the end of the 19th century, when financial-industrial cartels, run by names like J.P. Morgan, John D. Rockefeller, Andrew Carnegie, etc., used the ‘money power’ to take over the American economy. These financiers created tax-exempt foundations to shield their wealth from taxes but, more importantly, to allow it to grow and grow.

Their growing wealth has been used, gradually, to change how American society views health, disease, and cures.

Reader, please read and contemplate.

In the last half of the 19th century, wealthy industrialists began to give endowments to build private universities around the country. Of course, the universities supported capitalism, and produced the skilled managers and engineers for the industrial corporations.

At the end of the 19th century, the ‘money power’ cartel controlled

the economy and began to set up tax-exempt foundations, chartered by the government. These foundations would protect their money from confiscation, but also harbor it in perpetuity. The endowments only grew and grew within the walls of the private, but government-chartered, foundations. The foundation trustees, men of wealth and beholden to the cartel, would be there generation after generation to make sure this source of incredible power would be continued, un beholden to any other societal power.

Physicians in the 19th Century

Before 1900, there were many approaches to curing disease in the population – homeopathy, herbs, and other lay healers. In addition, ‘regular’ or ‘orthodox’ practitioners used methods that were unpleasant and often lethal: bleeding, harsh purgatives (like

The medical student apprenticed at the side of a practicing physician and attended lectures in these schools. The physicians owned the school and earned income by charging fees for the lectures. None of the sects had enough clout to control licensing, but the ‘orthodox’ profession controlled by far the largest number of schools. ‘Scientific’ medicine – using laboratory research - were taught at only a few university medical schools in a limited fashion.

The students came from all classes. The upper class went abroad to Scotland for training and only three American medical programs (Pennsylvania, Harvard, and Dartmouth) were offering lectures to supplement their apprenticeships.

The profession had no status and low income. The most prominent practitioners (the ones who catered to the wealthy) blamed this on the number of medical schools and over-production of degrees.

Medicine as ‘Science’

In Europe in the mid-1800s, there were many physicians who were part of social reform movements. They “studied the economic, social and occupational causes of disease and worked for reforms to eliminate them.” Rudolf Virchow in Germany was one of them.

In 1882 Koch presented - to the Berlin Physiological Society - his discovery of the tubercle bacillus, as the external agent of disease. Virchow and others argued that since pathogenic micro-organisms lived in healthy bodies, they are not the cause of disease. In their view, invading micro-

poisonous mercury compounds), and inducing pus-filled blisters. Thomas Jefferson called them an ‘inexperienced and presumptuous band of medical tyros let loose upon the world.’ The public shied away from them, since the cure more often killed than cured.

In the second half of the century, there were about 160 private unregulated medical schools, teaching one or more modalities.

organisms could cause disease only after the host organism had been weakened by some physiological or environmental misery.”

Wealthy capitalists funded the germ theory of disease. They did not want to shine any light on the effect of their industrial empire building on the human condition. Frederick T. Gates, the powerful manager of Rockefeller Sr’s foundations and investments, agreed: disease is a technical not a social problem. The germ theory of disease fits the capitalist ideology of applying science and technology to the world.

The American Medical Association (AMA)

The AMA, representing the medical profession, was weak at the end of the 19th century. Only 8,400 physicians were members. In 1901, AMA reformers gained power and completely reorganized the structure, so that physicians were encouraged to join their local medical societies which fed up to a hierarchical central board.

Members were strongly encouraged to influence their state licensing boards. In addition, the reformers wished "to foster scientific medicine and to make the medical profession a power in the social and political life of the republic." Generally, private practitioners of all types supported the change, wishing to raise the social and economic status of the profession. By 1910 there were 70,000 doctors as members.

In 1906, the AMA reformers inspected all 160 medical schools and reported to the state licensing boards. By 1910, 166 schools were down to 131.

Although the scientific medicine approach became more dominant because of these actions, the teaching of scientific medicine required more money that the local wealthy could give: lab buildings, teaching hospitals and clinics, equipment, full-time lab teachers and researchers, clinical faculty.

The Carnegie Foundation and the Flexner Report

The Carnegie Foundation for the Advancement of Teaching had been established in 1905 to upgrade the status of college teachers and create a uniform system of higher education. Their plans for the education system produced managers and engineers for their industrial empires, but did not share with the students how the 'money power' worked.

Wishing more status for its reforms, the AMA asked the Carnegie Foundation to fund a

study of medical schools. Here was an opportunity for the Carnegie Foundation to enter the reform of professional education. The Foundation chose Abraham Flexner, a brother of Dr. Simon Flexner, director of the Rockefeller Institute for Medical Research. Abraham was not a physician, but a professional educator, a graduate in the classics of the Johns Hopkins University.

In his 1910 report, Flexner totally supported the AMA's scientific medical reformers. He criticized commercial medical schools for producing too many doctors, for requiring too little education for admission, for inadequate facilities and faculty, and for attracting 'the crude boy' or 'the jaded clerk.' (10) More private medical schools closed their doors. Then in 1911 Frederick T. Gates of Rockefeller's General Education Board (GEB) met with Flexner and asked, "What would you do if you had a million dollars with which to make a start in reorganizing medical education in the United States?"

John D. Rockefeller, Sr.

The financial cartel's 'money power' harvested vast fortunes. The wealthy financiers used chartered tax-exempt foundations to protect fortunes from confiscation and to grow them generation after generation. As Frederick T. Gates, Rockefeller's manager, said, "The people's voice is merely 'the voice of reckless greed to lay violent hands on other people's property'." The wealthiest man in the country, John D. Rockefeller, Sr., created multiple foundations: the General

Education Board (GEB), Rockefeller Foundation, etc. Between 1919-1921 Rockefeller Sr. gave \$45 million for medical education. These endowments were required to be matched by the local wealthy.

From 1910-1930s the foundations gave an unprecedented \$300 million for medical education/research. Eighty-three million dollars came from Gates/Rockefeller's General Education Board (GEB).

The scientific medical schools were put to the service of the 'money power'. The medical schools and teaching hospitals produced managers and professionals beholden to their money, and thus supporters of the finance capitalist system. The scientific

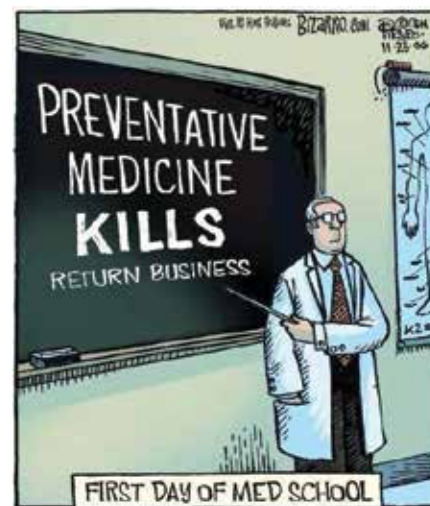
laboratories focused on germs as the cause of disease, **not** any environmental or occupational causes.

Conclusion

"In the great majority of cases the toll of the major killing diseases of the 19th century declined dramatically before the discovery of medical cures and even immunization." This improvement was the result of social movements in general living and working conditions as well as sanitation.

However, the industrial/financial cartel has only grown more powerful, never giving up their 'money power' and their hold on the medical profession.

Chris Christie's Shot at John Birch Society Reflects Establishment's Struggle With Losing Relevance

For that reason it is automatically contrary to everything we stand for, and one of the movements we shall oppose with all the strength we can. — JBS founder Robert Welch, 1974

Good riddance, 2022.

It has been a year in which the national debt continued its stratospheric ascendancy to unimaginable heights; a year during which record numbers of migrants continued waltzing into the United States as if a banquet awaited them on the other side; a year Americans paid nearly double for milk and eggs and almost triple for gas; and a year in which average citizens were bullied by an inescapable, coordinated campaign espousing the insane idea that boys who want to be girls need only to click their heels and believe it.

But 2022 didn't suddenly happen. The debt has been climbing for decades. Our porous border and self-destructive immigration policies have been inviting illegal aliens for decades. The collaboration between the Federal Reserve Bank and the U.S. government has been perpetuating a corrupt and immoral inflationary money system for more than a century. Powerful internationalists have been using

their influence to cripple the U.S. economy through a propaganda campaign demonizing cheap and reliable energy for decades. And the Judeo-Christian values and morals responsible for creating a nation that became the envy of the world have been under assault for at least six decades.

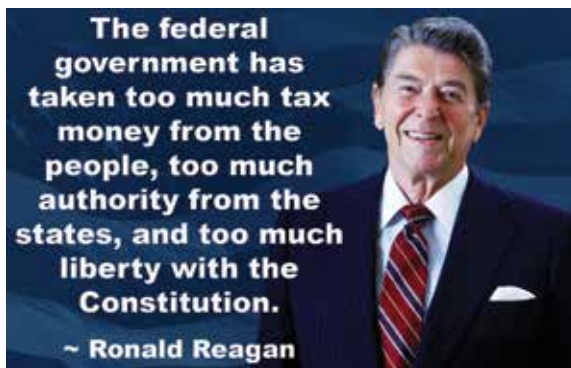
What we experienced in 2022 was a tipping over of destructive ideas and policies that have been building up for quite some time. But what set these destructive, asinine policies and ideas into motion?

For a long time, the prevailing narrative among conservatism has been that America's premature decline is the result of nuanced yet organic collective choices, specifically liberalism. And if we can just unchoose liberalism, we can save the Republic.

That's former New Jersey governor and probable 2024 presidential candidate Chris Christie's message. And anyone who believes there is more to the story is a John Birch Society conspiracy theorist.

On November 19, during a speech at the 2022 Republican Jewish Coalition Leadership meeting in Las Vegas, Christie used the JBS to make his point. In the 1960s, the

Republican Party had nearly been taken over by extremists, he said. "We also had conflict inside the party... driven by The John Birch Society." The Birchers were conspiracy extremists with major sway over the party, he added. But, fortunately, the venerable William F. Buckley, Jr. — Mr. Respectable Conservative — and his National Review magazine cohorts came to the rescue and banished the Birchers to political Siberia, after which the Republican Party reached the GOP golden age, the Ronald Reagan Era.



Christie has been telling this story for at least a year. It's the premise of his latest book, Republican Rescue: Saving the Party From Truth Deniers, Conspiracy Theorists, and the

Dangerous Policies of Joe Biden. And it's the vehicle his strategists have fueled to take him all the way to the 2024 presidential primaries, where it will surely stall and die on the side of the road. Not only is this poor strategy, but it's based on fiction.

Mr. Bill Buckley is long gone and National Review has been dwindling in relevance for years, but The John Birch Society not only never left, but has continued to grow in relevance.

The New Republic magazine, for all



the drivel it has published over a century, managed to understand this truth with a March 8, 2021 article aptly titled "The John Birch Society Never Left." Moreover, apparently we've "won the long game," according to Salon nearly a year later, which managed to squeeze in a seed of truth in its usual mound of claptrap. A couple months after Salon's momentary lapse of unreason, professional pundit Travis Gettys announced in Raw Story that "the Birchers have won." And between then and now, there have been numerous media rumblings that, like the broken clock that's right twice a day, managed in rare moments of sobriety to correctly analyze that the JBS message has prevailed.

For years, in the '60s, Buckley and his team at National Review tried to destroy the JBS — as did nearly every influential major media voice in the industry. They lobbed smear after smear, painting founder Robert Welch and JBS members as unhinged crackpots who saw a communist behind every bush. (Decades later, the declassification of the Venona files proved there were indeed Soviet assets in "virtually all major U.S. government agencies." Who's the

crackpot now?) They dedicated entire issues to discrediting the JBS. Why? Because instead of attributing America's decline to bumbling liberalism and gross stupidity, as they did, we insisted it was largely by design. It was a conspiracy.

Mr. Christie acknowledges no such thing. His message is that we need a return to spineless sellout establishment Republicans, many of whom are globalists themselves. William Buckley, the hero in Christie's story, ironically used to say, "A Conservative is a fellow who is standing athwart history yelling 'Stop!'" During the last 60 years, America has had an even split of Republican and Democratic presidential terms, yet in all that time we have conserved nearly nothing - not our sovereignty, not our currency, not our national identity. The country has marched in the same destructive direction: bigger government, more unrestrained immigration, larger and larger debt, more involvement with international organizations, and further moral corrosion.

Even Reagan, Mr. Conservative himself, stayed the path. Reagan's presidency was marred by federal spending and revenue increases, large deficits, and amnesty for illegal aliens. The 40th president's proposed federal budget for fiscal year 1989 constituted the largest proposed budget for the federal government in the history of the United States at the time. Reagan also didn't eliminate even one of any number of unconstitutional federal programs or departments, despite his famous rhetoric that government is the problem and not the solution. Only during the Trump years was there a slight deviation, specifically with regard to immigration policies and international entanglements like the Paris Agreement and UNESCO.

JBS never left because more people are learning the tragic truth about what really is happening in America and the world. Conspiracies are flourishing because they keep succeeding. It's becoming commonly accepted in America that a small and elite international group of people of diverse ethnicities

who wield immense power through a network of private, nonprofit, and public institutions have been orchestrating America's destruction. In many other countries, the majority of people already know there exists an international oligarchic class orchestrating events. The goal of the conspiracists is to impose a one-world totalitarian government, one in which a powerful and sovereign United States does not exist. What the world experienced in the form of Covid tyranny was a dress rehearsal of the type of control and oppression they wish to level on us.

What has happened is that decades of JBS education have converged with reality. As a result, people now believe "conspiracy theories."

During his templated speeches, Christie likes to bring up Reagan's famous "A Time for Choosing" speech to segue into the call-to-action portion. America is indeed at a time for choosing. Will we choose globalism or freedom?

Here is The John Birch Society, from the man who dedicated his golden years to working toward a free America for all its citizens: "We are not beginning any revolution or even a counter-revolution in any technical sense, because while we are opposing a conspiracy we are not ourselves making use of conspiratorial methods. Yet our determination to overthrow an entrenched tyranny is the very stuff out of which revolutions are made. The net result of these reflections is that we are not a copy of any movement of the past. We are unique. We are ourselves. We are something new, as befits a moving force for a new age." — Robert Welch, 1974

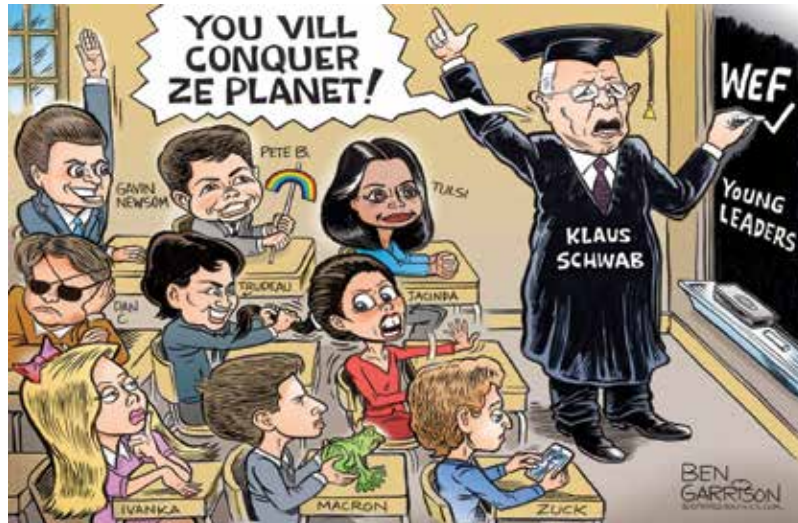

Of course, what is fascinating about this little tidbit of a news story of the great un-following is how Elon Musk was recently the Davos darling, the Diva, the debutante of the Davos Ball, until he wasn’t. 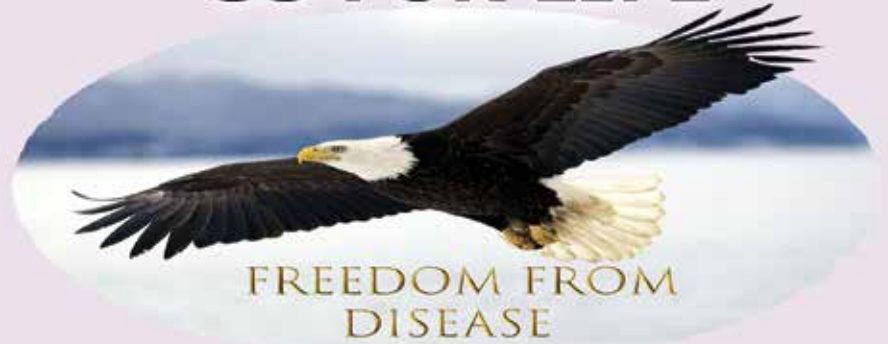

for malpractice on a scale never seen before resulting in over 100,000 deaths due to COVID-19 malpractice or due to an untested

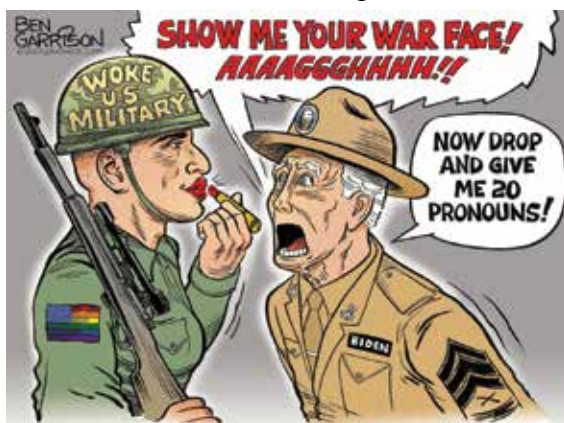
rushed vaccine that caused more harm than it prevented.

Overturn 2020 Election

Supreme Court Justices may well see these approaching storm clouds and conclude that the Court's intervention is necessary to prevent larger civil unrest resulting from constitutional violations that are undermining public trust and confidence in the outcomes of both the 2020 and 2022 elections. When criminals break the law — state and federal statutes — to rig an election, we are dependent on prosecutions by law enforcement agencies that have sadly become politicized and complicit. When they break the Constitution — the supreme law of the land — to rig an election, the only recourse may be the Supreme Court or military tribunals.

As the Brunson lawsuit argues, all of Congress was put on notice prior to its January 6th vote by more than a hundred of its own members detailing serious allegations of election frauds and calling for creation of an electoral commission to investigate the allegations.

Moreover, the Office of Director of National Intelligence (ODNI) was required to submit a report on foreign threats to the 2020 Presidential election by December 18, 2020. That deadline was set by executive order and by Congress itself. When December 18th came and went without ODNI submitting its report,

Congress should have started asking questions and investigating. In fact, DNI John Ratcliffe announced on that day that the 17 U.S. intelligence agencies he was overseeing had found evidence of foreign election interference but were split as to its significance and whether such breach of national security was sufficient to overturn the outcome of the election. And yet there was no action whatsoever by Congress, no inquiry and no investigation. Instead, Congress approved the possibly fraudulent election results on January 6th without asking any questions of the DNI and the Intelligence Community.

When the results of the 1876 presidential election were in doubt, Congress created a special Electoral Commission made up of five House members, five Senators, and five Supreme Court Justices to investigate. In contrast, in early 2021 Congress had nearly two weeks to investigate before the January 20th date of the Presidential Inauguration. Had Congress waited even just one more day to January 7th, they would have received the long-awaited ODNI report reflecting a split in

the Intelligence Community and the DNI's own conclusion that the People's Republic of China had interfered to influence the outcome of the presidential election. As Dr. Barry A. Zulauf, the Analytic Ombudsman for the Intelligence Community, concluded at the time, the Intelligence Community shamefully delayed their findings until after the January 6th Electoral College certification by Congress because of their political disagreements with the Trump administration. This paints a picture of collusion and conspiracy involving members of Congress and U.S. intelligence agencies to cover up evidence of foreign election interference and constituting the crime of High Treason.

The Brunson lawsuit does not claim the election was stolen, merely that a large majority of

Congress, by failing to investigate such serious allegations of election rigging and breaches of national security, violated their Oaths to protect and defend the Constitution against all enemies, foreign and domestic – an Oath also taken by Supreme Court Justices and members of the U.S. military.

The fact that the Brunson case has made it to the Court's docket suggests profound concerns about a lawless January 6th Congressional committee, politicized federal law enforcement and intelligence agencies, and major constitutional violations intended to overthrow an elected government by manipulating the outcome of the presidential election.

Chesterfield venue adds age limit on Christmas drag show after criticism by GOP lawmaker

JEFFERSON CITY — A Chesterfield entertainment venue placed an age limit Monday on people attending an upcoming drag show after a potential candidate for governor raised questions about whether the event was pornographic in nature.

Sen. Bill Eigel, R-Weldon Spring, sent a letter Monday to Chesterfield Mayor Bob Nation saying the event may violate state and local statutes designed to protect minors from pornographic material. "I urge you to take immediate action to ensure the venue does not allow anyone under the age of 18 to participate in the event," Eigel said.

The Factory, which is hosting the event, did not respond to requests for comment. But the venue, at 17105 North Outer 40 Road in

Chesterfield, altered its website Monday afternoon or evening to say Wednesday's event was for ages 18 and older because of "mature content."

Eigel announced in September that he is considering a 2024 bid for governor. He is the former leader of a conservative faction in the Legislature's upper chamber. In making drag shows a campaign issue, Eigel is following in the footsteps of other Republicans who are raising cultural issues such as transgender rights as they seek votes. For example, Rep. Heather Scott, an Idaho Republican lawmaker, told an audience that drag queens and other LGBTQ supporters

are waging a "war of perversion against our children." And last week, Florida Gov. Ron DeSantis said he would consider sending child protective services to investigate parents who take their

kids to drag shows.

In Texas, a Republican-sponsored bill would place new restrictions on drag performances by labeling any commercial enterprise that hosts one as

a "sexually oriented business." The letter comes as one of Eigel's potential GOP opponents, Secretary of State Jay Ashcroft, is pushing for the adoption of a controversial new state rule that would strip public libraries of state funding if they display books that might appeal to the sexual interests of minors.

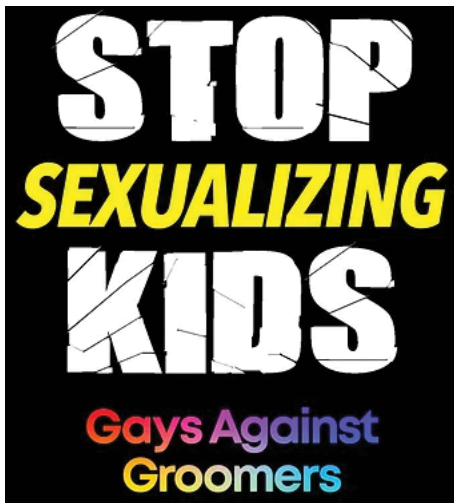
Lt. Gov. Mike Kehoe also is running for governor in the 2024 Republican gubernatorial primary. The issue for Eigel is Wednesday's presentation of "A Drag Queen Christmas." Records show it is at least the second year The Factory has featured the holiday show. But Eigel said the activity should be halted by police had it gone forward without an age limit. "Performances of this nature must be restricted to adult

audiences of 18 years or older," he wrote. Nation, the Chesterfield mayor, said he has held high-level meetings with the police chief, local prosecutors and city administrators to discuss a possible response to the letter, as well as the likelihood that the event could draw protesters.

He said he asked the owner of the venue to bar minors from attending the show but had not heard a response Monday afternoon, before the business posted the new age limits. "We're getting an awful lot of phone calls and emails," Nation said.

In addition to targeting drag shows, Eigel is among at least three Republican lawmakers who have introduced bills for the upcoming legislative session that would criminalize gender-affirming care for minors. Gender-affirming care for some minors experiencing gender dysphoria, a medical condition that involves a conflict between people's sex assigned at birth and their gender identities, is considered medically necessary by a number of major accredited organizations, including the American Academy of Pediatrics and the American Medical Association.

For minors, such care typically includes puberty blockers, which are recommended to transgender youths before the onset of puberty, or hormone therapy for teenagers. The legislation is Senate Bill 281.

TSA's Gender-Neutral Screening Upgrades Cost \$18.6M

The Transportation Security Administration is spending \$18.6 million on gender-neutral security screening to “advance civil rights” for those whose genders were incorrectly assumed when they traveled through the nation’s airports.

TSA said it hopes to improve the customer experience when it rolls out the “non-binary screening systems” in January, Fox News reported.

The \$18.6 million comes from President Joe Biden’s annual budget, the FY22 Omnibus Appropriations fund, to improve Advanced Imaging Technology units in airport checkpoints, updating the algorithm for “increased accuracy and efficiency.”

When travelers’ assumed genders don’t match what the imaging technology identifies them as, they are subject to additional screenings



and sometimes pat downs. TSA receives 26,542 screening complaints annually, Fox News reported, 6 percent of which are from members of the LGBTQ community.

TSA Executive Director for Travel Engagement Jose Bonilla said he is confident the new sharper imaging technology will

cut down the number of people subjected to pat-downs and the number of complaints from minority communities. “This technology should really be gender-neutral, you know it really should be, and we’re there,” Bonilla said.

The TSA had already updated its protocols to permit less invasive screening measures for some

passengers who trigger a scanner in “sensitive areas.” That reduced pat downs and was in effect until the TSA’s gender-neutral AIT technology was implemented. The TSA has also already stopped considering gender when validating identifications — TSA employees no longer consider a traveler’s stated gender when determining whether they match the ID they’re presenting, Fox reported.

TSA pre-check, which allows pre-approved travelers to skip certain security protocols, now has the gender option of “X” on its application. In April, the security agency began allowing travelers to self-select their gender regardless of the gender listed on their ID.
