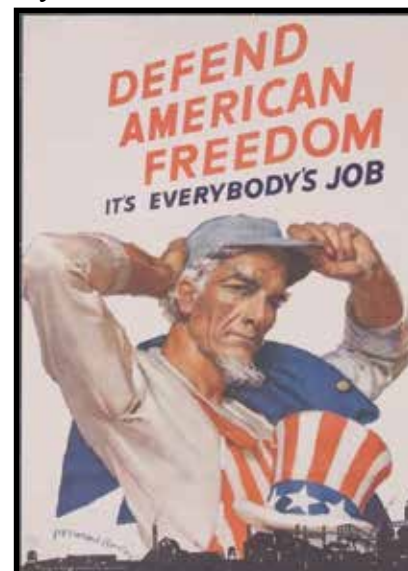

### US Lawmaker: 700,000 to 1 Million Illegals Gather at US Border with Mexico to Storm Country After Title 42 Ends

## Scientists Slam WHO's 'Weak' Proposed Limits on PFAS in Drinking Water

The World Health Organization's draft drinking water guidelines for two "forever chemicals" reveal a "striking and inappropriate disregard of the best available science," scientists wrote in a peer-reviewed article published Wednesday.

The World Health Organization's (WHO) draft drinking water guidelines for two "forever chemicals" reveal a "striking and inappropriate disregard of the best available science" and must be "extensively revised" to adequately protect public health.

So wrote former U.S. government scientists Betsy Southerland and Linda Birnbaum in an article published Wednesday in the peer-reviewed journal *Environmental Science & Technology*.

The stakes are extremely high, according to Southerland, the former director of science and technology at the U.S. Environmental Protection Agency's (EPA) Office of Water, and Birnbaum, the former director of the National Institute of Environmental Health Sciences. That's because once finalized, the WHO's regulatory framework for per- and polyfluoroalkyl substances (PFAS) in drinking water is likely to be adopted by many countries.

The United Nations agency's draft guidelines are much weaker than

rules imposed in Denmark and advanced in Canada, and they could facilitate legal challenges to the EPA's proposed standards that are much more stringent albeit still insufficient according to many public health advocates.

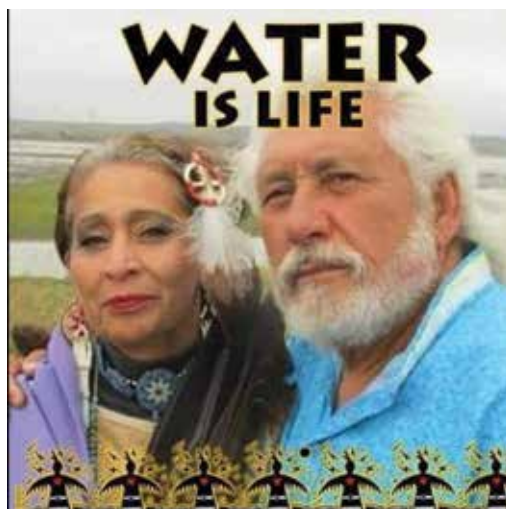
PFAS are a class of hazardous synthetic compounds widely called "forever chemicals" because they persist in people's bodies and the environment for years on end. Scientists have linked long-term PFAS exposure to numerous adverse health outcomes, including cancer, reproductive and developmental harms, immune system damage and other negative effects.

The substances — used in dozens of everyday household products, including ostensibly "green" and "nontoxic" children's items, as well as firefighting foam — have been detected in the blood of 97% of Americans and in 100% of breast milk samples.

The WHO's draft guidance recommends drinking water limits of 100 parts per trillion (ppt) individually for perfluorooctanesulfonic acid

(PFOS) and perfluorooctanoic acid (PFOA) — two of the most well-studied PFAS — and 500 ppt total for the 29 PFAS compounds that can be reliably measured, though this is a fraught topic.

The WHO's proposed limits on PFOS and PFOA are 25 times higher than those put forth last month by the EPA, and such a significant gap could hinder federal and state efforts to better regulate the nation's drinking water.



What accounts for the glaring discrepancy between the two agencies? According to the new article, the WHO has proposed relatively weak PFAS limits because its working group contends that "there is significant uncertainty and lack of consensus on whether PFOA and PFOS can be linked to adverse health effects."

Southerland and Birnbaum condemned the WHO's conclusion as "a striking and inappropriate disregard for the best available science." As the authors noted, numerous studies "link exposure to PFOA, PFOS, and other PFAS with multiple health effects, including immune effects, increased cholesterol, liver, and thyroid problems, reproductive and developmental harm, and multiple types of cancer."

In addition to failing to "take into account the overwhelming global scientific evidence of serious health effects in epidemiological studies," the WHO's guidelines "misrepresent the effectiveness of affordable, readily available treatment technology," Southerland and Birnbaum argued.

Southerland and Birnbaum continued: "At the same time that the European Chemicals Agency is considering restrictions on the manufacture and use of all PFAS on the basis of the scientific evidence, it is stunning that the WHO maintains no health-based guidance values can be developed. "To support the work of public health agencies worldwide providing people with safe drinking water, the WHO guidance levels need to be extensively revised."

The new article comes almost six months after more than 100 scientists sent a letter calling on the WHO to completely overhaul or withdraw its draft guidance and to disclose authorship and potential conflicts of interest.

In response to that letter and other demands for transparency, the WHO published a list of contributors in January. However, it remains unclear if the list is comprehensive.

Moreover, the WHO has not yet disclosed the feedback it received during the public comment period, nor has the agency announced when it plans to finalize its proposed rules.

"It is critically important for the safety of drinking water worldwide," wrote Southerland and Birnbaum, "that WHO recommendations are based on the best available science on the health effects of PFAS and the effectiveness of drinking water treatment technology."

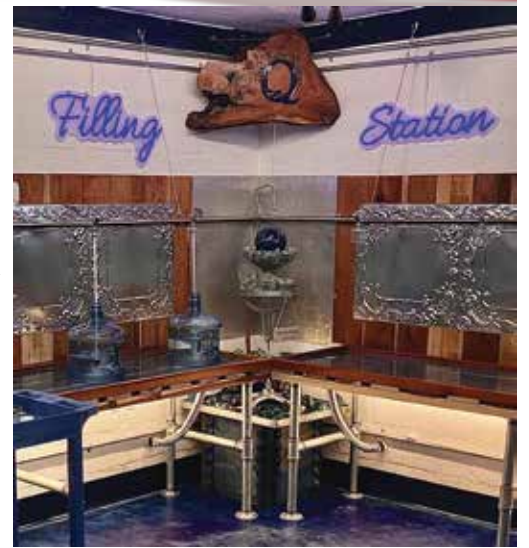

In 1867, Lysander Spooner detailed many of the Constitution's shortcomings in his essay The Constitution of No Authority concluding that "whether the Constitution really be one thing, or another, this much is certain—that it has either authorized such a government as we have had, or has been powerless to prevent it. In either case, it is unfit to exist."

He wrote this over 150 years ago, before the Fed, before the income tax, before the world wars the government was eager to join and the smaller wars of choice that continue to this day, and now with the looming prospect of nuclear Armageddon.

### **A Stateless Government**

The idea that coercive governments represent a contradiction in theory has been developed in such works as Robert P. Murphy's article, "But Wouldn't Warlords Take Over?," videos of Hans-Hermann Hoppe presenting his thesis, "State or Private Law Society?," and Murray

Rothbard's "Power and Market: Government and the Economy." There are many more. My own book, "Do Not Consent," argues that the government we need is the government that's right in front of our face.

Finding something other than the gang of bandits running our lives will forever be only a dream if we don't have a radical cultural change. The late Gary North said it best when he wrote in 2015: We need to know what we have lost. We need to know why we have lost it. Only then will it become clear that there must be a restoration of liberty. This means a restoration of personal responsibility on a scale that is almost unimaginable today. It is going to come, but only after the great default has at last bankrupted the federal government.

When the government goes belly-up, it will be as close to a state of nature as we will ever experience. It will be a time to start fresh without the mistakes of the past—by freeing the free market from state coercion.

## RFK Jr. and the CIA

Just a few months after being sworn in as president, John F Kennedy, RFK Jr's uncle, said the following in a speech given before the American Newspaper Publishers Association: "The very word "secrecy" is repugnant in a free and open society; and we are as a people inherently and historically opposed to secret societies, to secret oaths, and to secret proceedings. We decided long ago that the dangers of excessive and unwarranted concealment of pertinent facts far outweighed the dangers which are cited to justify it." On November 22nd, 1963, President Kennedy was assassinated in Dallas.

There are hours of damning evidence that clearly show that the CIA, organized crime, and the highest levels of the US Federal government were all involved in the assassination of JFK. Including the magic bullet, the grassy knoll, and the presence of young CIA asset, George H.W. Bush, in Dallas that day. A day that he claimed he could not remember. announced he was running for president. On June 5th, following major victories in the primaries, he was gunned down after giving a speech at the Ambassador Hotel in Los Angeles California.

Nina Rhodes-Hughes was one of a small few who witnessed the assassination and she claims there was another shooter standing to her right.

She later expressed outrage that the police ignored her statement. The shot that killed Robert Kennedy was fired up close in the back of his head, and the whole operation was blamed on a single lone gunman who was standing in front of him.

Regicide is the ritual killing of a king to memorialize a subversion of power. And while the Kennedy family is as greasy as the rest of the

swamp, the two brothers stand out like mythical kings. Aside from Dr Ron Paul who said we need to get rid of them, nobody in government questions the crimes of the CIA.

While promoting a book on television in 1978, a young RFK Jr referred to American politics as a one-party system. And his father and uncle's demise as an occupational hazard. ## IRS has spent \$10M on weapons, ammo and combat gear since 2020

The taxmen are armed to the teeth. A new report shows the Internal Revenue Service has been stocking up on weapons, ammunition and combat gear to the tune of \$10 million since 2020. The findings

released last week by OpenTheBooks, a watchdog group that tracks government spending, reveal that in 2021 alone the IRS spent more than \$5 million shoring up its arsenal for its increasingly militarized agents.

Since 2020, the oversight group found, the IRS has spent \$2.3 million


on ammunition, \$1.2 million on ballistic shields, \$474,000 on Smith & Wesson rifles, \$463,000 on Beretta 1301 tactical shotguns and \$243,000 on body armor vests. A slew of other line-item expenditures – include a mysterious \$1.3 million spent on "various other gear for criminal investigation agents."

The tax-collecting agency has also loaded up on hundreds of thousands of dollars worth of tactical lighting, gear bags, holsters, ballistic helmets and optic sights for weapons since the COVID-19 pandemic, according

to the report. Gun lockers at the IRS already appeared to be well-stocked prior to the agency's recent spending spree,

Pre-2020, the IRS had stockpiled 5 million rounds of ammunition for its 2,159 special agents. At the time, the agency owned 4,500 firearms, including 621 pump action and semi-automatic shotguns, 539 semi-automatic rifles and 15 submachine guns. Since 2006, the agency has spent \$35.2 million – adjusted for inflation – on guns, ammo and

## Apeel is used in USDA Organic & it's backed by Bill Gates & the World Economic Forum...

**The latest threat to our health or a distraction from bigger problems?**

At first blush, concerns about Apeel seemed like fake news. Fact checkers were quick to point out that the safety data sheet circulating the internet was for a different product with the same name, not for the edible food coating backed by Bill Gates and the World Economic Forum that was raising hackles on social media. But, when members of the Organic Consumers Association alerted us to news that this product was being used in organic, we had to investigate.

### How big of a food safety concern is Apeel?

Given everything else Bill Gates and the World Economic Forum expect us to swallow or inject, we can't be too skeptical, but are the problems with Apeel on the same level as other food safety concerns? Is it as important to avoid Apeel as it is to reject genetically engineered foods? Toxic pesticides? Factory-farmed animal products laced with livestock drugs, including mRNA vaccines? Synthetic biology? Nanotechnology? Undigestible insects? Lab-grown meat replacements? Our conclusion is that Apeel is equivalent to other preservatives commonly used to extend the shelf-life of ultra-processed food and should be avoided.

According to Apeel's GRAS notice submission to the FDA for Edipeel, the industrial process they use to extract monoacylglycerides from grape seed leaves residues of ethyl acetate, heptane, palladium, arsenic, lead, cadmium and mercury. One European Food Safety Authority review of monoacylglycerides (E 471) notes that "the potential exposure to toxic elements resulting from the consumption of E 471 could be substantial." Another EFSA review warns of the possible presence of the carcinogen glycidol in monoacylglycerides.



Monoacylglycerides are among a number of environmental compounds that could be causing diabetes due to their capacity to increase insulin secretion in the absence of high blood sugar.

### What's Apeel doing in organic?

It's hard to understand how the Organic Materials Review Institute approved Organipeel. According to its EPA registration, Organipeel is 0.66 percent citric acid, a non-

organic substance that's allowed in organic as long as it isn't synthetic. Apeel doesn't disclose what's in the other 99.44 percent of the product!

Apeel's patents claim that, "In some preferred embodiments, the coatings are made from the same chemical feedstocks that are naturally found in the plant cuticle, (e.g., hydroxy and/or dihydroxy palmitic acids, and/or hydroxy or epoxy oleic and stearic acids) and can thus be organic and all-natural." It strains

credulity to imagine that Organipeel could be composed exclusively of allowed ingredients.

### Is Apeel synthetic biology (synbio)?

Apeel is frequently listed among the best-funded synbio companies. In 2018,

founder and CEO Dr. James Rogers told Food Navigator that Apeel would soon use synthetic biology instead of extracting its ingredients from agricultural byproducts.

A 2019 post on the Apeel blog celebrated Jennifer Doudna, the inventor of CRISPR-mediated genome editing: "The world is rightfully excited about CRISPR. This groundbreaking technique not only enables scientists to add or remove genetic material with much greater precision but also much faster and cheaper than any previous method. Moreover, it works efficiently in virtually all cell types and organisms tested. This not only enables molecular biologists to do more complex genetic experiments but also provides a pathway towards



true synthetic biology by design."

### What's Apeel's relationship with the World Economic Forum?

Not only has Apeel been supported by Bill Gates and the World Economic Forum, but founder and CEO Dr. James Rogers is a WEF Young Global Leader. In April 2020, he wrote an article for the WEF celebrating the COVID lockdowns as good for the environment and a model for future action on climate change.

### What's the appeal of Apeel?

The Weston A. Price Foundation wrote an informative article about Apeel back in 2018, "Is Apeel Appealing?": "Do our foods need to be traveling on boats for months at a time before sitting on shelves even longer? And what about the nutritional value of our foods? Will it be affected by Apeel and does that matter to us? Is Apeel's "second skin" even appealing?"

Ultimately, the arrival of Apeel in the marketplace can serve to remind us of the many reasons to eat local, traditional, organic, biodynamic and chemical-free foods. That's the most important take-away. Nowhere does anyone claim that Apeel does anything to maintain nutrient density. Even with refrigeration, every day post-harvest is a loss. Most produce loses 30 percent of nutrients three days after harvest. You get the best nutrition eating straight from the garden!

## Three Congressmen Introduce Gold Standard Bill to Stabilize the Dollar's Value

As America faces the twin threats of inflation and bank failures, three U.S. congressmen introduced a pivotal sound money bill that would enable the Federal Reserve note "dollar" to regain stable footing for the first time in more than half a century. Rep. Alex Mooney (R-WV) - joined by Reps. Andy Biggs (R-AZ) and Paul Gosar (R-AZ) - introduced H.R. 2435, the "Gold Standard Restoration Act," to facilitate the repegging of the volatile Federal Reserve note to a fixed weight of gold bullion.

Upon passage of H.R. 2435, the U.S. Treasury and the Federal Reserve are given 24 months to publicly disclose all gold holdings and gold transactions, after which time the Federal Reserve note "dollar" would be formally pegged to a fixed weight of gold at its then-market price. Federal Reserve notes would become fully redeemable for and exchangeable with gold at the new price, with the U.S. Treasury and its gold reserves backstopping Federal Reserve Banks as guarantors.

Monetary experts have noted a return to a gold standard would substantially curtail the economic damage caused by inflation, runaway federal debt, and monetary system instability." A gold standard would protect against Washington's irresponsible spending habits and the creation of money out of thin air," said Rep. Mooney in a statement. "Prices would be shaped by economics rather than the instincts of bureaucrats. No longer would American families, businesses, and the economy as a whole be at the mercy of the Federal Reserve and reckless Washington spenders."

The Gold Standard Restoration Act also makes several findings as to the harm the Federal Reserve System has inflicted on everyday Americans - particularly since President Richard Nixon "temporarily suspended" gold backing of America's monetary system in 1971. H.R. 2435 points out: "The Federal Reserve note has lost more than 40 percent of its purchasing



power since 2000, and 97 percent of its purchasing power since the passage of the Federal Reserve Act in 1913."

Historians have observed that the elimination of gold redeemability from the monetary system freed central bankers and federal government officials from accountability when they expand the money supply, fund government deficits through trillion-dollar bond purchases, or otherwise manipulate the economy. "At times, including 2021 and 2022, Federal Reserve actions helped create inflation rates of 8 percent or higher, increasing the cost of living for many Americans to untenable levels...enrich[ing] the owners of financial assets while...endanger[ing] the jobs, wages, and savings of blue-collar workers," H.R. 2435 states.

Notably, Rep. Mooney's bill would also require full disclosure of all central bank and U.S. government gold holdings and gold-related financial transactions over the last 6 decades - a seemingly taboo subject surrounded by mystery and deception. "To enable the market and market participants to arrive at the fixed Federal Reserve note dollar-gold parity in an orderly fashion... the Secretary and the Federal Reserve shall each make publicly available... all holdings of gold, with a report of any purchases, sales, swaps, leases, and any other financial transactions involving gold, since the temporary suspension on August 15th, 1971, of gold redeemability obligations under the Bretton Woods Agreement of 1944."

In the years leading up to Nixon's panicked "temporary suspension" of gold redeemability, abusive U.S. deficit spending and currency debasement had prompted many foreign central banks to turn in their Federal Reserve notes for gold. However, this disgorgement of America's gold holdings was largely conducted in secret. That's why H.R. 2435 also requires

the Fed and the Treasury to disclose "all records pertaining to redemptions and transfers of United States gold in the 10 years preceding the temporary suspension in August 15, 1971, of gold redeemability obligations."

U.S. sound money groups and industry leaders are cheering Mooney's actions. "Government cannot continue to spend and print on a massive scale without producing existential threats to the currency and our economy,"

said Lawrence W. Reed, president emeritus of the Foundation for Economic Education. "The gold standard never failed America, bad ideas and bad politicians did. If we do nothing, disaster awaits us just as it drowned earlier civilizations that spent and inflated their way to ruin," Reed continued.

"Today's debt-based fiat-money system serves primarily to support big government and wealthy financial insiders - while the Federal Reserve's serial policy of currency debasement punishes savers and wage earners," explained Stefan Gleason, President of the Sound Money Defense League and Money Metals Exchange. "A return to gold redeemability would arrest the problem of inflation, restrain the growth of wasteful and inefficient government, and kick off an exciting new era of American prosperity," Gleason concluded.

The full text of Rep. Mooney's gold standard bill can be found [at Mises.org.] It was introduced on March 30, 2023, and referred to the House Committee on Financial Services.

## An Overlooked Contributor to Obesity?

The World Health Organization estimates that approximately 2 billion people worldwide are deficient in iodine.

Thyroid hormones are known to affect obesity and lipid disorders, and one often-overlooked component in this equation is iodine deficiency. Obesity and metabolic syndrome are increasing dramatically worldwide, contributing to cardiovascular morbidity and mortality, as well as other obesity-related endocrinopathies.

Dietary iodine is recognized as an essential nutrient, as it is necessary for the synthesis of the thyroid hormones thyroxine (T4) and triiodothyronine (T3), both of which are required for normal thyroid function. The dietary reference intake for dietary iodine, as dictated by the World Health Organization, is 90g per day for children 5 years of age or younger, with an increase corresponding to age: 120 g/day for children 6 to 12 years, 150 g/day for adults, and 200 g/day for pregnant or lactating women.

### Worldwide Deficiency

The World Health Organization estimates that approximately 2 billion people worldwide are deficient in iodine. Included in this figure are an estimated 285 million school-age children with iodine deficiency. In the United States, iodine status is considered marginal

at best, within the range of 100 to 199 milligrams per liter. However, in some parts of the world, iodine deficiency remains a significant health problem. Added to insufficient intake is the recurrent exposure to the halogens chlorine, bromine, and fluoride, which also contribute to deficiency.

Of the dietary iodine intake, approximately 80% is sequestered by the thyroid gland, which uses it for the synthesis of thyroxine, via the sequential addition of four iodine molecules to the amino acid tyrosine. In addition to the thyroid, other bodily tissues also concentrate io-



dine, including the salivary glands, the gastric mucosa, choroids plexus, the lactating mammary gland, and the ovaries. Consequently, as a result of decreased iodine status or deficiency, thyroxine cannot be made, which may ultimately result in thyroid dysfunction and subsequent weight gain.

Since thyroid hormones affect many bodily functions, including muscle, heart, liver, kidney, and the developing brain, optimal status is crucial for favorable health in all age groups. In one study with morbidly obese patients, a high degree of subclinical hypothyroidism (19.5%) was observed, with subjects having elevated levels of T3, T4, FT3, and TSH. There is also evidence of a significant correlation between the metabolic syndrome, of which symptoms include abdominal obesity and insulin resistance, and thyroid dysfunction, both of which contribute to cardiovascular disease.

Iodine deficiency manifests as a variety of illnesses, collectively termed iodine deficiency disorders (IDD), which results when iodide intake is less than 20 mg per day. With iodine deficiency, an increase in serum TSH, and a significant decrease in both serum T4 and free T4, have been noted. These observations have been correlated with marked thyroid histological alterations, including "cylindrical epithelial cells, diminution or absence of colloid and dilatation of blood capillaries." In moderate iodine deficiency, the thyroid gland, under the influence of thyroid-stimulating hormone, hypertrophies to concentrate iodide in itself, resulting in a colloid goiter. Most of these cases remain euthyroid.

### Iodine and the Thyroid

The pattern between thyroid diseases and iodine intake is distinctly correlated, despite the absence of marked disease patterns, including cretinism and endemic goiter. Depressed iodine status has been

correlated with elevated serum TSH, and it is an indicator of an insufficient T3 receptor saturation. Additionally, iodine deficiency affects brain development, which is particularly important in young children and adolescents. Given the increased obesity level in children, iodine status is a crucial consideration. An elevated serum TSH is an indicator of a potential risk.

An elevated serum TSH, along with a normal serum T4 and T3, is an indication of subclinical hypothyroidism, while overt hypothyroidism is associated with an elevated TSH and a low T4, along with variable levels of T3.

A 64% reduction in plasma thyroxine has been confirmed with iodine deficiency. Despite the consumption of iodinated salt, iodine deficiency disorders continue to exist, and goiters are still endemic in many populations. Sari et al have evidenced a "positive correlation between thyroid volume and body weight, body mass index, body fat percentage, and weight circumference," along with a positive correlation between TSH and both body weight and body fat.

In children and adolescents, goiter/hypothyroidism, impaired mental function, retarded physical development, and an increased susceptibility of the thyroid to nuclear radiation are correlated with a dysfunctional thyroid. Considering the marked increase in childhood obesity, a nutritional deficiency in iodine should be addressed.

Implications of thyroid dysfunction in adults include goiter/hypothyroidism, impaired mental function, spontaneous hyperthyroidism in the elderly, iodine-induced hyperthyroidism, and increased susceptibility of the thyroid to nuclear radiation. Consequently, the spectrum of IDD includes serious complications.

Of these implications, brain damage and irreversible mental retardation in children are considered the most significant disorders induced by iodine deficiency.



### Supplements Available

Although iodine deficiency has been addressed via the widespread application of public iodine supplementation programs, including the iodization of salt, in many regions of the world iodine deficiency remains a public health concern. Consequently, supplemental iodine represents an optimal approach to deficiency. Various forms of supplemental iodine are currently available, including liquid and tablet forms, both of which consist of potassium iodine or iodine derived from food sources such as kelp.

The earliest form of potassium supplementation was that of Lugol's solution, first made in 1829 by the French physician JGA Lugol. Lugol's solution is composed of 5% iodine along with 10% potassium iodide, with a final concentration of 130 mg/mL iodine. Iodine derived from kelp offers a natural alternative to supplementation. However, concerns with kelp-derived iodine should be considered, specifically with the knowledge that they are typically heavily contaminated with heavy metals, including arsenic, cadmium, and mercury.

It has been noted that "more attention should be devoted to heavy metal levels in kelp, particularly where they may play a role in a subsistence diet." In some species of kelp, as much as 65.5 parts per million arsenic has been extracted. The FDA tolerance level on arsenic is 2 ppm in kelp-containing products. Additionally, as a result of herbal kelp

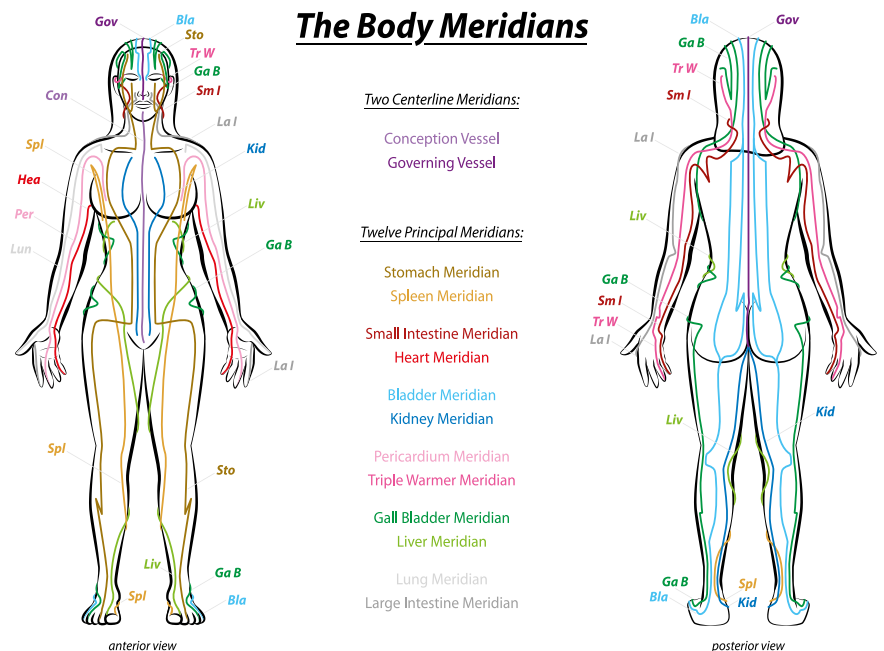

## The Money Matrix: Part 10, Bankers Take Control of AT&T and Mass Communications, 1900-1939

This article will describe how J.P. Morgan and its banking allies took control of the American Telephone & Telegraph Company (AT&T), and thus control of the telephone utility. The same telephone utility lines were used to transmit national radio broadcasts (beginning 1920's) and TV (beginning 1940's).

### Introduction

“When a commercial bank makes a loan contract with a borrower, the bank CREATES the deposit in the borrower's account.” Have you repeated this fact 15,000 times yet? Private banks CREATE what we use as money. This ‘money power’ can also be called Finance Capitalism or Wall Street. The ‘money power’ controls the entire society, since they decide who gets ‘loans’ – new bankmoney. They give it to their friends, to weapons manufacturers, to multinational corporations. The private creation of bank credit (bankmoney) concentrates wealth in elites and destroys our republican form of government.

In the U.S. Constitution, this power was given to Congress to issue sovereign money, like the old gold and silver coins from the U.S. Treasury and the Greenbacks of Abraham Lincoln. When the Congress authorizes and spends sovereign money as an asset, wealth is more fairly distributed to the citizens. The nation does not go into debt. Here is Edward Kellogg in 1883: “The most fundamental law in any nation is that which institutes money; for money governs the distribution of property, and thus affects in a thousand ways the relations of man to man.”

### Background: The “Money Trust” and the Pujo Committee, 1912

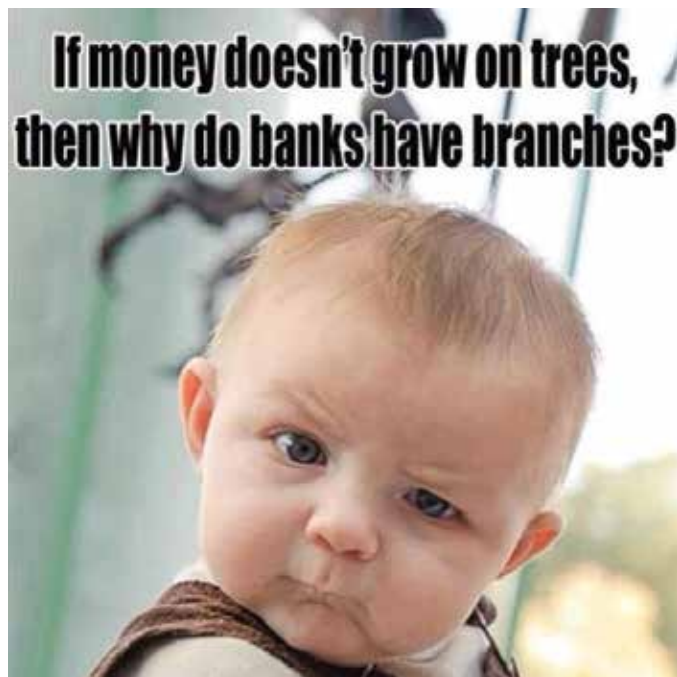
Towards the end of the 19th century, wealthy elites took over control of the economy, by creating financial-industrial cartels. Bankers and industrialists like J.P. Morgan, John D. Rockefeller, Andrew Carnegie, etc., used the ‘money power’ to do this – the private banking system CREATING bankmoney in

the account of a borrower.

In 1912 the House Committee on Banking and Currency was authorized to “investigate the concentration of control of money and credit.” It was called the Pujo Committee, after its chairman, Congressman Arsene Pujo of Louisiana. The committee did not find a single money trust that would be unlawful under the Sherman Act, but they did find a dangerous concentration of money and credits in the hands of a few men of great power in the financial world, especially in New York, the most powerful was J.P. Morgan.

### The Mechanisms of Control

To understand the mechanisms of control, one must understand the



difference between investment banks and commercial banks. Investment banks, such as J.P. Morgan & Co., are private partnerships, and do not have the power to CREATE bankmoney when ‘making loans’. Commercial Banks, such as National City Bank of New York (today's CITIBANK), are private corporations that have a government charter with this power of CREATING bankmoney when ‘making loans.’ The investment banks, by either controlling the commercial banks or working in tandem with them, create the ‘Money Trust’.

A major conclusion of the Pujo Committee was: “Large corporations, such as insurance companies, railroads, producing and trading corporations,

and public utility corporations, are heavily influenced by their dependence on the investment banks to buy their new issues of stocks and bonds, needed by the corporation to expand and grow. This dependency gives the bankers influence over the corporation. In addition, the committee identified a coterie of investment and commercial banks -- around J.P. Morgan & Co. in New York -- creating a monopoly over the buying/selling of securities of the large corporations.

### Banking Syndicates to Buy/Sell Stocks and Bonds

The investment and commercial banks join together in ‘syndicates’. The investment bank gets a loan

from the commercial bank. With this loan money, the investment banker buys the corporation's stocks or bonds. They are bought cheap. The investment bank sells, at a high price, to other investment banks and commercial banks, in the syndicate. With this sale, the investment bank repays its loan to the commercial bank, and makes a nice tidy profit.

There may be multiple levels in the syndicate, each rung selling to the next lower rung at a higher price (to make their profit). At the bottom will be the selling of the securities to the public – at the highest price. The most powerful syndicates are found around the J.P. Morgan banking house.

### J.P. Morgan and AT&T

According to the Pujo Report, J.P. Morgan has participated in syndicates between 1906 and 1912 that market the securities of the public utility, AT&T and its subsidiaries. The total dollar value was in excess of \$300,000,000. AT&T's total capital stock and funded debt was \$621,000,000. These dollar figures point out the great influence the Morgan firm has over this utility.

1880's. Vail pushed centralization and top-down control of the company, but the owners did not agree. Vail left and went to South America for business. “Sometime in the early 1900s”, Vail received a phone call from J.P. Morgan to meet on Jekyll Island, South Carolina, where Morgan spent his ‘free time’ in his private clubhouse. Morgan told Vail on this visit or shortly afterward that “he and a group of other financiers aimed to gain control of the Bell company, wishing not only to reestablish its former dominance but to build the greatest wire monopoly the world had ever seen. And he wanted Vail in charge.” Vail agreed.

In February 1906, a Morgan banking syndicate underwrote \$100,000,000 of AT&T bonds and began the reorganizing of the company on a “national scale.” “After 1906 the house of Morgan served as principal banker to AT&T.” Vail was made president of American Telephone & Telegraph (AT&T), the current holding company for the entire Bell system, and began immediately to build a monopoly. Vail's new slogan for the utility was: ONE SYSTEM, ONE POLICY, UNIVERSAL SERVICE. Meaning, monopoly.



## Why We Don't Need Term Limits

Once again, the Convention of States (COS) organization is calling for a Constitutional Convention to get a term-limit amendment added to the U.S. Constitution. Here's their pitch from their own website: If Americans want it [congressional term limits], it's the job of their representatives to do it. But Washington will never limit itself, and the Founders knew that which is why they gave us Article V.

It's time to use Article V to rein in the out-of-control federal government. More than 80% of America wants it, and we only need three-fourths of the states to ratify proposed amendments. For people who prattle incessantly about their fondness for the Constitution, they sure do want to rewrite it.

There are many, many constitutional and historical problems with the COS push for a congressional term-limits amendment. First, it should be cause for concern to their supporters that a self-described conservative/constitutional group would adopt such a progressive and paternalistic attitude toward the right of the people to elect their representatives, one of the most fundamental rights in a free society.

That right is so sacrosanct, in fact, that although the COS "constitutional scholars" likely won't understand, there is a persuasive argument to be made that an amendment limiting the number of terms for which the people of a state could elect one of their representatives would be a violation of Article IV of the Constitution. Article IV reads, in relevant part: "The United States shall guarantee to every state in the union a republican form of government." A republic, as defined by James Madison in *The Federalist*, No. 10, is "a government in which the scheme of representation takes place."

Now, if COS is arguing that the people should no longer be allowed to

elect the representative of their own choice, are they not in equal measure arguing against the continuing guarantee of republican government, as set forth in Article IV? Yes, they are. They won't admit that. They might not understand that.

Additionally, when it comes to limiting terms, supporters like to focus on the ability to "curb" the time a politician can remain in office. The truth of the matter, however, is that no matter what you or I may think of the person elected by this or that constituency, it is the right of the people of a district or state to elect the person of their choice to represent them, regardless of the opinion of other constituencies. That's the very definition of republicanism.

The solution to the problem of other people electing politicians you don't like is for you to elect other politicians to prevent those politicians from enacting policies with which you disagree. The solution isn't to prevent people from electing whomever they choose! That would be the very definition of fascism, as well as, once again, a denial of the republican form of government guaranteed in the Constitution.

Finally, let me provide the honest seeker of solutions — solutions that don't involve opening the Constitution to the tinkering of those who have spent millions of dollars to make that happen — a bit of a historical perspective on this issue. To my way of thinking, I'd rather support my position on this issue with statements

from our Founding Fathers rather than an opinion poll conducted by an organization that lists neocon and career Washington, D.C., bureaucrat Anthony Lake as one of its advisors.

So, here's a bit of historical perspec-

tive from our Founding Fathers: Alexander Hamilton in *The Federalist*, No. 72 expressed his sense of the question of term limits: "Nothing appears more plausible at first sight, nor more ill-founded upon close inspection."

During the debates on the subject at the original Constitutional Convention in Philadelphia in 1787, Connecticut delegate Roger Sherman expressed a similar opinion: "Frequent elections are necessary to preserve the good behavior of rulers. They also tend to give permanency to the Government, by preserving that good behavior, because it ensures their re-election."

In *The Federalist*, No. 53, James Madison wrote: "No man can be a competent legislator who does not add to an upright intention and a sound judgment a certain degree of knowledge of the subjects on which he is to legislate. A part of this knowledge may be acquired by means of information which lie within the compass of men in private as well as public stations. Another part can only be attained, or at least thoroughly attained, by actual experience in the station which requires the use of it.... A few of the members [of Congress], as happens in all such assemblies, will possess superior talents; will, by frequent re-elections, become members of long standing; will be thoroughly masters of the public business, and perhaps not unwilling to avail themselves of those advantages. The

greater the proportion of new members and the less the information of the bulk of the members, the more apt they will be to fall into the snares that may be laid for them.

At the Constitutional Convention of 1787, Gouverneur Morris spoke on the subject, too. Madison records Morris saying: The ineligibility proposed by the [term limits] clause as it stood tended to destroy the great motive to good behavior, the hope of being rewarded by a re-appointment. It was saying to him, "make hay while the sun shines."

Last one: John Adams wrote in his *Defense of the Constitutions of the United States of America*: "There is no right clearer, and few of more importance, than that the people should be at liberty to choose the ablest and best men, and that men of the greatest merit should exercise the most important employments; yet, upon the present [term limits] supposition, the people voluntarily resign this right, and shackle their own choice... They must all return to private life, and be succeeded by another set, who have less wisdom, wealth, virtue, and less of the confidence and affection of the people."

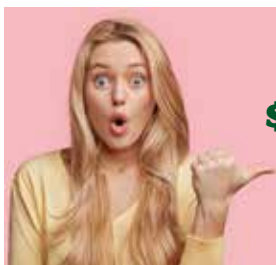
There is wisdom in the Founders' wariness of the concept of limiting corruption by limiting terms of representatives. When viewed through the Founders' lens, it becomes clear that an elected representative would be less attached to the attitudes of his constituents if he knew that no matter how he performed in Congress, his time among the lobbyists would eventually expire. In that case, a corrupt and scheming politician would take maximum advantage of his access to graft in the limited time available to him.

**In summary, let's not try to fix the Constitution without first trying to follow it.**

## U.S. Approves First 3 COVID Vaccine Injury Claims - And Pays Out a Total of \$4,634.89

The U.S. government approved its first three payments to people injured by COVID-19 vaccines — amounting to a total of \$4,634.89. The Health and Resources Service Administration (HRSA) vaccine injury claims report, updated monthly, shows one \$2,019.55 payment for anaphylaxis and two payments — \$1,582.65 and \$1,032.69 — for myocarditis.

The payments were made through HRSA's Countermeasures Injury Compensation Program (CICP). The CICP was established under the Public Readiness and Emergency Preparedness (PREP) Act, which protects pharmaceutical companies from liability for injuries sustained from "countermeasures," such as vaccines and medications, administered during a public health emergency.

Since 2010, when it approved its first claim, the program has compensated a total of 33 claims for vaccine injuries — but these are the first awards for COVID-19 vaccines. "These long-awaited awards were overdue, highly anticipated and speculated upon," said Kim Mack Rosenberg, acting general counsel for Children's Health Defense (CHD). "What is remarkable is that less than \$5,000 was paid — total. This is a tragedy that highlights the severe limitations of the program."

CHD Acting President Laura Bono called the payouts for myocarditis "insulting," given that mortality rates increase to 50% within five years of diagnosis. Bono said: "The CICP is a pathetic, government-run program that gives complete liability protection



to the very industries profiting from the COVID vaccine or product. While victims linger with their injuries, paying out-of-pocket for expenses, or at worst die, the industries run to the bank."

Since the start of the pandemic, people claiming injuries related to COVID-19 vaccines and other countermeasures submitted 11,425 requests for compensation. Of those, only 19 have been declared eligible for compensation and are undergoing a "medical benefits review" to determine payment.

The anaphylaxis case had been pending medical benefits review since the fall of 2021, and the two myocarditis cases had been pending review since January. During the medical benefits review, HRSA determines any costs remaining after insurance, workers' comp, disability or other reimbursements or payments.

Wayne Rohde, an expert in vaccine injury compensation, wrote on his Substack that given the "18+ months to review previous medical benefits that

may have been awarded to the injured party [the anaphylaxis case], this process tells me it was a major injury that resulted in very large medical bills." Myocarditis is a serious condition that also requires a lot of medical attention, Rohde said.

To date, there have been 1,541,275 reports of adverse events following COVID-19 vaccination submitted to the Vaccine Adverse Event Reporting System (VAERS).

### How does vaccine injury compensation work? VICP and CICP

HRSA, which operates under the U.S. Department of Health and Human Services (HHS), administers two vaccine injury compensation programs: the National Vaccine Injury Compensation Program (VICP) and the Countermeasures Injury Compensation Program (CICP).

The VICP is a special, no-fault tribunal housed within the U.S. Court of Federal Claims that handles injury claims for 16 common vaccines on the childhood vaccination schedule. To date, it has awarded more than \$4 billion for medical bills, lost wages, lawyer fees, and pain and suffering to thousands of people for vaccine injuries. The program does not currently cover COVID-19 vaccine injuries. Should COVID-19 vaccines be moved into the program, any injuries would be handled by the already overwhelmed VICP.

The CICP, the only program that covers COVID-19 vaccine injuries at this time, is even less equipped to deal with them, Rohde told The Defender. "For COVID-19 vaccine-injured people, the CICP is the worst place, it's the worst op-

tion," Rohde said, "because it is not really a compensation program, it's a reimbursement program for medical costs." The CICP allows individuals to claim compensation only for unreimbursed medical expenses — meaning those not fully reimbursed by insurance or government programs, such as Medicaid — for death and for lost wages up to \$50,000.

According to the Centers for Disease Control and Prevention, under the CICP: "Eligible individuals may be compensated for certain reasonable and necessary medical expenses and for lost employment income at the time of the injury. Death benefits may be paid to certain survivors of covered countermeasures recipients who have died as a direct result of the covered countermeasure injury." "The U.S. Department of Health and Human Services is the payer of last resort. Therefore, payments are reduced by those of other third-party payers." "There's no pain and suffering here, there's nothing," Rohde said.


Because the CICP reviews and resolves claims through an administrative rather than a judicial process, no details other than the amount of the payments have to be shared with the public. "It's designed to be very convoluted, very non-transparent," Rohde said. The CICP was known for its cumbersome claims process and low likelihood of success for claimants even before the pandemic. Since then, it has seen unsustainable growth.

According to HRSA's numbers, of the 11,941 claims filed with the CICP since 2010, nearly 11,000 of them are still under review. The HRSA budget for COVID-19 vaccine injury compensation will increase in fiscal year 2023 — from approximately \$1 million to \$5 million — and its budget for staffing and contractors will jump from \$5 million to \$9.5 million.

### How would COVID vaccine injury compensation change under the VICP?

For vaccine injury claims to be covered under the VICP rather than the CICP, three requirements must be met: The vaccine needs to be

## Southern Baptist Convention Urges Expansion of Red Flag Law Following Covenant School Shooting

Michael Foust reported for Christian Headlines on Thursday that 13 Southern Baptist Convention leaders and pastors signed onto a letter from the SBC urging Tennessee's Republican-controlled Legislature to pass an expansion of the state's red flag law. The letter tells the legislators opposing the expansion to man up and pass the increased infringement before the session ends.

"You have," intoned Brent Leatherwood, president of the Ethics & Religious Liberty Commission of the Southern Baptist Convention, "an opportunity now to respond [to the Covenant School shooting] in a way that is loving, protective of our liberties, and consistent with God's design for the state."

The expansion of the state's present egregious infringement of the Second and Fourth Amendments to the Constitution of the United States would include family members. This would, according to Leatherwood, "strengthen our state's [existing] orders of protection [i.e., red flag law] to guard the broader population from those who are a danger to themselves or others." And just how would such a danger be determined? According to WBBJ: "[The expansion would allow] a court to issue a risk protection order [a gun confiscation order] upon a finding by clear and convincing evidence that a person poses a significant danger of causing personal injury to the person or others if allowed to possess or purchase a firearm."

And who could "petition" for the infringement? [It] authorizes a law enforcement officer or a relative [of the person at risk of losing his firearms] to petition for a risk protection order. Dear reader: Please notice that no crime has been committed by the targeted person. And the standard under which his rights would be violated would be greatly lowered. A Tennessean presently has his Fourth Amendment rights guaranteed under the U.S. Constitution: "The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and



no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized." According to Cornell Law School, "Courts usually find probable cause when there is a reasonable basis for believing that a crime may have been committed ... or when evidence of the crime is present in the place to be searched..." Under the proposed infringement, only a "finding by clear and convincing evidence" is necessary for the targeted citizen to lose his firearms.

Red flag laws are in effect "pre-crime" laws, targeting individuals who "may" pose a "significant danger" to himself or to others. Leatherwood ignores any of these concerns in his letter. Instead, he declares that such laws "prevent the loss of innocent lives without eroding our cherished, fundamental rights." In fact, he charges that not passing the expanded infringement of the Second Amendment may actually strengthen it:

In fact, because this solution [to the problem of deranged individuals like the "transgender" who murdered six at the Covenant School last month] is so clearly situated in the mental health arena, by not passing [the expanded infringement], you [legislators] risk undermining support for the Second Amendment.

One pastor who wasn't buying any of this is Chuck Baldwin, senior pastor of Liberty Fellowship in Kalispell, Montana: So now the Tennessee Southern Baptist Convention has come out in full force in support of what can only be categorized as one of the most egregiously unconstitutional and unbiblical assaults on

individual liberty and the right and duty of God-ordained self-defense that one could name: Red Flag gun confiscation laws.

Brent Leatherwood has proven to the world that he is totally and thoroughly ignorant of God's Natural Laws of Liberty and of the repeated instruction of God's Revealed Word regarding the Christian duty of Liberty and self-defense. Last week, Florida Governor Ron DeSantis traveled to a foreign country to sign legislation that makes it a felony crime for anyone to distribute literature containing speech that an individual may find offensive, harassing or threatening.

In an age of Soros-funded DAs, prosecutors and liberal activist judges, this is a recipe for disaster, enabled by the reckless policies of DeSantis.



Big League Politics reported on DeSantis signing HB 269 into law during a surprise visit to Israel last week: "Florida Governor Ron DeSantis flew to a foreign country on Thursday to sign an anti-hate speech law that makes speech deemed "harassment" or "intimidation" a felony punishable by 5 years in prison. DeSantis signed HB 269 in Jerusalem, and it is being touted as a law to combat anti-Semitism by its proponents... The measure makes it an explicit felony hate crime to distribute literature in a door-to-door

manner if that literature is arbitrarily deemed to be harassment or intimidation by its recipient.

**Relevant language from the law:** "784.0493 Harassment or intimidation based on religious or ethnic heritage.

(1) As used in this section, the terms "credible threat" and "harass" have the same meaning as in s. 784.048.

(2) A person may not willfully and maliciously harass or intimidate another person based on the person's wearing or displaying of any indicia

relating to any religious or ethnic heritage.

(3) A person who violates subsection 2 commits a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083.

(4) A person who violates subsection 2, and in the course of committing the violation makes a credible threat to the person who is the subject of the harassment or intimidation, commits a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

(5) A violation of this section is considered a hate crime for purposes of the reporting requirements of s. 877.19."

Political commentator Scott Greer noted that messages as innocuous as "Make America Great Again" or "It's Okay to be White" could easily be considered felony hate speech under the provisions within this vaguely-written hate crime law." Democrats are licking their chops as DeSantis takes measures against the 1st Amendment. His poor leadership is hurting the Republic.

military-style equipment, according to OpenTheBooks.

The IRS is also in the midst of a hiring spree, with current openings to hire 360 criminal investigators based in all 50 states. The agency notes that applicants must be willing to "carry a firearm; must be prepared to protect him/herself or others from physical attacks at any time and

without warning and use firearms in life-threatening situations; must be willing to use force up to and including the use of deadly force."

The IRS has said that its special agents are armed because they consistently are involved in organized crime, drug and gang investigations. President Biden provided the agency with more than \$80 billion in new funding as part of the \$739 billion

Inflation Reduction Act he signed in August. The agency claims it needs the funds to hire 86,852 new employees over the next 10 years that conservatives argue will be used to crack down on low- and middle-income Americans.

## The Banana Republic of Quartzsite, Arizona

Prior to the last 4 years did you ever think that the United States could descend into being a Banana Republic? Although the change appears to be sudden, it has been meticulously worked on one small step and one stolen election at a time while the majority of us were politically asleep. "At the time of declaration of candidacy". So, if someone declares their candidacy and the Town Council informs them that they owe some money on their current water bill or a library late fee, they are off the ballot. It



sounds like they are not given a chance to rectify the situation.

Arizona State requirements are: "A person shall not be a member of a city or town council unless, at the time of the election, the person is eighteen years old, is a qualified elector residing within the city or town and has resided in the city or town for at least one year next preceding the election, or if an area has been annexed to the city or town for a period of less than one year next preceding the election has resided in such area for at least one year next preceding the election. If an annexed area is subject to the provisions of this subsection, a person may meet the residency requirements if the person has resided within the existing limits of the city or town for the one-year period."

— <https://www.azleg.gov/ars/9/00232.htm>. Council; qualifications of members; oath; selection of mayor; vacancy

Phoenix's City Council requirement matches the state requirements. Why does Quartzsite need additional requirements? Does the Town Council have the authority to add additional requirements to state requirements?

Why would they weaponize this

Isn't that why we have elections? If the people don't like a candidate, they don't vote for them. If they owe the town money, it could be for a trumped up fine used as a political weapon. Don't you want the opportunity to decide rather than the council of 5?

As a result of this political

More than enough signatures were collected and verified, so Code 30.09(b) will be on the November 2023 ballot.

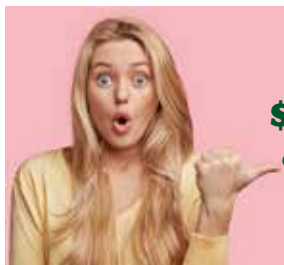
