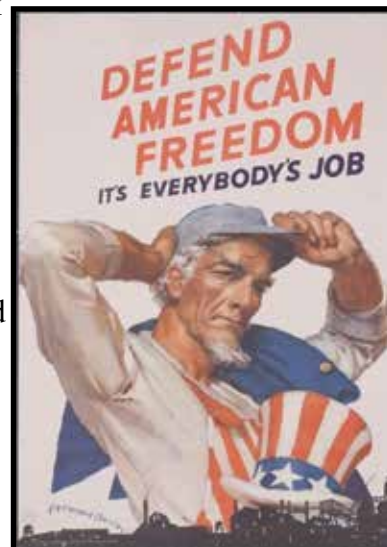

### Unbelief and Its Consequences

## Cruz says Wristbands Smugglers use to Track Migrants are like ‘Leg Irons’

**DHS secretary testifies he had no knowledge of colorful wristbands used by cartels!**

McALLEN, Texas (Border Report) — Texas Republican U.S. Sen. Ted Cruz earlier this week grilled Homeland Security Secretary Alejandro Mayorkas for two minutes on wristbands that he says drug cartels use to mark the migrants they are illegally crossing from Mexico into the United States.

This was in reference to the same wristbands that Border Report two years ago reported were heavily found in the Rio Grande Valley, worn by family units after they crossed the Rio Grande into South Texas from northern Mexico.

“Along the southern border, you see thousands of these wristbands because the illegal immigrants wear them,” Cruz said during Tuesday’s Senate Judiciary Committee hearing

in Washington, D.C., in front of a giant poster with blown up colorful wristbands of purple, yellow, orange and white.

“Every color corresponds to how many thousands of dollars they owe the cartels. You have turned these cartels into multibillion-dollar criminal organizations. And these are modern-day leg irons because these are children being sold into sex slavery,” Cruz said.

When asked about the wristbands, Mayorkas responded: **“I don’t know what they are.”** That brought a tirade of criticism from Cruz who told Mayorkas, “You’re incompetent at your job.” **“Mr. Secretary, I want to say to you right now, your behavior is disgraceful. And the**

**deaths of the children, those assaulted and raped, they are all at your feet, and if you had integrity, you would resign!” Cruz said.**

When given the chance to later respond by the committee chairman, Mayorkas refused calling Cruz’ comments “revolting.”



themselves up to law enforcement and claiming asylum in the United States.

But on Friday, a U.S. Customs and Border Protection official said they aren’t seeing very many of these identifying bracelets anymore in the Border Patrol’s RGV Sector.

And that could have to do with the fact that most migrants crossing illegally into this part of South Texas now are single adults, not families, who are crossing in other areas, like Del Rio and El Paso, Texas.

In February, there were a total of 114,189 encounters with undocumented migrants in the RGV Sector and 58%, or 67,241, were

single adults. There were 23,756 families and 23,192 unaccompanied minors who crossed, according to CBP data.

That’s a huge change from the 489% increase in family units crossing into the RGV in Fiscal Year 2021 –over 52,000 — from Fiscal Year 2021, CBP reports.

And it’s significantly less than the 60,271 families that crossed into the El Paso Sector in February, or the 38,933 families who crossed into the Del Rio Sector in South Texas during that same time period, according to CBP.

The different wristband colors indicate how much they have paid; where they cross; if they have tried to cross before; and if this is their last time trying to get across without having to pay again, several officials have told Border Report.

It’s all part of a highly organized system the Mexican drug cartels use to mark and identify different groups of migrants they are smuggling into the United States.

Since a surge of immigrant families began crossing illegally in 2019 from northern Mexico into the Rio Grande Valley, these wristbands have been commonly found in areas where routes are known to bring in smugglers. The bracelets would litter parks and areas where Border Patrol come across those readily giving

## SICK! Radical Democrat Katie Hobbs Allows Pornography to be Filmed in Arizona's K-12 Public School Classrooms

Katie Hobbs vetoed a new law making it illegal to film or facilitate sexually explicit acts in government buildings and classrooms months after a teacher in Arizona was fired for shooting a porno in her classroom and posting it to OnlyFans. "No 12-year-old child should ever have to worry that their middle school desk was the location of a porn shoot, yet because of Hobbs' actions, this is precisely the case," said Arizona State Senator Jake Hoffman.

SB1696 passed through the House and Senate with Republican support. Radical left Democrats predictably voted against this measure.

Last November, a teacher was caught filming porn in her 8th-grade classroom and sharing it on OnlyFans and social media.

AZ Family reports, Lake Havasu City, AZ (3TV/CBS 5) — A teacher at Thunderbolt Middle School is reportedly caught in a scandal — one that's horrifying both parents and students. "That was my friend's daughter's desk. And she is mortified over the situation, 'that is my desk.' She has no care knowing students have seen her everything and on students' desks," said Thunderbolt mom, Kristina Minor.

The teacher has an online account where students found her por-

nographic content, which appears to be filmed in her 8th-grade classroom. "She was sharing these links to her sex site on her social media accounts, which are public, which children follow her," said Minor. The sick teacher reportedly used a photo from the school yearbook on her OnlyFans page.

Lake Havasu Unified School District said in a statement, "It has come to our attention that students have been airdropping explicit material. The images did not happen during the school day and the person depicted no longer works for LHUSD. Please remove all images from your child's phone and talk with them about the appropriate use of technology." No criminal charges were filed against the individuals involved in making the sex tape, leaving parents disgusted and outraged.

Hobbs vetoed the bill banning porn shoots in classrooms and government buildings, calling it a "poor measure to address those concerns." She also claimed, "it serves as little more than a thinly veiled effort to ban books." State Senator Jake Hoffman released the following statement, calling Hobbs' actions "absolutely sickening." Hobbs Allows Pornography to be Filmed in Arizona's K-12 Public School Classrooms.

PHOENIX, ARIZONA- Senator Jake Hoffman is calling out Governor Hobbs for her outrageous veto of a bill that would have made it a crime to film por-

nography in any buildings funded by taxpayer dollars, including the classrooms of our K-12 public schools.

Seven months ago, local media reported two teachers in Mohave County were fired after students and parents found easily accessible pornographic material posted online, made by the couple, some of which was created in the very classroom one of those teachers was working in. Unfortunately, current state law does not establish this as an illegal practice.

SB 1696 (sexually explicit materials; government; prohibition) would have prohibited government property from being used as a site to film or facilitate sexually explicit acts and would have established a violation as a class 5 felony.

"Once again, Katie Hobbs is spotlighting Democrats' far-left extremism by

vetoing yet another bill intended to protect our children from exposure to sexually explicit materials at the hands of Arizona governments," said Senator Hoffman. "It's absolutely sickening that Katie Hobbs is allowing pornography to be filmed in our state's taxpayer funded classrooms. These should be safe spaces for our kids to learn in, not venues for the sexually explicit adult entertainment industry. 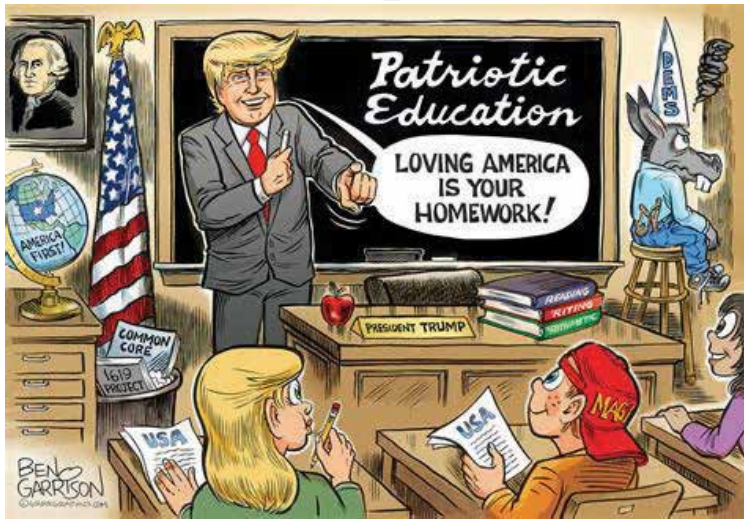
government control over the economy.

## Arizona Man Blames Court-appointed Fiduciary for Money Woes

In Arizona, fiduciary complaints can take up to two years to investigate! PHOENIX — A former high-level executive who spent just over a year placed into a court-appointed conservatorship went from an early retirement to bankruptcy.

Bill Chalmers calls himself a survivor after being placed into the probate court system. “There’s a pride that is taken away, the decisions of how much money you get to spend, whether or not you buy chicken or Kraft macaroni and cheese,” said Chalmers.

The probate court system is intended to protect the vulnerable, but some worry it can exploit those in need of help with financial and other decision-making. In the probate court, a judge is able to assign a stranger or strangers to make all your personal, financial, and health decisions for you.

During a divorce proceeding, a lawyer questioned Chalmers’ ability to make decisions, so a Maricopa County probate court interceded in 2017. The courts will assign a team to someone like Chalmers made up of a guardian ad litem, a court-appointed lawyer, a fiduciary, a lawyer for the fiduciary, and oftentimes a psychiatrist. A guardian ad litem is assigned by a court to help protect the interest of a person like Chalmers. “I pay for everybody,” said Chalmers.

Rick Black, a national advocate for the Center for Estate Administration,

known as CEAR, which works across the country for reform, estimates that there are 15,000 to 20,000 victims each year nationwide due to predatory attorneys and fiduciaries, conservatorships, and guardianships. “And to me, that’s the epitome of a dysfunctional system,” said Black.

Chalmers had questions after he got out of his 13-month court-appointed conservatorship with East Valley Fiduciary Services. “My ballpark figure of how much I lost during that period of time was a little over \$700,000,” said Chalmers. In 2020, Chalmers filed a 200-page complaint with the Arizona Fiduciary Board, the entity in Arizona in charge of licensing and discipline. In total, there were 38 allegations against East Valley Fiduciary Services that claim procedures were not followed. “They left me with my own bank account, with \$200,” he said. Chalmers showed up to the board meetings for years asking for updates on the investigation.

It is unclear how many complaints there are against fiduciaries because only complaints ending in discipline are made public. ABC15 Investigators found in 2019, East Valley Fiduciary Services was disciplined with a one-year probation after allegations that they placed a man in a secure, assisted living facility against his will. Even during a probation period, a fiduciary is able to take on new wards. “Generally speaking, if someone is on probation already, just the fact a complaint comes in isn’t necessarily a violation,” said

Aaron Nash, who runs Arizona’s Certification & Licensing Division at Arizona Supreme Court. One of the divisions Nash helps oversee is the Fiduciary Licensing Program which helps to protect elderly and otherwise vulnerable adults. Fiduciaries are licensed individuals or businesses that manage people’s financial affairs, medical decisions and other matters. The fiduciary certification and licensing division is the entity that approves and tracks licenses and complaints.

It took more than two years for the fiduciary board to finish investigating Chalmers’ complaint. They substantiated 10 of the allegations in October 2022. Those include filing a conservator’s accounting that was inaccurate and/or misleading, failing to timely file an inventory and appraisal with the court, not filing an estate budget with the court, and failing to provide 120 days of funding to the ward at the end of the conservatorship, in violation of a court order.

A lawyer for East Valley Fiduciary

Services said in an email to ABC15 that they do not agree with the substantiated allegations, “(EVFS) has not had the opportunity to respond to them, and they have not yet been tested in any contested legal proceeding where EVFS would have the opportunity to present evidence and call and cross-examine witnesses regarding the allegations.” The lawyer added that court proceedings were highly contentious with Chalmers and said that Chalmers still owes them money. As for Chalmers, he wants reform. Six years after this all began, it is still not over for him. “To be honest, I don’t want my story to come out. I don’t want people to know, but if I can stop this from happening to someone else’s mother or someone else’s father,” Chalmers said.

## Connecting the Dots – The True Cost of Renewable Energy. Is it Another Unattainable Idiotic Fantasy?

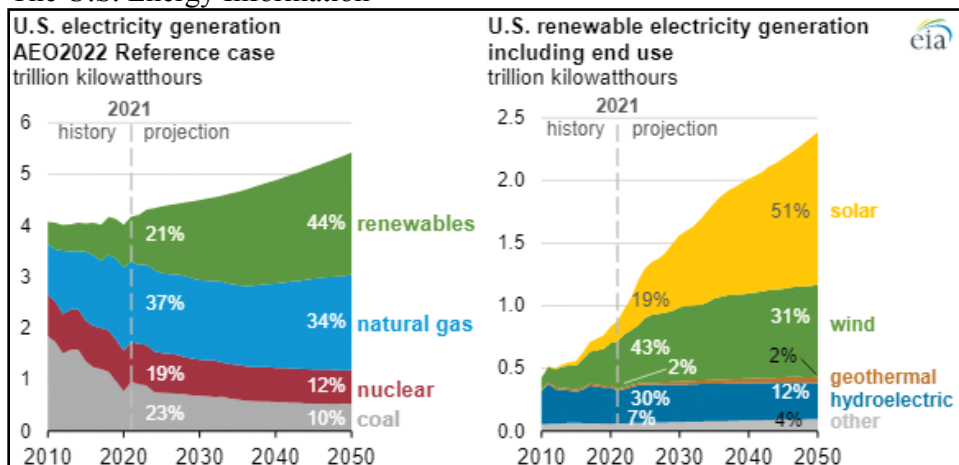

Over the past fifty years of my engineering life, I have been very involved in renewable resources and the environment. This includes developing computer control systems for wind turbine generators and founding companies that installed solar thermal panels and photovoltaic (PV electric) panels for residences and commercial buildings. I have three patents on a solar thermal panel that uses linear parabolic mirrors to track the sun and have four patents on a water purification system that removes virtually all contaminants. As a result, I have a deep understanding of the issues presented in this article. My experiences and research studying this for the past 40+ years, tells me that the present push for renewable energy and having enough mined materials is an unattainable objective and an idiotic fantasy.

### Renewable Energy Forecast

The so-called Inflation Reduction Act (IRA) proposed by puppet Biden and his CCP controllers purported to “curb inflation” to “green” the economy and save the planet. The reason to do this is because of “Climate Change”, previously known as “Global Warming”. This is supposed to give us cheap green energy and save the planet. Over the next seven years to 2030, an estimated \$3.4 trillion will be invested in wind and solar. Currently, wind and solar supply less than 10% of U.S. energy compared to 84% percent from hydrocarbons: coal, oil and natural gas.

The U.S. Energy Information



Administration (EIA) projects that the share of U.S. power generation from renewables will increase from 10% in 2021 to 44% in 2050. This increase in renewable energy mainly consists of new wind and solar power.

### U.S. Energy Information Administration, Annual Energy Outlook 2022 (AEO2022)

Achieving “Net Zero” carbon dioxide emissions would require literally millions of wind turbines, billions of solar panels, millions of 1,000-pound lithium battery modules for vehicles, millions of more lithium battery modules to back up intermittent electricity generation, millions of transformers, and tens of thousands of miles of new transmission lines. All these technologies must be manufactured from metals, minerals and petroleum, extracted from the earth, via mining and a manufacturing effort unprecedented in history.

Manufacturing wind turbines is a resource-intensive process. A typical wind turbine contains more than 8,000 different components, many of

which are made from steel, cast iron, and concrete. One such component are magnets made from neodymium and dysprosium, rare earth elements mined almost exclusively in China, which controls 95% of the world’s supply of rare earth minerals.

Energy storage systems, such as stand-alone batteries or solar-battery hybrid systems will be necessary to provide electric power generation back-up capacity for times when non-baseload renewable energy sources such as wind and solar are unavailable. Science and policy analyst David Wojick calculated that “just the lithium batteries needed to back up wind and solar electricity generation in a “net zero” USA would cost \$23 trillion – America’s entire 2021 gross domestic product – and probably many times that.”

### Mining the rare earth minerals for wind and solar is the issue.

From the World Atlas: “Mining is the extraction of minerals and other geological materials of economic value from deposits on the Earth. Mining adversely affects the environment by inducing loss of biodiversity, soil erosion, and contamination of surface water, groundwater, and soil. Mining can also trigger the formation of sinkholes. The leakage of chemicals from mining sites can

also have detrimental effects on the health of the population living in or around the mining site.” Securing just one ton of rare earth elements produces 2,000 tons of toxic waste.

To meet greenhouse gas emission reduction targets under the Paris Agreement, renewable energy production has to scale up fast. This means that global production of several rare earth minerals used in solar panels and wind turbines - especially neodymium, terbium, indium, dysprosium, and praseodymium, must grow 12 times by 2050.

In the Democratic Republic of the Congo, tens of thousands of youngsters, as young as 7, work 12 or more hours per day for \$1 or \$2 in unsafe conditions, mining cobalt for the lithium batteries used in laptops, cellphones and other digital devices.

Men, women and children are working without even the most basic



protective equipment, such as face masks and gloves.

A major supply gap in copper is threatening the transition to green energy. Copper

is used in construction, wiring, solar panels, wind turbines, electric vehicles and other technologies. Green energy use made up just 4% of copper usage last year but it is forecast for 2030 to be 17%. This raises the demand for copper to 36.6 million metric tons. In 2022, the globally mined output of copper was only 21.8 million tons.

The other challenge is that rare earth metals mining is massively concentrated in just a few countries: particularly China, which dominates 80% of mining and nearly 95% of refining. Europe and the US are overwhelmingly dependent on China, which would be in a position to control global supply and could be



easily abused.

As recently as 1990, the U.S. was the world's number-one producer of minerals. Today, it is in seventh place. Even though the nation has vast mineral reserves worth trillions of dollars, America is now 100% dependent on imports for some 17 key minerals and, for another 29, over half of domestic needs are imported.

Grid restructuring and accelerating electric car deployment also means exporting jobs and offshoring environmental consequences. Some 90% of solar panels are imported, as are 80% of the key components for wind turbines. Asian companies dominate global battery production and account for 80% of all planned factories. Even if we expand domestic manufacturing, our import dependencies remain for critical energy minerals. It takes a large capital investment and between 10 to 20 years to develop new mines as the regulatory agencies in the U.S. make it very difficult to open new mines.

All energy-producing machinery must be fabricated from materials extracted from the earth. No energy system is actually "renewable," since all machines require the continual mining and processing of millions of tons of primary materials and the disposal of hardware that inevitably wears out. Compared with hydrocarbons, green machines entail, on average, a 10-fold increase in the quantities of materials extracted and processed to produce the same amount of energy.

### **Do we have enough mineral resources to support the Renewable Energy growth forecast?**

The hard reality is, there are not, will not be, and cannot be, enough mines, metals and minerals on the entire planet to reach any "net-zero" US economy by 2050, much less a global green environment.

My article in the April 2023 issue of "The Patriot Free Press" titled "Connecting the Dots – The True Cost of Electric Vehicles" on pages 13 through 17 discusses the mining and environmental issues around the

critical metal demand for renewable technologies. The scale of material demands for building "clean technology" machines and the environmental impact are massive! The article and references are also available on my Substack at [billlowstuter.substack.com](http://billlowstuter.substack.com).



In Mark Mills' article *The Hidden Costs of Going Green*, (2021 *Dakota Digital Review*) he states:

"For example, replacing the energy output from a single 100-MegaWatt (MW) natural gas-fired turbine, itself about the size of a residential house (producing enough electricity for 75,000 homes), requires at least 20 wind turbines, each one about the size of the Washington Monument, occupying some 10 square miles of land. Building those wind machines consumes enormous quantities of conventional materials, such as concrete, steel and fiberglass, along with less common materials, including "rare earth" elements such as dysprosium."

All forms of renewable energy require roughly comparable—and enormous—quantities of materials in order to build machines that capture nature's flows: sun, wind and water. Wind farms come close to matching hydro dams in material consumption, and solar power requires even more. In all three cases, the largest share of the tonnage is found in the use of conventional materials like concrete, steel and glass. Compared with a natural gas power plant, all three so called "green" options require at least 10 times as many total tons mined, moved and converted into machines to deliver the same quantity of energy.

For example, building a single 100-MegaWatt (MW) wind farm

- never mind thousands of them -requires some 30,000 tons of iron ore and 50,000 tons of concrete, as well as 900 tons of non-recyclable fiberglass for the huge blades.

With solar hardware, the tonnage in cement, steel and glass is 150 percent greater than for wind for the same energy output.

If episodic sources of energy (wind and solar) are to be used to supply power 24/7, even greater quantities of materials will be required. One needs to build additional machines, roughly two to three times as many, in order to produce and store energy when the sun and wind are available for use at times when they are not. Then there are the additional materials required to build electricity storage. For context, a utility-scale storage system sufficient for one of the above-noted 100-MW wind farms would entail using at least 20,000 Tesla-class batteries."

### **Wind Power Facts**

"The average wind tower height is around 90m – 130m (295 feet – 426 feet). The wind turbine foundation bears the load transmitted from the wind turbine tower and the turbine on the top, especially the huge overturning moments. It can be either round in shape or octagon shape. The foundation diameter ranges from 15m to 22m (50 feet – 72 feet).

The construction of 15- to 20-foot-deep concrete foundations to support

all of the 328-ft.-high towers with 2-MW turbines in Ohio's Blue Creek Wind Farm

each required 30,000 tons of cement. On average, each below-ground foundation used 60 truckloads of concrete.

The gearbox, which transforms the slow turning of the blades to a faster rotor speed, and the generator are

massive pieces of machinery housed in a bus-sized container, called the nacelle, at the top of the tower. The blades are attached to the rotor hub at one end of the nacelle. Some nacelles include a helicopter landing pad.

On the GE 1.5-megawatt model, the nacelle alone weighs more than 56 tons, the blade assembly weighs more than 36 tons, and the tower itself weighs about 71 tons, for a total weight of 164 tons.

New roads have to be built, or existing ones need to be extensively "upgraded." It requires more than an old dirt logging track to get a 150-ft blade, a 70-ton nacelle, or the huge crane needed to put it all together up a mountain. The road needs to be wide, straight, and very strong.

Several acres around each turbine have to be cleared as well. For best performance, the GE 1.5-megawatt turbine needs 82 unobstructed acres around it and the Vestas V90 needs 111 acres. On a ridgeline, the sloping away of the land and the hope that the wind is always perpendicular to the line of the ridge mean that about 5 acres are actually cleared around each turbine.

A wind turbine facility may also require a new substation or two, as well as new transmission lines. The combination of all this -- road building, extensive clearing, and the installed facility itself -- not only significantly degrades and fragments wildlife habitat but also has a serious effect on erosion and water flow, not



to mention the aesthetics of a mountainside or open land. And of course the visual intrusion affects the landscape for miles around.

Because of the way the electric grid works, constantly matching supply with demand to avoid dips and surges of power, the variable production of wind turbines and solar is treated



as part of the demand side of the equation. A base level of power is provided from large plants, and other plants are kept burning to be able to provide the maximum likely power (peak load) needed as it varies through the day. As demand drops, those plants are diverted from power generation, and as demand rises, they are brought back on to resume generating the needed power. These plants burn fuel whether or not they are producing electricity.

In other words, these peak load plants must continue burning fuel when demand falls or wind and solar production rises, because either trend may reverse at any time. The effect of wind turbines and solar, because they are out of the control of the grid's dispatchers, just like user demand, is only to bring the spinning standby plants in and out of production. But, again, the plants continue to burn their fuel. Also, the additional fluctuations of wind power add to the cost and inefficiency of that burning.

A further irony is that because an increase in wind power or solar power capacity is seen on the grid as an increase in demand fluctuation, it requires input of other grid sources to cover it. Rather than reducing other sources, wind and solar power requires building more conventional capacity, particularly natural gas-fired plants, which it then forces to operate less efficiently."

### **Environmental issues & Recycling**

All machines wear out, and there is nothing actually renewable about green technologies, since one must engage in continual extraction of materials to build new ones and replace those that wear out.

All this requires mining, processing, transportation, and, ultimately, the disposing of millions of tons of materials, much of it functionally or economically unrecyclable.

Wind turbine blades can't be recycled so they are piling up in landfills. Built to withstand hurricane force winds, the blades can't easily be

crushed, recycled or repurposed. A wind turbine's blades can be longer than a football field, so at the end of their lifespan they can't just be hauled away. First, you need to saw through the fiberglass using a diamond-encrusted industrial saw to create three pieces small enough to be strapped to a tractor-trailer.

Tens of thousands of aging blades are coming down from steel towers around the world and most have nowhere to go but landfills. In the U.S. alone, about 8,000 will be removed in each of the next four years. It's going to get worse: Most were built more than a decade ago, when installations were less than a fifth of what they are now, and the blades were much smaller.

The International Renewable Energy Agency (IRENA) forecasts that by 2050, with current plans, wind and solar garbage will constitute double the tonnage of all forms of global plastic waste. Similar scales are expected from end-of-life batteries used in electric cars and on power grids. China's annual battery trash alone was already estimated to be 500,000 tons in 2020. It will exceed 2 million tons per year by 2030. Currently, less than 5% of such batteries are recycled.

When the 20 wind turbines that constitute just one small 100-MW wind farm wear out, decommissioning and trashing them will lead to fourfold more nonrecyclable plastic trash than all the world's (recyclable) plastic straws combined. There are 1,000 times more wind turbines than that in the world today. If current International



Energy Agency (IEA) forecasts are met, there will be over 3 million tons per year of unrecyclable plastic turbine blades by 2050.

Wind farms kill 10-20 times more birds and bats than previous-

ly thought. We are talking about an unsustainable death toll of 30 million birds and 50 million bats a year in the US alone. This carnage includes protected species that cars and cats rarely kill - eagles, hawks, falcons, owls, condors, whooping cranes, geese, bats and many others. The raptor slaughter will cause rodent populations to soar. Butchery of bats, already being decimated by White Nose Syndrome, will hammer agriculture and forestry.

Wind turbines are supposed to last 20 to 30 years, which is far less than energy generation fueled by coal, natural gas or nuclear power. Turbine heights are now stretching taller than 850 feet with blades 350 feet long because the bigger the turbine, the more energy it can capture. But the bigger the turbine, the more that can go wrong and the further it

falls if it collapses. Failures are now happening more frequently and in a shorter time frame on the newer larger turbines.

A recent Department of Energy vision for offshore wind (never mind onshore wind farms) in the U.S. would lead to nearly 10 thousand tons of neodymium alone "buried" inside more than 4 million tons of machinery that will eventually head for waste dumps. That sounds like a lot of material worth recovering, but it pencils out to a neodymium concentration in the trash that is one-tenth of the natural ore grade for that mineral at a mine site. Such realities can lead to the surprising outcome that the energy required to recover a recycled mineral can be greater than expended to get it from nature's ore.

As the wind turbines have to be spread far apart, more and more land in densely populated areas will be needed to meet Biden's climate control goal of 100% carbon-free electricity by 2035.

**Photovoltaic (PV) Electric Panels**  
Solar energy is one of the sources of renewable energy that is being pushed to achieve a "Net Zero" environment. Experts have found that the rare metals required to build solar panels, such as indium and tellurium, are not in sufficient supply to keep up with demand.

PV cells contain semiconductor materials that absorb light and transfer it to electrons that form an electric current. Solar panels are laid out like a sandwich with cells in the center. About 90% of commercial solar panels use silicon as the semiconductor, which converts light into electricity. Thin strips of metal, usually silver, crisscross the surface of silicon crystals in each cell and move electricity into the panel's copper wiring.

Silicon is still the dominant semiconductor metal used in solar cells, accounting for more than 90% of the market. As the adoption of solar energy grows, demand for silicon for PV panels could rise to 807,500 tons by 2040, up from 390,00 tons in 2020, according to the IEA's projections. If thin-film technologies gain more market share from silicon, demand for cadmium and tellurium





could rise as much as sevenfold, while demand for gallium could reach 10 times more than current production. There are not enough resources to meet future demand.

However, solar panels can fail or underperform over the expected 25-year life due to a number of different reasons. It is normal for the cells to slowly lose power due to what is known as light-induced degradation which results in an average 0.5% loss per year. This slow degradation is often not noticeable and most solar panels will still perform at 80% or higher of the original rated capacity after 20 years depending on the type of cell used.



Prices for polysilicon, the form of silicon metal used in PV panels, have climbed over the past year as demand has outpaced supply and disruption to production at facilities in China has further tightened the market. Other minor metal prices have also risen on supply constraints during the COVID-19 pandemic.

### Environmental Issues

By 2050, with current plans, the quantity of worn-out solar panels—much of it nonrecyclable—will constitute double the tonnage of all today's global plastic waste, along with over 3 million tons per year of unrecyclable plastics from worn-out wind turbine blades. By 2030, more than 10 million tons per year of batteries will become garbage.

Experts also question the true “clean” nature of solar energy, given that mining for its essential components involves the handling of highly toxic materials, and contamination of surrounding soil and water in the process. It has been reported that people living close to China's mines are suffering, directly and indirectly, related health problems. Mining for rare metals is considered to be one of China's most polluting industries, presenting potential disasters relating to contamination that threatens to cause a wide-scale catastrophe.

By depleting earth of its resources, solar energy is not sustainable as the

components required are finite and polluting to mine and process. In addition, solar energy is considered to be a clean energy alternative to help reduce questionable CO2

emissions, but as mining for these precious metals causes other environmental damage the current process for producing solar panels has to be revised.

### Recycling

Currently, recycling rates for critical metals are below 1% and some rare earth metals aren't recycled at all. Millions of solar panels have been installed in the last two decades—and since they typically last between 25 and 30 years, many will soon be ready for retirement and probably headed to a landfill. But new efforts to recycle these panels could reduce both the amount of waste and the new material that needs to be mined.

Only about 1% of panels in the US are recycled—it isn't mandated by federal regulations, and recycling the devices is currently much more expensive than just discarding them.

About 8 million metric tons of decommissioned solar panels could accumulate globally by 2030. By 2050, that number could reach 80 million tons.

### Summary - Conclusion

Wind and solar energy are not nearly as “clean” and “good for the environment” as the “Green” lobbyists want you to believe. The renewable energy industry is dependent on rare earth minerals imported from China, the procure-

ment of which results in staggering environmental damages. As one environmentalist said, “There's not one step of the rare earth mining process that is not disastrous for the environment.” That the destruction is mostly unseen and far-flung does not make it any less damaging.

All forms of energy production have some environmental impact. However, it is disingenuous for lobbyists to hide the impacts of their industry while highlighting the impacts of others. From illegal bird deaths to radioactive waste, renewable energy poses serious environmental risks that the lobby would prefer you never know about. This makes it easier for them when arguing for more subsidies, tax credits, mandates and government support.

President Biden is not placing Americans first because, rather than permitting critical mineral mines in the United States, his administration is looking for ways to invest in foreign mineral mines, producing jobs



abroad and helping the economies of those countries to expand. Several companies have spent decades trying to get permits in the United States to develop mines in Minnesota, Nevada, Alaska and Arizona only to be thwarted by environmentalists and the Biden Administration.

There are not enough minerals available in the U.S. for Biden's “Net Zero” energy transition goals.

He is therefore making the United States much more dependent on foreign countries, particularly China. Today, the United States is the largest producer of oil and gas, has the most coal reserves in the world and the largest inventory of nuclear plants that can produce reliable power for centuries to come and yet Biden wants to throw that away for unreliable, intermittent electricity, while pushing for the electrification of everything, without developing the domestic energy mineral mines that the solar and wind technologies require.


Despite massive growth in the generating capacity of wind and solar farms, fossil-fuel-powered electric plants remain an irreplaceable component of a reliable electrical grid. Wind and solar power, as technology currently stands, cannot adequately substitute for power from fossil fuels. This is because wind and solar power suffer from the insurmountable problem of being intermittent - wind turbines don't work when

it's not windy, and solar panels don't work when the sun's not shining.

Biden's push for total renewables electrification of the U.S. economy with intermittent technologies is a disaster waiting to happen and is an Idiotic Fantasy! There are not enough natural resources to accomplish the goals they are wanting. It involves huge transfers of wealth to

foreign nations and powers, rapidly growing dependency upon China and other authoritarian regimes, and increased foreign entanglements to ensure delivery of foreign made products that could be produced by Americans here at home.

## The Money Matrix: Part 11, Media AT&T Public Relations aka Social Engineering: 1907-1939

### Introduction

“When a commercial bank makes a loan contract with a borrower, the bank CREATES the deposit in the borrower’s account.” Have you repeated this fact 15,000 times yet? Private banks CREATE what we use as money. They have never taken money from one account to loan to another. No, they always CREATE the borrower’s deposit for the loan.

### Congress Investigates AT&T – By 1935, the Largest Business in the World

When the J.P. Morgan-led bankers installed Theodore Vail as AT&T President in 1907, Mr. Vail proclaimed the Bell System as “ONE POLICY – ONE SYSTEM – UNIVERSAL SERVICE”. Vail began the practice of “public relations” as a central corporate policy.

In 1935-1936, for two years, Congress authorized the Federal Communications Commission (FCC) to investigate the privately-owned public utility AT&T. The FCC was formed as an independent agency by the Communication Act of June 19, 1934, “For the purpose of regulating interstate and foreign commerce in communication by wire and radio...”

The “Telephone Investigation” was “the first comprehensive study in the course of sixty years’ history of this largest business in the world.” In 1939, N.R. Danielian published his book, A.T.&T.: The Story of Industrial Conquest, based on the hundreds of reports by FCC experts and thousands of Congressional pages of interviews with A.T.&T. executives. The author showed how “...with the expansion of the channels of communication... Political propaganda has become an indispensable tool of business policy.” All page references in the body of this article refer to this book.



### “Telephone Investigation” Findings - 1935-1936

Danielian confirms the financial control of the bankers over AT&T and the Bell System. The bankers directed a self-perpetuating executive committee and president, residing over the only corporation at the time generating over a billion dollars of yearly revenue. AT&T was the holding company, which owned more than 50% of the stock in 19 Bell regional companies, which blanketed the nation. AT&T’s president had the power to vote the Bell companies’ stock and select their directors and officers. “The System constitutes the largest aggregation of capital that has ever been controlled by a single private company at any time in the history of business.”(p.3) The Bell System “wire... used for telephone, telegraph, radio, wire-photo, and teletype services... the nerve fibers of modern civilization.”(p.16)

### Public Relations aka Social Engineering

Danielian’s conclusion: “... the Bell System is a political organization of the first magnitude... interested primarily in the retention of control.”(p.400) He points out that AT&T used “unrelenting prop-

aganda and advertising by the use of every contact that is available to them.”(p.273) On p. 280, the author asked: “Whether the United States shall continue a democracy, or shall revert to a form of oligarchic control imposed by corporate states through assumption of state powers, today hangs in the balance.”

Here are just some of these social controls documented by the Telephone Investiga-

tion:

### PUBLICITY DEPARTMENTS:

\* AT&T and all local Bell companies had their own publicity departments, with annual conferences of company officials.

### BANK ACCOUNTS:

\* Each bank account was a chance to communicate with and influence a prominent citizen. Thus, the corporation used many more bank accounts in city and local communities than needed.

\* From AT&T’s 1927 Treasurers’ Conference: “In the City of Chicago, eight accounts are not absolutely necessary... but in dealing with eight banks we have close relations with the leading financial interests of the city.”(p.287) “In the smaller communities, distributing the account to two or three banks... we have slightly more idle mon-

ey... advantages obtained from additional contacts justify the practice.”(pp.287-288)

### LABOR & EMPLOYEES:

\* Bell employees are found throughout all states and counties.

\* Employees are trained to be public relations agents with the public.

\* Employees are encouraged to join business, social, scientific, professional, athletic associations and clubs - to sell the system not the service. From 1925 to 1934, Bell companies paid \$4.9 million for employees’ dues in these social organizations: \$4 million was charged to operating expenses, which were ultimately charged to the customer.

### STOCKHOLDING:

\* In April 1927, AT&T President Gifford characterized the Bell System as “a public utility, publicly owned.” The typical advertisement shows a picture of a lonely old lady, peeling potatoes, described as “One of the Owners of the Bell System.”

\* Stock sold to employees. And, sold by employees to customers.

\* As of 1935, outstanding stock in hands of investors: 18,660,000 shares.(p.175)

\* The largest number of stockholders of any concern in the U.S. But only 5.1 per cent of stockholders, according to the ledgers of AT&T, owned 50.5 per cent of the outstanding shares, as of September 16, 1925. (pp.176-179) Danielian: “It is still

the estate of the large investor. It could not be otherwise, in view of the distribution of wealth in the... U.S.”(p.181)

**CIVIC AND COMMUNAL LIFE – using every conceivable channel:**

- \* Employ lawyers.
- \* Place insurance.
- \* Award contracts – hundreds of millions of dollars spent each year making purchases. For example, when printing the Telephone Directory, contracts were awarded to the highest bidder “due to local political reasons”(pp.289-290)

**BOOKS:**

- \* Paid authors to write and publish three books on telephony, but all the books were strictly distributed supposedly from ‘independent authors’ – all with strong condemnation of government ownership of utilities.

**UNIVERSITIES:**

- \* AT&T officers sought lectures at colleges and universities to give “sound thinking” about public utilities.

**MOTION PICTURES:**

- \* 1926-1935 AT&T produced 56 motion picture films for publicity purposes. They were distributed by



Bell to theater managers, who used them since the films had no advertising and were for ‘information and education’. There were close to 1 million showings with an average audience of 442.

- \* The films were shown in schools and at civic meetings free of charge and an operator and project would be provided. During 1932-1935, Ohio schools showed The Telephone Story 5 thousand times, reaching over 1 million children.(p.305)

**PRESS:**

- \* Bell distributed suggested news materials and employees’ magazines to newspapers. Between 1926-1935, Bell distributed 1.2 million copies

of a monthly AT&T bulletin.

- \* From 1915-1931, AT&T paid a syndicated news service \$102 thousand dollars. The news service presented itself to newspapers as independent of industry.
- \* Intimate contacts with editors and reporters were established and systematically maintained by Bell representatives.
- \* Bell representatives attended regional press association meetings.

**ADVERTISING:**

- \* Between 1927-1935 Bell spent \$51.9 million on advertising.
- \* Bell advertising was directed at feelings, attitudes, emotions: constant progress - telephone as convenience and necessity - efficiency of operation - constant service improvement - popular ownership - romantic aspects of communication.
- \* Bell dispensed this patronage to purchase good will.

**POLITICS OF RATE ‘REVISIONS’ (NOT ‘INCREASES’):**

- \* To reduce the public’s opposition to rate ‘revisions’, Bell companies enacted a coordinated campaign for public endorsement: newspaper advertisements – pay envelope

enclosures to Bell employees – suggested talks to employees’ clubs and organizations – window posters

**LOBBYING with ‘Legislative Agents’:**

- \* In each state and District of Columbia, one or more attorneys or agents of Bell System watch all proposed and pending legislation.
- \* From 1923 to 1936, Bell employed 251 field representatives, making a practice of employing the most influential local attorneys available.
- \* Bills are referred to the legal department of AT&T, who receive about 10,000 bills when state legislatures are in session, and about 5,000 bills during the off year.
- \* State manuals, governors’ messages, and legislative journals are forwarded to New York.
- \* Agents are asked to immediately report on subjects as: telephone, telegraph, corporations, trusts, monopolies, discrimination, taxation, eminent domain, utility regulation, public ownership, labor and its benefits, labor controversies.
- \* Notice of an introduction of a bill to be reported immediately by telegraph or telephone.
- \* Used indirect methods of private contacts with legislative and committee members.

Today, the FCC is a captured agency of the telecommunications industry.

A disturbing new report from the United Nations Programme on HIV/AIDS (UNAIDS) adds to growing concerns about global leaders pushing to normalize pedophilia. The report “The 8 March Principles for a Human Rights-Based Approach to Criminal Law Proscribing Conduct Associated with Sex, Reproduction, Drug Use, HIV, Homelessness and Poverty” on the UNAIDS website offers legal guidance on issues related to sex, including involving children under age 18.

Without any discussion about what the age of consent should be, the report suggests minors can consent to having sex with an adult. “Sexual conduct involving persons below the domestically prescribed minimum age of consent to sex may be consensual in fact, if not in law,” the report states. It also advises lawyers, judges and law enforcement to consider “the rights and capacity of persons under 18 years of age to make decisions about engaging in consensual sexual conduct and their right to be



heard in matters concerning them” when considering enforcement of laws about sex with minors.

The report continues: “Pursuant to their evolving capacities and progressive autonomy, persons under 18 years of age should participate in decisions affecting them, with due regard to their age, maturity and best interests, and with specific attention to non-discrimination guarantees.” In other words, Live Action News writer Cassy Fiano-Chesser pointed out “the report calls for sex between adults and minors to be decriminalized, so long as the minors ‘consent.’ Minors, of course, cannot truly consent to sex with an adult,

something these so-called experts should know.” However, the report portrays the matter as an issue of rights and acceptance.

The forward to the report was written by a “proudly gay” lawyer, Edwin Cameron of South Africa, who argued that laws about sex can make people feel ostracized because of their sexual behavior. “Criminal law may thus impel hostility, exclusion, inequality, discrimination and marginalization of individuals and groups, sometimes to the point of violence. As a result, human rights, democratic values and social inclusiveness all suffer,” Cameron wrote.

He argued that laws criminalizing sexual behavior “codify discrimination” against people of different sexual orientations. Cameron did not mention it, but some now argue that an adult who is sexually attracted to children is a sexual orientation, not a pedophile.

Another disturbing aspect of the report was its insistence that killing unborn babies in elective abortions is a human “right.” The report calls for completely decriminalizing abortions – a move that would protect dangerous untrained abortionists and quacks from prosecution. “Abortion must be taken entirely out of the purview of the criminal law, including for having, aiding, assisting with or providing an abortion...” the report states. It also argues that pregnant mothers should not be punished for using drugs or alcohol during pregnancy even if the unborn baby is harmed.

The groups involved in creating the report include the International Commission of Jurists, UNAIDS and the Office of the United Nations High Commissioner for Human Rights, according to Fox News.

## Democrat Katie Hobbs Hangs LGBTQ Flags Above American Flag at Arizona Capitol

Katie Hobbs has placed multiple pride flags outside her office at the Capitol above the American flag and state flag to kick off “LGBTQI+ Pride Month.”

executive director of Legislative Council, said he removed the flags because they were “nonconforming” and Hobbs did not go through the proper channels in order to display them on the



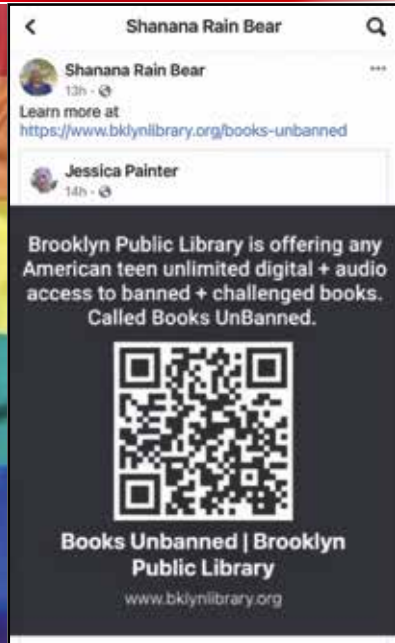
building. He said he was not directed to do so by Bowers, Fann or anyone else. “I think the rules are pretty minimal,” Braun told the Arizona Mirror.

## The little-known history of Acupuncture in America

I attended a masters degree program in the US for Chinese medicine, and in the 4 years it took to complete the program, I was never taught a crucial piece of history about acupuncture in America: it was first popularized by black and hispanic people.

The story I was taught was that Nixon went to China in 1971 and while he was there, a reporter from the New York Times, James Reston, had to get an emergency appendectomy. When the hospital used acupuncture for his pain relief, he was so stunned about how well it worked he wrote about in the newspaper. This was the first formal introduction of acupuncture to the public and started a gradual interest among mostly white men to professionalize acupuncture within school settings and state regulations.

What my teachers left out of this history is a much more interesting story: outside of Asian-American communities, members of the Black Panthers and Young Lords, two very important civil rights groups, were actually some of the first people in the US to widely practice acupuncture. Here's an abbreviated history: In 1970, the Black Panthers and the Puerto Rican activist group, the Young Lords, pioneered a community health clinic in the Bronx called the

members from heroin. At the time, the only treatment for drug addiction was to take another drug: methadone. They were unsatisfied with the idea of having to be dependent on methadone forever, so they began to investigate new ways to help people detox naturally. A few members, including Mutulu Shakur (Tupac Shakur's stepfather), had personal experience with acupuncture in the local Chinatown, and decided to try using it at the center.

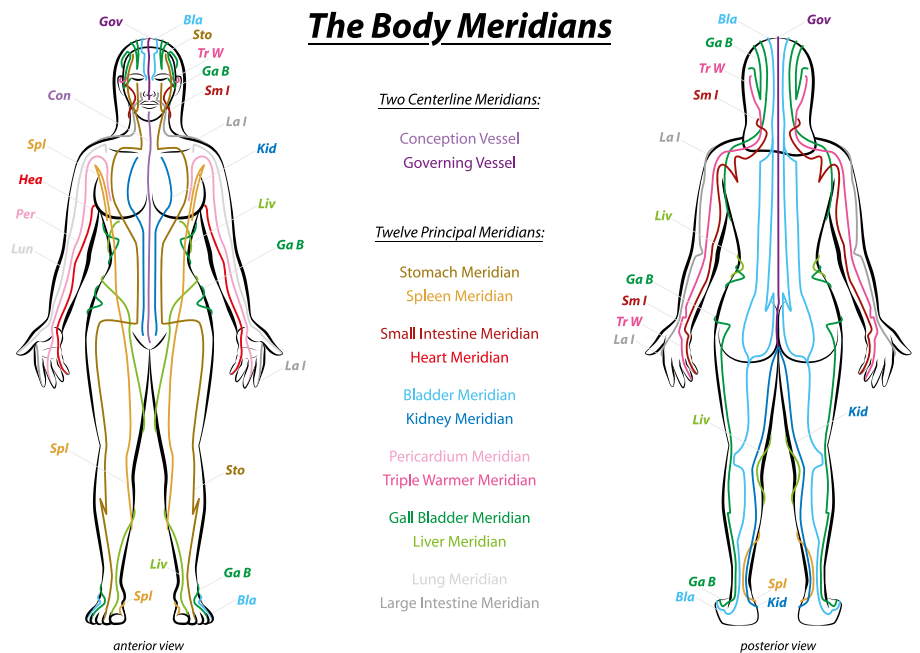
By 1972 The Black Panthers and Young Lords were providing free acupuncture to detox thousands of people at the Lincoln Detox Center. They also developed the NADA (National Acupuncture Detoxification Association) protocol, an ear acupuncture treatment that is still widely researched and used for the treatment of addiction, trauma, stress, and mental health.

By the early 80's, the US government had systematically shut down the clinic, through an operation called COINTELPRO, erasing this history of the Black Panther & Young Lords' huge contribution to healthcare in America.

Pretty interesting history, right? Are you surprised you didn't know about it? Is this rattling what you thought you understood about the Black Panthers? You are not alone!

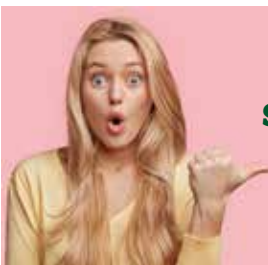

I have basic human respect for everyone's journey. Ultimately, that's what they're responsible for and nothing else. But I have lost a lot of respect for the people who can see, but are not willing to do anything. I sometimes get angry because I think that is a good section of the population we could really use and need, right? It's not like everybody has to have the ambition to become the President or do something huge. If everybody just did their little part in their world, we'd be all so much better off. I want you to see it for what it is, these ARE the most dangerous people because these are the ones who look away. These are the ones who drive past an accident and they say, "Oh, I have something on my calendar today, I can't help here, or I gotta go somewhere and I can't help." When you become that apathetic, when you become that detached, then it becomes very dangerous, right?

We have turned into a very, very selfish egotistical society. Me, myself and I, and this self improvement on all levels has turned into an obsession. It doesn't matter how good your life has become. These people always want to make their own life better and so often at the expense of everyone else. This is not what freedom is. This is not how this was intended to be. Some people have been programmed so intensely, they can't step out of it and they've been

programmed into egotism. They've been programmed to live a life like, "Just make sure you're well off, make sure you eat well, make sure you are well taken care of and that's all good." But then it goes like, "Why would you want to save the world? You can't save the world. We're not here to save the world. We're just here to have a beautiful experience, right?"

These are all the spiritual, new agey things that people say, "Oh, you can't. There's no such thing as saving the world. There's nothing

wrong with the world. Everything is in perfect order." Blah, blah, blah, blah, blah. That's like pushing the wagon over the edge to me. It's simply not true. Why do we have discernment? Why do we have the ability to judge? Why do we have the ability to see? It's not to use it in vengeance, but to use it as creative tools. If I have the ability to judge between wrong and right and yes, in this life, in this reality, there's a clear difference between right or wrong, a very clear difference. And so I think the responsibility is not so much, "Oh, I have the responsibility to save the world." I have the

It started in the 80s to have this self exploration, of this self improvement, of this ideal that we were just worried about ourselves and now we're stepping



into a greater and broader awareness of we are a community, we are also a collective. That's not communism. That's so often mistaken for communism, or socialism, any of that crap. But the responsibility, when you are not just awakened, but when you are in a good place spiritually, physically, mentally, you have a natural responsibility that comes from within, to help others to reach that too. Because, ultimately, in the big scheme of things, if their experience remains bad, your experience won't remain good for long right?

In my viewpoint, I can't really ever be fully free, in the largest way of looking at this, unless we're all fully free. That's kind of the idea here. And I know we won't get everyone on board and I know everyone has their own journey. Don't get me wrong, but I have to strive for an ideal. It's like when people ask me "Well, are you a Christian?" And I say, I really strive to live a Christ-like life, now do I fall short? Yeah, I fall short, every day. That's my intention: a Christ-like life. What are these qualities? What are these intentions? What are the stories? What are the teachings? What are the truths? That's really what matters for me.

So can we continue to be a light of

inspiration and perhaps, that ignites their fire too? Yes. Can we continue to be role models? Yes. And can they at some point change their mind? Yes. Here's the most important thing that I would encourage you all to see, and keep an open mind and heart about it. Nothing can keep people from waking up wiser the next morning than they were the night

before, and with the willingness to change their heart and their mind. Because at some point, we all changed our hearts and minds so everybody can have that experience. So in my view, I at least see them that way. It's not my responsi-

bility to make it happen, but I see them with the potential to open their minds and hearts.

I just feel like something must be wrong with that person. own life to do that?" Wow. That's everything that's wrong with the world in one little comment there. But apparently a lot of people think that way. "It's not my problem. It's not my business." I can't think that way. You can tell me all about how everyone creates their own reality, how that is the child's experience. Yes, but it's also my experience to walk into that field. And it's my experience to become a change maker in that field. So you say that to me, go your own way. We have nothing in common. I can't, I just can't. That might be harsh, but that's who I am.

Fifteen or sixteen years ago, my wife Kristine and I were done with this bullshit, with society because everything that's unfolding now so clearly, we saw it back then because

we were just paying attention. So to us it was almost as ridiculous as it is to most people now. We just saw it earlier, I guess or we just opened our eyes to it.
