The Declaration of Independence:

In Congress, July 4, 1776 The unanimous Declaration of the thirteen United States of America, When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.--Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world.



Members of Congress are seeking to pass an extreme and unconstitutional gun control legislation that would effectively nullify the Second Amendment.

The tragic shooting at Covenant School in Nashville, Tennessee, on March 27 has given leftists another excuse to push their predetermined goal of civilian disarmament. Notably, they are conveniently ignoring the cause of the shooting — a radical, gender-confused individual who allegedly had a hatred for Christians — along with broader radicalization among "LGBT" individuals.

Unfortunately, many Republican politicians are caving to leftist pressure and joining the effort to incrementally make it impossible for civilians to defend themselves. In Tennessee, for example, Governor Bill Lee signed an executive order strengthening draconian background checks while calling on the state General Assembly to enact a "red flag" law. We must ensure that Congress doesn't cave or restrict our God-

given freedoms!

Several unconstitutional guncontrol bills have been introduced in Congress. These include:

H.R. 698, the "Assault Weapons Ban of 2023": This bill would ban the possession, sale, manufacture, and transfer of firearms erroneously classified as "assault weapons."

H.R. 768, the "Extreme Risk Protection Order Expansion Act of 2023": This bill would implement a national "red flag" law. "Red flag" laws are particularly dangerous as they allow the government to confiscate law-abiding Americans' firearms — without due process or even an accusation of a crime merely because they are labeled as "dangerous." This violates both the 2nd and 4th Amendments. Furthermore, "red flag" laws wouldn't even have prevented the Nashville shooting.

H.R. 715, the "Bipartisan Background Checks Act of 2023": This bill would enact draconian federal background checks for firearm transfers between ordinary American citizens. Expanded

background checks will result in citizens needing the government's permission to own or purchase a firearm — violating the Second Amendment — and it also would inevitably result in a national gun registry. Such a registry would enable the government to easily confiscate people's weapons at a future date, similar to what actually happened in other countries like Australia.

H.R. 625, the "Keep Americans Safe Act": This bill would limit magazines to 15 rounds of ammunition or less — this bill would not "keep Americans safe."

H.R. 660, "Ethan's Law": This bill would require Americans to store their firearms in a certain way inside their own homes — a major violation of privacy — if a minor is present. Violating the law would lead to criminal penalties, including the seizure and forfeiture of the firearm.

H.R. 2392, the "Pause for Gun Safety Act": This bill would mandate a national, sevenday waiting period for firearm transfers, another unconstitutional defense.

H.R. 2403, the "Enhanced Background Checks Act of 2023": This bill would require a nationwide background check period of at least 10 days for firearm purchases.

Regardless of the specific proposals being pushed in Congress, they are unconstitutional and only amount to advancing the Left's civilian-disarmament schemes. For an illustration of its ultimate goal, one only needs to look at Canada, which is in the process of totally outlawing firearms.

The ability of a person to defend him- or herself is a fundamental God-given right. Stripping individuals of this right would make them utterly dependent upon the government for their very lives and allow it to strip them of other rights without fear of reprisal. It is imperative that we protect and defend the Second Amendment. Urge your U.S. representative and senators to oppose these bills and any other legislation that infringes upon the God-given right to selfdefense.

Reports of Stolen Pets on the Rise

In recent months, some social media sites are reporting an uptick in animal thefts.

Efforts to verify just how many animals have been taken have not been as productive as initially hoped, but there have been specific incidents reported by owners involving pets stolen from their own yards when, even briefly placed outside.

If you have experienced such an event or know of any in your area we would appreciate hearing from you. If these are more than 'isolated instances' it would be very helpful for the public at large to be aware of the dangers so they can take steps to protect their animals before it happens to them.

New technologies offer a wide array of anti-theft tools that can easily be utilized to protect family pets, including collar-friendly tracking devices and door cameras that can alert owners to the presence of strangers in the vicinity of



family pets, and video options that can provide clues to the identity of those involved in theft.


Strategic placement of cameras and even careful consideration when putting a tracking device in the collars of pets — could help in avoiding detection of the tracker until the pet's rightful owner can determine their whereabouts.

Securing the areas pets utilize by eliminating 'blind spots' on the property and securing gates from the inside can help to protect them from theft, and pet doors can provide them a means of escape if a perpetrator should enter the yard.

Remember: Microchips cannot assist you in the actual tracking of your missing pet.

They can enhance the likelihood of recovery when they are scanned at a shelter or veterinarian's office but they will not afford you the luxury of discovering their whereabouts if they're lost or stolen.

Still, microchips are useful, particularly when pets are at a greater risk of becoming lost or stolen. Wanderers then, like Huskies and German Shepherds, can easily benefit from being microchipped.

Valuable thoroughbred dogs can easily be worth thousands and they too, are at higher risk for being lost or stolen simply because of their inherent value to thieves.

AZ Governor Signs Probate Reform Laws Inspired by Disney Family Court Battles

In a Year of Vetoes – Arizona Legislature and Governor Agree on Need for Sweeping Court Reforms with Unanimous Votes in Both Chambers

Arizona Governor Katie Hobbs signed into law SB1291, drastically elevating the rights of citizens in guardianship and conservatorship in historic reform for an area of civil law that has long been noted for abuse. Governor Hobbs had previously signed SB1038, establishing a Probate Advisory Panel. Both bills passed out of the Legislature with unanimous support in both the House and Senate, which together bring long-needed reform and accountability to probate courts in Arizona.

The grassroots effort was led by Sherry Lund, who was motivated to act after her family endured over a decade of emotionally devastating and extremely costly litigation in two states to prove her stepson, the grandson of Walt Disney, was competent and not in need of a guardian or conservator.

Her experiences led her to found 5-14 Protecting Liberty, a grassroots organization dedicated to probate reform.

"The amount of money that was demanded to be paid by our family through the legal action to protect

our son's rightful inheritance was nothing short of extortion. Across our nation the courts, attorneys, and fiduciaries have developed a pattern and practice of abuse that protects their sources of financial gain, pulling it from private citizens and into their pockets. After what happened to our family, I could not sit by and watch as other Americans are abused by the system that was designed to protect them," said Mrs. Lund.



Both bills were sponsored by Senator John Kavanagh R-Fountain Hills, who stated in public testimony that probate reform is "a very important issue" and spent hours in stakeholder meetings to develop the bill language that would ensure the rights of individuals are not lost unnecessarily in Arizona courts.

Rep. Alex Kolodin R-Scotts-

dale, who sponsored the striker amendment that added stronger protections for Arizona citizens, called SB1291 "a phenomenal bill" and was instrumental in seeing it passed. By Arizona law, the bills will become effective 90days after Sine Die of the Arizona Legislature. Mrs. Lund in expressing her gratitude said, "Immense thanks are due to Sen. John Kavanagh for his efforts at getting both of these bills through the legislature,

to Rep. Alex Kolodin for his strong legal language and commitment to the Constitution, and to Governor Katie Hobbs who recognized the need for reform and signed SB291 and SB1038 into law."

Asked about her next plans, Mrs. Lund replied, "I'm not stopping. There is much more to do in Arizona to protect children and families. Nationally, I won't stop until every state is upholding the Constitution in probate matters. Our case led me to meet so many other families, from around the country, with horror stories that cannot be ignored. I have the ability to affect positive change and am determined to do so."

Bouse Real Estate Mystery

There is a story unfolding in Bouse, Arizona that caught my attention recently, but little did I know how interesting and complicated this tale was. On June 16, 2023, a story ran in the Parker Pioneer that caught my interest and the more I investigated the more intriguing the story became! The article I read said that it involves ongoing disputes between neighbors along Thomas Road in Bouse, but as I dug into the story it became clear to me that it involved much more than that. From what I have discovered already, it involves not only the La Paz Board of Supervisors, the La Paz County Attorney's Office, the Community Development Department and the County Administrator's Office, but also a whole cast of other characters, and a few who have died under questionable circumstances.

This story began some 20 years or so ago, and if there is one thing we learned from the Richard Nixon Watergate Scandal, sometimes the coverup is more devastating than the incident itself. I am not saying this is on the same level of something that would cause a President of the United States to be removed from office, but in a county the size of La Paz, this seems to be a pretty big deal. La Paz County residents' homes, property and maybe even their lives are at stake.

The current events revolve around Bouse resident and property owner Laurie Nash, her neighbors, County District 2 Supervisor Duce Minor, Chief Civil Deputy County Attorney Jason Mitchell, Community Development Department Director Mike Ramos, the U.S. Army Corps of Engineers and other La Paz County employees.

The basic facts in this case show

that the washes in this area of Bouse have been illegally altered, perhaps for years. These illegal alterations to the natural paths of these washes are now causing damage to Bouse residences' property and the county seems to be trying to wash their hands of any responsibility in the matter, even though county employees have been involved since the beginning.

that have been installed in the area without permits and the county may have been aware of this for some time. Now as the washes begin to reclaim their natural paths at least one of these non-permitted septic systems has been flooded during heavy rains. Mitchell, the Chief Civil Deputy County Attorney, is quoted in the Pioneer article as saying; he wasn't sure what Nash's specific grievances were, but just from reading the article

Mitchell is quoted in, it is pretty clear to me what Nash's grievances are: the county has not been doing its job and now those in the position of power are playing a game of CYA by issuing violations to residents that were

duped into believing improvements on their properties were legal and approved.

Community Development Department Director, Mike Ramos was accused by Nash of citing her while not citing anyone else, and she accused the department that he directed and caused her to lose

a civil case against one of her neighbors, because Ramos not only includdone was legal, but they both appear ed a picture that was not of her propdivided parcels and then gifted them erty but also failed to fulfill her Public Records Request in a timely fashion as is required by

law.

According to the June 16, 2023, Pioneer article, Duce Minor says he is sympathetic to Nash's situation but for some reason he too "...isn't sure of what it is she wants. He said they can't go back and undo all the subdivisions and development on the land, even if they were originally done illegally." I am not sure, but I have a feeling the U.S. Army Corps of Engineers may have a differing opinion on the subject how to resolve this situation. One thing seems clear to me; the vulnerable residents of Bouse should not be violated and caused to bear the burden of this situation.

Minor is also quoted in the same article as saying; "I want to help her, I want to help everyone." I cannot help but think of a quote I read one time when I was researching the Watergate Scandal: "Never say no when a client asks for something, even if it is the moon. You can always try, and anyhow there is plenty of time afterwards to explain that it was not possible." - Richard M. Nixon

I am just beginning to appreciate the depth and complexity of this story. The Patriots Free Press plans to continue this investigation until we get to the bottom of what is going on and who is ultimately responsible. Get the US Out of The United Nations

Surrendering Sovereignty for "Peace"

Following the horrific devastation of World War II, Americans were open to new ideas in the hope that it would prevent another world war and bring world peace. Foisted on them by the Deep State was the idea for the United Nations. The United States enlisted as a founding member of the United Nations when the U.S. Senate approved the UN Charter on July 28, 1945. After only six days of formal deliberation, the Senate voted 89 to 2 in favor of joining the world body. The two patriots who voted against ratifying the Charter and UN membership were Senators Henrik Shipstead (R-Minn.) and William Langer (R-N.D.).

Charter for World Government

The UN Charter contains a Preamble and 111 Articles in its 19 Chapters. Although being approximately the same size as the U.S. Constitution, the two founding documents could hardly be any more different. Whereas the U.S. Constitution creates a government with strictly limited and defined powers, the UN Charter establishes the framework for expansive global governance towards one world government.

Article 1 of the UN Charter states that its purpose is: "To maintain international peace and security." The word "peace" appears a total of six times in Article 1. As a

A Department of Commerce (DOC) press release stated the \$42.45 billion funding is part of the "Broadband Equity, Access, and Deployment (BEAD) program from President Biden's Bipartisan Infrastructure Law to administer grant programs within their borders."

"What this announcement means for people across the country is that if you don't have access to quality, affordable high-speed Internet service now — you will, thanks to President Biden and his commitment to investing in America," said Secretary of Commerce Gina Raimondo. "Whether it's connecting people to the digital economy, manufacturing fiber-optic cable in America, or creating good paying jobs building

Internet infrastructure in the states, the investments we're announcing will increase our competitiveness and spur economic growth across the country for years to come."

The White House fact sheet shared these highlights:

* Awards range from \$27 million to over \$3.3 Billion, with every state receiving a minimum of \$107 million. * 19 states received allocations over \$1 billion with the top 10 allocations in Alabama, California, Georgia, Louisiana, Michigan, Missouri, North Carolina, Texas, Virginia and Washington.

With these allocations and other Biden administration investments, all 50 states, DC, and the territories now have the resources to connect every resident and small business to reliable, affordable high-speed internet by 2030.

The States, D.C., and territories (Eligible Entities) will need to apply for the grant funding through the DOC describing how they propose to run their grant programs. Once approved, the eligible entities can begin awarding grants to telecommunications companies and broadband providers to build infrastructure to provide high-speed internet.

The concept of providing high-speed internet access to all, regardless of where one lives sounds great, but in reality, will be a difficult task to

costs, as well as the few subscribers

Avoiding the obvious expense and ongoing infrastructure requirements to achieve his goal of high-speed internet access for all Americans by 2030, Biden chose to use the announcement opportunity as another 2024 reelection campaign speech. Biden declared: "For decades" — for decades — and the middle class was hollowed out. Too many good-paying manufacturing jobs moved overseas. Public investment was slashed. Core sources of our economic strength, like infrastructure, manufacturing, and innovation, were also hollowed out.

The president then rambled on about the failure of "trickle-down economics" while attacking the wealthy and big corporations, before he shared his memorized campaign talking points and his vision of building "the economy from the middle out and the bottom up instead of the top down; to grow the economy by educating and empowering workers, by promoting competition to support small businesses, and investing in ourselves again for the first time in a long time."

To add to Biden's broadband announcement, according to The Epoch Times, a memo was released at the same time, in which "senior

The White House staff memo focused on Biden's supposed successes of his first two years in office, with the administration's policies leading the way, while sharing that Bidenomics is working.

"The President's economic strategy has powered the strongest recovery of any major economy in the world. Among leading economies, the United States has had the highest economic growth since the pandemic and currently has the lowest level of inflation. This progress wasn't inevitable or an accident — it has been a direct result of Bidenomics," the memo stated, before announcing that Biden will "deliver a major speech in Chicago" on Wednesday "to highlight how his strategy of growing the economy by growing the middle class is delivering for the American people."

The timing of Biden's broadband investment announcement and the memo reveals that this was more about the president's 2024 reelection campaign than whether all Americans will actually have high-speed internet access by 2030. Only time will tell.

What is Dirty Electricity?


Dirty electricity exists everywhere. Some levels of dirty electricity are found in almost every building whether it be in homes, businesses, schools, or in public places. Wherever electronics like computers, phone battery chargers, Wi-Fi, TVs, game consoles, smart electric meters, compact fluorescent lighting, or solar panel inverters operate the electrical circuits are radiating dirty electricity. Dirty electricity can be present on electrified wires anywhere and probably has been on them since the beginning of widespread telegraph electrification in 1844.

Dirty electricity is the least understood and hardest to mitigate of the four types of Electro Magnetic Fields (EMFs), compared to the other types of EMFs that are

prevalent in our environment, which are: Alternating Current (AC) Magnetic Fields (MF) from motors in refrigerators and air conditioning, Alternating Current

(AC) Electric Fields (EF) from electronic devices like computers, and Radio Frequencies (RF) from wireless devices like cell phones and wi-fi.

The term "Dirty Electricity" was coined by the electrical utility industry to describe Electro-Magnetic Frequency (EMF) or Electromagnetic Interference (EMI). Dirty Electricity is caused by plugging in electronics and all electrical appliances. It is created in the process of converting Alternating Current (AC) electricity into Direct Current (DC) for the equipment to operate. By converting AC to DC electricity and stepping down the voltage from 120 volts AC to 12 Volts DC, a measurable side-effect is wasted electrical energy created in the





ty-cycle sine wave of alternating current (AC) power as high frequency voltage transients. The surge of electrical energy radiates into living environments in the form of voltage transients and spikes. Clean Power VS Dirty Power Clean power is electricity coming through an electric

outlet with little to no electrical noise. "Electrical noise" does not necessarily mean audible noise, though it can be present in some circumstances. It refers to electromagnetic frequencies lying outside the desired range expected from any power source. Although it can be heard with proper testing equipment as discussed later.

Dirty power has electromagnetic noise that causes interference with your household power wiring. Such noises originate from external sources like power lines or originate from inside your property.

Both Wind Turbines and Solar energy create dirty electricity on the power grid.



This electronic modulation creates dirty electricity that is put on the power grid to your home and business.

(DC) and must be changed to alternating current (AC) to be put on the power grid. An Inverter is an electronic device that creates an alternating voltage by chopping up the DC to simulate an alternating

waveform and generates a lot of dirty energy in the process. For solar on your home or business, the voltage is changed from 12- or 24-volts




DC to 120 Volts AC. For large scale commercial solar arrays the voltage is converted to thousands of volts and then transformed to 345,000 volts to place on the high-tension power lines. Solar arrays create huge amounts of dirty electricity on the power grid as a result.

Is Dirty Electricity Harmful?

Dr. Sam Milham, who authored one of the most powerful studies on dirty electricity and cancer, has spent nearly thirty years researching the impact of electromagnetic fields (EMFs) on health. In his book, "Dirty Electricity: Electrification and the Diseases of Civilization", Dr. Milham provides the epidemiological link between

dirty electricity and cancer, heart disease, diabetes, Alzheimer's, suicide, and neurological disorders such as multiple sclerosis (MS) and ALS (Lou Gehrig's disease).

Decades of scientific evidence point to a connection between electrical energy and a wide variety of medical, emotional, and cognitive health problems. You can purchase the meters yourself or hire an EMF professional. Dr Mercola's book, "EMF*D - 5G Wi-Fi, & Cell Phones" has a chapter on resources which provides information on meters for measuring all four of the types of radiation that are hazardous to your health. The types of meters, functionality, and cost can be researched on the internet. There are many meters, and you will need more than one to measure the 4 types of fields. There is no one best meter.

I purchased a Trifield Model TF2 EMF meter which measures Magnetic, Electric and Radio Frequency (including cell phone) radiation



fields. I have taken readings on every electrical appliance in

the house from varying distances. The further away you are from the source the lower the field strength. If you double the distance from the source, say from two feet to four feet, the field strength decreases to one fourth the power. Moving sources further away will



I also purchased a Broadband EMF Meter and filters by GreenWave. https://greenwavefilters.com/product/EMF-meter/ This basic meter measures the amount of dirty electricity (a.k.a. electrical noise, line noise, EMF) present on the wiring in buildings. You can find out how much dirty electrical pollution is on your wiring at home, business etc. You can hear the difference GreenWave filters make in reducing it.

The EMF meter is compatible with 50/60-Hz electrical circuits with voltage anywhere between 100V and 240V. This meter will display, and you can hear the difference immediately without the filter and the reduction with the filter plugged in.

This can help you determine the best number of filters to install in each room and where to place the filters for optimal results.

EMF / EMI Remediation Four Basic Principles 1) Avoid unnecessary exposure to EMF's, especially inside your own home and from your personal devices (such as your cell phone), where you

have the most control.

2) Put as much physical distance as you can between you and the source of EMF's you can't avoid. 3) Decrease the amount of EMF exposure coming into your home from external sources by using EMF filters.

4) When all else fails, shield yourself with EMF protective blankets, clothing, and Faraday bags. These are all available online.

Dirty electricity is an inevitable oc-

currence that affects your home and business electricity. It is a nuisance that can quickly escalate into potential damage and costs. Unlike clean power, dirty power is characterized by electromagnetic irregularities that cause interference with your property's power and cause many health problems. Fortu-

nately, dirty power can be reduced with a little electrical knowledge and expertise.

"The explosive recent increase in Radio Frequency radiation and high frequency transient sources, especially in urban areas from cellphones and towers, terrestrial antennas, Wi-Fi and Wi-Max systems, broadband internet over phone lines, and personal electronic, equipment suggests that like the 20th century EMF epidemic, we already have a 21st century epidemic of morbidity and mortality underway, caused by high frequency electromagnetic

fields."

The question is how big a role does it play in the current US health crisis. The controversy persists. Fortunately, we now have tools to address the question pragmatically. Interventions like those described above can give us a glimpse into how electrical energy can play a part

in health. While these interventions may not conclusively eliminate the hazard, it can reduce it. We can begin to learn about the important effects of the electrical environment around us, and how it affects our state of health and wellness.

After all the reading I have done on EMFs' hazards and the articles I have written on their harmful effects on all life (see billlowstuter. substack.com), I now take EMF and EMI exposure very seriously.





The FBI caved to congressional pressure Wednesday night on the eve of a contempt vote, agreeing to let all members of the House Oversight Committee see an informant memo alleging Joe Biden was involved in a \$5 million bribery scheme as well as some related documents.

The committee's chairman, Rep. James Comer, R-Kentucky, announced the deal just hours before his panel was to vote to find FBI Director Christopher Wray in contempt. "After weeks of refusing to even admit the FD-1023 record exists, the FBI has caved and is now allowing all members of the Oversight and Accountability Committee to review this unclassified record that memorializes a confidential human source's conversations with



a foreign national who claimed to have bribed then Vice President Joe Biden," Comer said. "Americans have lost trust in the FBI's ability to enforce the law impartially and demand answers, transparency, and accountability," he said. "Allowing all Oversight Committee members to

review this record is an important step toward conducting oversight of the FBI and holding it accountable to the American people."

At issue is a document known as an FD-1023 containing allegations from a confidential informant in June 2020 traded US policy for money to his family. The committee now will also be able to see two earlier documents from the same informant related to the allegation.

Comer told Just the News the allegations involve the country of Ukraine and remain under investigation by the bureau, and have not been disproven as Democrats have suggested. "Let's be clear: the allegations contained within this record are not closed as the White House and Democrats would have the American people believe," he said. "Former Attorney General Barr confirmed this information was sent to the U.S. Attorney in Delaware for further investigation and the FBI has confirmed it is being used in an ongoing investigation. "We also know the confidential source who provided this information is highly credible and trusted, has worked with the FBI for over a decade, and has been paid six figures."



AT HARVARD, UNC

In a blockbuster ruling on Thursday, the U.S.Supreme Court ruled affirmative action, as exercised in the college admission processes at Harvard and the University of North Carolina (UNC), are unconstitutional violations of the Equal Protection Clause of the 14th Amendment.

Chief Justice John Roberts authored the majority opinion in this 6-3 decision against UNC and 6-2 decision against Harvard. Roberts was joined by Justices Thomas, Brett Kavanaugh, Samuel Alito, Neil Gorsuch and Amy Coney Barrett.

Justices Sonia Sotomayor, Elena Kagan and Ketanji Brown Jackson dissented in the UNC case. Justice Ketanji Brown Jackson recused herself from the Harvard case as she formerly served on Harvard's Board of Overseers, leaving Justices Sonia Sotomayor and Elena Kagan as the two remaining dissenters in that case.

The opinion consolidated two cases brought by Students for Fair Admission (SFFA)— Students for Fair Admissions v. Harvard College and Students for Fair Admissions v. University of North Carolina. As previously reported by the Daily Citizen, both cases were filed in

2014 and SCOTUS STRIKES DOWN have been AFFIRMATIVE ACTION POLICIES making their way through the court system. In both

cas-

es, SFFA sued over the schools' admissions processes. The question presented to the Supreme Court was whether colleges and universities could use race as a factor in admission and whether the admission processes at those schools were a violation of the Constitution.

The majority held, "Because Harvard's and UNC's admissions programs lack sufficiently focused and measurable objectives warranting the use of race, unavoidably employ race in a negative manner, involve racial stereotyping, and lack meaningful endpoints, those admissions programs cannot be reconciled with the guarantees of the Equal Protection Clause."

The opinion explains that, in the past, the Court permitted race-based admission processes only if they complied with strict scrutiny, never used race as a stereotype or a negative, and had an endpoint. Roberts

wrote that the admission processes at Harvard and UNC, "however well intentioned and implemented in good faith," failed the

criteria.

The Court clarified, "... nothing prohibits universities from considering an applicant's discussion of how race affected the applicant's life, so long as that discussion is concretely tied to a quality of character or unique ability that the particular applicant can contribute to the university." In other words, as Roberts explains, "the student must be treated based on his or her experiences as an individual-not on the basis of race." He also warned that this does not mean that universities can "establish through application essays or other means the regime we hold unlawful today."

The Court declared, "Many universities have for too long wrongly concluded that the touchstone of an individual's identity is not challenges bested, skills built, or lessons learned, but the color of their skin. This Nation's constitutional history does not tolerate that choice."

In Justice Sonia Sotomayor's dissent, she claimed the decision "rolls back decades of precedent and momentous progress."

Justice Clarence Thomas, the Court's second black justice, wrote in his concurring opinion, "... the Constitution continues to embody a simple truth: Two discriminatory wrongs cannot make a right. ... Today ... the Constitution prevails." He concluded, "I hold out enduring hope that this country will live up to its principles so clearly enunciated in the Declaration of Independence and the Constitution of the United States: that all men are created equal, are equal citizens, and must be treated equally before the law."

The Court's ruling will no doubt have widespread ripple effects across the nation as colleges and universities revamp their admission processes to comply with the Supreme Court's opinion. Moving forward, institutions of higher education will be required to consider each student applicant based on individual merit and the content of the applicant's character rather than skin color.

Racial discrimination is always wrong. We applaud the Supreme Court for a ruling founded on fairness and equal protection under the Constitution.

Why do we have so many secrets? Julian Assange told us why. From an essay he wrote: "Authoritarian regimes give rise to forces which oppose them by pushing against the individual and collective will to freedom, truth and self realization. Plans

which assist authoritarian rule, once discovered, induce resistance. Hence these plans are concealed by successful authoritarian powers."

When governments become authoritarian, they inspire resistance. Techniques must then be developed to repel that resistance. Those techniques must then be concealed. In short: the worse a country is, the more secrets it has. We have a lot of secrets now.

Julian Assange became famous as we were creating a vast new government-within-a-government, a system of secret prisons, extraordinary rendition, mass surveillance, and drone assassination. If they did this to Andrei Sakharov, or Nelson Mandela, every human rights organization in the world would be denouncing this as an intolerable outrage. Every NGO would be lining up to lend support. Every journalist would be penning editorials demanding his release. But because our own governments are doing it, we get silence.

If you're okay with this happening to one Julian Assange, you'd better be okay with it happening to many others. That's why this moment is so important. If Assange is successfully extradited and convicted, it will take about ten minutes for it to happen again. From there this will become a common occurrence. There will be no demonstrations in parks, no more news stories. This will become a normal part of our lives.

Don't let that happen. Free Julian Assange.





"Projections...show that debt held by the public would reach its historical high of 106 percent of GDP by 2029 and continue to grow at an increasing pace...to more than 219% of GDP – more than twice the size of the economy - by 2051." There is more evidence of trouble coming in the annual reports of Social Security and Medicare Boards of Trustees, they state concerning Medicare: "The Hospital Insurance (HI) Trust Fund will be able to pay 100 percent of total scheduled benefits until 2031... At that point, the fund's reserves will become depleted ... " Then concerning the bulk of Social Security, the report states; "The Old-Age and Survivors Insurance (OASI) Trust Fund will be able to pay 100 percent of the total scheduled benefits until 2033 ... " That is only 10 years until Medicare and Social Security will be totally depleted!

These reports came out of the Executive Branch on March 31, 2023, and were sent to all in leadership of Congress, and yet we are seeing the Executive Branch, the Biden administration, push spending in ways and magnitude we as a country have never seen before in history. Let's continue in the Book of Amos chapter 8.


6 That we may buy the poor for silver, and the needy for a pair of shoes; yea, and sell the refuse of the wheat?

When evidence began to emerge that petroleum based medicines were causing cancer, Mr. Rockefeller founded the American Cancer Society through which he suppressed that information.


John D. Rockefeller is duly credited as the founder of the pharmaceutical industry. And the reason that medical error is currently the third leading cause of death in America.



Continued from Front Page *U.S. Declaration of Independence* the most wholesome and necessary for the public good.

He has forbidden his Governors to pass Laws of immediate and pressing importance, unless suspended in their operation till his Assent should be obtained; and when so suspended, he has utterly neglected to attend to them.

He has refused to pass other Laws for the accommodation of large districts of people, unless those people would relinquish the right of Representation in the Legislature, a right inestimable to them and formidable to tyrants only. He has called together legislative bodies at places unusual, uncomfortable, and distant from the depository of their public Records, for the sole purpose of fatiguing them into compliance with his measures.

He has dissolved Representative Houses repeatedly, for opposing with manly firmness his invasions on the rights of the people.

He has refused for a long time, after such dissolutions, to cause others to be elected; whereby the Legislative powers, incapable of Annihilation, have returned to the People at large for their exercise; the State remaining in the mean time exposed to all the dangers of invasion from without, and convulsions within.

He has endeavored to prevent the population of these States; for that purpose obstructing the Laws for Naturalization of Foreigners; refusing to pass others to encourage their migrations hither, and raising the conditions of new Appropriations of Lands.

He has obstructed the Administration of Justice, by refusing his Assent to Laws for establishing Judiciary powers.

He has made Judges dependent on his Will alone, for the tenure of their offices, and the amount and payment of their salaries. He has erected a multitude of New Offices, and sent hither swarms of Officers to harass our people, and eat out their substance.

He has kept among us, in times of peace, Standing Armies without the Consent of our legislatures. He has affected to render the Military independent of and superior to the Civil power.

He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his Assent to their Acts of pretended Legislation:

For Quartering large bodies of armed troops among us:

For protecting them, by a mock Trial, from punishment for any Murders which they should commit on the Inhabitants of these States:

For cutting off our Trade with all parts of the world:

For imposing Taxes on us without our Consent:

For depriving us in many cases, of the benefits of Trial by Jury:

For transporting us beyond Seas to be tried for pretended offences For abolishing the free System of English Laws in a neighbouring Province, establishing therein an Arbitrary government, and enlarging its Boundaries so as to render it at once an example and fit instrument for introducing the same absolute rule into these Colonies: For taking away our Charters, abolishing our most valuable Laws, and altering fundamentally the Forms of our Governments:

For suspending our own Legislatures, and declaring themselves invested with power to legislate for us in all cases whatsoever.

He has abdicated Government here, by declaring us out of his Protection and waging War against us.

He has plundered our seas, ravaged our Coasts, burnt our towns, and destroyed the lives of our people. He is at this time transporting large Armies of foreign Mercenaries to compleat the works of death, desolation and tyranny, already begun with circumstances of Cruelty & perfidy scarcely paralleled in the most barbarous ages, and totally unworthy the Head of a civilized nation.

He has constrained our fellow Citizens taken Captive on the high Seas to bear Arms against their Country, to become the executioners of their friends and Brethren, or to fall themselves by their Hands. He has excited domestic insurrections amongst us, and has endeavoured to bring on the inhabitants of our frontiers, the merciless Indian Savages, whose known rule of warfare, is an undistinguished destruction of all ages, sexes and conditions.

In every stage of these Oppressions We have Petitioned for Redress in the most humble terms: Our repeated Petitions have been answered only by repeated injury. A Prince whose character is thus marked by every act which may define a Tyrant, is unfit to be the ruler of a free people.

Nor have We been wanting in attentions to our British brethren. We have warned them from time to time of attempts by their legislature to extend an unwarrantable jurisdiction over us. We have reminded them of the circumstances of our emigration and settlement here. We have appealed to their native justice and magnanimity, and we have conjured them by the ties of our common kindred to disavow these usurpations, which would inevitably interrupt our connections and correspondence. They too have been deaf to the voice of justice and of consanguinity. We must, therefore, acquiesce in the necessity, which denounces our Separation, and hold them, as we hold the rest of mankind, Enemies in War, in Peace Friends.

Continued from Page 22 U.S. Declaration of Independence We, therefore, the Representatives of the United States of America, in General Congress, Assembled, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by Authority of the good People of these Colonies, solemnly publish and declare, That these United Colonies are, and of Right ought to be Free and Independent States; that they are Absolved from all Allegiance to the British Crown, and that all political connection between them and the State of Great Britain, is and ought to be totally dissolved; and that as Free and Independent States, they have full Power to levy War, conclude Peace, contract Alliances, establish Commerce, and to do all other Acts and Things which Independent States may of right do. And for the support of this Declaration, with a firm reliance on the protection of divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor.
