Climate Scientist: Public Being "Misinformed on a Massive Scale"

The narrative that the Earth is currently experiencing its warmest temperatures in over 100,000 years has some problems, according to some top climate scientists. Cliff Mass, a meteorologist who specializes in weather prediction and modeling at the University of Washington claimed in an interview that the public is being **"misinformed on a massive scale."**

All through July we've been deluged with pronouncements of "hottest ever" days, weeks, and months. Earlier this month, UN Secretary-General António Guterres proclaimed that "the era of global warming has ended; the era of global boiling has arrived."

Is the planet essentially "boiling," or is the secretary-general engaging in some hyperbole for effect?

The latter is true if you ask Mass, who believes the exaggerations of this summer's heat aren't good for anyone. "It's terrible. I think it's a disaster. There's a stunning amount of exaggeration and hype of extreme weather and heatwaves, and it's very counter-productive," Mass said. "I'm not a contrarian. I'm pretty mainstream in a very large [academic] department, and I think most of these claims are unfounded and problematic," he stressed.

According to Mass, the climate has been "radically warmer," particularly about a millennium ago when the Medieval Warm Period



occurred. For a time from 900 A.D. to 1300 A.D., Europe recorded that growing seasons were extended, grapes grew in Northern England and Greenland — now essentially an ice island — was colonized.

"If you really go back far enough there were swamps near the North Pole, and the other thing to keep in mind is that we're coming out of a cold period, a Little Ice Age from roughly 1600 to 1850," Mass said. "Global warming, it's a serious issue, but it's a slow issue, it's not an existential threat," he concluded.

Certainly, the summer of 2023 has been a warm one in certain areas of the world — but is it record-breaking? Is it the warmest summer in 120,000 years, as many climate hysterics claim?

Well, since global temperature records — if they can even be reliably calculated — only go back as far as 1979, it's an impossible question to truly answer. But many weather observers appear to

be saying, "it's probably not the warmest."

"I haven't seen anything yet this summer that's an all-time record for these long-term stations, 1936 still holds by far the record for the most number of stations with the hottest-ever temperatures," said John Christy of the University of Alabama at Huntsville. In Christy's mind, the extremely high temperatures of this summer may be due to mankind's intervention, but probably not because of greenhouse gas emissions. They are more likely due to the Urban Heat Island (UHI) effect.

"In Houston, for example, in the center it is now between 6 and 9 degrees Fahrenheit warmer than the surrounding countryside," Christy pointed out. In fact, not even the vaunted IPCC is completely assured that this summer's temperatures are all-time highs.

"Neither the UN, IPCC nor the US

VFW Kicks-Off Annual Competitions

Quartzsite, Arizona. (August 1, 2023) – Commander Edward Reid of the Veterans of Foreign Wars of the U.S. Post 769, announced the kick-off of two of the VFW's Annual Competitions.

The *Patriot's Pen* youth essay competition is for middle school students in grades 6-8 in this area to have the opportunity to compete and win thousands of dollars in national awards.

The VFW enacted the Patriot's Pen competition in 1995 to encourage young minds to examine America's history, along with their own experiences in modern American society by composing a 300- to 400-word patriotic-themed essay. The theme for the 2023-24 competition is "How Are You Inspired by America?"

Students begin by competing at the local Post level. Post winners advance to District competition with District winners advancing to the state competition. State first-place winners compete for their share of thousands of dollars in awards, and

the national first-place winner is awarded \$5,000 and an all-expense-paid trip to Washington, D.C. Each year, more than 125,000 students participate nationwide. Deadline for student entries is October 31. For details visit: www.vfw.org/PatriotsPen.

The Voice of Democracy Scholarship Competition gives local high school students the opportunity to compete for thousands of dollars in scholarships and a trip to Washington, D.C.

Students must write and record a three-to-five-minute essay on the selected theme using an audio CD or flash drive and present their recording, typed essay and completed entry form to their local VFW Post by October 31. The 2023/2024 theme selected is "What Are the Greatest Attributes of Our Democracy?" Students begin by competing at the local Post level, then Post winners compete at the District level with the winner advancing to the state competition.



All state first-place winners receive a four-day trip to Washington, D.C., and the chance to compete for their share of more than \$150,000 in scholarships. The first-place winner receives a \$30,000 college scholarship.

The National Association of Broadcasters (NAB) started the Voice of Democracy Scholarship program in 1947. The VFW became a national sponsor in the late 1950s and assumed sole responsibility for the program in 1961. The competition was created to provide students grades 9-12 the opportunity to express themselves in regard to democratic ideas and principles.

Around 40,000 students participate in the competition each year and the VFW awards more than \$2.1 million in educational scholarships every year. For details: www.vfw.org/vod.

The North Atlantic Treaty Organization (NATO) is a UN-subservient alliance that threatens U.S. national sovereignty. It is imperative that Congress follow the advice of the Founding Fathers and withdraw the U.S. from this entangling alliance.

The Senate also voted 65-28 to add a similar proposal to the fiscal 2024 NDAA. Meanwhile, Joe Biden is pledging that the United States will remain involved in NATO. Neocons and other globalists want to keep our constitutional Republic forever entangled in harmful, anti-sovereignty treaties and international organizations. Please contact your U.S. representatives and senators and urge them to put American sovereignty first and withdraw our country from NATO.

NATO is a UN-subservient alliance that threatens U.S. national sovereignty. It is imperative that Congress follow the advice of the Founding Fathers and withdraw the U.S. from NATO and every other entangling alliance.

American leadership favors foreign



intervention and fealty to NATO and other international organizations. In March 2022, U.S. President Joe Biden stated, "We take Article 5 as a sacred commitment, not a throwaway, a sacred commitment that relates to every member of NATO." And later in his gaffe-filled speech, he stated, "We have a sacred obligation under Article 5 to defend each and every inch of NATO territory." Biden also made several concerning statements, calling for regime change in Russia and suggesting that the U.S. would send, or had already sent, troops into Ukraine. In other words, Biden pledged U.S. fealty to NATO at the expense of the U.S. Constitution and national sovereignty.

At the heart of the conflict are the Deep State and Biden administration's desire to further expand NATO eastward, eventually extending membership to Ukraine (a country that borders Russia and was previously a Soviet socialist republic that comprised part of the U.S.S.R. from 1919 to 1991.) Because of the invasion, Finland joined NATO, and Sweden is in the process of joining.

However, rather than expanding NATO, the United States should withdraw from it. The United States currently contributes about 22 percent of the NATO budget — the largest share of any NATO country, meaning that U.S. taxpayers foot a large chunk

of the bill for Europe's defense.

NATO's Threat to US National Sovereignty

NATO was originally founded in 1949 as a collective-security alliance between the United States, Canada, Denmark, Iceland, the United Kingdom, Norway, the Netherlands, Luxembourg, Belgium, France, Portugal, and Italy. It was established on the basis of countering the Soviet Union and its captive communist satellite nations. The NATO military alliance is cemented in Article 5 of the founding North Atlantic Treaty, which states in part: "The Parties agree that an armed attack against one or more of them in Europe or North America shall be considered an attack against them all and consequently they agree that, if such an armed attack occurs, each of them, in exercise of the right of individual or collective self-defense recognised by Article 51 of the Charter of the United Nations, will assist the Party or Parties so attacked by taking forthwith, individually and in concert with the other Parties, such action as it deems necessary, including the use of armed force, to restore and maintain the security of the North Atlantic area."

Ultimately, however, NATO is a regional arrangement under the

auspices of the United Nations. Article 52, Section 1, of Chapter VIII of the UN Charter states: "Nothing in the present Charter precludes the existence of regional arrangements or agencies for dealing with such matters relating to the maintenance of international peace and security as are appropriate for regional action provided that such arrangements or agencies and their activities are consistent with the Purposes and Principles of the United Nations."

In other words, under the charter, the UN allows its member nations to form regional arrangements so long as they are consistent with the "Purposes and Principles of the United Nations." Furthermore, Article 53, Section 1, of Chapter VIII of the UN Charter states, "The Security Council shall, where appropriate, utilize such regional arrangements or agencies for enforcement action under its authority."

The UN Security Council, which includes non-NATO countries like Communist China and Russia which NATO is ostensibly designed to defend Western Europe from and is currently at odds with over Ukraine — can use regional arrangements such as NATO to enforce UN Security Council resolutions. If that wasn't enough, Article 54 of Chapter VIII of the UN Charter further mandates that: "The Security Council shall at all times be kept fully informed of activities undertaken or in contemplation under regional arrangements or by regional agencies for the maintenance of international peace and security." In other words, both Russia and Communist China are kept aware of NATO's activities.

NATO is nothing more than an armed extension of the globalist United Nations. Article 1 of the North Atlantic Treaty reaffirms NATO's subservi-

ence to the UN, stating: "The Parties undertake, as set forth in the Charter of the United Nations, to settle any international dispute in which they may be involved by peaceful means in such a manner that international peace and security and justice are not endangered, and to refrain in their international relations from the threat or use of force in any manner inconsistent with the purposes of the United Nations."

Ultimately, NATO serves the purposes of the United Nations. A UN Security Council resolution can authorize the use of force and use NATO as its instrument of enforcement, thereby calling American troops and forces to combat anywhere around the world without a congressional declaration of war or the consent of the American people through their elected representatives in Congress.

Likewise, Article 5 of the North Atlantic Treaty affirms "that an armed attack against one or more of them in Europe or North America shall be considered an attack against them all..." This means that if, say, Montenegro or any other NATO member is attacked, it is to be regarded in the same manner as an attack against the United States.

As a result, the U.S. Armed Forces can likewise be called to action in the defense of that country. This clause also has the capability of dragging the United States into a war — possibly even a world war — as some are currently predicting regarding the

U.S.-Russia stalemate over Ukraine. NATO increases the likelihood of entangling the U.S. into a regional or world war, without even a congressional declaration of war.

Another infringement on U.S. sovereignty by NATO is its Status of Forces Agreement. U.S. servicemen and their families stationed in NATO countries are not under U.S. jurisdiction. Rather, they are subject to the courts and laws of the foreign country hosting them. *The Status of Forces Agreement* of the NATO Pact places members of the U.S. Armed Forces and their civilian components under the jurisdiction of those foreign courts and laws.

Through NATO, the American taxpayer foots the bill for Europe's defense, even risking the possibility of being dragged into war. Meanwhile, it places those American servicemen and their families in Europe under their foreign courts and laws. As for NATO itself, it is ostensibly designed to protect Europe from one of the very countries that is informed about all of its activities and that can determine whether it is used for enforcement action through the United Nations Security Council.

This is virtually analogous to stating that the main purpose of a city's local police department is to protect its residents from a city councilman's seat!

NATO does not serve the American people or U.S. national security. Instead, it serves the United Nations to carry out its goals of bringing about a collectivist New World Order.

The Once Elusive Vaccine Safety Debate Goes Mainstream

Those who have been patiently waiting for a true debate surrounding vaccine safety science to occur have been out of luck. To the surprise of few, the most recent episode saw Peter Hotez, again back down from an open offer, and nearly \$2.7M, to debate RFK, Jr. on the Joe Rogan Experience podcast. Nevertheless, the situation capitulated much-needed public attention to an important topic.

For those new to this story, members of government health agencies and medical bodies all the way down to established medical professionals have praised these extremely lucrative injectable pharmaceutical products free from liability for any harm they may cause. 'Safe and effective' was the talking point, any other discussion was 'debunked' they told you, a conspiracy theory.

The public has been given nothing but constant assurances that vaccines were safe despite little to no discussion of a laundry list of possible risks, and no true informed consent. Then came the reality that vaccines are not tested against inert placebos or subjected to the "gold standard" double-blind placebo study to establish safety prior to licensure during pre-licensure safety testing.

The inconvenient truths mounted. No studies have ever compared the total health outcomes of the CDC's vaccine schedule between vaccinated and unvaccinated groups. No system is in place or body of scientific investigation in the books to assess who may be more susceptible to adverse reactions to preempt injuries. Broken adverse event reporting systems and an adversarial vaccine court continued to tarnish the government assurances backing the vaccine medical products of multinational corporations. Greed, conflict of interest, regulatory agency revolving doors, and billions paid in criminal fines by Big Pharma from past product failures and frauds have been demanding for open debate to occur.

THE PUBLIC DEBATE SPACE
The story didn't start with Joe Rogan's podcast. Many were relieved



to learn a debate was set to occur in full public display just down the road from the CDC, in Atlanta in 2018. Doctors, researchers, journalists, professors, and vaccine developers were set to give the public the facts. Until the entire 'settled science' side of the vaccine debate withdrew. Most cited communications from their superiors and medical groups as their excuses for not confidently appearing to present their exhaustive 'settled science' the public keeps hearing so much about. **Among the Atlanta debaters with cold feet was Dr. Peter Hotez.**

A year later, Hartford's Legislative Office Building was the site of another hopeful vaccine debate put together by Connecticut Rep. Josh Elliot. The forum included three Yale doctors representing its Schools of Public Health, Epidemiology, and Medicine respectively, and for good measure, a 35-year pediatrician and longtime member of the American Academy of Pediatrics. The group would face none other than Robert F. Kennedy Jr. Yet less than 10 hours before the forum was set to start, Rep. Elliot abruptly canceled the debate as the infallible Yale intelligentsia ran for the doors.

LEGAL AND GOVERNMENT DISCUSSION

Meanwhile, operating in the background was another powerful avenue delivering blunt-force legal truths about vaccine safety in a court of law under oath. Attorney for the Informed Consent Action Network, Aaron Siri Esq. was busy serving the public much needed,

informative wins against America's top public health luminaries.

First was longtime vaccine developer known as the 'Godfather of vaccines,' Dr. Stanley Plotkin who volunteered to be an expert witness in a child custody case where the parents were split on vaccinating their child. Siri expertly deconstructed Plotkin and the entire 'settled science' for two full days on the stand. It remains a historically significant time capsule in the safety science conversation.

Next up on the stand was world-leading vaccinologist, Dr. Kathryn Edwards, who couldn't cite any of the exhaustive evidence showing no link between vaccines and autism. Another high water mark showing the willful knowledge gap in the 'settled science' vaccine safety science many seem to be fine with.

Even the CDC conceded to having any deeper knowledge when it failed to produce scientific studies that back up its long-declared assertion that vaccines given to babies in the first six months of life do not cause autism.

Underpinning an aspect of ICAN's legal approach was a meeting (largely unknown to the public) of historical proportions in 2017. Robert F. Kennedy Jr., Del Bigtree, and Aaron Siri along with a small delegation of scientists and parents of vaccine-injured children appeared on the campus of the National Institute of Health (NIH), an agency within the United States Department of Health and Human Services (HHS), for a meeting regarding the "Safety Of Vaccines."

The meeting was arranged by the newly elected President, Donald Trump, who had expressed concerns about vaccine safety throughout his campaign. Sitting across the long conference room table from the Kennedy delegation were scientists that are considered the world's leading specialists on child health, mental health, and vaccines from across the NIH, including Francis Collins, Anthony Fauci, Lawrence Tabak, and many others. Reed Cordish, President Trump's appointed Assistant on Intergovernmental and Technology Initiatives, was tasked with moderating the discussion.

In the end, it was clear that the greatest minds in vaccine science were unprepared to answer the basic questions about vaccine safety the Kennedy delegation asked, even though most of the points and questions raised had been culled from HHS's own literature, studies, and websites. The only thing settled about the science represented at that meeting by top agency representatives around vaccine safety was that it was woefully incomplete.

Board of Supervisors:

- * David Plunket (NO GRADE) - No interaction with him.
- * Holly Irwin (A) - Kind and helpful.
- * Duce Minor (F) - Total disconnect with the public, condescending, says one thing and does another.

La Paz County Chief Deputy Civil Attorney:

- * Jason Mitchell (A+) - advises county employees to say and do nothing (so the County does not get sued.)

Other county employees:

- * Assessor Anna Comacho and her entire staff, Richard Garcia, Matthew Aguilar, and Ana Lamas of the Recorder's Office, and the entire staff of the Health Department received a grade of (A+) from Ms. Nash.

A main concern is that it has been rumored that the Army Corps of Engineers has opened an investigation into the illegal alteration of washes in La Paz County which could lead to some liability for future water damage done to private property. “Bidenomics”: More Spending, More Regulations, Higher Taxes

To hear Joe Biden tout the benefits of his so-called Bidenomics program, one would think things in the country are just ducky. Unfortunately for Biden and his plans to ride this program into the White House in 2024, the American people aren't stupid.

The plan, touted in Chicago yesterday, includes making public investments, empowering and educating American workers, and promoting competition. All of this takes money — which the government doesn't have. It only has what it takes by force from taxpayers, then redistributes it to parties and people that it favors, while punishing those it disfavors.

In a memo obtained by the New York Post, Biden advisors Anita Dunn and Mike Conilon touted the benefits of his program: “There is clear and compelling evidence that Bidenomics is both a winning economic strategy that is delivering results, and an approach that is strongly supported by the vast majority of the American people.” Really? Let's look.

* The latest poll from the Associated Press reveals that barely a third

of U.S. adults approve of Biden's economic performance, while seven out of 10 rate the economy as poor.

* A Fox News poll finds that only one in five Americans believe that “Bidenomics” is helping them.

* A Gallup poll finds that three-quarters of Americans think economic conditions are getting worse, not better.

* These Americans have seen their weekly average earnings, adjusted for inflation, drop from \$400 when

* And they remember that inflation was just one percent when he entered the Oval Office, as compared to the nine percent they suffered under just a few months ago.

They also refuse to buy into the concept that “trickle-down” economics doesn't work. That economic concept — often referred to as “supply-side” economics based on the Laffer Curve — posits that when tax rates are reduced, the economy grows,

creating more tax revenues along with a higher standard of living for everyone.

The latest numbers on just how well that theory works in the real world were reported by the Tax Foundation in January. In 2020 taxpayers reported more than \$12.5 trillion in adjusted gross income, an increase of \$650 million over the previous year.

That report also put the lie to Biden's claim that the “rich aren't paying their fair share.” According to the foundation, the top one percent of taxpayers paid an average rate of 26 percent of their income in federal income taxes, a rate “more than eight times higher than the 3.1 percent average rate paid by the bottom half of taxpayers.”

In addition, the Tax Foundation reported, while the top one percent's share of the national income rose from 20.1 percent in 2019 to 22.2 percent in 2020, their share of federal income taxes paid rose from 38.8 percent to 42.3 percent. Say that again: The top one percent of taxpayers paid almost 43 percent of the total income taxes paid in 2020. And Biden thinks they aren't carrying their share of

National Climate Assessment have high confidence in detection or attribution of trends in heat waves [in] the US[.] So either the IPCC is wrong or the media/activist scientists are wrong. "Pick one," said Roger Pielke of the University of Colorado Boulder.

ga-Hunga Ha'apai volcano spewed large amounts of a greenhouse gas — water vapor — into the Earth's atmosphere.

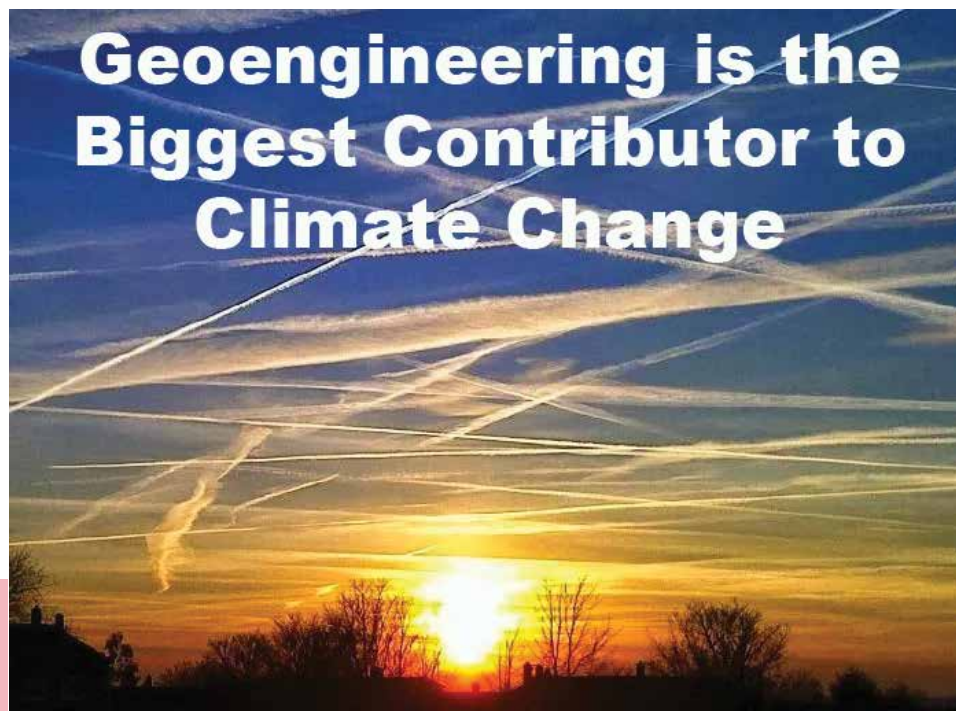
Many scientists are concluding that this year's higher-than-average temperatures have more to do with an excess of H2O in the atmosphere — not CO2.

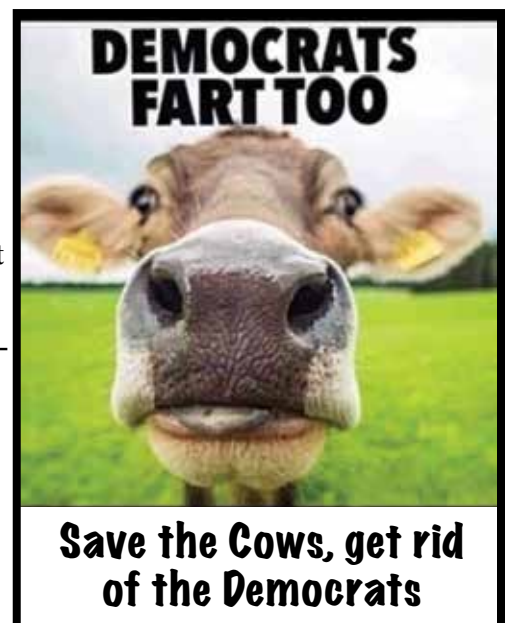

Why “We’ll All Feel the Sting” if Pollinators Disappear

I was reading about bumble bees recently, specifically, their looming demise, thanks to human greed and ignorance and started thinking about the tree of the knowledge of good and evil. Should we have eaten from it? Well, we did, but then apparently upchucked everything we learned and, in the process, fooled ourselves into thinking that technology has allowed us to recreate the Garden of Eden from which we’d been banned. You might call it the “Garden of Capitalism,” in which humans can take what they want without consequences, forever and ever and ever. This seems to be the myth at the core of the dominant global culture.

Of course, there are consequences which we officially refuse to let ourselves see.

For instance, Amy van Saun, an attorney for the nonprofit Center for Food Safety (writing about the shocking disappearance of bees and other pollinators of much of the food we eat) notes that one of the primary causes is the ever-increasing use of pesticides, in particular, something called neonic-

otinoids (or “neonics”), which wreak their own special hell on the planet’s ecosystems. Neonicotinoids “are the most widely used insecticides in the world,” she writes. “Unlike traditional pesticides, which are typically applied to plant surfaces, neonics are absorbed and transported through all parts of the plant tissue.” Modeled after nicotine, neonicotinoids interfere with insects’ nervous systems, causing tremors, paralysis and eventually, death.

Neonicotinoids are so toxic that one corn seed treated with them contains enough insecticide to kill over 80,000 honey bees. Like cluster bombs, land mines, Agent Orange and

depleted uranium, “they persist in the environment,” almost as though (forgive the analogy) commercial farming is like an ongoing war on nature.

If neonics are so dangerous,

what is the U.S. Environmental Protection Agency (EPA) doing about it? Not very much as it turns out, despite scientific evidence of their danger, which is why the Center for Food Safety, along with the Pesticide Action Network North America, are suing the agency.

As van Saun writes, “Almost half of all U.S. farmland is planted with pesticide-coated seeds,” but the agency

refuses to regulate them. The result, according to a United Nations report, is that cropland is approximately 50

times more toxic than it was a quarter of a century ago (at the beginning of the 21st century) and the world is currently experiencing an “insect apocalypse.”

Indeed, it begins to appear that the EPA has a mission that transcends “environmental protection.” It may well be that this agency (part of a governmental culture that supports and benefits from wealth and war) has a mission that is more about the official denial of the dangers of planetary exploitation. The EPA’s refusal to acknowledge the damage caused by neonics is just a small part of it.

“Critics accuse the EPA of being inappropriately cozy with the pesticide industry and biasing its decisions to favor companies selling pesticides,” the Guardian writes. “Several EPA scientists came forward last year, publicly alleging that EPA management routinely pressures EPA scientists to tamper

with risk assessments of chemicals in ways that downplayed the harm the chemicals could pose. “The scientists complained, among other things, that key managers move back and forth between industry jobs and positions at the EPA.”

This is when I started hearing an alarm go off in my head: Cultural malfunction alert! Cultural malfunction alert! This is what things look like when exploitation prevails: when grabbing all the goodies you can is at the cultural core, rather than something a bit more complex, such as understanding and revering the eco-reality (also known as nature) in which we live. Beyond that,



can we not create a culture that faces the paradoxes of life with a certain level of openness and continued interest in learning? Life is not something to be reduced to simplistic opposites: win vs. lose, good vs. evil. There is darkness within all of us, but we can’t let it determine our fate or shape our understanding of the world.

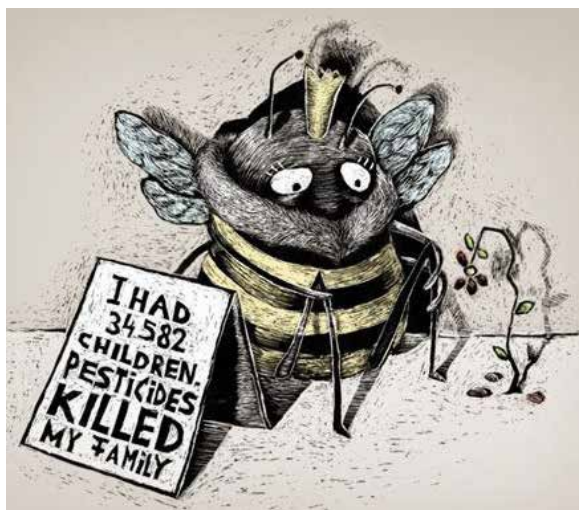
Yet I fear this is the nature of “modern,” as opposed to Indigenous, culture. Humanity, over the past few millennia, has moved its sense of reverence away from Mother Earth and essentially to Father Sky, rather than continuing to revere both. As a result, Mother Earth is ours to do with as we choose. The opposite viewpoint (apparently the indigenous viewpoint, which European land-grabbers called “savage”) isn’t quite so simple. The natural world, while rife with struggle,

can’t be reduced to “survival of the fittest.” Rather, it exists in a state of complex cooperation among all concerned including plants



and animals and evolves via the interdependence of all life. As Rupert Ross wrote in his remarkable book about “indigenous”, culture, “Returning to the Teachings”: “The Lakotah had no language for insulting other orders of existence: pest ... waste ... weed.”

Back to pesticides and weedkillers. Back to climate change and the apparent inability of the polluters who purport to be in charge of Planet Earth to address it adequately: Superficial change won’t do it. The change has to be cultural. It has to be spiritual. **Believe me, if we fail to change who we are and “the bees” the pollinators disappear, we’ll all feel the sting.**



Despite 12 Deaths During Clinical Trials, CDC Signs Off on RSV Shots for Newborns (Excerpts)

The Centers for Disease Control and Prevention (CDC) on Thursday recommended the first-ever monoclonal antibody marketed as a defense for all newborns against respiratory syncytial virus, or RSV. Beyfortus, also known as nirsevimab, is produced by pharmaceutical giants Sanofi and AstraZeneca. In a press release, the CDC referred to the drug as a “powerful tool” and a “new immunization.” According to the agency: “ACIP [Advisory Committee on Immunization Practices] voted to include nirsevimab in the Vaccines for Children program, which provides recommended vaccines and immunizations at no cost to about half of the nation’s children.

According to The Associated Press (AP), the drug will be offered as a “one-time shot for infants born just before or during the RSV season and for those less than 8 months old before the season starts,” and for some high-risk 8-19 month-old infants.

Beyfortus will be “broadly available for all infants regardless of whether they have a health condition,” CNBC reported. Some medical experts criticized the recommendation, pointing to infant deaths that occurred during the clinical trial for Beyfortus and questioning the need for their widespread administration to this age group.

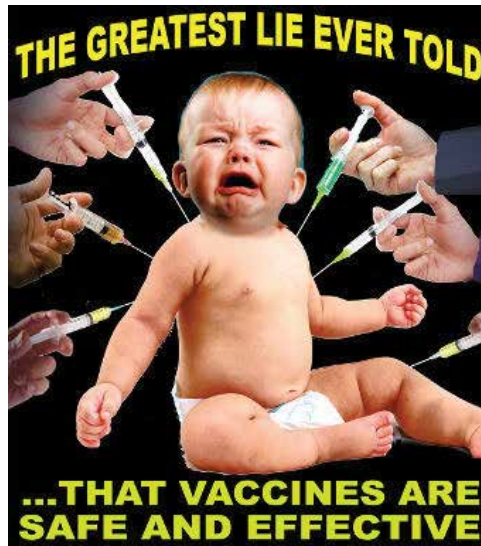
Cardiologist Dr. Peter McCullough told

The Defender: “While monoclonal antibodies are reasonably safe and effective, they are not clinically indicated nor medically necessary in all newborns.” “This new preventive strategy should be considered in rare cases with baseline lung disease such as severe asthma or cystic fibrosis. Injecting all newborns should be off the table and rejected by parents who want to avoid unnecessary drugs and potential harms.”

ACIP recommended adding Beyfortus to the childhood vaccine schedule, which would provide manufacturers a waiver of liability, but also recommended coding it as a drug for insurance purposes and leaving it out of the National Vaccine Injury Compensation Program (NVICP).

ACIP ignores ‘unrelated’ infant deaths during Beyfortus clinical trial. ACIP member and CDC epidemiologist Jefferson Jones, M.D., MPH, acknowledged that “a primary limitation” in the clinical trial was that “RSV testing may be more common for children with risk conditions inflating RSV-specific hospitalization rates.” “The (study) population did

in all — were reported during the clinical trial, which the U.S. Food and Drug Administration (FDA) claimed during a June review were “unrelated” to the antibody. CNBC reported in June that of the 12 infants, “four died from cardiac disease, two died from gastroenteritis, two died from unknown causes



but were likely cases [of] sudden infant death syndrome, one died from a tumor, one died from COVID, one died from a skull fracture, and one died of pneumonia.”

Nass also took issue with ACIP members downplaying the potential risks of Beyfortus and noted that Beyfortus’ product label does not specify most potential adverse events associated with the drug. “According to the label, the only risks specified are rashes and anaphylaxis. This is a very uninformative label, hardly worth the paper it is printed on,” Nass wrote. “The label does not provide any details about side effects,” Nass added. “The label does not inform us of the causes of deaths,” Nass said, referring to the 12 infant deaths which occurred during the clinical trial for Beyfortus. “This is extremely worrisome.”

The label also states, in part, that “Carcinogenesis, mutagenesis and reproductive toxicity studies have not been performed with Beyfortus” and that “No formal drug interaction studies have been performed” with the drug. There is also “limited experience with co-administration of Beyfortus with vaccines.”

CDC ‘playing fast and loose with the definition of vaccine’

Experts are also raising questions about the CDC’s treatment of Beyfortus as a vaccine in some instances and as a drug in other cases.

According to CNBC, “Beyfortus works like a vaccine, but the shot is considered a drug, not a vaccine,

because it is an antibody injection. Vaccines prepare the body’s immune system to release antibodies that fight viruses, while Beyfortus injects these antibodies directly into the bloodstream.”

Nass took issue with this juggling of classifications, writing on her Substack: “CDC is playing fast and loose with the definition of vaccine again, calling it a vaccine when convenient and a drug when that is more convenient. In order to get it onto the childhood vaccine schedule it becomes a vaccine — giving the manufacturer a waiver of liability. But it must be coded for reimbursement as a drug.

Is widespread administration of an RSV monoclonal antibody to infants needed? According to the AP, “In the U.S., about 58,000 children younger than 5 are hospitalized for RSV each year and several hundred die,” while according to CNBC, “RSV is the leading cause of hospitalization among infants in the U.S.” According to the CDC, nearly all children are infected with RSV before the age of 2. According to Nass, the risk of death from RSV is lower than the risk of injury or death by vaccines and other treatments being pushed for the illness.

In May, Nass wrote that the CDC published a paper on RSV deaths in infants between 2009 and 2021, which found “were only a total of 300 deaths in children less than one year over the 12 years, or 25 on average per year.”

Citing CDC figures, Nass wrote on her Substack yesterday that “4 million babies are born yearly in the U.S. 20,000 die in their first year. RSV kills 0.125% of them. It is way down the list of top causes of death.” She added: “RSV almost never causes chronic problems, except perhaps asthma. Or maybe children with an asthma tendency are also more susceptible to severe RSV.”

“RSV does hospitalize a lot of U.S. infants. It frightens parents and causes a lot of work for doctors. And so, this group of pediatricians on CDC’s advisory committee went gaga over this new product, which is supposed to be 70-80% effective at preventing severe

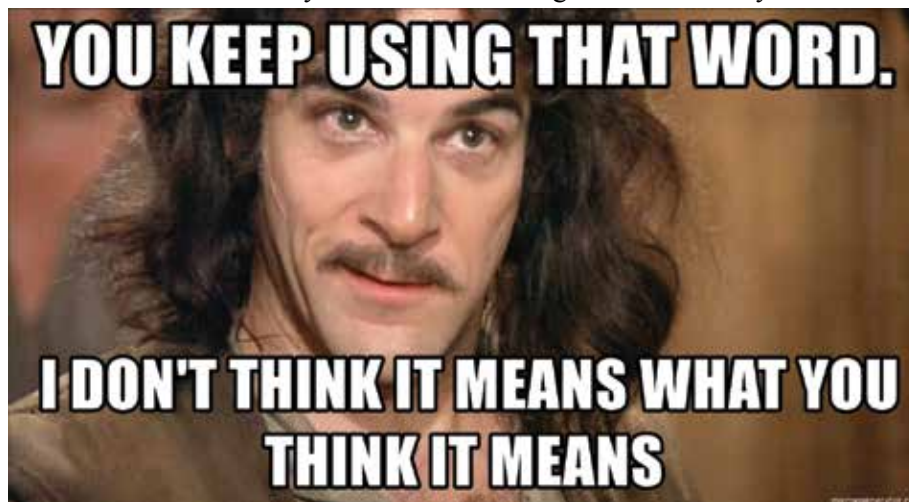

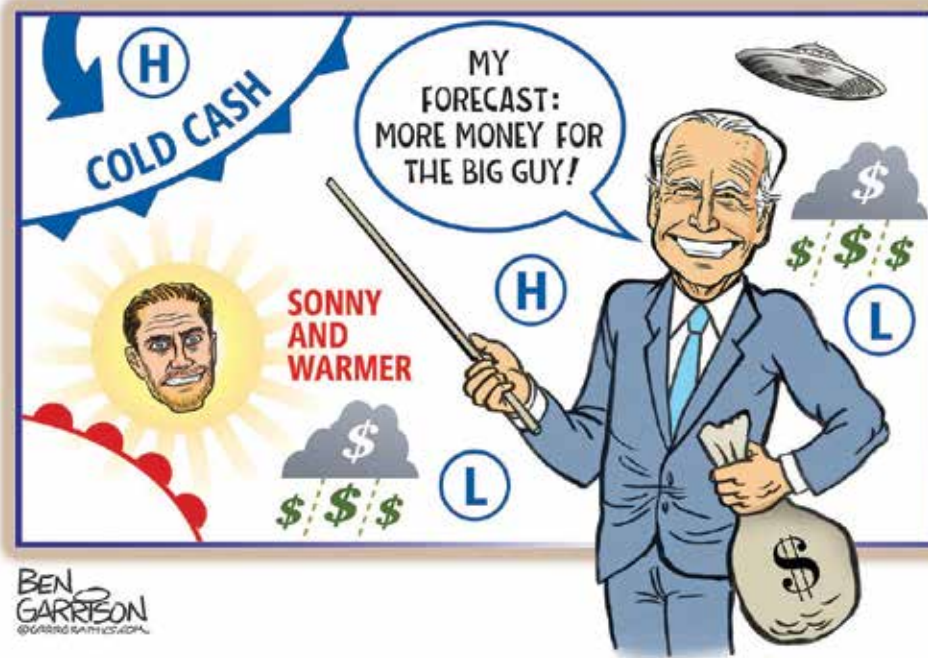

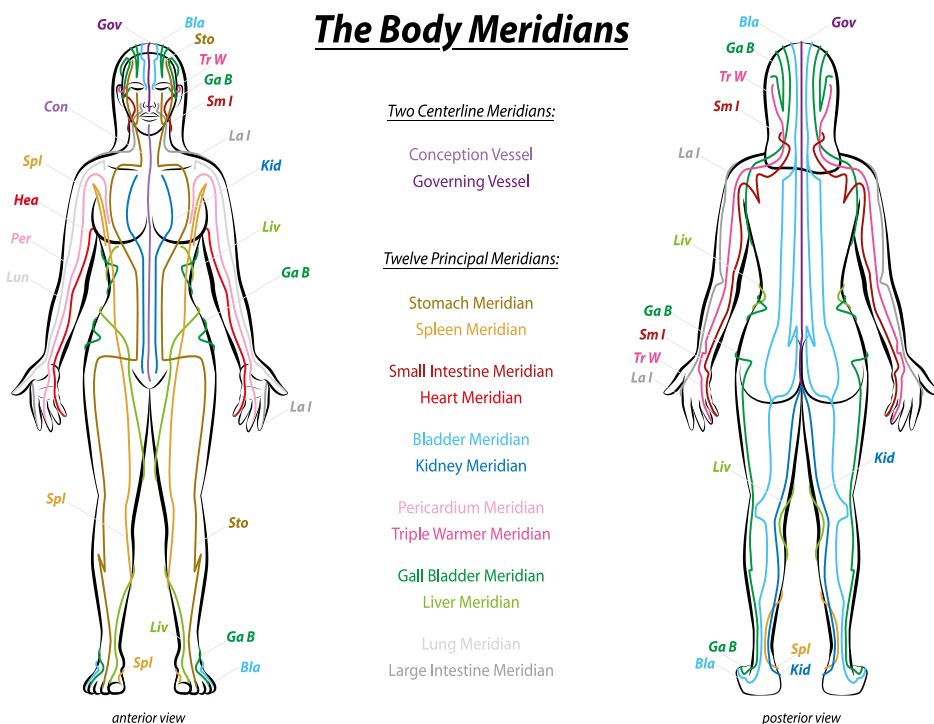
