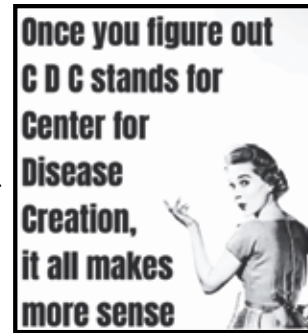
>70,000 people are stuck in the desert in Black Rock City at the Burning Man festival and there are rumors of a scary outbreak that FEMA had to arrive for?

#### CHANGING BEHAVIOR, SUCH AS:

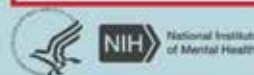


- >Making a plan or researching ways to die

## Defund & Abolish Unconstitutional Federal Law Enforcement

The federal government is increasingly meddling in and taking control over local law enforcement, threatening the autonomy of local police and leading to a federalized police force. Congress must defund and abolish every federal agency that threatens the independence of local police.

**URGENT:** Congress is currently working on the fiscal 2024 appropriations bills, which must be passed before September 30 to avoid a partial government shutdown much-feared by the globalist establishment. This is an excellent opportunity to defund the many unconstitutional federal law-enforcement agencies in existence. Contact your U.S. representative and senators, and urge them to protect local police and county sheriffs by defunding and abolishing every unconstitutional FEDERAL agency that illegally meddles in local law enforcement.

The federal government is increasingly meddling in and taking control over local law enforcement, threatening the autonomy of local police and leading

to a federalized national police force. Congress must defund and abolish every federal agency that threatens the independence of local police and county sheriffs.

One of the many ways America is exceptional is that it is the only country whose law enforcement is completely locally controlled. Every other country has at least some national control over law enforcement.

However, this important feature is under attack in the United States. Initiated and led by communists and Marxists, there is an active push to destroy locally controlled police and replace it with a nationalized police force. Unfortunately, many “conservatives” also have supported greater federal involvement and oversight in law enforcement.

Federal agencies are increasingly meddling in law-enforcement matters and usurping the role of local police and county sheriffs — even though this is unconstitutional under the 10th

Amendment. The primary agencies involved in this subversive effort include:

- **Department of Justice:** The DOJ has a major role in the federalization of local police. For example, it runs the Community Oriented Policing Services (COPS) program (see below), which has seen its funding more than triple between fiscal years 2015 and 2023 (more information below). Additionally, the DOJ runs an “Equitable Sharing” program and has forced many cities into consent decrees, both of which severely reduce the autonomy of local police departments. Furthermore, the DOJ is actively involved in persecuting political opponents of the Biden administration.
- **Federal Bureau of Investigation:** The FBI, an unconstitutional federal agency within the DOJ, is increasingly violating Americans’ rights and engaging in unconstitutional domestic law enforcement activities.



- **Dept. of Homeland Security:** The DHS is increasingly meddling in local-law-enforcement activities and taking control over local police departments. For example, DHS “fusion centers” (see below) are converting local police departments into subdivisions of the federal surveillance state (more details below), and it is engaging in other unconstitutional surveillance activities.

Additionally, as outlined in the article “Police: National or Local?,” published in the October 31, 2022 issue of The New American magazine, it expounds on these examples and lists several other examples of federal meddling in local law enforcement. The examples included:

- **COPS:** The Office of Community Oriented Policing Services (COPS) in the Department of Justice was established by Clinton Attorney General Janet Reno, with plans to implement a six-year, \$8.8 billion grant program that would enable state and local law-enforcement agencies to hire or

redeploy 100,000 additional police officers. Since 1994, COPS has invested more than \$14 billion to help advance federally directed “community policing.”

- **Buffer Zone Protection Program (BZPP):** Under the Department of Homeland Security (DHS), the BZPP is flooding local jurisdictions with Big Brother surveillance technology such as night-vision cameras, facial-recognition technology, license-plate readers, traffic light camera video feeds, etc.

- **FLETC: Federal Law Enforcement Training Centers (FLETC),** according to the FLETC website, “provide tuition-free and low cost training to state, local, campus, tribal and territorial law enforcement agencies. Programs are conducted across the United States and are normally hosted by a local law enforcement agency. Training is also conducted at FLETC facilities located in Glynco

(Brunswick), GA; Artesia, NM; Charleston, SC; and Cheltenham, MD.”

- **Fusion centers:** According to DHS, “Fusion centers conduct analysis and facilitate information sharing, assisting law enforcement and homeland security partners in preventing, protecting against, and responding to crime and terrorism.” By the end of 2012, the DHS had marked 1,849 locations scattered throughout the 50 states that would serve as regional surveillance collection centers. The DHS has spent many millions of dollars establishing these federal-local “collaborative” efforts. They have not exhibited a single terrorist caught during the program, though thwarting terrorism served as justification for the program.

- **1033 Program:** Section 1033 of the National Defense Authorization Act of 1997 gave the secretary of defense permanent authority to militarize local law enforcement by transferring war-fighting equipment: tanks, Humvees, MRAPs, Bearcats, Stingrays (for cellphone monitoring), full-auto

rifles, grenade launchers, and more to police, ostensibly to fight the “war on drugs” and “war on terrorism.” This juicy carrot comes with the stick of federal training and monitoring. The same “progressives” who supported this militarization of the police now denounce this militarization of the police.

Finally, basically every federal agency has its own law-enforcement branch, giving them the ability to enforce their unconstitutional edicts. Examples of such agencies include (but certainly aren’t limited to) the ATF, IRS, TSA, EPA, FDA, USPS, Education Department, and the Treasury Department.

Congress must defund and abolish the DOJ’s COPS program, as well as the FBI, DHS, and all other unconstitutional federal law enforcement. Under the U.S. Constitution, the federal government has no role in domestic law enforcement; such activities are

reserved to the states and, by extension, localities. This is for good reason — local police and county sheriffs are key to protecting citizens against tyranny, but in countries with federalized police, nothing is stopping the central government from violating people’s God-given rights.

National police are the hallmark of dictatorships and oppression around the world. The autonomy of our local police is paramount to the survival of our Republic. Accordingly, contact your U.S. representative and senators, and urge them to defend the U.S. Constitution — and support independent local police — by defunding and abolishing federal law-enforcement agencies and programs.

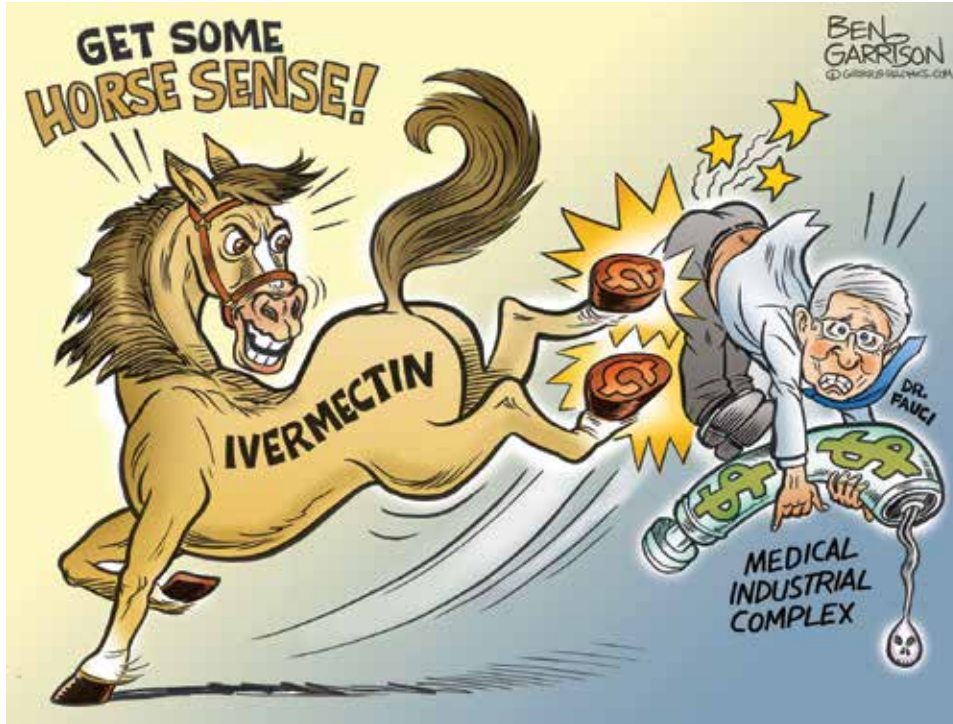


## Ivermectin Is a Proven Cure for Covid. Don't Let Anyone Tell You Different.

In September 2021, the corrupt American Medical Association told doctors to stop prescribing Ivermectin for COVID-19. In a statement, the AMA, along with the American Pharmacists Association (APhA) and American Society of Health-System Pharmacists (ASHP), warned: "We are alarmed by reports that outpatient prescribing for and dispensing of ivermectin have increased 24-fold since before the pandemic and increased exponentially over the past few months. As such, we are calling for an immediate end to the prescribing, dispensing, and use of Ivermectin for the prevention and treatment of COVID-19 outside of a clinical trial. In addition, we are urging physicians, pharmacists, and

other prescribers (trusted health care professionals in their communities) to warn patients against the use of Ivermectin outside of FDA-approved indications and guidance, whether intended for use in humans or animals, as well as purchasing ivermectin from online stores."

Dr. Joseph Mercola asks. "How many died unnecessarily as a result of these commands?" Mercola's question is a good one. Those who died from Covid died because of a lack of treatment. For an untested vaccine to be put into use under "emergency use authorization" there must be no cures. Therefore the medical establishment (which serves as a marketing agent for Big Pharma) had to deny that there were any cures and to prevent doctors from curing patients with Ivermectin and HCQ before the knowledge of the cure spread. ## Direct Energy Weapons on Maui?!

The inclusion of Hawaii on the list might seem like a mere coincidence, but the "coincidences" KEEP piling up! And not only is the research lab operating in the state of Hawaii, but its precise location is on the island of MAUI. "The AFRL Directed Energy Directorate operates two major telescope sites that are used to advance SSA technologies. One of these sites is located on Kirtland Air Force Base, New Mexico, and the other site is located on Maui, Hawaii. The Maui site is called the Air Force Maui Optical and Supercomputing (AMOS) site."

Satellite detection and iden-

tification, atmospheric compensation and resolved imaging, astrodynamics and orbital metrics, sensor development, laser propagation through the Earth's atmosphere(!), database cataloging of satellite images and high-performance computer modeling and simulation are all areas of focus at the AMOS site.

As I mentioned previously, DEWs not only include lasers, but also microwaves, particle beams, and sound beams. It will be more difficult to anticipate the undetectable types of directed energy, such as sound beams.

I'm not claiming that this particular facility was responsible, but I am pointing out that it has the capabilities to fire these lasers into the atmosphere and anywhere else as directed.

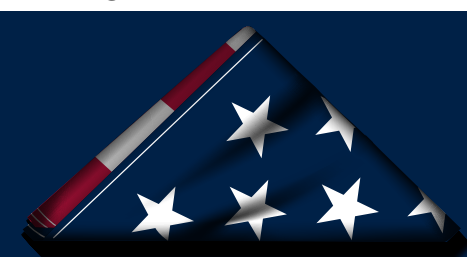

but I don't think we should take away a person's choice"

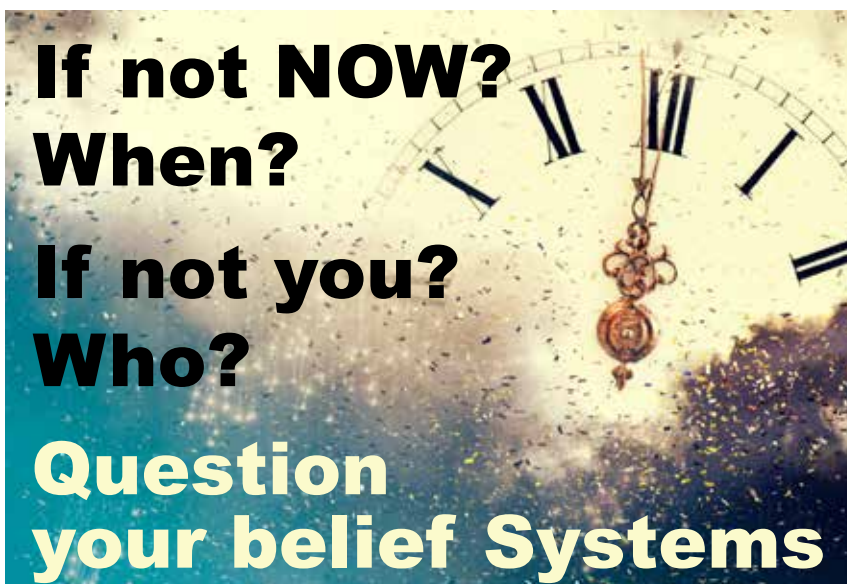
What could prompt people to make these types of arguments? What could cause such a strong resistance to the truth and fervent defense of the potential extermination of the human race? Is there some other force at work here?

Liz Harris, a member of the Arizona House of Representatives 13th legislative district, was expelled from the Arizona State Legislature for daring to question the state's Election Integrity. On April 12, 2023, Harris was expelled from the Republican controlled legislature for inviting a guest who spoke before a joint hearing of the House and Senate elections committees on Election Integrity. That is not a misprint, she was expelled for inviting a speaker to address this group. She was replaced by Julie Willoughby whom Harris defeated in the general election in 2022.

In January 2023, Harris introduced legislation that would ban both mail-in voting and in-person early voting and make it easier to challenge election results in court. This move obviously ruffled some feathers among members of both parties. It is the same tactic that applies to Trump. Allegedly, with the money obtained from the scam they groom law students who become judges, so they control the system from the inside out. They go after key public officials by throwing money at them to make sure they will do their bidding. Their entire goal is to destroy the integrity of elections and those that stand for election integrity.

Is this theory so far-fetched and unbelievable? Anyone paying any attention knows an infiltration by the Cartel has been taking place in our high schools and businesses in Arizona for some time now, so why would we not expect it to be happening in our government? Representative Windy Rogers ran the meeting in question where Ms. Breger testified, and she congratulated Jackie Breger at the conclusion of her testimony, but it was Liz Harris that was expelled. Here is an interesting note; Windy Rogers has raised 3.3 million dollars since then for what? We could not find anything.

According to State Representative John Filmore (Mesa), who is the primary sponsor of HB 2596, Arizona Senate President Karen Fann won't bring his House bill to a vote because it doesn't have the votes to pass. The bill would prohibit the use of electronic voting and tabulating devices, require paper ballots to be used in all elections and be counted by hand and returns must be made within 24 hours of polls closing. It would also restrict the eligibility to vote with an absentee ballot to only electors that meet one of four specified criteria and the bill would repeal the Active Early Voting List. It would also repeal authorization and requirements related to voting centers, emergency voting centers, on-site early voting, the duplication of ballots, and electronic vote adjudication. Senate President Fann has maintained her position that the bill will fail because it does not have the votes necessary even though there is a Republican majority.

It seems to me that this infiltration of the Republican party by people who claim to be conservatives but act in a liberal manner has spread outside of the "State of Maricopa". In 2020 and 2021 Warren Peterson

(Gilbert and Queen Creek) and Sonny Borrelli (Central Maricopa County) were outspoken about voter integrity. These two publicly stated they wanted election reform back in 2020 and 2021, yet with a Republican governor in office they didn't do anything to make it happen and then blamed the failure on the opposition; Paul Boyer in 2020 and Rusty Bowers in 2021. Reportedly Sonny Borrelli was instrumental in the setup of the hearing for which Liz Harris was eventually expelled. According to Harris, Borrelli made the decision not to have any names of speakers listed on the agenda for this hearing, which was later used as evidence against her. According to Harris, four co-sponsors joined to expel her and they were all Republicans! These four Republicans were Teresa Martinez (Maricopa, Casa Grande and Eloy), Travis Lingenfelter (Kingman), Ben Toma (Peoria, Glendale, Surprise and Sun City West) and Leo Biasiucci (Bullhead City and Lake Havasu City.)

Harris points out that Ben Toma (one of the co-sponsors) was implicated in the Breger report. Harris also claims that Leo Biasiucci has been convicted of a felony for Computer Tampering and Alterations of Data, however his felony however was set aside allowing him to run for office. I could not find any details on how or why Biasiucci's felony was set aside. Biasiucci originally ran for office as a candidate for the Green Party! "Special Politics" are everywhere.

Lieutenant Colonel (Retired) Ivan E. Raiklin, former Green Beret and a Constitutional Attorney, recently appeared on the Tucker Carlson Show concerning Election Integrity. He explained to Tucker specifically

what Constitutional regulations you would use to pull back the electors and decertify an election. Ivan was asked at this hearing on February 23, 2023, if Arizona's election could and/or should be decertified, but he was not allowed to appear at this hearing. Sonny Borrelli allegedly contacted Ivan Ralklin several times telling him not to testify to this information. Harris says she asked Sonny Borrelli and Warren Petterson "since when do we tell our reps what they can and cannot testify about?" According to Harris the answer she got was: "We must control the chair (Windy Rogers)."

Under new rules just going into effect, emails in an Arizona House or Senate member's legislative account will be destroyed 90 days after they are sent or received. The calendars, text messages and "communications on online platforms" of our state's senators and representees can be destroyed after what they call the "reference-value" has been served. In other words, any time after the lawmaker decides it's no longer needed.

House Speaker Ben Toma (remember he was one of the four who signed on to Liz Harris's expulsion) said they had been working on the new records rules for months and they wanted a consistent policy that "strikes a balance" between what they must tell the public and protecting their private information. "The old retention policy was ancient and really outdated and it didn't really reflect the way people communicate these days," Toma said. This new "rule" would keep the citizens of the state from being able

to access certain information concerning our elected officials. It has been reported that this information would include (but not be limited to) information on real estate deals in which public officials are involved.

It seems clear to me that the political system in Arizona is broken, and it is not confined to Maricopa County. The "Uni-Party" controls everything in this county, and Arizona is no exception. If this situation is not resolved the voters in this state will be at the mercy of the Deep-State of Arizona. Ballot stuffing has been documented, it has been recorded on video tape in Arizona, but the GOP of Arizona did not stand up against many of the measures used as roadblocks to fair elections or the judges who are trying to "fix" the elections by refusing to allow evidence to come to light.

There is a war going on in Mohave County for the heart and soul of the Republican party there. According to articles by Brian Ference (which can be found at BrianFerence.com) Mohave County Republican Chair Jeanne Kentch is attempting to silence anyone and everyone that will not stop talking about Election Integrity "...and seeks to punish dissent and Free Speech." It appears to me that free speech is being stripped from the volunteer PC's in the GOP. Allegedly, Brian Ference was also the victim of this type of attack

Misty Devenney (Director of District 2) was served with a Workplace Harassment injunction. Also served with Workplace Harassment injunctions were Dr. Christina Dumal and Donna Ramirez. All the injunctions were signed by a Mohave County judge and in effect banned these committee per-

duct and mass emailing. According to MCRCC's PC Handbook, the Standing Rules Committee is to provide a written set of rules necessary for orderly conduct and acceptable demeanor during meetings. Their proposal was out of their purview because the committee can only propose items concerning their meetings. Their proposal included hours of operations at the District Offices and Mohave County events as well as PC mass emailing to other PCs. This proposal was not within their purview. Dumal claims additional malfeasance occurred relating to the proxies. Proxies shall be validated by the MCRCC Secretary prior to a meeting, but at this meeting (according to Dr. Dumal) there wasn't anyone there to validate the proxies, and there was no separate credentialing area. The person manning the sign-in area did not validate the proxies. Moreover, proxies were not counted, and no one came to count the votes concerning the Standing Rules committee proposal. When the call for New Business took place, the speakers were ignored, and Kentch quickly moved for an adjournment. Mohave County Supervisor Ron Gould made the adjournment motion, and according to Dr. Dumal "He's another elected Republican

who does not adhere to the rules." Our website, TFPnews.com has much more info on Mohave County GOP.

La Paz County has some of the same problems we see statewide. In Quartzite we have council members who refuse to recuse themselves in obvious cases of conflict of interest. Thanks to our unconcerned politicians our population is declining, cost of living is rising and the threat of property damage in certain areas from illegally altered washes grows greater, to mention just a few. sons from entering the headquarters where they work. Kentch then used the fact they had not been at work as grounds to expel them!

Dr. Dumal wrote a letter that she sent to the Chairman of the Arizona Republican Party Jeff Dewit. Dr. Dumal has years of experience in County Republican proceedings. Dr. Dumal attended the MCRCC meeting on July 8, 2023, and states that Chairwoman Jeanne Kentch displayed "Gross malfeasance... by non-adherence to MCRCC's bylaws and Robert's Rules." Her letter continues, "The malfeasance by Chairwoman Jeanne Kentch and the chairman of the bylaws and Standing Rules committee chair... was unconscionable."

Dr. Dumal (a seasoned public servant) also pointed out the following concerning MCRCC meetings; the Standing Rules Committee had submitted a proposal for a Code of Con-

## The saga of Quartzsite Town Code 30.09 (b) continues.

§ 30.09 QUALIFICATION OF COUNCIL CANDIDATES. (B) The qualifications for eligibility of Mayor or Council candidates for election or appointment to these positions includes the requirement that no delinquent or fixed fines and penalties, user fees, permit fees and sales tax be owed to the town at the time of declaration of candidacy.

Quartzsite Committee for Voters Choice PAC had all the intentions of having that code presented to the voters of Quartzsite through the use of a referendum. The PAC gathered all the signatures required to have this code moved to the ballot in November. Unfortunately, probably only a select few council members, Jim Ferguson (the town manager) and the town lawyer had other ideas. They love the code and want to use it again in the future to keep people off the ballots despite it being used in

the past and taken to court. The Town of Quartzsite lost and was made to pay all legal fees involved.

The town of Quartzsite changed the wording of the petition to ensure that all that would be repealed is the addition of "or appointment" which was added earlier this year. We thought it was legalese and since we only had 3 days to collect the signatures, it didn't occur to us that it wasn't correct so we didn't challenge it. If we had unlimited funds to pay to a lawyer none of this would have happened, but it has. The town has gotten its way, FOR NOW! If we replace key council members the code will be stricken from the books immediately (please read the article Why the Recall on



Page 15).

## They Were Elected, Why the Recall?

Quartzsite Committee for Voter Choice, PAC has initiated a recall of Vice Mayor Lynda Goldberg, Karey Amon, and Starr Bearcat.

If we thought all the members of the Town Council were elected “fair and square”, we would not do a recall. However, the Town Council used code 30.09(b) to keep their opponents off the ballot. We believe this changed the outcome of the election. Even though the disqualified candidates ran as write-in candidates, it is almost impossible to win an election as a write-in. One of the options on the 2022 ballot said to vote for 3 people; there were 3 names listed and 2 blank lines for write-ins. This is disturbing because

their opponents off the ballot, they can keep anyone they don’t agree with off the ballot. They eliminated their competition and took away our right to vote.

We decided to recall only three of the Council Members after speaking with many Quartzsite residents and the majority agreed on these three. Some of the other town council members voted along with these three on many issues but we felt like three recalls were enough to do at this time.

We haven’t seen positive changes in Quartzsite. The town is declining under this current town council’s economic policies. There are fewer Snowbirds and vendors here than in the past. If we lose the vendors, we lose

enforcement make for a better town, even if the code doesn’t make sense. The town council should evaluate whether the code is reasonable before enforcement. Here are some examples in the last few months:

The town decided that Hi Ali Swap Meet is an RV Park instead of a Swap Meet because vendors live on the property. As a result, they can claim it is in violation of a code that



enforce said that churches needed to be 30 feet from the property line when businesses only had to be 10 feet. This came up when the Alliance Church applied for a permit to add a handicapped accessible restroom to their building that would extend into this 30-foot area. It is unlawful to have different codes



many Quartzsite voters travel to cooler climates for the summer and vote with an absentee ballot. They didn’t have the opportunity to learn what is happening locally. Voters not aware of the write-ins campaign selected the three people who were on the ballot. If the candidates who were forced to run as write-ins were on the ballot it is very likely that one or more would have been elected.

Our right to vote is not being upheld if everyone is not allowed to be on the ballot that is qualified according to Arizona law. If the council can keep

the Snowbirds. Our town’s survival as a viable community is dependent on small vendors and the Snowbirds. The town is making it harder for the small businesses to justify the cost of operating here. The decline started before the COVID-19 mess so don’t let anyone try to say that the decline is the result of COVID and not their policies.

30.09(b) isn’t the only code that has been weaponized against the people and inconsistently applied at will. It appears that some of the council members believe that more codes and code

says that all RV parks need to have a 6 foot concrete fence around the park and three inches of gravel. They are only enforcing this code with new RV parks so once they reclassified Hi Ali as a new RV Park, they could apply the code to it. The ownership didn’t change. Three inches of gravel makes sense to stabilize an area that has mud, but not on the hard desert surface. If you apply some not-so-common sense you know that three inches of gravel on a hard surface creates a safety hazard.

The town has a history of inconsistently enforcing codes. There are Swap Meet areas in Quartzsite that have the same conditions as Hi Ali but didn’t get the same violation. If the code is good for one Swap Meet, then it needs to be applied to all Swap meets; and if it is good for a new RV park then it is good for every RV park. And why should the Town care if there is a fence around it or not? That should be up to the owner. Hi Ali is prime real estate. I have to wonder if there is another reason they are doing this.

Another code the town tried to

for churches and businesses. This was voted down after the people spoke up.

Yet another example of the town council inconsistently applying rules is when the town council was discussing and voting on a crosswalk for Quartzsite Southern Academy. They had Sam Saxton recuse himself from the discussion and vote and had him move out to the audience. When Vice Mayor Lynda Goldberg’s husband was up to continue in his position as President of the Municipal Property Corporation Board of Directors, Goldberg didn’t recuse herself from the vote or disclose her relationship to him, nor did any other council member ask her to recuse herself and step down from the dais. Vice Mayor Lynda Goldberg voted to keep her husband employed by the Town.

If you agree that we need to recall these Town Council members, please sign the petitions. We need at least 260 signatures on each petition to get on the ballot. 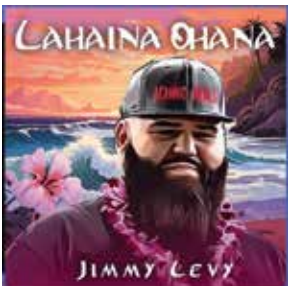

## UN Publishes Final Draft of Declaration That Targets “Misinformation,” Backs WHO Pandemic Treaty

Another global power grab.

The United Nations (UN) is no fan of free speech and one of its plans to “address” so-called “misinformation, disinformation, hate speech and stigmatization” is on the verge of being finalized.

This unelected intergovernmental organization, which wields significant influence over its 193 member states, recently published the final draft of its Political Declaration of the United Nations General Assembly High-level Meeting on Pandemic Prevention, Preparedness and Response.

The final draft contains several agreements from heads of state and government to crack down on lawful speech. Additionally, it contains pledges from these heads of state and government to back two instruments that will give the UN’s World Health Organization (WHO) enhanced powers to target “misinformation” and build out its surveillance networks.

These instruments, the International Pandemic Treaty and amendments to the International Health Regulations (2005), have been in the works since 2021 and despite facing major push-back, are on track to be completed by

May 2024.

The final draft of this political declaration is being developed for the UN’s High-Level Meeting on Pandemic Prevention, Preparedness and Response which will take place on September 20, 2023 in New York. The political declaration outlined in this

In section OP35, the heads of state and government agree to “take measures to counter and address the negative impacts of health-related misinformation, disinformation, hate speech and stigmatization, especially on social media platforms” and counter “vaccine hesitancy in the context of pandemic prevention,

preparedness and response.” Additionally, section OP42 includes an agreement to combat “misinformation.”

The UN member states back the pandemic treaty in section OP15 and agree to encourage the Intergovernmental Negotiating Body (the group that’s responsible for drafting and negotiating the pandemic treaty)

to conclude their negotiations on the “WHO convention, agreement or other international instrument on pandemic prevention, preparedness, and response” (the full name of the WHO’s pandemic treaty).

Not only do UN member states give explicit backing to the pandemic treaty and push for it to be finalized but they also encourage the Intergovernmental Negotiating Body (INB) to prioritize the “need for equity.” Equity is framed by its proponents as something that encourages fairness but critics have warned that equity policies can lead to bias and the injection of “radical ideology.”

The support for the amendments to the International Health Regulations (IHR) is contained in section OP16 of the final draft. This section encour-



draft will be finalized at this meeting.

While UN political declarations aren’t usually legally binding, they do wield significant legal influence. According to the UN, declarations “represent the dynamic development of international legal norms and reflect the commitment of states to move in certain directions, abiding by certain principles.”

The proposed speech crackdowns are outlined in several sections of the final draft of this political declaration.

ages the working group that’s focused on these amendments to continue its work with respect to the intended finalization date of May 2024.

## ACLU: Taxpayers Must Foot Bill for “Transgender” Killer’s Mutilation Surgery

The American Civil Liberties Union has stepped beyond its customary defense of the indefensible. The communist outfit’s latest crazy lawsuit demands that taxpayers pay for the “transition” of a baby murderer into a woman.

The murderer is Jonathan Richardson, who masquerades as a woman called Autumn Cordellioné. Or, as the ACLU’s lawsuit says, “an adult transgender female prisoner confined in a male institution.” By “institution,” the ACLU doesn’t mean the Bughouse. It means the Big House. Richardson is serving time at the Branchville Correctional Facility in Perry County, Indiana, about an hour southwest of Louisville, Kentucky.

### The Lawsuit

The risible 10-page lawsuit is a concatenation of kooky claims rooted in the equally kooky “science” that says men can turn into women and women can turn into men.

Among the highlights are that Richardson, who suffers with “gender dysphoria,” was “assigned the sex of male at birth [but] has identified as female since she was six-years old.”

Though doctors prescribed female hormones to treat Richardson, he’s still a mess. “She,” the ACLU alleges, has “attempted suicide because she could not stand the fact that her sex at birth fails to match the fact that she is a woman and cannot tolerate her male body.”

As well: She has also lived as a woman to the extent possible in a prison designated to house only men. She has requested gender-affirming items, and has been permitted to obtain [bras], panties, make up, and form fitting clothing.

Despite the receipt of hormonal therapy, she continues to suffer the serious negative symptoms of gender dysphoria. Specifically her genitals remain a

source of extreme and continuing distress which is getting worse. The very sight of her genitals causes her to have great anxiety. She has soiled herself rather than use the toilet because of the stress of seeing her genitals....

She believes that the only remedy for her persistent gender dysphoria and the serious harm it causes her, is to receive gender-affirming surgery - specifically an orchiectomy and vaginoplasty [removing the penis and testicles and creating a fake vagina]. In other words, Richardson is faking it to get into women’s prison.

The prison system’s big mistake was giving Richardson the hormones and women’s accessories. It implicitly conceded the absurdity that “transgender” ideology is legitimate science, and that “gender-affirming care” is real medicine.

Noting that normal prisoners receive such surgeries, the ACLU says the state law that prohibits “transgender” surgical mutilation is “unconstitutional” because it violates the federal Constitution’s Eighth Amendment, which forbids cruel and unusual punishment.

The lawsuit also falsely alleges that the prison is violating Richardson’s right to equal protection of the law.

In addition to declaring the law unconstitutional, the ACLU wants the court to bill taxpayers to remove Richardson’s manhood. The court must “enter a preliminary injunction (later to be made permanent) enjoining defendant from enforcing Indiana Code... requiring defendant to take

all steps necessary to provide plaintiff with gender affirming surgery, including the necessary preparatory steps prior to performance of the surgery, and providing the surgery itself.”

### Richardson’s Crime

Of course, the ACLU’s lachrymose tale of Richardson’s “gender dysphoria” didn’t elaborate on his crime. **He strangled his wife’s 11-month-old daughter** when the mother was at work — a crime to which he confessed.

**“I killed the little f\*\*\*ing bitch.”**

When Richardson was on suicide watch in jail while awaiting his trial, “a disturbance erupted in the suicide cell, and officers suspected that Richardson had a role in instigating that disturbance,” court records say. Lieutenant James Spence, a corrections officer, escorted Richardson out of the cell to talk

to him in an attempt to determine the source of the cellmates’ discontent. Richardson explained that he and the others were upset because of a lack of privileges for inmates under suicide watch. Lieutenant Spence then asked Richardson what he was being incarcerated for, and Richardson responded “Murder.” At that point, another officer checked Richardson’s booking sheet and advised Lieutenant Spence that Richardson was incarcerated for reckless homicide. When Lieutenant Spence relayed that information to Richardson, he stated “well all I know is I killed the little f\*\*\*ing bitch.”

In his appeal, Richardson claimed that the confession was inadmissible because it violated his Miranda rights, and that the prosecutors never proved he actually committed the crime. The court didn’t buy those lies and upheld his conviction.

**The ACLU does not explain why Richardson married a woman if he has always believed he is one. Maybe he’s a lesbian, too.**

### Gender Dysphoria

Had Richardson been executed instead of receiving a 55-year prison sentence, Indiana’s prison system wouldn’t be dealing with yet another of the ACLU’s pro-murderer crusades.

Most likely, Richardson is a fetishist who derives sexual pleasure from dressing in women’s attire and accessories.

If he really suffers with “gender dysphoria,” the false belief that one is the wrong sex, hormones and genital mutilation are not the appropriate treatments.

Dr. Paul McHugh, psychiatry professor emeritus at Johns Hopkins University, says “gender dysphoria” is akin to anorexia nervosa and body dysmorphic disorder. “Its treatment should not be directed at the body as with surgery and hormones any more than one treats obesity-fearing anorexic patients with liposuction,” he wrote in 2015: “The treatment should strive to correct the false, problematic nature of the assumption and to resolve the psychosocial conflicts provoking it. With youngsters, this is best done in family therapy.”

Other questions we are asked on our website, however, often have fewer clear-cut answers. Pets in heaven are not really addressed in the Bible although in Isaiah chapter 11 (starting around verse 6) we find that animals will be there. In these cases, I usually depend on common sense: I cannot imagine God would destroy and send to oblivion anything as pure, innocent and loving as my dearly departed pets! 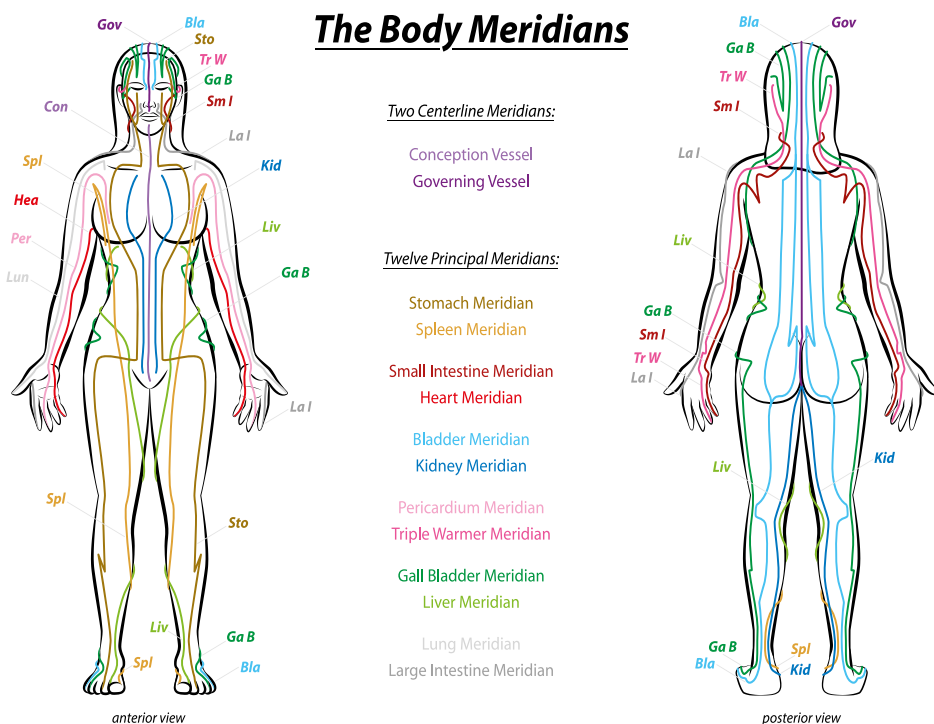
