What’s So Great About Democracy?

US officials and statisticians in the private sector incessantly sing the praises of democracy. They even invade and wage wars of aggression against countries that lack democracy.

But what really is so great about democracy? Actually, only one thing. And, no, it’s not freedom.

After all, if democracy is so great, why does the Bill of Rights protect us from it? We often forget that.

The First Amendment for example, protects us from a democratic vote in the US Congress that would punish us for criticizing government officials. In other words, even if Congress were to vote in favor of such a measure by a 95 percent margin and then it was signed into law by the president, this democratically enacted measure would still be null and void.

In fact, if one carefully searches the entire Constitution (the document that called the federal government into existence) one will note something important: Nowhere in the document is the word “democracy” mentioned. Given the outsized importance that US officials and private-sector statisticians put on democracy today, isn’t that an interesting and revealing omission?

The reason that the Framers didn’t include the word “democracy” in the Constitution was because they understood something that all too many Americans today fail to understand: that democracy is actually



a grave threat to liberty. That’s why the Framers strictly limited the powers of the federal government to just a few enumerated powers. They didn’t want federal officials (including democratically elected ones) to be empowered to do whatever they wanted to do in the interests of the people or of society.

Our American ancestors were extremely leery of democracy. That’s why they demanded the enactment of a Bill of Rights as a condition for approving the Constitution. They were not satisfied with the enumerated-powers concept, which ostensibly limited democratically elected federal officials to the few powers that were enumerated in the Constitution. They wanted additional protection from democracy. That’s what the Bill of Rights was designed to do — to protect us from democracy.

So, what is the one thing that is good about democracy? It enables

the citizenry to change the political direction of the country in a peaceful manner by voting out public officials with whom they disagree and replacing them with people with whom they agree. Without the ability to do that, the only recourse the citizenry would have to change direction would be a violent revolution, which can be costly in terms of death and destruction.

Given that voting people out of office and replacing them with others is the sole benefit of democracy and given the grave threat that democracy poses to the rights and liberties of the American people, is it really worth all the celebratory hoopla or waging foreign wars of aggression over? I say no. I say let us instead do what our American ancestors did. Let’s focus on freedom and figure out how we can achieve it here at home.

How Low will Fake News Go?

Media bring ‘anonymous’ sexual allegations against anti-trafficking hero. Media operatives unable to corroborate reports with ‘victims’.

Media operatives last week brought seven sexual assault allegations against Sound of Freedom hero Tim Ballard from anonymous women, accusations which Ballard has categorically denied.

Sound of Freedom, a thriller based on Ballard’s real-life exploits to infiltrate child sex trafficking rings, is a sleeper hit which has so far pulled in over \$200 million since its release in July. The movie has struck an emotional chord with many Americans who feel organized pedophilia is being overlooked

Media operatives, however, have relentlessly lashed out against the film. In addition to claims of “racism,” “QAnon ties,” and “antisemitism,” media sites have also run reports against small time donors to the crowd-funded film.

On Monday Vice cited unidentified sources — including an anonymous letter — that Ballard sexually assaulted seven women during his child rescue missions. The report, which is quick to note Ballard’s support for Donald Trump, claims that while the former Homeland Security agent was undercover he was assisted by women who pretended to be his wife. During these highly risky operations, Vice insists, Ballard took advantage of the women who were aiding him.

Vice claims to have learned this from sources “familiar with the situation” who say the women are remaining anonymous “because they fear retaliation” — though it is unclear what retaliation they would face. The news site (recently acquired

by a fund linked to billionaire George Soros) admits it has not heard directly from any alleged victims.

For his part, Ballard vociferously refuted the report. “As with all of the assaults on my character and integrity over many years, the latest tabloid-driven sexual allegations are false. They are baseless inventions designed to destroy me and the movement we have built to end the trafficking and exploitation of vulnerable children”, Ballard said in a statement published through the SPEAR Fund, a nonprofit for which Ballard is a senior advisor. The SPEAR Fund collaborates with anti-trafficking organizations and funds their efforts. *“We will keep fighting for the vulnerable all over the globe, and we know that the truth will always prevail,”* Ballard added.

Sound of Freedom has stirred controversy by calling attention to pedophile rings such as that run by Jeffrey Epstein and Ghislaine Maxwell, who counted many powerful leaders (such as CIA Director William Burns) among their associates. None of those associates have been charged however, and accusations against them are quickly covered up by media operatives. This has sparked widespread anger which has been exacerbated by Sound of Freedom.

Ballard himself has kicked the media’s nest by drawing strong comparisons between child sex traffickers and supporters of gender ideology.

In a recent interview with Tyler O’Neill and Sound of Freedom star

Jim Caviezel (who plays Ballard in the film) Ballard revealed the strategy child traffickers use. By studying their literature he said, he discovered

the doctrines they had developed, which he says was akin to a political platform.

“I called them ‘The pedophile network doctrines,’” he shared. “They include things like: separate children from parents because parents are a bad influence, the state knows best; sexualize kids, let them see pornography; take God out of education because that just gets into the way; consent, consent, consent — children can consent to anything. At 12 years old they should be able to vote, they should be able to do anything.”

In April, a report endorsed by the United Nations claimed that children can indeed consent to sexual relationships despite age of consent laws. Ballard said that the very agenda he risked his life to fight is now being pushed into mainstream culture by Leftism.

“Now, what am I saying here? - My stomach is getting sick as I’m reading this. I read this every day — it’s the Woke Left agenda. I’m not saying

they’re colluding or talking. It doesn’t matter, it’s the same dark source - but pedophiles are sitting back right now saying, *‘We’ve been pushing this agenda for decades and now we don’t have to push anymore because the Left is taking care of it for us in America.’*”

Essential to that agenda is gender disorientation (which is being forced on children in the form of indoctrination and even genital mutilation) “and this whole trans voice on children,” Ballard went on. “You know, again, I’m Libertarian: adults, do whatever you want. I’ll fight for your right to do whatever you want in terms of adults. I’m talking about children. And what they are saying is that children can consent to having their bodies filled with a chemical that will destroy their reproductive system. They can consent to ripping apart their genitalia. This is insanity. In and of itself it is horrible, but what it will lead to is what the pedophiles have been asking for. If you can consent to that, guess what? What’s more fluid than gender? AGE.”

The Problem With Public Education

Have you looked at the national public school report card lately? There is no academic category in which half of public-school students are proficient. Only 24% of America's 12th graders are proficient in math. A third are proficient in reading.

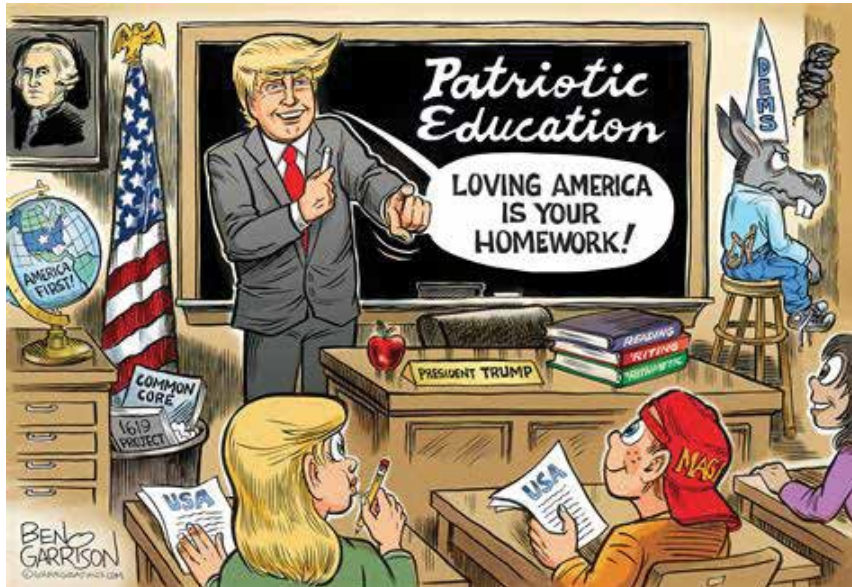
And only 12% of those seniors have an understanding of American history. Is it any wonder our nation is in deep trouble?

Abysmal report cards are nothing new. Public schools have been failing America's youth for decades, but they aren't just dumbing down the next generation. Public schools are systematically brainwashing students with harmful ideologies. Public education has been instrumental in producing an increasing number of anti-America, amoral and socialist-minded adults.

Academic Failure

From the late 1970s, the decade responsible for the ominous, unnecessary, and unconstitutional creation of the federal Department of Education, to today, scholastic performance has bottomed out across disciplines. According to results from the U.S. Department of Education's National Assessment of Educational Progress (NAEP), also known as the "Nation's Report Card," only about one-third of children in grades four, eight, and 12 are "proficient" in reading. Just six percent of 12th graders were "advanced." And well over a third are "below basic," which means they are functionally illiterate.

According to the results of ACT standardized tests, college-bound students are doing worse than they have ever done in the examination's history. SAT scores have been declining ever since the test began, with the architects being forced to "re-center" it every few years to conceal the plunging scores. On every metric, America's children are getting worse, and the trend is spiraling downward.



Taxpayer-funded Social Re-engineering

Recent polls show that one in three millennials favor communism and as many as 70 percent would likely vote for a socialist candidate. In 2020, thousands of young people were propagandized and weaponized against their own country as they burned, looted, and sought to tear down their cities. An Alternative Education School in Quartzsite

There is an attack going on against alternative education in this country and few seem to even notice it. Organized strikes against Charter Schools have taken place in Oklahoma, Illinois, Wisconsin, and West Virginia. Other states have placed caps on the number of Charter Schools and Innovation Zones that are allowed in their state. The Innovation Zones are places where the development of new innovative educational programs (intended to facilitate the growth of the students of the area) are developed. The states limiting these advancements are Alabama, Arkansas, District of Columbia, Iowa, Kansas, Maine, Mississippi, Michigan, Missouri, New Mexico, Ohio, Rhode Island, Texas, Utah, Virginia and Washington State.

Thankfully Arizona is not found among these states but aggressive

attacks against Alternative Education and Charter Schools are growing and if we don't do anything about it, these attacks will show up everywhere in every State in the country. The obscene amount of money being spent on K through 12 Education in this country is mind-boggling. Even



worse, there is a lack of positive results leaving our children unprepared for college and the life ahead of them. Plus there is an indoctrination of our children happening that is even grimmer and we are all paying for it!

Therefore, it was very refreshing to find a private alternative education school thriving in La Paz County. I was fortunate to get an inside view of a K through 12th grade school that exists in Quartzsite, is affordable for all, and is expanding. According to the New York Daily News, alternative forms of education record a proficiency rate almost three times greater than what is being reported there locally, and the same is true in some areas across this nation. Quartzsite Southern Christian Academy (QSCA) is the name of the school, and it is located at 100 N. Kofa Avenue in the town of Quartzsite.

QSCA opened in August of 2022 and currently has 28 students attending (which is two students short of their capacity). According to principal Jeff Saxton, they hope to double their total capacity for students to 60 by sometime next year. Currently the student-teacher ratio is 4 students to 1 teacher, and with the expansion, QSCA will be looking to hire two more teachers. I find the organization and construction of the classes very interesting, currently consisting of class groups of kindergarten, 1st and 2nd, and 3rd through the 12th grades. It uses a modified model of the old "one room schoolhouse" approach which currently employs 4 divisions

of "learning centers" or "schoolhouses." I would assume the addition of two new teachers might add two more "learning centers" for the upper grades.

The separation of the "learning centers" has more to do with than space and age, however. Each student is comprehensively tested in the areas of Math, English, Social Studies, Science, Word Building, the Bible, and Literature. Based on the results of this testing, students are placed in the level of instruction indicated for

each subject matter. In other words, a student may be studying 3rd grade level Math, 4th grade level English, and 5th grade level Science, depending on their competency level in each subject at any particular time. Students can excel at their own individual speeds and early graduation is a reasonable goal.

QSCA uses the ACE (Accelerated Christian Education) Curriculum program and staff were trained in the delivery of the program in Tennessee. The school offers lessons in English or Spanish and currently has two bilingual teachers. The philosophy at QSCA recognizes the uniqueness of each student, with an emphasis on positiveness. Principle Saxton stressed to me that many students have come to them from unfriendly environments and at QSCA absolutely no bullying or harassing is tolerated, period. Parents are made aware that protecting the students and teachers at QSCA is their number one concern at all times.

I was able to sit down with two QSCA students for a few minutes and the experience was eye-opening. It reminded me of my days in parochial school, minus the nuns. I talked with Kellie, a 5th grader, and Aerowynne, a 10th grader about the school and what they thought of it. They both agreed that their teachers try to make them feel comfortable and a part of the school community. Aerowynne is excited about the introduction of inter-school competitive sports at QSCA, by way of a cross country running team next year. She is ready! **Go Road Runners!**

Having been involved with education for most of my life in one way or another, one of the most interesting aspects of my conversation with Principal Pastor Jeff Saxton came when he explained how and what caused him to start QSCA. He said it came out of two concerns, a family need and a community need. His grandchildren were already being home-schooled and the middle school in Quartzsite had closed their doors. Pastor Saxton came to Quartzsite after 25 plus years of Pastoring in Louisiana and knows the reason why he ended up in Quartzsite was because that is where God wanted him. I probably should also let you know Aerowynne is his granddaughter.

I can almost hear some of you out there saying; "That's good for those that can afford a private school" but here is some great news; there is a thing called the "Freedom of Education Act". As I understand it there are no restrictions or qualifications whatsoever for residents of Arizona. The "Freedom of Education Act" moves state money with a student when they change schools. Principal Saxton says they will help parents get this "State Scholarship" and will help them with all the paperwork needed for their child to attend. Again, there is no "financial test." - The bad news for some maybe, Pastor Jeff says they have no room for mediocrity at QSCA. For more information:

FASCISM RUN AMOK: Canadian libraries engaging in mass BOOK BURNINGS to purge history and truth from people's minds

A strange phenomenon is taking place in Canada where books at public schools and libraries are disappearing. CBC Investigates published a report about the matter, explaining that all books published in 2008 or earlier are being “burned,” so to speak, because they do not meet the Justin Trudeau regime’s new “equity-based” process for public materials.

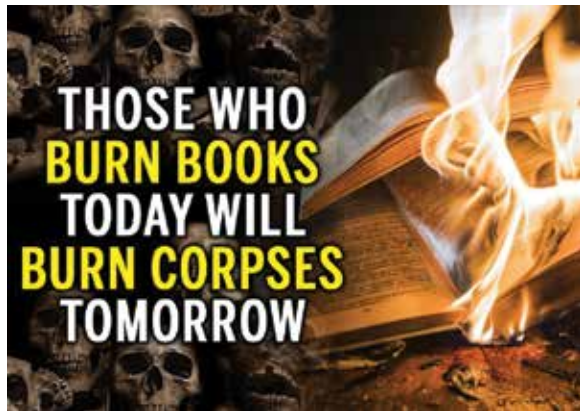
Everything from *Harry Potter* to *The Hunger Games* to *Roll of Thunder, Hear My Cry* is no longer allowed at Canadian public schools and libraries because they do not meet the anti-white standards being forced on Canada.

“This year, I came into my school library and there are rows and rows of empty shelves with absolutely no books,” said Reina Takata, a 10th grade student who says her public high school library in Mississauga, Ontario (which she visits during her lunch hour most days) is devoid of most books.

While still in grade school at Erindale Secondary School, Takata also noticed that books were gradually disappearing. Now, as a high school student, she is noticing this phenomenon more and

more, estimating that more than 50 percent of her school’s library books are now gone.

All books published prior to 2008 are now ILLEGAL at Canadian public institutions, including schools and libraries, in certain provinces. Back in the spring, Takata says staff at her school informed all students that “if shelves look emptier right now, it’s because we have to remove all books [published] prior to 2008.”



In speaking to CBC Toronto, Takata and other students, parents, and community members at the Peel District School Board (PDSB)

revealed that there is an inconsistent approach being taken as far as the new equity-based book weeding process taking place in their area goes.

Last spring (for those who missed it) a provincial directive from the Minister of Education started forcing public school systems and libraries to remove all books published in 2008 and prior because they do not qualify as “inclusive.”

Before CBC went public with an exposé about all this, it reached out to Ontario Education Minister Stephen Lecce’s office, only to receive no comment either from him or his department. Lecce did, however,

issue a general statement indicating that he had told the PDSB to stop burning all the books published prior to 2008.

“Ontario is committed to ensuring that the addition of new books better reflects the rich diversity of our communities,” Lecce said. “It is offensive, illogical and counterintuitive to remove books from years past that educate students on Canada’s history, antisemitism or celebrated literary classics.”

To be clear, this does not mean that the book burning will end. It just means that arbitrarily burning all books published prior to 2008 will no longer be the standard.

“I think that authors who wrote about Japanese internment camps are going to be erased and the entire events that went on historically for Japanese Canadians are going to be removed,” Takata, who is Japanese, commented. “That worries me a lot.”



Another major concern is how Canadian authorities are arbitrarily defining things like “inclusivity,” seeing as how there is nothing inclusive from a white person’s perspective to have all European and Caucasian reading material banned simply because it does not focus on non-white issues, cultures, or history.

“Who’s the arbiter of what’s the right material to go in the library, and who’s the arbiter of what’s wrong in our libraries? That’s unclear,” said Tom Ellard, a PDSB parent and the founder of a group called Libraries Not Landfills. “It’s not clear to the teachers who’ve provided us this material, and it’s not clear to me as a parent or as a taxpayer.”

The nation’s largest teachers’ union has included the controversial, highly graphic illustrated book “Gender Queer” in its recommended summer reading list for teachers.

The National Education Association (NEA) included the memoir, written by Maia Kobabe, under the “banned books” section of its “Great Summer Reads for Educators” list. Fox News also reported that the list included the book “White Fragility,” a staple of popular critical race theory narratives that argues that white Americans generally try to evade taking responsibility for racial inequality.

The graphic novel has indeed

captured national attention on more than one occasion for its highly sexualized content and imagery, which includes illustrations of the author engaged in sex acts and masturbation as well as a drawing of a *pedophilic sex act between an adult man and a boy*.

Kobabe and her supporters have always argued that the book is necessary to highlight the experiences of “gender queer” youth.

Incredibly, Kobabe has said that the book is “a lot less explicit than it could be... The topic of gender touches on identity and touches on sexuality” - the author told NPR in January, as noted by Fox. “It’s hard to fully explain, I think, how a gender identity can impact every facet of life as an adult without touching at least a little bit on sexuality and so I wanted to not shy away from that.”



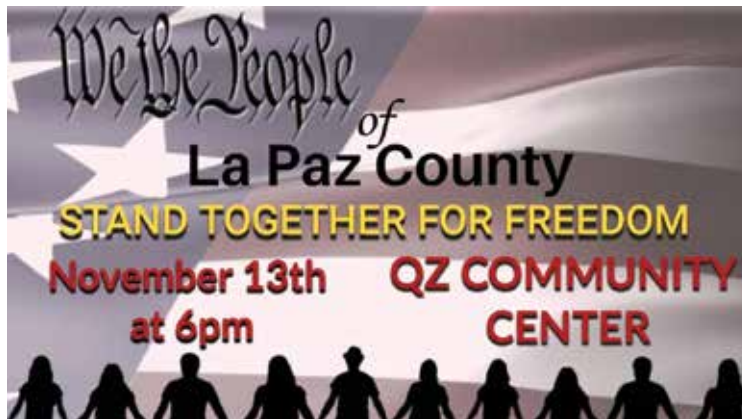

What is Happening in Arizona? Part 2

As we reported in the article "What is Happening in Arizona" last month, there is turmoil within the Republican Party in Mohave County. One of the central characters in this story is Dr. Christina Dumal, who has already tried unsuccessfully to enter a Resolution of Censure by the Mohave County Republican Central Committee (MCRCC), based on the events which transpired concerning events involving Liz Harris along with other events she believes violate the Arizona Constitution. I conducted an interview with her about the ongoing situation which follows.

TPFP: Dr. Dumal, it is my understanding that you are fairly new to Mohave County politics. Tell me a little about your past history in Arizona County Government and your past activity within the Republican Party in Arizona.

Dr. Dumal: Shortly after my husband and I moved to AZ in 2008 we started getting involved with various groups around Florence. There were anti taxation groups and groups that scrutinized Pinal County BOS budgets. We got involved in a San Tan Valley Tea Party group and were just trying to learn everything we could about the AZ government. Eventually we ended up in the Pinal County Republican Committee (PCRC) as appointed PCs. That was 2012. Subsequently we were elected PCs, state committeeman, and then ultimately I became chair of District 6, & my husband was vice chair. He was also the PCRC treasurer. We worked with a great PCRC chair, the late Michael Burke. District 6 consisted of 10 precincts that ran from Eloy through Coolidge, part of Florence, to San Tan Valley. It covered 2 Congressional Districts, and 2 LDs. It was a lot of work, but we really enjoyed it. What we didn't enjoy was the infighting, so after our team hung up our last door hangers in 2018, we resigned, swearing never to return to politics again.



We moved to Mohave County in June 2019, and five years later after our move and dealing with some medical problems I decided to try it again. I got involved with the Bullhead City GOP officially in Jan 2023. I was looking forward to beginning up here in an off-election year so that I'd have a chance to get to know the other PCs. However, we needed to have a highly productive fundraiser in order to keep our local office open... I got very involved with that fundraiser.

TPFP: In case the reader doesn't know could you please tell us what a PC is and what is the difference between an appointed PC and an elected PC?

Dr. Dumal: A PC is a Precinct Committeeman and is the backbone of the political party. We're the ones who knock on doors to distribute information about candidates or talk with occupants, attend events, work fundraisers, register voters, and in Mohave County we also are scheduled to work at our local offices. For each precinct there is one PC for every 125 registered republican voters. For example, in Bullhead City, Precinct 211, according to the 2023/2024 MCRCC Precinct Committeeman Handbook, we have 13,332 active registered republican voters. Therefore can have up to 99 PCs. Every two years a PC must run for election. If there are PC vacancies during the interim years, then PCs can be appointed.

TPFP: When did you first start questioning what was going on in the Mohave County Government?

Dr. Dumal: I can only address what I saw in the Mohave County Republican Central Committee (MCRCC) which is the organization that supports Republicans who are running for office in

Mohave County. It also registers voters. I first started questioning things about a month and a half after becoming a PC. On Friday, February 3rd, 2023, we PCs were tasked with contacting voters who had received provisional ballots. We had nothing to do with retrieving the names and

phone numbers that we were to call; that was done by Ted Boyd. I contacted a voter who was not at home, so I left a message for her to contact me. The issue was resolved that evening by phone but on Feb 10th the District 2 Director received an email from the Chairwoman concerning this voter's original complaint. Ms. Kentch emailed Director Asel and since my name was listed in the email, he discussed the situation with me.

Ms. Kentch assumed that I had caused the problem. What she failed to do

was investigate the aspects of the incident and perform an objective investigation or she would have determined that we PCs were given incorrect information by Ted Boyd. I contacted Chairwoman Kentch explaining that I had been given incorrect information, but even after numerous emails she failed to recognize the problem. Investigation into problems like this is an absolute necessity, but Chairwoman Kentch does not investigate. The next issue occurred in April after the expulsion of Representative Liz Harris. Rep John Gillette sent out a letter to the 3 district directors who in turn sent it to the PCs. His letter was full of misinformation and nonsense. A huge majority of PCs signed a response disagreeing with Ms. Kentch's e-mail defending Gillette, which I sent to her. She never responded.

TPFP: I understand there was another issue concerning some land owned by Rep. Leo Biasiucci?

Dr. Dumal: Yes, he had brought in a partner, and they needed to get some land rezoned for a commercial venture. The Mohave County Planning and Zoning Committee voted unanimously against rezoning the

two parcels, and most other residents were against the rezoning. However, on Monday, April 10th, 2023, three Mohave County Supervisors, Gould, Angius, and Bishop, voted to change the zoning of two parcels in the Topock/Golden shores community. These three supervisors ignored the Mohave County Planning and Zoning Commission's unanimous vote against this zoning change and ignored all input from the residents of this area, all of which were against this zoning change.

TPFP: Misty Devenney is another PC that has been under attack, was she involved with this zoning issue?

Dr. Dumal: Misty Devenney tried to get this and another issue placed in the May MCRCC newsletter but her request was denied. I sent an email out to all of Mohave County PCs concerning these issues, and then at the July 8th quarterly meeting our District 2 Director (Cary Asel) resigned. During his 7 months as a director, he had been constantly harassed by Chairwoman Kentch.

TPFP: It is also my understanding there was an incident involving alleged homophobia?

Dr. Dumal: Yes, there was one such incident that occurred in the BHC GOP office with several witnesses; Mr. Jim Fuller harassed several PCs; he was adamantly against Scott Presler's gay lifestyle. Scott had been a guest speaker at our May 6th dinner and had given a voter registration presentation on May 7th in BHC. He was planning on returning in September to which Mr. Fuller was adamantly against. Director Asel requested incident reports and submitted them to

Chairwoman Kentch. No action was taken.

TPFP: I have been told there were several other incidents involving PCs, is that accurate?

Dr. Dumal: That is correct. There was an incident that occurred at a BHC Dollar Tree store, and another involving a Voter List Maintenance document given to several PCs after the monthly meeting. The final straw for me occurred during Kentch's outrage on June 23rd at 3:06 PM, over these and other incidents when she yelled at Director Asel to keep his PCs in line. He warned her to stop yelling, or he would hang up as his son was in the other room and could hear her screaming. When she did not stop screaming, he hung up on her. It is clear that Chairwoman Kentch could have discovered the truth about these incidents; however, it was once again clear that Chairwoman Kentch does not objectively investigate incidents.

TPFP: It sounds like there is a communication problem, do you agree?

Dr. Dumal: Yes, actually I have tried to keep the PCs informed on what has been going on but there are some who would rather that not happen. At our July 8th quarterly meeting the Standing Rules Committee (of which Stanley Hicks is Chair) proposed new rules for the District Offices and Mohave County GOP events. Additionally, the Committee proposed rules against mass emailing. The emailing rules were set up to stop me from

sending out information. What Kentch and Hicks failed to realize was that the Standing Rules Committee's purview is only over meetings, which are described in our bylaws and do not include any criteria for District Offices, Mohave County

events or mass emails.

TPFP: Can you please put the pieces together on all this and tell us what exactly is going on?

Dr. Dumal: After Mr. Asel resigned, Chairwoman Kentch (in violation of the by-laws) appointed Ms. Eva Corbett as Interim director. On July 27th, a vote was held with only one candidate on the ballot. Misty De-



venney was nominated from the floor and subsequently won the election. I requested a vote count from Chairwoman Kentch but was denied the vote tally. As such Chairwoman Kentch violated AZ GOP's by-law F, Manner of Voting. Chairwoman Kentch decided that the information given by MCRCC's parliamentarian, Ron Gould, for the July 27th vote was incorrect so she scheduled a revote for September 22 whereby only elected PCs could vote, excluding appointed PCs. Misty declined to be renominated due to the messy conflict created by Chairwoman Kentch.

TPFP: What is this about a Resolution to Censure?

Dr. Dumal: I will again try to present an updated resolution to censure the following officials at the September 30th meeting to be held at Bullhead City Mohave Community College; Wendy Rogers, Joseph Chaplik, Gail Griffin, Travis Grantham, Ben Toma, Leo Biasiucci, Teresa Martinez, Selina Bliss, Michael Carbone, Lupe Diaz, Timothy Dunn, John Gillette, Matt Gress, Laurin Hendrix, David Livingston, David Marshall Sr., Steve Montenegro, Quang H. Nguyen, Michelle Pena, Beverly Pingerelli, Justin Wilmeth, Bill Gates, Jack Sellers, Clint Hickman, Thomas Galvin, Ron Gould, Jean Bishop, Hildy Angius, and Jeanne Kentch. These censures are due to their actions concerning either the expulsion of Representative

Liz Harris, their dereliction of duties, and/or their violation of the Arizona Constitution.

TPFP: I understand there was a meeting that took place on Friday September 22nd that involved a vote, can you give us a summary of what happened?

Dr. Dumal: The meeting was a District 2 Director revote for the vote that took place on July 27. The two candidates were Barbara Houston and Valerie Medina. This was Barbara's second attempt to become District 2 director. There weren't any nominations from the floor. 5-minute speeches were made by each candidate and both stressed unity within our

party. Questions followed. Valerie was asked how she was going to manage to be the director while working full time, living far from the office, and running for recorder. Valerie gave two examples of others who were quite involved yet managed, such as her boss, Supervisor Gould, and chairwoman Kentch. Both candidates were asked who they would choose to be their office managers. The vote was monitored by Supervisor Gould, and the count was accomplished by those on each side. Valerie won. Chairwoman Kentch violated AZGOP by-law F again; she did not announce the vote tally and did not include that information when she emailed the results to the PCs. Valerie received keys to the GOP office and it will be open from Tuesday through Saturday. Call for office hours. MohaveCountyGOP.com

Follow up: The censure was not brought up at the meeting of the MCRCC, held on September 30th and according to two different sources, there was an attempt to get Chairwoman Kentch to resign and when that attempt was circumvented communication between the two sides broke down. There seems to be as much division in Mohave County as there is in D.C. these days.

Younger kids to teenagers (as everyone knows) spend a lot of time on the internet, in some cases for a good reason but in reality, the internet is a pretty dark place filled with hackers, online groomers, and child predators. It's quite easy to get a person to trust another person on the internet, especially teenagers who come from dysfunctional families that don't really pay attention to them. Trump Blasts Bizarre New York Fraud Ruling

"That is a fantasy world, not the real world," the Democratic judge concluded.

James took the opportunity to gloat on X. "Today, a judge ruled in our favor

Never at a loss for words, the former president took to Truth Social to air his grievances on the bizarre decision. 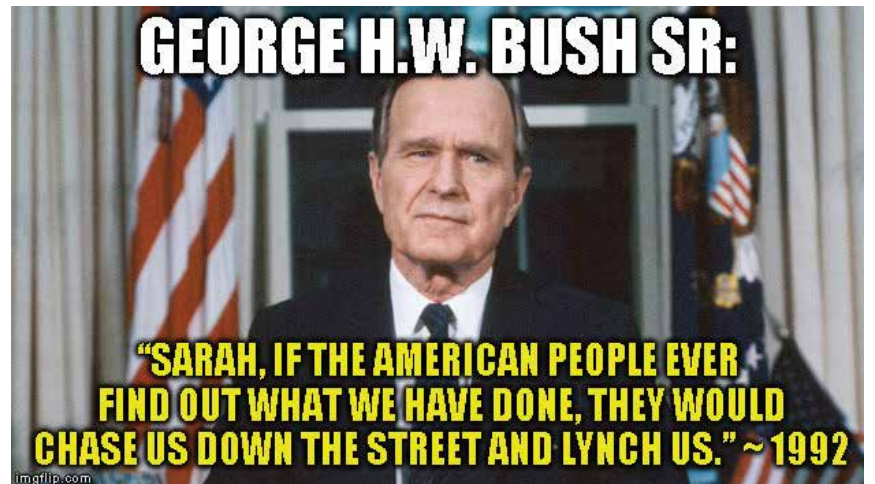

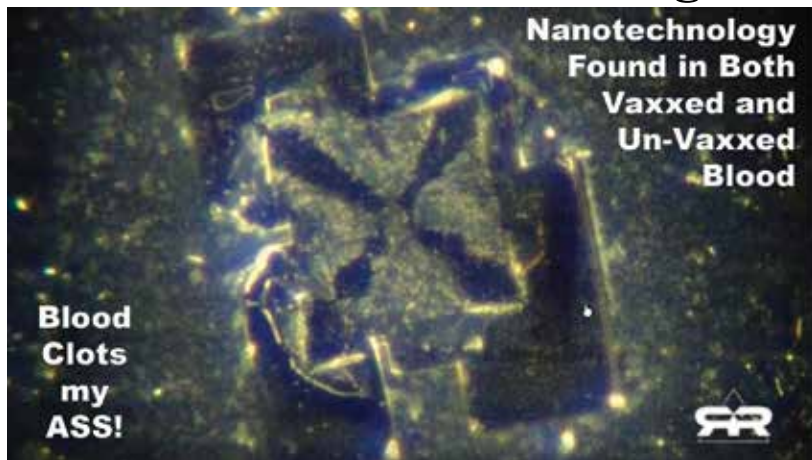
Nanotechnology Found in Both Vaxxed And Un-Vaxxed

Using Dark-field microscopy, Doctor Ana Maria Mihalcea has captured in great detail what the scientific literature describes as effective technologies that exist today. Technology such as Quantum Dots.

HORRIFYING: Rep. Thomas Massie Exposes Taxpayer-Funded “Transgenic Edible Vaccines” Which Turns Edible Plants Like Lettuce and Spinach Into mRNA Vaccine Factories to Replace mRNA Shots!

In a shocking revelation, Rep. Thomas Massie (R-KY) has recently brought to light a deeply concerning issue that should alarm every American citizen.

The U.S. government is currently funding research into “transgenic edible vaccines,” a term that sounds like it’s straight out of a dystopian science fiction novel. Yet, it is very much a reality, and it’s happening right under our noses.

The Gateway Pundit reported in 2021 that scientists at the University of California, Riverside, have been experimenting with turning edible plants like lettuce and spinach into mRNA vaccine factories.

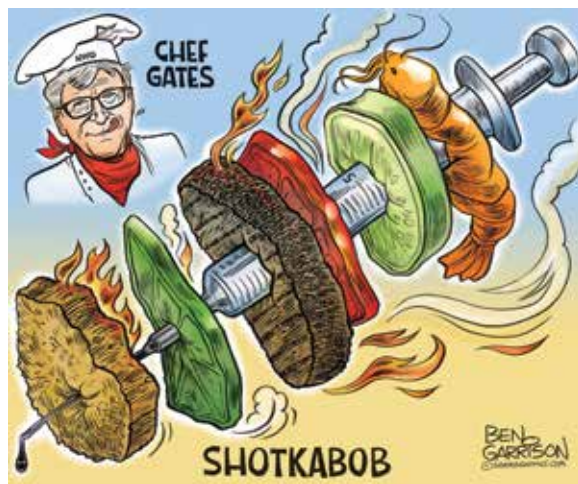
According to the press release published by the University of California (Riverside), the project aims to utilize mRNA technology (similar to that used in COVID-19 vaccines) to turn edible plants into vaccine factories.

The research is funded by a \$500,000 grant from the National Science Foundation and has three primary goals:

- 1) To successfully deliver DNA containing the mRNA vaccines into plant cells where it will replicate.
- 2) To demonstrate that plants can produce enough mRNA to rival a traditional vaccine shot.
- 3) To determine the right dosage of the vaccine.

Juan Pablo Giraldo, an associate professor at UCR, is leading the research. He envisions a future where people could grow these transgenic plants in their gardens and farmers could cultivate entire fields of them. “Ideally, a single plant would produce enough mRNA to vaccinate a single person,” said Juan Pablo Giraldo. “We are testing this approach with spinach and lettuce and have long-term goals of people growing it in their own gardens,” Giraldo said. “Farmers could also eventually grow entire fields of it.” Effectively delivering the genetic material to a plant’s chloroplast, small organs in plant cells that convert sunlight into energy the plant can use, is critical

to rolling out the vaccinated food. “[Chloroplasts are] tiny, solar-powered factories that produce sugar and other molecules which allow the plant to grow,” Giraldo said. “They’re also an untapped source for making desirable molecules.”



The research involves altering the genetic makeup of plants, which could have unforeseen consequences. “Genetically modifying edible plants with experimental vaccines for public consumption is the culmination of a dream” the associate professor explained. “One of the reasons I started working in nanotechnology was so I could apply it to plants and create new technology solutions. Not just for food, but for high-value products as well, like pharmaceuticals,” he said.

On Wednesday, Rep. Massie began his speech by stating, “Mr. Chairman, I rise in support of my amendment, which states that none of the funds made available by this act may be used to fund any grant related to any transgenic edible vaccine.” He went on to elaborate that this isn’t some far-fetched idea, “Does the term transgenic edible vaccine sound far-fetched? Well, it’s not. We’re funding it... I don’t think the American people should be funding this and I think, and I would hope, that we’ve learned something from the COVID experience with SARS-CoV-2, that some of our science projects aren’t the best ideas,” Massie continued.

“What could possibly go wrong with this research? Well, we found out a few years ago when a biotech

company was experimenting with growing a vaccine in corn to keep pigs from getting diarrhea. What happened? Well, the next year where the corn was grown, the prior year the corn came up, and it got co-mingled with soybeans that were being grown there. It contaminated 500 bushels of soybeans, which were then co-mingled with 500,000 bushels of soybeans. And those all had to be recalled and destroyed. Luckily, they caught it.”

“Do we want humans eating vaccines that were grown in corn meant to stop pigs from getting diarrhea? I don’t think we want that to happen. Yet that almost happened, and it could happen. There’s another case where the pollen cross-contaminated another crop of corn, and 155 acres of corn had to be burned. What are the cases where we’re not discovering this? I think it’s dangerous to play God with our food,” Rep. Massie asked.

He warned against the dangers of playing God with our food supply, emphasizing that it’s not just about keeping prices low; it’s about ensuring the safety and integrity of the food we consume. “I think we need a safe food supply, and this is about food safety. Ultimately, the people in this country need to know what’s in their food, and if we start contaminating the DNA of our food with DNA from other animals or viruses, the pollen could spread and we don’t know what could happen. I would hope we’ve learned a lesson from the Wuhan lab that sometimes things

escape, sometimes things don’t go as you plan and so that’s why I think it’s a bad idea to fund transgenic edible plant vaccine research from the USDA,” said Massie.

According to the congressman, his amendment to prohibit USDA funding of this research was passed by the House.

The Defender reports: The amendment, introduced by Rep. Thomas Massie (R-Ky.) to the agricultural appropriations bill H.R. 4368, would bar the U.S. Department of Agriculture (USDA) and the U.S. Food and Drug Administration (FDA) from funding the vaccines for fiscal year 2024.

A vote on the full bill in the House is still pending as of this writing. In an interview with The Defender, Massie said he introduced the amendment after learning about a recent project in California, funded by a \$500,000 grant from the National Science Foundation, that involves growing lettuce and trying to get the lettuce to produce mRNA vaccines that are intended to be consumed by humans who eat the lettuces.

Massie said he is concerned “that plants cross-pollinate and pollen from these modified plants, food-producing plants, could carry in the wind to other fields and contaminate them. We could really contaminate a lot of our food supply with unknown doses of vaccines that would deliver unknown dosages...Plants release pollen and it can go anywhere with the wind or with insects and I just think it’s a bad idea,” he added.

Time To Name The Clients: JPMorgan Flagged Over \$1 Billion In Suspicious Epstein Transfers

JPMorgan flagged over \$1 billion in suspicious transactions linked to deceased pedophile Jeffrey Epstein, which the bank reported to the US government - the US Virgin Islands has claimed in its lawsuit against the bank.

“JPMorgan was a full-service bank for Jeffrey Epstein’s sex trafficking,” said Mimi Liu, an attorney for the USVI, which says the enormous sum bolsters key allegations in their legal action against the bank, which they say knowingly

benefited from Epstein’s wrongdoing, Bloomberg reports, noting that this is the first time in the case that the ‘sheer volume of Epstein’s financial activity at JPMorgan over a 16-year period has been disclosed.’

The suspicious activity was detailed in a 2019 filing to the US Department of Treasury, a USVI attorney told a federal court in Manhattan on Thursday. The filing was made after Epstein died in a Manhattan jail cell a month after his arrest on sex trafficking charges. Epstein had been with the bank from the late 1990s through 2013, when they finally

cut ties with him.

Epstein notoriously trafficked some of his victims to a private island in the USVI.

JPMorgan denies that it let Epstein’s activities slide, and

Over \$320,000 of the payments were made to “numerous individuals for whom JPMorgan had no previously identified payments,”

Singer wrote, accusing the bank of failing to disclose the payments until after the end of discovery (the period in which parties in a lawsuit exchange evidence.)

The bank claims that’s irrelevant, because the USVI doesn’t have legal standing to claim JPMorgan obstructed a trafficking investigation because it wasn’t a victim.

That said, Liu is urging the judge in the case to decide various claims in the USVI’s favor without a trial. **“The only reason that JPMorgan after 16 years reported the \$1 billion in suspicious transactions was because he was arrested and then he was dead,”** she said.

says it reported around 150 cash transactions to a federal regulator between 2002 and 2013.

Last month, the USVI told the judge in the case that the bank facilitated over \$1.1 million in payments from Jeffrey Epstein to “girls or women,” many of whom had Eastern European surnames.

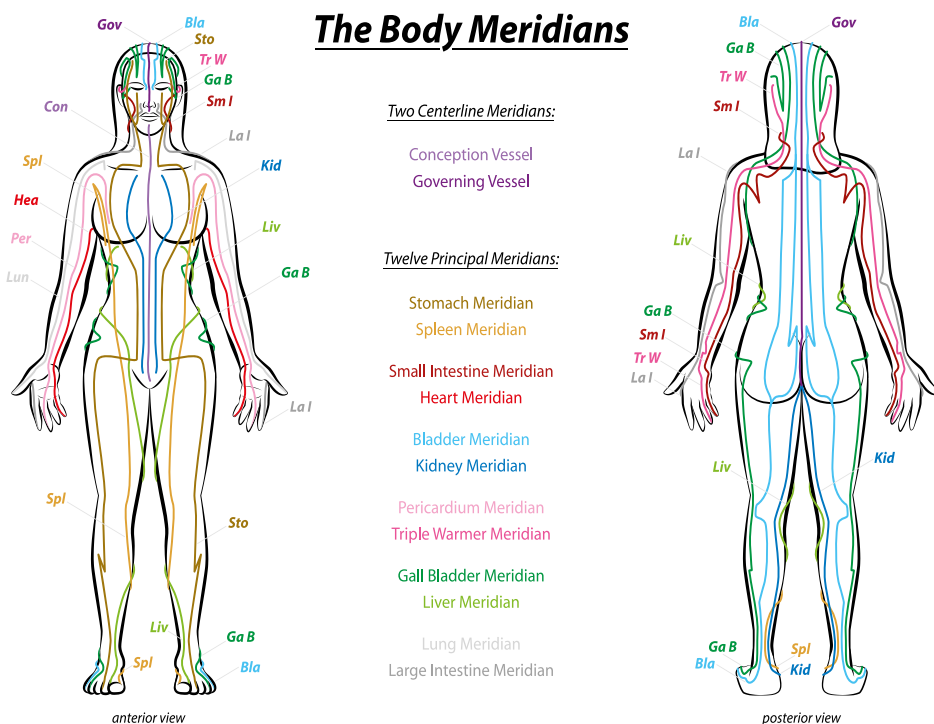
