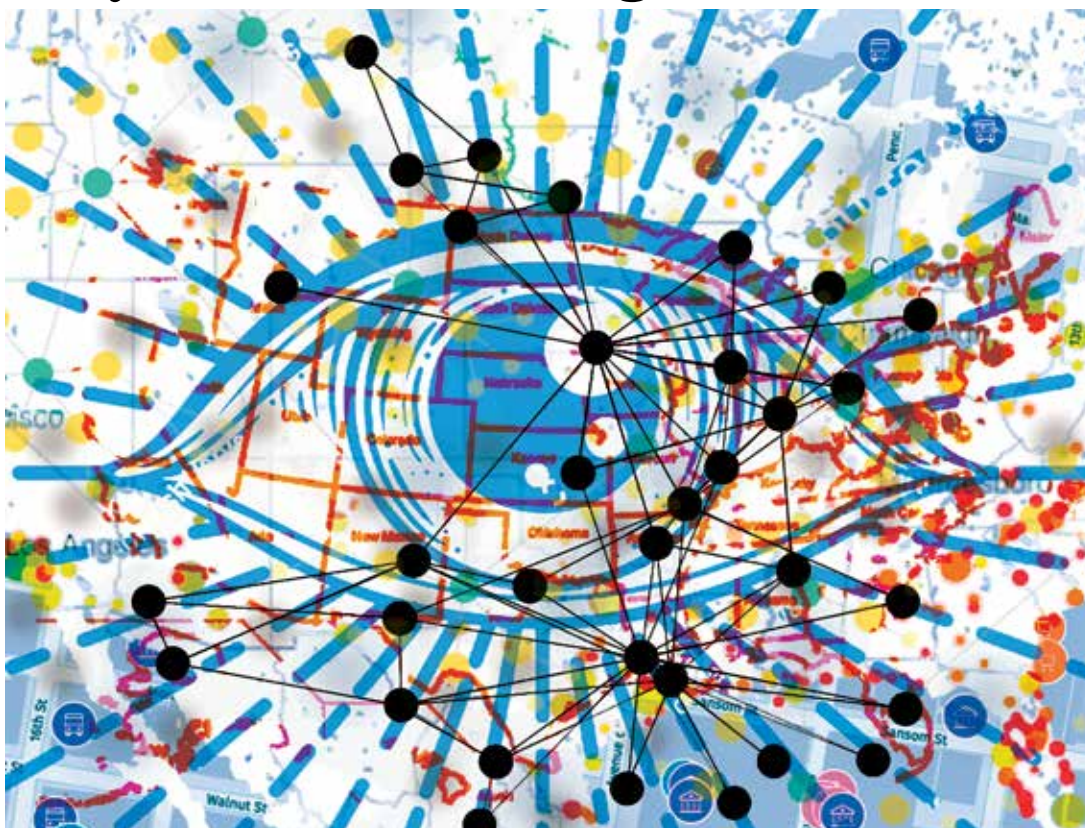

Transcript of Joel Sussman statement at the Aurora, ON City Council meeting on Sept. 21, 2023

Good evening. Restructuring of Canadian mayors and municipalities under the auspices of the United Nations began in 1992. PM Mulrooney signed Canada onto UN Agenda 21. Canada thus became a UN member nation-state. 178 countries signed on, lured by the promise of big money to go green. By 2000, countries, including Canada, were being governed by directions of the UN G7 G20 World Economic Forum and World Health Organization, to name some.

Every organization named is a for-



eign-based NGO, non-governmental organization, and every member of all these organizations is unelected. Parliamentary procedures for law changes weren’t followed. In 1994, a municipal primer was issued to all local towns, outlining how they were to restructure their governments.

Though the municipal primer was a non-binding agreement, all towns adopted it. For our public officials, the mayor and counselors of that day were partnered with a private corporation, the Corporation of the Town of Aurora, who appointed a chief administrative officer who helped implement the global agenda instead of a local one.

The International Council on Local and Environmental Issues, ICLEI, became the main source of consultation to push and fund the global agenda. We remind you that the World Economic Forum and the United Nations signed a strategic partnership framework in 2019

to jointly accelerate the implementation of the 2030 Agenda for Sustainable Development.

This is the same World Economic Forum whose chairman, Klaus Schwab, famously declared you will own nothing and be happy. This is the same Klaus Schwab who, referring to Canadian Prime Minister Justin Trudeau, boasted “we have penetrated more than half of his cabinet”. We would ask Mayor Maracas and the Councilors, why should the citizens of Aurora bow down to the intrusive dictates of an unelected foreign entity?

In the Declaration of Independence, America's founders defined unalienable rights as including "life, liberty, and the pursuit of happiness." These rights are considered "inherent in all persons and roughly what we mean today when we say human rights," said Peter Berkowitz, director of the State Department Policy Planning Staff.

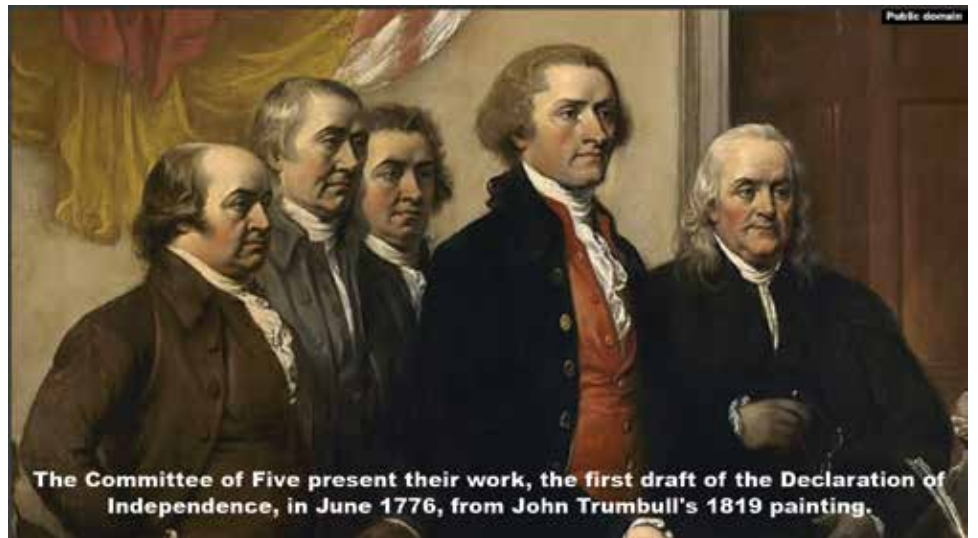
These rights don't just protect Americans at home but form the basis for a moral foreign policy abroad, said Mr. Berkowitz: "We took obligations to champion them in 1948 when we led the effort in the United Nations

to pass the Universal Declaration of Human Rights. There have been presidents from both political parties [who] have championed human rights. And America's founding commitments involved respect for the dignity that inheres in all human beings."

A year ago, U.S. Secretary of State Mike Pompeo convened the Commission on Unalienable Rights with a specific mandate, said Director Berkowitz: "Secretary Pompeo asked the members of the Commission to investigate, to reground America's undoubted commitment

to human rights in foreign policy, in America's founding documents - the Declaration of Independence, and the Constitution of the United States - in the American Constitutional tradition and also to help us



understand America's undoubted commitment to human rights in light of the Universal Declaration of Human Rights, which we signed onto in 1948."

Unalienable rights directly affect U.S. relations with individual countries, said Director Berkowitz: "We see it, for example, in Secretary Pompeo's repeated condemnations of the imprisonment of Muslim Uighurs in Chinese internment camps. We saw it in the 1980s when Ronald Reagan championed the hu-

man rights of the dissidents that the Soviet Union had cruelly imprisoned in their gulags. We hear it when the administration takes on the Islamic Republic of Iran, which also represses its own citizens."

While "human rights are certainly not the totality of American foreign policy," noted Director Berkowitz, they are "one essential component, one key part of the mix of American foreign policy."

The New Bill of Attainder

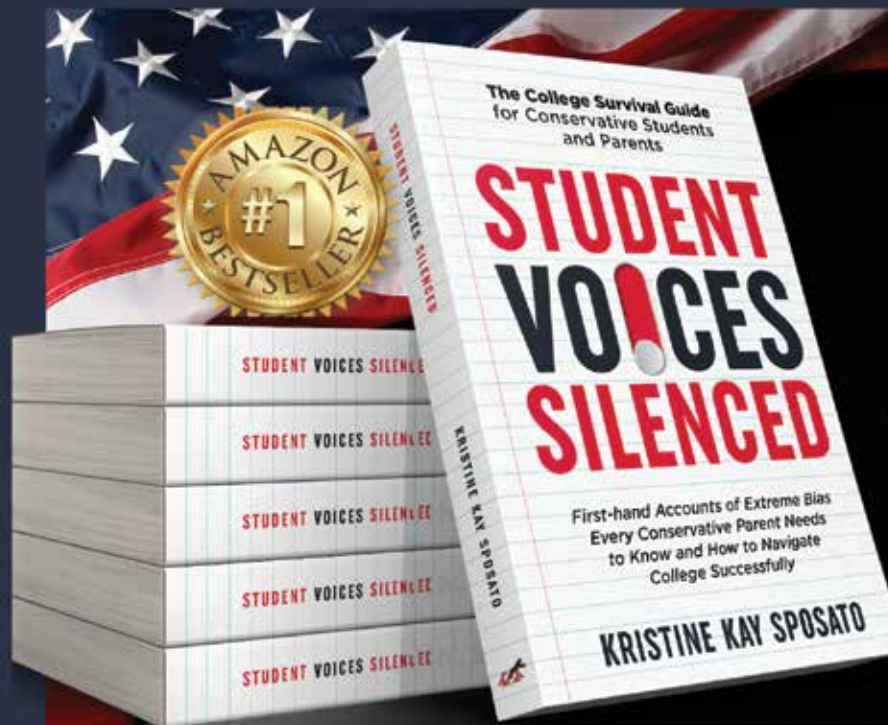

Hezbollah Chief: US “Directly Responsible” For Gaza Atrocities, Will Soon Pay “Heavy Price”

Summary recap:
Hezbollah Secretary-General Hassan Nasrallah’s speech went for just under one-and-a-half hours, and while full of threats and ultra-pro-



vocative heated words aimed at Israel and the United States, this was not a declaration of war speech. But he emphasized that Hezbollah’s full entry into war with Israel will be determined based on developing events in Gaza, and whether Israel halts its attacks on the Palestinian people. Shelling on the Israel-Lebanese border was reportedly ongoing through and by the end of the speech in Beirut (Nasrallah addressed his top officers via remote feed from a secure location). Some highlights from Nasrallah’s speech...

All “Options” on the table

“I assure you all options are open on the southern front. They can be adopted anytime,” he said. “I assure you it will not be the end, this is not sufficient.” “If you wish to steer away from a regional war, you must end the war on Gaza. This front will develop according to developments in Gaza.” “If Israel strikes Lebanon it will be the most foolish act in all of Israel’s existence.”

US sent message to Hezbollah, warning its ships & planes will attack

Nasrallah related that Hezbollah was warned soon after Oct. 7 that US ships and war planes positioned in the Mediterranean would bombard southern Lebanon if Hezbollah fighters escalate attacks on Israel.

But Nasrallah said, “We will continue to infiltrate” and that Hezbollah’s calculus will be “a civilian for a civilian” – meaning that attacks from southern Lebanon will be determined based on the intensity of Israel’s attacks on Palestinians.

On prospect of major regional war

“To the Americans I say, focusing your threats on Hezbollah and the region are pointless,” Nasrallah said. The US said it “would not only attack Lebanon but will attack Iran.”

“Your fleets in the Mediterranean do not and will not cause us to fear. We have prepared for your fleet what it takes. You Americans remember your defeats from Lebanon (early 80s), Iraq, and Afghanistan... your humiliating retreat from Afghanistan. He praised the recent attacks by Iraqi Shia militias against the US based in the region. “If an all out war erupts your fleet will be no good, your warplanes will be pointless, you will pay a heavy price.”

America oversees aggression on Gaza, and can stop it “Only you Americans can end what is happening now in Gaza, since you started it. The only factor that will affect our position is the progression of the war.” US is “directly responsible”. “I tell Israel: Do not go any further. Many civilians have already died. I promise you: A civilian for a civilian.”

Hezbollah attacks have forced Israel to pull military assets

At one point in the speech he laid out that Hezbollah’s daily missiles and shelling of northern Israel (which have remained limited) have served to force Israel to deploy up to one-third of its military hardware and assets to its northern border. Nasrallah explained that in doing so, Israel is not prevented from focusing its full firepower on attacking “resistance factions” (Hamas and PIJ) in Gaza.

More notes from the speech via Bloomberg:

- * “We have to be ready and present for all future probabilities”
- * Attacks on Israel near Lebanon borders “is very big from our side and very important and it won’t be enough for us anyway.”

- * The group is aware it’s taking a risk in the daily border attacks against Israel.

- * Israel was forced to deploy heavily on the border with Lebanon, taking away from its fight in Gaza. Says the Oct. 7th attack on Israel was purely Palestinian decision and execution and “no one knew” about Hamas plan

- * The US is “directly responsible” for Israel attacks on Gaza

- * Israel will fail in wiping out Hamas as it failed in 2006 with its aim to wipe out Hezbollah

- * Praises “martyrs” in Lebanon and elsewhere who were killed in fighting against Israel since the conflict began
- * Dying in fight against Israel is “greatest of all”

- * “Just watch how a fighter advances and places a rocket on an Israeli tank. How can they defeat this land and these types of fighters?”

- * Previous and future sacrifices in Gaza, West Bank and all fronts are worth it

- * Hamas attack showed Israel’s vulnerability and weakness strategically

and militarily to the point that the US sent its ships to the Mediterranean at the onset of the attack

At 3 p.m. Lebanon time (9am ET), the leader of Hezbollah Hassan Nasrallah will give his first speech since the war between Israel and Hamas began, at a moment Israel is on a very high state of alert along its northern border.

Secretary-General Nasrallah’s speech could prove a turning point in the whole conflict depending on whether he tells his many tens of thousands of hardline Shia troops that a full war front will be opened against Israel. Will broader regional war kick off? Watch the speech live from Beirut: The US, Israel, and various Lebanese political factions have warned and urged Iran-backed Hezbollah not to escalate the conflict with Israel.

Further Israeli officials have warned of military strikes on Hezbollah’s key backers in Damascus and Iran should it escalate the war along Israel’s northern border.

How Blinken and Company Laid the Groundwork for the Hamas Attack

Banner headline events almost always flow from quieter real-life causes, and the worst attack on Israel in fifty years is not an exception. The coordinated raids and massacres on October 7 were possible only because of more subtle interventions over two and a half years in rooms at the State Department and the White House, with indirect help from nonprofits like the Soros-funded International Crisis Group. These interventions were driven by a small network of government and interest group insiders whose actions have gone unreported in establishment media. Though their further consequences aren't yet clear, they'll almost certainly involve a push to weaken both Israel and an Israeli government resistant to accords with Iran.

The interventions flowed from one motivation: the State Department's determination to achieve a "reset" with Iran, restoring the consensus reached at the end of the Obama Administration through its 2015 nuclear deal. This was the main priority of high-level department staff, including Robert Malley, whose family history as well as his work at the International Crisis Group align him with pro-Iranian movers, and the recently-retired Wendy R. Sherman, whose legacy is the 2015 deal. These players, along with National Security staffer Brett McGurk, had been crucial in pushing the Obama-backed alignment with Iran. In the Biden Administration, working under Secretary of State Antony Blinken, they have had a supportive superior: a low-key gladhandler

who has made his career supporting whatever establishment foreign agenda is teed up for action. In this case, that foreign agenda, perhaps at the urging of ex-president Obama, has been bringing Iran back to the negotiating table by reducing Israel's power in the region while sidelining Netanyahu, an ardent opponent of negotiations.

From Washington, these players have run a concerted effort in that direction. Peace negotiations or conversations with Iran continued consistently even as more evidence surfaced of Iranian aggression. Malley used his influence to help install a likely Iranian operative first at the State Department and then at the Pentagon -- part of a larger infiltration of agents, several of whom have links to the International Crisis Group. Antony Blinken announced the American-pushed ceding by Israel of miles of potentially resource-heavy land to Lebanon, much of which is controlled by Hezb'allah, a proxy for Iran. And, in the face of August videos of Hezb'allah-trained fighters engaged in war games training, U.S. officials urged Israelis to "de-escalate" and discuss "border demarcation."

The Administration also tried to broker a normalization proposal between Israel and Saudi Arabia

that included "dealing with" the Palestinian issue: a rebuke to the Trump Administration, which had bypassed Palestinian leadership in the Abraham Accords. As occurred during the Obama Administration, Biden officials assured reporters that "there was 'a common understanding' among all the leaders in the region" that the Palestinian issue was key to normalization with Israel -- despite events during the Trump Administration proving this untrue. Still, this false claim had its own strategic logic, since linking Saudi-Israel normalization to an unlikely peace with the Palestinian leadership diminished the possibility of that normalization and kept Iran, which opposes it, at the negotiating table.

There was the push in Israel proper against Netanyahu, ostensibly meant to stop Netanyahu's coalition from limiting the discretionary powers of Israel's Supreme Court, which even non-supportive observers think is merited after the Court's 30-year aggrandizement of power. In practice, it meant Blinken and Biden directing heavy public criticism at Netanyahu's government and using American funds to support protests which paralyzed the country, drawing members of its security services into politics even as they vouched for the fact that Israel's border with Gaza was secure.

These moves had real consequences on and after October 7. Hamas's tactics were similar to those broadcast in the Hezb'allah war games a few months earlier. Reports indicate that Israel's cyber defense system was compromised -- a suggestive fact when it's backlit against Iranian permeation of American defense networks. Hezb'allah, more secure since the U.S.-backed Israel-Lebanon agreement last year, launched rockets at Israel after Hamas's invasion.

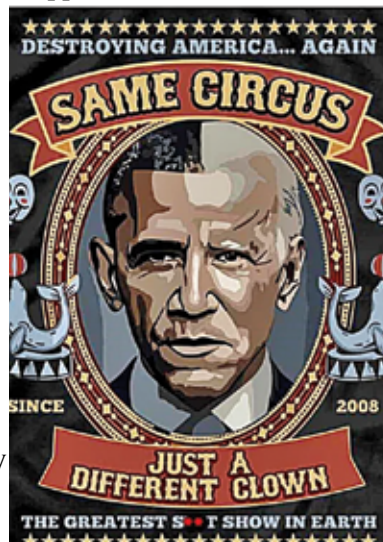
Finally, in the wake of the attack, the Palestinian "issue" is in the forefront, Netanyahu is weakened, and Iran's hand in the region is strengthened. Already, the Administration is pushing to maximize these results. The White

House is leaking its concerns that an Israeli attack could lead to a "regional conflagration" -- an early justification for limiting Israel's response. In the face of a Wall Street Journal report alleging Iranian involvement in the planning of the attack, The New York Times reported anonymous American officials claiming that "key Iranian leaders were surprised by the Hamas attack." Israel and the United States are gearing up for a campaign against Hamas that's explicitly compared to its campaign against ISIL -- one that in the hands of Robert Malley and Brett McGurk ended up strengthening Iran in 2015.

All the while, as explicitly pro-Hamas support surfaces and is condemned, establishment media's rhetorical push favors neither Israel nor its government. Reports and interviews in the Times and on MSNBC have insinuated or outright argued that Gaza's undeniably immiserated reality made the crisis inevitable. The Times has focused on the fact that "severe divisions in Israel over a judicial overhaul" encouraged the attack and gone so far as to suggest that the Abraham Accords caused the attack by antagonizing Palestinians. The New Yorker has emphasized the Netanyahu government's lack of preparation and Palestinians' desperation. Finally, when foreign networks in Washington do get reported on, they're not Iran's.

One of the reasons these narrative lines can get pushed is the selective silences of people, mostly Democrats and neo-conservatives, who have long called themselves Israel's friends but whose domestic loyalties are to the think tank and administrative nexus which helped make the attack possible: the one which effectively took power a quarter century ago and which has pushed the Middle East from one disaster to the next ever since. These establishment loyalists are ready to criticize institutions for failing to condemn support of Hamas, but not to admit that the roots of the attack on Israel go deeper: towards the heart of an establishment that has systematically made itself unaccountable to the American people and hospitable to ideologues running radicalisms inside it. Until these players acknowledge this and address it, they're enabling it.

The Clintons, Qatar and the Israel Massacre

It's not easy to understand the Middle East, but one facet can be found in following the money. One open-wallet nation, Qatar, has been chummy with both Hamas terrorists and U.S. politicians. Our chief investigative reporter Micah Morrison provides the details in our Investigative Bulletin about Qatar's connections with a former U.S. president and a secretary of state.

Shortly after the world began learning the details of the massacre of Israeli civilians on October 7, Hillary Clinton published a note of support on X for "everyone affected by the horrific attacks by Hamas" and expressed "strong support of our ally," Israel. The former secretary of state had nothing to say about one of Hamas's key allies, the energy-rich kingdom of Qatar, and not surprisingly: Qatar is not only an important friend of the U.S. in the region but also for many years was a generous patron of Bill and Hillary Clinton. As Judicial Watch President Tom Fitton noted on X, Qatar funneled money to the Clintons when Mrs. Clinton was secretary of state and she "hid this until disclosures from Wikileaks and pressure from Judicial Watch forced her to admit to tens of millions of previously hidden foreign cash payments to 'Clinton Inc.'"

Slipping money into the hands of slippery politicians—a time-



ongoing state support for a murderous terrorist organization. But the Clinton experience does provide a snapshot of the Qatari influence operation and a warning about what Qatar may be up to elsewhere, including in the United States.

The Qatar-Clinton money trail begins around 2008, when the Clinton Foundation—under pressure due to Mrs. Clinton's imminent ascent to State Department leadership—published a list of donors. Among them: Qatar, listed as contributing between \$1 million and \$5 million. A Clinton Foundation spokesman later acknowledged that Qatar had been sending the Clintons money "since 2002."

Pressure mounted on the Clintons in 2014 with the publication of a Judicial Watch investigative report disclosing that Bill Clinton had earned upward of \$48 million in speaking fees around the globe, including from Arab countries, while Mrs. Clinton served as secretary of state. "Former President Clinton trotted the globe collecting huge speaking fees while his wife presided over U.S. foreign policy," Tom Fitton noted at the time.

In 2016, a leaked Wikileaks email revealed that five years earlier, in 2011, the Clintons had received a \$1 million gift from Qatar. That gift was never reported by the Clintons, a clear violation of the disclosure agreement the Clintons had signed with the State Department when Mrs. Clinton took the helm. Soon after the 2011 gift, a high-ranking Qatari official pressed the Clinton circle for "five minutes" with the former president.

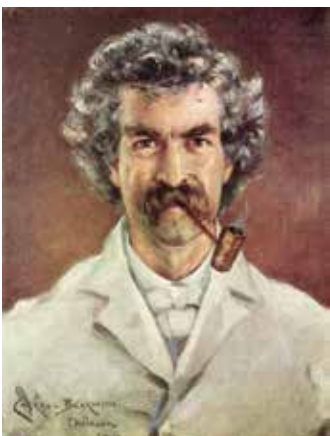
Judicial Watch Freedom of Information Act (FOIA) lawsuits also turned up more evidence of Clinton conflicts of interest, including the courting of Qatar. A Judicial Watch FOIA disclosure in late 2016 revealed a list sent by a Clinton Foundation senior adviser to a high-ranking aide to Secretary of State Clinton; the list noted more than 200 foreign leaders to be invited to the 2009 Clinton Global Initiative annual meeting, including the emir of Qatar, the Qatari prime minister, and the minister of foreign

affairs.

Qatar's pursuit of influence in the United States is not limited to the Clintons and their allies. According to investigative reports, Qatar has given \$1 billion to American universities since 2011. Qatar also is a major purveyor of anti-Semitism. Its media is filled with anti-Semitic and anti-Israel propaganda. And at the UN—not exactly a bastion of pro-Israel sentiment—a high-ranking Qatari official was recently denied a senior post on the grounds of anti-Semitism. That's useful context when considering Qatar's role supporting Hamas.

Here at Judicial Watch, we're watching Qatar closely. At home, with concern rising about anti-Semitism on U.S. campuses, we won a recent lawsuit forcing disclosure of information about Qatar's funding of American universities. Abroad, with lessons learned from our Clinton investigations, we're following the flow of Qatari money. We'll keep you updated.

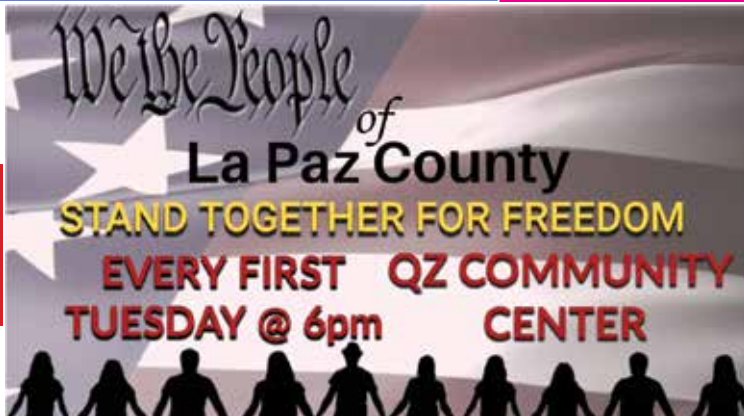

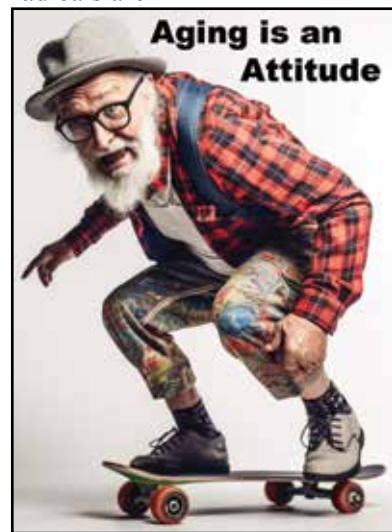
I'm presenting a lot of information that every person needs to be aware of. So please read the entire article. Then, pass the information on to everyone you feel would be interested. Thank you.

greater profits while destroying the health of the consumers. Low fat milk is a serious consumer trap. This concept has been sold to the American public as a healthy alternative to whole milk. 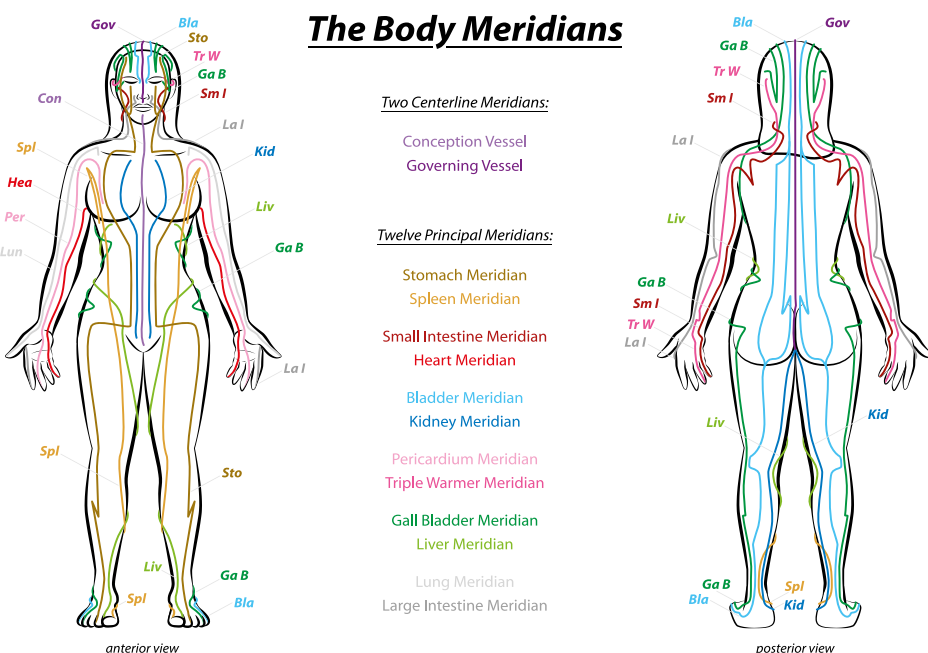

Can a Herbal Compound Work just as Well as the World's Top Blood-Sugar-Lowering Pill?

Berberine facts

Berberine is a yellow-colored compound found in several plants, including barberry, goldenseal and Oregon grape. It's traditionally been used as a remedy for diarrhea in China, but ever since researchers accidentally discovered its hypoglycemic (blood-sugar-lowering) effects, there's been a lot of interest in berberine as an antidiabetic agent.

Promising studies

A number of clinical trials have found berberine to be an effective treatment for type 2 diabetes. In one involving 116 type 2 diabetics with high cholesterol, those receiving 1 g/day of berberine saw significant reductions in their hemoglobin A1c (HbA1c) levels compared with those taking a placebo. HbA1c levels reflect blood sugar control, and so are used to diagnose and manage diabetes. The berberine takers also had reduced levels of cholesterol and triglycerides (fats) in their blood, which are usually raised in type 2 diabetics.

In another placebo-controlled trial, berberine was able to lower levels of free fatty acids in the body---known to be toxic to the pancreas and to cause insulin resistance. "Berberine might play a pivotal role in the treatment of type 2 diabetes", the researchers concluded.

Berberine vs metformin

Berberine has also been pitted against the diabetes drug metformin---with impressive results. In a small 'pilot' (preliminary) study, 36 newly diagnosed diabetics were given either 500 mg of berberine or metformin three times a day. After three months, both treatments worked equally well for blood sugar control: levels of fasting blood sugar, postprandial (after eating) blood sugar and HbA1c were all significantly reduced. But berberine had additional beneficial effects

on total cholesterol and triglycerides that metformin didn't.

In a larger trial, berberine not only had a blood-sugar-lowering effect on a par with metformin, but the herbal compound was also just as effective as the antidiabetic drug rosiglitazone (Avandia). "We strongly suggest berberine as an ideal medicine for type 2 diabetes," the researchers stated.

How might it work?

A number of lab studies support these findings and also suggest the possible mechanisms behind berberine's hypoglycemic effects. Some studies point to its ability to boost insulin secretion, while others suggest that its anti-inflammatory action might be key.

According to one group of scientists, berberine's effects on blood sugar may be a side-effect of its antimicrobial activity. They reckon that the herbal compound may be killing off certain gut bacteria that play a role in inflammation and insulin resistance.

Safety and side-effects

In general, berberine appears to be safe, although it can cause minor stomach problems like bloating, constipation and diarrhea. But these tend to be resolved by reducing the dosage.

In contrast, metformin is associated with a potentially life-threatening condition called 'lactic acidosis'---a buildup of lactic acid in the blood. Although rare, it has a death rate of 30--50 % so metformin now comes with a warning about acidosis as well as a laundry list of contraindications (conditions

in which the drug should not be used because of possible harmful effects). More common adverse effects include vomiting, diarrhea, abdominal pain and taste disturbances.

Rosiglitazone, the other drug berberine has been compared with for efficacy, is actually no longer

on the market in Europe because it increases the risk of heart attack and stroke.

But there are some concerns with berberine too. It hasn't been studied as much as metformin and

other drugs and, so far, it's still not known whether it's safe to take for diabetes in the long run. There's also the potential for the compound to interact with other medications.

Reviewing the evidence

Berberine seems just as effective as metformin for lowering blood sugar in type 2 diabetics, and has the added benefit of improving fat metabolism. This, coupled with its good safety profile, makes berberine a promising alternative to the diabetes drug, especially as metformin has numerous contraindications.

But the research is still in its early days, with most of it being done in China, so we still need to see how berberine fares as a long-term treatment in different ethnic diabetic populations.

If you do wish to try berberine to treat your type 2 diabetes, you should do so only under the supervision of a qualified, experienced medical herbalist, who can advise on the proper dosages and on drug interactions.

But don't forget the importance of diet and exercise - especially if you're on the cusp of developing type 2 diabetes. The evidence is clear that lifestyle changes can be even more effective than metformin in stopping 'prediabetes' from becoming full-blown diabetes.

Who will benefit from berberine?

Those with prediabetes and those who are insulin resistant. How do you know if you're insulin resistant from bloodwork? Increased cholesterol, high LDL, Low HDL, high triglycerides, high glucose, high insulin, and the most important factor is high Hemoglobin A1C. Eliminating simple sugars and grains will also complement the use of berberine for these patients. Medications like Statins, Beta blockers, Lasix, and steroids are well known to cause diabetes too. Your GENES aren't your destiny, your lifestyle is.

Hemp vs. CBD: Everything You Need to Know

Are you wondering about the differences between hemp and CBD oil? How do hemp and marijuana differ? With so many new hemp products on the market, conscientious consumers want to pick the best supplements made with the highest-quality processes and ingredients. If you want to learn how to distinguish between all the terms and products — or just see what all the excitement is about — read on.

People have used hemp (Cannabis sativa) since ancient times for its incredible health benefits. This diverse plant has thousands of uses and people used it — legally — for centuries. Early Americans grew the fast-growing plant for textiles and rope due to its stronger-than-steel stalk. But in 1970, due to political pressure, the Controlled Substances Act outlawed both hemp and marijuana in the United States. Companies still sold hemp products after then — you might have seen hemp shirts or jewelry or hemp seed hearts — but they came from imported sources.

With the passing of the 2018 Farm Bill (Agricultural Improvement Act), farmers can once again grow hemp in the U.S. Companies can also sell hemp throughout the country. As a result, you suddenly see thousands of hemp products like CBD or hemp extract on the market — and with them, a lot of

possible confusion.

Let's break it down.

The Beneficial Compounds in Cannabis

Hemp and marijuana are different forms of Cannabis. While all hemp comes from Cannabis sativa and contains low levels of



THC, marijuana is bred for high THC and can be Cannabis sativa or indica. THC is the compound responsible for the psychoactive effects that people experience. Farmers breed hemp to have low THC content. In fact, the law classifies hemp as any Cannabis sativa containing 0.3 percent or less THC.

The hemp plant contains many natural chemical compounds, including the phytocannabinoids it's famous for. These natural substances stimulate the body's endocannabinoid system, which keeps the body in balance (physiological homeostasis).

THC — Tetrahydrocannabinol

Most people have heard of THC because of the "high" it produces when used recreationally.

Marijuana plants contain around 10 percent THC or even greater,

compared to the much lower 0.3 percent or below for hemp. While some states regulate non-hemp Cannabis products, it is not federally legal to sell in the U.S. If a hemp plant or hemp-derived product contains greater than 0.3 percent THC, it would also not be federally legal. On the other hand, full-spectrum hemp products that do contain up to 0.3 percent THC can now legally be sold nationwide. They can also be shipped in the postal mail, used in most public places, and taken on airplanes across state lines (be careful with international travel as other countries have different laws).

Some hemp products contain no THC. These products are considered broad-spectrum — as compared with full-spectrum. Full-spectrum products are recommended because THC in itself is one of hemp's beneficial compounds, with analgesic effects that ease physical discomfort as well as relieve daily stress and anxiety.

CBD — Cannabidiol

The benefits of CBD are impressive! It is most known for its ability to bring relaxation and calm, ease joint discomfort, support a healthy inflammatory response. **On top of that, while CBD promotes an alert calm during daytime, it promotes restful sleep at night.** Growers often breed

the hemp plant for a high CBD (cannabidiol) concentration, besides having low THC. Hemp-derived CBD with less than 0.3 percent THC is now widely sold.

You can also buy non-hemp CBD derived from marijuana, but it's only legal in states with medical marijuana laws and is not federally legalized in any state, so you should not mail it, use it in public, or take it on airplanes. Hemp-derived CBD is perfectly fine in these places.

Other Cannabinoids and Nutritious Compounds

While CBD and THC are best known, Cannabis contains trace amounts of a wide variety of other cannabinoids. These include CBG (cannabigerol), CBC (cannabichromene), and CBN (cannabinol). Scientists are exploring the health benefits of hemp's minor constituents, and the research results show promise.

Hemp contains protein, chlorophyll, fiber, plus many vitamins, fatty acids, flavonoids, antioxidants, terpenes, and a wide variety of synergistic metabolites. In a full-spectrum product, all the plant compounds work together, creating a stronger effect on the body than each would alone. This is known as the "entourage effect." October 12th George Soros international network of foundations worth over \$25 billion started shutting down offices around the world.

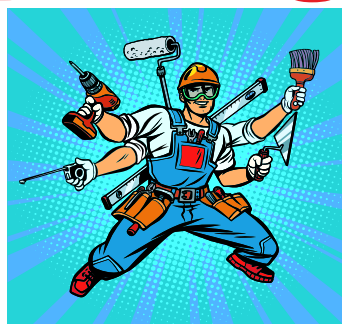
October 13th 800,000 tons of radioactive waste from Pennsylvania's oil and gas industry went missing.

Trump's Colorado Ballot Eligibility Defense is Headed Down the Wrong Path: Legal Scholar

Reacting to the progress so far in a Colorado courtroom where the first real test over whether Donald Trump can be on the ballot next year, retired conservative Judge Michael Luttig suggested the former president's lawyers have failed to confront a pivotal point in the 14th Amendment.

Appearing on MSNBC on Sunday morning with host Ali Velshi, Luttig — who has been one of the leading proponents for banning Trump over his actions up to, on and after the Jan. 6 insurrection — claimed there is just as strong case to ban the former president after the Colorado testimony because the former president's lawyers are misreading a key detail in the constitutional amendment.

"Section Three of the 14th Amendment very simply says that any person who has previously taken an oath to support the constitution of the United States, and thereafter

engages in an insurrection or rebellion against the constitution of the United States, should be disqualified from holding any office under the United States" the retired jurist reminded the MSNBC host.

"I've read some of the transcripts, I've read reports about the arguments that have been made this week in both Colorado and Minnesota — even more specifically, I've read some of the questioning by the judges from the bench," he continued. "It seems to me that, frankly, all parties to these different litigations in the various states, to this point, have misunderstood Section Three of the 14th Amendment."

"As I've said, it disqualifies one who is engaged in an insurrection

or rebellion against the Constitution of the United States of America, it does not, by its terms, disqualify one who engages in an insurrection or rebellion against the United States, or the authority of the United States," he asserted, "There is a world of constitutional difference between those two."

"It is, of course, to the former president's advantage for his lawyers to argue that Section Three disqualifies anyone who engages in an insurrection or rebellion against the United States; that's not what Section Three actually says," he elaborated. "But in both litigations, Ali, both parties have focused on almost exclusively whether the attack on the United States Capitol on January 6,

constituted an insurrection or rebellion against the United States."

"Unfortunately, at least as far as I have seen, the challenges to the president's qualifications to hold a future office have essentially bought into that wrong argument by the former president's lawyers," he continued. "They, for their part, have tried to establish that the former president did not incite or participate and an insurrection against the United States. The compelling case under Section Three for the former president's disqualification is this: his efforts to overturn the 2020 presidential election and remain in power, notwithstanding that he had lost his election, constituted a rebellion against the Constitution of the United States. Specifically, the executive investing clause of the United States Constitution, this very simply prescribes that the term of the president of the United States extends for four years, and four years only, unless he is elected, or reelected, by the American people."

The original copies of the Old Testament were written in Hebrew and Aramaic, the Apocrypha in Greek and Latin, and the New Testament in Greek. Stop Con-Con Aggregation Scheme in Congress: H.Con.Res. 24 & S. 810

URGENT: The U.S. House Judiciary Subcommittee on the Constitution and Limited Government (chaired by now-Speaker of the House Mike Johnson) recently held a hearing on “Examining Proposed Constitutional Amendments” — including those proposed via the Article V constitutional convention method. Republicans in the U.S. House are increasingly falling for a disastrous Article V convention, which could reverse the existing Constitution’s limitations on government power and interference.

Members of Congress have introduced a resolution to call an Article V Constitutional Convention, or Con-Con. If enacted, this would decimate the Constitution and the God-given individual liberties that it protects. Deceptively, the resolution aggregates old, rescinded, and unrelated state legislative applications to Congress for a convention.

House Concurrent Resolution 24 (H.Con.Res. 24) is sponsored by Representative Jodey Arrington (R-Texas) and cosponsored by four other representatives. If passed by the House and Senate, it would call “a Convention for proposing amendments to the Constitution of the United States for a date and place to be determined.”

Importantly, H.Con.Res. 24 deceptively reaches the 34-state threshold for calling a convention by aggregating “Balanced Budget Amendment” (BBA) applications with unrelated — and in many cases, centuries-old — applications for a plenary convention. The

resolution states:

Whereas congressional and State records of plenary applications for amendments on any subject and applications for the single subject of Inflation-fighting Fiscal Responsibility Amendments compiled by the Article V Library counts Nevada’s “continuing” application, reported February 8, 1979, in the Congressional Record, as the 34th thus achieving the “two thirds” congressional mandate to call the Convention for proposing amendments; congressional records reported 39 applications by the end of 1979, 40 in 1983, and 42 total applications over time.



Despite mentioning “Fiscal Responsibility Amendments” (FRA) in its preamble, H.Con.Res. 24 does not limit the scope of the convention to only BBA or FRA Con-Con applications — there is nothing stopping Congress from considering any other topic in the Constitutional Convention it would call under the resolution.

Several of the aggregated applications have either been rescinded or have already seen their objectives met — they should be ineligible to be counted in any manner whatsoever.

S. 810, sponsored by Senator Mike Braun (R-Ind.), has been introduced. This bill would require the U.S. House Clerk and the U.S. Senate Secretary to make it easier for people to find and view each application for an Article V convention. Although S. 810 sounds innocuous, Sen. Braun stated in a press release supporting a similar bill in the previous Congress that such legislation would “help hold Congress accountable to public desire for a Convention.”

The John Birch Society has been warning about this aggregation scheme. Delegates to any constitutional convention possess the inherent sovereign right of the people at large to propose any amendments or an entirely new constitution, as was the case in the original Convention of 1787. In other words, any Constitutional Convention under Article V cannot be limited.

In a 1982 interview with the Los Angeles Times, President Ronald Reagan said, “Well, constitutional conventions are kind of prescribed as a last resort, because then once it’s open, they could take up any number of things.” He was right. A Constitutional Convention, under Article V, could reverse the existing Constitution’s limitations on government power and interference. Furthermore, the aggregation scheme decimates any possible notions that the convention would be “limited” or confined to a single subject or amendments.

Every so-called “balanced budget amendment” proposal includes loopholes or escape clauses that would easily allow Congress to continue to increase spending and/or raise taxes. In other words, these amendments would make an unbalanced budget constitutional!

Commenting on H.Con.Res. 24, one Con-Con proponent claimed the resolution was “designed to restore federal fiscal sanity.” However, as shown above, this claim is false. Rather, all Congress needs to do is to end its wasteful and unconstitutional spending; if it does this, federal spending would likely decrease by at least 80%, thus quickly eliminating our nation’s fiscal problems.

Things They Didn't Teach You in Church: War Against Children

As the sun rose on the first Saturday in October, a party in Israel, which had begun around 10 pm the night before, was still in full swing when several small black dots appeared in the morning sky. As the dots got closer, it became clear they were motorized paragliders approaching from Gaza in the west. Survivors reported that it seemed like only a few moments before dozens of Hamas fighters opened fire on the young Israelis at the music festival celebrating Sukkot. Video on social media showed gunmen descending in paragliders, plunging into the panicked crowd, mowing down fleeing attendees with bursts of automatic fire. Many victims were shot in the back as they fled.

The festival was held in a dusty field outside the Re'im kibbutz, about 3 miles from the wall that separates Gaza from southern Israel, and authorities say it was the worst coordinated assault on Israeli civilians ever carried out by Hamas militants. Israeli emergency services said more than 260 bodies were recovered from the site of the festival. The death toll rose as teams continued to clear the area.

A former employee of the Israel Defense Forces, Mr. Karplus, said many of the fighters, who also arrived in trucks and on motorcycles, were wearing body-armor and firing AK-47 assault rifles and rocket-propelled grenades. Karplus escaped and hid in a building. "We heard them going from door to door, and in a few hours, they could have found us, but they didn't know we were there." Karplus said that eventually, Israeli soldiers and police arrived, and he was taken to the hospital for treatment.

There are many videos, taken and posted on social media, recording the carnage that took place. Video released by CNN shows militants taking hostages from the music festival, and medics, international human rights organizations, and journalists have documented Hamas militants killing women, children and the elderly in their attack. The killing of babies and small children are the most horrific



acts caught on video. Reuters reported that U.S. Secretary of State Blinken, who flew into Tel Aviv, told reporters he was shown photographs and videos of a baby riddled with bullets, soldiers beheaded, and young people burned alive in their cars and hideaways.

Israeli Defense Minister Yoav Gallant played a video for NATO and stated, "Children were tied up and shot." Images of the dead infants were included in the video played to NATO and the New York Post reported Hamas terrorists slaughtered at least 40 babies and young children, decapitating some of them. This might sound unheard of in the history of mankind. You might be surprised, but it is not.

The Bible tells us of an incident where Pharaoh ordered all male children of Israel to be killed in the Book of Exodus chapter 2 verses 8 thru 22 but Moses was hidden by his mother and eventually saved and protected by Pharaoh's own daughter, when she found him in the river and raised him as her own son. But that is not the only example of attempted child genocide documented in the Bible. Both Pharaoh and Herod believed if they could kill the young of Israel there would be a whole generation of Israelites missing from society that would not be able to challenge their power.

In the Book of Matthew chapter 2 King Herod ordered the death of all male children 2 years of age and un-

der, for the same reason Pharaoh did, both leaders saw the children of Israel as a threat to their power. It is hard to imagine there is any other reason for the intentional slaughter of Israel's young today. Herod found the birth of Jesus especially threatening and in Matthew chapter 2 he interrogated the wise men and his chief priests trying to determine where the Messiah would be born. Then in verse 8, speaking of the wise men,

8 And he sent them to Bethlehem, and said, Go and search diligently for the young child; and when ye have found him, bring me word again, that I may come and worship him also.

Herod didn't want to go worship Christ, he wanted to kill the Messiah who he saw as a threat to his power, but God is in control. Verse 12 reads:

12 And being warned of God in a dream that they should not return to Herod, they departed into their own country another way.

It happened again in Nazi Germany. According to the United States Holocaust Memorial Museum when the war in Europe ended, 1 to 1.5 million Jewish children were dead, they were victims in the Nazis' calculated program of genocide. Jewish children died from starvation and exposure because of a lack of adequate clothing and shelter, but children, especially twins, were also used in concentra-

tion camps for medical experiments that often resulted in the deaths of the children. A former Auschwitz concentration camp prisoner no. 26281, Stanisława Rachwał née Surów, testified: "Next to the crematoria were deep pits intended for burning those corpses... small children who arrived in transports at night were loaded into dump trucks, driven to the pits and "spilled" alive into the pits... The pits were already burning when the children were being thrown in." It all sounds way too familiar.

In each case, the target of the child genocide was Israel, just as it is today. The Nazis didn't limit the child genocide to Jewish children however, Romani children were victims of a "euthanasia" program, and most children of Lidice and many in the Soviet Union were murdered. According to the History Web Site, on October 10, 1944, 800 Romani children were systematically murdered, gassed to death on that one day at Auschwitz. There is another similarity between what we see happening today and what happened in Nazi Germany.

According to The Times of Israel the radical Islamic Arabs were Germany's natural friends, Haj Amin al-Husseini told the Nazi leader in 1941, speaking for the Arab nation and the Muslim world, that they had the same enemies, namely the English and the Jews. In a meeting between Adolf Hitler and the Grand Mufti of Jerusalem, Haj Amin al-Husseini, on November 28, 1941, at the Reich Chancellery in Berlin, the Muslim world sought an alliance with Nazi Germany and Fascist Italy. Muhammad Amin al-Husayni was the Mufti (Chief Muslim Islamic Legal Religious Authority) of Jerusalem during WWII. Who knew? In 1935, the Persian government changed the name of the country from Persia to Iran!

The Mufti observed that the Arabs had acted in reaction to a direct English assault upon their honor. Again, it all sounds way too familiar.

Sadly, as a foot note, the attempted Child Genocide of the Jewish race is not confined to Radical Islam, according to USA Today, 83% of adult Jews say abortion, in all or most cases, should be legal.
