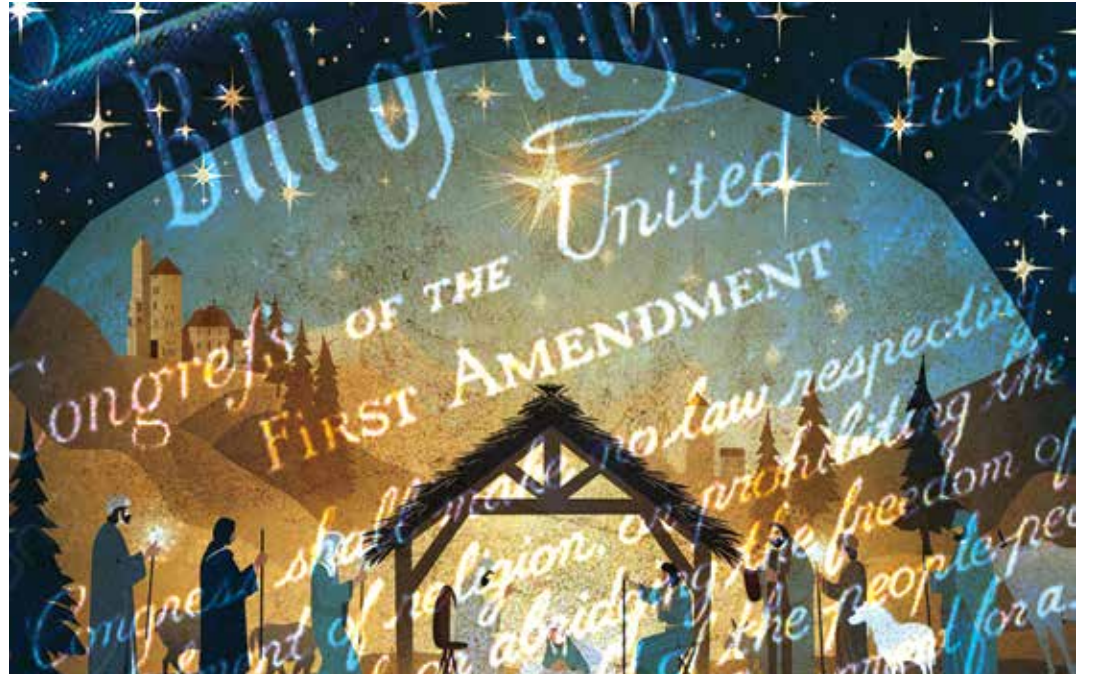
Constitutional Q&A: The Twelve Rules of Christmas

The Christmas season is unquestionably the most festive time of the year for Americans, celebrated across the nation by persons of all walks of life and political beliefs. Even those without strong religious beliefs join in the festivities of a season dedicated to sharing, helping the less fortunate and striving for peace in the world.

However, the goodwill of the Christmas season has been squelched in many public schools, where uninformed administrators are turned into Grinches by misguided fears that the law requires anything religious be banned from public schools. Over the years, The Rutherford Institute has been contacted by parents and teachers alike concerned about schools changing their Christmas concerts to "winter holiday programs" and renaming Christmas "winter festival" or canceling holiday celebrations altogether to avoid offending those who do not celebrate the various holidays.

Examples of the purging of Christmas from our schools abound:
 * A Minnesota charter school banned the display of a poster prepared to promote the school's yearbook as a holiday gift because the poster included the word "Christmas";
 * Traditional Christmas songs, such as "Joy to the World" and "Silent Night" have been banned



from holiday concerts by a New Jersey school district. The district justifies the ban as needed to avoid violating the "separation of church and state," even though it is clear that religious music can be performed in public schools;
 * A teacher in Texas who decorated her door with a scene from "A Charlie Brown Christmas", including a scrawny tree and Linus, was forced to take it down. She was told by her principal that some students might be offended or feel uncomfortable.

Students asked to send seasonal cards to military troops have been told to make them "holiday cards" and instructed not to use the words "Merry Christmas" on their cards. Similarly, Christmas trees, wreaths, candy canes and even the colors red and green have been banned as part of the effort to avoid any reference to Christmas, Christ or God.

Hoping to clear up the legal misunderstanding over the do's and don'ts of celebrating Christmas, the following Constitutional Q&A on the "Twelve Rules of Christmas" provides basic guidelines for lawfully celebrating Christmas in

schools, workplaces and elsewhere.

Q: May public school students speak about Christmas at school?
A: Public school students' written or spoken personal expressions concerning the religious significance of Christmas (i.e. T-shirts with the slogan, "Jesus Is the Reason for the Season") may not be censored by school officials absent evidence that the speech would cause a substantial disruption of the orderly operation of the school.

Q: Are public school teachers forbidden from celebrating the holiday at work?
A: So long as teachers are generally permitted to wear clothing or jewelry or have personal items expressing their views about the holidays, teachers may not be prohibited from similarly expressing their views by wearing Christmas-related clothing or jewelry or carrying Christmas-related personal items.

Q: May students be taught about Christmas?
A: Public schools may teach students about the Christmas holiday, including its religious significance,

Things They Didn't Teach You in Church: Be Useful to the Lord

God has a plan, and most Christians have a vague idea it has something to do with salvation, but few Christians have a solid understanding of the actual plan of God. Biblical illiteracy is self-inflicted; the Bible is everywhere. Guidance is sometimes needed, but with the help of a Strong's Exhaustive Concordance, a Smith's Bible Dictionary and a King James Bible you can take any word in the KJV Bible, back into its original language and understand what it meant at the time it was written; a concordance works just like a dictionary. A good Bible teacher is also very helpful, but always check them out in the Word.

Do you know what God's plan is? Do you know how you fit into it? The answers to these questions should be very important to you. It is difficult to imagine being useful in any endeavor if you don't understand what is happening. Our Father has work that needs to be done, His Son gave His life to further God's plan of salvation, and God wants His children's help. Some of His children are useful to Him and work to do His will, but unfortunately many are not.

In Isaiah 47, God warns his children that if they trust in enchantments, sorceries, astrologers, and prognosticators they will be lost. These people are fakes. Then in Isaiah 48, God tells us His prophecies always come to pass, but some of His children are very stubborn, they're more interested in hearing from psychics and fortune-tellers, astrologers, palm readers and career politicians. These people will tell you what you want to hear or what they know will get them more money. God has told us what is going to happen and the events to watch for just before the end.

Isaiah 48: 5 - I have even from the beginning declared it to thee; before it came to pass, I shewed it thee: lest thou shouldest say, Mine idol hath done them, and my graven image, and my molten image, hath commanded them.

An idol can do nothing! God wants us to know they have no power, and He has told us everything we need to know to make it through life. You learn God's plan from His Word, if you don't know the plan you cannot be useful.

Hindsight is usually 20/20, but sometimes it takes History a while to catch up with the truth. If a new "teaching" emerges, the first place you need to start is in the Word. If you can't find it there it's probably not true. For example, in around 1830 many churches and denominations began teaching (for the first time ever) that God's children would not be here for the tribulation of Antichrist. According to the Bible, the false Christ comes first, he deceives most of the people, a few will stand up and testify against him and then Jesus returns. Isaiah 48: 11 - For mine own sake, even for mine own sake, will I do it: for how should my name be polluted? and I will not give my glory unto another.

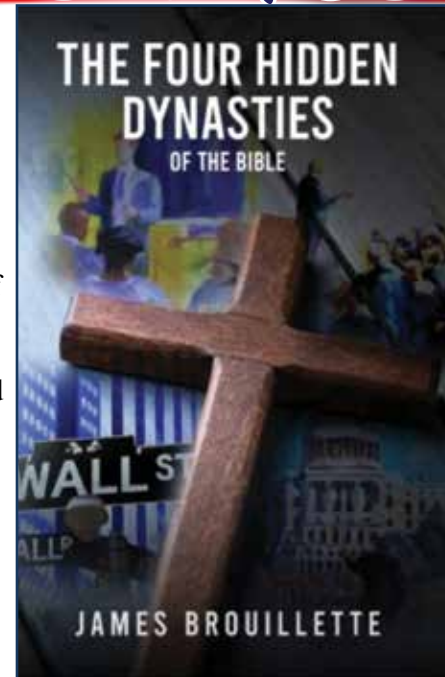
The reason God hardened Pharaoh's heart in the Book of Exodus was so he wouldn't free the Israelites. This led to the unleashing of the plagues upon Egypt which allowed God to show

everyone who the God of Israel is: it was proof of God's power and control. If God had destroyed His people out of anger for what they had done, it would have polluted (damaged) His name with the gentiles (non-believers). It would not have been useful to His plan. God is calling His children to Him (that includes everyone). Jesus opened salvation to all (2 Timothy 3:15).

Revelation 22:13 - Mine hand also hath laid the foundation of the earth, and my right hand hath spanned the heavens: when I call unto them, they stand up together.

God is the creator of heaven and earth and when He speaks, most of His creation stands at attention waiting to do His will. Not some here on earth however; there's one thing God desires but won't make His children do, He won't make them love Him. Forced love is not real love, therefore, His children have free will. God has been in control since the beginning, and with His blessings a person naturally prospers here on earth. Many of God's children prosper because they are useful!

History will repeat itself as long as these bankers and their corrupt politicians are in charge.

Under this fractional reserve scheme, we inevitably become debt slaves to a ruling class of financial elite. Not because they are better or smarter than anyone else, but because they have rigged the system to benefit themselves at the expense of most people on the planet. Catherine Austin Fitz is an expert on this issue. She was an assistant secretary of Housing and Urban Development under President George Bush Senior and then an adviser to the Clinton administration.

Catherine Austin Fitts:

Let's set up a game of Monopoly and you want to buy Park Place. What I can continually do is just print money, give myself more money, lower the value of your money by printing more, no matter how hard working you are, or how successful you are, I can always end up buying you for free.

So how come, if you or I make up money, it's called counterfeiting, but if the banks do it, it's increasing the money supply? How did the banks get this power?

Jekyll Island is where, in 1910, representatives from the Rockefellers, Rothschilds, Morgans and other private bankers gathered secretly to draft the legislation that would create the Federal Reserve. Ed Griffin literally wrote the book on what happened at Jekyll Island.

Ed Griffin:

Central banks are banking cartels which have gone into partnership with the respective governments in the countries where they operate and they've been given monopolistic power over the creation of the na-

tion's money supply. That's what the politicians handed to them as a gift, you might say, for the partnership. Now in return, what did the bankers do for the politicians? They promised to create money out of nothing now they've got this legal power to do it anytime the government needs it.

Since 2008, we've witnessed the greatest fake money printing run in recorded history. This financial sleight of hand disguises the costs, hides who's to blame and leaves us as debt slaves working to pay off the bill. I found it revealing that in the same year the Federal Reserve was founded (1913), The Internal Revenue Service was also established and income tax was then instigated so you and I would have to pay the politician's debt plus interest to the bankers.

Bill Still Writer, Director The Money Masters:

The problem is, we have a privately owned central bank system in the United States disguised as a government owned system. Now if you look at the telephone book here in the Washington, DC area, you look up the Federal Reserve in the blue government pages. It's not there. It's in the white pages right next to the Federal Express. It's a privately owned central bank.

Walter Cronkite interviews Alan Greenspan, former Chairman of the Federal Reserve Walter Cronkite:

What should be the proper relationship between the chairman of the Fed and a President of the United States?

Alan Greenspan:

Well, first of all, the Federal Reserve is an independent agency, and that means basically that **there is no other agency of government which will overrule actions that we take.**



Catherine Austin Fitts:

We have a private bank that prints money on behalf of the Treasury. The Federal Reserve prints money on a debt based system which creates scarcity, but it puts a group of insiders in a position of having access to all the data about the economy when we don't. So you have a small group of bankers who understand the data and how money works in the economy. It gives them the ability to print money in a way that the insiders are protected and everybody else is drained.

Catherine went on to compare a healthy economy to a vibrant Taurus balanced, freely flowing and energized throughout, in contrast to what's happening in the current economy.

Catherine Austin Fitts:

What you have is a system that's very dynamic, and it's trying to optimize but intertwined in the core of it you have a tapeworm. The way a tapeworm works in your body, is that it injects a chemical into your body that makes you crave what's good for the tapeworm and bad for you. You have a parasite that's very much manipulating and engorging itself at the expense of the whole.

We live in a tapeworm economy,

where the financial elite are the tapeworm, and they're feeding on us and they don't like it when people blow their cover.

After Catherine began exposing



government corruption at the highest level, the FBI raided her company and seized its assets. She was dragged through the courts for 10 years before being found innocent.

So we've got the Federal Reserve, a privately owned corporation with a monopoly on creating money but with no accountability, backed up by a government with a monopoly on force. The country got sold on the Fed as an institution that would help stabilize the economy and remain independent of politics. But in fact, in close to a century of existence, the Federal Reserve has done just the opposite.

Since they took charge, we've been robbed through inflation and the purchasing power of the dollar has declined more than 96%. The wealth gap makes it clear - most of the money is going to a very few. Only 16 years after the Federal Reserve was in power, America experienced the Great Depression. My research revealed that before the big crash in 1929, the elite bankers pulled their money out of the stock market. After the crash, they used that money to buy up cheap stocks in smaller failing banks for pennies on the dollar.

Among the bankers who consolidated their wealth this way were the Rothschilds, Rockefellers and Morgans. A similar scenario played out in the 2008 financial collapse with the same bankers benefitting. In the years leading up to the collapse, the biggest banks including Bank of America, Citigroup, and Chase, controlled by the Rothschilds, Rockefellers and Morgans were bundling and trading bad loans that they knew would eventually fail.

It's like putting rotten oranges in a box and selling them as grade triple A. The bundlers of the debt knew it was only a matter of time before someone would open that box and see that the content was worthless, since they were the ones who packed the boxes in the first place. When the rotten oranges (the unsound loans, derivatives and credit default swaps) were finally discovered, everyone was impacted. People lost their homes, their jobs, their businesses and their retirements. Meanwhile, the biggest banks (who created the problem in the first place) were the ones who got bailed out. Why is that? Why would the Federal Reserve give trillions to the banks, even though the majority of Americans were against bailing them out? Why not help those most in need rather than the perpetrators of the financial collapse?

Now this economic cycle of fishing line out fishing line in, lots of units in circulation, pull them in, has been going on for centuries, and it's stolen and accumulated the real wealth of the world into the hands of the few.

At the international level, central bankers use the World Bank and the International Monetary Fund to

Can Milei Really Shut Down Argentina's Central Bank?

The monumental fiscal and monetary hole that Peronists Massa and Fernández have left for Javier Milei is difficult to replicate. Ex-president Mauricio Macri himself explained that the inheritance Milei received is “worse” than the one he found from Cristina Fernández de Kirchner. Peronism leaves a country in ruins and with a massive time bomb for the next administration.

The enormous economic problems of Argentina start with a primary fiscal deficit of 3% of GDP and a total deficit (including interest expenses) exceeding 5% of GDP. Moreover, it is a structural deficit that cannot be reduced unless public spending is slashed. Public expenditure already accounts for 40% of GDP and has doubled in the era of Kirchnerism. If we analyze Argentina's budget, up to 20% is purely political spending. The previous left-wing administration only cut spending on pensions, which were half of the adjustment in real terms, according to the Argentine Institute of Fiscal Analysis.

Massa and Fernández's interventionist policies and price controls have left a shortage of meat and gasoline in a country rich in oil and livestock, demonstrating again what Milton Friedman said: “Will we read next that government control of prices has created a shortage of sand in the Sahara?” We must not forget that the Fernandez administration leaves Argentina with an annual inflation rate of 140% following an insane increase in the monetary base of more than 485% in five years, according to the Central Bank of Argentina.

This confiscatory and extractive fiscal and monetary policies have created a disaster in the central bank reserves. Fernandez leaves a bankrupt central bank with negative net reserves of \$12 billion and a time bomb in remunerated liabilities (Leliqs) that exceed 12% of GDP and effectively means more money printing and inflation in the future, when they mature. With a country

risk of 2,400 basis points, the self-proclaimed “socialism of the 21st century” government has left Argentina and its central bank officially bankrupt, with 40% of the population in poverty and with a failed currency.

Milei must now confront this poisoned legacy with determination and courage. Macri, who suffered from the error of gradualism, recently argued that there was no room for mild measures, and he is right. Milei has promised to shut down the central bank and dollarize the economy. However, can it be accomplished? The answer is yes. Absolutely.

To understand why Argentina must dollarize, the reader must know that the peso is a failed currency that even Argentine citizens reject. Most Argentine citizens already save what they can in US dollars and conduct all major transactions in the US currency, because they know that their local currency will be dissolved by government interventionism. The government has 15 different exchange rates for the peso, all fake, of course, all of which have only one objective: to steal from citizens their US dollars at a fake exchange rate.

The central bank is bankrupt, with negative net reserves, and the peso is a failed currency. Therefore, shutting down the central bank is essential and the country needs to have an independent regulator without the power to print currency and monetize all the fiscal deficit, and it must eliminate the possibility of issuing the insane Leliq (remunerated debt) that destroys the currency today and in the future.

Shutting down the central bank requires an immediate and strong solution to the Leliqs, which will have to include a realistic approach to the



monetary mismatch in a country where the “official exchange rate” is half the real market rate against the US dollar. Taking a bold step to recognize

this monetary mismatch, closing the central bank, and ending the monetization of debt are three essential steps to end a path to the destruction of a country comparable to that of Venezuela. Milei understands this and knows that the US dollars that citizens save with enormous difficulty should flow back to the domestic economy by recognizing the monetary reality of the country making the US dollar a legal tender for all transactions.

The monetary issue is one side of a hugely problematic coin. The fiscal problem needs to be addressed. Milei needs to put an end to the bloated fiscal deficit, and that requires an adjustment that eliminates political spending without destroying pensions. This must involve selling some of the many inefficient and bloated public companies and the excess spending in purely political subsidies. Secondly, Milei must put an end to the ridiculous trade deficit. Argentina must slash the misguided protectionist and interventionist laws if the Peronists are open to the world to export all they can. To do this, it

needs to put an end to the ridiculous “currency exchange rate clamp” and the 15 false exchange rates that the government uses to expropriate dollars from citizens and exporters with unfair rates and confiscations.

Taxes need to be lowered in a country that has 165 taxes and the highest tax wedge in the region, where small and medium-sized enterprises pay up to 100% of their sales.

Argentina must change what is currently a confiscatory and predatory state. Additionally, bureaucratic barriers, protectionist measures, and political subsidies must be removed. Furthermore, Milei must ensure legal certainty and an attractive and reliable regulatory framework where the ghost of expropriation and institutional theft does not return.

Milei's challenges are many, and the opposition will try to sabotage all market-friendly reforms because many politicians in Argentina became very powerful and rich, turning the country into a new Venezuela.

If Argentina wants to become a thriving economy that returns to prosperity, it needs a stable macroeconomic and monetary system. It must recognize it has a failed currency and a bankrupt central bank and implement the urgent measures required as quickly as possible. It will be difficult but not impossible, and the potential of the economy is enormous.

Argentina was a rich country made poor by socialism. It needs to abandon socialism to become rich again.

As the US Treasury Runs Out of Creditors, Its Options Dwindle

Are the chickens coming home to roost for the US Treasury? As Ryan McMaken noted in a recent Mises Wire article, the United States is in a debt spiral and there's no easy way out.

The problem is multifaceted, but the origin is profligate government spending. While it typically spikes during crises, spending is increasing at an alarming rate even outside of crisis periods. And tax revenues are not keeping up, which means ever-deepening deficits. Government expenditures spiked during the 2020 crisis, but even ignoring those spikes, annual spending has increased by about \$1.6 trillion since 2019, while tax receipts have only increased by about \$600 billion.

The government must borrow to make up the difference, which has led to a mountain of debt. Total public debt has ballooned to over \$32 trillion, which is over 180 percent of gross domestic product (GDP), excluding government spending and transfers.

Due to the unpopularity of price inflation and the inexorable tendency for the market to reestablish interest rates that accord with people's real time preferences, the Fed has allowed interest rates to rise. This, combined with the sheer size of the debt has caused the government's interest payments to increase to unprecedented heights. **In 2020, interest payments were a little over \$500 billion, but they have almost doubled since then.**

Congressional Budget Office projections show that these interest payments will take up ever-larger portions of the federal budget, causing deficits to sink even further. The government will have to use more debt to pay off past debts.

On top of all of this, the US Treasury is running out of buyers for its debt. The Fed, which has always been a ready buyer of government debt with

newly created money, is allowing its holdings of US Treasury securities to roll off its balance sheet. It cannot resume monetizing the debt without exacerbating price inflation, which is still above its stated target of 2 percent.

Like the Fed, foreign governments such as China and Japan are also reducing their purchases of Treasuries, leaving the US with a smaller customer base for its debt. As Robert P. Murphy showed in a recent talk, the proportion of debt held by foreigners has been declining since 2014.

This too-much-supply and not-enough-demand phenomenon came to a head at an October Treasury auction that turned into a fiasco when thirty-year yields reached 4.837 percent and primary dealers, who are required to purchase any leftovers, had to mop up over 18 percent of the auctioned debt. So, everybody's appetite for US government debt is running low, and that includes foreigners, the government's own money printer, and favored financial institutions.

What does this mean for next year, when \$7.6 trillion in government debt will mature? This is almost a third of all of the US's outstanding debt, which means a ton of supply is about to hit this market with already declining demand. Unless the government decides to tighten its belt and dramatically reduce spending (flying pigs are more likely), it will have to replace maturing debt with more new debt.

Here are some possible scenarios:
A financial crisis and official re-

cession occur, which gives the Fed "permission" to flood the economy with new money, lower interest rates, and make another massive purchase of government debt, as it has in prior crises. The issue with this scenario is that

the Fed is still in the throes of its battle against price inflation. Although some economists say that recent official price inflation statistics show that the Fed is done with its rate hikes, measures

of market inflation expectations have remained elevated in the past few months. We could be heading into a 1970s-style stagflation, in which the Fed must choose (according to the conventional Phillips curve framework) between dealing with unpopular inflation and unpopular unemployment. If we are capable of learning from experience, we know what it takes to get out of such a mess: a painful but healthy and necessary correction precipitated by a Volcker-style sharp increase in interest rates.

Treasury auctions continue to founder, leading to a debt crisis. Treasury yields skyrocket as the whole world loses confidence in the US government's ability to repay its debts. It's difficult to imagine such a globally catastrophic scenario, especially since the US has its own money printer. It seems the Fed and the US government would happily choose to inflate as much as necessary to avoid such an outcome.

The US government performs a "soft default," similar to its actions in the 1930s and in 1971, in which the dollar is transformed in such a way as to rescue the government from its debt obligations. In the 1930s, the government devalued the dollar by changing its gold redemption ratio from \$20.67 to \$35.00 per ounce, as well as limiting and prohibiting gold ownership for US citizens. In 1971, Nixon "temporarily" (read: permanently) reneged on the US's promise to redeem foreign governments' dollars for gold. One avenue the US could take along these lines is the implementation of a central bank digital currency (CBDC). A CBDC could be programmed to have negative interest rates and other incentives that would push CBDC holders to buy government debt. Such a tyrannical move would be disastrous for citizens, but the ability to control interest rates, increase tax revenues, and direct and stimulate spending makes this option very attractive to a debt-riddled government that has painted itself into a corner.

Of course, we could see a combination of these unfold in 2024 and beyond. As I stressed in a recent talk, there is a lot of uncertainty surrounding what the Fed will do. We've seen the Fed do many unpcs in just the past two decades. The Fed is used to stretching its own power and scope in ways that nobody fully realized the Fed could or would.

Some things are certain. However, reckless fiscal and monetary policy have put the US government and the economy in this mess - the Fed and the government will use reckless fiscal and monetary policy to try to escape it.

Study: Fast Food & School Lunches Contain Harmful Animal Contraceptives and Antibiotics

Summing up the effects of the greedy and cruel mass industrial scale of meat production in the US (which has an unscrupulous history all of its own) Moms Across America wrote in its October 9 press release: “Due to large, industry, confined animal feeding operation conditions, which include extremely close quarters, unsanitary spaces, and high incidence of disease, most of America's nonorganic meat comes from livestock that is heavily treated with antibiotics, growth hormones, and an anti-parasitic which is also a known aviary contraceptive.”

The extensive testing included 21 of the country's most popular fast food brands, with 42 samples of fast food meals collected from them. The 21 brands include the top 20, as rated by QSR50. They also included In-N-Out

and calories. For this press release, Moms Across America honed in on the portion of the testing focused on the veterinary drugs and hormones results in the top ten brands: McDonald's, Starbucks, Chick-fil-A, TacoBell, Wendy's, Dunkin' Donuts, Burger King, Subway, Domino's and Chipotle.

With a collective annual gross sales of \$134,308,000,000, these food companies can surely afford to find ways to avoid poisoning

their consumers, including our nation's school children. A whopping 30 million school meals are served to our children each day, and for many kids, these contaminated meals are their primary source of nutrition. But alas, looking the other way and coveting its windfall profits, like other corrupt industries, including Big Pharma, the fast food racket is no different. Moms Across America noted that the 2017 salary for the CEO of McDonald's was \$21.8 million, or \$1.8 million a month. Meanwhile, the average fast-food server makes roughly \$25,620 yearly (\$2,135 per month).

Shockingly, 40 percent of the fast food samples contained the animal antibiotic Narasin, which has been shown in animal studies to cause anorexia, diarrhea, dyspnea, depression, ataxia, recumbency, and death and pathologically by degeneration, necrosis, and repair of heart and skeletal muscles. Even worse, 60 percent of the food samples contained the antibiotic.

Monesin, which is not approved by the FDA for human use and has been shown to cause death or severe harm when consumed by humans. The FDA has approved Monevet 90 (Monesin) for use in cattle and goats fed in confinement for slaughter. That fact—knowing that sentient beings are treated in such a manner—is hard to think about. And realizing the deadly poisons entering their bodies is sickening. Even though they declare it poses no risk to humans if used according to directions, the agency warns humans to wear protective clothing, waterproof gloves, and a dust mask when mixing and handling the product. Monovet 90 is toxic and lethal to horses, with acute toxicity progressing so quickly that,

unsteady and immobile, horses die before exhibiting other gross signs. And just like the deadly mRNA jabs, the poisons in our food—the focus here is antibiotics and hormones, but the list is long—are orchestrated by the same deep-state cabal seeking to control the world's population by 2050. Research Shines a Light on the Dark Side of Statins and Cellular Function

Statins are one of the most commonly prescribed drugs in America, with over 40 million adults taking some dosage of them every day. The common belief is that statins safely help lower heart disease risk by reducing cholesterol, but is it true?

Certain studies propose a weak connection between taking statins and the risk of heart disease, while others raise concerns about the safety claims attributed to the popular drug. Additionally, a considerable body of evidence challenges the notion that lower cholesterol levels invariably translate to reduced heart disease risk, questioning the solidity of this scientific premise.

Let's review the safety and potential adverse effects of statins and why they might be woefully overprescribed.

Statins exposed: Shattering the illusion of cholesterol salvation. Statins do exactly what they are chemically designed to do – they lower cholesterol. They do this by naturally reducing the amount of cholesterol your liver makes.

That leads us to the first point – your body makes most of the cholesterol that it has. The evidence that high cholesterol leads to heart disease is not extremely convincing and is based largely on old scientific theories. So, while statins actually lower cholesterol, whether it's valuable is generally not asked.

Several studies have acknowledged that while statins reduce LDL cholesterol, this reduction did not translate into a meaningful reduction in heart disease risk.

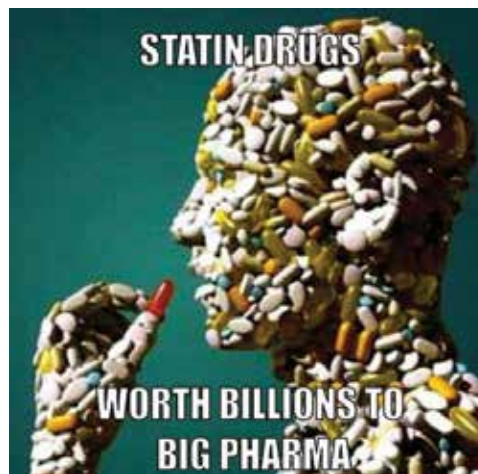
Challenging the narrative: Statin "side effects" are intended consequences

Drug side effects are typically unintended consequences of a medication not part of its mechanism of action to treat a given disease. For instance, low libido is a side effect of many depression and

anxiety medications. Statins cause thinning hair, problems in the eyes, weaker bones, and higher risks of hemorrhage, particularly in the brain, and these are just a handful of the "side effects."

The reality is, however, that these are not side effects of statins – they are a result of the drug functioning as intended. Cholesterol in the blood is needed throughout the body to strengthen cells, and statins reduce the amount of cholesterol the body produces. It also makes the liver better at filtering out serum cholesterol from food.

With less cholesterol, all of the "side effects" of statins become apparent. The damage that statins do looks very similar to regular aging because they block cellular regeneration, so doctors often write off their effects as the patient experiences old age. And with many of the over 40 million statin patients in America being well into their 60s and 70s, you can see how writing off the damage from



statins as old age is problematic.

Old science, new money

Just how many dietary guidelines we use now are based on ancient science? In the same way that sugar is healthy and fat is harmful, the idea that

cholesterol is inherently linked to heart disease is outmoded and overdue for dissection.

The problem is primarily that because statins are so overprescribed, they have become a \$20 billion industry. Statins are a class of drug that does exactly what they say, but we don't question whether or not that's valuable, and so they are prescribed very commonly and very lucratively.

Strategies that actually help your heart: The reality of many modern medical problems is that we live in a society that makes us sick. We are depressed, so we turn to alcohol, cigarettes, or food to take our minds off of how we feel, but these things can be extremely damaging.

One of the easiest things you can do to decrease your risk of heart disease is to stop smoking entirely and limit your alcohol consumption as much as possible. Cutting out processed foods as much as possible is also key to reducing your heart disease risk, and lowering your sugar intake to as little as possible is also key. High sugar consumption is directly correlated to obesity, some types of cancer, heart disease, and type 2 diabetes.

Even through long daily walks, regular exercise helps the body use sugar and reduce systemic inflammation. Strength training increases your heart health, helps keep you trim, increases bone density, and can help prevent fractures as you age.

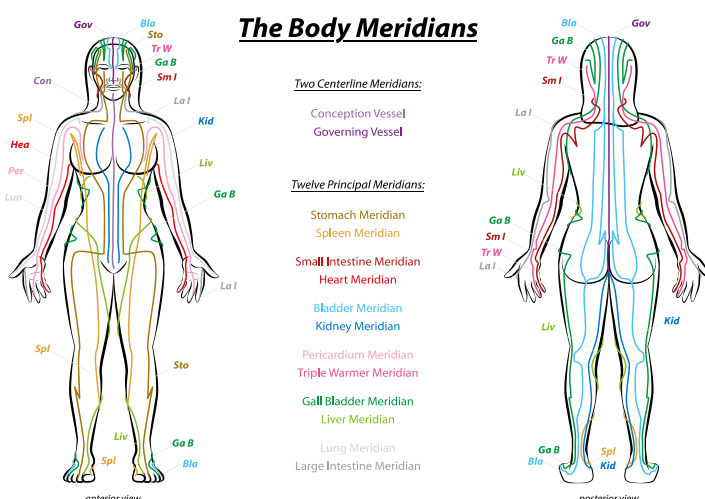
Finally, getting adequate sleep with blackout curtains and no external light can dramatically help our hearts. Poor sleep quality is directly linked to heart disease as well as a multitude of other negative health effects.

If you want to reduce your risk of heart disease, you need to look at your lifestyle habits first before you take an over prescribed drug like statins.

Warning: Ultra Processed Foods Are Not Food – They Are Addictive Like Tobacco

Increasingly associated with an unhealthy diet, most Americans now get the bulk of their calories from highly addictive and highly profitable ultra-processed foods (UPFs, aka highly processed foods, or HPFs). A recent study—which, parallel to big pharma, underscores another avenue of greed and corruption targeting our nation’s health—revealed that highly processed foods like potato chips and ice cream are just as addictive as alcohol or nicotine. What makes UPFs so addictive? The main reason is that, with little digestive effort, they deliver fats and carbs to the gut much faster than minimally processed foods. That in itself may not sound so bad, but void of nutritional value, UPFs are so altered that it can often be difficult to recognize the underlying ingredients.

These convenient, affordable, highly profitable, intensely flavored, aggressively marketed and available everywhere foods are essentially “concoctions of concoctions,” as aptly noted by Bee Wilson of The Guardian. They are engineered from ingredients that are already highly refined, such as cheap vegetable oils, heavily refined flours, whey proteins, and sugars, which are then whipped up into a synthetic food that is made appetizing with the help of industrial additives such as emulsifiers, artificial colors, flavors, and preservatives. More often than not, these unsafe foods contain genetically modified

ingredients that are laden with pesticides. Noting the difference between minimally processed foods and highly processed foods, infectious disease doctor Dr. Chris van Tulleken explained: “If a food’s wrapped in plastic and it’s got something that you don’t typically find in a domestic kitchen, then it’s almost certainly an ultra-processed food. We know that this stuff is addictive. We know it’s now as harmful as cigarettes in terms of the global effects.”

The study, conducted by the University of Michigan and Virginia Tech and published in *Addiction*, used the criteria established for labeling tobacco products as ad-



dictive substances to define HPFs as being highly addictive. In 1988, the U.S. Surgeon General issued a report identifying tobacco products as addictive based on their ability to meet three primary criteria (with a fourth added later) based on their ability to 1) cause highly controlled or compulsive use, 2) cause psychoactive (i.e. mood-altering) effects via their effect on the brain, 3) reinforce behavior, and, 4) trigger strong urges

or craving.

According to study authors Ashley Gearhardt, lead author and U-M associate professor of psychology, and Alexandra DiFeliceantonio, assistant professor at Fralin Biomedical Research Institute at Virginia Tech, the addictive potential for foods

such as cookies, ice cream, potato chips, and french fries may be a critical factor contributing to the elevated public health costs associated with “a food environment dominated by cheap, accessible, and heavily marketed highly processed foods.” The authors concluded that highly processed foods meet the same criteria used to identify

- cigarettes as an addictive substance:
- * They trigger compulsive use where people are unable to quit or cut down (even in the face of life-threatening diseases like diabetes and heart disease).
 - * They can change the way we feel and cause changes in the brain that are of a similar magnitude as the nicotine in tobacco products.
 - * They are highly reinforcing.
 - * They trigger intense urges and cravings.

Without question, poor diets overpowered by HPFs now contribute to preventable deaths on par with cigarettes. They also lead to obesity and depression. The researchers remarked that, like tobacco products, the food industry schemes their HPFs to be “intensely rewarding and hard to resist.” Gearhardt noted that there is no biomarker in the brain to tell people whether something is addictive or not. Thus, identifying that tobacco products were addictive “really boiled down to these four

criteria,” which have stood up to years of scientific evaluation. Pointing out that when the Surgeon General’s report was released more than thirty years ago, tobacco products were the largest cause of preventable death. Gearhardt added, “highly processed foods meet every single one of these criteria.”

Indeed, like industrial tobacco products, which contain thousands of chemicals, including nicotine, HPFs contain complex substances that cannot be simplified into a single chemical agent through a precise central mechanism. Gearhardt remarked that despite the damning report thirty years ago regarding tobacco, many smokers (addicted, no doubt) and tobacco manufacturers refused to accept their harmful and addictive nature. The delay in taking action with practical strategies to address the public health crisis around tobacco cost millions of lives.

Aware of the damage being done by HPFs and striving for immediate action to address the contaminated food crisis as our nation’s health deteriorates, DiFeliceantonio commented that it is time to “stop thinking about highly processed foods just as foods, but instead as highly refined substances that can be addictive.” In a noble move looking out for America’s children, whom the Biden administration and Big Pharma have sorely neglected during the pandemic, Gearhardt added: “When we realized tobacco products were addictive, it made us realize that smoking wasn’t just an adult choice, but that people were getting hooked and couldn’t stop even when they really wanted to. This same thing appears to be happening with highly processed foods and this is particularly concerning because kids are a major target of advertising for these products.”

7. Anything fake, genetically modified or cloned has no essence of life in it. Therefore, it is deadly.

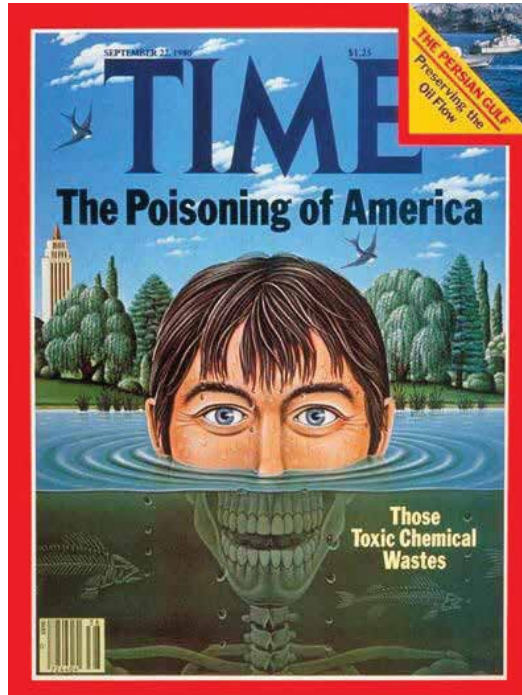
Life is not static. We can, at any moment, be swept away into a radical transfer of reality. Change happens without our permission and usually without altering our behavior.

Unconstitutional Killings

The Biden administration is killing people, openly in Ukraine and Gaza and secretly around the world. It has continued to use the killing machinery crafted by President George W. Bush, expanded by President Barack Obama and employed by President Donald Trump. The Fifth Amendment prohibits killing persons, restraining liberty and taking property without due process; that means a jury trial at which the government must prove criminal behavior or fault, depending upon its goal.

If the country is at war -- lawfully and constitutionally declared by Congress -- obviously the president can use the U.S. military to kill the military of the opposing country. And if an attack on the U.S. is imminent, the president can

strike the first blow against the military of the entity whose attack is just about to occur. *There are no other constitutional circumstances under which a president may kill.*

When President Harry Truman targeted Japanese civilians as the Japanese government was within days of surrendering in World War II, he murdered them. Notwithstanding his unprosecuted war crimes, and with the government's version of Pearl Harbor still fresh in many Americans' minds, Truman was regarded as heroic for using nuclear bombs to cause the profoundly immoral, militarily useless and plainly criminal mass killings of the hated Japanese.

Fast-forward to the 9/11 era, and Bush had precedent to begin his own presidential killings of people the government wanted Americans to hate. While Congress did authorize him to use force against those who caused or aided the 9/11 attacks, we all know that his thirst for Middle Eastern blood knew no regard for the Constitution, evidence, proportionality, civilian lives, morality or human decency. Thus, \$3 trillion spent and 1 million dead in Afghanistan and Iraq.

Julian Assange sits in a British dungeon awaiting decisions on his extradition to the U.S. because he courageously, lawfully and constitutionally published documents and videos demonstrating conclusively that Bush's use of drones targeted and murdered Afghan and Iraqi civilians,

and his administration covered it up.

Obama took this to another level when he targeted and killed Anwar al-Awlaki, who was born in the U.S. Obama's attorney general, Eric Holder, advised Obama that the killing was lawful, as al-Awlaki had encouraged folks in the Middle East to fight against American soldiers there. Holder likened killing al-Awlaki to police shooting at a bank robber whom they are chasing while he is shooting at them.



Holder forgot that al-Awlaki was unarmed, was not charged or indicted for any crime, was never accused of violence, and was not even the subject of an arrest warrant when a drone evaporated him while sitting at an outdoor cafe in Yemen.

The exercise of power by the federal government is largely based on precedent and politics. Whenever a president wants to kill, he need only find an example of a predecessor having killed with impunity -- without due process, without a declaration of war and without an imminent attack. And then he needs only to calculate what he thinks he can politically get away with.

Joe Biden -- whose drones in 2021 destroyed a dam in Syria, killing thousands, and who targeted civilians in Afghanistan, killing dozens, and whose shipments of guns to Ukraine and Israel are killing tens of thousands of folks he wants us to hate -- is using unlawful powers that his modern predecessors used and got away with to target and kill unsympathetic persons. But the U.S. has not declared war on Russia or Gaza.


The nature of political power is to expand so that it fills a perceived need, unless there are mechanisms in place to restrain its expansion.

The founding generation believed that British monarchs had no limits on their powers and that was a good enough reason for the 13 colonies to secede violently. They also believed that they had crafted the Constitution and the Bill of Rights to impose sufficient restraints on the federal government. And they believed that the states could peacefully leave a federal government they had voluntarily joined when it exceeded its constitutional powers.

The Constitution is the supreme law of the land. Its language is clear that only Congress writes laws and declares war, and presidents can kill only troops in wartime or civilians consistent with due process. Sadly, the Founders were wrong.

Every president takes an oath to preserve, protect and defend the Constitution as it was written, not as he may wish it to be. Yet, today, the president writes laws and rules that let him restrain personal liberty and kill with impunity, and Congress and the American people let him get away with it. Formally, we still have a Constitution. Functionally, it has utterly failed to restrain the government.

Ultimately, we have ourselves to blame for these killings and undeclared wars. Why do we repose the Constitution for safekeeping into the hands of those who subvert it? If a future president uses Bush's lust and Obama's logic and Biden's hatreds to kill Americans in America, then no one's life, liberty or property will be secure.

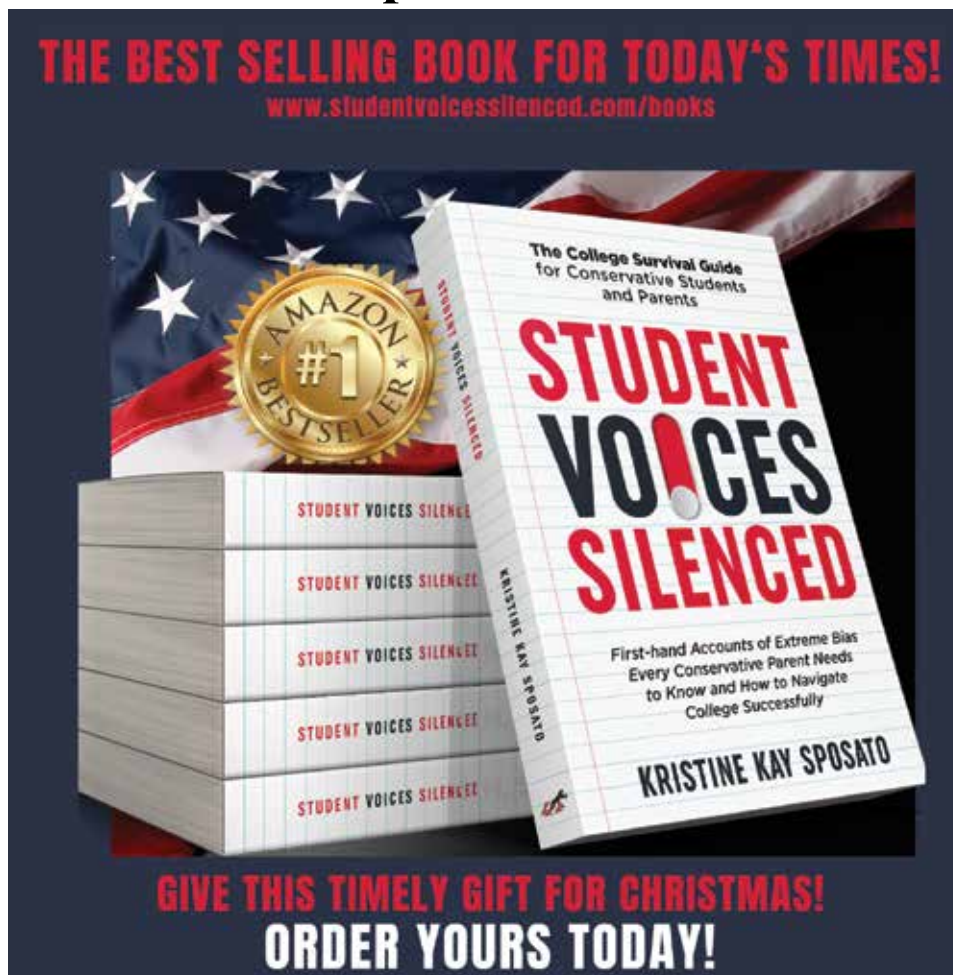
Unwillingness of Higher Education to Address Hamas/Palestinian Protests on Campuses and How To Prepare Our Students For These Conflicts

However, prices are still sky-high due to Biden’s reckless spending, and overall inflation has only recently stabilized after a significant surge in recent years. Newsom also claimed that the 18 percent increase in the average hourly wage compared to three years ago is “nearly the best 3-year gain in 40 years.” However, Bidenflation in the last three years has not allowed American workers to actually enjoy their increased wages.

This year’s Thanksgiving dinner was 14.7 percent higher than the \$53.31 the holiday meal cost Americans in 2021. Families shelled out a whopping 25 percent more than the \$48.91 they did in 2019. According to an Associated Press-NORC Center for Public Affairs Research, two-thirds of people say rising costs have impacted their lives, while only a quarter have seen an increase in income. In addition, 75 percent of Americans view the economy as poor.

Meanwhile, as grocery store prices continue to skyrocket, the Biden Administration’s rules and regulations could potentially put a \$9,000 price tag on homeowners due to rising prices related to cars, washing machines, gas stoves, and dishwashers.

First Hostages Released in Temporary Cease-fire

With Palestinians worldwide continuing

After seven weeks of war, the first diplomatic breakthrough between Israel and Hamas has finally occurred with the confirmed release of 13 Israeli and 11 Thai and Filipino hostages by Hamas, and the release of 39 Palestinian prisoners by Israel. The released hostages consist of elderly women and children, including toddlers. Over a four-day cease-fire brokered primarily by Qatar, Hamas has pledged to release 50 hostages

and Israel has agreed to release 150 prisoners.

Israel is vowing to resume and continue the war until Hamas is destroyed and all hostages are released. Hamas, for its part, was accused of violating the cease-fire only minutes after it began, when air-raid sirens sounded in southern Israel. The bloody war, which began soon after Hamas' vicious terrorist attack on southern Israel, has resulted in the deaths of more than a thou-



sand Israelis (most of them innocent citizens) and has since claimed the lives of more than ten thousand Palestinians and resulted in widespread destruction across the Gaza Strip.

to insist on the complete extermination of Israel, it is unlikely that any cease-fire or peace agreement brokered by third parties will do anything other than furnish an interval for Hamas and other Palestinian militant and terrorist organizations to rearm. It is to be hoped that, in the almost inevitable continuing conflict, the lives of innocent civilians (including the more than 200 hostages still held by Hamas terrorists) will be respected.

Former Supreme Court Justice Sandra Day O'Connor Dies at 93

unprescribed antibiotic ionophores livestock, even at low levels, consistently because of potential damage to the microbiome as well as the risk of antibiotic-resistant bacteria growth. We question if the side effects of these ionophores in dogs and horses, leaving their hind legs dysfunctional, might be related to millions of Americans presenting with restless leg syndrome and neuropathy, conditions unknown to most humans just a generation or two ago. Further testing must be conducted on the side effects of these drugs in our food and the effects on humans."

Summary of Test Results

Three veterinary drugs and hormones were found in ten fast food samples tested.

* One sample from Chick-fil-A contained a contraceptive and antiparasitic called Nicarbazin, which has been prohibited.

* Six out of ten, or 60%, of the fast food samples contained antibiotic Monesin, which is not approved by the FDA for human use and has been shown to cause severe harm when consumed by humans.

* Four out of ten, 40% of the samples contained antibiotic Narasin, which has been shown, in animal studies,

to cause anorexia, diarrhea, dyspnea, depression, ataxia, recumbency, and death and pathologically by degeneration, necrosis, and repair of heart and skeletal muscles.

Monensin and Narasin are antibiotic Ionophores; toxic to horses and dogs at extremely low levels, leaving their hind legs dysfunctional. Ionophores cause weight gain in beef and dairy cattle and are therefore widely used but also "cause acute cardiac rhabdomyocyte degeneration and necrosis." For many years, ionophores have also been used to control coccidiosis in poultry. However, misuse of ionophores can cause toxicity with significant clinical symptoms. Studies show that ionophore toxicity mainly affects myocardial and skeletal muscle cells.

Only Chipotle and Subway had no detectable levels of veterinary drugs and hormones.

so long as it is taught objectively for secular purposes such as its historical or cultural importance, and not for the purpose of promoting Christianity.

Q: Are teachers allowed to send holiday cards or gifts to their students or their students' families?

A: Public school teachers may send Christmas cards and gifts to the families of their students so long as they do so on their own time, outside of school hours.

Q: Is Christmas music prohibited in schools?

A: Public schools may include Christmas music (including those with religious themes) in their choral programs if the songs are included for a secular purpose such as their musical quality or cultural value or if the songs are part of an overall performance including other holiday songs relating to Chanukah, Kwanzaa, or other similar holidays.

Q: What if a student does not believe in or celebrate Christmas?

A: Public schools may not require students to sing Christmas songs whose messages conflict with the students' own religious or nonreligious beliefs.

Q: May students give out Christmas cards at school?

A: Public school students may not be prohibited from distributing literature to fellow students concerning the Christmas holiday or invitations to church Christmas events on the same terms that they would be allowed to distribute other literature that is not related to schoolwork.

Q: Are people allowed to put up Christmas displays in parks?

A: Private citizens or groups may display crèches or other Christmas symbols in public parks subject to the same reasonable time, place, and manner restrictions that would apply to other similar displays.

Q: Is a city or town prohibited from sponsoring a holiday display?

A: Government entities may erect

and maintain celebrations of the Christmas holiday (such as Christmas trees and Christmas light displays) and may include crèches in their displays at least so long as the purpose for including the crèche is not to promote its religious content and it is placed in context with other symbols of the Holiday season as part of an effort to celebrate the public Christmas holiday through its traditional symbols.

Q: Can my employer prohibit me from celebrating Christmas while on the job?

A: Neither public nor private employers may prevent employees from decorating their offices for Christmas, playing Christmas mu-

sic, or wearing clothing related to Christmas merely because of their religious content so long as these activities are not used to harass or intimidate other employees.

Q: Can my employer require me to work on Christmas?

A: Public or private employees whose sincerely held religious beliefs require that they not work on Christmas must be reasonably accommodated by their employers unless granting the accommodation would impose an undue hardship on the employer.

Q: If the Constitution requires a "separation of church and state," why is Christmas a national holi-

day?

A: Courts have routinely held that government recognition of Christmas as a public holiday and granting government employees a paid holiday for Christmas does not violate the Establishment Clause of the First Amendment. The government has a valid secular interest in providing a day of rest to citizens and may accommodate the religious beliefs of citizens in doing so.

School District's Attempts to "Decenter Christmas" Challenged by Liberty Counsel

For at least the last two years, Holt Public Schools in Holt, Michigan (population 25,000), has adopted a Marxist, anti-Christmas agenda in advising teachers to not use Christmas symbols, decorations, or other such expressions during the Christmas holidays. In its annual memo, which demands that teachers "review the meaning of Decentering Christmas," the district promoted anti-Christian, anti-faith, pro-Marxist ideologies with the veiled warning to teachers to obey or else.

During that time, teachers and parents have complained, and yet the school district has ignored them and kept in place its anti-Christmas, anti-Christian agenda. Last week, Liberty Counsel intervened and warned the district and its board members that it is ready to challenge their Marxist agenda in court.

Its letter pulled no punches: *Liberty Counsel provides pro bono advocacy and assistance on a variety of issues ... including the public education of traditional holidays such as Christmas... We have affiliated attorneys across the United States, including Michigan.*

After reviewing the horrific anti-faith memos and attached materials sent to the teachers in 2021 and 2022, Liberty Counsel demanded that the district retract all the scurrilous materials and memos that were previously issued, or else face "additional action." The board has until Thursday, December 7, to respond.



From its "demand" letter: The FAQ and the "Decentering Christmas" Christmas 2021 emails are rooted in Critical Theory (CT), and the "Racial Justice Guide" which the email promotes is rooted in Critical Race Theory (CRT).

CT includes within its relentless criticism of cultural institutions an intense hatred for Christianity and associated holidays, such as Christmas. CRT seeks to upend the social order by recasting the Marxist ideology of CT in racial

terms....

Critical Race Theory departs from Critical Theory in holding that "there is no human race per se; there are just white oppressors and the non-white oppressed."...

CRT "uses race to continue CT's intense criticism of the cultural institutions in order to fundamentally change society."

In contrast to these ideologies, Christianity teaches that all people are made in God's image, regardless of race, class, or sex, and have inherent dignity and worth. Christmas is part of our Nation's history and traditions and may not be banned by public schools....

The District has clearly communicated that Christianity, Christmas, and "whiteness" [93 percent of Holt is white] are problems to be remedied. "Christmas" is a word to be excised from the vocabulary of District staff in favor of "winter season." Decorations deemed "religious" by the District, including Christmas trees (or even the colors red and green associated with Christmas) must be eliminated in favor of "a tree that is winter themed or has plain white light bulbs."

Liberty Counsel reviewed its recent First Amendment victories in similar circumstances: *Groff v. DeJoy* (in which a mailman was denied his First Amendment rights), *Kennedy v. Bremerton School District* (in which a football coach was denied his First Amendment rights), *Shurtleff v. City of Boston* (in which a Christian group was denied its First Amendment rights), and *Students for Fair Admissions v. Harvard* (in which the school's race-based admissions standards violated the Fourteenth Amendment).

It reminded the school board that their successful case against the City of Boston cost that city more than \$2 million in legal fees. The law firm declared that "after *Shurtleff*, *Kennedy*, and *Groff* such [Christmas] symbols may not be purged by the District." (Emphasis in original.) If that wasn't enough, Liberty

Counsel reached back to a Supreme Court decision from 1943 — *West Virginia v. Barnette* — to remind the board what the high court ruled then: "If there is any fixed star in our constitutional constellation, it is that no official, high or petty, can prescribe what shall be orthodox in politics, nationalism, religion, or other matters of opinion, or force citizens to confess by word or act their faith therein."

The demand letter concluded: Liberty Counsel demands the immediate retraction of the District's past (and proposed) unconstitutional bans on Christmas holiday symbols, decoration, and expression, and the "Racial Justice Guide." Please inform Liberty Counsel in writing by close of business on December 7, 2023, that the Christmas bans and "Racial Justice Guide" have been retracted and rescinded. If the District fails to provide this response, Liberty Counsel will take additional action to prevent irreparable harm to cherished liberties.

In announcing its "demand" letter, Liberty Counsel issued a public statement: Instead of being "inclusive," these directives are rooted in Critical Race Theory and promote a hatred for and discriminate against Christianity and associated holidays, such as Christmas. They violate school policy, the First Amendment, and Title VII of the Civil Rights Act of 1964 by showing hostility on the basis of religion and on the basis of race.

Dr. David Hornak, Holt's superintendent of schools, has a week to come to terms with Liberty Counsel or face the consequences.

Henry Kissinger: War Criminal and Enemy of Mankind

Former US secretary of state and national security advisory Henry Kissinger died on Wednesday. He was 100 years old. Kissinger is perhaps most notable for his work during the Nixon Administration when he helped Nixon prolong the Vietnam War and expand it to Cambodia and Laos.

But his influence was certainly not limited to the Nixon years, he served in an official capacity in the Ford administration, and in more informal roles during the Reagan and Bush years as well. Throughout it all Kissinger was a ruthless servant of the American foreign policy establishment. As a Harvard-educated political scientist, Kissinger was employed to provide gravitas and legitimacy to a number of US wars and interventions, most of which ended in bloodbaths for the ordinary people of the countries Kissinger claimed to be improving.

Kissinger likely had the most freedom to inflict damage under Nixon, and thus his greatest crimes were committed in the Vietnam milieu. Spencer Ackerman this week efficiently sums up much of Kissinger's worst deeds:

* The Yale University historian Greg Grandin, author of the biography Kissinger's Shadow, estimates that Kissinger's actions from 1969 through 1976, a period of eight brief years when Kissinger made Richard Nixon's and then Gerald Ford's foreign policy as national security adviser and secretary of state, meant the end of between three and four



million people.

* No infamy will find Kissinger on a day like today. Instead, in a demonstration of why he was able to kill so many people and get away with it, the day of his passage will be a solemn one in Congress and — shamefully, since Kissinger had reporters like CBS' Marvin Kalb and The New York Times' Hendrick Smith wiretapped — newsrooms. Kissinger ... was a practitioner of American greatness, and so the press lionized him as the cold-blooded genius who restored America's prestige from the agony of Vietnam.

* Not once in the half-century that followed Kissinger's departure from power did the millions the United States killed matter for his reputation, except to confirm a ruthlessness that pundits occasionally find thrilling. America, like every empire, champions its state murderers....

Kissinger played a key role in a variety of coups, killings, and bombings across

the globe, and he often enthusiastically endorsed regime acts that he knew would target innocent civilians. Kissinger's criminal mind was frequently employed to push the Gulf War and later the so-called Global War on Terror. Kissinger's gimmick was to present himself as the "voice of reason" by positioning himself as a "realist"—even though he wasn't actually a realist—and as a dispassionate critic of other foreign policy advisors.

Yet, Kissinger never came down on the side of actual foreign policy restraint, and he was reliably hawkish whenever the question of a new war came up. He had about as much respect for the sovereignty of foreign states as Vlad Putin on his most militant days. As Rothbard showed, however, Kissinger was able to morph between the roles of hawk and ultra-hawk as political realities dictated.

For example, during the Reagan years, Kissinger played the role of moderate within the administration. As Rothbard describes it: "One problem is that the Republican "pragmatists" are not very dovish. Not only are the grand old Republican isolationists of the pre-1955 era dead as a dodo, but there are not even any dovish Establishment realists of the Cyrus Vance or George Ball variety, let alone such Grand Old Men as George Kennan. The battle is between the hawks and the ultra-hawks. On the merely hawk side are the Vietnam war criminal Henry Kissinger and his many followers, war-mongers who, however, want

to stop short - at the brink of a nuclear holocaust. This evil "pragmatism" is scorned by the ultras, the Kirkpatrick, the Van Cleaves, the Aliens, the Pipeses, all who want to burn out the universe to the furthest star."

By the time of the leadup to the Gulf War in 1990, however, Kissinger had left this "moderation" behind, at least as far as Iraq was concerned. Rothbard wonders if Kissinger's "ultra-hawkish views" were perhaps related to Kissinger's lucrative work as a "consultant" in which his client list included the government (i.e., dictatorship) of Kuwait. Regardless of his motivations, Kissinger continued to serve an important role in pushing federal war propaganda well into his final decades.

He served this role both as an advisor behind closed doors and as a public intellectual appearing in newspapers and on television. Americans of decades past were no less inclined to blindly accept the pronouncement of government "experts" as they are now. Indeed, Americans of the mid-twentieth century were perhaps more inclined to do as they were told. After all, where were they to find a dissenting opinion except in subscription-only physical newsletters mailed out by the small minority of those who dissented from the dominant narratives?

As late as the 1990s, Kissinger was still frequently trotted up as the "voice of reason" on foreign policy. Or, as Rothbard put it: "Kissinger is so Beloved, in fact, that whenever he appears on Nightline or Crossfire he appears alone, since it seems to be lese majesty (or even blasphemy) for anyone to contradict the Great One's banal and ponderous Teutonic pronouncements. Only a handful of grumblers and malcontents on the extreme right and extreme left disturb this cozy consensus."

Kissinger's views were often predicated—at least publicly—on disproven theories like the "domino theory." He helped develop the still-used idea that the US must go to war everywhere on earth that some ally is threatened—or else. As Kissinger put it: "We must understand that peace is indivisible. The United States cannot pursue a policy of selective reliability. We cannot abandon friends in one part of the world without jeopardizing the security of friends everywhere.

Rutherford Institute Warns Against Government's Plan To Ask Households About Sexual Orientation, Gender Identity in Mandatory Survey

WASHINGTON, DC —The Rutherford Institute is sounding a renewed warning against efforts by the government to amass extensive, sensitive private information about individual citizens and their households through its mandatory American Community Survey (ACS). Rutherford Institute attorneys have also formally lodged concerns over a proposal by the U.S. Census Bureau to expand the already exhaustive, invasive ongoing monthly survey to include questions about each household member's sex assigned at birth, current gender (including transgender, nonbinary, or others), and sexual orientation.

For individuals alarmed by the U.S. Census Bureau's efforts to collect and track private information about the citizenry, their home life and personal habits, The Rutherford Institute has made its updated "Constitutional Q&A: American Community Survey" guidelines available at www.rutherford.org. The Institute has also provided a form letter of complaint for lodging objections to the ACS with

the Census Bureau.

"In an age when the government has significant technological resources at its disposal to not only carry out warrantless surveillance on American citizens but also to harvest and mine that data for its own dubious purposes, whether it be crime-mapping or profiling based on race or religion, the potential for abuse is grave," said constitutional attorney John W. Whitehead, president of The Rutherford Institute and author of *Battlefield America: The War on the American People*. "Any attempt by the government to encroach upon the citizenry's privacy rights or establish a system by which the populace can be targeted, tracked and singled out must be met with extreme caution. The American Community Survey qualifies as a government program whose purpose, while seemingly benign, raises significant constitutional concerns."

The American Community Survey

prevent a Chinese invasion of Taiwan is for NATO to "win"—whatever that means—in Ukraine. There is zero reason to assume that Beijing's views of Taiwan have much of anything to do with Ukraine, but thanks in part to Kissinger, people buy the idea that the US must intervene everywhere for "the security of friends."

For nearly seventy years, Kissinger was able to push his faux "realism" which just happened to align repeatedly with the goals of the militant moralists who have perennially sought to invade and carpet bomb foreign people for the sake of saving them from themselves. Because Kissinger served the regime so well, we must now endure countless paeans in the media and from the respectable classes of Washington. Get ready to see George W. Bush, Michelle Obama, Mitch McConnell, and Hillary Clinton all mourn together at his funeral as they hail one of the history's great war criminals.



(ACS) is a highly invasive, ongoing monthly survey issued by the U.S. Census Bureau to collect detailed housing and socio-economic data from about

3.5 million households each year. The ACS requires recipients to provide the government with extensive and sensitive information about each and every person in their household, including their work schedules, their physical disabilities and limitations, the number of automobiles kept at the residence, and their access to phone-service and the internet. The information collected by the ACS is not anonymous: the survey is to contain the name, age, sex, race, and home address of each person at the residence, along with the phone number of the person who fills out the form. There are so many questions on the ACS that it is estimated the

average household will have to take 40 minutes to answer the questions. When people do not respond online or by mail, the Census Bureau repeatedly sends field representatives to their homes at unannounced times to harass and interview them until they answer the survey. People have reported that field representatives remained outside their houses for hours while waiting for them to arrive home or come out, have walked around their homes, and have talked to minor children when parents were away. The questions on the ACS are so invasive that many initially think the survey is a phishing scam to steal their personal information. Institute attorneys warn that the data collected and amassed by the Census Bureau through the ACS would be a goldmine for criminals.

The Quandary of Excess Deaths

“Unprecedented.” “Striking.” “Dramatic Surge.” These terms are used in media and medicine to explain the increase in excess deaths or the “premature” mortality the United States has experienced over the past few years. Those of us paying attention have an idea what these “excess” deaths, or deaths above the usual baseline, are from—and I think the people doing these analyses do too, but will they ever admit it? Better yet, will there ever be a way to know truly?

Several studies have been released over the past few months, and all of the study authors twist themselves into pretzels to explain away the difference in mortality in the U.S. vs. other “wealthy” nations. Terms like “inequity,” “pandemic insufficiencies,” etc., flood their pages. They do a mammogram and find cancerous tumors—stage 4. The cancer has also spread, and they give her months to live. The doctor doesn't attribute this “turbo” cancer to her previous mRNA vaccine dose, instead saying, “This is one of those rare times when someone gets cancer at a young age...” Sadly, Kelly also passes away. Her untimely and early death is added to the death statistics, but no doctor reports to

VAERS. No one tries to figure out “why?” Kelly is now a young excess death statistic that the statistician will attempt to explain away by “inequity.”

Multiply this by the millions. If doctors won't investigate a link between any number of seemingly “random” conditions and the brand new medical technology injected into the arms of two hundred million people, how will they EVER link back to the thing that we all know is causing these problems? Answer? We won't.

We are only talking about excess deaths here, not injuries and disability. That is an entirely different ball game in and of itself. But to give you an idea—one study showed that there were close to a million excess deaths last year, with only 25% of those attributable to COVID itself, and even that is debatable given the metrics for determining what a COVID death is. Because of all of the hiding, obfuscating, scare tactics, and “fake news/conspiracy theorist” monikers thrown around, statisticians and researchers are left to all manner of pretzel twisting to try and figure out why—in one of the wealthiest and most well-developed countries in the world—there are

hundreds of thousands more dying per year than in other countries.

Malaysia Airlines Flight 370 Captured by Unknown Forces

Research points to the most sensational cover-up in history

Malaysia Airlines Flight 370 disappeared on March 8th 2014. On May 19, about nine weeks later, a leaked video was published to YouTube by a third party who claimed to have received it on March 12th. The video shows what appears to be a jet airliner on fire being trailed by three spiraling orbs. Eventually, the three orbs change to a vertical pattern and disappear in a flash with the airliner, leaving a dead-end trail of smoke in the sky. A month later on June 12th, a second video was published to the same channel that showed the exact same event taken from a different viewpoint. These videos have been deleted from YouTube but can still be found on archive-dot-org.

Ashton Forbes and his team have been researching these videos extensively, and have provided exhaustive evidence that these videos are legitimate. Including digital forensics verified by CGI professionals, eyewitnesses, and government data, Forbes and his team have successfully addressed all de-bunker claims and have listed them for all to see on X-dot-com @JustX-Ashton. So far, nobody has been able to de-bunk this research.

Their research shows that the first leaked video was taken from a pair of American signals intelligence satellites known as USA-229. Twin satellites capable of creating 3D stereoscopic images by capturing two slightly different views. The twin USA-229 satellites are logged at the exact location, time, and apparent



angle required to have captured this video. This event occurred at around two-thirty in the morning, it was completely dark, the wavelengths captured by these cameras are for detail, and the stereoscopic effect allows for added depth perception.

The source of the second video has been identified as an MQ-1C Gray Eagle unmanned combat drone with Infrared and thermal technology. This video focuses on the heat signature. The man responsible for leaking these videos seems to be Lt. Cmdr. Edward Lin. He was accused of being a spy, but court transcripts prove that this was just spin. The details of his crimes, including the time they happened, are redacted, but it came out in the trial that the classified information in question was published on the internet. And Lt. Cmdr. Edward Lin had full security clearance to the same technology used to capture these videos.

Using Inmarsat satellite ping data and military radar to track its path, and eyewitness testimony to verify it, Forbes put together the final flight path of Malaysian Airlines Flight 370: On March 7th at 16:42 UTC Flight 370 takes off from Kuala Lumpur International Airport. At 17:21 the plane abruptly turns back towards

the nearest airport in Penang. A witness on an oil rig reported that the plane was on fire. Several witnesses along the East Coast reported hearing a loud bang and seeing a glow coming from the plane as it passed overhead. At 17:52 the co-pilot's mobile phone pings the local tower. At 18:40 an eyewitness on a boat reported that the plane was glowing orange and appeared on fire. The Inmarsat ping data shows the same sharp left turn that we see in the videos, and then abruptly goes to zero as the plane disappears.

The CCP released Chinese satellite images that appear to be three orbs. They first claimed it was debris, and later said that releasing the image was a mistake. According to Chinese media, nineteen families have signed a statement claiming they made calls that connected to missing passengers after the disappearance but without an

answer.

Some people are saying this was alien UFOs saving a plane from crashing. But this doesn't explain the fact that three different advanced US military surveillance cameras

captured this one event. Twenty-three of the passengers on board were related to Freescale Semi-Conductors, a field leading the development of super-conductor technology, which is what this appears to be. Some type of superconductor targeting system for teleportation. Which is reminiscent of what the NAZIs were doing with their highly classified Die Glocke project.

Luminous objects like this were first reported in May of 1940 as Germany invaded Belgium and by 1942 several people reported seeing them in the skies over Germany. American pilots during World War Two called them Foo Fighters. Let's not forget Gary Mckinnon, who in 2002 was accused of perpetrating the "biggest military computer hack of all time", and who claimed to have seen evidence of an advanced off-world military fleet.

“Global Stocktake” Needed, Say UN Leaders at COP28

“Global stocktake” appears to be this year’s buzz phrase at the UN climate summit in Dubai. In his opening remarks yesterday, Simon Stiell, executive secretary of the UN Framework Convention on Climate Change, warned that the world is “standing at a precipice, facing the Global Stocktake.”

On December 1, at the official opening ceremony, UN Secretary General António Guterres invoked the phrase repeatedly, warning that the “success of this COP depends on the Global Stocktake prescribing a credible cure in three areas.” For those uninitiated into the latest faddish usages, “stocktake,” as either a noun or a verb, refers to assessing and recording the amount of stock held by a business, and appears to be derived from the common phrase “taking stock.” What UN movers and shakers mean by this term was clarified by Guterres as he laid out the “three areas” of urgent action:

First, drastically cutting emissions. Current policies would lead to an earth-scorching three-degree temperature rise. The Global Stocktake must set clear expectations for economy-wide Nationally Determined Contributions, that cover all greenhouse gasses, and align with the 1.5-degree limit. The G20 — which represents 80 per cent of the world’s emissions — must lead. I urge countries to speed up their net zero timelines, to get there as close as possible to 2040 in developed countries and 2050 in emerging economies.

Second, we cannot save a burning planet with a firehose of fossil fuels. We must accelerate a just, equitable transition to renewables. The science is clear: The 1.5-degree limit is only possible if we ultimately stop burning all fossil fuels. Not reduce. Not abate. Phaseout — with a clear timeframe aligned with 1.5 degrees.

Third, the Global Stocktake must not only commit to that — it must also commit to triple renewables; double energy efficiency; and bring clean

energy to all by 2030. The economics are clear: the global shift to renewables is inevitable.

The economics are certainly clear, as the catastrophic Biden-administration energy policies and their consequences have shown in ever-greater clarity. Waging war against fossil fuels, as Biden has done, and seeking to replace them with allegedly cleaner “renewables,” is a recipe for economic collapse and the end of the modern age with all of its cornucopia of benefits. These benefits include not only gasoline and natural gas, but also plastics, all of them derived from “fossil fuels.” It’s a recipe for returning to the world of the 18th century, before coal or oil was burned as fuel, and before plastics revolutionized material science. Such an agenda, if successfully realized, would entail a massive dieback owing to drastic curtailment of agricultural productivity — or do the would-be eco-tyrants believe that modern farm machinery, shipping materials, and fuel to energize the system of food production and distribution can be miraculously achieved without reliance on fossil fuels?

Moreover, the politics are equally clear, as attested by the confident and coercive cadences of Guterres’ address. Word choices such as “must” and “inevitable” signal the growing confidence of the climate globalists that their agenda will be implemented, and that political roadblocks of yesteryear, such as concerns over national sovereignty and the stymieing of modern progress, are dissipating, at least among elite policymakers. A large part of that confidence is no doubt due to the Biden administration’s slavish implementation of broadly unpopular energy policies in the name of Paris Agreement requirements — with zero regard to the protests of ordinary Americans, who have watched soaring fuel prices and other self-imposed shackles on American industry erode their standard of living.

In the end, if these ultra-radical global reforms take full effect, even the elites will feel the pain, as the Left finally achieves its ultimate goal: the destruction of modern Western civilization by any means possible. But if they succeed in doing so, they will kill the very goose whose golden eggs they have long harvested to their own benefit.

COP28 President: “No Science” to Show Fossil Fuel Phaseout Will Prevent 1.5°C Increase

On the eve of COP28, the president of the event, Sultan Al Jaber, the minister of industry and advanced technology for the United Arab Emirates (UAE), commented that “there is no science” or “scenario” in which a fossil fuel phaseout will keep the world’s average global temperature increase under the 1.5°C goal demanded by the United Nations.

Al Jaber made the comments at an event put on by women’s climate-action group SHE Changes Climate on November 21. Questioned by Mary Robinson, the chair of the Elders group (“an independent group of global leaders working for peace, justice, human rights and a sustainable planet”) and a former UN special envoy for climate change, Al Jaber took umbrage with Robinson’s assertion that the world is “in an absolute crisis

that is hurting women and children more than anyone.”

“I accepted to come to this meeting to have a sober and mature conversation. I’m not in any way signing up to any discussion that is alarmist. There is no science out there, or no scenario out there, that says that the phase-out of fossil fuel is what’s going to achieve 1.5C,” Al Jaber said.

“Please help me, show me the roadmap for a phase-out of fossil fuel that will allow for sustainable socioeconomic development, unless you want to take the world back into caves,” the COP28 president added. “I don’t think [you] will be able to help solve the climate problem by pointing fingers or contributing to the polarisation and the divide that is already happening in the world. Show me the solutions. Stop the pointing of fingers. Stop it.”

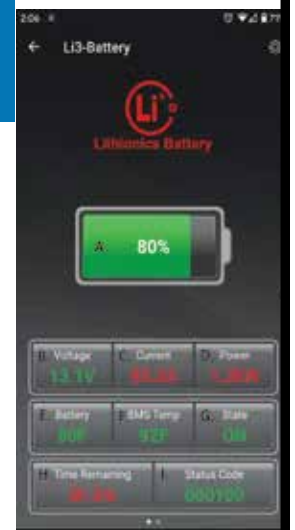
