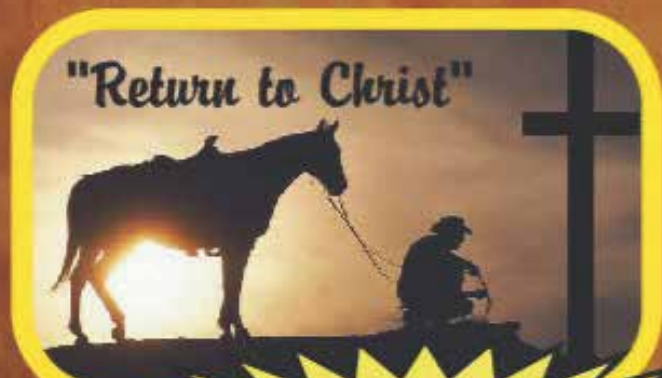

"They that are with Him" are those Christians that stand up against any and all attempts to change, do away with, or marginalize in any way the Word of God.

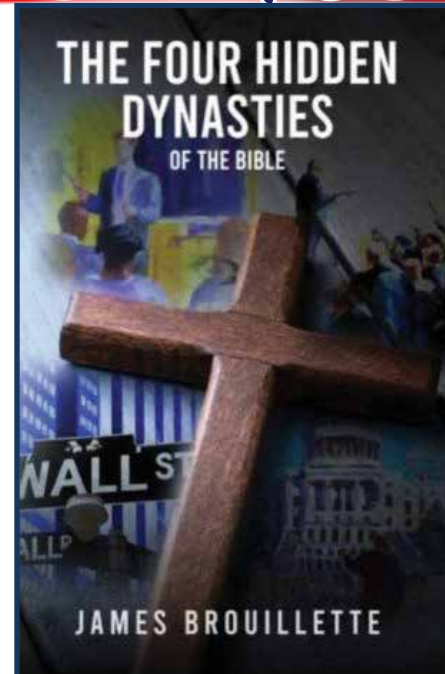

Signs include the ongoing collapse of woke media giants like Disney, the successful boycotts of products like Bud Light and companies like Target, but if you know how to read social trends you can see more subtle signs. People are less afraid to ridicule Social Justice Warriors, less afraid of cancel culture and more willing to criticize their delusions.

This is what happens when you spend years trying to control people's speech with "neo-pro-nouns" and terrorize the internet with cancel culture. declare war on traditional western values – Everyone starts to hate you and eventually they will organize to kick your ass.

The only thing keeping the woke movement afloat at the moment is their alliance with corporations and the establishment media. Globalist think tanks still spend billions of dollars funding social justice programs and the current government provides cover for the exploits of far-left zealots. Without the elites, the woke ideology would not exist. Millions of Americans are ready to snuff it out for good.

The Bad And The Ugly... Election 2024

As I have mentioned in past articles, I still believe there might not be a presidential election in November. Though, current conditions would allow for one as long as nothing changes dramatically in the next several months. There hasn't been this level of national division over an election since the Civil War and regardless of what happens or which side "wins" there will be a high potential for a violent reaction.

The election of 2024 is developing into its own Black Swan event. Any indication that Donald Trump will be arrested before November or any widespread blue state plans to remove him from the ballot will be seen as election interference and I have no doubt that many Americans will seriously consider armed revolt.

Then again, Trump's mere presence as a candidate will be used by far-left groups as a rationale to stoke riots. His re-entry into the Oval Office would mean endless mob actions and perhaps even terrorist attacks. So, in this regard it doesn't really matter if we end up with Biden or Trump, the eventual outcome will probably be the same – Civil unrest followed by a declaration of martial law in the next couple of years.

My position on Trump has always been one of skepticism, primarily due to his terrible cabinet choices (including Anthony Fauci). However, I recognize that after four horrendous years of Joe Biden's woke authoritarian empire there is no way that half the country is going to tolerate another term, especially if that term is achieved through perceived sabotage.

Then there is the potential for shock events, such as Biden stepping down at the last minute. Trump being arrested but winning anyway. Or, a major geopolitical crisis which is used by the Democrats as an excuse to "postpone" the election (and make no mistake) there are many of these triggers in place today.

Geopolitical Tensions Soaring

The potential for war on multiple fronts, including Ukraine, Israel, and perhaps Taiwan is extraordinary in 2024. For now, I am focused on Israel's conflict in Gaza and the chances of retaliation from surrounding Islamic states. As I've mentioned in previous articles, Gaza has no chance whatsoever of stopping Israel militarily and they never did, but that's not really relevant. What matters is how their neighbors respond.

Lebanon and Hezbollah appear poised to commit to war on Israel in the near term, but Iran is the big question mark. Would they openly engage the Israelis? Such a move would completely destabilize all of the Middle East, disrupt a massive portion of the world's



oil supply and probably draw the US and Europe into the fray.

The biggest threat for now, is the shutting down of shipping lanes through the Red Sea and the Strait of Hormuz. This could disrupt supply chains and energy resources for many months and accelerate the economic crisis and, this could in turn be used by the establishment as a rationale to put "boots on the ground" in the region.



Economic Powderkeg

The economic situation is far more distressed than international relations, believe it or not. There is a precarious game being played by

the Federal Reserve with US debt and interest rates, culminating in a Catch-22 that I have been warning about for years.

Some analysts argue that the Fed is about to cut rates in 2024 (I remain doubtful); but if they do, get ready for an immediate and renewed spike in inflation. If they don't commit to substantial rate cuts then the national debt will continue climbing by around \$600 billion per month (around \$7 trillion a year). This is unsustainable and it threatens the world reserve status of the dollar.

If the Fed's intent is to influence elections (again, I highly doubt this), then they aren't going to be helping Joe Biden much by cutting rates. Biden is already known as the inflation president creating another ramp in CPI by the end of 2024 would be a disaster for his campaign.

Keeping Biden in office would only further cement public outrage over socialist policies as the economy continues to dive into either stagflationary crisis or deflationary depression depending on which path the central bank chooses.

And remember, the 30%-plus price increase we have seen across the board on necessities in the past few years is going to remain in place for quite some time. It doesn't matter what the Fed does, you are going to continue paying 30% more to survive compared to 2019-2020, and for many people this is swiftly killing their standard of living. This is why no one takes "Bidenomics" seriously – Until they see a return to cost normalcy it doesn't matter what kind of spin Biden places on jobs numbers or CPI. Nobody cares.

Catch-22

I suspect the Fed will continue

down the path of deflation. They might try to cut rates once or twice, but when CPI jumps they will go right back to higher rates and tighter credit. This is exactly what they did in the 1970s and early 1980s, though, the US wasn't adding \$600 billion in debt every month during that particular crisis.

How this deflation translates will depend on other factors including geopolitical factors (as mentioned above). I predict we are about to see an aggressive resurgence of unemployment by the end of the year. Americans are not buying more, they are merely spending MORE for the same amount of stuff. The stagflationary process always leads to a painful decline in overall consumption and standard of living – We had our three-year boost due to covid helicopter money, and now that boost is fading. Any action by the Fed on rates at this point will not help retail or the service sector, it will only serve to keep stock markets afloat a little longer.

Again, the end result is the same no matter what the central bankers do, and this is by design. If the US elections play into the establishment's plans at all, I suspect it would be more in line with the optics of a renewed Trump presidency. It might serve globalist interests more to keep the system intact, not to protect Biden but in preparation for Trump's return, only to collapse the entire house of cards once he enters office (or even right after he wins). Setting up conservatives as scapegoats for full spectrum economic crisis makes a lot more sense than trying to maintain the

facade for Biden for another four years.

If the globalists fail to set the stage for the Reset in 2024, then they may be facing a mounting movement to bring them to justice. The juggling act is about to come to an end.

A New Year's Resolution Worth Keeping

In the closing days of 2023, the Biden Administration once again announced a large military aid package for Ukraine, this time a “mere” quarter of a billion dollars. Without a new authorization of funds from Congress, it is said to be the last bit of money left over from the more than \$100 billion already authorized by Congress for the proxy war with Russia through Ukraine.

President Biden’s request for an additional \$100 billion to spread around Ukraine, Israel, and Taiwan was rejected by a Congress eager for its winter break, and with each passing day it looks like it’s going to be harder to push it through. For example, a recent Fox News

Last month Secretary of State Antony Blinken inadvertently revealed what exactly all the spending for war is about when he stated that as much as 90 percent of the aid for Ukraine is actually spent

in the United States. The money is used “to the benefit of American business, local communities, and strengthening the US defense industrial base,” he said in an interview. In other words, the money “for Ukraine” is actually a massive welfare program for well-connected military contractors back home.

As we begin the year 2024, we need to hone in on the real threat to the United States. It is not Russia or China or Iran. The true threat is closer to home: it is a corrupt system that bleeds the country dry to fight imaginary enemies while enriching the military-industrial complex.

For the New Year, Congress should resolve to end the stranglehold of the military-industrial complex by reining in out-of-control military spending. Members should simply vote “no” on military spending bills until they are drafted to benefit the American people rather than the Beltway elite. I don’t hold out much hope of this happening in the short run, but it only takes a few dedicated Members to make a real difference.

Supreme Court agrees to take case that could upend hundreds of Jan. 6 prosecutions

A legal issue that could potentially upend dozens of convictions in the Jan. 6 attack on the U.S. Capitol has landed before the nation's highest court.

The U.S. Supreme Court agreed Wednesday to hear the case of Joseph Fischer, who was charged with various crimes in connection with the Capitol riot when thousands of Donald Trump supporters descended on the building and violently breached its doors as Congress began to certify President Joe Biden's win in the 2020 election.

"The motion of petitioner for leave to proceed in forma pauperis and the petition for a writ of certiorari are granted," the Supreme Court said in the order. Court filings indicate that Fischer is represented by federal public defenders.

According to federal prosecutors, Fischer, then a police officer with the North Cornwall Township Police Department in Pennsylvania, yelled "Charge!" before running toward a line of police officers at the Capitol that day. He is also alleged to have had a "physical encounter with at least one police officer." He was charged with multiple felonies, as well as trespassing and disorderly conduct.

The most serious of those charges was obstruction of an official proceeding of Congress, a violation of federal statute 18 U.S.C. § 1512(c) (2).



That statute reads (in relevant part) as follows:

(c) Whoever corruptly —
(1) alters, destroys, mutilates, or conceals a record, document, or other object, or attempts to do so, with the intent to impair the object's integrity or availability for use in an official proceeding; or
(2) otherwise obstructs, influences, or impedes any official proceeding, or attempts to do so, shall be fined under this title or imprisoned not more than 20 years, or both.

The question the justices will consider, according to the docket, is whether the D.C. Circuit erred in construing the statute, "which prohibits obstruction of congressional inquiries and investigations[,] to include acts unrelated to investigations and evidence?"

Prosecutors have argued that while the enumerated offenses in the first subsection are specifically aimed at actions like destroying evidence, the

second subsection, starting with the word "otherwise," is meant to essentially be a "catchall" to address any other action, "corruptly" taken, to block "any official proceeding."

Defendants have argued the statute is confined to actions such as destroying potentially incriminating documents, as consulting firm Arthur Anderson was found to have done on behalf of Enron as the then-crumbling energy company was starting to crumble, leading to what was then the largest corporate bankruptcy in the world.

Lawyers for Jan. 6 defendants have repeatedly tried to get the obstruction charge dismissed. For the most part, they have failed — 18 federal district judges in Washington have upheld the obstruction charge in Jan. 6 cases, following in the footsteps of U.S. District Judge Dabney Friedrich, a Trump appointee who was the first to issue a written ruling on the matter.

Only one judge at the trial level found the statute does not apply:

U.S. District Judge Carl Nichols, a Trump appointee and the presiding judge in the case of Garret Miller, a defendant in a separate case that was consolidated with Fischer's for purposes of challenging the obstruction statute.

The Justice Department appealed, and a three-judge panel of the U.S. Circuit Court of Appeals for the District of Columbia heard the case in December 2022. In a fractured ruling in April, the three judges reversed Nichols' dismissal of the obstruction charge, and Fischer, along with Garret and a third defendant, Edward Lang, appealed to the Supreme Court.

A decision to uphold the dismissal would likely wreak havoc on the government's yearslong prosecution of the Jan. 6 attack. More than 290 defendants have been charged with felony obstruction under the statute or attempting to do so. Some of the most recognizable names to emerge from the attack — including so-called "QAnon shaman" Jacob Chansley, Scott Fairlamb, and Paul Hodgkins — have pleaded guilty to the offense, while federal juries have convicted high-profile defendants such as Guy Reffitt and Oath Keepers leader Stewart Rhodes, along with four of his co-defendants, on the count.

According to the Justice Department, more than 327 people accused in the Jan. 6 attack have been charged with the federal obstruction defense, which carries a potential 20-year prison sentence, and at least 92 have been convicted of it.

The Impact of Jan. 6, Three Years On ~ The Epoch Times

Over 1,200 people have been arrested and hundreds prosecuted, but concerns have grown over prosecutorial tactics.

It's been three years since the Jan. 6 "Stop the Steal" rally in Washington ended in a breach of the U.S. Capitol by protestors. In the interim, the Department of Justice (DOJ) and FBI have undertaken the largest manhunt in their history, arresting over 1,200 people who entered Capitol grounds that day. The manner of these arrests, and the information used to make them (in some cases) have raised questions about FBI protocol amid the agency's effort to round people up. More than half of those arrested have faced sentencing on numerous charges.

Many of those held on charges related to Jan. 6 have been incarcerated in the D.C. Metropolitan Jail, dubbed the "gulag" by critics for the treatment of Jan. 6 defendants there. The political fallout of the events of that day continues to resonate throughout Washington and the nation as a whole.

Opponents of former President Donald Trump, including members of the House of Representatives' now-defunct January 6 committee, have promoted the narrative that President Trump himself was responsible for the Capitol breach. These critics have argued that the Jan. 6 rally amounted to an attempted "insurrection" against the United States government and was guided by President Trump.

On these grounds, President Trump has faced challenges to his right to appear on the ballot in several states. He's also been charged with a series of federal crimes related to the incident and its aftermath by special counsel Jack Smith, a move that has drawn sharp criticism from President Trump and his congressional allies, decrying it as a "witch hunt" against the 2024 Republican frontrunner. Even as the event itself fades into the historical background, its aftereffects continue to significantly influence American politics.

Here's an overview of key events that have happened in the three years since

Jan. 6, what's to come, and the questions that remain unanswered.

Arrests and Prosecutions
According to the DOJ's most recent statistics 1,237 people have been arrested in relation to Jan. 6. The vast majority of these people—1,160—have been charged with entering or remaining in a restricted federal building or grounds, including 140 charged additionally with entering the area armed with a dangerous or deadly weapon. About a quarter have been



charged with obstruction of an official proceeding—a charge that critics say has been applied to a degree well beyond its original scope.

Roughly a third have been charged with assaulting, resisting, or impeding officers, including 120 charged with using a dangerous or deadly weapon or causing serious bodily injury to an officer. Seventy have been charged with destroying government property, while 56 have been charged with theft of government property.

Notably, despite claims that the event amounted to an insurrection, none of the defendants arrested in connection to Jan. 6 have been charged with insurrection.

Attorney General Merrick Garland has called this "the most wide-ranging investigation, and the most important investigation that the Justice Department has ever entered into." However, the FBI's tactics in making these arrests, and the methods it's employed to identify and apprehend Jan. 6 suspects, have raised many questions. For instance, many Jan. 6 defendants have been arrested by use of a SWAT team. This is unusual, according to former FBI special agent Stephen Friend, who

blew the whistle on the FBI's handling of Jan. 6 cases and lost his job for it. "I've arrested over 150 violent criminals," he said in a new documentary about Jan. 6 from The Epoch Times. "I never had to use SWAT." He added, "That really is the utmost, highest level of enforcement."

Former FBI special agent Garret O'Boyle, another whistleblower featured in the documentary, noted odd deviations from standard procedure in the ways that information against sus-

pects was gathered. In one case, Mr. O'Boyle noted that information was obtained from an anonymous tip uncorroborated by law enforcement—a source of information not commonly given much credence among law enforcement officers. In another, he reported that a 25-year-old photo was used to identify a suspect—another deviation from standard procedure.

The FBI did not reply to a query on these allegations.

In other cases, information was acquired through the cooperation of social media companies and financial institutions. Particularly headline-grabbing was the revelation that Bank of America had "voluntarily" handed over bank records to the FBI of people in Washington on Jan. 6.

All said, Jan. 6 defendants' sentences add up to hundreds of years in prison. But the largest sentences have been reserved for those deemed ringleaders. Enrique Tarrío, the former leader of the Proud Boys, has been sentenced to 22 years in prison. Stewart Rhodes, leader of the Oath Keepers, was sentenced to 18 years. A handful of others considered most responsible for the events of that day have also received

sentences of over a decade in federal prison.

'January 6 Jurisprudence'

After their arrests, Jan. 6 defendants were subject to what attorney Joseph McBride dubbed "special January 6 jurisprudence," which he described as a reversal of standing legal precedents in favor of pursuing and imprisoning Jan. 6 defendants.

"There's a term that we developed in one of our cases, what we call the 'special January 6 jurisprudence,'" Mr. McBride told The Epoch Times. "It's the concept that all constitutional law, criminal law, civil rights law—from the inception of our country, up until January 5, 2021—is one body of case law and then you have everything else that came after it." He and fellow Jan. 6 attorney Ed Martin discussed a series of areas where "January 6 jurisprudence" diverged from what came before it, including in areas related to free speech, due process, and defendants' core constitutional rights.

Many concerns about the treatment of Jan. 6 defendants in the courts revolve around a heretofore little-known statute of U.S. law against "obstructing an official proceeding." The use of this obscure statute, Mr. Martin said, could be chilling on free speech. The statute, developed in the aftermath of a scandal wherein Enron employees shredded documents ahead of an investigation, is at its core similar to obstruction of justice, Mr. McBride told The Epoch Times. For roughly 330 Jan. 6 defendants, however, the scope of the law has been expanded dramatically.

The relevant section of U.S. law imposes a penalty of up to 20 years in prison on felony charges for "whoever corruptly ... obstructs, influences, or impedes any official proceeding, or attempts to do so." But its use in the case of Jan. 6 defendants is unprecedented, Mr. McBride said, and could have serious implications for freedom of speech in the United States. "It's an obstruction charge and it has to do with a person or a group of people, like Enron, destroying evidence relating to a forthcoming investigation," he said.

"Did any of these people do that? No.

Do you see people running around with ballots in their hands? No,” Mr. McBride said. “So they improperly expanded the scope of this statute in order to create this massive dragnet under which they would drag all these people into it.” Mr. Martin added that by extension, the application of the law could be used to chill political speech. The law “is supposed to be about evidence tampering,” Mr. Martin said. “It’s supposed to be about altering evidence. It’s not about when there’s an official event, a school board meeting, an Electoral College count, a congressional hearing.”

With the expanded scope of the statute, Mr. Martin said, everyday Americans could find themselves facing felony charges and up to 20 years in prison simply for undertaking any action that could be construed as obstructing or interrupting anything deemed an “official proceeding.” “So now, if you go to any public meeting, you go to your town council and get up and say, ‘You’re killing babies, stop abortion now,’ and they gavel out the meeting, you’ve now committed a felony in America,” he said.

Currently, a case about the application of the law by federal prosecutors is pending in the Supreme Court, where the attorneys expressed optimism that it would be struck down. Additionally, prosecutors in many of the cases sought the addition of a so-called “terrorism enhancement” during sentencing, one of several considerations that can be used to dramatically increase the prison sentences of those convicted of a crime.

The threat of having this enhancement applied against him was part of what drove 37-year-old Matthew Perna—already facing charges of witness tampering, entering and remaining in a restricted building or grounds, and two counts of disorderly conduct—to commit suicide, his aunt, Gerri Perna, told The Epoch Times. Mr. Perna was initially set to face four misdemeanor counts. Later, the DOJ escalated the charges, adding on the felony charge for obstruction of an official proceeding and threatening to further lengthen the sentence by requesting the terrorism enhancement. “Matthew Lawrence Perna died on February 25, 2022 of a broken heart,” his family said in an obituary. “His community (which he loved), his country, and the

justice system killed his spirit and his zest for life.”

Due Process Concerns

Also within the scope of “January 6 jurisprudence,” Mr. McBride contends, is a series of due process violations that have grown to be nearly commonplace in Washington’s courts. Mr. Martin argued that this was part of a methodological approach on the DOJ’s part. “Part of the approach of the Justice Department and the prosecutors and law enforcement has been to intimidate, if not terrorize, the people they are arresting,” Mr. Martin said.



Both attorneys listed a series of examples, many of which began well before Jan. 6 defendants ever stepped into a courtroom. Generally, when someone is arrested on charges of a crime, they are only held in prison prior to their trial or plea agreement under very limited circumstances, Mr. McBride said, including whether their alleged crime was violent and if they posed a flight risk. For many Jan. 6 defendants, it didn’t work out that way. These defendants instead faced months in prison ahead of their court dates. “In 99.9 percent of all these cases, these men should have all been sent home during the pendency of their trials,” Mr. McBride said. “Because the D.C. court wanted to punish them—not for what they did, but for what they believe in, and who they support—they lock these men up in complete violation of the due process rights.”

While in pretrial detention, these defendants faced persistent violations of their constitutionally guaranteed rights amid conditions that one member of

Congress described as “nothing short of human rights violations.” They were subjected to solitary confinement and neglect of their core physical health, were deprived of basics like razors and haircuts and, in some cases, were beaten and verbally abused by guards.

Cynthia Hughes, aunt of Jan. 6 defendant Tim Hale-Cusanelli, told The Epoch Times that the conditions these defendants faced in jail were “despicable.” “They’re denied every basic human right,” Ms. Hughes said. Like other Jan. 6 defendants, Mr. Hale-Cusanelli wasn’t allowed outside, wasn’t

allowed access to priests or spiritual advisors, and his core physical health was disregarded. At the time, Mr. Hale-Cusanelli was suffering from an ear infection that had nearly deafened him in one ear, with little medical intervention offered by the jail.

These degrading conditions, Mr. McBride said, amounted to a violation of the 8th Amendment’s prohibition on cruel and unusual punishment. “If you’re convicted of a crime, and you go to jail, the punishment for your crime is the deprivation of your freedom,” he said. “You’re not allowed to punish people cruelly and unusually, not allowed to lock people up in solitary confinement, feed them bugs, medically torture them, whatever it is. That’s what the prohibition against cruel and unusual punishment is.”

This was far from the only violation of the defendants’ due process rights, the attorneys say. In many cases, they were deprived access to the lawyers for long periods of time. Their communication with their lawyers, Mr.

McBride said, was subject to inspection. Protected attorney-client conversations were monitored, constituting a violation of Sixth Amendment rights. Additionally, Mr. McBride said, some defendants have been deprived of their Brady rights. Brady rights refer to the Supreme Court precedent requiring the prosecution to turn over all exculpatory evidence to the defendant and their legal counsel.

An additional due process concern referenced by both attorneys was that of venue. Of the many cases tried in Washington, practically every defendant sought a change of venue, noting that Washington, perhaps the most Democrat-leaning city in the country, was incapable of providing them with a fair jury of their peers. Every single one of these requests was denied, Mr. McBride said.

The DOJ did not return a request for comment.

Political Fallout

Aside from the effects on the lives of those caught up in the FBI’s massive prosecutorial net after Jan. 6, the event’s political fallout continues to resonate to this day. The Capitol breach has been used by Democrat activists as justification to remove President Trump from the ballot in several states. A portion of the post-Civil War 14th Amendment prohibits any person who, “having previously taken an oath ... as an officer of the United States ... to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same” from holding public office again.

Many Democrats maintain to this day that Jan. 6 constituted an attempted insurrection against the United States government, despite the lack of insurrection charges against any of its participants. The leader of this alleged insurrection, they say, was President Trump, and his allies. This was the narrative advanced by the Jan. 6 panel, which was disbanded after Republicans took back the House.

Under that panel, terms like “insurrection,” “assault on democracy,” and “attack on the Capitol” became commonplace in the mainstream media when referring to the events of the day. “The narrative that they continue to promote, and to this day they do it, is that these are armed insurrectionists,

who are felonious bad actors,” Mr. Martin told The Epoch Times.

Thus far, this narrative has been used as the basis both for a federal criminal prosecution of President Trump, and as the basis for his removal from the 2024 presidential ballot. States like Colorado and Maine have attempted to do so, pending intervention from the Supreme Court. Legal experts, however, expect the high court to

overturn the effort. Still, as President Trump appears poised to clinch his party’s nomination for the presidency later this year, Jan. 6 seems likely to remain a forefront political issue for some time.

Unanswered Questions

While much has been uncovered about what really happened on Jan. 6 by invested journalists diligently scrutinizing the thousands of hours

of photos and videos taken that day, many questions remain unanswered three years after the fact. A major lingering question involves the absence of the National Guard that day. President Trump, aware of the potential for violence on Jan. 6, had authorized the deployment of the National Guard to the Capitol, pending approval of Congress’ sergeants at arms and Washington Mayor Muriel Bowser. Without

the consent of these two, President Trump was unable to unilaterally order the presence. Both declined to request the assistance, leaving the Capitol understaffed and unprepared for the massive crowds that descended on it that day. Questions as to why this assistance was not requested by any of the relevant authorities—and why the Capitol was so understaffed that day—have yet to be answered.

1,000 Days Without A Trial: Jan. 6 Prisoner Shares His Story of ‘Endurance, Perseverance, And Hope’

On Oct. 12, Jake Lang passed a milestone: 1,000 days in jail without a trial. To mark the anniversary, he wanted to share with the American people “the horrific conditions of confinement,” which he says he and many of his fellow Jan. 6 prisoners have had to endure. “During this time, I’ve done 20 months of solitary confinement,” Mr. Lang told The Epoch Times. “For 15 months of that, I wasn’t allowed to have a haircut or a shave.” This was intentional, he said, to make Jan. 6 prisoners look like “homeless vagrants” or “deranged terrorists” during video court appearances. Jan. 6 prisoners are frequently denied family visitation, Mr. Lang said. They spend months with no sunlight. Lights in their cells remain on at night, depriving them of sleep.

His account aligns with first-hand reports from other Jan. 6 prisoners, detailed in a Congressional report in 2021. Troublesome prisoners are subjected to “diesel therapy,” where inmates are shackled together—frequently with violent gang members—for long bus or plane rides to another facility. The trips can take hours, days, or weeks. Fights are frequent. Personal belongings and discovery for their trials—family photos, exculpatory documents, and notes related to their cases—are often lost. Family members lose track of them.

28-year-old Edward Jacob Lang has been charged with several counts, including an “obstruction” charge, for which he could receive a 20-year sentence. As reported by The Epoch Times, Mr. Lang has challenged this

charge with the Supreme Court. Following his arrest on Jan. 16, 2021, Mr. Lang has been shuttled from one prison to another. In New York, he was moved to three different facilities, including the MDC Brooklyn

where Jeffrey Epstein was held. Then he was taken to an airport in Newburgh, New York, put on a plane with about 200 convicted felons, and transported to Oklahoma, he said. He was moved to Northern Neck Regional in Warsaw, Virginia, and then to the DC Jail, known to Jan. 6 prisoners as “The Gulag.”

Confined to his cell for 23 hours and 15 minutes each day for three months, he was frequently physically assaulted. The first time was on Sept. 18, 2021, before a rally in the DC mall in support of Jan. 6 prisoners. About 6 a.m., he said “around 70 officers began banging on the cell doors” of Jan. 6 inmates, ordering them to get dressed and grab their mats. They were being moved to “a more secure location,” they were told.

Guards were shouting. Inmates were confused and scared. “Some thought we were being taken outside to a firing squad,” he said. “They thought they were going to kill us.” To ease their fear, he began singing the national anthem. A guard threw him against the wall and punched him in the ribs. They were all taken to the basement and placed in cells with no windows, no sinks, or toilets.



The ordeal lasted eight hours. Mr. Lang was then “tossed in the hole.” “It’s disgusting down there,” he said. “The walls are wet. There’s vermin and cockroaches, and there’s a little slot in the door that they feed

you through like a dog.” About 10 months later, Mr. Lang was brought back up to the pod—an independent section within the facility that holds a small number of prisoners. His fellow Jan. 6 prisoners gathered at his cell door to greet him. “One of the guards yelled for them to get away from my door, just arbitrarily enforcing a rule that didn’t exist,” he explained. “He called the sergeant, who opened the door and unloaded a whole can of military-grade pepper spray directly into my eyes.”

Naked and in cuffs, an emergency response team dragged him from the cell and brought him to a shower. Female guards watched, “laughing hysterically” at his pain. He wasn’t given soap, so the oil ran down his body to his groin where the burning became excruciating. In his cell, the burning oil transferred to his mattress. He woke from nightmares thinking he was on fire.

When he was thrown back in “the hole,” he went on a 12-day hunger strike that cost him 30 pounds. Negotiations for ending his hunger strike included a haircut, family visitation, and a Congressional investigation into the deaths of Ashli Babbitt and Rosanne Boyland. He was

then moved to Alexandria Regional Jail and placed in solitary. After reporting his treatment to the press, he was sent to a federal penitentiary in Lewisburg, Pennsylvania. After more press interviews, he was moved to Rappahannock Regional Jail in Stafford, Virginia. One month and multiple interviews later, he was back at Northern Neck. A week later he was once again at Lewisburg, and then landed back at the DC jail, where he has been for the past six months.

“Friday, October 13th marked my 1,000th day in prison. But God’s grace has supplied me and the rest of the January 6 prisoners with strength, endurance, perseverance, and hope, knowing that we will have vindication from this political persecution. One day, from all over the country, more than 200 of us will emerge from these prisons and gulags. We will be redeemed and restored and all of the things they’ve done to us will all be washed away.”

Mr. Lang’s trial had been set to begin Oct. 10, but was postponed pending an indication on his Supreme Court petition.

[Editors Note: As of this publication, Mr. Lang’s trial has still not happened. Key elements left out of this article, Mr. Lang is a hero. He saved some lives that day including Philip Anderson from a stampede. He has not accepted a plea deal, his faith in Christ is very strong and will not allow him to do so. I Went To Grab A Burrito And Now I'm (Possibly) Going To Prison

My decision to go to Washington, D.C. in 2021, was made on January 20th, 2017. I was sitting with my friend in Long Beach, California, when she said, "Dude, you love Trump. Why aren't you in D.C. right now?" Indeed. One. I am a dude. Two. I love Trump. So, in my mind, I knew at that point I was going to D.C. when Trump wins again in January, 2021.

On January 6th I poured out into the streets of Washington, D.C. like a million other patriotic Americans, exercising my right to peaceably assemble, listen to President Trump's speech, go sightseeing, and grab a burrito. That's when things went sideways on me.

I saw a group of people already standing on the steps, so I recorded the fact that the barricades were already removed, and that people were already on the steps before I proceeded. At NO POINT, did the Capitol Police ever declare an unlawful assembly. Had the Capitol Police done so, I would have left. I was standing right next to Officer Warner, who told the crowd we were allowed on the steps before I had reached the Capitol. See the Officer Warner video [on the TFP-Pnews.com website]. The back of my head can be seen at 2:19 in the video, I'm wearing a gray North Face jacket.

To my surprise, the Columbus doors (which weigh an estimated 20,000 lbs and are magnetically sealed) were opened from the inside. Once the right facing Columbus door was opened, the crowd surged and I had no choice, but to move forward, or be trampled. This is known as the defense of necessity, which my former, private "defense" attorney (Anthony Solis) never discussed with me.

Once I was inside the Capitol, I could not move any further as the Capitol Police had established a police line, which some agent provocateurs (Zac Alma) came from behind those officers, so those individuals had already gained access to the building.

I was inside for a total of 28 minutes and was never accused of any violence, nor any vandalism, I simply moved through the doorway, once inside, I couldn't leave. The worst that the prosecution could say about me was I was standing in close proximity to people that were saying "naughty" things. So I'm guilty.

When I was able to leave, I did so in an orderly fashion and walked back to my hotel room, that's when I learned about the events on the Westside of the Capitol, and realized something bigger and more nefarious had happened.

I was finally charged in October of 2021, at that point I retained the services of Anthony Solis, of Calabasas, CA. I received discovery from the Government in January 2022, the Government provided every stitch of video evidence of my presence in the Capitol, except the video of my entry... Why is that?!? On the Statement of Offense, the time, and point of my entry that day is clearly marked, 2:27pm the Columbus Door. The Government knew, yet they were hiding the evidence.

On February 13, 2022, weeks before I pled guilty to parading, by the grace of God, I found a video of my entry into the Capitol on the Gateway Pundit. I could not believe my eyes. The video of my entry was more damning than I could ever imagine. I provided that video to Solis, at which time he told

me it didn't matter, and I said, "Okay, if it doesn't matter, then it doesn't matter. I think the whole thing is odd."

Six weeks after I pled guilty, I discovered Brady v. Maryland, and its implications for my case. I wrote an email entitled, "Exculpatory Evidence" to Solis, and I didn't hear back from him. There's a two-hour time difference between Austin (where I live now) and Los Angeles (where Solis lives). At that point I said one of three things happened: 1. Solis was traveling, 2. Solis was in court, 3. Or, I caught him. I knew at that point, I knew I had caught Solis working with the DOJ to deny me exculpatory evidence.

Once I caught Solis, I wrote Judge Walton's Chamber directly to alert him that there is, and always was a Brady Violation. After three months, Judge Walton granted me a status hearing (via conference call), and during the status hearing told me the video doesn't exist. Tortorice, the prosecutor, lied to Judge Walton, and Solis didn't say a word. They all knew the video existed, but I was led like a lamb out to slaughter.

Two months after I was sentenced, I continued to badger Solis to ascertain the video of my entry into the Capitol, On October 15th, 2022, Solis wrote an email to Tortorice confessing that they had conspired against me to withhold exculpatory evidence from me. [see evidence at TFPnews.com]

I went hard at the prosecutor, Tor-

torice, and told him I know that he has the video, and I know that he knows, that I know. The DOJ claims they are not intentionally withholding any videos from me. The DOJ knows that I have the video, the Internet has the video, yet they claim it doesn't exist.

I'm still fighting to get back in front of the court, to provide not one, but two videos of my entry into the Capitol on January 6th, which, was confirmed by the D.C., and affirms my defense of necessity, which is an affirmative defense, which means, it negates criminal and civil liability when invoked.

In closing, I caught my former, private "defense" attorney, Solis working with the DOJ to deny me Due Process, and per the 5th Amendment, I cannot be denied, "life, liberty or property, without Due Process." My entire life has been turned upside down because of a lie, and the fact that I caught the DOJ, they are coming after me even harder. It's gotten to the point, I've started to receive death threats. Unreal.

Like any true Patriot, I'm going to fight until the finish. My hope is that my case will be the first domino to fall in the lie that is, "The January 6th Insurrection." From an editorial note, not one defendant, nor President Trump has been charged with, nor convicted of, 18 U.S. Code 2383 insurrection, or rebellion.

Sounds like a class-action lawsuit for defamation of character to me. God bless, America!

DOJ Acted in 'Bad Faith and Treachery' by Withholding Exculpatory Jan. 6 Evidence, Attorney Says

A Texas man who took photos at the U.S. Capitol for his father's congressional campaign was found guilty on Sept. 13 of three Jan. 6 crimes, despite his attorney's last-ditch mistrial motion based on the Department of Justice's alleged "bad faith and treachery" for withholding hundreds of pieces of exculpatory evidence.

Ryan Scott Zink, 34, of Lubbock, Texas, was found guilty by a federal district court jury of corruptly obstructing an official proceeding—a felony—entering and remaining in a restricted building or grounds, and disorderly and disruptive conduct in a restricted building or grounds. A fourth count was dismissed before trial.

Chief Judge James E. Boasberg set sentencing for Dec. 18 in Washington. [It has been rescheduled again]

Judge Boasberg denied Mr. Zink's oral and written demands for a mistrial based on claims that prosecutors withheld "plainly exculpatory evidence" they are required by law to disclose and provide to the defense.

In his written supplement to an oral motion for mistrial, defense attorney John Pierce said he found out after business hours on Sept. 10 about possibly hundreds of exculpatory videos and photographs held by the U.S. Department of Justice. Prosecutors planned to use some of the evidence to impeach Mr. Zink's testimony, Mr. Pierce wrote, but the defense had never seen the items.

'Hundreds of Photographs'

"Defense counsel now realizes that many hundreds of photographs and videos taken by Zink on Jan. 6 have been improperly withheld by the prosecution," Mr. Pierce wrote. "The number of withheld video and image files may total more than 1000. This constitutes, by far, the bulk of the evidence in this case and the defense still hasn't seen it."

Mr. Zink said he went to Washington on Jan. 6 to take photographs of his

father, Jeff Zink, who was running for Congress in Arizona.

The father and son ended up on the



patio atop the east steps of the Capitol. Mr. Zink Jr. photographed a California man—Hunter Ehmke—jumping onto a window sill and kicking out some of the panes of glass before being tackled and detained by Capitol Police.

The FBI arrested Mr. Zink in Texas on Feb. 4, 2021. His father, Jeff Zink, who stood next to him on the Capitol patio, was never arrested or charged. Mr. Pierce said his firm spent nearly seven months trying to secure discovery evidence in the case after being retained in February 2023. Multiple requests were made of Mr. Zink's previous counsel and the prosecutors in the case, he said.

"We now believe that dozens or hundreds of the illegally withheld images

are campaign-oriented headshots and depictions of Jeff Zink," Mr. Pierce wrote in his supplementary motion for mistrial. "This supports the essence of Ryan Zink's defense: that Ryan went to D.C. on Jan. 6 for purposes of supporting his father's congressional campaign and to gather campaign images of his father. "Thus, the government cut the very heart out of Ryan Zink's defense when it misled defense counsel and withheld this evidence," Mr. Pierce wrote.

Prosecutors mocked Mr. Zink's defense that he was at the Capitol to take photos of his father, Mr. Pierce wrote. "The government has misled the jury with examination questions designed to disparage, denigrate, insult and deprecate Zink's defense—while knowingly possessing and withholding evidence which would have supported Zink's defense," Mr. Pierce wrote. "The unfairness of the proceedings cannot be overstated," he said.

Prosecutors have not filed a written response to Mr. Pierce's oral and written motion for mistrial. The DOJ's policy is to not comment on cases outside of filings made with the court.

Jeff Zink told The Epoch Times in November 2022 that he was told charges against his son would be dismissed

if he dropped out of the race for Arizona's 3rd Congressional District. The offer was made via anonymous, untraceable phone calls, he said. Jeff Zink lost the race to incumbent Ruben Gallego on Nov. 8, 2022.

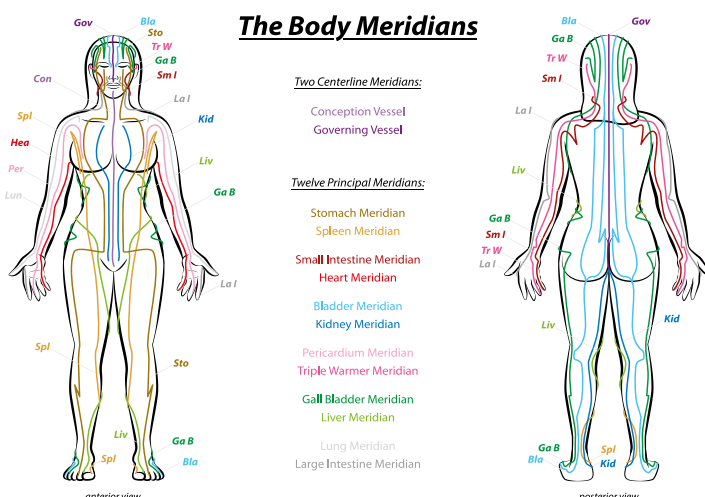

The Founding Fathers made the Constitution palatable by including a Bill of Rights. Without the First 10 Amendments, the Constitution is just what its early critics, including Patrick Henry and Thomas Jefferson, said it was; a dangerous consolidation of power far less representative of liberty than the Articles of Confederation.

The First Amendment was always a huge concern with statists of every era. Those who thirst for power, and will compromise themselves in order to attain it, have never looked favorably upon those critical of them. John Adams, the second president of the United States, passed the Alien and Sedition Acts for just this reason. He bristled at criticism. Fortunately, Thomas Jefferson succeeded him in office and scrapped this tyrannical concept. But the notion reared itself again in 1860, with the election of Abraham Lincoln. Adams was a civil libertarian compared to Lincoln. "Honest" Abe didn't pass



any new Alien and Sedition Acts; he just shut down over two hundred newspapers that opposed any of his unconstitutional actions.

Woodrow Wilson revived these odious acts during World War I. Eugene Debs and others were imprisoned for opposing the pointless shedding of blood, and America's participation in it. The Supreme Court, in perhaps its worst ruling ever, upheld Wilson's right to jail antiwar protesters. Great "liberal" justice Oliver Wendell Holmes coined the phrase "yelling fire in a crowded theater" to justify such heinous oppression, placing an ugly asterisk on free speech. Apparently no concerned American asked at the time, just how protesting a war could be construed as yelling fire in a crowded theater. This expression gained great renown across the land, and is forever on the lips of those who seek to censor dissent.

Franklin Roosevelt built upon the actions of Wilson, who was inspired by the maniacal despot Lincoln. One of the countless unconstitutional agencies created under the New Deal, the Federal Communications Commission was in effect a national Alien and Sedition Act for the radio stations, and would go on to control content in Hollywood and on every television network. It banned selling advertising that discussed "controversial issues." Vulgarity and "extremist" opinions were strictly forbidden. FDR pushed several inquisitions in Congress, most notably the one chaired by then Senator Hugo Black. You know, the former KKK member who went on to become a "liberal" Supreme Court

justice and arbitrarily awarded the 1948 Senate election to "Landslide" Lyndon Johnson, who was the first to court the dead vote.

The Black Committee and other inquiries attempted to severely curtail the ability of journalists to criticize the New Deal. FDR himself is documented to have personally tried to ruin the careers of his political opponents. And all of this was years before the Pearl Harbor false flag. Once America entered the war, FDR went after draft evaders, and memorably incarcerated American citizens in concentration camps. Not just Japanese Americans, but German and Italian Americans, too. The Roosevelt administration also stole billions in personal property from these poor souls. Much as Lincoln had locked up any northern anti war voices without any due process, FDR imprisoned those opposed to his war. In 1945, his successor Harry Truman had anti war poet Ezra Pound arrested, and he spent a decade in a mental institution.

We must consider today's "Woke" authoritarianism in its historical context. The precedents are all there. Cancel culture was born when Lincoln "canceled" his critics in the press, and threw thousands of uncharged citizens into makeshift prisons. Wilson followed this precedent, but FDR expanded it into a totalitarian art form. His administration "canceled" its critics in a variety of ways. FDR used J. Edgar Hoover to target some of them. His administration confiscated millions of telegrams to and from Roosevelt opponents. Long

before Richard Nixon's laughable efforts to use the IRS to monitor his critics, FDR had the fledgling agency audit almost everyone who opposed him. Indeed, FDR led a veritable crusade against free speech.

The Social Justice Warriors might look different. Tattooed. Pink or purple hair. Transitioned into countless new "genders." Utterly addicted to name-calling. But they are the logical descendants of those who supported the Alien and Sedition Acts. Who threw citizens into jail that objected to our involvement in faraway wars. Who wanted to use the IRS, and the FBI, to "cancel" critics of the political elite. Not enough tried to stop this onerous censorship in 1860. Or 1918. Or 1939. And too few are trying to stop it now. The January 6 political prisoners are a testament to that, subjected to the cruel and unjust punishment explicitly prohibited by the Constitution, which was inflicted on northern "Copperheads" during the Civil War, and anarchists and "Reds" during World War I, and "Nazi sympathizers" during World War II.

The crazed adherents of Identity Politics are hardly the first to want to silence their critics. Get them fired from their job, and rendered unemployable. And increasingly, prosecuted for their Thought Crimes. Those opposing Lincoln's mad war and suppression of civil liberties were the Thought Criminals of their time, long before Orwell gave a name to them. Everyone reading this little missive is a modern day Thought Criminal. There are millions of us. Is there room in their overcrowded prisons for all of us? As Lord Acton, the great lover of liberty who was friends with Robert E. Lee, not Ulysses S. Grant, reminded us; power corrupts, absolute power corrupts absolutely. Those in power in America 2.0 are absolutely corrupt.

How many of us truly believe in free speech? Almost everyone has a big "but," to quote the late Pee Wee Herman. Sure, I'm for free speech but... not for "Holocaust denial." Disbelievers in the Apollo moon landings. Or their even more extreme bedfellows, the flat earthers. Those who think mass shootings were a hoax, or "fake news." White people outraged by the

Great Replacement. Just referring to the Great Replacement can get you canceled, unless you're supporting such a thing. Which all of our horrific leaders do. Try mentioning how the average American woman today weighs what the average American man did sixty years ago, and see what happens. There are a lot of caveats to the mainstream ideal of "free speech."

The symbolic prosecutions, these figurative "fire in a crowded theater" abridgements of free speech, are in full swing. Alex Jones supposedly owes nearly a billion dollars to selective Sandy Hook parents. And now any mention of Sandy Hook is even more anathema to public discourse than the Great Replacement is. Jones also apologized for "Pizzagate." Which was ridiculous; look at those disturbing pictures on Instagram, and the Podesta emails published by Wikileaks. If Donald Trump had paintings of children with freshly spanked bottoms on the walls of Mar-a-Lago, do you think it might be reacted to differently than it was in the case of Podesta's brother? Now Rudy Giuliani owes almost \$150 million to two particular "offended" election poll workers?

The only acknowledged exceptions to free speech at one point were overtly slanderous or libelous comments. This is understandable; people do have a right to protect their reputation. But it's a slippery slope, and obviously applied in a wildly unfair manner. There's a fine line between libel and justified criticism. Donald Trump, think whatever you want to think of him, has been the object of slander from numerous national figures. This includes physical

and even death threats. But if Trump ever brought a slander suit against the Fake Media he rages against, it would be laughed out of every courtroom. Because it's Trump, not because it isn't slander. Obama, Clinton, Biden- they'd all be treated much more respectfully by this hopelessly corrupt, Tik Tok "justice" system of ours. Some slander is more equal than others.

But slander and libel have been supplanted now by the Orwellian term "hate speech." Which has been accepted by almost everyone, even though the very term immediately destroys any concept of free speech. And now "disinformation" and "misinformation," entirely subjective terms (like "hate speech"), are being bandied about as potential "crimes." This is essentially what Jones and Trump are being prosecuted for; the notion that they are misleading others with speech that the State finds "offensive," or "racist," or "disinformation/misinformation." Trump is being tried in court for contesting the results of an election. And for exaggerating the value of his assets. That doesn't seem to worry most Americans. They need to remember that whole, "First they came for the Communists" thing. Don't think they won't come after you.

If we were really protected by the First Amendment, then there would be no possibility of being prosecuted for our views on an election. Or a virus. Or a vaccine. Or any historical event. Every opinion is protected under the First

Amendment. Well, theoretically. If you say something "offensive" to any of the groups and individuals that are allowed to be perpetually "offended," then you are now subject to a politicized prosecution. No one should want to go anywhere near one of our Orwellian courtrooms. They're nearly as dangerous as hospitals. Thought

Criminals, by definition, are not being pursued for their actions. They aren't robbers. Or rapists. Or murderers. It's a difficult

task to prosecute the thoughts of others. But our authoritarian leaders are up to that task. And millions are complicit by their silence.

Today, Facebook, Instagram, Twitter, and YouTube ban, suspend and "cancel" those users who have unwelcome views. First Amendment be damned. As the "conservative" defenders of the cancel culture remind us, "They're private companies! They have a right to ban people!" As I would respond, you mean like restaurants, for instance? So did business owners in the segregated south have a right to deny service to certain people? They don't need a reason, right? After all, they're private companies! What exactly is the difference between denying admission to a restaurant, or a store, or a neighborhood, on the basis of skin color, or on the basis of political philosophy? Or even simply wearing a MAGA hat? It's a selective discrimination thing, you wouldn't understand.

It isn't easy being a true supporter of free speech, in a society that doesn't value it. Where more people than not are fine with stipulations on it. "The First Amendment doesn't protect hate speech," their nauseating mouthpieces in our state controlled media will bleat, as effortlessly as they will bleat "Oswald killed Kennedy" or "Diversity is our Strength." The word "hate" doesn't appear anywhere in the Bill of Rights, or the Constitution itself. But there is no one there to counter them when they make these statements, which are disinformation if anything is. I'll be waiting for someone, perhaps a member of the loyal "opposition," to point that out. But fewer people have probably read the Constitution than have read the Bible.

I thought the internet was beyond their control. They let us have unfettered access to true diversity of thought for a few decades. But the social media conglomerates gave them their opening. FDR "canceled" the editors and radio commentators of his day. Now, the "Woke" leftists can get big tech to deny access to crucial internet platforms to those who write or say discouraging words. Many in the alt media cheered the de-platforming of Alex Jones. YouTube and Facebook are shells of their former selves. Many like me are "shadow banned." They restrict our access to a larger audience. That's one way to control the competition. FDR and Lincoln would have loved it. What they ideally want is an FCC to control internet content. The VFW Is More Than A Drinking Club

This article began as an attempt to share the story of the Flags and Flowers program and it will, but it quickly became much bigger. As I started to put into words the feel-good story my newspaper friend suggested, I realized there's a lot we do for veterans in this little town to feel good about that no one knows.

Let's start with the Flags and Flowers program. A young boy in the Midwest, Preston Sharp, went to the cemetery with his mom to put a flag and flowers on his veteran grandfather's grave. While there, he noticed many veteran's graves were not being honored or remembered. He decided to change that. 10 years later, he put flags and flowers on veteran's graves in all 50 states. He came to the VFW and Auxiliary national convention in Phoenix this summer to challenge our members to put flags and flowers on veteran's graves in every cemetery across the nation.



Our opportunity came up this fall when a snowbird veteran's wife came to me and said, 'we were at the cemetery and the flags were horrible, we took them down, do you have more?' Luckily, I did, she asked for a list of veterans, so I gave her what we had and she and her husband spent hours with the list and map, making it all make sense. On our way back from an auxiliary training, we stopped and bought 120 red silk flowers to go with the new flags. Another veteran and his wife cut them all apart for us and we announced our own Flags and Flowers event. After hearing us talk about it, one of our regular meat raffle attendees said, "that's around the corner, I'll come help". So, from a couple volunteers, it grew to 12 and I cannot express how beautiful our little

cemetery looks with 110 fresh flags and flowers waving in the breeze. Our auxiliary committed a budget line to replace them twice a year, so we all remember and can feel that pride.

Remembering forgotten veterans, like the Bataan death March survivor and the Spanish American war survivor buried in Hi Jolly Cemetery is only a small part of what we do at our VFW post and auxiliary. Across this town, every week, all year long, volunteers check on veterans, making sure they are fed, houses are clean, laundry done. One quiet but friendly veteran makes sure any veteran that needs a ride to a Dr appointment gets there. Another veteran makes sure he has breakfast with the son of a veteran at the beginning and end of the season. An auxiliary member stands as proxy for an elderly aux member at the food bank each month because he

can't stand in line anymore, then she cooks the food and shares it with another veteran and a veteran's widow. Another veteran brings in special dishes to the canteen each month,

as he knows those guys won't ask, but it's something he can do. One member crochets her way across the country as they travel here each year, making lap robes for the VA hospital in Yuma that another volunteer visits every month



with books you donate. Our chaplain sends 2 dozen birthday cards to members each month, makes countless check in calls and keeps us apprised of potential need.

What about the money our guests donated at Thanksgiving, as we fed 40 veterans and their spouses with honor? It paid for 2 bicycles at our family event in December, where this community generously donated many gifts for 140 kids this year: incredible. The special touch of community members giving

us parent gifts year after year, so we can teach the value of giving to these kids is priceless.

The pride of a child when they recite the pledge of allegiance and get a flag and certificate is immeasurable. The absolute awesomeness of multiple motorcycle clubs come together with RV parks across town to bring Christmas to kids in this town, at an event where the volunteers show up as elves without anyone asking.

The tears of joy when the meat raffle helps us get someone tires or pay for propane; so precious.

Spearheading the local Wreaths Across America program to remember, honor and teach is an event we do with honor each December just as we commemorate Memorial Day, 9/11-Patriot's Day, Veteran's Day, Pearl Harbor Day, and others. Part of our purpose is to serve our veterans,

families, and community.

The VFW may look like just a drinking club, and we will admit that it is a safe place for our members to let down their hair. More importantly, it's a place where a veteran with PTSD knows he's safe, because everybody understands; where the social visiting turns into a plan of action for a holiday meal, including new volunteers sharing their favorite desserts. A place



where members show up at a friend's father's memorial, even though they didn't know him, just so she feels supported. A place where

members cry in joy with a veteran's widow when she got her 6-month cancer free report. A place where a member cares for another's dog or cleans her house before she comes home from surgery, so she won't overdo it. A place where members network and find funds for family emergencies; where they meet to relax after helping

Americans — and Democrats — Acquiring Firearms at Record Pace

The Washington Examiner reported on December 7 that in each of the previous 12 months, Americans purchased more than a million firearms. On Black Friday last year there were nearly a quarter of a million firearms sold, and the 1.6 million sold in November 2023 was the third-highest November sales in history. The National Shooting Sports Foundation (NSSF) estimated then that by the end of 2023 citizens would have added another 14-plus million firearms to their arsenals.

Startlingly, in a December 11 article, Newsweek reported that an NBC News survey of gun ownership in the country revealed that 41 percent of Democrats now say they live in a household where there is at least one firearm, up eight percent in just the last four years. Those Democrats contributed to yet another record: More than half of all American households now have at least one firearm.



NSSF spokesman Mark Oliva attributes the gun purchases largely to increased crime and the fear of increased firearms regulations. “There are many communities with sustained levels of crime that have not abated. Those concerns, along with the punishing anti-gun measures by the Biden administration and threats of more gun control promised by the Biden-Harris reelection campaign, cannot be discounted as contributing factors,” Oliva said.

When Newsweek asked retired Florida State University Professor Gary Kleck about the increasing

number of Democrats owning guns, he elaborated that “it may be a response to recent increases in crime rates in big cities, where Democrats claim a larger share of the population.” That is, Democrats vote in progressive district attorneys, who emasculate criminal laws, resulting

in more criminals being allowed back on the streets, where

they commit more crimes.

Progressive district attorneys have caused a doubling of gun violence in the Big Apple, and the same ideology of the liberals controlling Oakland, California, has caused a similar tragedy on the West Coast: Crime there jumped by 26 percent in 2023, including a 52-percent increase in carjackings, according to Newsweek.

Urge Congress to reintroduce and pass the American Sovereignty Restoration Act.

URGENT: Legislation to Get US Out! of the United Nations has been introduced in the 118th Congress. H.R. 6645 and S. 3428, titled the Disengaging Entirely from the United Nations Debacle (DEFUND) Act, are respectively sponsored by Representative Chip Roy (R-Texas) and Senator Mike Lee (R-Utah). These bills would fully withdraw the United States from the United Nations, restoring U.S. national sovereignty. Both H.R. 6645 and S. 3458 are pending in the House and Senate Foreign Affairs Committees, respectively. Contact your U.S. representative and senators, and urge them to support and cosponsor these bills, and to ensure their passage in Congress.

The United Nations is one of the greatest threats to U.S. national sovereignty and the God-given freedoms of Americans. It is imperative that Congress enact legislation to fully withdraw the United States from the UN and all its associated entities.

On December 6, 2023, Senator Lee introduced the DEFUND Act (S. 3428) in the U.S. Senate. In his remarks, when he introduced the resolution in the Senate, Sen. Lee said: At the UN's inception in 1945, President Truman

presented a choice between international chaos and the establishment of a world organization for peace. Yet, despite the UN's existence, chaos abounds. Adversaries leverage their UN positions and the goal of peace is overshadowed by the ambition for supranational governance. The true hope for a peaceful world lies not in such global institutions but in the strength of our national sovereignty, the use of the strength of forge and continue to foster bilateral relationships around the world.

Furthermore, in a previous interview with The New American, Representative Thomas Massie (R-Ky.) also made a strong case for terminating U.S. membership in the UN: First of all, I don't think we should be in the United Nations. It's a collection of dictators, and you give them all a vote in the organization. I'm a sponsor of a bill to get us out of the United Nations, and to get the United Nations

out of the United States [and] some related world associations, [such as the] World Trade Organization [and the] World Health Organization. The World Trade Organization has been hostile to the United States. They are the ones who ... "forced" Congress to take off the country of origin labeling for beef and pork. Obviously, they only forced the ones here who have weak minds ... to get rid of those labels — but that came from the World Trade Organization. The World Health Organization has redefined things like the definition of "vaccine" and "herd immunity." And then our own CDC is following suit and trying to redefine these terms.

It is Orwellian in the sense that they're trying to control thought by controlling the language that we use. And for Joe Biden to throw in with all of that, it's that we have a president like that. — U.S. Representative Thomas Massie (2021)

According to a press release from the office of Senator Lee, the DEFUND Act would:

- * Repeal critical acts that bind the U.S. to the UN, such as the United Nations Participation Act of 1945 and the United Nations Headquarters Agreement Act.
- * Ceases all forms of U.S. financial support to the UN, including assessed and voluntary contributions.
- * Prohibits any U.S. involvement in UN peacekeeping operations.
- * Revokes diplomatic immunity for UN officials within the United States. Formalizes withdrawal from the World Health Organization and other UN conventions.
- * Sets stringent conditions for any future engagement with the UN, requiring Senate approval with explicit withdrawal provisions.

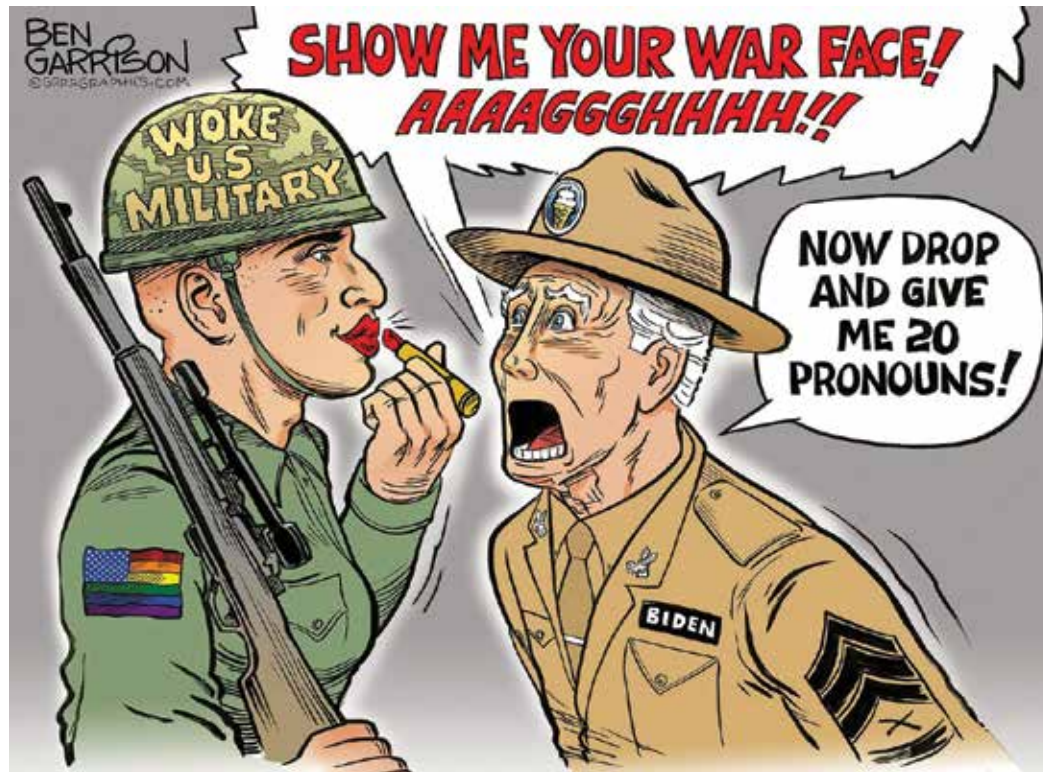

- 10) The UN seeks disarmament of all nations leading to it alone having a military arm.

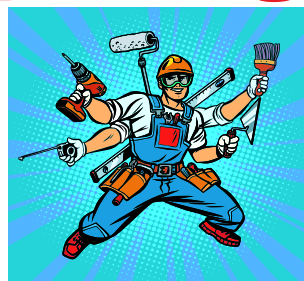
