Is This the 'Perfect Crime'?

On Easter Sunday, an unknown number of thieves broke into a cash storage facility and walked off with \$30 million. The Los Angeles Times describes the caper as "seamless, sophisticated, stealthy." The Times broke the story midweek.

The crooks targeted a Gardaworld building in Sylmar. Gardaworld is a Canada-based global cash management and security company which also operates its own fleet of armored vehicles," according to the New York Daily News.

The FBI and Los Angeles police have been tight-lipped about the robbery and have not identified any suspects.

Obviously, the first thing the authorities are looking at is an inside job. The facility is on a quiet suburban street in a nondescript building. It wasn't generally known that the facility housed tens of millions in cash.

Gardaworld describes itself as a "global champion in security services, integrated risk management and cash solutions, employing more than 132,000 highly skilled and dedicated professionals." The money is insured but this "champion of security services" just lost \$30 million to thieves. Not exactly "secure," is it?

Officials said the burglars appeared to enter through the roof. At least one alarm was triggered during the crime, but it was not connected to local law enforcement, according to a source familiar with the investigation who was not authorized to



discuss it publicly. In any case, the thieves were able to get in and out without anyone knowing.

There was also a hole in the side of the building covered by a piece of plywood. A law enforcement source confirmed to The Times there was an effort to breach the side but it was not clear how that area was used in the heist.

Neighbors reported hearing "weird noises" at the time of the heist. "That sound is embedded in my head," one woman told the Times. She heard the noises for two hours and added, "my mind is still going crazy over what happened. I know it's just money, but they're invading your space."

New York Post: "George Alhosry, owner of the Kwik Market and Deli down the street from the cash facility, said his business' Wi-Fi was down for most of Sunday. "We couldn't access the Lotto," he told the LA Times, adding that cell phone calls also would not go through.

It is not clear if the Wi-Fi issue

is connected to the robbery, but Wi-Fi jammers are a common tool used by robbery gangs who target homes in Southern California, the outlet noted.

The gadgets allow seasoned thieves to shut off security cameras that can capture video or still images of the crime in action, it explained. Investigators are looking at similar heists around the globe, thinking the thieves may be an international ring.

It has "all the markings of a really well-thought-out job" performed by a "professional crew," according to Scott Andrew Selby, co-author of "Flawless: Inside the Largest Diamond Heist in History."

How disappointed are we going to be if the criminals turn out to be a couple of second-story crooks who had some inside information about the facility?

John McEarchan, a former FBI agent speculates that it's almost certain that an employee was involved in some way.

The Big Picture

“Transgender Day of Visibility”

The purpose of Biden’s “Transgender Day of Visibility” proclamation is to increase the number of children who experience gender dysphoria.

The understandable controversy regarding Joe Biden’s smear of Easter Sunday was the timing of his



“Transgender Day of Visibility” proclamation, which he released on Good Friday. But, by itself, that misses the main point.

What did Biden’s proclamation actually say? It was two pages long and more than 630 words. The content of that proclamation is a good marker of what Biden’s agenda is and what a second term would look like.

It is clear that the purpose of the proclamation is not to provide aid and comfort to individuals, and particularly children, who are suffering from gender dysphoria. Its purpose is to increase the number of children who experience gender dysphoria by literally encouraging it.

Transgender individuals are not suffering from a biological disease. They are suffering from a mental disorder, even if so-called “medical professionals” refuse to admit it.

If a president issued a statement on World Schizophrenia Awareness Day, it would not begin by honoring the “extraordinary courage” of schizophrenics. Nor would it declare that they “help America thrive.” That would make no sense. They are suffering from a disease.

Let’s say a president issues a proclamation that says we should love children confused about their gender. One might wonder why that particular group of suffering people was being singled out, but you could do that in a paragraph or two, just like Biden’s Easter statement. The reason Joe Biden took two pages for his “Transgender Day” proclamation is because he professed his total support for the ideological agenda of this fringe

movement.

He also expressed his disdain for anyone who disagrees with him. There was more language in the statement hating on parents and normalcy than there was loving on trans kids. For example, the president of the United States took a shot at parents who don’t want their

young children exposed to confusing ideas about choosing their gender and the rest of the LGBTQ agenda. That’s most Americans. But Joe Biden claimed they were “banning books.”

He said that laws protecting girls’ sports and protecting children from mutilating surgeries were “hateful,” “terrifying,” and “un-American.”

Biden again endorsed the misnamed “Equality Act” in this proclamation. This legislation seeks to elevate transgenderism as a protected civil rights class equal to race and religion.

If a school didn’t allow black athletes to play on an all-white team, there is a moral and legal consensus in America that such bigotry is wrong, and the school would lose its federal funds. However, in Biden’s statement issued on Good Friday, he indicated that he would punish any school that refused to allow a 180-pound boy to play on the girls’ basketball team and shower with the girls. In Biden’s opinion, any school or community against that is in the throes of bigotry and no different from racists. That’s what Joe Biden wanted us to celebrate on Easter.

A Statement Of Support

As I noted above, Biden’s proclamation pledged his loyalty to the extreme transgender agenda. It was a statement of support and encouragement. He declared to the trans community, “You are loved. You are heard. You are understood... You are America ... and I have your back.”

Can you imagine Joe Biden saying that about MAGA Americans? There

are about 80 million of us. No, he wouldn’t. In fact, he’s called us “semi-fascist.” Would Biden say that about people who love Jesus and love America? They’re being attacked left and right. They’re being excoriated in the media and popular culture. They’re being labeled “a danger to the country.” Elements of the federal government seem to think they are dangerous terrorists. The Big Picture: Trans Day

The president of the United States did not say one word indicating that he was hoping and praying persecuted Christians would be able to worship in safety. Attacks on churches in America are at record highs. There was not one word by the president this weekend calling on people (his voters) to stop attacking churches and synagogues.

New Study: Kids Grow Out of Gender Confusion. Lawsuits Ahead?

Just days after President Biden proclaimed March 31 “Transgender Day of Visibility,” the Daily Mail has reported what anyone not taken in by “transgender” propaganda already knew: Young people grow out of “gender dysphoria” or confusion if given the chance. It’s what your grandmother would have called a “phase.”

More important than the study, though, is what it means for the kids rushed into chemical castration and mutilating surgeries. It’s powerful ammo in the lawsuits they will file to punish the doctors — and possibly some parents — who swallowed the fake science pushed in “transgender” propaganda.

The Study

“The majority of gender-confused children grow out of that feeling by the time they are fully grown adults,” the website reported: “Researchers in the Netherlands tracked more than 2,700 children from age 11 to their mid-twenties, asking them every three years of feelings about their gender. Results showed at the start of the research, around one-in-10 children (11%) expressed “gender non-contentedness” to varying degrees. But by age 25, just one-in-25 (4%) said they “often” or “sometimes” were discontent with their gender.” The researchers concluded: “The results of the current study might help adolescents to realize that it is normal to have some doubts about one’s identity and one’s gender identity during this age period and that this is also relatively common.”

“This study provides even more reason to be skeptical towards aggressive steps to facilitate gender transition in childhood and adolescence,” the Ethics and Public Policy Center’s Patrick Brown told the Mail. “The fact that

rates of satisfaction are lower even just a few years later suggests that for the vast majority of people, prudence and caution, rather than a rush towards permanent surgeries or hormone therapies, will be the best approach for teenagers struggling to make sense of the world and their place in it.” Thus, he said, public policy must forbid “gender transition,” as science deniers call the biological impossibility.

The Mail claimed the study’s drawback was that it studied kids in the general population instead of those “clinically diagnosed with gender dysphoria.” The researchers studied 2,770 people in the “Tracking Adolescents’ Individual Lives Survey,” and asked them to “respond to the statement ‘I wish to be of the oppo-

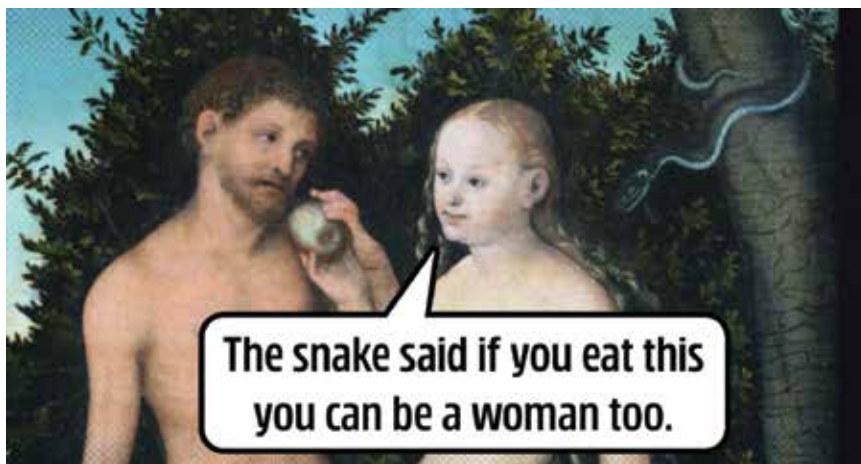

site sex’ at six different points over 15 years.”

Continued the Mail: Researchers looked for those expressing “gender non-contentedness,” or unhappiness with being the gender aligned with their biological sex. The study, published in the journal Archives of Sexual Behavior, found that overall 78% of people had the same feelings about their gender over the 15 years. Around 19% became more content with their gender and just about 2% became less comfortable.

Brown told DailyMail.com: “As anyone who has ever been a teenager knows, puberty and its after effects can be a confusing time of hormonal surges, physical changes, and social insecurity. “It isn’t surprising that the highest rates

of being dissatisfied in one’s body would peak during this time.” Yet Tranny Madness has gripped the country, a graphic in the story shows.

Diagnoses of “gender dysphoria” from 2018 and 2022 — concomitant with the rise of “transgender influencers” on social media — increased massively: 274% in Virginia, 247% in Indiana, 193% in Colorado, 171% in South Carolina, and 143% in Washington state.

Lawsuits Coming

The study’s result suggests that headshrinkers and other doctors such as surgeons and endocrinologists who provide “gender-affirming care” had better double up on their malpractice insurance.

As Dr. Paul McHugh, psychiatry professor emeritus at Johns Hopkins University, has explained, gender dysphoria — as opposed to merely being a tomboy — is a treatable condition akin to anorexia nervosa or any other body dysphoria. “Its treatment should not be directed at the body as with surgery and hormones any more than one treats obesity-fearing anorexic patients with liposuction,” he explained in 2015: “The treatment should strive to correct the false, problematic nature of the assumption and to resolve the psychosocial conflicts provoking it. With youngsters, this is best done in family therapy.” McHugh also explained that adult men such as Bruce Jenner, who goes by Caitlyn,

cross-dress for a sexual thrill.

That aside, the lawsuits have begun. Luka Hein has sued the doctors who affirmed her “self-diagnosis” that she was the “wrong gender.” They chopped off her breasts, a procedure called “top surgery” in tranny propaganda. She was 16 years old. Due to her age and catastrophic life, she “was incapable of understanding the lasting consequences of her decision,” the lawsuit says. The doctors, then, were negligent, the lawsuit alleges. After Hein’s parents divorced, she cut herself and entertained suicide. An online sex predator traumatized her, and her psychological problems worsened, which is when she began wondering about “gender transition.”

A pro-tranny headshrinker pushed her to become “transgender,” the lawsuit alleges, by encouraging her to join a homosexual support group and discussing “chest-binding.” She found “more information about transgender people and began reading and listening to their stories.” But worse still, doctors planned “top surgery” on her “very first visit” to a gender clinic. Though the doctors amputated her breasts, her parents wisely refused to allow a hysterectomy.

As for the president, in his proclamation for “Transgender Day of Visibility,” he told those confused about their sex that “You are loved. You are heard. You are understood. You belong. You are America, and my entire Administration and I have your back.” He didn’t tell them “you need a psychiatrist.”

Both agree the U.S. government has borrowed its way into disaster with the only way out being to debase the currency. Pal estimates the debasement to be 15% a year and thus if your investments and income isn’t rising by that much you are falling behind. Schiff doesn’t put a percentage on the money printing or debasement but essentially agrees. What a person is to do is where they disagree.

“People who are getting out of the dollar or the euro and buying Bitcoin have jumped out of the frying pan into the fire,” Schiff said. “I mean, so you don’t have to reinvent the wheel if you want to get out of Fiat currencies, you can own gold, but you could also own other good inflation hedge assets, real assets.”

Making his case for Bitcoin, Pal said, “We’ve memed a trillion dollar currency into existence. We’ve memed it. It’s just a human narrative. But guess what? So’s gold. So is everything that we do, including religion. Everything is a meme. So memetics rule the entire

way that humans understand the world around them.”

The word Meme was coined by the British evolutionary biologist Richard Dawkins in his 1976 book *The Selfish Gene*, from Greek *mimēma* ‘that which is imitated’, on the pattern of gene. Thus, this definition is derived; “an element of a culture or system of behavior passed from one individual to another by imitation or other non-genetic means.”

So while Schiff argued for holding gold because it is a “real” asset, Pal views gold (and everything else we presume) as just a belief. Forget the yellow metal is number 79 on The Periodic Table. Forget the U.S. dollar was once represented by 1.60 g (24.75 grains) of gold. Forget as Martin Zweig wrote in the *Wall Street Journal*, “Adjusted for changes in the cost of living, an ounce of gold has approximately the same purchasing power it had in ancient Rome 2,000 years ago.”

He claims gold is only valuable just because humans think it’s valuable. Our forefathers thought it had value and that belief is passed on to us. Pal believes that Bitcoin’s 14 years of existence give it the same qualities and will not fall victim to what the economist Joseph Schumpeter called “the perennial gale of creative destruction.”

Schiff countered that Bitcoin has a price, but has no value. The fact a Bitcoin has gone from less than a \$1 to \$70,000 makes it no better than tulip bulbs in 17th century Amsterdam or Beanie Babies in the mid-1990’s. Bitcoin is merely a vehicle for speculation.

Schiff’s contention that buyers of Bitcoin are “stupid” and its price will go to zero annoyed Mr. Pal. In turn, Mr. Pal’s contention that Bitcoin is the greatest performing financial asset of all time rankled Schiff.

“Peter, it’s been around 14 years,” an exasperated Pal argued. “We’ve gone through four cycles where it’s gone down 90% and it still is the best performing asset. So your, ‘Oh my God scenario goes down 90% [is no big deal].’ I’ve gone through three of those myself.”

The ex-hedge fund manager who retired at 36 makes 14 years sound like forever. For folks my age 14 years ago seems like yesterday. Pal’s continued emphasis on Bitcoin’s 14 year existence makes Schiff’s argument better than Schiff himself did.

“Obviously we don’t need these ETFs. That’s just the manufacturer to try to pump up demand. But yes, it’s easy to store your Bitcoin relative to gold, but the difference is when you’re storing gold, you’re storing something. And so since you have something, it takes some effort to store it,” Schiff said “When you’re storing Bitcoin, you’re storing nothing. So what good is the fact that it’s easy to store nothing? Yes, I’ve got a very safe, secure supply of nothing and Bitcoin though, as long as people think it’s going to go up, as long as they maintain that delusion and

more people want to buy it, sure, it will have a price. And if enough people don’t sell it, then some people can, right?”

Pal responded that that was the case with all investments. To which, Schiff excitedly shouted, “No it’s not. No it’s not. Gold is an actual commodity that’s used.”

Pal poo-pooed this argument claiming just a small percentage of gold is actually used. He dismissed jewelry use. Which Schiff countered with, “But they’re not wearing their Bitcoin.” Schiff mentioned gold’s use as a conductor of electricity. He might have roused Pal’s attention with “gold is utilized to mount processing chips onto motherboards” of computers.

Launching again into attack mode Schiff said, “But eventually the story blows up. You know, people stop believing in the fairy tale. You know, you talk about all these young kids that think they’ve reinvented the wheel and think that

they know more than their parents or their grandparents. You know, it's like, look, you know, little kids believe in all sorts of things.

They believe in the tooth fairy. They believe in the Easter Bunny and Santa Claus, you know, but they don't believe in these things for their

whole lives. As they get older, they start to see the truth. And I think the same thing is going to happen with Bitcoin. People are going to grow up and they're going to learn from the mistakes of their youth."

At the end of the Jimmy Carter presidency the Gold Commission was approved and was formed early in the Reagan Administration. The commission was packed with an-

ti-gold types with Ron Paul carrying the torch for the minority. Paul had Murray Rothbard ghost write the minority report with Paul and businessman Lew Lehrman signing as authors.

In Lehrman's new autobiography The Sum of It All, Lehrman distances himself from the report. Canadians Protest Trudeau's Carbon Tax

As the calendar flipped to April this week, consumers in Canada were hit with a steep 23-percent increase in the nation's carbon tax. The tax, originally instituted in 2018, is aimed at reducing emissions of greenhouse gasses, which climate zealots argue are leading to global warming, which creates out-of-control climate change. The federal carbon tax went up to \$80/tonne from \$65/tonne on Monday.

Consumer anger over the increase boiled over into nationwide protests on Monday. Protesters snarled traffic in several cities, and the RCMP was called in to maintain order. Protesters temporarily blocked the Trans-Canada Highway, which links Nova Scotia and New Brunswick. Protesters nationwide carried signs that read "Axe the tax" and "Trudeau must go."

"We've had enough," Jeff Galbraith, a People's Party of Canada candidate, said at a rally in British Columbia. "I think we got a lot of frustrated, disillusioned, disheart-



ened, disenfranchised Canadians. A majority of Canadians ... they feel they have no voice anymore."

In New Brunswick, mechanic Samuel Field spoke on behalf of his customers. "It's important for me to stand up for them, because I'm there to provide for them," he said. "I want us all to succeed. It's not good what's going on. Our industries are being destroyed, our communities are being destroyed, it's hurting our families."

Trudeau countered that Canadian families are set to receive their quarterly rebate checks later this month. Those rebates are also increasing and are heavily weighted toward Canadians with lower incomes so, in a sense, they represent cli-

mate-based wealth redistribution.

Prior to the April 1 increase, seven premiers from the provinces — including Canada's only Liberal Party premier New Foundland's Andrew Furey — called for Trudeau to halt the proposed increase. In a letter

to Trudeau, Furey asked the prime minister to convene an emergency meeting of Canada's leaders to discuss alternative ways of addressing the so-called climate crisis.



"I therefore call on you to pause the April 1 carbon tax increase until the affordability and infrastructure issues improve," Furey wrote. Conservative Party leader Pierre Poilievre also called for Trudeau to meet with premiers.

"I am requesting that, within six weeks of receiving this letter, you convene an emergency meeting of Canada's 14 first ministers to discuss the carbon tax crisis," Poilievre wrote. "Included in these discussions should be your willingness to allow provinces to opt out of the federal carbon tax and pursue other responsible ideas for lowering emissions without taxes."

Trudeau hit back at Poilievre in a statement issued by a spokesman: "Meanwhile, Pierre Poilievre, who

has yet to show any credible plan to tackle climate change, is lying about how the price on pollution impacts affordability, and wants to cancel the same Canada Carbon Rebate that puts more money back in the pockets of eight out of 10 Canadians."

Premiers from the four Atlantic provinces were joined by premiers from Saskatchewan, Alberta, and Ontario in asking Trudeau to rethink the nation's carbon tax policy. Previously, Saskatchewan stopped collecting and remitting the carbon tax.

Saskatchewan Premier Scott Moe also called upon Trudeau to call a meeting of the premiers to discuss the carbon tax.

"It's time for leaders to listen to the overwhelming majority of Canadians

who oppose the carbon tax and the way it is increasing the cost of living. Canadians expect us to work together and that's why we are asking the Prime Minister to hold this important meeting," Moe posted on X. When asked whether he would call that meeting,

Trudeau continued to hammer home his climate-crisis message and wealth-redistribution scheme.

"I will continue to talk with premiers, but I will continue to be pressing Andrew (Furey) and all others on the actual facts, that we have a plan to fight climate change that puts more money back in the pockets of Canadians that need it," the prime minister said.

Poilievre and other Conservatives in Canada believe that the next general election, which must take place no later than October 20, 2025, should be a de facto referendum on Trudeau's carbon tax. In his zeal to enact a "great reset" with climate change as humanity's focus, Trudeau has neglected the needs of Canadian citizens.

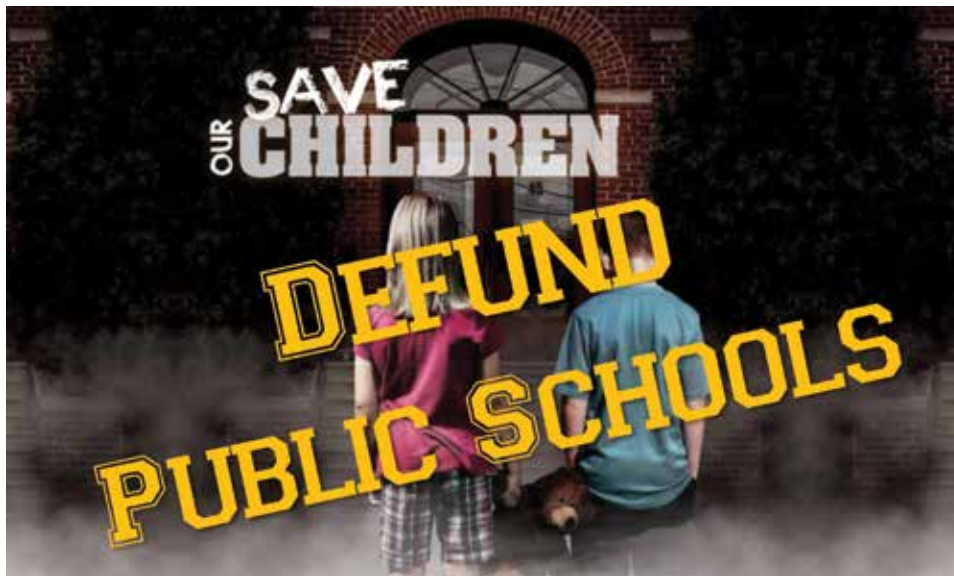

How to Spot and Treat a Heart Attack

In the U.S., a heart attack occurs every 40 seconds, impacting approximately 805,000 people annually. Among them, 605,000 experience their first heart attack. Further, in about 1 in 5 cases, the heart attack is “silent,” meaning heart damage has occurred, but the person isn’t aware of it.

Knowing the symptoms of a heart attack — and the related but different cardiac arrest — is important so you can get emergency medical care without delay.

What Is a Heart Attack — and What Are the Symptoms?

A heart attack, also known as a myocardial infarction, occurs when blood flow to the heart becomes suddenly blocked. Without enough oxygen, the heart muscle becomes damaged and may begin to die, which is why restoring blood flow quickly is essential. Most often, there’s a complete or partial blockage in an artery near the heart that causes the heart attack. Coronary heart disease, which involves plaque building up in the arteries, is often a contributing factor. The plaque build up can narrow the arteries, blocking blood flow. Common symptoms of a heart attack include:

- * Chest pain, including feelings of pressure, squeezing or fullness
- * Feeling light headed or weak
- * Pain in the jaw, neck or back
- * Pain in arms or shoulders
- * Shortness of breath

These symptoms may come and go and can vary in intensity. Low levels of oxygen in the blood, known as hypoxemia, can also occur, as can pulmonary edema, which is fluid accumulation in the lungs. If the heart is unable to supply blood to the body, a sudden drop in blood pressure, or cardiogenic shock, can also occur.

What Is Cardiac Arrest?

Cardiac arrest occurs suddenly due to a malfunction in the heart that causes it to stop beating. Some cases of cardiac arrest have no symptoms. In other instances, fatigue, shortness of breath, chest pain, dizziness, nausea, heart palpitations (fast or pounding heart beat) or loss of consciousness may occur prior to the event.

While blood loss, lack of oxygen and

high levels of potassium and magnesium — which can cause arrhythmia, or irregular heartbeat — can lead to cardiac arrest, there are three primary causes.

- 1. Arrhythmia** — An electrical signal in the heart may lead to an irregular heartbeat known as ventricular fibrillation, which is the No. 1 cause of cardiac arrest. It describes a heartbeat so rapid that the heart trembles instead of pumping blood.
- 2. Cardiomyopathy** (enlarged heart) — This leads to abnormal heart contractions.
- 3. Coronary artery disease** — If coronary arteries become blocked by plaque, it restricts blood flow to the heart. Left untreated, this may lead to heart failure or arrhythmia, which can trigger cardiac arrest.

While cardiac arrest often occurs without warning or a known underlying cause, there are certain risk factors known to increase the risk, which include: smoking, alcohol or drug abuse, family history of heart disease or cardiac arrest, high blood pressure, obesity, heart disease, and low potassium or magnesium.

What’s the Difference Between Heart Attack and Cardiac Arrest?

Unlike a heart attack, which occurs due to obstructed blood flow to the heart — typically with the heart main-



taining its rhythm — a cardiac arrest results in loss of consciousness and absence of a pulse. As noted by the American Heart Association (AHA), “A heart attack is a ‘circulation’ problem and sudden cardiac arrest is an ‘electrical’ problem.”

The most immediate and recognizable difference is that a heart attack sufferer remains conscious with a beating heart, whereas an individual experiencing sudden cardiac arrest loses consciousness and lacks a detectable heartbeat. While a heart attack disrupts the heart muscle’s oxygen supply, cardiac arrest interferes with its electrical impulses.



During a heart attack, reduced blood flow may deprive part of the heart of oxygen, yet other segments of the muscle continue contracting.

Conversely, physical ailments such as cardiomyopathy, heart failure or arrhythmias affect the heart’s electrical system during cardiac arrest. Notably, experiencing a heart attack heightens the risk of sudden cardiac arrest due to the impact on the heart’s electrical system caused by oxygen deprivation. In essence, insufficient oxygen supply to the heart muscle during a heart attack impairs its electrical impulses, potentially precipitating cardiac arrest.

What to Do in the Event of a

Heart Attack or Cardiac Arrest

Both a heart attack and cardiac arrest are life-threatening conditions that need emergency medical attention. Call 911 and get to an emergency room as soon as possible. If you have access to an automated external defibrillator (AED), it should be immediately used to assist a person in cardiac arrest, in which the person is unresponsive and not breathing. AEDs are required in certain public spaces in many U.S. states, including schools, athletic facilities, casinos and public golf courses. When emergency medical personnel arrive to help a person in cardiac arrest, they will use a defibrillator immediately. After the shock is delivered, begin cardiopulmonary resuscitation (CPR) or chest compressions immediately, continuing for two minutes before checking to see if another shock is needed.

If you don’t have access to an AED, CPR or chest compressions should be given to the person in cardiac arrest while you wait for emergency personnel. For people with healthcare experience or those proficient in CPR, AHA advocates for traditional CPR, involving chest compressions and mouth-to-mouth breathing, in a 30-to-2 ratio — 30 compressions followed by two breaths, repeating this sequence.

For the general populace, AHA recommends and emphasizes the efficacy of hands-only CPR, also known as compression-only CPR. The gist is to push hard and fast in the center of the chest. Acting fast is crucial, as each minute that CPR is delayed, the person’s chance of survival goes down by 10%. So doing something, even if it isn’t perfect, is usually better than doing nothing. Fortunately, hands-only CPR is straightforward and involves the following steps:

- * Perform chest compressions at a rate of 100 to 120 per minute. This is about the same beat as the song “Stayin’ Alive,” which is 100 beats per minute.
- * The compressions must be done with enough force, to a depth of about 2 inches for an average adult
- * Don’t stop; minimize interruptions in chest compressions
- * Avoid leaning on the patient between compressions

Sadly, about 90% of people who experience cardiac arrest outside of a hospital setting die. However, if CPR is administered immediately, the person's chance of survival can double or triple.

Methylene Blue and Melatonin — Two Must-Haves in Case of Heart Attack

I recommend having methylene blue — the precursor molecule for hydroxychloroquine and chloroquine — and melatonin readily available at home in case of a heart attack. While sudden death is the most common symptom of heart disease, surviving individuals face the serious threat of reperfusion injury, where cellular dysfunction and death may worsen following the restoration of blood flow.

Methylene blue administration can significantly mitigate tissue damage; however, proper dosage is crucial to avoid overdose. Use a microspoon for precise measurement, as discussed in my interview with Francisco Gonzalez-Lima, Ph.D., an expert on methylene blue. [interview can be found on TFPnews.com]

For nonacute, longer-term treatments, including dementia prevention and treatment, post-stroke care, cognitive enhancement and overall health optimization, low doses of 0.5 milligram (mg) to 1 mg per kilogram of body weight are recommended.

Additionally, keep melatonin on hand in a 10 mg sublingual dose. This potent antioxidant can minimize reperfusion injury if taken immediately after a heart attack or stroke. Adminis-

ter methylene blue within minutes of the cardiac event as well to meet the critical time threshold, underscoring the importance of keeping these items in your emergency medical kit.

Heart Attack Treatment, Recovery and Prevention

Once you are in the hospital, doctors will work to stabilize your condition by providing oxygen and medications to dissolve blood clots. Interventions to help restore blood flow, including coronary angioplasty and coronary artery bypass, may also be needed. Many people not only survive heart attacks but go on to live long, healthy lives post-attack.

Cardiac rehabilitation is often recommended and involves a supervised program of physical activity, dietary changes and stress relief. For many, normal activities can be resumed within a few weeks of the event. Keep in mind that once you've had a heart attack, your risk of another increases.

This is why lifestyle changes are so important, not only for building a healthy heart, but for keeping it that way. This includes eating right, avoiding excess linoleic acid from seed oils, exercising, dealing with stress and getting proper sleep. For instance, women with low fitness levels have a higher risk of dying from any cause, including cardiac arrest. While cardiac arrest often occurs unexpectedly, leading an ongoing heart-healthy lifestyle is the best approach to prevention.

With that in mind, many conditions, including heart disease, appear to be rooted in mitochondrial dysfunction.

Ubiquinol — the reduced, electron-rich form of coenzyme Q10 (CoQ10) that your body produces

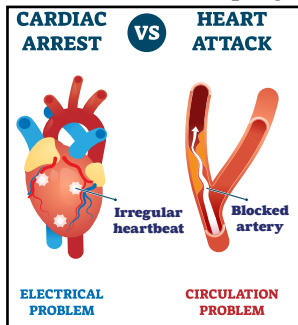
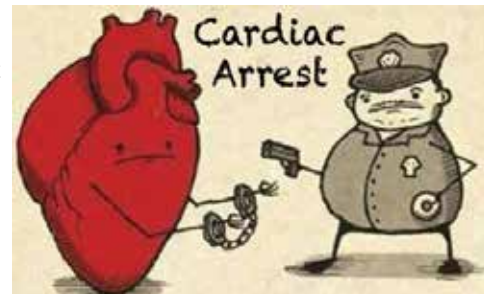
naturally — plays an important role in the electron transport chain of your mitochondria, where it facilitates the conversion of energy substrates and oxygen into the biological energy (adenosine triphosphate, or ATP) needed by your cells for life, repair and regeneration.

If you don't get enough of this important compound, your heart health could suffer, as CoQ10 is a key player in heart health. In fact, 75% of ischemic heart disease patients have low levels of CoQ10.

Depending on your age and health status, supplementation may be necessary to keep your CoQ10 levels high enough for optimal health. Young people are

able to use CoQ10 supplements quite well, but older people do better with ubiquinol, as it's more readily absorbed.

The suggested dose is usually between 30 mg to 100 mg per day if you're healthy, or 60 to 1,200 mg daily if you're sick or have underlying health conditions. If you have an active lifestyle, exercise a lot or are under a lot of stress, you may want to increase your dose to 200 to 300 mg per day. If you take a statin drug, you need at least 100 mg to 200 mg of ubiquinol or CoQ10 per day, or more. Ideally, you'll want to work with your physician to determine your ideal dose.

Attack on Small Farmers: Update on Engineered Famine in Oregon

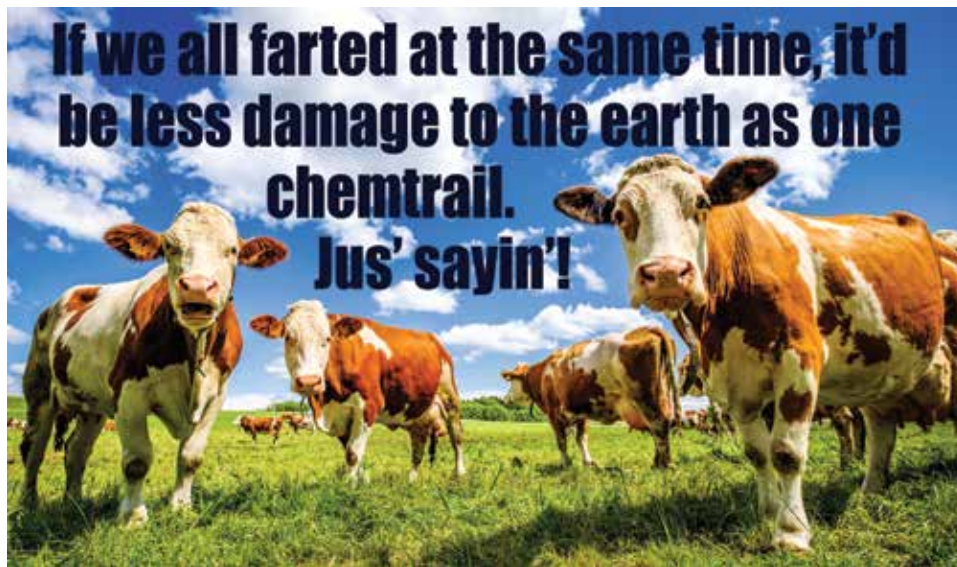
An engineered famine in Oregon targets small farmers as deceptive CAFO regulations trigger the fight for agricultural freedom.

The schemed famine has commenced in Oregon. Under the guise of water conservation and protecting groundwater, the state of Oregon has been aggressively closing small farms and market gardens. In the same way that big hospitals use government-issued certificates of need to block competing projects or land developers use eminent domain and fake blight to drive out property owners, Oregon bureaucrats are erroneously labeling small family farms as concentrated animal feeding operations (CAFOs) and restricting their use of water to effectively shut them down “for the environment.”

Significantly, the small farms under attack are not at all CAFOs. However, due to Oregon’s government and the state’s lucrative dairy industry joining forces, the overregulation is enough to drive many small farmers out of business. In its directive defining “what is a CAFO,” which was reinterpreted in 2023, the state describes a CAFO as “the concentrated feeding or holding of animals or poultry, including but not limited to horse, cattle, sheep, or swine feeding areas, dairy confinement areas, and poultry and egg production facilities where the surface has been prepared with concrete, rock or fibrous material to support animals in wet weather.”

Thanks to the state’s cleverly worded definition, the legislation effectively targets small farms. For example, a few-acre homestead with pasture, two milking cows, and a few chickens qualifies as a CAFO if it has any spot on the property that uses gravel or rock as a pathway to reach a small barn or a coop. The National Review noted that with significant implications and a steep price tag, a small farm labeled as a CAFO would have to install drain lines and holding tanks exceeding \$100,000 to provide equipment the farm neither needs nor wants.



Besides CAFO regulations, a policy put in place in 2021 during the pandemic tyranny restricts the way farmers can use water. Legally, rainwater is the only water that farmers are allowed to collect in Oregon. All the other water—from rivers, streams, and even groundwater on private properties—is considered a public resource. This means farmers in Oregon cannot use water from their own private wells to irrigate their crops and hydrate their animals without first getting a permit. This is yet another sneaky tactic strategically established during COVID to destroy small business owners.

Not taking the dire situation lightly, small farmers in Oregon are fighting against the new CAFO legislation. Sarah King, who owns Godspeed Hollow Farm in Newberg, filed a lawsuit against the state’s Department of Agriculture, alongside other Oregon farmers. King began her small milk-producing operation on her eleven-acre property in 2017. She and her husband own no more than two or three milking cows at a time. King explained that they intentionally keep things simple, noting that their animals know the routine. Free to wander most of each day, she said that her well-loved cows often come in from the fields and wait in the barn for their

turn to be milked, then back out they go. The National Review explained: Sarah’s clients contract with her in a “herdshare” system: They purchase an interest in the animal for a portion of its produce. They like the sustainable, ethical, transparent business model — and the raw milk that comes with the arrangement.

Industrial dairy farms follow a different model. They aim for efficiency and economies of scale by keeping tens of thousands of cows. These operations keep the livestock penned up for extended periods of time, producing significant waste in concentrated spaces.

Any sentient being who ponders the heartbreaking reality behind industrial dairy farming for more than a split second surely concludes that tens of thousands of cows penned up back to back for hours on end is cruel and inhumane. But alas, that aspect is left out of regulations which are strictly formulated with the deep state’s quest for profits and control.

There is a fundamental difference between the environment-ruining Big-Farm practices carried out in Industrial farming and the intentional methods employed at Godspeed Hollow. Indeed, Godspeed Hollow, one of Oregon’s smallest players in the

farm game, is no threat to Industrial Farming, thus the reinterpretation of the CAFO rules makes no sense, unless, as we’ve stated before, it’s about something bigger. After all, Sarah’s animals are only “confined” for 15 minutes per day and are otherwise free to graze and roam.

The forced famine underway in Oregon and elsewhere is undoubtedly tied to the Great Reset, which was fast-tracked here in the United States in August 2022 when President Biden signed the Inflation Reduction Act (IRA). A deceitfully clever path towards the global elite’s much anticipated green energy transition, the IRA contains \$394 billion in tax incentives, grants and loans directed at green investments in the sectors they aim to control. Globally, despite the massive farmer protests largely ignored by big Pharma-funded mainstream media, eliminating small farmers is at the top of the list.

How much longer can the voice of the people—both here and abroad—be silenced? If those trying to destroy our health and take away our right to choose the food we eat have their way, freedom as we know it will no longer exist. Importantly, with that in mind, speaking up pays off. For now, Sarah and other small farmers in Oregon have a reprieve from the ridiculous CAFO rules thrust upon them. While the lawsuit is in play, the Oregon Department of Agriculture has agreed to, for now, put a halt to enforcing its revamped CAFO rules, which were slated to take effect on April 1.

Nonetheless, a tough battle lies ahead for small farmers across America, from being forced to calculate greenhouse gases to exposure to GMO seeds. To fuel his agenda, the Biden administration has handed billions in taxpayer dollars to the nation’s largest agriculture corporations, associations, and universities to destroy small farmers. With grandstanding led by Bill Gates, mega companies from Cargill to the Nature Conservancy are on board, with \$40 million in advertising dollars to Farm Journal to control the message put out by the state-run mainstream media.

Government Cheapskates: America Has Paid A Total of \$38,893 to Avalanche of COVID Vaccine Injured Citizens

What Americans were sold during the COVID vaccine rollout hype was an injection to return to normal – medical blackmail. A two-dose series turned into multiple boosters, as high as nine now recommended by the CDC if you are counting. As many capitulated, no public spokesperson or mainstream media outlet marketing the shot uttered a word about its safety or what would happen if someone was harmed by the rushed, experimental product... a tactic called strategic silence.

A 'black hole' for COVID vaccine injury claims was the title of a June 29, 2021 Reuters article describing the Countermeasure Injury Compensation Program, or CICIP, run by the Health Resources and Services Administration. A program few Americans ever knew existed and probably still don't.

This is the program people who are injured by the COVID shot get tossed into if they are educated enough to recognize the harm from the shot and their doctor understands and is courageous enough to file a claim. Here are a few other stipulations that matter:

- No attorney & medical expert fee reimbursement
- 1-year statute of limitations (from the date of administration)
- No reimbursement for future medical care
- No pain & suffering damages
- No appeal to a higher court in the

CICP

- No medical testimony or hearings. You vs Secretary of HHS
- Lack of transparency on reporting of decisions

It's been three years since the COVID vaccine rollout and hundreds of millions of doses later, compensation for injury is still lacking to the point it borders on criminal. The CICP has recently released their monthly updated injury compensation numbers – three weeks late for those keeping an eye on them.

From the CICP data:

- Total COVID-19 CICP claims filed: 13,031
 - Pending or In Review: 10,588
 - Decisions: 2,443
 - Claims found eligible for compensation: 43
 - Claims compensated: 11
- For a grand total of...\$38,893.

Proponents of COVID vaccine safety will use this number, 11, as proof the vaccine is indeed safe ignoring how the CICP is monumentally unfit for its current purpose.

Speaking to Wayne Rohde, author of The Vaccine Court and host of Right on Point podcast about the CICP program, he said, "The CICP was never designed for a long-term, nationwide pandemic public health crisis."

Meanwhile, as the public tries to piece together the true human dam-

age caused by the COVID shots, we take a look at another broken, unfit program in the CDC's Vaccine Adverse Event Reporting System (VAERS). Can you spot an issue once the COVID shots began going into American arms on an industrial scale in 2021?

In addition to the deaths, there have been 214,906 hospitalizations, 154,245 urgent care visits, 242,537 doctors office visits, 10,767 cases of anaphylaxis, 17,688 cases of Bell's palsy, 5,115 miscarriages, 21,524 heart attacks, 28,215 cases of myo/per-carditis, 69,936 cases of 'permanently disabled,' and 39,544 'life-threatening' and so many more



reports to VAERS after the COVID shot. In all, a total of 1,630,913 reports.

Let's take a moment to do some math here. VAERS is a system that is notorious for underreporting. A study of the system found "fewer than 1% of vaccine adverse events are reported." Assuming the current number of VAERS reports of 1,630,913 is only 1%, the true number may be closer to something like 163,091,300.

Last month FDA director of the Center for Biologics Evaluation and Research Dr. Peter Marks appeared before the Select Subcommittee on the Coronavirus Pandemic to discuss possible issues with the fast-tracking of the COVID shots.

When asked by Chairman Brad Wenstrup if the government was prepared for such an avalanche of reports to VAERS, Marks replied,

"We tried to be prepared for that but the avalanche of reports was tremendous."

So on one side with VAERS, we have a broken government intake program getting overwhelmed on the front end while the other (CICP) sees the outflow of compensation for damages and cases awarded administratively throttled. Caught in between are untold numbers of Americans left hanging in the wind shouldering unsettled medical harms and the bills to follow. America can do better.

The entire vaccine damage infrastructure needs a historic overhaul.

From education for medical professionals to recognize and encourage reporting of harms from the shots to greater research on why some are more susceptible than others to vaccine injury while addressing decades of ignored scientific research.

Most importantly, a true compensation mechanism for the injured beyond CICP's pittance and the long-broken National Vaccine Injury Compensation Program. The beginning of a fair compromise should, at the very least, end the product liability shield for vaccine manufacturers.

"Drug companies should be liable in civil court for vaccine injuries and deaths and so should anyone giving vaccines to people being denied the human right to informed consent to medical risk-taking," said NVIC co-founder and president Barbara Loe Fisher. "There is an urgent need to hold vaccine manufacturers and doctors accountable in civil court for the safety of vaccines and how they are being given."

One of the Most Important Supplements

As huge as the nutritional supplement industry is, it's easy to believe that it has always existed. Yet, before 1940, the only nutritional supplement available was a yeast tablet.

Through the 1940's and 1950's it was recognized that for several reasons, complete nutrition was not generally available to most people. Therefore, more concentrated nutritional sources were made available, as supplements. 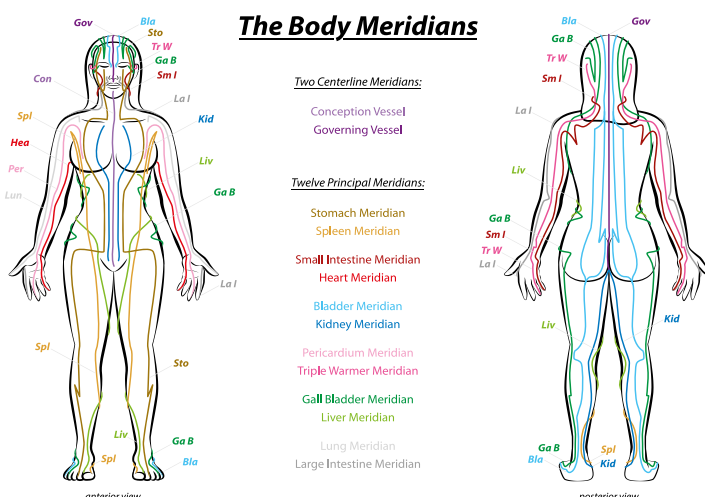

Buckskin Fire Board Declines Renewing the Chief's Contract

On February 13th, at the regular Meeting of the Buckskin Fire Board, an unusually large crowd showed up to protest the proposed renewal of Chief McMahan's contract for two more years. At the Call to the Public, several La Paz residents spoke concerning their interactions with the chief. Among those who spoke were representatives from the Parker Chamber of Commerce, the Roadrunner Resort, the Town of Parker, David Plunkett (speaking as a private citizen) and others.

The complaints about the chief included, but were not limited to, being anti-growth, over regulating, terminating BFD's decades long participation in community events, absentee problems due to his other commitments, and having a general bad attitude with some residents, businesses, and some employees of other government agencies. Also, a video showing the chief recently speaking as a candidate for the office of Mohave County Board of Supervisors District 5, at the Mohave Democrats Blue Wave Luncheon, has

been circulating.

After listening to the complaints concerning the chief the Buckskin Fire Board put the topic of renewing the chief's contract off until the following meeting, which was scheduled for March 20th, and encouraged people to request it be put on the agenda of that meeting so they could fully air their concerns.

Evidently, there was an expectation of a large crowd at the March 20th meeting because it was moved next door to the Sheriff Department's Boating facility. There was a good crowd at this meeting, but it seems like some of the people from outside the boundaries of the Fire District decided not to attend, but Ronnie Simms, a resident of town who sits on the Parker Fire Board, was the first to speak at the Call to the Public. It was Simms's belief that



many of the issues that were raised at the February meeting were Parker Fire Board issues, not the province of the Buckskin Fire Board. Then David Plunkett, who was listed

as a speaker on the meeting's agenda, decided not to speak, presumably because he was representing the current Parker Town Manager, who was unable to attend. However, there were still several people, including La Paz County Supervisor Duce Minor, who spoke at the Call to the Public against renewing Chief McMahan's contract.

The meeting began with a ceremonial badge pinning for Firefighter Jensen Wolfe, then the Call to the Public was held. One notable person in attendance that spoke in favor of the chief was Anna Camacho, La Paz County Assessor. Camacho said that the chief was responsible for solving a problem at the La Paz County office building that had existed for a very long time, causing a multitude of problems for county employees, such as headaches and other ailments. The problem was a broken pipe which Camacho credited the chief for discovering and said its repair has eliminated the long existing problem. Others there in support of the chief were several Buckskin firefighters and others from the community. Among those supporting the chief, who spoke at the Call to the Public,

was Captain Jason Weatherford.

After the Call to the Public and Plunkett declined to speak, the board moved into Executive Session a little before 7 pm. According to the Buckskin Fire District posted Notice/Agenda, the Executive Session was for: "legal advice pursuant to A.R.S. §38-431.03. A.3: possible instructions to legal counsel pursuant to A.R.S. §38-431.03.A.4 and for personnel matters pursuant to A.R.S. §38-431.03.A.1 re: Fire Chief contract and employment terms."

The Executive Session lasted over 3 hours, and when the regular meeting resumed, after approving the minutes from the last meeting and some expense reports, the board chairman, Jeff Daniel, moved the meeting to item 7 on the agenda, "(Discussion & Possible Action): Possible Board action regarding Fire Chief contract." Almost immediately, a motion was made, seconded and a vote was taken; 3 votes against renewing, 1 vote for renewing, and 1 abstention was the result. The chief was given 30 days' notice that his contract would not be renewed.

One of the confusing issues concerning this situation is that Buckskin Fire District and the Parker Fire Department have an agreement in place where the Buckskin Fire chief and the district's secretary also serve as the Parker chief and secretary. No one seemed to know what effect, if any, this move by the Buckskin Fire District would have on that arrangement.

Louisiana's (37-0) Shot Heard Round the World

Louisiana is the first state in the U.S. to pass a bill to end the United Nations, World Health Organization and the World Economic Forum in the state and the globalist organizations to ban rules and mandates.

The Louisiana Senate passed a bill with 37-0 votes to end cooperation between the state and local governments with the UN, the WHO and the WEF. The Senate accuses them of committing a globalist coup and trying to impose their rules and mandates around the world, writes Thepeoplevoice.

Senator Thomas Pressly and two co-sponsors introduced Senate Bill 133 (SB133SB-133) on February 29. The proposed law states: "The World Health Organization, the United Nations and the World Economic Forum have no jurisdiction or power in the state of Louisiana."

The bill describes practical steps to ensure that rules, regulations and mandates of globalist organizations have no power in the Pelican State. "No rule, regulation, remuneration, tax, policy or mandate of any kind of the World Health Organization, the United Nations and the World Economic Forum shall be enforced or carried out by the State of Louisiana or any agency, department, council, committee, political component, state government agency, parish, municipality or any other political entity."

Effective Federal Funds

Tenth Amendment Center report: Based on James Madison's advice for states and individuals in Federalist 46, a "refusal to work with Union officials" is an extremely effective meth-



od of effectively making federal laws unenforceable, as most enforcement actions are dependent on help, support and leadership from the states.

This is just as true for international institutions – probably even more so. These institutions do not have their own enforcement mechanism. All of their power is based on voluntary compliance and enforcement by local jurisdictions.

Fox News senior judicial analyst Judge Andrew Napolitano agreed that such an approach would be very effective. In a television discussion about federal gun laws, he noted that a single state that refuses to cooperate in enforcement would make federal gun laws "almost impossible" to enforce.

The federal government is heavily dependent on the cooperation of states to implement and enforce almost all of its laws, rules and laws. By simply renouncing this necessary cooperation, states can in fact negate many federal actions. As the National Governor's

Association noted during the partial government shutdown in 2013, "States are federal government partners for most federal programs." This enforcement problem is even greater when it comes to international bodies such as the WHO and the UN.

Legal Basis

Some could argue that Louisiana is required to enforce WHO or UN mandates because of treaties, but this does not hold up in any legal investigation.

The Supreme Court has consistently stated that the federal government cannot claim state and local resources for its own purposes. Under the anti-mandate doctrine, states are sovereign entities and can use their resources at their discretion. It follows logically that international organizations cannot claim state and local resources either. Even if the U.S. government is obliged to enforce a U.N. mandate based on a treaty, it does not follow that states must enforce local governments the same.

The anti-dating doctrine is mainly based on five cases of the Supreme Court dating back to 1842. *Printz v. U.S.* serves as the cornerstone. "In *New York*, we ruled that Congress cannot force states to establish or enforce a federal regulatory program. Today we find that Congress cannot bypass that prohibition by directly engaging the officials of the states.

The federal government may not issue

guidelines that require the states to address certain problems, nor instruct the officials of the states or their political subdivisions to conduct or enforce a federal regulatory program. It does not matter whether there is policy-making and there is no need to weigh the burden or benefit on a case-by-case basis; such orders are fundamentally incompatible with our constitutional system of dual sovereignty."

No provision of constitutionality is necessary to appeal to the anti-commandeering doctrine. States and local governments may refuse to implement federal laws or implement federal programs, whether they are constitutional or not.

What Follows

SB133 goes to the House for further treatment. It has been referred to the Commission on Domestic and Government, where it must be heard and adopted by a majority vote before it continues in the legislative process.

Tennessee Senate BANS 'Chemtrail' Geo-Engineering

The bill continues, "The intentional injection, release, or dispersion, by any means, of chemicals, chemical compounds, substances, or apparatus within the borders of this state into the atmosphere with the express purpose of affecting temperature, weather, or the intensity of the sunlight is prohibited."

For years, many have suspected the government's spraying of aerosolized particulate matter into the atmosphere – seen as lingering white cloud trails that don't dissipate – not only manipulates the weather, but also destroys the Earth's ecosystem. The bill comes as top geoscientists recently accused the United Nations

specifically “aerosolized coal fly ash, they say are sprayed out of jets” and “into the troposphere” where it’s “systematically breaking down Earth’s support systems and poisoning life on this planet.”

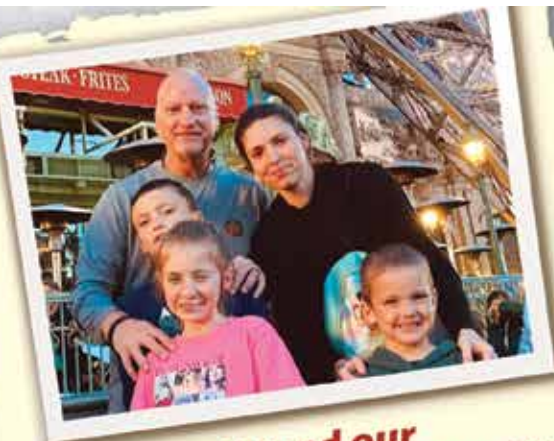

Things They Didn't Teach You in Church:

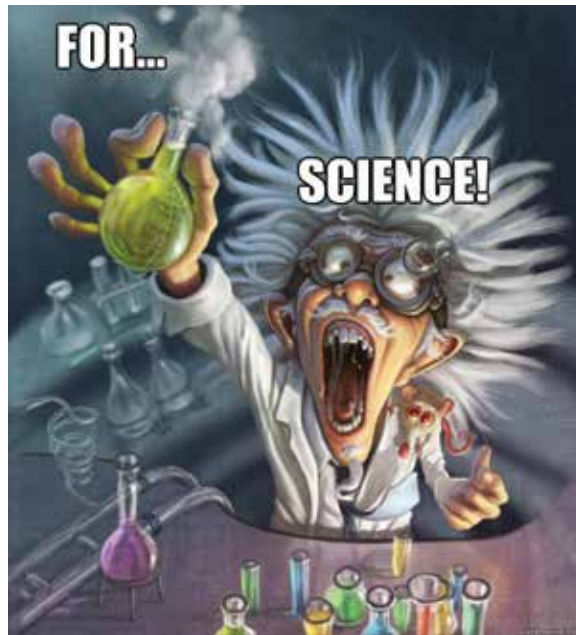

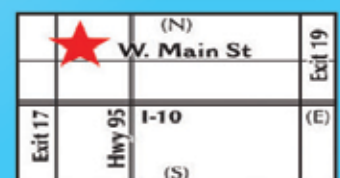
