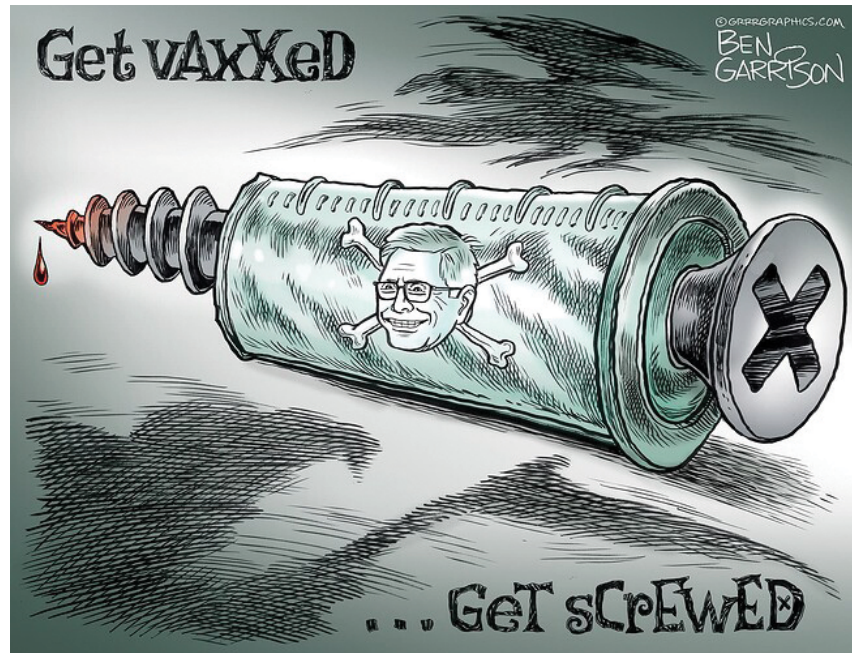
Arizona Republican Party Declares Covid-19 Injections Biological and Technological Weapons, Passed 'Ban the Jab' Resolution! Passed with 95.62% of the vote!

The Arizona Republican Party is now the second state Republican Party to pass the 'Ban the Jab' resolution and declare COVID-19 injections biological and technological weapons.

Shout out to Patriot Dan Schultz! When I reached out to Dan and asked him to submit the resolution, he did not hesitate. Dan submitted the 'Ban the Jab' resolution to the Republican Party of Arizona. The Arizona GOP voted today and passed the resolution with 95.62% of the vote! The resolution declares the COVID-19 injections biological and technological weapons and calls on the Governor to prohibit their distribution, the Attorney General to confiscate the vials, and conduct a forensic analysis of their contents.

In addition to being an attorney, Dan is a former West Point graduate and former U.S. Army counterintelligence and human intelligence officer. Dan Schultz advocates the Precinct Strategy, which seeks to wrestle control of the Republican Party back to the people. Previously, Dan Schultz submitted the 'Ban the Jab' resolution to the Maricopa County GOP. On Saturday January 13th, the Maricopa County GOP passed the resolution with 87.4% of the vote! A total 1494 votes were cast, 1306 in favor, 188 against. Maricopa County is the largest Republican County in the nation.

The text of the resolution submitted by Dan Schultz follows:

Arizona 'Ban the Jab' Resolution:

Whereas: Strong and credible evidence shows Covid 19 and Covid 19 injections are biological and technological weapons, and Pfizer's clinical data revealed 1,223 deaths,

42,000 adverse cases, 158,000 adverse incidents, and approximately 1,000 side effects, and an enormous number of people have died and or have been permanently disabled after having been injected by the Covid 19 injections. Strong and credible evidence from Sweden exists that Covid mRNA shots alter human DNA. Government agencies, media, tech companies, and other corporations have committed enormous fraud by claiming Covid injections are safe and effective. The Florida Department of Health has called for a halt to the mRNA injections, and continued experimentation on humans and denial of informed consent are violations of the Nuremberg Code and therefore constitute crimes against humanity,

Resolved:

On behalf of the preservation of the human race, the 2024 Arizona Republican Party Presidential Nominating Convention Delegates call upon Governor Hobbs and the state legislature to prohibit the sale and distribution of Covid injections and all mRNA injections in Arizona, and for the Arizona Attorney General to immediately seize all Covid injections and mRNA injections in Arizona and perform a forensic analysis on these so-called "vaccines."

Democrats Block Amendment to Require Informing People if They're Eating Bugs

Democrats don't want people to know whether they're consuming products with insect-based ingredients.

Minnesota Senate Democrats rejected an amendment that would have required foods containing insects to be labeled.

Shocker!

The move comes after the Senate this week passed an omnibus agriculture policy bill called S.F. 4225. Before the bill was passed, Sen.

Torrey Westrom (R-Alexandria) introduced an amendment that would require food to be properly labeled if it contains either insect products or artificial "cell-cultured" food like lab-grown meat.

Westrom said, "this just sets forth that if there's bugs in your food for protein, cricket flour, whatever it is, it needs to be labeled. The consumers need to know. If your meat is cell-cultured and grown in a petri dish, you also need to know. Consumers should have that knowledge as they shop in the stores."



Republican colleague Sen. Jim Abeler echoed Westrom's remarks, calling the amendment a "no-brainer." "Let's tell people what's in their food that some people

don't even consider to be food," he said. "Just because there's no money in the bill doesn't mean we can't establish a policy."

The bill's author (Sen. Aric Putnam

D-St. Cloud) shot down the proposal, claiming that although "consumers should know what they are consuming", the issue of labeling insect parts in products was a "future problem" that didn't need to be addressed yet.

"Everybody wants to have consumer awareness of the food that they eat, but some of us want to do it in a thoughtful way," he said. "One thing that came from that discussion is that currently there is only one space in the entire country that is selling cell-cultivated meat and that was a restaurant in San Francisco that has already stopped doing it," Putnam added.

Westrom's amendment was ultimately defeated in a 33-34 vote. Why are Democrats so against this common-sense measure to simply empower consumers by informing them about what's in their food, especially as more "progressive" companies attempt to introduce insect-based products into the food supply? Because they want to force you to "eat the bugs" in the name of fighting climate change, in accordance with World Economic Forum doctrine.



Zimbabwe's New Gold-Backed Currency

The Reserve Bank of Zimbabwe has introduced Zimbabwe Gold, or the ZiG, in paper and coin form, following the new currency's debut as a digital payment method in October. It replaces the Zimbabwean dollar and is backed by a basket of gold and foreign currencies.

The central bank began distributing the physical currency on April 29, and



all of the country's lenders had a supply of it by the end of that day, according to Bloomberg. The launch of the ZiG was announced on April 5, set at an exchange rate of 13.56 ZiG to the U.S. dollar.

Digital trading in the ZiG began on April 2, although it was first introduced in October at a rate tied to the price of gold. The transition to the new currency caused havoc on the local stock market. Businesses

will be required to pay at least 50% of their taxes in ZiG.

The central bank set its interest rate at 20% with the introduction of the new currency, down from a world-high of 130%. Central bank governor John Mushayavanhu

(who took office on March 28) said the inflation rate in Zimbabwe should fall from 55% to 2% annually thanks to the new, more stable currency.

Currently, more than 80% of transactions in

the country are conducted using U.S. dollars, while the Zimbabwean dollar has lost almost 75% of its value this year alone.

The ZiG is backed by 2.5 tons of gold and \$100 million in foreign currency reserves, for a total value of \$285 million. That sum is three times the value of the ZiGs being issued, according to Mushayavanhu. He said at an April 5 press conference: "We want a solid and

got a first dose of Pfizer, felt horrible, had a heart attack on the day of the shot and was sicker than a dog after that. He died 5 days later from an aortic aneurysm.

Experts Agree: Turbo Cancers are Caused by the Toxic mRNA COVID-19 Jabs

We are hearing the term “Turbo Cancer” more and more often. What does Turbo Cancer mean? The phrase, which is essentially a long-term effect of the COVID-19 jabs, describes the long list of aggressive cancers that are rising at a record pace in COVID-19-vaccinated individuals. These Turbo Cancers, most often resulting in rapid death, including but are not limited to Leukemia, colon cancer, esophageal cancer, breast cancer, liver cancer, brain tumors, pancreatic cancers and so on, that grow undetected very, very rapidly, and present at a late stage. When asked by Del Bigtree, “How do these cancers get to such a late stage in often very young individuals without being recognized?” Oncologist Dr. William Makis explained: “I think it’s the rapid growth of the tumors, and they don’t seem to be causing symptoms, so they only present when the tumors are quite large already—they are pretty much stage four, stage three, stage four when they’re presenting. And some of these tumors can grow quite big. Some of these tumor masses can get 10 centimeters, even 15 centimeters. Oncologists are just shocked; they struggle to treat them. They don’t know what to do with these cancers. Even if they try to surgically excise them, thinking that the tumor hasn’t spread, they will find out the tumor has already spread after the surgery; it grows that quickly.”

The Turbo Cancer crisis in the United States is already about as bad as can be imagined. Yet, unfortunately, it is becoming more lethal. What is causing these Turbo Cancers? Issuing grave warnings about the jabs throughout the pandemic, numerous es-

teemed doctors who have studied the unprecedented mRNA COVID-19 injections have all reached the same straightforward conclusion—ingredients in the toxic COVID-19 jabs damage the natural cancer surveillance system intrinsically provided

by our body’s immune system.

Of course, the causes of the influx of Turbo Cancers are much more complex and complicated. Dr. Makis explained that a number of mechanisms have been proposed towards the cause and are starting to get backed by publications and findings in the literature. One significant explanation (also mentioned by Dr. Peter McCullough) is the ingredient N1-methyl-pseudouridine that is inserted into the mRNA. This ingredient—which won the Nobel Prize in Physiology or Medicine 2023—is added to keep the spike protein “alive” longer as it torments the entire body. Yet, in doing so, it alters the activity of critical proteins in the natural immune system, impairing the body’s ability to detect cancers. Typically, these vital proteins, called toll-like receptors, can prevent tumors from forming and growing, but not when pseudouridine-modified mRNA is around. A recent review published in PubMed titled “Review: N1-methyl-pseudouridine (m1Ψ): Friend or foe of cancer” declared: “Mounting evidence indicates that these vaccines (like many others) do not generate sterilizing immunity, leaving people vulnerable to recurrent infections. Additionally, it has been discovered that the mRNA vaccines inhibit essential immunological pathways, thus impairing early interferon signaling. Within the framework of COVID-19 vaccination, this inhibition ensures an appropriate spike protein synthesis and a reduced immune activation. Evidence is provided that adding 100% of N1-methyl-pseudouridine (m1Ψ)



to the mRNA vaccine in a melanoma model stimulated cancer growth and metastasis, while non-modified mRNA vaccines induced opposite results, thus suggesting that COVID-19 mRNA vaccines could aid cancer development.”

Read the last part of that last sentence again—mRNA vaccines could aid cancer development! Remarking on the PubMed review (authored by Rubio-Casillas et al.) Dr. McCullough explained that not only could the COVID-19 mRNA jabs aid cancer development, but they could actually cause and worsen cancer, not make it better. And the more boosters one gets, the more maddening and accelerated the Turbo Cancer becomes. Despite this unsettling evidence, the federal government continues to shake Big Pharma’s hand and simply looks the other way. Not even the American Cancer Society’s (ACS) recent warning of an unexplained surge in new aggressive cancers in the U.S. can spark the Biden administration to contemplate, “Hmmm... maybe we should take a really close look at these COVID-19 jabs.” It is maddening.

Edward Dowd, author of Cause Unknown: The Epidemic of Sudden Death in 2021 & 2022, has reported for months that cancer statistics from the U.K. appear to support the Turbo Cancer claims in young people. Dowd noted a sharp uptick in cases of cancers in the under-45 age group that have already metastasized by the time they are diagnosed. Such cancers are known as “malignant neoplasms without specification of (the original) site (of excessive growth).” Dowd recently noted that, based on trends, cancer death rates should have gone down in 2021 and 2022, but they didn’t. Dowd shared, “We should have seen negative excess deaths, but we didn’t,” adding, “We saw add-ons and add-ons, and the absolute numbers are kind of stunning.”

Likewise, Professor Angus Dalgleish (an expert in immunology and Pro-

fessor of Oncology at St. George’s Hospital Medical School in London) recently referenced the worthless boosters and their contribution to Turbo Cancer. He wrote on April 15 that “the third useless jab (booster) not only has no possible benefit” but shatters what is left of the immune response and controls cancers by suppressing the T cell responses and switching the antibody response to a tolerizing one. Hence, this completely destroys the immune response that had been regulating these underlying cancers. Dr. Makis also confirmed this belief, pointing out that vaccination alters T-cell signaling, causing profound impairment in type 1 interferon and cancer surveillance. According to Dalgleish, there is no worse candidate to stabilize the spike protein than N1-methyl-pseudouridine, noting it should have been avoided as [it] may cause excess cancer in recipients. And Makis and McCullough clearly agree. As he wrapped up his report, Dalgleish added: “As I completed this last paragraph, I was informed by radio and by my GP surgery by email that our completely incompetent NHS and Department of Health are offering a spring booster campaign to those over 75 and at risk. What they will be at risk of is increasing their chances of dying of cancer. Do these people not read the literature, or are they just plain stupid, or just not care?”

As we watch the manifestation of Turbo Cancers here in the United States being swept under the rug, the obvious conclusion is the Biden administration and his tax-payer-funded agencies also “just don’t care.” But what they don’t realize is the fact we can’t be silenced. With much gratitude, Dr. Makis, Dr. McCullough, and several others have

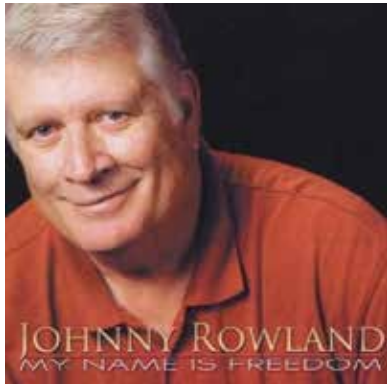

In Loving Memory of Johnny Ray Rowland

Johnny Ray Rowland, Sr., passed away on March 9th, 2024 at the age of 74 after a nearly year-long battle with cancer.

Johnny was born on September 6th, 1949, in Minden, Louisiana to Irvin William Rowland and Allene Cooke Rowland. Johnny is survived by his wife, children, grandchildren and other members of his family.



Johnny spent most of his life living on the family farm in Dubberly, Louisiana, where he and his sister were third generation descendants. He lived with his wife and his youngest three children in Colorado, Louisiana, Texas and Arizona; he became well known in each of these locations. Johnny graduated as valedictorian of the Dubberly High School class in 1967. He earned All-State honors as a member of the Dubberly High School class C State Championship Basketball Team. He was a gifted speaker and won multiple

speech contests while in high school and went on to use that ability in multiple forums. He attended Louisiana University and Louisiana Tech University.

Johnny was a talented singer, songwriter and entertainer and he followed a career path using those skills. He was the leader of a well-known band in Southern Louisiana and he traveled the country singing and writing songs. Analyzing the WHO Pandemic Agreement

What on earth does the vaguely worded document mean in practice?

I recently tried to treat a bout of insomnia by reading the REVISED Draft of the negotiating text of the WHO Pandemic Agreement, dated March 7, 2024.

The Agreement's stated objective is as follows: Article 2. Objective: The objective of the WHO Pandemic Agreement, guided by equity, and the principles and approaches set forth herein, is to prevent, prepare for and respond to pandemics.

The Agreement's wording strikes me as too general and vague to yield any definite interpretation of what exactly the Articles mean in practice. I suspect that this is intentional, as it will give public health agency bureaucrats (representing Bio-Pharmaceutical interests) room to interpret it as they please and impress their interpretation on braindead politicians and media outlets. The mantra will be, "Per our obligations set forth in the WHO Pandemic Agreement of 2024, we must do..."

I also suspect that the Agreement will serve as an enhanced mechanism for transferring vast sums of

money from public coffers to the vaccine cartel.

Articles 14 and 18 strike me as especially concerning.

Article 14. Regulatory systems strengthening



1. Each Party shall strengthen its national and, where appropriate, regional regulatory authority responsible for the authorization and approval of pandemic-related products, including through technical assistance and/or cooperation with WHO, other Parties and relevant organizations, as appropriate, with the aim of evaluating and monitoring the quality, safety and efficacy of such products.

2. Each Party shall take steps to ensure that it has legal, administrative and financial frameworks, as appropriate, in support of: (a) issuing emergency authorizations and approvals for pandemic-related products and/or, as appropriate, regulatory reliance processes for the timely authorization and approvals of such products, consistent with

national law...

Article 18. Communication and public awareness

1. Each Party shall promote timely access to credible and evidence-based information on pan-

demics and their causes, effects and drivers, with the aim of countering and addressing misinformation or disinformation, particularly through risk communication and effective community-level engagement.
2. The Parties shall, as appropriate, promote and/or conduct research and inform policies on factors that hinder or strengthen adherence to public health and social measures in a pandemic, as well as trust in science and public health institutions and agencies.
3. The Parties shall promote and apply science- and evidence-based approaches to effective and timely risk assessment, and culturally appropriate public communications.
4. The Parties shall exchange information and cooperate, in accordance with national law, in preventing misinformation and disinformation, and

endeavour to develop best practices to increase the accuracy and reliability of crisis communications.

Article 14 is likely to be interpreted as providing an enhanced mechanism for emergency authorizations of hastily developed vaccines of dubious efficacy and safety, which can be foisted onto the frightened citizens who pay for them while having zero recourse in the event they are injured by the emergency authorized "countermeasures."

Article 18 is likely to be interpreted as providing governments with yet more power for censoring their citizens in the name of "public health emergencies."

My overall interpretation of the revised draft of the WHO Pandemic Agreement is that it will serve as an enhanced instrument for the Bio-Pharmaceutical Complex to expand the power and efficiency of its international vaccine racket. Judging by the WHO's top donors, Bill Gates and his cronies in Berlin, Washington, London, and Geneva (where the WHO and WEF are headquartered) will be wielding outsized influence behind the scenes.

FLYNN MOVIE: Delivering Truth Amidst Turmoil, The General's Journey Through Persecution and Patriotism

Constitutional Sheriffs Event Offers Solutions, Fake Media Loses It!

LAS VEGAS — Sheriffs have the power and the duty to stand for the U.S. Constitution they swore an oath to uphold, and to protect the rights of the people in their counties (regardless of what state or federal authorities might do) explained a wide range of speakers including sheriffs, media personalities, victims of political persecution, businessmen, and military leaders.

Respect for the oath of office to the U.S. Constitution was one of the clear messages from the Constitutional Sheriffs and Peace Officers Association's (CSPOA) "Resist the Temptation" conference on April 17. That constitutional mandate applies to everything from elections and immigration to free speech and even the protection of order from lawlessness, the lawmen and their allies heard. The event made headlines worldwide and was broadcast globally by Frank-Speech, reportedly being seen live by more than 50,000 people. Videos from the event continue to circulate widely on social media and beyond.

Organized by CSPOA founder Sheriff Richard Mack and CEO Sam Bushman (a syndicated radio host) the summit brought together an impressive array of Trump insiders, lawmen, elected officials, and experts. Each had unique insights and perspectives to share. Taken together, the speakers offered a long list of action items for the law-enforcement community and for citizen activists concerned about America.

Sheriff Mack (who served two terms as sheriff in Arizona) sued the Clinton administration in the '90s over a gun-control bill that he refused to enforce. The case eventually made its way to the U.S. Supreme Court, which ruled in favor of sheriffs and against the Clinton gun-control scheme.

In the landmark decision (*Printz v. United States*) the Supreme Court, citing the 10th Amendment and more, ruled once again that the federal government could not "commandeer" state or local governments. Known as the "anti-commandeering doctrine," the case upholds the Constitution's

reservation of powers not delegated to the federal government to states and the people.

Numerous speakers at the event touted the ruling as key, not just for sheriffs but also for state and local governments. Hundreds of sheriffs nationwide are members of CSPOA and have been trained on their authority under the U.S. Constitution and common law, as well as the details of the 1997 ruling.

Unsurprisingly, federal supremacists and totalitarians seeking to centralize coercive power in Washington, D.C., are on the warpath against Mack and CSPOA. The dishonest attacks by the media offered fresh evidence that constitutional sheriffs are a major thorn in the side of those who would run roughshod over the rights of Americans.

Several sheriffs offered ideas for their colleagues in other counties. One of the lawmen who spoke at the conference, Sheriff Bob Songer of Klickitat County, Washington explained how sheriffs across the nation could deputize citizens and form a posse. Sheriff Songer (whose posse includes some 150 carefully screened citizens) even offered his department's policy manuals and guidelines for other sheriffs across the nation who may wish to set up their own.

In an interview with The New

American magazine, Sheriff Songer noted that the radical left was furious about his decision to supplement his department's ranks with everyday citizens. However, considering the savings to taxpayers and the need for more manpower in everything from search and rescue to dealing with potential threats to the community, Songer said creating a posse could be helpful to law-enforcement nationwide.

Another chief law-enforcement officer (CLEO) with experience deputizing citizens was Sheriff Glenn Hamilton of Sierra County, New Mexico, who went on stage with Pastor Caleb Cooper of New Hope Revival Church. When state authorities demanded lockdowns and claimed churches were not essential during Covid, Cooper knew he could not close his doors. The only thing worse than having somebody die from Covid because his church stayed open (Cooper told state police) would be having somebody die of Covid without having heard the Gospel and ending up in hell. "We just could not close our church," Cooper told *The New American* magazine, emphasizing the importance of the Church continuing to shine the light in dark times. "We are essential."

Cooper and Sheriff Hamilton devised a plan. Because law enforcement was considered essential and was therefore not subject to the lockdown orders,

Sheriff Hamilton went to New Hope Revival Church right before Resurrection Sunday and deputized the entire congregation. "I would have deputized every man, woman, and child in my county if that is what it took," Sheriff Hamilton told *The New American* in an interview.

The whole saga was featured prominently in the documentary "*Non-Compliant 2*" by KrisAnne Hall. It was contrasted with the outrageous behavior of an anti-constitutional sheriff in Florida, who arrested a pastor for refusing to shut his church before Governor Ron DeSantis shut down the rogue sheriff by declaring churches essential. As Sheriff Hamilton explained, almost all New Mexico sheriffs also resisted unconstitutional abuses against gun rights in the state.

A third lawman who spoke at the summit (Barry County Sheriff Dar Leaf) offered details of his ongoing investigations into irregularities in the 2020 election. Upon being given evidence of alleged criminal acts, Sheriff Leaf said he had a duty to investigate. And yet, instead of helping get to the bottom of it, state officials (including the far-left attorney general) responded by waging war on Sheriff Leaf and his efforts.

"It's been nothing but walls and having to knock down walls to get to the information that I need to get to," Leaf told *The New American* in an interview before his talk. "The walls being put up are probably the most frustrating — and walls put up by people you'd think would be helping you out in an investigation, like the attorney general's office and the secretary of state."

Considering the enormity of the crimes being alleged and the significance of them, Sheriff Leaf told *The New American* that there should have been a task force of local, state, and federal law enforcement investigating. "Everybody should have been involved in it," he said. "There's a lot to this. I think we would have had this all resolved by now if we had done that." "You're talking about (potentially) the greatest fraud ever committed in the world — committed on the American people," added Sheriff Leaf.

Numerous other sheriffs have also

opened investigations into widespread reports of voter fraud and election crimes. In fact, at a previous CSPOA event in Las Vegas, this writer interviewed more than half-a-dozen sheriffs for The New American who were trying to get to the bottom of it all, only to be viciously attacked by the far-left media, the Democratic Party, and their allies.

Other highlights of the conference included a speech by former National Security Advisor General Mike Flynn

(Ret.), who also served as a top intelligence official responsible for coordinating federal, state, local, tribal, and international intelligence. Among other topics, Flynn discussed his new documentary, Flynn, exposing how and why the Deep State targeted him as the first one of Trump's key officials. In an interview with The New American, he noted that the DVD had soared to number one in Amazon's DVD sales. "Remember, local action for national impact," Flynn told the crowd.

Pointing to the open border and the ongoing invasion of hostile military and terrorist forces, veteran Boone Cutler, an associate of Flynn's who helped write the book on Fifth Generation Warfare, announced a new training program for law enforcement on irregular warfare. Saxon Aerospace founder John Ferguson also offered resources to help law enforcement prepare for tough times ahead, later telling The New American that the nation might already be lost.

Also speaking was MyPillow founder Mike Lindell, a leading voice calling for election reforms to restore confidence and integrity to voting. In an interview with The New American, he called for citizens to sign the petition at LindellOffenseFund.org for paper ballots and hand counting in elections. Especially urgent: getting rid of the machines that can be hacked. Popular radio host Wayne Allyn Root enthusiastically called on Americans to get involved in the freedom fight,

too. Former Mesa County, Colorado, Clerk Tina Peters (who uncovered serious problems with the election and has been ruthlessly persecuted for speaking out) gave an update on her efforts. Former Arizona Representative Mark Finchem (who is running for state Senate and is endorsed by Donald Trump) also gave an update on his lawsuits against election fraud.

Dr. Richard Fleming, a medical doctor, attorney, and physicist, discussed the bioweapon attack on humanity in the form of the Covid injections. He urged viewers to contact their state attorneys general with a letter demanding action.

FreeAndEqual.org chief Christina Tobin (who is seeking to provide a platform for candidates outside the two-party duopoly) spoke on how the establishment seeks to keep Americans trapped in either the Republican or Democratic parties.

Several victims of the January 6 persecution by the Biden Department of Justice (including Casey Cusick and Tom Hamner) spoke about the horrors they endured, and yet offered a message of hope.

Also speaking were two congressmen targeted by the Deep State for speaking out, Steve Stockman of Texas and Steve King of Iowa.

Former Congressman Stockman explained how the Obama administration went after him with a vengeance, squandering over \$20 million in tax dollars and going through multiple grand juries until they could find one willing to help in the persecution. He was eventually jailed in federal prison and treated terribly until Trump commuted his sentence. He urged Americans to pray for and write to former Arkansas State Senator Jon Woods, who was also persecuted by the same forces and remains behind bars in atrocious conditions.



Former Congressman King of Iowa, meanwhile, was smeared by the far-left media with fake allegations of racism until he was run out of office. During his talk, he exposed the "carbon capture" scam, the ongoing attack on private-property rights, the globalist undermining of national sovereignty, and more.

South Dakota farmer Jared Bossly (a victim of the "carbon capture" scheme) shared details of what is happening in his state and beyond. Entrepreneur Patrick Byrne (former CEO of Overstock.com) gave a detailed presentation on Deep State activities and how to fight back.

This writer (who served as the emcee) also spoke on the importance of the oath of office and the biblical foundations of law and resistance to tyranny.

Estimates cited in news reports suggest about 10 percent of the nation's sheriffs are members of CSPOA.

As always happens when influential conservatives gather to effectively oppose tyranny and globalism, the establishment media (which was crawling all over the event) pretended to be outraged. The far-left U.K. Guardian, for instance, ran a propaganda piece demonizing the event before it even happened under the headline "Danger to our democracy: fears over Trump allies summit with far-right sheriffs."

Shortly after the conference finished, fringe left-wing activist Brandy Zadrozny (who repeatedly cackled as political prisoners shared horrifying details of abuse in federal prison) ran a vicious hit piece attacking the gathering. "A sheriff, a felon and a conspiracy theorist walk into a hotel. They're there for the same conference," screamed the headline. "The Constitutional Sheriffs and Peace Officers Association is urging lawmen to form posses, seize voting machines and investigate baseless claims of voter fraud."

Virtually all of the attack pieces masquerading as journalism misrepresented the CSPOA and what it teaches its members, the public, and the nation's sheriffs. The NBC "News" report by Zadrozny (who several attendees said has a reputation for lying and dishonesty) offered a representative example of the lie: "The group sees sheriffs as the highest authority in the U.S., more powerful than the federal government."

Of course, nothing could be further from the truth. Not one person at the summit or at CSPOA has ever claimed that a sheriff has more power than the federal government. However, it is a fact that sheriffs are the chief law-enforcement officers in their jurisdiction, that they are not accountable to or employed by the federal government, and that they all have an obligation to obey their oath of office to the U.S. Constitution and their state's constitution — not enforce federal regulations and statutes.




Virtually all of the establishment media left before the press conference, when they would have had the opportunity to ask most of the speakers any thing they wanted. Instead, they simply lied or distorted what the speakers said and what the CSPOA

and its members stand for.

Despite the hatred from the totalitarian media, the event was very well received by attendees and online viewers. Multiple law-enforcement officials told The New American magazine that they learned a lot. In the end, it may well be the nation's sheriffs and state governments who stand between citizens and the escalating lawlessness and tyranny that is overtaking the nation.

The Great Replacement is No Longer a Theory, it's Reality!

Dutch political commentator Eva Vlaardingerbroek delivered a speech at the 2024 CPAC Hungary convention.

Eva Vlaardingerbroek:
Hello, Hungary, hello, Budapest, hello, fellow Europeans and American friends. Thank you so much for having me. Allow me to skip formalities for a moment and dive right into a subject that is not so cheerful, but very, very necessary to discuss.

Let me walk you through the past seven days in Europe. This week in Stockholm, three elderly women in their 70s were stabbed in broad daylight on the streets. In London, four people were stabbed in a time span of just 42 hours.

In Paris, hundreds of African migrants took to the street to riot. And in Brigolo, also in France, yet another church was burned down to the ground. And that, ladies and gentlemen, is just a few incidents in just a couple of days on our beautiful continent.

We all know that these incidents aren't incidents anymore. If there's one thing that's for sure, it's that we know (and our governments also know) that there is a link between mass migration and crime. In the Dutch city of Dordrecht, something interesting happened the other day.

They announced (and this is a small city in the Netherlands) in my home country, that a new asylum center will be put in that little town. What did the municipality do? They said, "we are going to offer citizens who live in the vicinity of this center a thousand euros to take extra safety measures." Our new reality in Europe consists of frequent rapes, stabbings, killings, murders, shootings, even beheadings. Let me be clear about one thing. This did not used to happen before. This is a newly imported problem.

Samuel P. Huntington predicted this over 25 years ago when he wrote (and I quote) "in the new world of mass migration, the most pervasive, important, and dangerous conflicts will not be

between the social classes. They will not be between the rich and the poor. They will be between peoples belonging to different cultural entities. Tribal wars and ethnic conflicts will occur within civilizations." Well, boy, was he right and the worst part is, we as a society seem to have become indifferent to it.

When another white boy or white girl dies at the hands of an immigrant, we might shake our heads, we might let out a sigh, we might even get angry for a minute or two, and then we go on with our lives. We offer the family thoughts and prayers, but nothing ever changes. Ladies and gentlemen, what does that say about us? This is the response of a society that has already given up.



A society that has already accepted its defeat. But is this true? Have we given up? Do we really accept the new reality that our globalist leaders have in mind for us? I know one thing for sure, and that is that if nothing changes, if we don't start to seriously fight for our continent, for our religion, for our people, our countries, then this time that we live in will go down in history as the time in which Western nations no longer had to get invaded by hostile armies in order to be conquered. This time will then go down in history as the period in which the invader was actively invited in by a corrupt elite, and not only did this corrupt elite invite the enemy in, they made the native population pay for it too.

Everyone who has eyes can see it. The native white Christian European population is being replaced at an ever-accelerating rate. Let me back this up for you with some statistics from my home

country.

Let's take Amsterdam, the capital. Amsterdam currently consists of 56 per cent migrants. The Hague, 58 per cent migrants. Rotterdam, almost 60 per cent migrants. And, of course, most of these immigrants come from non-Christian, non-Western, African and Middle Eastern countries. Conclusion, the Dutch population is already outnumbered in the majority of our cities.

Let's look onwards. London, 54 per cent migrants. Again, conclusion: native population outnumbered. Brussels (colour me shocked) 70 per cent migrants. Conclusion, native population - majorly outnumbered and other Europeans will, of course, follow suit soon if they haven't already.

So, I'm going to draw the forbidden conclusion here. The Great Replacement Theory is no longer a theory. It's reality.

Nicaragua takes on Germany over Gaza genocide: an interview with Carlos Argüello Gómez

Nicaraguan lawyer and diplomat Carlos Argüello Gómez speaks to The Grayzone about his case against the German government for its facilitation of Israel's genocide in the besieged Gaza Strip, its potentially historic implications, and its similarities to the successful case he argued for the ICJ in 1986 which brought massive penalties against the United States for its illegal dirty war on Nicaragua at the time.

Max Blumenthal: Why did Nicaragua feel compelled to bring this case against Germany? Perhaps you can fill us in on the latest development?

Dr. Arguello: Yes, thank you. Well, naturally, the main state committing the crime is Israel. The main abettor of what is happening is the United States, but the next one is Germany.

In the first case, South Africa brought a case against Israel of genocide, and that case is pending. So far, Israel has been ignoring the orders of the court. In the case of the main abettor (the United States) we don't have any jurisdiction to bring the United States to the court.

Not only does the United States accept the jurisdiction, but even when it became part of the Genocide Convention (which was 40 years after the convention from 1948) it wasn't until 1988 that they became a party, with a lot of reservations, saying that they couldn't be taken to the court, and that it [was] only genocide according to a decision by a court in the United States — with a lot of reservations that make it impossible to go against

the United States. Germany doesn't have that type of reservation, and Germany is the second [largest] supplier of weapons to Israel. So our position was a question of principle, beginning with: that it was very important to sit down and to make countries clear that there is an international obligation to prevent these types of situations.

The Genocide Convention specifically says in its first article that all countries have the obligation to prevent and punish genocide. We have the obligation to prevent — that doesn't mean that the genocide has to have been completed already, that it has to have been determined by a court that there has been genocide. You have the obligation to prevent [it].

So what we have stated in the court (and have proven) is that Germany has had all notice, beginning from the Secretary General of the United Nations from the ninth of October, saying that genocide was possibly being committed. Even the International Court said that genocide was being committed.

Now, you have to understand that if genocide is being committed (obviously) international humanitarian law is being [violated]. Whether or not you are massacring an entire population (with the intent of destroying it completely, which is genocide) you are still violating international humanitarian law.

Now the problem (to divide the

situation) is Israel only accepted jurisdiction on the basis of the Genocide Convention. So you can't claim against Israel violations of international humanitarian law, only genocide. And so that was another of the points that I'll get to.

First (going back) the principle involved here is all states have responsibility to prevent these types of inter-



national crimes. The court had already given indication of this 20 years ago, in an opinion that the International Court had given on the construc-

tion of a wall in Israel. The Court itself had felt that all states had the obligation to prevent what was happening. All states had the obligation to enforce the humanitarian law conventions, but nobody paid attention.

Germany never paid any attention to what was happening. The court even said that the Palestinians had the right to self-determination in that case. Nobody paid attention. So now we come to when the most crucial genocide is being evidenced — because genocide has been committed for many years. It's not a question of just the past few months but it is absolutely evident. Countries continue as if it wasn't, as if the Genocide Convention and all the international laws had nothing to do with them.

So we thought that as a matter of principle we had to bring before the court this question. Now, I wish to clarify, because I have been asked: 'why Nicaragua?' Well, with Nicaragua, we have a lot of experience in the court. We came to the court forty years ago against the United States, on a question of principle also. It was the principle of non intervention... of the state. In that we made a very important contribution to international law. And since then we have been in the court many times. We have been in the court more than twice as many times as Germany. So it's not that we are discovering the court in this situation. We have experience and that's why

in this case we wanted it to the benefit the Palestinian people that are being massacred (at the very least) if not committing genocide against them.

Now, another situation (and this is on a personal level) after South Africa brought the case against Israel (and that was at the end of December last year) then in January, I was just listening to interviews by very important commentators and very important lawyers. Everybody was saying, 'Well, no, genocide is possible... it's very difficult to prove that,' and whatever.

So I think the whole understanding of people who were watching what was happening was: well, obviously, then nothing is happening. It's very difficult to prove. I mean, that wasn't the issue. Israel was massacring everybody. It was violating all international humanitarian law. The only thing was that only genocide could be brought against them directly.

The fact of bringing this case against Germany, which includes not only genocide, but also its obligations, German obligations, to also help prevent the violation of international humanitarian law. All that is on the table with Germany. Against Israel, only the genocide. Against Germany, we have all international law, humanitarian law also on the table. So I mean, that aspect is also very important.

Part of the reason, right, but obviously, Germany will try to avoid [it] and say that, as they said in the court, that we can continue in this case without the presence of Israel. But independently of what is happening, each country in the world, all countries in the world, have the obligation to prevent [genocide]. It's an independent obligation. So, I mean, this is more or less where we are. And hopefully, the court will order. There are no third states, I'm sorry, there are no other parties, but Germany and Nicaragua involved in this. There is no reason why the court can not simply order that Germany cease supplying weapons to Israel, which is what we hope will happen.

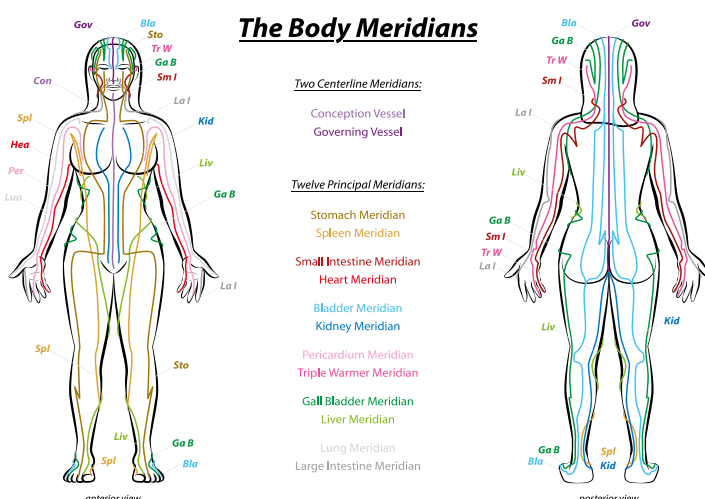

O’Keefe Media Group Exposes Alleged CIA Plot Against Trump

According to a new undercover report by the O’Keefe Media Group, high-level intelligence community executives (including former Central Intelligence Agency (CIA) Director and Secretary of State Mike Pompeo and former CIA Director Gina Haspel) withheld information from former President Donald Trump throughout his administration.

A video posted on social media by James O’Keefe features Amjad Anton Fseisi, purported to be the project manager for cyber operations at the CIA. In the video, the undercover reporter for O’Keefe Media Group gets Fseisi to admit that several intelligence agencies deliberately withheld information from Trump out of some absurd fear that he might “disclose it.” Fseisi is seen in the recording admitting that intelligence agencies “all got together and said, ‘We’re not gonna tell Trump.’”

“The executive staff,” Fseisi said in response to a question about who specifically was involved in the decision. “We’re talking about the director and his subordinates.” That would include Pompeo and Haspel. According to Fseisi, the intelligence



agencies “kept information from [Trump] because we knew he’d f***ing disclose it.”

“There are certain people that would... give him a high-level overview but never give him any details. You know why? Because he’ll leak those details.” Can you guess why Fseisi says Trump would leak sensitive information? Because Trump is... wait for it... a Russian asset! “He’s a Russian asset,” Fseisi claimed. “He’s owned by the f***ing Russians.”

Wait there’s more.

“Amjad reveals to OMG’s Undercover American Swiper that intel agencies not only kept intelligence information from a sitting United States President and Command-

er-In-Chief, they also used FISA to spy on [Donald Trump],” O’Keefe says on X/Twitter. “And his team and [sic] are still monitoring President Trump according to Amjad who says, ‘We monitor everything.’ Amjad adds ‘we also have people that monitor his ex-wife. He likes to use burner phones’ – information only an insider with access to highly sensitive information would state.”

“We steal it [information]” and “We hack other countries just like that,” Amjad, who states he currently works on the CIA’s China Mission Center, explains how intel agencies obtain information. He also describes a broken intelligence system where “We don’t share information across agencies” because the CIA is “very reluctant” to share information with the “careless” NSA.

O’Keefe Media Group’s bombshell undercover footage supports earlier reports by investigative journalists Michael Shellenberger, Matt Taibbi, and Alex Gutentag that revealed how the American intelligence community illegally ran a spy operation

against then-candidate Trump’s presidential campaign in 2016 and illegally acquired intelligence that was later used to justify the Federal Bureau of Investigation (@FBI) official probe, “Crossfire Hurricane,” which in turn led to Special Counsel Robert Mueller’s investigation that ultimately did not find evidence of Russia collusion by the 2016 Trump campaign.

Contractors like Fseisi hold the duty to withhold sharing confidential or national security information. In denying his statements, Fseisi may have realized he could be held liable for violating internal agency provisions and federal laws like the Executive Agency ethics provisions, which restrict what he may share with others outside of his contracted-to agency. Additionally, any government worker or agency head who withheld information from a superior (i.e. President Trump) may violate: (a) obstruction of justice by deception (18 USC 1512); (b) conspiracy to obstruct (18 USC 371); and false statements (18 USC 1001). Agency regulations may also provide offenses related to insubordination, reflecting poorly on the agency in public, or misrepresentation or dishonesty.

When O’Keefe confronted Fseisi on the streets of Washington, D.C., he denied making the statements in the above video.

Rep. Matt Gaetz (R-Fla.) is now calling on the Select Subcommittee on the Weaponization of the Federal Government to investigate.

Public Schools and the State's Omnipotent Bayonet

Vast sums are spent on “reforming” government schools, only to end up with the same lousy product. Thinking outside the box means abandoning public schools

From everything I read you would think we were incapable of solving social problems.

In truth, we find matters only getting worse because the proposed solutions almost always involve the culprit—the state—taking more control over our lives.

The state is a box we desperately need to think outside of if we're ever going to establish civil relations among people. We would do well to remember that the state is absolutely not in the business of making our lives better. It is an institution appended to the rest of society through force for the purpose of enriching the lives of its members.

Modern welfare states might make this difficult to understand, but it's no less true. The state is not in the business of producing wealth and then distributing it to the neediest or deserving. It is not the successful entrepreneur turned humanitarian when it dishes out payments to favored beggars, whether they be unemployed workers, corporate cronies, foreign dictators, research facilities, or any other rent seeker. The state is best thought of as a homicidal thief who takes pains to appear as a good guy.

The state is fundamentally a criminal organization and liberty's greatest enemy. It's that simple, and that ugly. For starters, see Murray Rothbard's book, *Anatomy of the State*, Albert Nock's essay “*The Criminality of the State*,” and Llewellyn Rockwell's book *The Left, the Right, and the State*. “Your entire life is at the mercy of the State,” writes Hans-Hermann Hoppe in *A Short History of Man*.

The state, being criminal and criminally inept, creates the crises that naïve or disingenuous people blame on liberty.

Interventionist mania has been hugely successful but only as a means of bloating the state. Otherwise it achieves the opposite of its stated aims. Has the state been successful in preventing terrorist attacks? Has it achieved its stated goal of eradicating poverty? Have state regulations in healthcare, which began long before ObamaCare, succeeded in making healthcare better and more affordable? Did its countless financial regulations prevent the recession of 2007–8? How about the job it did following September 11, with George Orwell at home and bloody cakewalks overseas, both of which are running indefinitely? Should we be surprised the state is meddling in Israel-Hamas, Ukraine-Russia, and China-Taiwan? The American state seems bent on pursuing nuclear Armageddon.

School Shootings

Americans are horrified at the wanton nature of school shootings. One occurrence is intolerable, but repeat occurrences are unthinkable in a civilized society. Yet the school in Parkland was preparing for just such a crisis because they had no politically acceptable way of preventing it.



Why did the kangaroo go to school? To improve its jump-start!

As long as the state is in charge there won't be a politically acceptable way. What if it decided to outlaw gun ownership? Completely, totally, immediately, no exceptions (other than the usual exceptions: members of the political class and their cronies). Make violators pay with their lives. Aside from it being a human rights nightmare and therefore politi-

cally unacceptable to many, it would at least maximize the risk and minimize the likelihood of a crazy person walking into a school and shooting people. But it wouldn't stop them from killing. Law-abiding murderers would have to find other means to carry out their crimes.

What grade would we give the state for the job it's done educating our children? Not only are our kids exposed to a creativity-killing environment but they're forced to sit defenseless in rooms all day, with everyone hoping the next attack doesn't happen at their school.

Leave it to the state to play Russian roulette with children. Leave it to guileless parents to let the state get away with it. It might still be argued that since these are state schools, the state should at least be responsible for ensuring the safety of its students. Not a chance. Parents of the victims can't expect to sue the government for gross negligence or wrongful death and win. They can try, but governments protect themselves with something its lawyers call sovereign immunity. You can only sue governments if they let you, and since they're all broke and corrupt the chances of success are nil. So parents sue people like Alex Jones instead.

It's one of those fascinating aspects of the institution so many people regard as indispensable—you can't hold the state responsible for its actions or negligence. You can't hold it responsible for school slaughters or overseas military murders. You can't hold it responsible for its endless lies and the damage they cause. You can't hold it responsible for balancing its budget. You can't hold it responsible for deliberately debasing the currency.

In the spirit of double standards, the state, backed by its omnipotent bayonet, can hold you responsible for anything it chooses, especially the payment of tribute. We've surrendered our freedom to armed government bureaucrats.

One difference between a prison and a public school is this: you can't walk into a prison heavily armed and start shooting people, at least not without guards shooting back at you right away. In a public school, killers will enter a world in which a careless student can be suspended for pointing his finger in the shape of a gun. But if an Uber rider pulls up armed with malign intentions, what's to be done? Tell him to go away? Hope he loses his nerve? The only deterrent is the threat of much-delayed retaliation, though sometimes it's a brave parent who circumvents authorities and risks confronting the shooter.

I don't like the thought of any kid attending a public school. Not at all. Neither should you.

In a satirical essay mocking the breathless demands of gun-controlers following a mass shooting, Gary North draws the irresistible conclusion that public schools are too dangerous: “Students in public schools are at risk. Terrible risk. Unacceptable risk. There is no excuse for this any longer. None. The statistics are clear. Students get gunned down only in public schools.”

The solution? He recommends charter schools or homeschooling. “We must close the public schools forever . . . for the sake of the children.” I fully agree. But closing dangerous indoctrination centers will never happen as long as the state is in charge of our lives.

The Zionist Death Grip on the United States Government

When Netanyahu demanded that the protests against Israel be stopped, the US government complied because our members of Congress have all been bought and paid for with tax dollars given to the American Israeli Political Action Committee, known as AIPAC. AIPAC openly brags about this on their official website, because they don't have to register under the Foreign Agents Registration Act, which requires agents of foreign principals to register and provide transparency.

Beginning in 1962 they were known as the American Zionist Council, and President John F. Kennedy was ordering them to register as a foreign agent. Along with members of the US government, the Zionists fought against this. In October of 1963, forms were prepared for them to register. But the next month, JFK was assassinated. And Israel has never been asked to register since.

Four years later, Israel attacked the USS Liberty, murdering dozens of Americans and injuring over a hundred. The US government helped them cover it up as an accident.

On the day of 9/11, five Israelis who were seen photographing the collapse of the twin towers and celebrating were arrested and detained for several



weeks. In documents later released by FOIA requests, the FBI redacted their faces in pictures where they were posing in front of the burning towers. And described them as being happy and jovial. One of them stated that, "Israel now has hope that the world will understand us." The end of the declassified document asks if they had foreknowledge of the event and were there to film it, and the answer was redacted. As soon as they were released, they returned to Israel and went on television where they confirmed that the answer was yes.

The dancing Israelis had fake student IDs, and several accounts of suspicious Israeli art students were reported to be infiltrating government buildings. Over a hundred of these Israeli art students were arrested. Fox NEWS

reported that these art students served in military intelligence and explosive ordnance units.

In March of 2000, several of these Mossad art students were living in the World Trade Center as part of the World Views Artist-in-Residence program. They occupied floors 90 and 91 where walls were unfinished and structural beams were exposed. A member of this group of artists, Hanan Serfaty, was arrested by the DEA as part of the Israeli spy ring. But the identities of an additional 14 Israelis who were with him have never been released to the public. These Israeli artists were sharing the space with a group of Austrian artists known as Gelatin who were working on a project called "The B thing" that involved removing

windows on the 91st floor of the North Tower. A small balcony was constructed for people to stand on while photographs were taken by a helicopter. Another group called "E-team", managed the helicopter with the designation number, N666LH. This helicopter was to be in an art exhibit memorializing this project scheduled for September 11th 2001.

In March of 2001, E Team had an art project called "127 windows." Officially, they were going to write their name on the exterior of the tower. They had an artist's rendering of what the project was supposed to look like, but it never appears to have happened. And on 9/11, American Airlines Flight 11 crashed into the exact spot where they were supposedly preparing to do this.

In 2001, Gelatin published a book on the project and described it as conspiratorial work. It includes a drawing of someone falling headfirst from the 91st floor with the words, "300 meters of pure pleasure". Gelatin was originally spelled the same as the explosive, but was officially changed in 2005 and the 9/11 Commission report does not mention Gelatin, E-Team, or any of the Israeli Mossad art students.

Have you always known that there was more to Christianity than you had been taught? Did something happen that made a light go on in your head? Was there some verse in scripture that you had heard many times before, then suddenly you realized what it really meant? Was there a person in your past that believed with all their heart and one day it became clear to you that for them to believe the Word as strongly as they did there must be more to it? Surprise! The IRS Lied About Who Those 80,000 New Agents Would Target

“Never trust a man who lays his hand on his heart when he assures you of anything,” goes the old axiom. That’s why I never trust a Democrat who makes any promise ever about a federal agency or program.

Take Medicare. In 1966 when Medicare began, it cost \$3 billion. The House Ways and Means Committee estimated that Medicare would cost about \$12 billion by 1990. Instead, it cost \$107 billion and today costs the government close to a trillion dollars. So when Joe Biden and the Democrats assured Americans and Republicans in Congress that the \$80 billion the president wanted to augment the IRS tax-collecting ability was only going to target “the rich,” everyone with two working brain cells knew it was a lie.

It will surprise no one that an audit by the Treasury Inspector General For Tax Administration found that “President Biden’s plan to hire a new army of tax collectors is falling flat, and the agents already at work are targeting the middle class.” “As of last summer, 63% of new audits targeted taxpayers with income of less than \$200,000,” reports the Wall Street Journal. “Only a small overall share reached the very highest earners, while 80% of audits covered filers earning less than \$1 million.”

Bank robber Willie Sutton supposedly responded to the question of why he robs banks



by saying with a shrug, “That’s where the money is.” So, too, the IRS audits well-off but not “rich” taxpayers because they can’t afford the army of tax attorneys that the super-rich can bring to the table.

Here’s a gentle reminder of the assurances given to us by the Biden administration and Democrats in Congress. “These resources are absolutely not about increasing audit scrutiny on small businesses or middle-income Americans. As we’ve been planning, our investment of these enforcement resources is designed around the Department of the Treasury’s directive that audit rates will not rise relative to recent years for households making under \$400,000,” wrote IRS commissioner Charles Rettig in an August 2022 letter to concerned senators.

Janet Yellen was even more adamant. “Contrary to the misinformation from opponents of this legislation, small business or households earning \$400,000 per year or less will not see an increase

in the chances that they are audited,” she wrote in a letter to Rettig.

Reason.com: “It’s almost like they didn’t tell us the truth the first time around. But that’s not even the most embarrassing thing in the report: The IRS had set a goal of hiring 3,700 new agents in the first year of boosted funding.

Instead, in the first six months, they’d hired 34. Awkwardly, “revenue agent

staffing had actually decreased by 8%, or more than 650 employees, between the end of fiscal 2019 and March 2023,” per a previous watchdog report. And it’s not just hiring that’s in trouble: The agency has completed just 33 percent of its fiscal year 2023 milestones outlined in its strategic operating plan, which is... tough given that the year is over.”

This is the classic Lucy with the football telling Charlie Brown “this time, I won’t pull the ball away and laugh at you when you kick empty air and fall flat on your arse”. Most of us don’t fall for it.
