Following the Florida election debacle of 2000, Americans were promised a more honest, transparent and verifiable system of elections. We didn't get it, because the election stealers won that election and decided that keeping the current system was their best guarantee of re-election.

The election of 2016 changed that. The candidate being cheated by the system, Donald Trump, still prevailed thanks to a landslide that overcame the vote rigging. He will see having an honest election system as his best chance for a second term. Hence, there is a real opportunity to throw out the current system (which is designed to enable and conceal stealing elections) and replace it with a system that hinders cheating as much as possible.

To begin, stolen elections are a reality in this nation. John F. Kennedy stole the 1960 election from Richard Nixon. Nixon stole his re-election in what became known as the Watergate scandal. George W. Bush likely stole the 2000 election from Al Gore, and everyone had a ring-side seat watching Hillary Clinton trying to steal the election from Donald Trump.

Now then, I wish to offer a suggestion for a very simple way to have a more open and honest election system. It is not 100% foolproof, but is designed to make it very difficult for cheating to happen and difficult to conceal it. This stands in sharp contrast to the current system, which is designed to facilitate and conceal the manipulation of elections.

The necessity to overhaul our system goes beyond restoring Democracy in the United States. The 2016 election debacle has wrecked America's image around the world. Restoration of honest elections will be the first step on the very long road back to being respected by other nations.

First, some basic rules.

- *No electronic machines!
- *No central tabulation centers!
- *Everyone who votes must have an ID to prove they are a US citizen and eligible to vote. Absentee

ballots are only given to those who can prove they are unable to vote in person.

*After the voters vote, their finger is marked with ink that takes a week to fade away, to prevent them from voting more than once. For those concerned about hygiene, a spray could be used.

*All voting is done on paper ballots. All ballot boxes are kept in the polling area where voters can see them (to avoid ballot box stuffing or swapping).

*When the polls close, the precincts hand-count the ballots in full view of witnesses, and verify the accuracy. All paper ballots are to be stored for an entire year after the election.

*The totals for that polling place are posted for all to see and copies provided to all witnesses.

*In the city newspaper the next day, all the totals for all the city precincts are printed, along with totals for the city. This allows everyone to first verify that their precinct totals were reported accurately, and to verify the math leading to the city totals for themselves.

*Now, we move up a level! The

Mohave County Sheriff Doug Schuster stated in an open forum that citizens with guns can be dangerous. This is a problematic statement, especially considering that citizens have defended this country with firearms since its founding. As a constitutional sheriff, such a sentiment seems misplaced.

The issue arose during a discussion about volunteer posse members losing their right to carry weapons while serving the sheriff's office. I was upset when posse and search and rescue members had to surrender their guns while serving the county and bettering their community. Sheriff Schuster

explained that insurance would not cover armed volunteers and reiterated that citizens with guns can be dangerous. He vowed that as long as he was sheriff, volunteers would never be allowed to carry guns while serving the sheriff's office.

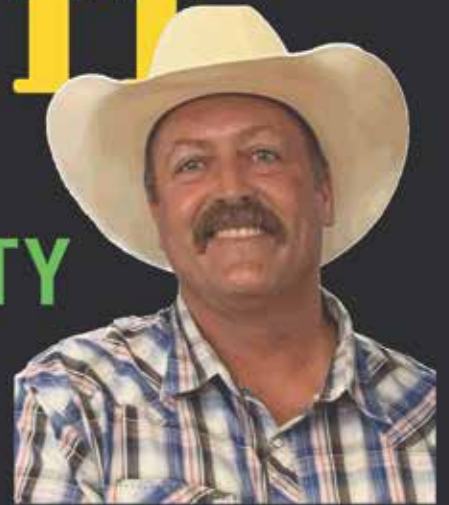
The problem is that all his statements are false except for his refusal to allow armed volunteers. Endorsement #18 of Arizona county's insurance pool (our insurance company) clearly states there is a pathway for citizens to be armed while assisting the sheriff's office, as many other counties do. Schuster refuses to acknowledge this and denies citizens the ability to protect themselves while on duty as posse members.

Biden's Debate Performance Was Revealing

Last night, President Joe Biden and former President Donald Trump faced off in Atlanta in what's supposed to be the first of two presidential debates. Each man had essentially one job.

Trump needed to appear stable enough to counter the characterization his opponents have built up of an unhinged maniac who is dead set on tearing the country down to nurse the hit his ego suffered in 2020. And Trump did a perfectly good job at that.

Biden, on the other hand, needed to show his base, his top donors and the nation's undecided voters that (despite his age) he is physically and mentally capable of being president for another four years. That was his one job and he failed spectacularly.

The incumbent's walkout was awkward and he started stumbling in his very first answer. His voice was quiet, he coughed often and his face remained almost entirely inert when Trump was speaking. He also had trouble getting the numbers right in the many statistics he tried to bring up and completely lost his way on a handful of sentences he started.

This may all seem petty but remember, Biden's only real job last night was appearing sharp and presidential enough to dispel the concerns about his old age. Nothing said on stage last night by either candidate was all that new or unfamiliar and nobody seriously expects candidates to present

comprehensive, nuanced plans for entirely solving all the country's biggest issues, two minutes at a time. These debates are not about policy, they're about optics.

That's why Biden's team spent an entire week holed up at Camp David, preparing the incumbent for last night's debate. The president spent seven whole days on a mock debate stage with over a dozen aides and advisors, gaming out responses to every Trump argument they could think of and helping him practice all aspects of his performance.

President Biden was as prepared for this debate as a sitting president could ever hope to be, and it still went terribly. That has many raising doubts about whether what happened to Biden on that debate stage was really an accident.

Such sentiments were stoked by the acknowledgment among many top Democrats and virtually all major establishment-friendly media figures that Biden not only had a terrible debate performance but is experiencing serious cognitive problems. In the days before the debate, all the way up until the opening remarks, these groups were totally aligned in calling such talk Republican propaganda that was made up and amplified by deceptively edited viral videos. Yet immediately after the debate, nearly everyone on the Democrat-friendly CNN and MSNBC post-debate panels was openly speculating about how Biden could be replaced.

It's understandable why many think this was coordinated. Are we really supposed to believe that all these people, including the advisors who spent a full week watching Biden practice, had no idea this would happen? And, further, why did the Biden-friendly pundits and high-level Democrats who have clearly had no issue denying and spinning the obvious signs

of Biden's decline in recent years all flip on a dime in unison? Remember, the Democrats asked for this debate.

There are problems with the idea that what we saw last night was a high-level, coordinated takedown of Biden's candidacy. Mainly, there are no clear replacements that will clearly perform better than Biden on election day. Biden's vice president, Kamala Harris, is deeply unpopular with all but a few Democratic voting blocs. Yet, Democrats need those voting blocs onboard if they are going to win. Without an obviously strong, universally liked candidate, passing on Harris could prove fatal.

Even then, Gavin Newsom — the closest thing Democrats currently have to such a candidate — is from the same state as Harris. That could cause problems thanks to the Twelfth Amendment. Hillary Clinton is still unpopular [although her recent facelift and appearance indicate she wants the position] and Michelle Obama has made it clear she has no interest in running. Any other option will lack name recognition, a serious problem this close to election day. On top of all that, any replacement plan relies on Biden willingly stepping aside — which he already refuses to do.

So it could very well be the case that the best chance Democrats have remains rallying behind Biden, the candidate that almost all of them

now admit is not mentally fit to be in office. This farcical situation is as revealing as it is absurd.

Four years ago, Biden rode the wave of political exhaustion that had swelled during the Trump years and crested through the pandemic into the oval office. His campaign represented a promise to return to a government that works the way we all learned it did in elementary school. Where,

through our choice at the ballot box, the president represents us and acts as we would act to address the problems we face at home and abroad.

That depiction is an illusion. Most of the federal government's power lies in the hands of unelected officials and bureaucrats whom we don't even get to pretend to choose. The fact that Biden is so obviously not the one running the country now exposes that illusion, and it hurts his effort to appear like he can and will run it for another four years.



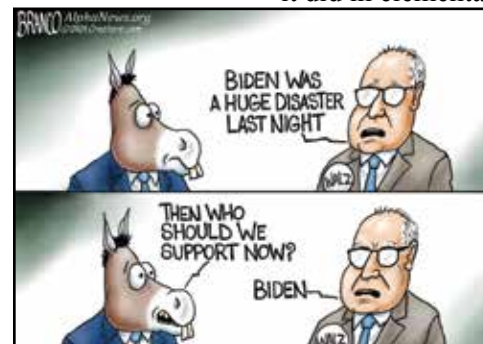

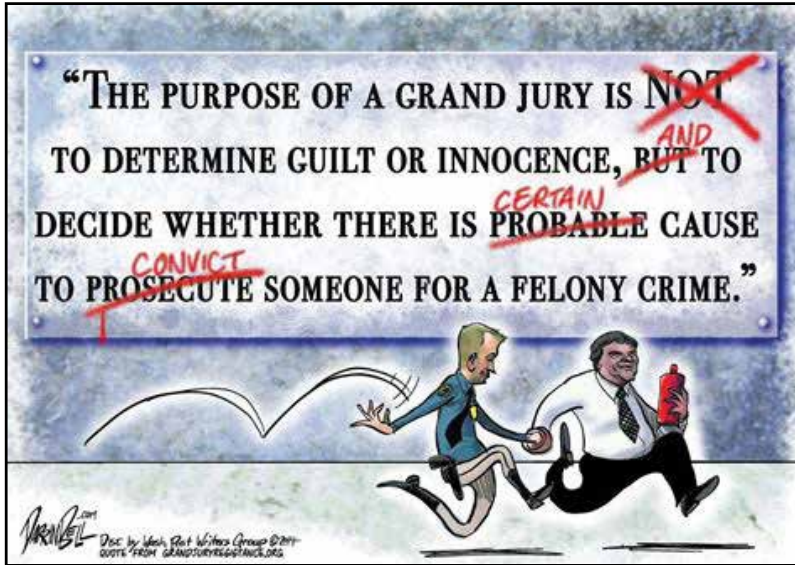

Walter Spawr and The Importance of the Grand Jury

Walter Spawr contacted The Patriots Free Press asking us to share his story. I have not yet had the time to investigate all of the facts but wanted to give our readers a primer for the story to come.

Walter states that his property in Mohave County was rezoned illegally and negatively impacted him. He has a background in Law so he immediately filed a lawsuit. The defendant brought in 2 attorneys who made numerous false statements, which amounted to 71 criminal violations, under A.R.S.13-2310 and 13-2311. The court accepted the false statements as true and thereby dismissed the case. Walter filed a criminal complaint with the Lake Havasu City Police department, who



reviewed it and sent it on to the county attorney for prosecution.

For the next year the county attorney stonewalled Water with multiple false justifications for not giving the case to the Grand Jury. So Walter gave the county attorney a 30 day notice that he would go directly to the Grand Jury to present his case. The county attorney did not tell Walter to not come or identify any law preventing him from doing

so. Walter walked into the Grand Jury room and was confronted with an assistant county attorney who asked him to walk outside so they could discuss this presentation. Once outside he was confronted with 2 more county attorney staff members who said Walter will not be allowed to go back into the building. These 2 people used their body positions to block the doorway and said there is no way Walter will get back into that room.

The following day Walter served the county attorney with a notice of Private Citizens Arrest for obstruction of justice under A.R.S. 13-2409. Walter then went to the county sheriff with the arrest notice to ask the sheriff to take the county Attorney into custody and to the court to be arraigned. After a lengthy argument the deputy sheriff said he would arrest Walter if he tried to

go back to the Grand Jury. During the next year Walter presented over 100 pages of legal documents, including a Supreme Court Decision, supporting Water's Constitutional right to present his case directly to the grand jury, to the County Board Of Supervisors. Walter asked them to introduce an ordinance to protect citizens from county officials who violate law and cover up white collar crimes. The Supervisors refuse to talk to him. On May 30, 2024, Walter walked back into the grand jury room and handed out 12 packets of legal information explaining what the county attorney was doing by covering up crimes. Again Walter was met with threats of arrest, but this time it is for trespassing. There is no law prohibiting anyone from reporting crimes directly to the grand jury members.

A few days later Walter was notified by the Kingman Police that a trespassing complaint was being issued against him.

Notice of Vacancy

Town of Quartzsite Council Position

The Town Council of Quartzite will be accepting applications on July 1, 2024 through August 15, 2024 from Quartzsite residents for consideration of appointment to one (1) vacant Town Council position. Interested persons can pick up their application for Council position at the front counter of Town Hall.



The Council will start reviewing complete applications of potential candidates after August 19, 2024, and select one or more applicants for interviews for the Council appointment. Possible appointment for the vacant seat will be considered at the Town Council Meeting of September 10, 2024, at 7:00 p.m. The council vacancy will remain open until filled.

Pursuant to Arizona Revised Statutes § 9-235, the Council shall fill

a vacancy until the next regularly scheduled Council election as the vacancy occurs more than thirty days before the nomination petition deadline.

Qualifications for Council appointment are found in Arizona Revised Statutes, A.R.S.89-232(A), which states in pertinent part the following: "A person shall not be a

member of a city or town council unless, at the time of the election [appointment], the person is eighteen years old, is a qualified elector residing within the city or town at the time of the election (appointment) and has resided in the city or town for one year preceding the election (appointment).

All complete applications shall be submitted to the Quartzite Town Clerk and will be accepted until August 15, 2024 at 5:00 pm.

GOP Governors Say No to WHO Pandemic Treaty

The governors of 24 Republican-led states have sent President Joe Biden a letter announcing their opposition to the proposed World Health Organization (WHO) pandemic agreement, part of the International Health Regulations (IHR). The governors argue that such an agreement threatens national sovereignty and jeopardizes Americans' constitutional freedoms.

Proponents of the treaty argue that such an agreement is necessary due to the risk of another pandemic similar to Covid-19, which unnecessarily paralyzed much of the world in 2020. But the governors argue that the agreement grants the WHO unprecedented powers over America and could lead to an acknowledgment that WHO is the absolute global authority on healthcare.

"We, as governors of our respective states, stand united in opposition to two proposed instruments currently under negotiation that would purport to grant the World Health Organization (WHO) unprecedented and unconstitutional powers over the United States and its people," the governors wrote. "These proposed changes could drastically change the role of governors in response to their charge as the

state health officials."

The governors are concerned that the proposed treaty will elevate WHO from its advisory capacity to the foremost authority not just in pandemic emergencies, but on any public-health issue.

"If adopted, these agreements would seek to elevate the WHO from an advisory body to a global authority in public health," the letter claimed. "Under the proposed amendments and treaty, the WHO's Director-General would supposedly gain unilateral power to declare a 'public health emergency of international concern' (PHEIC) in member nations, extending beyond pandemics to include a range of perceived emergencies."



Though the WHO refers to the proposal as an "agreement," it is essentially a treaty, as the governors note. In the United States, the U.S. Senate must approve any treaty by a two-thirds vote. The U.S. president or the U.S. ambassador to the UN may not simply sign a treaty and expect it to have any legal authority.

Furthermore, the treaty as proposed

would go against the Constitution. The governors had especially harsh words for WHO's current Director-General Tedros Adhanom Ghebreyesus. "The objective of these instruments is to empower the WHO, particularly its uncontrollable Director-General, with the authority to restrict the rights of U.S. citizens, including freedoms such as speech, privacy, travel, choice of medical care and informed consent, thus violating our Constitution's core principles," the governors, including Ron DeSantis of Florida, Greg Abbott of Texas, and Glenn Youngkin of Virginia, wrote.

The governors came out strongly in favor of federalism as it pertains to future health emergencies and vowed to refuse any WHO intervention: "As governors, we affirm that public health policy is a matter reserved for the states, not the federal government and certainly not international bodies like the WHO. We are committed to resisting any attempts to transfer authority to the WHO over public policy affecting our citizens or any efforts by the WHO to assert such authority over them."

Other Republicans have also de-

nounced the proposed agreement, with Wisconsin Senator Ron Johnson leading a revolt in the Senate against the proposed agreement. GOP senators sent their own letter to President Biden in early May.

"In light of the high stakes for our country and our constitutional duty, we call upon you to (1) withdraw your administration's support for the current IHR amendments and pandemic treaty negotiations, (2) shift your administration's focus to comprehensive WHO reforms that address its persistent failures without expanding its authority, and (3) should you ignore these calls, submit any pandemic related agreement to the Senate for its advice and consent," the senators wrote.

DOJ Indicts Surgeon Whistleblower Who Exposed Transgender Surgeries on Minors

The Department of Justice has indicted Dr. Eithan Haim (a relatively unknown surgeon) on four felony counts related to his alleged violation of a medical-records law. Dr. Haim gained notoriety last year for exposing Texas Children's Hospital's clandestine transgender surgeries and treatments on minors.

Dr. Haim anonymously leaked evidence of these procedures to conservative journalist Christopher Rufo. Despite announcing the program's discontinuation in accordance with Governor Greg Abbott's 2022 directive equating such interventions with child abuse, Texas Children's Hospital continued its transgender program. The hospital finally ceased its trans-medical practices after a state law took effect in September 2023, banning drug and surgical "gender-affirming" interventions for minors.

National Review explains that in January, Haim disclosed his identity, aiming to protect himself from retaliation by the DOJ

and the Department of Health and Human Services. Federal officials had approached Haim in June, revealing he was a potential target in a criminal investigation regarding his leaking of medical records. The prosecution claims he failed to redact sensitive patient information.

Rufo, who reviewed the records before publishing his initial article, disputes this claim. "For my own part, I can confirm that nothing in the information provided to me identified any individual; all the documents were, in fact, carefully redacted," Rufo wrote in his latest City Journal story, where he broke the news of Haim's indictment.

Assistant U.S. Attorney for the Southern District of Texas Tina Ansari, leading the criminal investigation, contends that Haim had no right to

share the medical records of minor patients with the public. However, she omitted that the disclosed documents were not patient charts, were redacted to protect sensitive patient information, and complied with the Health Insurance Portability and Accountabil-

ity Act (HIPAA). HIPAA permits the disclosure of anonymized information and even protected information if it's used to stop egregious medical misconduct.

U.S. marshals notified Haim of the indictment at his home this week, summoning him to court for violating HIPAA. Haim and his legal team, who are still unclear on the full nature of the charges, are scheduled to appear in court on June 17.

"My client is anxious to get to trial to get his side of the story told," attorney Marcella Burke told National Review. "I am confident this will result in the correct decision being made."

We are Being Played; Know the “Rules” of Their Game or the US & Our Constitutional Republic Loses

Saul Alinsky’s “Rules for Radicals” is a widely used primer for organizers trying to create social change and political justice. These “rules” have also been adopted by many national, state and local politicians in their quest for power or support for issues which may not have anything to do with social change.

Alinsky was a Chicago-born archaeology major who, in the midst of the Great Depression, dropped out of graduate school and became involved first with the labor movement and then with community organizing. He has experienced unusual notoriety in recent years due to his connection with presidential candidate Hillary Clinton and alleged connection to President Barack Obama.

Clinton interviewed him and wrote her senior thesis, “An Analysis of the Alinsky Model,” while at Wellesley.

Critics of the President (who also



worked as a community organizer in Chicago prior to embarking on his political career) often link his name with that of Saul Alinsky, sometimes in ways that suggest the two men knew each other and worked together. While untrue, there is some evidence he did teach and practice Alinskian methods to create “change” as an organizer.

With an understanding of the “Rules” and a look back over the past 20

years, we will see that they are being employed by a vast number of “organizers” across all political interests to “divide and conquer” in a quest for power and support.

Disruption of meetings and creating fear are two of Alinsky’s most visible trademarks: using spectacles such as fighting, vulgarities, and incessant interruptions to make up for a lack of numbers; targeting an individual to make a large point; and using ridicule to persuade the undecided. All were visible in the 2016 Presidential Election cycle.

Alinsky (who died in 1972) explained that his book was concerned with how to create mass organizations to seize power and give it to the people. “What follows is for those who want to change the world from what it is to what they believe it should be. ‘The Prince’ was written by Machiavelli for the Haves on how to hold power. ‘Rules for Radicals’ was written for the Have-Nots on how to take it away.”

The “Rules for Radicals” outlined by Alinsky are:

1. “Power is not only what you have, but what the enemy thinks you have.” Power is derived from money and people. “Have-Nots” lack money so they must build power from flesh and

blood.

2. “Never go outside the expertise of your people.” It results in confusion, fear and retreat. Feeling secure adds to the backbone of anyone.

(Consider how organizers start by getting ‘the people’ to see them as one of them. Obama did this shortly after becoming President when he attacked a Cambridge police officer (without any facts) for arresting a black Harvard professor. We learned later that the officer was correct in his arrest. That was a non-issue for the President as he used this incident to let Blacks everywhere know he was one of them and he understood their fears.)

3. “Whenever possible, go outside the expertise of the enemy.” Look for ways to increase insecurity, anxiety and uncertainty.

(Consider Donald Trump’s characterizing opposing candidates like an editorial cartoonist by emphasizing one outstanding trait – “Crooked Hillary,” “Little Marco,” etc. This approach was well outside the norm for political battle, and put those who were targeted on defense.)

4. “Make the enemy live up to its own book of rules.” If the rule is that every letter gets a reply, send 30,000 letters. You can kill them with this because no one can possibly obey all of their own rules.

5. “Ridicule is man’s most potent weapon.” There is no defense. It’s irrational. It’s infuriating. It also works as a key pressure point to force the enemy into concessions. (Obama, Clinton, Trump, and Harry Reid are all guilty of using ridicule.)

6. “A good tactic is one your people enjoy.” They’ll keep doing it without urging and come back to do more. They’re doing their thing and will even suggest better ones.

Rules For Radicals

7. "A tactic that drags on too long becomes a drag." Don't become old news.

8. "Keep the pressure on. Never let up." Keep trying new things to keep the opposition off balance. As the opposition masters one approach, hit them from the flank with something new.

(Consider flank attacks by Democrats with charges that Candidate McCain had an affair, and then the release of the "Access Hollywood" video painting Trump as a molester.)

9. "The threat is usually more terrifying than the thing itself." Imagination and ego can dream up many more consequences than any activist.

10. "The major premise for tactics is the development of operations that will maintain a constant pressure upon the opposition." It is this unceasing pressure that results in the reactions from the opposition that are essential for the success of the campaign.

11. "If you push a negative hard enough, it will push through and become a positive." Violence from the other side can win the public to your side because the public sympathizes with the underdog.

(Consider Clinton's charge that temperamental Trump was unfit to serve, and Trump's charge that "crooked" Hillary was unfit to serve. And Senator Harry Reid's aggressive approach to almost any issue and Hollywood's romanticizing of provocative issues.)

12. "The price of a successful attack is a constructive alternative." Never let the enemy score points because you're caught without a solution to the problem.

13. "Pick the target, freeze it, person-

alize it, and polarize it." Cut off the support network and isolate the target from sympathy. Go after people and not institutions; people hurt faster than institutions.



(Consider what we are witnessing with just about every Trump appointee... racism, fascism, xenophobia, etc.)

Alinsky methods work. They have been widely adopted in the quest for power by politicians, Hollywood, interest groups and other organizations with vested interests. They have contributed to today's absence of any fundamental truth and the resulting absence of productive political discourse. Moral relativity is the only truth and from this comes political correctness, gender conflict, gender confusion and so many other confusing aspects of US culture that had at one time been anchored in truth. These methods, though, create the very unrest and disparities that those who use them claim to be fighting against.

One of many troubling aspects of Alinsky's philosophic approach centers on the notion of "means and ends." "Means and ends are so qualitatively interrelated that the true question has never been the proverbial one, 'Does the End Justify the Means?' but always has been 'Does this particular end justify this particular means?' ...

THE END JUSTIFIES ALMOST ANY MEANS. Moral rationalization is indispensable

at times of action...to justify the selection for use of means and ends."

This philosophy made national news in 1996 when Vice-President Gore's role was exposed in a money-laundering scheme involving the California-based Hsi Lai Buddhist temple. Gore admitted his mistake on TV when questioned in a news conference, but he continued by adding, "Think of the importance of what we were doing and how we were going to use this money." The ends justify the means (laws are to be broken for the right ends) was in evidence at the highest levels of our government.

A fundamental reason many felt Hillary Clinton lost her presidential bid was that Democrats forgot the "white working man."

Alinsky points to the political power of this group in the book's last chapter, "The Way Ahead."

"America's white middle class... is where the power is... The middle

class are fearful people, who feel threatened from all sides: the nightmare of pending retirement and old age with the social security decimated by inflation; the conflict of cultures threatening job competition; the high cost of long-term illness; and finally with mortgages outstanding, they dread the possibility of property devaluation from non-whites moving to the neighborhood. They are beset by taxes and installment buying. They are victimized by TV commercials with fraudulent claims. Their pleasures are simple - once a week dinner out, gardening, etc. They look at the unemployed poor as a parasitical dependency, recipients of the vast variety of massive public programs they will pay for."

"Rules for Radicals" is an important book. The book is centered on manipulation through disruption using tactics (means) that are justified by the ends...the ends of those seeking power that comes from division.

We are being played and unless we know the "rules" of their game, the US and our Constitutional Republic will lose."

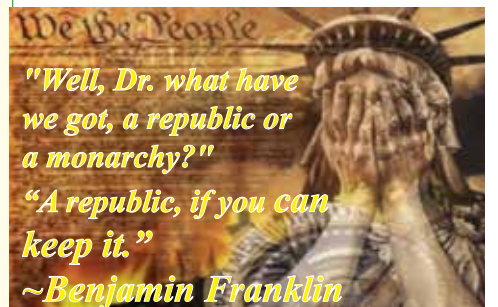

Julian Assange Is Free!

It wasn't until 1969 that the Supreme Court's modern First Amendment jurisprudence made it clear that whenever there is a clash between the government and a person over the constitutionality of the person's speech, the courts will give every benefit and draw every inference to the speaker and none to the government. This is so because the freedom of speech is a natural right. It is also expressly protected by the Constitution, thus it is always to be presumed constitutional and lawful.

I have argued elsewhere that because the essence of government is the negation of liberty, this presumption against the government should always



be the case. Even when it purports to be protecting liberty, the government (because its existence without unanimous consent is based on stealing liberty and property from those who have not consented) should always be presumed wrong, immoral, unconstitutional and unlawful. But the courts have only made that so in the case of the freedom of speech.

I offer this brief legal lesson in order to examine just how twisted the government's views on speech have become in the Trump and Biden years, as the Department of Justice in

both administrations has persecuted mercilessly and sought to prosecute aggressively the Australian journalist Julian Assange for his exercise of the freedom of speech - up until now.

Here is the backstory.

Assange was the head of WikiLeaks, an international digital journalistic enterprise that specializes in publishing formerly secret matters about governments. In 2010, WikiLeaks acquired secret U.S. videos showing an attack on civilians and journalists in Baghdad perpetrated by American Apache helicopters. The 2007 attack killed a dozen civilians and two Reuters employees. The George W. Bush administration had egg on its face, as it had previously denied that this attack had taken place.

The video also contained audio that revealed the cavalier, childish and remorseless attitude of the military personnel who perpetrated the deaths of these innocents.

In the ensuing weeks and months, WikiLeaks re-

leased hundreds of thousands of pages of secret classified materials and diplomatic cables, which further embarrassed the Bush and Obama administrations. The government claimed that this was the largest security breach of secret materials in American history. The documents revealed government crimes and death on a grand scale.

WikiLeaks' source for these secret materials was an Army intelligence specialist, Bradley Edward Manning. Manning was arrested and charged with numerous offenses, not the least of which was providing aid and com-

fort to an enemy, for which he was exposed to the death penalty. Manning pleaded guilty to some of the charges and was tried and convicted on the remainder of them.

He was sentenced to 35 years in a military prison. In 2017, President Barack Obama commuted Manning's sentence to time served, and he was ordered released just hours before the inauguration of Donald Trump to the presidency.

Trump, who had been harshly critical of both Manning and Assange, ratcheted up his attacks on Assange and Obama after Manning's prison release. His anger was interpreted by his Department of Justice as his wish for an indictment of Assange, which the DoJ obtained 18 counts including espionage. The DoJ then sought Assange's extradition from London, whereupon he fled to the Ecuadorian Embassy there, where he resided in the basement for seven years until he was forcibly extracted by British police.

The case against Assange is a sham and is motivated by the U.S. intelligence community and its colleagues in the DoJ. It is a sham because the First Amendment protects the freedom of speech of all persons, not just Americans. Even though the materials Assange and WikiLeaks received had been stolen by Manning, because they were and are of profound interest to the public (American drones targeting civilians, secret U.S. military actions in countries with which the U.S. was not at war, and government lying to the public on a grand scale) the media is free to reveal them.

The Supreme Court announced this legal principle in the Pentagon Papers case in 1971. There, Daniel Ellsberg, a civilian employee of the Pentagon, stole classified materials that demonstrated that U.S. Army generals had been lying to President Lyndon B. Johnson and LBJ had been lying to the public about military progress during the war in Vietnam.

When Ellsberg turned the materials over to The New York Times and to The Washington Post, the Nixon DoJ obtained a court order barring their publication. Within days, the Supreme Court lifted that order and issued an opinion further expanding First Amendment rights (to include the right to know what the government

has done).

The court ruled that publishers are immune from civil liability and criminal prosecution when they publish data of material interest to the public, even if the data was stolen.

Ellsberg, like Manning, was indicted for espionage. Yet, when the trial judge in Ellsberg's case learned that the FBI had vandalized the office of his psychiatrist looking for his medical records, the judge dismissed the case.

Last weekend, the American and British governments agreed to set Assange free if he pleads guilty to one count of conspiracy to commit espionage. He will be sentenced to time served and then go home to freedom in Australia. I am ecstatic that Assange is free. Once he reaches Australia, he should denounce the governments that persecuted him and renounce his own guilty plea since he has committed no crime. Then, he should resume WikiLeaks revelations!

The feds have perfected three things — lying, stealing and killing. In the Assange revelations, we learned that they have excelled at what they have perfected. They don't care about the Constitution or the rule of law, both of which they have sworn to uphold. The deep state is animated by a warped belief that its personnel are superior to the Constitution and can use the powers of government however they want, so long as they can get away with it.

They prefer the government's unbridled liberty and the servitude of the rest of us. Assange is a hero. He exposed government without limits — the archenemy of personal freedom.

SCOTUS Overturns Chevron in Massive Defeat for Regulatory Agencies

On Friday, the United States Supreme Court greatly limited the ability of regulatory agencies such as the Environmental Protection Agency (EPA) to essentially fill in the details when laws are unclear. The 40-year-old Chevron Decision effectively granted the regulatory state (which consists of unelected bureaucrats) power to broadly interpret laws and, in effect, create laws based upon those interpretations.

However, in today's 6-3 decision in *Loper Bright Enterprises v. Raimondo*, the Court's conservative wing voted to overturn *Chevron U. S. A. Inc. v. Natural Resources Defense Council*. "The Administrative Procedure Act requires courts to exercise their independent judgment in deciding whether an agency has acted within its statutory authority, and courts may not defer to an agency interpretation of the law simply because a statute is ambiguous; *Chevron* is overruled," wrote Chief Justice John Roberts in the decision.

Left-wing court watchers claim the decision is a large gift to corporations and could result in numerous deaths due to the Deep State's inability to intervene against "bad laws." California Democratic Rep. Adam Schiff was immediately worried about how the decision would affect the EPA's ability to make climate change law. "This partisan Supreme Court just shredded



another precedent, overturning the *Chevron* decision and weakening our ability to combat the climate crisis, hold corporations accountable, and much more," Schiff posted on X. "Our people and our planet will feel the consequences."

Conservatives are overjoyed at the news, with some considering it an opening salvo in the battle against the Deep State. "HUGE WINNING.... SCOTUS overturns 1984 *Chevron* decision," posted Steve Milloy, a climate realist with *JunkScience.com*. "Regulatory agencies don't get to make up law anymore. @realDonaldTrump made this possible!"

The *Chevron* decision held that government agencies should be given wide discretion when there is ambiguity in law. Today's SCOTUS ruling found that those decisions rightly are the purview of courts, not bureaucrats. "Courts must exercise their independent judgment in deciding whether an

agency has acted within its statutory authority," Roberts wrote.

The rise of the regulatory state has been going on since the New Deal of the '30s, which led to a bloated government full of alphabet agencies. The Court recognized this. "During the 'rapid expansion of the administrative process' that took place during the New Deal era ... the Court often treated agency determinations of facts binding on the courts, provided that there was 'evidence to support the findings,'" Roberts wrote. "But the Court did not extend similar deference to agency resolutions of questions of law."

In concurrence, Justice Neil Gorsuch claimed that *Chevron* was simply bad precedent in that it relied on the opinions of regulators, which usually echoed the wants of the executive branch. "Beginning in the mid-1980s, however, this Court experimented with a radically different approach. Applying *Chevron* deference, judges began deferring to the views of executive agency officials about the meaning of federal statutes." Gorsuch wrote. "With time, the error of this approach became widely appreciated. So much so that this Court has refused to apply *Chevron* deference since 2016."

Justice Elena Kagan, who dissented along with Justices Sonia Sotomayor

and Ketanji Brown Jackson, wasn't so convinced, and argued that "if the court finds, at the end of its interpretive work, that Congress has left an ambiguity or gap, then a choice must be made. Who should give content to a statute when Congress's instructions have run out? Should it be a court? Or should it be the agency Congress has charged with administering the statute?" Kagan argued that *Chevron* "has become part of the warp and woof of modern government, supporting regulatory efforts of all kinds—to name a few, keeping air and water clean, food and drugs safe, and financial markets honest." "The majority is sanguine; I am not so much," she wrote.

Any victory in the war against the Deep State must be appreciated, and this is potentially a huge win. While the EPA and other climate-change friendly agencies attempt to regulate gas stoves out of existence and create other onerous regulations, they now have one less arrow in their quiver.

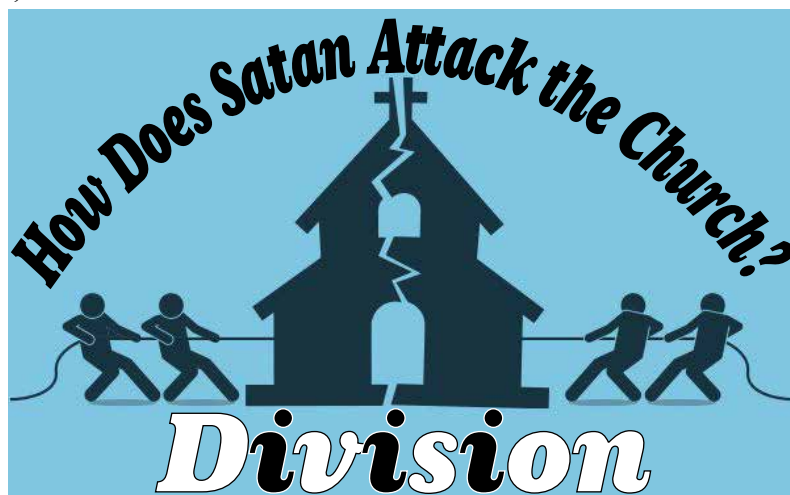
chapter 1 tells us what God thinks about denominations - Paul is teaching here.

Directed Energy Weapons: A New Era of Warfare

What are Directed Energy Weapons?

Directed Energy Weapons (DEWs) use different regions of the electromagnetic spectrum to affect their targets using variations of light including those that cannot be seen by the human eye.

There are 3 classifications of DEWs:

First, there are High Energy Lasers which use beams of light on the infrared spectrum to attack one target at a time. The output of HEIs are 200,000 times greater than a laser pointer you may have at home. These weapons are capable of melting steel.

Second category of weapons would be the Millimeter Wave Weapons which use wavelengths between 1 and 10 mm to generate over 1 kilowatt of power. MWWs can affect multiple targets at once because they use larger beams.

The third category of DEWs are termed High Power Microwave Weapons (HPMWs). They can produce more than 100 megawatts of power which is 150,000 times more powerful than your microwave at home. These HPMWs have longer wavelengths than HEIs and can hit multiple targets at once.

DEWs are also launched at different strengths depending on the mission. Each DEW can be calibrated to perform tasks ranging from non-lethal to lethal, depending on factors such as the time on target, the distance to the target, and even the part of the target on which the DEW is focused.

Military Applications for DEWs

* Lasers can be used for remote sensing to support military operations. The military can use DEWs to measure and monitor objects without ever making physical contact with the object or subject.

* DEWs offer plausible deniability, 5th generation warfare's best friend. These silent weapons can travel immense distances and engage multiple targets from up to thousands of miles away.

* DEWs can be launched from targets on earth to other targets on

earth. They can be launched from earth at targets in space and they can be launched from satellites in space to targets on earth. This weapon offers near-real time attacking capabilities as they can be calibrated and deployed to engage targets in a matter of seconds. * The US government has deployed DEWs on land vehicles, aircraft, helicopters, and ships. These weapons are also utilized on satellites.

What is Fifth Generation Warfare (5GW)?

* "War will no longer be what it was originally. Warfare will transcend all boundaries and limits. In short, unrestricted warfare." This means that war will be fought using creative, less attributable attacks. Anything goes in 5gw.

* It is "moral and cultural warfare that is fought through manipulating perceptions and altering the context by which the world is perceived." The theory suggests that in 5gw "violence

is so dispersed that the losing side may never realize that it has been conquered. The secrecy of 5gw makes it the hardest generation of war to study."

Using Wildfires as a Weapon

* The US government wargamed using wildfires in Vietnam

to attack enemy strongholds in the jungle, destroy enemy supplies, and to create visibility (post-burn) of the landscape below.

* A declassified, secret report entitled "Forest Fire as a Military Weapon Final Report June 1970," discusses conditions preferable when selecting a target for forest fire sabotage.

- Heavy fuel loadings of unusually dry material.
- Many simultaneous ignitions.
- Intense solar insolation.
- An unstable atmospheric lapse rate.
- Marked vertical and/or horizontal wind shear.

* They also discuss when selecting a target, you must understand the location's dry season, the vegetation of the location, the humidity content of brush on the ground, and how to preplace litter at ideal humidity levels to ensure the fire catches.

Concerns About the Use of DEWs in

Hawaii

* Lasers can cut through steel, aluminum, and many other materials in a matter of seconds.

- We see melted aluminum in the burn zone of Lahaina. The melting point for Aluminum is 1,221°F. This is something seen in wildfires as they can burn as hot as 2000 °F.

- We see melted glass. The melting point for glass is 2,522 to 2,912 °F. This is less likely to occur in a wildfire as the heat required is a lot greater. However, this can happen to cars that burn during wildfires as the car itself can generate the heat necessary.

- We see melted tires and rims. The melting point for tire rubber is 1,112 °F which is not significant in this case.

- The melting point for aluminum-alloy is 2511 °F.

- The melting point for steel is between 2500 to 2800 ° F.

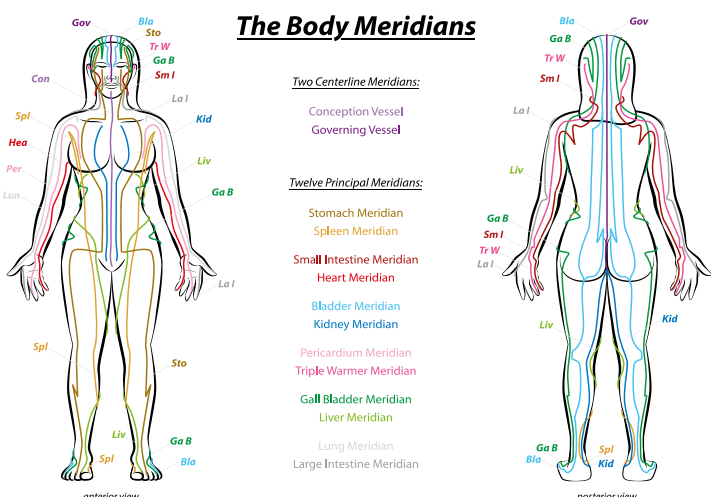
- Most shockingly, The melting point for chrome is 3380 °F.

* DEWs are not confirmed to be used in Maui but are suspected. The eventual heat a wildfire can cause on its own could have the effect we see in Maui when looking at the tires and aluminum alone. If we are being generous, it could even explain the glass in cars melting, as it is possible to generate enough heat in a car fire to have this effect. However, considering the high temperature requirements necessary to melt the materials most commonly

used to make the rims of tires (especially chrome) this is cause for further investigation.

* DEWs can be invisible to the human eye and are silent weapons systems.

This is especially useful in a clandestine attack. Starting spontaneous fires from space could easily go unnoticed.

* Gravity and wind conditions have minimal effect on laser weapons.

The winds during the Maui Fire were blowing up to 67 mph.

* DEWs are able to be launched from space-to earth and earth-to-space because these factors do not have a great effect on the beams.

* Technological advances may soon solve DEW limitations, such as weather, power loss, and visibility restrictions. In defense terms, that means they have most-likely already solved these problems and have yet to disclose this publicly.

* Confirmed by Japan, Chinese Lasers were spotted above Maui several months prior to the fires. As we know lasers can be used to map objects remotely. This alongside rumors surrounding the location of Chinese satellites on the day of the fire offers more questions than answers.

* DEWs and other conventional weapons are completely legal in space.

It is not crazy to think there may be laser weapons above your head. Both

the US and China have repeatedly thwarted attempts by the international community to make conventional weapons like DEWs illegal in space. Russia, China, and the US all have anti-satellite

(ASAT) weapons programs, which explore the use of these systems. They were confirmed to be in development by the US Air Force in 2021.

* Forest flammability depends on the amount and arrangement of dead vegetation at ground level, the moisture content of vegetative fuel and the weather at the time of the fire. Maui has had decreased rainfall for the past 15 years. They are currently in a drought. The dry season for Maui is from April to October. The highest temperatures in Maui are recorded from July to September. Hawaiian Electric invested less than \$245,000 dollars on wildfire prevention from 2019-2022. This includes neglecting the task of clearing brush from around power lines.

* 5th Generation warfare is happening all around us. Could this be an example in Hawaii? This is entirely on the table. In 5gw you have the right to question everything. Though we may not have definitive answers on how this fire was started, enough questions remain. Considering the selection of Maui as a future "smart city", the media blackout on location and the lack of federal response, something strange is going on. When your questions are not answered but rather ignored, that usually means you should keep pushing. You've hit a nerve.

Walter Spawr & Grand Jury
