A stunning cascade of events in June and July saw President Biden fall out of favor among his elite supporters and withdraw abruptly from the presidential race, to be replaced as a candidate by his under-achieving vice president, Kamala Harris. Harris has enjoyed little news coverage since the 2020 election, and such attention as she has garnered has been largely unfavorable. Yet despite strong reservations about her candidacy being voiced by some in the Democratic Party (such as Alexandria Ocasio-Cortez of New York), Harris somehow underwent a total media makeover in a single week, transformed by the magic of astroturfed hype from a ditzzy California liberal with an off-putting laugh into a hip, savvy policy maven raised up by destiny to be Donald Trump's electoral nemesis.

Kamala Devi Harris was born in Oakland, California, to an Indian-American mother and a Jamaican-American father. Her mother, a successful endocrinologist, and her father, an economics professor in the post-Keynesian tradition, were divorced when Kamala was seven. Harris lived around the United States and in Canada while growing up, but ended up attending law school in California, where she graduated in 1989 and was admitted to the bar in 1990.

The ambitious Harris soon became a fixture in left-wing California politics. As deputy district attorney in Alameda County in the early 1990s, she began publicly dating Willie Brown, the married speaker of the California Assembly. Brown, who had a reputation not only for public extramarital dalliances but also for

elevating his cronies to lucrative positions in the state government, appointed Harris in 1994 to the Unemployment Insurance Appeals Board. Subsequently, he appointed her to the California Medical Assistance Commission. As the Los Angeles Times reported at the time: "Assembly Speaker Willie Brown, continuing his rush to hand out patronage jobs while he retains his powerful post, has given high-paying appointments to his former law associate and a former Alameda County prosecutor who is Brown's frequent companion. Brown, exercising his power even as his speakership seems near an end, named attorney Kamala Harris to the California Medical Assistance Commission, a job that pays \$72,000 a year. Harris, a former deputy district attorney in Alameda County, was described by several people at the Capitol as Brown's girlfriend. In March, San Francisco Chronicle columnist Herb Caen called her "the Speaker's new steady."... Harris accepted the appointment last week after serving six months as Brown's appointee to the Unemployment Insurance Appeals Board, which pays \$97,088 a year." In 2024 dollars, those two salaries equate to \$151,000 and \$206,000, respectively.

In 1998, Harris moved to San Francisco to become an assistant district attorney, and six years later she was elected district attorney of the City by the Bay. In that capacity she served for two terms, until 2011. Among her more-celebrated achievements were creating new units for environmental crimes and hate crimes, her efforts to ban all gun shows within city limits, and her opposition to the death penalty. She also led a group of prosecutors seeking to influence the Supreme Court's 2008 Heller decision on the Second Amendment.

After two terms as San Francisco DA, Harris became California's attorney general in 2011. During her six-year term, she fought to invalidate California's Prop 8, which defined marriage as being between one man and one woman. She worked to overturn California's ban on affirmative action, and supported a bill to microstamp firearms, to make it easier for the state of California to track them.

National Debut

Kamala Harris first burst upon the national scene in 2017, when she was elected to the U.S. Senate. Her three years as California's junior senator solidified her image as a

Justices allow Arizona to enforce proof of citizenship law for 2024 voter registration

A divided Supreme Court on Thursday afternoon granted a request from the Republican National Committee and the Republican leaders of Arizona’s legislature to reinstate a state law that requires residents to provide proof of citizenship to register to vote using a form provided by the state. The court turned down a request, however, to reinstate the portion of the same law that would bar voters who register using a standard federal form from voting for president or by mail unless they provide proof of citizenship.

The vote was 5-4. In a brief unsigned order, three of the court’s conservative justices – Clarence Thomas, Samuel Alito, and Neil Gorsuch – indicated that they would have granted the RNC’s application to fully reinstate the law. Four other justices – Sonia Sotomayor, Elena Kagan, Amy Coney Barrett, and Ketanji Brown Jackson – indicated that they would have denied the RNC’s request in its entirety, keeping in place a ruling by a federal district court in Arizona blocking the state from enforcing the law. Chief Justice John Roberts and Justice Brett Kavanaugh did not publicly signal how they voted, but they must have provided the two remaining votes necessary to revive the portion of the law dealing with the state form. The RNC and the legislative officials had asked the justices to act by Aug. 22, to give the state enough time to print ballots before the election.

The National Voter Registration Act of 1993 requires states to “accept and use” a standard form to register voters for federal elections. That federal form requires would-be voters to swear, under penalty of perjury, that they are U.S. citizens, but they are not required to provide proof of citizenship.

The Arizona law at the center of the dispute is known as H.B. 2492.

Enacted in 2022, it directs county officials to attempt to verify the U.S. citizenship of anyone who attempts to register using the federal form. If the officials cannot do so – for example, because they do not have access to databases that would provide information about citizenship – the applicant must submit proof of citizenship (such as a passport or birth certificate) to vote for president or by mail. In a separate provision, the law also requires anyone who registers using Arizona’s state form to submit proof of citizenship.

Soon after the law was enacted, the federal government and a group of private plaintiffs (including voting-rights groups and Democrats) went to federal court in Arizona to challenge H.B. 2492. They argued that the NVRA supersedes Arizona’s requirement to submit proof of citizenship to vote for president or by mail. The private plaintiffs also contended that a 2018 consent decree barred the state from enforcing the requirement to provide proof of citizenship to register using state forms.

decreed barred Arizona from enforcing the state-form provision. In a final order entered in May of this year, the district court prohibited the state from enforcing any of the provisions.

The Republican National Committee and Republican leaders of the state senate and house joined the case to defend the law. On July 18, a three-judge panel of the U.S. Court of Appeals for the 9th Circuit granted their request to put the portion of the district court’s order dealing with the consent decree and the state-form provision on hold. However, the court of appeals left in place the part of the order holding that the NVRA supersedes the federal-form provisions.

On Aug. 1, a different three-judge

panel reinstated the district court’s order, prompting the RNC and legislative leaders to come to the Supreme Court on Aug. 8, asking the justices to put the district court’s order

on hold “to the extent it requires Arizona to (1) accept state-form voter registration applications lacking documentary proof of citizenship and (2) allow voters who have not provided documentary proof of citizenship to cast ballots for president or by mail.”

Pointing to what it characterized as the 9th Circuit’s “disruptive displacement of election rules enacted by the Arizona Legislature in 2022,” the RNC contended that the Purcell principle – the idea that courts should not change election rules during the period of time just prior to an election – warranted the Supreme Court’s intervention. The RNC also criticized the district court’s order as an “unqualified abrogation of the Arizona legislature’s sovereign authority to determine the qualifications of voters and structure participation in its elections.”

First, it contended, by pointing to the 2018 consent decree as a reason to prohibit the state from enforcing the proof-of-citizenship requirement for its own voter registration forms, the court of appeals “ignored the established rule that a consent decree generally yields to a change in the law, including a change in statutory law.” The RNC suggested: the 9th Circuit’s reasoning “presents significant separation-of-powers concerns” because it “would mean that a judgment entered unilaterally by an executive branch officer indefinitely displaced the Legislature’s power.”

Second, the RNC continued, requiring proof of citizenship for voters who want to register using the federal form and then vote by mail provision that protects against fraud. But the

district court’s ruling “expands a statute focused on voter registration to require Arizona to expand mail-in voting,” the RNC complained. And the NVRA does not preempt state law with regard to voting for president, the RNC added, because the Constitution only gives Congress limited power over the selection of presidential electors. “That authority does not permit Congress to displace state rules for registering to vote in presidential elections.”

Represented by U.S. Solicitor General Elizabeth Prelogar, the Biden administration had urged the justices to turn down the RNC’s request “to the extent it seeks a stay of the portion of the injunction based on the United States’ NVRA claim.” The RNC’s “ cursory discussion of the relevant issues provides no sound basis for a stay,” Prelogar insisted, particularly when it is seeking relief based on the premise that a federal law is unconstitutional.

More specifically, Prelogar continued, the Supreme Court in 2013 ruled – in a case involving Arizona – that states violate the NVRA if they reject a federal form based on the voter’s failure to provide proof of citizenship. States cannot require a voter to provide any additional information beyond what

Mexico's slide into semi-dictatorship will threaten U.S. trade, border security

Mexico's leader plans legal changes that will give the government near total powers. Here's how it will affect the U.S.

When we think about Latin American dictatorships, the first countries that come to mind are (rightly so) Cuba, Venezuela and Nicaragua. However, there are growing signs that we may soon have to add a much bigger country, Mexico to a subcategory of non-democracies.

Leftist populist President Andres Manuel Lopez Obrador (who leaves office on October 1st) has announced plans to make constitutional changes that would leave his protégé, President-elect Claudia Sheinbaum, with almost absolute powers. That would not only turn Mexico into an elected autocracy, but threaten to disrupt America's trade with its biggest commercial partner in the world, and increase political strife and illegal migration. Last year, Mexico became the top U.S. trade partner, surpassing China for the first time in 20 years.

Lopez Obrador's proposed constitutional changes would change the way in which judges are elected and eliminate several autonomous government agencies. They are very likely to pass and have already sparked a rare public confrontation with the Biden Administration. U.S. Ambassador to Mexico Ken Salazar, who until now had gone out of his way to avoid criticizing the Mexican

government, said on Aug. 22 that Lopez Obrador's planned judicial reform poses a "risk" to Mexico's democracy and "threatens the historic commercial relationship" between Mexico and the United States. Under Lopez Obrador's judicial reform, which is supported by Sheinbaum, Mexico would start electing its judges and Supreme Court justices by popular vote. That would allow the ruling party to use its huge electoral machinery to pack the courts with loyalist judges, and would in effect leave the government in full control of the executive, legislative and judicial powers.

If these reforms are implemented, the U.S.-Canada-Mexico free trade agreement will be in serious trouble, U.S. and Canadian trade experts say. The three-decade-old treaty is coming up for a new renegotiation in 2026, and neither the United States nor Canada are likely to accept renewing it without an independent Mexican court system.

A day before Salazar's statement, investment bank Morgan Stanley downgraded its Mexican stocks appraisal, in effect telling its clients to sell Mexican shares, in part because of Lopez Obrador's planned judicial reform.

The Mexican president reacted angrily to Salazar's remarks, calling the U.S. envoy's statements



"improper" and an intervention in Mexico's internal affairs. On Tuesday, he declared a "pause" in Mexico's ties with the U.S. and

Canadian ambassadors, although he did not extend it to their respective governments. Sheinbaum said that neither investments in Mexico nor the country's democracy are in any danger by the planned reforms.

I have serious doubts about that. The proposed legal changes are already on shaky ground because the government has twisted the law to get a questionable two-thirds majority in Congress it needs to change the Constitution. Using a dubious interpretation of the law, Mexico's government-controlled National Electoral Institute awarded the ruling party and its allies 73% of the seats in the lower house of Congress, despite the

fact that they only won 54% of the vote in the June 2 elections.

In addition, Mexico has a long history of elected authoritarian governments, which would make Sheinbaum's near absolute powers hardly a novelty. An all-powerful party, the Institutional Revolutionary Party, ruled Mexico for about 70 years in the 20th century, before the country's transition to democracy in 2000.

Nearly 30 years ago I covered Mexico as a correspondent for The Miami Herald. I wrote a book on Mexico titled "Bordering on Chaos," in which I portrayed the country as a nation grappling with record homicide rates, besieged by drug trafficking, plagued by corruption and dominated by an almighty ruling party. Three decades after a democratic transition, thanks (in part) to closer ties with the United States helped modernize Mexico, the country seems to be going back to where it was then. That's very bad for Mexico, and will be bad for the United States.

Chairman Jordan:

I appreciate the Committee's interest in content moderation on online platforms. As you are aware, Meta has produced thousands of documents as part of your investigation and made a dozen employees available for transcribed interviews. Further to our cooperation with your investigation, welcome the opportunity to share what I've taken away from this process. There's a lot of talk right now around how the U.S. government interacts with companies like Meta, and I want to be clear about our position. Our platforms are for everyone - we're about promoting speech and helping people connect in a safe and secure way. As part of this, we regularly hear from governments around the world and others

with various concerns around public discourse and public Safety.

In 2021, senior officials from the Biden Administration and the White House repeatedly pressured our teams for months to censor certain COVID-19 content, including humor and satire and expressed a lot of frustration with our teams when we didn't agree. Ultimately, it was our decision whether or not to take content down, and we own our decisions, including COVID-19-related changes we made to our enforcement in the wake of this pressure. I believe the government pressure was wrong and regret that we were not more outspoken about it. Also, I think we made some choices that (with the benefit of hindsight and new information) we wouldn't make



today. Like I said to our teams at the time, I feel strongly that we should not compromise our content standards

due to pressure from any Administration in either direction - and we're ready to push back if something like this happens again.

In a separate situation, the FBI warned us about a potential Russian disinformation operation about the Biden family and Burisma in the lead up to the 2020 election. That fall, when we saw a New York Post story reporting on corruption allegations involving then Democratic presidential nominee Joe Biden's family, we sent that story to fact-checkers for review and temporarily demoted it while waiting for a reply. It's since been made clear that the reporting was not Russian disinformation, and in retrospect, we shouldn't have demoted the story. We've changed our policies and processes to make sure this doesn't happen again. For instance,

we no longer temporarily demote things in the U.S. while waiting for fact-checkers.

Apart from content moderation, I want to address the contributions made during the last presidential cycle to support electoral infrastructure. The idea here was to make sure local election jurisdictions across the country had the resources they needed to help people vote safely during a global pandemic. These contributions were made through the Chan Zuckerberg Initiative and were designed to be non-partisan, spread across urban, rural, and suburban communities. Still, despite the analyses I've seen showing otherwise, I know that some people believe this work benefitted one party over the other. My goal is to be neutral and not play a role one way or another - or to even appear to be playing a role. So don't plan on making a similar contribution this cycle.

More European Companies Go Bankrupt, Debts Soar and Shortages Grow

The number of business failures in the European Union rose by 3.1% in the second quarter of the year after having increased by 4.5% in the previous quarter. Yet, despite the collective European Union economy being ruined, the bloc insists on self-destructive policies, such as the imposition of anti-Russia sanctions, which has only boomeranged instead of bringing down the Russian economy as was hoped.



crease in the price of energy, which has only accelerated the deterioration of the bloc's economy. In this context, Finland's rejection of Russian timber due to European sanctions led to a sharp decline in the production of wood products, the closure of factories and an increase in prices. For its part, Russia found alternative buyers and significantly expanded its exports of this product.

Meanwhile, Sweden is considering offering migrants, refugees, and even its own citizens money to leave the country. This "voluntary" policy guarantees payments of just \$950 per adult from the government to cover the costs of leaving.

Effectively, it is a vicious cycle that is getting out of control and sooner or later, the whole sanctions regime will need to be dismantled since it is neither for the individual interests of European citizens nor European industry. The EU is becoming the biggest failure of the neoliberal model. Although it will unlikely collapse the bloc, it has exposed that the EU is no longer the economic powerhouse it once was.

Moscow is not under any illusions about Europe waking up from its inertia, with Russian foreign ministry official Dmitry Birichevsky expressing his belief that Russia will need to navigate through "decades" of economic sanctions from the West.

"This is a story for decades to come. Whatever the developments and results of a peaceful settlement in Ukraine, it is, in fact, only a pretext," he said on August 16, adding that Russia is working with other long-sanctioned countries like Iran, North Korea, and Venezuela to form an "anti-sanction" coalition. "The sanctions were first introduced much earlier. Their ultimate goal is unfair competition," Birichevsky continued.

Despite the sanctions, Russia's economy continues to grow at an impressive rate. GDP growth was 4% in the second quarter and 4.7% in the first half

of 2024. This is astronomically higher than the 0.2% recorded by Germany, Europe's supposed economic powerhouse, in the first quarter and 0.1% in the second quarter. France's GDP expanded by only 1.10% in the second quarter, while Spain and Italy recorded only 0.80% and 0.20%, respectively. This highlights how much the EU's economies struggle when Russia continues to boom despite the sanctions.

Even more alarmingly, the Ukrainian invasion of the Kursk Oblast, where the Russian gas transmission station ***Continues on Page 21***

According to Eurostat data, in terms of countries, Greece led the increase in business bankruptcies with a rise of 133%, followed by Lithuania (16.7%) and Slovakia (7.6%). At the same time, Italy's public debt has reached a new all-time high, exceeding €2.9 trillion in June 2024. According to the Bank of Italy, the country's debt increased by €30.3 billion compared to the previous month, reaching €2.94 trillion.

Evoking the famous phrase from former US President Bill Clinton's campaign, 'It's the economy, stupid,' a similar logic applies to the EU's struggling economy: 'It's the sanctions, stupid.' As of August 2, the EU had added up to 19,500 individual and sectoral sanctions on Russia, even though it is beyond doubt that such sanctions had a boomerang effect.

Ukraine's incursion into Russia's Kursk Oblast and the tightening of sanctions against the Russian gas industry, coupled with the gas shortage in the EU, have led to a record in-

It is a devastating stat." Blackburn continued, "Five to 600 children under the age of 18 go missing every single month in Tennessee, and nearly 60% of those children are minorities."

According to NBC NEWS the Department of Health and Human Services inspector general examined a random subset of 342 cases from March and April 2021, a period during which almost 17,000 migrant minors were released to live with sponsors and found that 16% of the cases had one or more safety checks that were not documented in the files. In 19% of the cases examined, there were no results about the outcome of various FBI fingerprint, child abuse and negligent safety checks. In more than one third of the cases, the IDs that were provided (in order to verify sponsor identities) were hard to read or had incomplete images. There were also mandatory home studies that were not conducted.

NBC NEWS also reported that in 2021 and 2022, more than 263,500 unaccompanied minors were released into this country and almost 15% of them were released to non-family sponsors. Wendy Young, president of "Kids in Need of Defense", advocates for unaccompanied migrant children, and she stated "...some kids are placed into settings where they may not know the person and they are treated as a second-class citizen in the family and under pressure to work." A Labor Department investigation found more than 100 children (many of them unaccompanied minors from Guatemala) were employed cleaning Midwestern slaughterhouses. The Labor Department said the children that were working overnight shifts used "caustic chemicals to clean razor-sharp saws," and that there were 102 minors as young

as 13, working hazardous overnight jobs cleaning slaughterhouses in eight states.

 radical-left reactionary and one of Trump's most vicious detractors on Capitol Hill. For one thing, she quickly staked out a position as one of the most anti-gun legislators in Washington — she was a co-sponsor of bills aimed at requiring universal background checks, banning so-called assault weapons, and imposing yet more unconstitutional federal controls on gun dealers. She was one of the most visible ringleaders of the Democratic parliamentary revolt during the Senate confirmation hearing of Supreme Court Justice Brett Kavanaugh, and has since raged against Trump's three Supreme Court appointees, whom she blames for the overturning of *Roe v. Wade*. She also supported and co-sponsored the Green New Deal in 2019, baring her radical-left environmentalist leanings for all to see.

On immigration-related issues, which have since become the defining issue of her term as vice president, then-Senator Harris opined in 2018 that Immigration and Customs Enforcement (ICE) should probably be scrapped, telling MSNBC, "I think there's no question that we've got to critically re-examine ICE and its role and the way that it is being administered and the work it is doing, and we need to probably think about starting from scratch." Also in 2018, during a confirmation hearing for Ronald Vitiello, whom Trump had nominated to lead ICE, Harris compared the public image of ICE to that of the KKK, helping to lay a rhetorical foundation for outrageous media lies in 2021 about ICE agents whipping illegal Haitian immigrants with riding crops.

Radical Views

It was during the 2020 presidential campaign, however, that Kamala Harris' leftist bona fides really burst forth. On abortion, Harris made it clear that *Roe v. Wade* did not go far enough, in her view. She proposed additional federal abortion protections, including a requirement for federal "pre-clearance" of any state abortion laws. Harris continues to rail against Trump for the overturn of *Roe v. Wade*, and will doubtless make it a prominent part of her 2024 presidential campaign.

Following the infamous George Floyd riots in Minneapolis in May and June of 2020, Harris lent public support to the rioters (whom she euphemistically called "protesters")



on *The Late Show With Stephen Colbert*. After Colbert commented, "I know there are protests still happening in major cities across the United States, I'm just not seeing the reporting on it that I had for the first few weeks," Harris replied: "That's right, but they're not gonna stop. They're not gonna stop and this is a movement. I'm telling you, they're not gonna stop and everyone beware, because they're not gonna stop. They're not gonna stop before Election Day in November and they're not gonna stop after Election Day. Everyone should take note of that (on both levels) that they're not going to let up and they should not and we should not."

In June 2020, Harris also publicly supported a bail fund (the Minnesota Freedom Fund) set up in support of jailed BLM protesters in Minneapolis, an act that contributed to her low popularity ratings even among Democrats. The fund (which is still in operation) has become an all-purpose slush fund providing bail money for blacks accused of violent crimes. Several of the individuals bailed out by the fund Harris supports subsequently committed violent offenses, including murder. One of the most notorious so far is 48-year-old George Howard, who just weeks after being enabled by the Minnesota Freedom Fund to bail out of domestic assault charges, got into an altercation on the highway and shot to death a 38-year-old motorist, Luis Damian Martinez Ortiz.

Harris also came out in support of providing full-service healthcare,

including Medicare, to illegal aliens. She has supported amnesty for illegals and backed sanctuary cities.

On guns, Harris was unafraid to proclaim as a presidential candidate that she supported mandatory gun "buybacks." Building on her earlier support and sponsorship of the Green New Deal, she called for reductions in red meat consumption in the name of fighting climate change, and supported bans on both fracking and offshore drilling.

With such a radical-left resumé (not at all unexpected for a politician from San Francisco but far outside the Overton window of Middle America) it is little wonder that Harris' first presidential campaign foundered badly, polling in the low single digits in a crowded field (beneath even Michael Bloomberg when he had not even declared his candidacy). Faced with incontrovertible evidence that her dog and pony show would not play well in flyover country, Harris dropped out of the race before the first primary was even held and that (we all assumed) was that.

For logic-defying reasons of his own, equally improbable presidential nominee Joe Biden chose Kamala Harris as his running mate, and the rest is history. By fair means or foul (mostly, one supposes, the latter), the unlikely duo squeaked out a dubious win in the 2020 election. With much of the attention focusing on the improbable electoral miracle in which a semi-coherent, superannuated former vice president covering in his basement had somehow managed to defeat a popular if unconventional sitting president, Vice President Kamala Harris faded from the front pages to fulfill mostly ornamental duties as Biden's heir-in-waiting.

It was broadly assumed that Biden had chosen the weakest, most vapid of all the candidates in a field crowded with weak, vapid entrants because he wanted "impeachment insurance." Biden, after all, was keenly aware of

his own shady dealings with corrupt foreign governments, as well as the outrageous lies, deceptions and dirty tricks he and his Deep State enablers had resorted to in order to discredit Trump and bring down his entire administration (think Hunter Biden laptop disinformation). He was also planning to stake the heart of the orange vampire via a coordinated, utterly amoral campaign of lawfare against Trump, his associates and anyone even peripherally involved in the events of January 6, 2021. Such a campaign would certainly trigger an indignant response from an outraged GOP, but with the clueless Kamala Harris as his successor, Biden would be insulated from any serious attempt to force him out of office.

This was the narrative most of us took for granted during those seemingly interminable years when we regarded with horror Biden's dismayingly incompetence coupled with his growing incapacitation — yet prayed he would limp across the finish line of his term in office to prevent Kamala (by all accounts an even worse choice) from becoming president.

Border Czarina

Early in his administration, Biden tasked Harris with working to solve the border crisis — supposedly. The press (in a Washington tradition stretching back decades) fondly dubbed Harris Biden's "border czar." Despite recent denials that any such title (honorary or otherwise) was ever conferred, the reality of Harris as "border czar" (or perhaps more accurately, "czarina") was formalized by a congressional resolution, and is beyond any reasonable dispute.

What is disputed is what (if anything) Harris ever did in this capacity. Most Americans probably assumed that the radical-left Kamala Harris would do

nothing to discourage and would likely even encourage the new stampede of illegal immigrants and asylum seekers across the southern border and that has proven to be the case.

Idle, she certainly was not. An often repeated lie of the Biden administration — that its hands are tied on the border unless Republicans pass enabling legislation — has long been used as an excuse for its inaction in securing the border post-Trump. With this lie as camouflage, Harris launched in 2021 the Partnership for Central America (PCA), which has been touted as a public-private partnership “working with businesses and social enterprises to make new, significant commitments to address the root causes of migration through economic opportunity in the region.” More specifically, the PCA under Harris’ leadership has been working allegedly to address “root causes” of illegal immigration (instead of securing the border itself), especially from the so-called Northern Triangle of Central America (Guatemala, El Salvador, and Honduras). This was to be done not only by encouraging private corporations to invest there, but also by channeling large amounts of U.S. foreign aid to the region as well. While claiming to be “independent, nongovernmental and nonpartisan,” the PCA in fact “partners closely with the U.S. Department of State and the U.S. Agency for International Development [USAID],” according to one article from the University of Virginia’s Darden School of Business’ Institute for Business in Society, another partner with the PCA.

Writer Felipe Saffie explained the rationale for the PCA as follows: “Irregular migration from Guatemala, Honduras and El Salvador to the United States is deeply rooted in a lack of economic opportunity, high levels of violence and citizen insecurity, an increase in climate volatility and a desire for family reunification... Investments in education, health care and transportation infrastructure are needed to promote economic devel-

opment, in addition to vocational and job training to develop a more skilled workforce... This situation stems from a variety of structural factors, including low levels of private sector investment, low labor productivity and a lack of skilled workers, high levels of labor informality and challenges in promoting the rule of law, sound governance and legal certainty. Governments, companies and institutions working together can work toward practical solutions, mobilize humanitarian aid and new investments, and offer hope and opportunity to potential migrants for a better life.”

Harris and the Biden administration were not alone in planning and launching the PCA. Shortly after the administration issued a “Call to Action” in conjunction with the rollout of the PCA in May 2021, Harris met personally with the World Economic Forum’s Klaus Schwab to plan further action in alignment with the WEF’s often touted goal of “stakeholder capitalism.” Schwab said at the time: “The Forum has been actively engaged in Latin America for decades, developing and supporting the implementation of a strategic agenda to address the region’s most pressing challenges and ensuring a robust participation of leaders. In response to this Call to Action, the World Economic Forum will convene a network of committed actors over time. The principles of Stakeholder Capitalism provide a fundamental guide for these actors on the role that long-term, sustainable investment can play.

The first 12 of those “committed actors” included Latin American corporations such as Bancolombia and the NGO Accion, as well as prominent North American companies such as yogurt manufacturer Chobani, online language school Duolingo, Mastercard, and Microsoft. The number of private partners with the PCA has since grown to more than 30, with the likes of textbook publisher Pearson, agribusiness giant Cargill and the George W. Bush Institute among more recent entrants.

These venerable companies and NGOs are not lining up to pour money into the slums of Guatemala City and Tegucigalpa for purely altruistic motives. The public part of “public-private partnership” is being mustered as a guarantor for their investments. A parallel government initiative, Central

America Forward, has been funneling both public and private money into the Northern Triangle to enhance job creation, workforce training, and access to credit for local workers — millions of them, according to a recent White House fact sheet. Of particular interest for our purposes was the creation by USAID of the Central America Service Corps (CASC), a fascist-style national service corps transparently modeled after Bill Clinton’s controversial AmeriCorps. This USAID-funded initiative will “work with over 60,000 vulnerable youth and offer them alternatives to irregular migration through community service projects and technical assistance to match youth to potential jobs, training and mentoring, facilitating financial inclusion efforts, and direct financial support through stipends.” Moreover, the activities of the CASC will be coordinated by USAID with the Peace Corps, the Inter-American Foundation, the U.S. Forest Service, and, of course, the PCA. In other words, thanks to Kamala Harris’ work, U.S. taxpayers are now subsidizing corrupt Central American governments at dizzying new levels, pouring foreign aid into jobs training, infrastructure

projects, and legal reform, and enabling foreign companies to “invest” resources with American taxpayers acting as risk guarantors.

Harris has also personally set up the initiative In Her Hands (IHH), a “women’s economic security initiative” that, in conjunction with the PCA, is specifically targeting economic and social opportunities for women in the region by “promoting gender parity” and the Latin American equivalent of affirmative action aimed at “elevating women within companies across the region.”

In other words, far from ignoring the border issue, Harris has been very busy indeed — attacking the problem with all of the misplaced priorities of the radical Left. These priorities include ignoring actually securing the border, professing to attack the root cause of other countries’ government corruption by enlarging the involvement of the U.S. government, and encouraging the private sector to pour money into the local public sectors to create the usual mishmash of woke social programs targeting problems that only seem to be exacerbated by the

involvement of leftist busybodies. The overarching imperative of American leftists such as Harris is, and always has been, feeling good about themselves rather than actually solving problems. Thanks to Harris and the PCA, leftist virtue signaling has become a major enterprise in Central America. Government and legal corruption in the region will continue to be subsidized, and the illegal immigration flow unabated, thanks to such meddling.

Elite Support

Yet the Powers That Be have already rebranded the clueless Harris as a foreign-policy force to be reckoned with, as evidenced by a hagiographic essay released by the Council on Foreign Relations (CFR) on July 25. According to Linda Robinson, a CFR senior fellow for women and foreign policy, "Harris's foreign policy experience has been far wider than recognized, equipping her to serve as the first woman president." The CFR (for the uninitiated) has been America's globalist foreign-policy establishment for more than a century, and, in coordination with various affiliates abroad (such as the U.K.'s Royal Institute of International

Affairs) is the entity primarily responsible for keeping America firmly in the globalist camp and building up the UN-centered global political, financial, and military order. Harris herself is not a CFR member, but the organization (and with it, the entire globalist establishment) has obviously thrown its support wholeheartedly behind her candidacy, as evidenced by Robinson's article. Harris has earned her spurs by dealing with a spate of "existential" issues, writes Robinson: The issues that the Biden-Harris administration has faced during this term could not be more existential: Russia's nuclear saber-rattling, the first conventional war on European soil since World War II; strengthening and expanding the North Atlantic Treaty Organization (NATO) alliance; confronting a rising China with strong defense and a strategy to manage the most competitive geopolitical rivalry of our time; and grappling with rapid technological and climate change that is altering the foundation and fabric of life, to mention a few of the daily challenges.

Left unmentioned, conveniently, is the fact that certain of those problems (China and Ukraine) have been

exacerbated by Biden administration policies and other debacles (such as Afghanistan) passed unmentioned. After lamenting the "trivial" news coverage of Harris that plays into "sexist and racist stereotypes," Robinson tries to burnish Harris' foreign-policy credentials by pointing out that she "has regularly participated in Cabinet meetings and emergency meetings in the White House situation room and held frequent lunches with the president to discuss and advise him on the most pressing issues of the day" (are we to suppose that no other vice president has ever done this?), and that Harris "has been given critical substantive foreign policy portfolios to manage as vice president" — including the aforementioned one on immigration. Robinson writes approvingly of Harris' work with the PCA, reminding her readers: "The vice president led a \$5 billion increase in private investment and bilateral aid to address root causes of crime, poverty, and unemployment that propel migration and set up offices in origin countries to allow asylum seekers to apply there rather than attempt the life-threatening journey through jungles alone or with coyotes who prey on the vulnerable." In the

course of this work, Harris met with the heads of Mexico, Guatemala, and Honduras and led the U.S. delegation at the 2022 Summit of the Americas.

Robinson also discusses Harris' meetings with world leaders, from Xi Jinping to Volodymyr Zelensky, and her trips to Asia and Africa, along with less-known activities such as her involvement with the National Space Council and her interest in AI. The message is clear: Kamala Harris (her deficiencies notwithstanding) is a reliable asset of the globalist establishment and as president, will be surrounded by handpicked CFR experts who will ensure that her policy priorities remain in alignment with the internationalist agenda.

This is the real Kamala Harris: radical-left social reformer and establishment-anointed globalist. Having been a behind-the-scenes policymaker for President Biden, a President Kamala Harris, we may confidently predict, will continue the foreign and domestic policies of Biden himself, to the continued benefit of globalist elites and to the usual detriment of the American people.

Harris, Walz, Blow CNN Interview; Network Accused of Editing 23 Minutes

Despite CNN's best effort to protect vice president and Democrat presidential nominee Kamala Harris from herself, her first big interview left her looking like she was clueless.

Interviewer Dana Bash offered a menu of soft questions that Harris should easily have answered but as is her norm, she instead offered the usual word salad. Running mate Tim Walz, governor of Minnesota, didn't help. He fumbled questions about past lies about his "war record" and drunk-driving arrest.

Not that CNN didn't do its best to get the two through the interview with as little damage as possible. X users claimed that the interview was 41 minutes, and that the network edited the pre-taped chin-wag to 18 because Harris sounded, well, like she always sounds: not very smart. If true, the network scrapped more than half the interview.

Our Administration, Trump's Fault
Harris wasted no time in attacking former President Donald Trump, who hasn't been running the country for the last four years.

Asked what she would do on Day 1 of her presidency, Harris promised, with no details, "to do what we can to support and strengthen the middle class."

Then came the attack on Trump: I think sadly in the last decade, we have had in the former president someone who has really been pushing an agenda and an environment that is about diminishing the character and the strength of who we are as Americans — really dividing our nation. And I think people are ready to turn the page on that.

As for Day 1, Harris spewed a cloud of ink like a squid. "I've already laid out a number of proposals in that regard, which include what we're gonna do to bring down the cost of everyday goods, what we're gonna do to invest in America's small businesses, what we're gonna do to invest in families," she said.

Bash then asked a surprisingly adversarial question, observing that one of Harris' cultish campaign slogans is "we're not going back." "But I wonder what you say to voters who do want to go back when it comes to the economy specifically because their groceries were less expensive, housing was more affordable when Donald Trump was president," Bash rightly asked. Harris blamed "mismanagement by Donald Trump" of the Covid-19 pandemic for massive price increases under Bidenomics. Trump, apparently — not the man in the White House — was responsible for the 8.3 percent inflation rate in 2022. Harris touted her plan to stop price gouging, which Democrats say won't become law, and promised a "tax credit of \$25,000 for first-time home buyers" to lower housing prices.

Bash rightly asked why she and Biden haven't executed those and other proposals during the more than three years of their administration. That was Trump's fault, Harris said: "Well, first of all, we had to recover as an economy and we have done that. I'm very proud of the work that we have

done that has brought inflation down to less than 3%, the work that we have done to cap the cost of insulin at \$35 a month for seniors. Donald Trump said he was gonna do a number of things, including allowing Medicare to negotiate drug prices. Never happened. We did it."



No to Fracking, Yes to Fracking
Bash also nailed her for U-turning on fracking. "There is no question I'm in favor of banning fracking," Harris said in 2019 during her failed presidential primary campaign.

Not so today, Harris said: "I made that clear on the debate stage in 2020, that I would not ban fracking. As vice president, I did not ban fracking. As president, I will not ban fracking."

When Bash pressed her on the question, Harris said the same thing: "In 2020 I made very clear where I stand. We are in 2024, and I have not changed that position, nor will I going forward. I kept my word, and I will keep my word."

When Bash asked why Harris changed her mind, Harris delivered the word salad: "Well, let's be clear. My values have not changed. I believe it is very important that we take seriously what we must do to guard against what is a clear crisis in terms of the climate. And to do that, we can do what we have accomplished thus far.

Trump Responsible for Immigration Invasion

Trump is also to blame for the Biden-Harris invited illegal-alien invasion at the border. "Why did the Biden-Harris administration wait three and a half years to implement sweeping asylum restrictions?" Bash asked. Harris claimed that encounters at the southwest border have decreased since she and Biden focused on it. "And through bipartisan work, including some of the most conservative members of the United States Congress, a bill was crafted which we supported, which I support."

The evil Trump sabotaged that effort, she lied: "Donald Trump got word

of this bill that would've — that contributed to securing our border and because he believes that it would not have helped him politically, he told his folks in Congress, 'Don't put it forward.' He killed the bill: a border security bill that would've put 1,500 more agents on the border and let me tell you something, the Border Patrol endorsed the bill."

As Trump's running mate, Senator J.D. Vance of Ohio, wrote in The American Conservative in February, fellow conservatives opposed the bill before Trump said anything about it.

Harris also said she doesn't regret misleading the public about Biden's obvious cognitive decline, although Bash didn't use those words.

Walz Dodges

Bash pressed Walz on three major falsehoods: his claim that he went to war, his claim that he wasn't drunk when cops arrested him for drunk driving in 1995, and his claim that he and his wife, Gwen, conceived their children using invitro fertilization.

Walz confessed the first by saying he misspoke, then dodged the second and third: "Well, I've been very public. I think they can see — my students come out — former folks I've served with, and they — and they do, they vouch for me. I certainly own my mistakes when I make 'em. The one thing I'll tell you is I wished in this country we wouldn't have to do this. I spoke about our infertility issues 'cause it's hell, and families know this. And I — I spoke about the treatments that were available to us that — that had those beautiful children there. That's quite a contrast in folks that are trying to — to take those rights away from us."

Edited Interview?

Minutes after the interview aired at 9 p.m. EST, X user Paulie wrote that a "good friend" is a CNN managing editor, and that CNN had "41 minutes of tape." But "Harris and her team objected to over half of the already taped interview." Harris forced the network to delete a question Bash asked, Paulie wrote. How, the CNN talker wanted to know, can Harris support the Green New Deal and fracking? Wrote Paulie: She didn't have an answer for it except to say she will "get it done." The phrase does not appear in CNN's transcript. [Visit JBS.org](http://VisitJBS.org)

The Cost of Illegal Immigration to Taxpayers

Prepared Testimony of Steven A. Camarota Director of Research Center for Immigration Studies For Immigration Integrity, Security, and Enforcement Subcommittee of the House Judiciary Committee Hearing entitled "The Impact of Illegal Immigration on Social Services,"

Summary

Illegal immigrants are a net fiscal drain, meaning they receive more in government services than they pay in taxes. This result

is not due to laziness or fraud. Illegal immigrants actually have high rates of work, and they do pay some taxes, including income and payroll taxes. The fundamental reason that illegal immigrants are a net drain is that they have a low average education level, which results in low average earnings and tax payments. It also means a large share qualify for welfare programs, often receiving benefits on behalf of their U.S.-born children. Like their less-educated and low-income U.S.-born counterparts, the tax payments of illegal immigrants do not come close to covering the cost they create.

Key Points

* The current surge of illegal immigration is unprecedented. Some 2.7 million inadmissible aliens have been released into the country by the administration since January 2021. There have also been 1.5 million "got-aways" — individuals observed entering illegally but not stopped. Visa

overstays also seem to have hit a record in FY 2022.

* We preliminarily estimate that the illegal immigrant population grew to 12.8 million by October of 2023, up

2.6 million since January 2021, when the president took office. This is the net increase in the illegal population based on monthly Census Bureau data, not the number of new arrivals.

* Illegal immigrants have a negative fiscal impact -- taxes paid minus benefits received -- primarily because a large share have modest levels of education, resulting in relatively low average incomes and tax payments, along with significant use of means-tested programs and other government services.

* Prior research indicates that 69 percent of adult illegal immigrants have no education beyond high

school, compared to 35 percent of the U.S.-born.

* Using the National Academies' estimate of immigrants' net fiscal impact by education level, we estimate that the lifetime fiscal drain (taxes paid minus costs) for each illegal immigrant is about \$68,000, although this estimate comes with some caveats.

* Illegal immigrants make extensive use of welfare. Based on government data, we estimate that 59 percent of households headed by illegal immigrants use one or more major welfare programs, compared to 39 percent of households headed by the U.S.-born.

* Based on their use rate of major welfare programs, we estimate that illegal immigrants receive \$42 billion in benefits, or about 4 percent of the total cost of the cash, Medicaid, food and housing programs examined in our study. However, this is only a rough approximation due to limitations in the data.

* Illegal immigrants can receive welfare on behalf of U.S.-born children. Also, illegal immigrant children can receive school lunch/breakfast and WIC directly. A number of states provide Medicaid to some illegal immigrants, and a few provide SNAP. Several million illegal immigrants also have work authorization (e.g. DACA, TPS and some asylum applicants), allowing receipt of the EITC.

* The high welfare use of illegal immigrant households is not explained by an unwillingness to work. In

fact, 94 percent of illegal immigrant households have at least one worker, compared to only 73 percent of U.S.-born households. However, the nation's welfare system is designed to help low-wage workers with children, which describes a very large share of illegal immigrant households.

* In addition to consuming welfare, illegal immigration makes significant use of public education. Based on average costs per student, the estimated 4 million children of illegal immigrants in public schools created \$68.1 billion in costs in 2019. The vast majority of these children are U.S.-born.

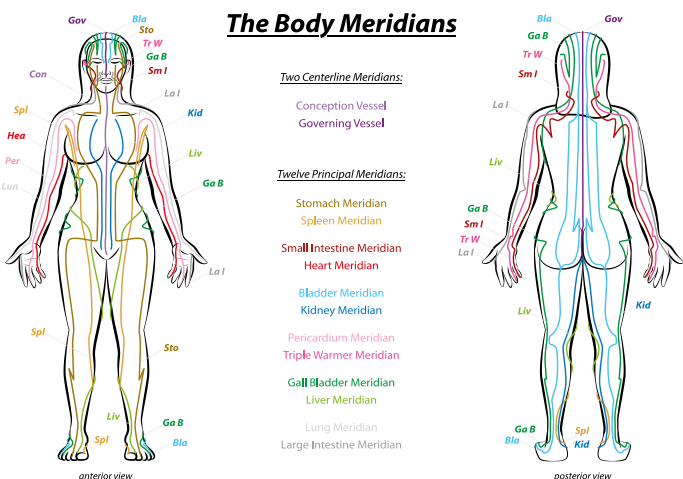
* Use of emergency medical services is another area in which illegal immigrants create significant fiscal costs. Prior research indicates that there are 5.8 million uninsured illegal immigrants in the country in 2019, accounting for a little over one-fifth of the total population without health insurance. The costs of providing care to them likely totals some \$7 billion annually.

* Illegal immigrants do pay some taxes. We estimate that illegal immigrants in 2019 paid roughly \$5.9 billion in federal income tax, \$16.2 billion in Social Security tax and \$3.8 billion in Medicaid taxes. However, as the net fiscal drain of \$68,000 per person cited above indicates, these taxes are not nearly enough to cover the cost of the services they receive.

* Illegal immigrants do add perhaps \$321 billion to the nation's GDP, but this is not a measure of their tax contributions or the benefits they create for the U.S.-born. Almost all the increase in economic activity goes to the illegal immigrants themselves in the form of wages. [... *The full article can be read at TFPnews.com*]

Illegal Immigrant Gang Takes Control of Parts of Denver, Authorities Say

Authorities have warned that Tren de Aragua, a gang of illegal immigrants from Venezuela, has reportedly taken control of parts of Aurora, Colorado.

On Wednesday, Raws Alerts shared a video of the gang allegedly taking control of an apartment complex in Aurora, which is a suburb of Denver. Raws Alerts tweeted, "An armed gang of illegal immigrants from Venezuela has reportedly taken full control of an apartment complex and parts of the town of Aurora."

In an interview with Fox News, Aurora City Councilwoman Danielle Jurinsky described the situation in the Denver suburb, saying, "Residents tell me they feel like they are living in a third world country at this point."

According to Jurinsky,

Tren de Aragua is taking over the city by going "block by block" and "apartment complex by apartment complex." She added, "I have heard too many stories from too many property owners, business owners, and residents, to think that this is anything other than a complete gang takeover in parts of our city."

Jurinsky told Fox News that she believes the gang is also involved in sex trafficking in the city, while a city resident told the outlet that the gang uses Aurora's apartment complexes for drug dealing.

"This is organized. They patrol the property with guns visibly, like they're not trying to hide them," the anonymous resident said. "There's no repercussions. These are ghosts."

In response to the reports of Aurora being taken over by the illegal immigrant gang from Venezuela, the Aurora Police Department released a statement on X, formerly Twitter, explaining that the department was "aware that components of TdA are operating in Aurora," but that "reports of TdA influence in Aurora are isolated."

The police department also noted that the city had created a special task force that is working with local, state, and federal partners to "specifically address concerns about Venezuelan gang Tren de Aragua (TdA) and other criminal activity affecting migrant communities."

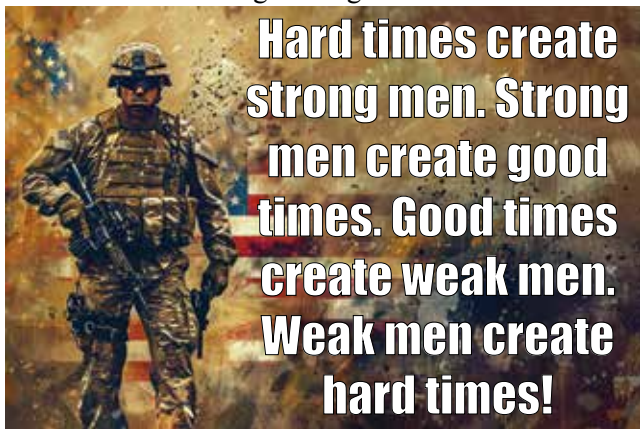
According to The New York Post, Tren de Aragua is a prison gang based in Venezuela that has been sending gang members across the southern

border between the United States and Mexico for years and recruiting members from migrant communities in the U.S., especially in Denver, New York, and Chicago.

Denver 7 reported that the Denver Police Department has confirmed members of the Tren de Aragua gang "are tied to crimes in the area." However, the department told Denver 7 that it was "not aware of any apartment buildings being 'taken over' by this gang in Denver."

This feature on NHK’s Asaichi has not only brought attention to individual struggles but has also highlighted a broader societal issue: the difficulty in openly discussing vaccine side effects without backlash. It presents a call to action for society to foster an environment where sharing such experiences does not invite judgment but rather understanding and empathy.

the federal form requires, she wrote. The NVRA therefore supersedes "Arizona's requirement that voters who register with the federal form submit documentary proof in order to vote for President or vote by mail."

Arizona, represented by Attorney General Kris Mayes, opposed the RNC's request. Mayes acknowledged the state's interest in defending and enforcing the law, but she countered that the "State also has an interest in smoothly administering its laws, especially for elections." Indeed, she wrote, "putting the district court's injunction on hold now" would be "destabilizing," because the state has not been enforcing the provisions at the center of the dispute.

The Democratic National Committee and the Arizona Democratic Party echoed this sentiment in their brief, observing that the relief sought by RNC and Republican legislators would also "mean people who voted for a presidential candidate or by mail earlier this year - including in the July 30 primary just two weeks ago - would suddenly be unable to do so."

to Europe is located, is the most direct cause of the recent rise in liquefied natural gas prices in the EU. Europe is experiencing delays in LNG deliveries from the Arctic LNG 2 project of the Russian company Novatek due to the tightening of US sanctions on the project. In addition, the growing demand for LNG in China and the Asia-Pacific region is also driving up prices.

The consequences of this price increase will only accelerate the deterioration of the economic situation in the EU. In fact, the ensuing situation will benefit any natural gas producer that can meet demand (including Russia) as long as Ukrainian forces do not destroy the gas transit point in the Kursk region and if Novatek can supply some LNG soon.

In effect, as the EU's economy continues to struggle, more businesses will close their doors as their political leaders continue masochistic anti-Russia sanctions that have not only boomeranged but also forced Russia to restructure its economy to be more self-sufficient and open to non-Western countries.

Mr. Spawr is very interesting, smart, articulate and has a good

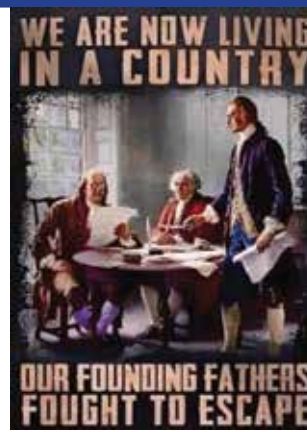

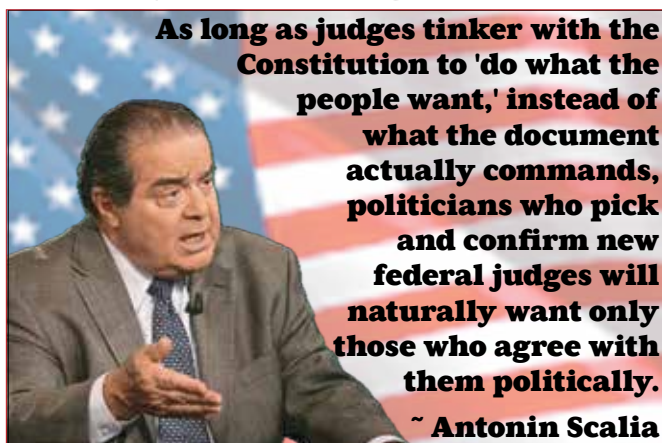
The Grand Jury Belongs to The People—Antonin Scalia (1992)

In a stunning six to three, 1992 Decision that went unnoticed (until now) Justice Antonin Scalia, writing for the majority said: In the Supreme Court case of United States v. Williams, 112 S.Ct. 1735, 504 U.S. 36, 118 L.Ed.2d 352 (1992), Justice Antonin Scalia, confirmed that the American grand jury is neither part of the judicial, executive nor legislative branches of government, but instead belongs to the people. It is in effect a fourth branch of government "governed" and administered directly by and on behalf of the American people, and its authority emanates from the Bill of Rights. The acts of the Grand Jury is the consent of the people.

"The grand jury is mentioned in the Bill of Rights, but not in the body of the Constitution. It has not been textually assigned, therefore, to any of the branches described in the first three Articles. "It is a constitutional



fixture in its own right. In fact the whole theory of its function is that it belongs to no branch of the institutional government, serving as a kind of buffer or referee between the Government and the people". — Justice Antonin Scalia.

"Thus, citizens have the unbridled right to empanel their own grand juries and present "True Bills" of indictment to a court, which is then required to commence a criminal proceeding. Our Founding Fathers presciently thereby created a "buffer" the people may rely upon for justice, when public officials, including judges, criminally violate the law." —Justice Antonin Scalia.

"The grand jury is an institution separate from the courts, over whose functioning the courts do not pre-

side. We think it clear that, as a general matter at least, no such "supervisory" judicial authority exists. The "common law" of the Fifth Amendment demands a traditional functioning grand jury." — Justice Antonin Scalia.

"Although the grand jury normally operates (of course) in the courthouse and under judicial auspices, its institutional relationship with the judicial branch has traditionally been, so to speak, at arm's length. Judges' direct involvement in the functioning of the grand jury has generally been confined to the constitutive one of calling the grand jurors together and administering their oaths of office. The grand jury's functional independence from the judicial branch is evident both in the scope of its power to investigate criminal wrongdoing, and in the manner in which that power is exercised." — Justice Antonin Scalia.

"The grand jury 'can investigate merely on suspicion that the law is being violated, or even because it wants assurance that it is not.' It need not identify the offender it suspects, or even "the precise nature of the offense" it is investigating. The grand jury requires no authorization from its constituting court to

initiate an investigation, nor does the prosecutor require leave of court to seek a grand jury indictment. In its day-to-day functioning, the grand jury generally operates without the interference of a presiding judge. It swears in its own witnesses and deliberates in total secrecy." — Justice Antonin Scalia.

"Recognizing this tradition of independence, we have said the 5th Amendment's constitutional guarantee presupposes an investigative body 'acting independently of either prosecuting attorney or judge" — Justice Antonin Scalia.

"Given the grand jury's operational separateness from its constituting court, it should come as no surprise that we have been reluctant to invoke the judicial supervisory power as a basis for prescribing modes of grand jury procedure. Over the years, we have received many requests to exercise supervision over the grand jury's evidence-taking process, but we have refused them all. "It would run counter to the whole history of the grand jury institution" to permit an indictment to be challenged "on the ground that there was incompetent or inadequate evidence before the grand jury."

— Justice Antonin Scalia.
