It's MAYDAY, MAYDAY, MAYDAY!

in the closing laps.


With the white flag out, Vindhurst dove low in turn one, making slight contact that sent both cars sideways. They raced side-

The Cultural Consequences of the Welfare State

The foundations of the welfare state can be found in Bismark's idea of the social state, which, at first, was used to fight socialists on a political level, but hell is full of good intentions. Bismark in the 1880s created compulsory insurance for accident, health, disability, and age (pensions). He called them "state socialism" and explained that all measures were socialist, and the state had to adapt to a little more socialism. What he wanted was to make the workers more dependent on the state and on him. That is, to have a dependent population under the ideology of national collectivism. The idea was that it would generate dependence and loyalty, which the German government needed to dominate Europe. He saw it as an advantage to have 700,000 pensioners drawing rents from the state, especially those who did not have much to lose and mistakenly believed they

had much to gain through public pensions.

Jesús Huerta de Soto explains that the conception of the human being as a creative actor leads to accepting the ethical principle that every human being has a natural right to appropriate the fruits of his own creativity. It is a fundamental principle that makes the market economy possible and which is

attacked by state interventionism. The welfare state (failing to comply with this ethical principle) produces a generalized lack of coordination and imbalance in the different areas in which it acts. hindering economic development. These attacks on human creativity also mean that the welfare state is slow to innovate, always lagging behind its competitors in the development and application of new technologies.

Hans-Hermann Hoppe explains the consequences of social democracy from several perspectives. During the 19th century, suffrage increased progressively until the beginning of the 20th century, when universal suffrage for men, and later for women, became generalized. In the 20th century, compulsory military service was almost universalized, taxes, indebtedness, and public employment increased. They destroyed the gold standard to replace it with fiat currency, the savings rate stagnated, and the preparation of intellectual elites and public education declined. Inversely, crime rates, dependency, structural unemployment, parasitism, psychopathy, and hedonism increased. The reason is that for the public, government moderation has only disadvantages. When you receive a subsidy without a guid pro quo there is no incentive to be more productive in the future. As a result, productive activity and

long-term forecasts decline. Redistribution taxes the most productive individuals by removing their incentive to produce, leading to the infantilization and moral degeneration of civil society.

One who best exemplifies the economic and social disasters of the welfare state is James Bartholomew in his book The Welfare State We're In, who shows its evolution in the United Kingdom. He shows how in the early 20th century the masses went to soccer matches in suits or how in the 1950s the winners of boat races politely shook hands with their rivals. By contrast, in the 2000s the winners made inappropriate gestures or soccer matches were full of alcoholic and violent hooligans in tracksuits. It also shows how private charity through donations fell from around 10 percent of wages during the Victorian era to 1 percent today, and how 25 percent of Britons now rely on government grants.

Bartholomew tells how the Victorian era and its virtues flourished from 1834 onwards, from Edwin Chadwick's 1832 report on the Poor Laws (which guaranteed free food and lodging) causing the incentive to seek work to be reduced, creating a culture of corruption and crime, what we might call "lumpen" culture. The government did not learn. In 1911, Churchill succeeded in introducing national unemployment insurance, even though the reality was that 10 million of the 12 million covered were already covered through friendly societies or workers' unions. These laws, which became more and more widespread, once again encouraged unemployment.

At the social level, unemployment increases suicide attempts tenfold and is the major cause of depression and unhappiness. So is incivility and delinquency, especially among young people. For example, in Northern Ireland, it was found that teenagers were twice as likely

to commit crimes if they were not working or studying. However, incivility does not only translate into crime. For example, in Birmingham it was found that while men are more likely to swear and threaten, women are more likely to engage in antisocial behavior such as not giving up their seat to a pregnant woman.

Bartholomew also explains the problems of the NHS (British public health service) and public education. On the NHS he denounces the long waiting lists and how it has caused (in conjunction with the public university) a reduction in the number of students becoming doctors. Public schools encourage behavioral problems because they keep all students compulsorily schooled in a prison type setting where a gang atmosphere is quickly created and power is held by the strongest. Alienated and bored children quickly become delinquent. This means that teachers have to take charge of pacifying instead of teaching,

often without success. The reality is that the poorest end up with the worst education and the worst healthcare.

The case of pensions is notable, which went from 14 percent in 1905 for those over 60 years of age to 57 percent in 2003, eliminating all incentive to save and impoverishing in general terms. While friendly societies fostered a sense of responsibility and created natural incentives to do good and live decently, due to the explicit declarations made by their members, the welfare state has led to the

elimination of this responsibility to act decently, encouraging incivility, vandalism, and law-breaking.

James Bartholomew remarks that out-of-wedlock childbearing was between 4-5% between 1900 into the early 1960s, but in 2010 it was at 40%. In the 1950s, for an unmarried young woman with children, there were virtually no social benefits, the burden was on her and her family, and abortion was illegal, so there was less incentive to have sex outside of marriage. Parents educated their children not to get any woman pregnant, because they

could ruin her, being a disaster for her.
On the contrary, in 2003 the state paid single mothers a "living wage" and often provided free housing, while the families only received more and more tax burdens. This has dire consequences, even with regard to violence. The risk of domestic violence in

marriage in 2001 was 0.2%, while cohabitation was 1.1% —more than 5 times higher. The risk of children being abused is 30% higher if their natural mother lives with an unmarried man, but also 20% higher if they are an unmarried cohabiting couple. In addition, the risk of children of single parents dropping out of school at 16 increases by 60%, having sex before 16 by 80% and smoking or doing drugs before 15 by 100%.

All of these policies and trends affect the poor the most. For example, divorce rates are 150% higher in the lowest income group compared to the highest. In contrast, married adult men are happier and healthier than single men being, for example, half as likely to commit suicide or half as likely to drink. As we have explained, the welfare state has greatly harmed the poor, condemning them to unemployment and social marginalization. Therefore, if we really care about the poor, we must end

the welfare state.



Killing Deadly Anti-Americanism

Hatred is like darkness: The more there is, the less you can see. For this reason, the object of hatred is never perceived clearly, ever painted in a darker color than the most shadowy recesses of its soul. Anti-American wrath is no exception. Listening to the hate-America-first crowd, you'd think our country was Hell on Earth instead of the best land this side of Heaven.

The United States does have its defenders, though. One of them, residing in The Boot (Italy), wants to give anti-Americanism the boot. Michele San Pietro describes himself as "a sixty-year-old Italian who loves America." He has visited our country five times. He says that is a

number that would be higher had his budget allowed.

Among other things, San Pietro appreciates our Constitution and that our political system has remained intact for almost 250 years. As for anti-Americanism, he notes that it's present both in the U.S. and abroad.

An Irrational Hatred


The problem is worsening, too. As I reported recently, two in three Gen Zers believe America is an unfair society. Not surprisingly, 40 percent of them also claim our Founding Fathers "are better described as villains than heroes." These are (do note) beliefs that correlate with anti-Americanism.

San Pietro bemoans it. As he writes in American Thinker, alluding to anti-Donald Trump sentiment: "No aversion toward a politician justifies an implacable hatred toward his or her country. Unfortunately, we know what implacable hatred toward a people as such may cause. So any kind of such hatred should be avoided, because it's a wrong and dangerous hatred. ... Nowadays you only have to look at the pages of Facebook (invented by an American)

to realize how intolerable boorish anti-Americanism has become. It's certainly a minority of degenerates, most of whom don't know a thing about the United States, but because of that we should not underestimate the problem. Give them an inch and they'll take a mile. Regrettably, such anti-American keyboard lions hardly ever find anyone who contradicts them. Even Americans don't react a lot: the overwhelming majority of them love their country, but they know it's far from perfect, and they tend to think it's legitimate to criticize it.

We Can't MAGA Unless We MARA

San Pietro is right about how even "good" Americans often fail to defend their country. In the least they're confused and sometimes cowed. This is incredible consid-



ering how much America has to recommend her. For example, San Pietro credits the U.S. with Italy's

Being the sole possessor of atomic weapons in WWII's wake, we could've conquered the world. Nazi Germany or the Soviets and virtually every empire in history surely would have. We didn't. Instead, we spent money getting our former foes back on their feet and then let them spread their wings. It's a striking departure from historical norms.

freedom and that's a good place to

In fact, virtually every common anti-American rap is risible. We didn't invent slavery but inherited it; then, along with other Western nations, we eliminated it. We didn't originate human-rights abuses; we did develop the gold standard by which they could be identified as human-rights abuses. The list goes on, too, but I won't. For the problem isn't a lack of facts but misguided feelings. If we're to MAGA, we must MARA: Make attitudes realistic again. As to this, we should not defend America; that's being defensive. Rather, we should mount an offense for America. For the "best defense is a good offense."

Stop With the "Not Perfect" **Business**

One of the first steps could be to stop taking pains (as even San Pietro does) to emphasize that "America isn't perfect." Why? A story: I used to spend a lot of time with a couple of nephews. Since they were homeschooled back then and lived in the hinterlands, their parents and

I (when I was around) were their whole world. They had many questions, as children will. One day the older boy, about five at the time, posed one and I replied, "I don't know." He looked at me startled, and said "Really?!" I was revered as omniscient, apparently.

Grown now, he takes for granted that Uncle Selwyn doesn't know everything. It's an adult characteristic to instinctively understand that nothing and

nobody apart from God is perfect. It shouldn't have to be mentioned and what does stressing it imply? Imagine you opened a speech about your mother with, "Now, we all know my mother isn't perfect." My, she must be quite the reprobate if that warrants emphasis.

The irony here is that it is the most imperfect among us, the most vice-ridden people, who hate America most. To them we should quote Jesus: "First take the plank out of your own eye, and then you will see clearly to remove the speck from your brother's eye." If you find a perfect country, don't go there. For then it will cease being so.

True Patriotism

Another attitudinal truth relates to patriotism. Philosopher G.K. Ches-



terton addressed it while critiquing famed writer Rudyard Kipling's patriotism, a quality the latter was known for. As Chesterton wrote in his 1905 book Heretics, "Kipling admires England, but he does not love her; for we admire things with reasons, but love them without reasons. He admires England because she is strong, not because she is English." Obviously. If you love your mother, this doesn't cease because she develops some serious problems, even if they're moral failings. You may weep for her, though.

This brings us to our mother country. If we love America and want to increase the love for her, we need to make her more lovable. This starts, and ends, really, with *cultivating virtue, i.e., "good moral habits" in ourselves and encouraging it in others. A good start would be avoiding cursing and salaciousness, as vulgarity and sexualization are major problems today.

Also realize that it's hard loving your nation if you don't have a nation, but only a "country." A nation is an extension of the tribe, itself an extension of the family. In other words, we must stop balkanizing ourselves via destructive immigration policy. This is the prudent thing to do — and Prudence is a virtue. For that matter, so is Love. Love negates hate, so let this happen in you. For whether lovable or damnable, if you hate something, be assured: You're probably not seeing it clearly.



you own the water on the land? Do you own the air above it? As property rights expert, Dr. Timothy Ball wrote, "All these questions speak to political issues that transcend private, regional and national boundaries. Nationally and internation-


ally, lack of this knowledge is being exploited by those who seek control..."

In the beginning of the nation – after the Declaration of Independence and the American Revolution, and the signing of the Treaty of Paris with Great Britain – the American people became complete, sovereign freeholders in the land with the same prerogatives as the King once had. Now in this new nation the English King had no further claim to the land and could neither tax nor otherwise encumber it.

From that point the United States government acknowledged private ownership by issuing land patents, also called "Letter Patents." They were signed by the President of the United States and recorded in the county record. The land then became the owner's property in a "true land title." There were no other claims on the land. Land Patents or "Allodial Titles" were one of the major motivators of the American Revolution, providing rights to the land, free and clear of the liens and encumbrances of the King of England.

A Land Patent is a contract or

Document of Title, issued by a government or state



But, as property expert Ron Gibson has written, the enjoyment of free and clear title allowing owners to "own" their land without interference from any government, including the government of the United States, didn't last long. Today, this history has been largely ignored by our government. Instead of a Land Patent or Allodial Patent issued when one buys property, we are issued a Warranty Deed. That is not a true title, but rather a "color of title." That means you have a partner in the ownership of the land. The partner is the State, which encumbers the property with taxes and liens and all of those things, which simply render you a tenant on what should be your own land.

Writes Gibson, "As a result of generations of constructive Trust Fraud perpetuated against the American people. . . we've been conned into believing we are 'owning' property, when in fact, and by law, we're only in 'possession' of property utilizing it as a renter or tenant would. So long as we pay our rent (i.e., taxes and mortgages), get the licenses, pay the fees, have it insured, regulated, zoned and permitted, we can still remain "in possession".

Therein lies the root of the misconception that property is just the place where we live. The Government's refusal to acknowledge true property rights has led to a massive destruction of the American system, and is at the root of the creation of the largest reorganization of human society ever attempted.

Goodbye Klaus Schwab

The blatant, deliberate, and sinister tyranny behind the COVID-19 pandemic focused a much-needed light on numerous endeavors that have, for decades—in the name of profit and power—caused intentional harm to the healthiness of humanity. The allegations include using WEF funds for private hotel massages and asking junior employees to withdraw thousands of dollars from ATMs on Schwab's behalf. Likewise, the whistleblowers contend that Hilde, a former Forum employee, scheduled "token"

WEF-funded meetings to justify her luxury holiday travels. Likewise, while lecturing to society that "you will own nothing and be happy," the letter alleged Schwab and his family used WEF funds on its swanky Villa Mundi overlooking Lake Geneva, a \$50 million WEFowned property—\$30 million purchase, \$20 million renovation—in Geneva. According to the letter, Hilde tightly controlled the property, reserving parts of it for private family use. In a statement to Blick, Schwab remarked: "It is a pure and simple lie that I asked young employees to withdraw thousands of dollars for me at automatic distributors."

Schwab's reign at the privileged NGO came


tumbling down after the WEF board held an emergency meeting on Easter Sunday, initiated by what they called an independent investigation into the allegations, stating that until that is complete, they remain unproven. As expected, Schwab denied everything, arguing against the investigation and threatening legal action against the whistleblower and those bringing his apparent crimes to light. Still, the claims against him were enough to prompt Schwab, who has reportedly begun defamation proceedings, to resign immediately as both chairman and board member. Along with that,

as an apparent gesture of good faith, Schwab forfeited a 5 million Swiss franc pension.

Per the WSJ, trust between Schwab and the WEF board had deteriorated over the past year. Interestingly, the board includes characters like climate change fear-mongering Al Gore and



UN Messenger of Peace and first artist ever appointed to WEF board Yo-Yo Ma, and CEOs like metaverse-loving Julie Sweet and decarbonization targets initiator AXA Group CEO Thomas Burberi. Suspicions of trouble brewing at the elite group were raised last year when it was reported that the WEF's board was working with a law firm to investigate its workplace culture following allegations of a culture of sexual harassment and discrimination. Given the likes of Al Gore and ongoing donations from Bill Gates, it seems plausible that the 87-year-old Schwab fits right in with many at the WEF, but if the allegations against him are confirmed, the high-stakes conflict may be his demise. One can only hope.



Prior to the whistleblower's allegations, Schwab—the puppet master of the Great Reset—had said he would hand over executive duties to a team led by Norwegian politician and diplomat Borge Brende, who has been president of the WEF since 2017. German-born Schwab founded the WEF in 1971 with a strategy to furnish a forum for policymakers and top corporate executives to tackle major global issues. Yet, what became glaringly apparent is Schwab's incessant push for globalization and his march of madness to merge humans and technology, also known as transhumanism. Indeed, his vision of the future is terrifying and void of the love that makes us human.

For years, and especially during the transformative pandemic, Schwab and his ritzy annual gatherings in Davos with an ever-growing list of CEOs and celebrities, and secrecy, to discuss the global agenda for the coming year, drew much warranted harsh criticism. Particularly because of the elitist manner in which the soiree was clearly detached from reality and utterly oblivious to the day-to-day lives of the rest of society. Did Venezuela Invade America In Secret?

The suspects were identified as 38-year-old Paata Kochyashvili, 46-year-old Zaza Otarashvili, and 52-year-old Besiki Khutsishvili. Each one faces a murder charge and a \$2 million bail.

The story gets even more infuriating. Fox News's Bill Melugin exclusively reported on Saturday that the three individuals arrested were illegal aliens from Georgia. Melugin also revealed that the head injury the victim suffered was a result of his skull being bashed in. Moreover, ICE has placed detainers on each of the illegals. More Evidence Shows Deported Illegal Alien Garcia Is Brutal

BBC/XKilmar Abrego Garcia Not that anyone needed it except far-left, pro-terror-gang Democrats, but more documentary and testimonial evidence has surfaced in the last 24 hours showing that Kilmar Abrego Garcia (the deported Salvadoran illegal alien) is a wife-beating thug and member of the MS-13 terror gang. Fox News obtained a second protective order filed by his wife, Jennifer Vasquez Sura. She reported to the circuit court in Prince George's County, Maryland, that Garcia told a relative he could murder Sura and get away with it.

As well, during his confirmation hearing before the U.S. Senate Judiciary Committee, the nominee to run the Drug Enforcement Administration (DEA), Terrance Cole, testified that Garcia's tattoos are, indeed, gang tattoos. So, yet again, pro-Garcia Democrat shills have received more evidence that their favorite "Maryland husband and father" is a violent goon who should have been deported.

The Latest

The latest on Garcia comes from yet another petition for protection. On August 3, 2020, Sura told the Prince George's County (PGC) Circuit Court (in a disjointed, written account) that Garcia took her phone, then demanded her car keys at 1:00 a.m. She refused, and told her explosive husband that she wanted to use the car, an answer that infuriated him.

Sura said she "went upstairs to make food for my kids but he turned off the stove, and told me I wasn't going to cook anything for them until I gave him the keys." Garcia locked her children in the basement, she alleged. Retrieving her phone from her car, she said she called 911. "I tried to return inside but he locked all the doors," she continued. "After 5 min waiting for the police, he opened the door and told me to give him the keys. I again tried to make food for my

kids because I could hear them crying and screaming."

When police arrived, Sura "opened the door and yelled for help. When my husband heard he grabbed me back inside & slapped me," she alleged: "Police came and he acted violent with them & broke my phone in front of the officer. This is not the 1st time. It has been a couple of occasions he takes my phone and car & I'm left without being able to call anyone."

Sura wrote that she has photos "of all the bruises ... left on my body," and the household goods Garcia destroyed. "Me & my kids are

afraid now," she wrote: "He has kicked me, pushed me, slapped me in the face and threatened me. I also have ... recorded that he told my ex-mother-in-law that even if he kills me no one can do anything to him."

Previous Evidence

On May 5, 2021, in a report found before the August 2020 petition for protection, Sura described Garcia as a violent maniac. In August 2020, he socked her in the eye and left a purple shiner, she claimed. In November 2020, he bashed her with a "work boot," her complaint alleged.

On May 4, 2021, she told cops: "I was watching on my laptop, and he yelled to turn it off, I told him I wasn't sleepy, he got angry, reached over shut and threw my laptop on the floor, and the baby started to cry because he was putting pressure on him. My reaction was to push him off of us and then he punched, scratched me on my left eye, leaving me bleeding."

If what Sura reported to police and the courts is true, then the story told in a GoFundMe effort to raise money for Sura and her kids, in which Garcia comes off as husband and father of the year, was a lie.

Cole Testimony

During Terrance Cole's hearing yesterday, GOP Senator Lindsey Graham of South Carolina asked the DEA nominee about MS-13 and gang tattoos. The MS-13 terrorist outfit, Cole testified, is involved in "extortion, kidnapping, drugs, intimidation, money laundering."

> Graham asked Cole whether gang members have membership cards. "Not necessarily the membership cards, but they are well recog-

nized based on tattoos and different [things]," Cole replied.

Graham produced the now-viral photo of the tattoos on Garcia's fingers. "Based on your time and experience and expertise in the DEA, what does that photo or those markings suggest to you?" Graham asked. "Well, they suggest that he's an MS-13 member — that those are his markings," Cole replied. "That's his brand."

Graham walked Cole through the tattoos' coded MS-13 symbols. "So based on your time as a DEA

agent in the field, particularly in Mexico, these tattoos are consistent with MS-13 associations?" Graham asked. "Yes sir, that's correct," Cole replied. Cole also said the tattoos don't represent any other terror organization.

MS-13 Membership Evidence Abounds

Other evidence abounds that Garcia is a member of MS-13. Sura's ex-husband, Edwin Trejo Ramos, the father of Sura's children, told the PGC Circuit Court in an emergency motion for a custody hearing that he feared for their lives. Ramos alleged that Sura "is dating a gang member." More evidence appears in documents from the PGC police department. They not only claimed Garcia was a member, but also provided his rank and street name. Garcia "was validated as a member of the Mara Salvatrucha (MS-13) Gang," the police report says.

Harford County Sheriff Jeff Gahler told a podcaster that Garcia is a gang member. Garcia "certainly has MS-13 ties, and I 100-percent believe, 1,000-percent believe him to be an MS-13 member, from everything I've read out of the police reports and what has been released," Gahler said.

In 2022, Tennessee Highway Patrol officers stopped Garcia in a car packed with passengers and heading from Texas to Maryland for "construction work." The car belonged to a convicted human trafficker, also an illegal alien, who had pleaded guilty to transporting illegal aliens.

esolution to Exit WTO Introduced in Congress

In a long-overdue step toward reasserting American independence, legislation to withdraw the United States from the World Trade Organization (WTO) has been introduced in Congress.

House Joint Resolution 93 (H. J. Res. 93), titled "Withdrawing approval of the Agreement Establishing the World Trade Organization," has been introduced by U.S. Representative Tom Tiffany (R-Wis.). It is co-sponsored by Representatives Andy Biggs (R-Ariz.), Thomas Massie (R-Ky.), Barry Moore (R-Ala.), Scott Perry (R-Pa.), and Tony Wied (R-Wis.).

This one-page resolution declares. "Congress withdraws its approval, provided under section 101(a) of the Uruguay Round Agreements Act, of the WTO Agreement as defined in section 2(9) of that Act." The Uruguay Round Agreements Act, enacted by Congress in 1994, established U.S.

membership in the WTO, which was formally established on January 1, 1995. Accordingly, H. J. Res. 93 would fully withdraw the United States from the WTO.

In a press release announcing the legislation, Tiffany declared: "The

WTO has repeatedly overlooked China's unfair trade practices and human rights abuses, undermined

American farmers and manufacturers, and eroded our national sovereignty. American trade policies should be made by American officials who are elected by American voters and accountable to American workers, not dictated by unelected international bureaucrats in Geneva. It's time to pursue a better approach to trade one that puts American industry, jobs and economic independence first.

It has been two decades since Congress last voted on whether to continue our membership in this deeply flawed organization. The American

people deserve to know if their elected officials stand with them, or with China's allies in the WTO.

> This is not the first time legislation to withdraw the United States from the WTO has been introduced. In 2020, for example, Senator Josh Hawley (R-Mo.) and Representative Peter DeFazio (D-Ore.) introduced identical resolutions S. J. Res. 71 and

H. J. Res. 89. As The New American reported at the time, Hawley also published a New York Times op-ed calling for the WTO to be abolished.

Restoring American Sovereignty

WTO membership has been detrimental to U.S. sovereignty. The global body explains on its website, "Although the WTO is not a UN specialized agency, it has maintained strong relations with the UN and its agencies since its establishment." Additionally, the WTO and UN have a formal agreement facilitating "cooperative ties between the two organizations." As such, the WTO effectively functions as the UN's "global trade ministry."

The WTO has repeatedly ruled against U.S. policies, even occasionally forcing Congress and state legislatures to bend to its will. For example, in 2015 Congress repealed a country-of-origin-labeling (COOL) law in response to a WTO ruling declaring the law illegal under WTO rules. Additionally, in 2018 the Washington Legislature repealed a state tax break for Boeing to comply with WTO rules.

Rather than allow foreign bureaucrats to dictate domestic federal and state policies, Congress should defend America's founding principles and restore U.S. sovereignty by enacting H. J. Res. 93 — and patriotic Americans should work to create the educated and activated electorate necessary for effecting long-term change.

Are Pakistan and India at War?

As of May 6, 2025, India and Pakistan are embroiled in a significant military and diplomatic standoff, marking one of the most serious escalations in their recent history. The crisis was triggered by a terrorist attack on April 22nd in Pahalgam, Indian-administered Kashmir, where 26 Hindu tourists were killed. Farage's party making big gains in **local British elections** | 3 May 2025 | The right-wing Reform UK party has won 677 out of more than 1,600 seats in England's local elections, while the Labour and the Conservative parties suffered heavy defeats across the country. As results began to trickle in on Friday, the party led by

proponent Nigel Farage emerged as the strongest performer in contests held in 23 local authorities across England, winning control of ten councils. These in-



cluded eight taken from the Conservatives -- Derbyshire, Kent, Lancashire, Lincolnshire, North Northamptonshire, Nottinghamshire, Staffordshire and West Northamptonshire -- along with Doncaster from Labour and Durham, where no party previously had a majority... According to a BBC projection, if a general election were held today, Reform UK would receive 30% of the vote, ahead of Labour at 20% and the Conservatives at 15%.

Ukraine critic wins first round of Romanian presidential election rerun | 4 May 2025 | George Simion, a critic of the EU who has been banned from entering Ukraine, won the first

round of the rerun of the Romanian presidential election on Sunday. With more than 95% of the ballots counted, Simion, the leader of the right-wing



Alliance for the Union of Romanians (AUR), received 40.52% of the votes, according to the news website G4 Media. Former senator Crin Antonescu and Bucharest Mayor Nicusor Dan, both known for pro-EU views, each received a little over 20% of the votes. "This is not just an electoral victory, it is a victory of Romanian dignity. It is the victory of those who have not lost hope, of those who still believe in Romania, a free, respected, sovereign country," Simion said, according to Reuters.

Germany 'has rebuilt the Berlin

Wall' - Vance has slammed attempts to "destroy" the anti-immigration AfD party | 2 May 2025 | U.S. Vice President J.D. Vance has compared the German government's treatment of the right-wing Alternative for Germany (AfD) party to rebuilding the Berlin Wall. On Friday, Germany's domestic intelligence agency, the BfV, classified the anti-immigration AfD as an "extremist" organization, citing "xenophobic, anti-minority, Islamophobic, and anti-Muslim statements made by leading party officials." The label enables police to closely monitor the party's activities. "The AfD is the most popular party in Germany, and by far the most representative of East Germany. And it has been rebuilt -- not by the Soviets or the Russians, but by the German establishment," he added.

| 27 April 2025 | Israeli jets bombed Beirut's southern suburbs yesterday - marking the third strike on the area since a ceasefire took effect in late November. A huge plume of smoke billowed over buildings after the attack but there were no immediate reports of casualties. An hour before the

strike the Israeli military warned it was targeting Hezbollah facilities in the Hadath area and urged residents to move. Importantly, Dr. Soon-Shiong harbors a grasp of the fundamental biology behind life-threatening diseases. He uses that understanding to share his insights into the alarming health crisis facing society following the experimental mRNA jabs.

In a discussion in late March 2025 with Dr. Drew about the COVID jabs [watch the entire 1½ hour interview at TPFPnews. com], Dr. Soon-Shiong posed the million-dollar question, "Why did we create a vaccine that does not clear the virus?" Great question. Dr. Drew took the inquiry a step further, asking, "Why did we create a vaccine that reproduces the most pathogenic component of the virus." He added, "Why not Natural Killer Cells To Sleep



the nucleo capsid, [or] why not the whole virus, why do we keep pushing on spike? It's insane." Framing the stance that essentially divided healthcare into the doctors who put the care of their patients first and the doctors bedazzled by the sway of Big Pharma."

Dr. Soon-Shiong replied: "You're singing my tune. This is exactly what I've been saying since 2020. I'm not only worried about long COVID—I think I understand why we are getting long COVID. Your idea about spike (called spikeopathy) is the idea that the spike could come either from the vaccine or from the COVID virus itself. If it comes from the vaccine, does it break off, and does it actually replicate? And if it replicates, does it persist? If it persists and replicates in certain parts of tissue, does it reduce what they call P-53? Is it then a harbinger of cancer? Is it going to act like hepatitis and HPV, God forbid, where in five years or 10 years from now, is it potentially the explanation why I am seeing eight-year-old, ten-year-old, and eleven-year-old [children] with colon cancer?"

Likewise, in a recent interview with Tucker Carlson [watch the entire 11/2 hour interview at TP-FPnews.com], Dr. Soon-Shion noted that besides the persistent rise in cancer rates despite decades of cancer research, the increase in certain types of cancers, like pancreatic, ovarian and colon, in younger people is astounding. Also a surgeon, Dr. Soon-Shion characterized the rapid rise in cancer in the United States (which now includes children) as a non-infectious pandemic of cancer, including deadly turbo-charged cancers.

This fact is incredibly disturbing, especially when you consider that cancer is essentially an immune system issue. We humans always have defective cells in our bodies that could turn into cancer. But usually (thanks to our body's incredible natural healing power) our immune system's killer cells (T cells and NK cells) zap them and keep them in check. This is a fundamental balance that our amazing bodies rely upon. However, when that balance gets thrown off (when those killer cells get suppressed or stop working effectively) that's when the defective cells that exist within us can become cancerous. So, what exactly is happening to sabotage our innate ability to fight these defective cells?

Dr. Soon-Shion shared with Tucker that he's now getting reports that individuals whose cancers have been in remission are now getting back the cancers, and they are progressing very rapidly. He explained that if you really consider the root cause of cancer (something he discussed years ago with Sanjay Gupta on 60 Minutes) it's not just about how quickly it grows. He argued that the actual issue is its inability to die. Cancer persists because it evades the body's key defenders, like natural killer cells and T-cells. Dr. Soon-Shion shared that what worries him most is that the cancer and the body itself, seems to have found a way to suppress these natural killer cells that conquer cancer. Once the suppressor cells kick in and you become immunosuppressed—there's nothing to


back. That's when we witness this rapid, unchecked progression.

Indeed, it appears how we are treating cancer—which is an incredibly lucrative business—is all wrong. Dr. Soon-Shion chatted with Tucker about the most recommended

ways we attempt to stop cancer: we radiate it, surgically remove it, remove the lymph nodes, and give chemotherapy. Likewise, we have now injected an experimental gene-altering "vaccine" that annihilates our immune system. He explained that these procedures are tipping the scales towards the suppressor cells—the ones helping cancer thrive. Instead of activating the killer cells inherently in our bodies programmed to destroy cancer, these treatments activate the suppressor cells.

With that in mind, we know that inflammation leads to disease, including cancer. Is inflammation behind the suppression of immune systems and the rapid increase in turbo cancers? Holding that thought, and noting that "a lot of people have pointed to both the COVID virus and to the mRNA COVID vaccines as potential causes," Tucker asked Dr. Soon-Shion if he thinks they are related. Not surprisingly, he shared that he does. Dr. Soon-Shion explained that certain viruses (like hepatitis and HPV) are known to cause cancers such as liver and cervical cancer by persisting in the body, creating inflammation, and inhibiting the P53 protein that protects against cancer. These are called oncogenic viruses.

Where does spikeopathy come into play? Dr. Soon-Shion explained: "The hallmark of an oncogenic virus is it must persist.



Why? Because it continues to create inflammation. With inflammation, you get suppression. Because your body is trying to suppress, it must inhibit something called P53 (which acts as a tumor suppressor by monitoring the health of cells). If [the virus] persists and causes inflammation and inhibits P53, it begins to have the hallmarks of an oncogenic virus.

So then the question is, does the COVID virus—whether it comes from the vaccine, which is the spike protein vaccine, or from the infection, which is spike-driven—get into every cell of our body? It goes wherever there are ACE2 receptors, which are in the blood vessels. So, wherever you have a

blood vessel in your body, that is where [the spike protein] is going to go. If there is an ACE2 receptor on that blood vessel, that's where it will go because that's the purpose of the spike protein—to penetrate and hijack that ACE2 receptor and get into the cells.

So that's why it gets into the pancreas. That's why you have brain fog—it disrupts the blood vessels of the brain and causes

mitochondrial dysfunction. That is why in the colon, which is a high ACE2-receptor. That's why the pancreas is the receptor. That's why you see young people have sudden heart attacks. You see young people with pancreatic cancer all of a sudden. You see young people's colon cancer all of a sudden. So, is it by coincidence that post-COVID infection, post-COV-ID vaccine, we're seeing all these events where we know the spike protein goes there? I don't think so. I think it's not a coincidence."

Remember, the COVID-19 virus is not clearing the body.


The only way to do that is with a T cell and an NK cell—the cells that kill cancer. Yet, that is not happening. Dr. Soon-Shion explained that COVID is like cancer, and cancer is like COVID in that immunosuppression causes the spread, and the immunosuppression from the spike protein allows the virus to persist. The dangerous COVID jab does nothing to clear the virus. Even worse, Dr. Soon-Shion explained that NIH's Francis Collins and Anthony Fauci knew the spike jabs from Pfizer and Moderna did not clear the virus, allowing pieces of the virus to remain, especially spike—whether from the infection or the mRNA jab—and when you get another infection, that virus brings along a nucleocapsid, which reconjoins and replicates again.

Two years later, here we are—the spike from the virus and from the mRNA COVID jabs both pave the way for cancer because both suppress the immune system, bringing in millions of new patient customers to serve as test subjects for the new mRNA cancer jabs, which are, of course, waiting in the wings.

New Study: COVID-19 Jabs Associated With 86 Serious

Neuropsychiatric disorder is a complicated and not completely understood blanket medical term that encompasses a wide range of medical conditions that involve both neurology and psychiatry. A study last year in Nature Human Behaviour—conducted by researchers with strong ties to Big Pharma—did its darndest to spotlight the short- and long-term neuropsychiatric consequences of long COVID and, as a solution, emphasized the importance of getting the COVID-19 jab. However, given the extremely damaging and destructive outcome of the failed experimental gene-damaging mRNA COVID injections, not to mention the depravity surrounding them, that hypothesis is insulting to those of us paying attention, and it makes no sense.

A more recent study, published on April 14, 2025, and still in preprint, sets the record straight, uncovering that 86 serious neuropsychiatric safety signals were reported following COVID-19 jabs. Sharing the report on X, Nicholas Hulscher, MPH, did an excellent job of framing the situation at hand, remarking: "The widespread collapse of common sense since 2021 may be explained by the fact that over 70% of the world's population received at least one dose of a neurotoxic COVID-19 vaccine—a product that instructs the brain to produce toxic spike protein for years."

Examples of neuropsychiatric conditions include autism, schizophrenia, bipolar disorder, attention deficit disorder, depression, anxiety, and the list goes on. Sadly, most people suffering from



neuropsychiatric disorders experience difficulties

in emotional functions, sleeping, performing daily routines, working, and

interpersonal relationships in general. Essentially, they become lifelong customers for Big Pharma. Because the COVID-19 mRNA injections are known to penetrate the blood-brain barrier, the preprint (whose authors include James A. Thorp, Claire Rogers, Kirstin Cosgrove, Steven Hatfill, Peter Breggin, Drew Pinsky, and Peter A. McCullough) explains that this could potentially cause a myriad of unintended adverse events.

Remember that not only can the COVID jabs cross the blood-brain barrier, but the lipid nanoparticle (LNP) technology used in the COVID-19 "vaccines" was developed to enable the delivery of contaminants to all body tissues, including the ability to cross barriers. The preprint highlights the carelessness of the FDA when, on December 11, 2020, it granted its first Emergency Use Authorization (EUA) for the Pfizer-BioNTech mRNA COVID-19 gene therapy product and Moderna's deadly jab one week later.



Though categorized as vaccines under a revised CDC definition, these unexplored COVID "vaccines" contain a stable

mRNA sequence encoding the COVID-19 spike protein, a single viral antigen. This spike protein can penetrate the blood-brain barrier via vascular damage, display pathological effects, and, along with the LNPs, trigger considerable inflammation. Research demonstrates that the spike protein's mRNA can be expressed in the brain after both natural COVID-19 infection and - notably - repeated mRNA COVID-19 vaccinations.


Unfortunately for the American citizens who were guilted and fear-mongered into getting the jabs, the FDA's hasty testing and utterly inadequate review processes, under the direction of Dr. Peter Marks, failed to address the inherent biological toxicity of the spike protein. Likewise, as pointed out by the preprint, the FDA overlooked the presence of potential amyloidogenic regions within the tertiary structure of the spike protein mRNA used in these pseudo-vaccines. The study notes a probable link between COV-ID-19 vaccination and accelerated Alzheimer's disease progression, potentially tied to chronic cytokine production.

Undoubtedly aware of the disaster that lay before humanity after the COVID-19 "vaccine" rollout, the preprint highlights that Perez, Moret-Chalmin, and Nobel Laureate Montagnier documented 26 cases of Creutzfeldt-Jakob Disease (CJD) in 2021, with symptoms emerging on average 11.38 days post-vaccination with Pfizer, Moderna, or AstraZeneca COVID-19 vaccines. Biomarkers supported the CJD diagnosis, though histological confirmation was not conducted. CJD is a rare, fatal, and rapidly progressive brain disorder caused by a prion protein.

Previous reports also indicate cognitive impairments and new-onset psychiatric conditions following COVID-19 vaccination. Of course, it would be foolish to think that vaccines are the only products pushed by Big Pharma that adversely affect mental health. We explained that this could potentially cause a myriad of unintended adverse events. Remember that not only can the COVID jabs cross the blood-brain barrier, but the FDA reported in January concerning new evidence of one of the best-selling drugs in U.S. historythe asthma drug Singulair—causing severe mental health issues in some patients.

Since cognitive deficits and the onset of psychiatric illnesses have been reported after the COVID-19 injections, Thorp and the other researchers decided to query the CDC/FDA Vaccine Adverse Event Reporting System (VAERS) to

Director of National Intelligence Tulsi Gabbard confirms task force is investigating Fauci's role in COVID-19 origins


As the world grapples with the devastating impact of the COV-ID-19 pandemic - including a slew of totalitarian medical mandates, lockdowns, censorship, fraudulent testing programs, and failed vaccine platforms, a disturbing narrative unfolds behind the scenes. For years, Dr. Anthony Fauci, the face of the U.S. response to the crisis, has been at the heart of a web of deception, lies, and catastrophic experiments.

Wuhan Institute of Virology: The obvious source

At the heart of this investigation lies the Wuhan Institute of Virology (WIV) in China. This lab, funded by the U.S. through the EcoHealth Alliance, conducted controversial gain-of-function research on bat coronaviruses before and during the COVID-19 pandemic.

Controversial experiments: WIV researchers, including Shi Zhengli, have been studying bat coronaviruses and manipulating their genetic makeup to make them more lethal and contagious. Fauci's involvement: From funds and boasting to denials and coverups Dr. Anthony Fauci, director of the National Institute of

Allergy and Infectious Diseases (NIAID), has been a key figure in U.S. pandemic response and a prominent denier of the lab-leak theory. However, evidence suggests that his involvement in funding the very research that may have caused the pandemic goes far beyond mere oversight. The bioterror was planned, the so-called vaccines were prepared beforehand, and coronavirus gainof-function experiments became a pandemic that public health officials like Fauci would glean power and profit from.

Funding WIV's gain-of-function research: Through EcoHealth Alliance, NIAID, led by Fauci, provided grants totaling nearly \$600,000 to WIV for research on bat coronaviruses between 2015 and 2019. This funding, approved by Fauci, helped facilitate the risky experiments that may have led to the COVID-19 outbreak.

Perjury under oath: Fauci repeatedly denied funding gain-of-function research at WIV during Congressional hearings, most notably in clashes with Senator Rand Paul. However, emails obtained through Freedom of Information Act (FOIA) requests reveal that Fauci approved the funding in question. These conflicting statements call into question Fauci's honesty and integrity.

Collusion and cover-up: Suppressing the truth

As the scandal raged on, Fauci and

his cohorts allegedly went to great lengths to suppress information about the virus's origins and discredit scientists who dared to suggest a lab leak.

Collaboration with Chinese officials: Rather than hold China accountable for the pandemic's origins, Fauci and other top U.S. public health officials worked with Chinese counterparts to produce a joint statement that refuted the lab-leak theory. This statement, published in The Lancet, was later found to be based on false information provided by Chinese officials.

Discrediting the lab leak investigation: Fauci and his cohort, Dr. Peter Daszak, have been accused of actively discrediting the lab-leak theory and attacking scientists who supported it. Daszak, a zoologist who worked closely with WIV and received NIH funding, even wrote a letter to The Lancet condemning the lab-leak hypothesis as a "conspiracy theory" before claiming to have no conflict of interest in the matter.

As the investigation into Fauci's role in the COVID-19 pandemic continues, one thing is clear: the truth has been suppressed for far too long. The gravity of the situation demands transparency, accountability, and decisive action to prevent such disasters in the future. determine whether COVID-19 "vaccines," compared to other vaccines, are linked to neuropsychiatric conditions. VAERS was

searched from January 1, 1990, to December 27, 2024, for adverse events (AEs) involving neuropsychiatric issues post-COV-ID-19 vaccination. The study spanned 420 months for all vaccines, with COVID-19 vac-







According to sources within the Town of Quartzsite, more than 50% of respondents to their General Plan Update Survey in 2023 communicated that they wanted a "cleaner community with nicer aesthetics."
