
Blazing Action at Blythe Speedway: High-Octane Thrills Light Up Mother's Day Weekend

- 3. The Crisis of Childhood Behavior in the Digital Age
- 4. The Over-medicalization of Our Kids

High in the report, the authors declare, "today's children are the sickest generation in American history in terms of chronic disease." Part of the reason: pesticides,

# Why Private Property Matters: Part 3 -The growing attack on property rights

The increasing encroachment of government regulations, pontificating politicians and the enforcement of Social Justice schemes have led to a loss of understanding of the terms private property and property rights.

Once it was understood that the unauthorized entering of private property was a violation to the utmost. The property owner was justified and supported in taking necessary actions to remove

the trespasser and secure that land.

Today, such ideas in the new America are considered radical, old fashioned, out of touch, and even reprehensible. The homeowner can be arrested for defending against an armed intruder. The intruder can actually sue a homeowner for shooting them even as they break down the door intending to rob and do harm. Home protection is called violence, perhaps even racism. It's a whole new world of compliance, fear, and acceptance rather than pride, protection, and prosperity in ownership.

The Green New Deal is the current name for the agenda to control living standards and obliterate private property and sound energy sources. Massive wind and solar farms bury massive amounts of land under their steel and concrete infrastructures, as private land and farms lying in their path find it nearly impossible to co-exist. Driving people off the rural lands and into

Inside the growing high rise city forests, the new Biden Administration is now preparing an all-out assault on private property ownership. In the name of Climate Change, Biden plans to form "denser, more affordable housing

> next to public transit." This is being done by removing zoning protection for single-family neighborhoods, destroying property values as public housing complexes are moved into the neighborhood. This is already being done in Oregon and in cities such as Minneapolis, where the mayor calls single-family zoning, "racist."

Landlords are also under attack as some new policies are actually forbidding them to even ask if a potential tenant can afford to pay the rent. Meanwhile, more regulations on landlords are raising costs, yet forbidding them the ability to raise rents.

Most of these programs come under programs with names such as Smart Growth or Sustainable Development, and are enforced through community comprehensive development plans mandated by state legislatures and funded through federal grants, primarily from HUD, EPA, or the Depart-

ment of Transportation. Compliance to the grants able policy.

The most recent attack on property rights, now gaining momentum across the nation, is called 30×30. The plan calls for locking away

30% of America's land and waters. Under Biden's new EO, at least 30% of all land in the U.S. would

be permanently set aside and maintained in a natural state. Activities such as energy development, forest management, livestock grazing, mineral exploration and development, and many recreational uses would be prohibited. This would require at least 680 million acres of land to be set aside – more land than the entire federal government currently manages.

Most of the land dedicated to achieving the 30 x 30 goal will be the federal land found in the 11 western states and Alaska. Forcing

rural communities and businesses that depend on the use of public lands and national forests to bear the brunt of the program would be inequitable. There is no other alternative, however. The bottom line is that "30 x 30" is an excuse to end the productive use of public lands and national forests and to set aside massive tracts of land to remain fallow.

If these policies for community development, landlord control, and confiscation of rural lands are allowed to carry out to their logical conclusion, eventually there will be no private property in the United States and all housing, farming, and industry will be simply government programs. In a word, communism.



# **UPDATE: Roth Private Property** Invasion and the "Quartzsite Four"

Well defined limits on government power in a free society are fundamental to protecting and defending the unalienable rights of the individual to life, liberty and the pursuit of happiness (property/estate). To this end, "the only purpose for which power can be rightfully exercised over any member of a civilized society, against his will, is to prevent harm to others. His own good, either physical or moral, is not sufficient warrant." - John Stuart Mill, On Liberty, 1859

Governments may not infringe upon a free person's life, liberty or pursuit of happiness (property/estate) unless that free person infringes on another person's life, liberty or pursuit of happiness (property/estate).

**RECAP:** Early in the morning Wednesday, March 26th, 2025, the Quartzsite Police Chief, his officers, code enforcement and the Town Attorney were pounding on the front door of Mike Roth's home in Quartzsite, AZ. When Mr. Roth answered his door they announced their intention to immediately execute a court approved property abatement order on him and his one acre private property.

The entire neighborhood block was closed, four large roll off dumpsters were delivered, dump trucks, dozers, trailers, a slew of government vehicles and employees all descended in raidlike fashion at the scene. The first place they started was a large pile of amazingly nutrient rich soil and mulch in his backyard. The Town Attorney claimed it was a fire hazard. The government marched forward, indiscriminately destroying and/or taking Mr. Roth's private property in broad daylight.

The fact is Roth's private property did NOT violate, threaten or harm any other person, nor did it deprive anyone of their rights to life, liberty and the pursuit of happiness (property/estate), thus, according to men like John Stuart Mill and John Lock, the government did NOT have the right to destroy and/or steal his private property.

I was on site most of the first day when the property was invaded and was explicitly told by the officers on scene that anyone invited onto Roth's private property had the right to be there, so long as they did not interfere and try to stop the government from executing their court approved abatement order.

The government took a long weekend and then returned to Roth's private property in full force on Monday, March 31st, 2025. Mr. Roth had 20 plus invited guests on his property, who were safely gathered together out of the work zones enjoying hot coffee and fresh doughnuts as the government arrived. The 20 plus guests included several members of the press, a retired law enforcement officer, business owners, blue collar workers, an educator, a beautician and several retirees... salt of the earth

people that were there to observe and record the actions of their government, which according to the officers from the previous encounter said they have the right to do.

The police on scene became aggressive right from the start and demanded that they leave the property because they were "obstructing government operations." According to the Arizona Revised Statutes states in 13-2402 Obstructing governmental operations; classification:

A. A person commits obstructing governmental operations if, by using or threatening to use violence or physical force, such person knowingly obstructs, impairs or hinders:

- 1. The performance of a governmental function by a public servant acting under color of his official authority; or
- 2. The enforcement of the penal law or the preservation of the peace by a peace officer acting under color of his official authority.
- **B.** This section does not apply to the obstruction, impairment or hindrance of the making of


an arrest.

C. Obstructing governmental operations is a class 1 misdemeanor.

When it was pointed out to the officers by several of the invited guests that clearly they were not obstructing government operations, several officers shifted and claimed the individuals

(invited to the property by the property owner) were trespassing and would be arrested if they did not leave. The Chief of Police was then heard calling in to the Sheriff's Department for backup and large capacity transport.

When the Sheriff's Department backup and large capacity vehicle arrived the arrests be-



gan and four individuals were arrested: Mike Roth, Robin Marie, Linda Mc Quality, and Phil Unruh... The "Quartzsite Four." Law Enforcement, choosing to make these arrests, unnecessarily created a chaotic and dangerous environment that was peaceful and orderly before they bullied, intimidated, threatened, and arrested invited guests.

The "Quartzsite Four" were arrested at around 8am and remained incarcerated at the La Paz County Detention Facility in Parker, AZ until around 6PM when they were finally able to go before a judge.

The "Quartzsite Four" had their first court appearance on April 30th, 2025 and they had their second court appearance on May 28th, 2025, both at the Town of Quartzsite Magistrate Court inside the Quartzsite Town Hall building.

At both court appearances the public was denied access to the courtroom, including the press. Only the defendants, individually, one at a time, were allowed to enter the courtroom at their appointed time.

The Quartzsite Magistrate Court staff claimed they denied public access to the court proceedings based on "the Arizona Supreme Court Administrative Order 2017-15(A)(6) both (a) & (b), the public shall be screened prior to entering the courtroom. This screening shall be by a trained court security officer by means of either a walk through or handheld metal detector."

The Magistrate Court posted a notice claiming that the public, being forbidden in the court, was temporary and that they are working to meet security requirements.

At both of the court appearances mentioned above, the court had a Quartzsite Police Officer

inside the magistrate court building. All those present wanting to observe the court proceedings shared a mutual disgust at the government's inability to be transparent and accommodating. The public has a right to observe almost all court proceedings.

It should be noted too that the Arizona Supreme Court Administrative Order 2017-15 was penned in 2017, yet three of the people who tried to attend and observe the court proceedings for the "Quartzsite Four" had also come out to the Quartzsite Magistrate Court on May 4, 2021 for the court appearance of Jim Konopacky, "pizza box guy," and at that time (in 2021) the public was allowed inside the courtroom. The court did not have a metal detector at that time and the public was welcome in the courtroom.

When the magistrate court clerk was asked about this apparent contradiction, she said that the Quartz-site Magistrate Court performed a "Court Security Assessment" in 2022 and the magistrate decided to implement the 2017 Administrative Order 2017-15 moving

forward, for "public safety." It was not clear, but it would appear the public has not been allowed to

observe court proceedings since their assessment in 2022.

The "Quartzsite Four" had their second court appearance on May 28th, 2025 and moving forward the defendant's attorney requested more time for discovery and the next court date was set for June 11, 2025 at 9am. Please join us there.

At Roth's private property it appears the government has ceased all operations. The only government connected equipment that remains at the property are four large

roll off dumpsters. A source inside the town government indicated that the Town of Quartzsite may

have violated Roth's rights and that is why all operations for further abatement have ceased at this time.

Roth was interviewed right after he left the courtroom on May 28th. He shared that the government's actions have "irreparably upended his life," that many tools and supplies he used for his pursuit of happiness were destroyed or stolen by the government. He said, "What's a man to do when the government sends men and women with guns and heavy equipment to your home, and then destroys your private property right in front of your face?"

To date, the total personal property Roth claims the government destroyed is in excess of \$125,000 and the amount of personal property that Roth says "the Town of Quartzsite stole" from him is over \$150,000. If the Town of Quartzsite continues to execute the court order for abatement, they can charge him up to \$130,000, and place a lien against his property in the process.

Many locals are convinced that this is a political retaliatory attack on Roth, a violation of private property rights, a clear example of lawfare, an attempted land grab of Mike Roth's property, and the use of bullying and intimidation against him to try and make him leave the Town of Quartzsite.

## Hawaii Becomes First State To Charge Tourists For Carbon Footprint

Hawaii became the first U.S. state to establish a climate impact fee on tourism this week, placing an additional tax on visitors to fund "climate change resiliency projects". As the country's inaugural "Green Fee," Act 96 will raise the state's current transient accommo-

dations tax (TAT) by 0.75% for a total of 11% placed upon the nightly lodging rate, effective Jan. 1, 2026, according to a press release by Governor Josh Green's office.

"Today Hawaii ushers in the first Green Fee in the nation. Once again, Hawaii is at the forefront of protecting our natural resources, recognizing their fundamental role in sustaining the ecological, cultural and economic health of Hawaii. As an island chain, Hawaii cannot wait for the next disaster to hit before taking action. We must build resiliency now, and the Green Fee will provide the necessary financing to ensure resources are available for our future," said Governor Green.

Green is ostensibly referring to the disastrous Maui fires in 2023 which did \$5.5 billion in property damage and became an international embarrassment for the Hawaiian state government. Of course, as we reported at the time, the fires had nothing to do with "climate change" and everything to do with the state's gross mismanagement of water resources and fire response.

The new Green Fee will apply to travelers staying in hotels, short-term vacation rentals and (for the first time ever) cruise ships. For a nightly hotel rate of \$300, the tax



would add an extra \$2.25 each day. This might not seem like much, but Hawaiian officials expect the tax to generate up to \$100 million per year, and like all progressive governments, they are licking their chops over the possibilities.

In essence, carbon footprint schemes are a tax on an invisible byproduct with an imaginary climate impact. These are taxes to solve a problem which does not exist. So, the sky is truly the limit on how far carbon taxes can be taken to bleed the American public and fuel further government expansion. It begins with a tax on hotel rooms, but there's nothing stopping the state from adding the same fees to everything from boat rentals to tiki torches.

Furthermore, if Hawaiian residents think they will be spared from such taxes, they are in for a rude awakening. The new Green Fee also applies to people living in Hawaii who stay at hotels and resorts, and there's little doubt that more taxes are incoming as the Green Fee sets the precedent. Some legislators have pushed for a carbon tax "kickback" to residents of the state, but this would represent a minimal offset if carbon taxes spread to all areas of the economy. Keep in mind, Hawaii already has one of the highest tax burdens for citizens

in the entire US.

Hawaii's carbon reduction plans call for a 70% cut in emissions by 2030, using a "phased-in system" with a carbon tax rate of \$80 per ton of carbon emissions by that year. Hawaii wants zero emissions by 2045. Meaning, a green fee on hotels is just the beginning and everything with a carbon footprint will ultimately be taxed into oblivion.

As we have noted many times, there is zero concrete evidence of a causation relationship between carbon emissions and climate change. All climate models used by scientists in the field to justify their global warming claims rely on data collected from the 1880s onward. That's a tiny window of 140 years in the Earth's climate history and conveniently ignores long term data from before the advent of human industry.

When we examine Earth's temper-

atures over millions of years, it's easy to see that modern civilization exists in one of the coldest periods, not the warmest. Numerous warming periods have occurred in the past with no human activity to cause the events. If we look at the behavior of the carbon content of the Earth's atmosphere over this same time period, it's obvious that there is no correlation between rising carbon and rising temperatures.

In other words, the entire basis for carbon taxation has been debunked. The only reason governments continue to push for emissions fees is because they know a large percentage of the population isn't aware of this information. Government and NGO funded climate scientists continue to spread disinformation on global warming because they have access to billions upon billions of dollars in grant money if they promote the narrative. The farce is simply far too lucrative to abandon.

# Reliance On 'Renewables' Makes Widespread Blackout

Imagine taking the subway to work when the train comes to a sudden halt halfway between scheduled stops. You pull out your smartphone to go online and see what the problem is, but you have no reception – no cell signal, no internet. Hours later, rescue work-

ers arrive to extract you and your fellow passengers from the stalled train. You make your way to the street in hopes of taking a taxi or an Uber, but without your phone apps and with credit card machines inoperable, you are forced to

search for an ATM - only to discover those aren't working, either.

You soon realize that everyone else is in the same predicament. Hospitals operating on emergency backup systems. People trapped inside elevators. Traffic snarled due to inoperable stoplights. Gas station pumps are not functioning. Airport terminals closed. People in darkened homes desperately searching for candles and battery-operated radios to learn what's happening.

On April 28, the residents of Spain, Portugal and parts of France didn't have to try to imagine this nightmare scenario. They found themselves prisoners of it for hours when an unprecedented blackout impacted at least 55 million people after the Iberian Peninsula electric grid system failed. The outage, described as one of the worst ever in Europe, "disrupted businesses, hospitals, transit systems, cellular networks and other critical infrastructure," according to the France 24 news channel.

Many news agencies, particularly in the U.S., insisted for days that it was too early to say what caused the massive blackout. Others, though, acknowledged the obvious.

**Nightmare More Likely** The Reuters news agency reported early on, "Redeia, which owns Red Electrica, warned in February in

its annual report that it faced a risk of 'disconnections due to the high penetration of renewables without the technical capacities necessary for an adequate response in the face of disturbances."

> While many observers did their best to point fingers at alternative causes, others were more straightforward in identifying the culprit. Raúl Bajo Buenestado is a nonresident energy scholar at Rice University's Baker Institute for Public Policy in Houston. He received a Fulbright scholarship as a graduate student and a grant for young researchers from Spain's Ministry of Education, and received his Ph.D. in economics from Rice. Currently, he is "primarily working on the generation investment incentives and capacity markets in the electricity sector. He also conducts research on gasoline retail markets," according to his online biography.

> After studying the April 28 blackout data, Buenestado authored a commentary concluding that mere minutes prior to the grid collapse, "renewable sources accounted for 78% of electricity generation in the Iberian Peninsula grid system, with solar alone contributing nearly 60%. By contrast, conventional technologies, such as gas-fired and nuclear power plants, comprised only around 15% of the total generation mix. This configuration is not unusual in Spain or Portugal,

where high shares of renewable generation are common, particularly during sunny and windy days."

Buenestado added, "What sets April 28 apart, however, is that, according to Spain's national electricity grid operator (Red Eléctrica de España), two consecutive gen-

> eration loss events occurred in southwestern Spain, likely involving large solar installations." Buenestado noted that "the risk of large-scale blackouts in electricity systems with high shares of renewable energy is well-established. However, the Iberian blackout of April 28 brings these long-recognized vulnerabilities into sharp focus." He

explained that unlike conventional power plants, solar and wind installations "depend on a stable grid to function correctly and cannot autonomously support grid stability during disturbances."

Before President Trump reversed the previous administration's war on fossil fuels, President Biden had committed the U.S. to reaching "100 percent clean electricity" by 2035 – a goal that seriously imperiled our own infrastructure. Biden's corresponding attacks on affordable and reliable energy sources like natural gas were unrealistic and unpopular with many consumers who preferred gas appliances and heating sources over those that would be allowable under federal

Likewise, Spain is "currently aiming to phase out fossil fuel and nuclear generation in favor of renewables," with a goal of renewables comprising 74% of total output by 2030, under the plan. The insistence on replacing affordable, dependable energy with more expensive and unreliable alternatives is both illogical and impractical. Natural gas remains the most cost-effective, reliable and increasingly clean fuel choice in the world.

It is telling that despite the Spanish government's anti-fossil fuel rhetoric, the U.S. recently became the main supplier of liquefied natural gas to Spain. Much of Europe - mimicking extremist climate change rhetoric – publicly decries America's continued production and use of traditional energy, while simultaneously gobbling it up.

Will the disaster of April 28 make European leaders think twice about abandoning our most reliable energy sources? Hardly. Following the devastating blackout, Spanish Prime Minister Pedro Sanchez said his government would not "deviate a single millimeter" from its plans to transition to so-called renewables. That's unfortunate. In the meantime, it is worth noting that one of the primary sources of energy used to restore electricity to the tens of millions in Spain, Portugal and parts of France who lost power was one that officials there claim to abhor - natural gas.

FDA approves new Moderna

Act, the bill seeks to restore sound monetary policy and return control of the nation's currency to Congress, as mandated by the Constitution. JBS urges citizens to contact their representatives and senators to support this pivotal legislation.

#### Repeal the USA PATRIOT Act

The USA PATRIOT Act, enacted in the aftermath of September 11, 2001, has long been a point of contention for civil liberties advocates. JBS contends that the Act infringes upon constitutional rights by expanding government surveillance powers and eroding privacy protections. The Society calls for the full repeal of the PATRIOT Act, emphasizing the need to balance national security with the preservation of individual freedoms. Citizens are encouraged to reach out to their legislators to advocate for the restoration of constitutional safeguards.

# Oppose S. 4104: The Misleading "Pro-Second Amendment" Bill Senate Bill 4104 has been presented

as a measure to protect Second Amendment rights; however, JBS warns that the bill contains provisions that could, in fact, undermine gun ownership rights. The Society highlights concerns that the legislation may introduce federal overreach and impose restrictions that conflict with the constitutional right to bear arms. JBS urges constituents to scrutinize the bill's language and to contact their senators to oppose any legislation that compromises Second Amendment protections.

#### Repeal the REAL ID Act of 2005

The REAL ID Act mandates the creation of standardized identification cards, which JBS argues paves the way for a national ID system, threatening personal privacy and state sovereignty. The Society asserts that such measures could lead to increased government surveillance and control over citizens' movements. JBS calls for the repeal of the REAL ID Act, advocating for the protection of individual liberties and

the decentralization of identification systems. Citizens are encouraged to voice their opposition to this Act by contacting their state and federal representatives.

# Get the U.S. Out of the World Trade Organization (WTO)

JBS maintains that the United States' membership in the World Trade Organization compromises national sovereignty and subjects domestic laws to international oversight. The Society argues that the WTO's regulations can override U.S. legislation, negatively impacting American industries and workers. By withdrawing from the WTO, JBS believes the U.S. can reclaim its trade autonomy and protect its economic interests. Citizens are urged to contact their legislators to support efforts to exit the WTO.

# Take the Deal, President Trump

Deal-making is said to be President Trump's specialty, yet after five rounds of indirect talks with Iran - most recently just days ago - we seem as far away from an agreement as ever. The fifth round ended last Friday with no breakthrough, but at least no breakdown. However, each day that passes without a document signed on the table is another day for the neocons to maneuver the US president toward an attack on Iran.

One way the war party does this is to continuously move the goal posts and change the rules of the game. Trump envoy Steve Witkoff (under great pressure from the neocons)



has himself signaled at least three position-shifts: from no enrichment at all, to low-level enrichment for civilian uses, back to no enrichment at all.

The neocons know that Iran will not give up its right to the civilian use of nuclear power and that is why they are applying maximum pressure to force Trump to officially adopt that position. They know if that becomes the US "red line" then they will win and they will get their war.

Israeli Prime Minister Netanyahu (in league with US neocons) has been warning us for 20 years that Iran is "months away" from a nuclear weapon – even though our own Intelligence Community recently re-affirmed that Iran is not working on a nuclear weapon at all. Of course this is the same Netanyahu who promised Congress in 2002 if the US would just invade Iraq, peace and prosperity would break out in the Middle East. "If you take

out Saddam, Saddam's regime," he told Congress in March of that year, "I guarantee you that it will have enormous positive reverberations on the region."

We know how that worked out.

Poll after poll shows that the American people are tired of intervention and tired of Middle East wars. President Trump himself recognized this in his scathing rebuke of neocons and interventionists during a recent speech in Saudi Arabia. However, rebuke in a speech is not enough. President Trump must actively turn away from the neocons - many of whom are prominent in his own administration.

The recent US debacle in Yemen where billions were wasted, civilians killed, and US military equipment destroyed – is just a taste of what the US would be in for if the neocons get their way and take us to war with Iran. The Iranian foreign minister laid down in the simplest terms how the impasse could be solved, posting

on X that, "Zero nuclear weapons = we DO have a deal; Zero enrichment = we do NOT have a deal.

My own preference is non-intervention and I do not believe Iran has the desire or the ability to militarily harm the United States. I share President Trump's view that it would be far better to re-establish relations with Iran and begin mutually beneficial trade with the country. If a mutually acceptable nuclear deal is the best way to take the neocon war with Iran off the table, then a deal is worth supporting.

President Trump should make his position clear to his negotiators: no more waffling or contradictions, get this agreement signed and put one in the "win" column.

herbicides, and insecticides, which, according to the report, Big Ag may be using at dangerous levels.

Prior to the report's release, The National Corn Growers Association [NCGA] and other groups from the farming industry voiced concerns that the commission would misrepresent them and ultimately hurt their bottom line. "Should the MAHA Commission Report baselessly attack and, worse yet, make claims that are simply untrue against the hardworking men and women who feed our nation, it will make further cooperation on this initiative very difficult and potentially put American food production at risk. We urge President Trump to ensure that the MAHA Commission report is based on sound science and evidence-based claims rather than opinions and preferences of social influencers and single-issue activists with little to no experience in actual farming and food production."

The actual report was careful to keep in check direct criticism of Big Ag practices and products, including the herbicide glyphosate, a weed killer believed by many to be a main contributor to Hodgkin's lymphoma. However, the report listed "crop protection tools" as a risk to children, stating, "it raised concerns about possible links between some of these products and adverse health outcomes, especially in children."

Still, the NCGA were, as their headline reads, "deeply troubled" by the report, writing that it "denigrates the safety of key pesticides used by corn growers and other farmers." The association issued its own statement after the MAHA Commission report was released: "The Make America Healthy Again Report is

filled with fear-based rather than science-based information about pesticides," the NCGA posted on its website. "We are deeply troubled that claims of this magnitude are being made without any scientific basis or regard to a long history of EPA expert evaluations about these products. Decades of extensive research and testing show that pesticides (including atrazine and glyphosate) can be applied safely for their intended uses. If the administration's goal is to bring more efficiency to government, then why is the secretary of Health and Human Services duplicating efforts by raising questions about pesticides that have been answered repeatedly through research and reviews by federal regulatory bodies."

John Klar, attorney, author, Vermont farmer and contributor to The Kennedy Beacon, pushed back against such criticism. "Despite widespread negativity toward the MAHA Commission Report (even before it was issued) it is hard to understand what any American would find objectionable," he wrote in an email to the Beacon. "The Report addresses multiple causes of the undeniable increase of disease in our children, including food, social media, lack of exercise and sleep, and environmental chemical exposures. It thoroughly documents these problems, then proposes a list of actions (including evidence-based study) pro-growth policies, and a transformation of our food, health, and scientific

systems to respond to this crisis." Continued Klar, "As a farmer and grandfather, I enthusiastically support providing healthier, whole foods for future generations, reducing chemical and social media exposures, and improving health outcomes for all. This does not require an assault on our farmers, but an alignment of federal policies to support and incentivize them to respond to dire needs. This is a business opportunity for those who grow food!"

#### Vaccines and Medications

Section four of the report is particularly revelatory, as it challenges the established notion among public health officials in previous administrations that vaccines and medications, once approved for use, are beyond further investigation and even beyond criticism.

"Since 1986, for the average child, by one year of age, the number of recommended vaccines on the CDC childhood schedule has increased from 3 injections to 29 injections (including in utero exposures from vaccines administered to the mother)," the report's authors write. "The number of vaccinations on the American vaccine schedule exceeds the number of vaccinations on many European schedules (including Denmark) which has nearly half as many as the U.S. Yet, no trials have compared the advisability and safety of the U.S. vaccine schedule as compared to other nations."

The report details how the vaccine industry has attained a unique

shield to the product liability other companies operating in different sectors face. Moreover, it states that many vaccines are mandated as a requisite for public school enrollment. However, the report's authors point out that in half of European countries, schools do not mandate any vaccines.

The report further concludes that both public and private sector censorship of scientists critical of some elements of the CDC's childhood vaccine schedule has resulted in a culture of fear among the scientific community. "Physicians who question or deviate from the CDC's vaccine schedule may face professional repercussions, including scrutiny from licensing boards and potential disciplinary action," the authors of the report write. "The American Medical Association (AMA), for example, adopted a new policy aimed at 'addressing public health disinformation' that called to ensure licensing boards have the authority to take disciplinary action against health professionals for spreading health-related disinformation."

As the public and press process the first MAHA Commission Report, the team that created it will get back to work: in keeping with President Trump's mandate when he established the commission in February, Kennedy and his colleagues now have 80 days to create a strategy for how the federal government should respond to the information presented in the report.

In a press conference at the White House later on Thursday, Kennedy thanked President Trump for his vigorous support of the MAHA agenda. "This is the beginning of a national conversation," Kennedy said, adding: it is also a "call to action" for "common sense."

# Biden Admin Knew Covid Shot Risks in Early 2021 But Kept Silent for Months: Senate Report

The Biden administration was warned of cardiovascular dangers associated with the COVID vaccines in February 2021 yet kept quiet until June, according to a Senate report.

The Biden administration was aware of cardiovascular dangers associated with the COVID-19 vaccines as early as its second month in office yet delayed disclosing them for months, according to

a report by the Senate Permanent Subcommittee on Investigations.

The Daily Wire obtained a copy of the report, which uncovered a February 2021 email from Centers for Disease Control & Prevention (CDC) Vaccine Safety Technical Work Group (VaST) co-lead Lauri Markowitz that reported of the almost 1,000 post-vaccination deaths reported at the time, those with "known" causes were "often cardiovascular."

The report further noted that Israel (which began vaccinating earlier than the United States) notified CDC officials that it found "large reports of myocarditis, particularly in young people, following the ad-

ministration of the Pfizer vaccine."
However, "rather than provide the public and health care providers with immediate and transparent information regarding the risk

of myocarditis following mRNA COVID-19 vaccination, the Biden administration waited until late June 2021 to announce changes to the labels for the Moderna and Pfizer COVID-19 vaccines based on the 'suggested increased risks' of myocarditis and pericarditis," the report found. "Even though CDC and FDA officials were well aware of the risk of myocarditis following COVID-19 vaccination, the Biden administration opted to withhold issuing a formal warning to the public for months about the safety concerns, jeopardizing the health of young Americans."

"For a number of months, they were talking about these things. At

some point in time, they actually internally said, 'Is there a signal of myocarditis, a safety signal?' And the answer was 'Yes,'" said Republican Sen. Ron Johnson of Wisconsin,

chair of the committee. "And yet, a couple of days later, they decided not to issue a warning on the Health Alert Network (HAN). Rather than provide informed

consent, the federal health agencies under the Biden administration, covered it up. They downplayed the signals."

Johnson added that the Biden administration stonewalled his committee, but the Trump administration is "beginning to

produce records, pursuant to the chairman's subpoena, that should have been provided years ago, without redactions, to Congress and the public."

The federal Vaccine Adverse Event Reporting System (VAERS) reports 38,615 deaths, 220,701 hospitalizations, 22,531 heart attacks, and 29,150 myocarditis and pericarditis cases as of April 25, among other ailments.

CDC researchers have recognized a "high verification rate of reports of myocarditis to VAERS after mRNA-based COVID-19 vaccination," leading to the conclusion that "under-reporting is more likely" than over-reporting.

An analysis of 99 million people across eight countries published in the journal Vaccine "observed significantly higher risks of myocarditis following the first, second



and third doses" of mRNA-based COVID vaccines, as well as signs of increased risk of "pericarditis, Guillain-Barré syndrome, and cerebral venous sinus thrombosis," and other "potential safety signals that require further investigation." In April 2024, the CDC was forced to release by court order 780,000 previously undisclosed reports of serious adverse reactions, and a study out of Japan found "statistically significant increases" in cancer deaths after third doses of mRNA-based COVID-19 vaccines. and offered several theories for a causal link.

In January, a long-awaited Florida grand jury report on the COVID vaccine manufacturers found that while only a miniscule percentage of the millions of vaccinations resulted in serious harm based on the data it had access to, such events do occur, and there are "profound and serious issues" in pharmaceutical companies' review process, including reluctance to share what evidence of adverse events they did find. # Biden Unaware of Executive Orders 'Signed' by Autopen

President Joe Biden issued 162 executive orders over the course of his Oval Office tenure, but according to a new report, most of them were signed by "autopen," giving rise to concerns that unelected White House staffers may have had more say in shaping policy than the president. The report is furthering those concerns and suggesting that Biden may not have even been aware of the existence of the orders being signed in his name.

The American energy advocacy group Power the Future published the report Wednesday, examining eight Biden-era

executive orders on climate change and U.S. energy policy, and found "no evidence" that Biden ever spoke about or acknowledged the existence of any of these orders. "Not in a press conference. Not in a speech. Not even a video statement," Power the Future's report stated. Power the Future Executive Director Daniel Turner said in a statement, "Americans deserve to know which unelected staffers or radical unnamed activists implemented sweeping change through an autopen. The Biden energy agenda destroyed the livelihoods of energy workers and fueled the record-high inflation that broke the budgets of millions of Americans." He asked, "The question is simple, and deserves an immediate answer: what did Joe Biden know, and when did he know it?"

According to the Oversight Project, dedicated to government accountability, practically every order signed by Biden was signed via autopen, with the exception of his announcement withdrawing from the 2024 presidential election. The Oversight Project cited House Speaker Mike Johnson (R-La.), who questioned Biden on an executive order affecting liquefied natural gas (LNG) and reported that the president didn't remember signing the order. "He looks

at me, stunned, and he said, 'I didn't do that,'" Johnson recounted. He continued, "And I said to him, 'Mr. President, yes you did, it was an executive order, like, you know, three weeks ago.' And he goes, 'No, I didn't do that.' ... It occurred to me ... he was not lying to me. He genuinely did not know what he had signed."

"For investigators to determine whether then-President Biden actually ordered the signature of relevant legal documents, or if he even had the mental capacity to, they must first determine who controlled the autopen and what checks there were in place," the Oversight Project wrote in a social media post. The accountability organization continued, "Given President Biden's decision to revoke Executive Privilege for individuals advising Trump during his first Presidency, this is a knowable fact that can be determined with the correct legal process..."

The "autopen" has been the subject of significant controversy in recent years due to Biden's excessive use of the technology. Devices have been around for centuries, allowing individuals to replicate their signature or sign multiple documents at once. Thomas Jefferson, for example, kept an early prototype, then called a "polygraph," in the White House and another

in his residence at Monticello. The device allowed a user to sign multiple documents at once but did require the signer to be present and to actively use the machine.

In the late 1930s, an automated version of the machine was developed, called the "autopen," which would store a template of a signature that could be reproduced without the presence of

the actual signer. The autopen became commercially available in the early 1940s and was quickly purchased by politicians, government officials, celebrities, and others. The first U.S. president to use an autopen was reportedly Harry Truman, although he only used the device to sign checks and answer mail. Likewise, most other presidents — such as John F. Kennedy, Richard Nixon, or Gerald Ford — who used an autopen relegated their use of the instrument to signing checks, correspondence, and autographs.

George W. Bush considered using the autopen to sign executive orders and legislation and even got the Department of Justice's (DOJ's) approval to do so,

but still insisted on signing such documents himself, flying to Washington, D.C. to sign emergency legislation in 2005, for example. Barack Obama was the first president to use the autopen to sign legislation, giving his approval to sign Patriot Act extensions via autopen while he was visiting France in 2011, the National Defense Authorization Act while vacationing in Hawaii in 2012, and fiscal legislation in 2013.

President Donald Trump has openly refused to use autopen signatures for executive orders and other legal documents. "We may use it, as an example, to send some young person a letter because it's nice," Trump told reporters in March. Contrasting his limited use of the autopen against Biden's much broader use, Trump added, "But to sign pardons and all of the things that he signed with an autopen is disgraceful." Trump has also suggested that pardons — and, potentially, executive orders — signed by the Biden administration via autopen may be legally "void" if the president didn't know what he was signing or didn't authorize its signature.

The Washington Stand asked the DOJ about potential investigations and, if applicable, prosecutions of the Biden administration's autopen use and was told, "No comment here."

## Physical Activity & Alzheimer's Risk

The journal Alzheimer's & Dementia has just published an analysis of the effects of physical activity on preclinical risk factors for



Alzheimer's disease (AD) among middle-aged adults at higher risk for its development. Three hundred thirty-seven adults were recruited from a subset of a larger longitu-

dinal cohort, the Alzheimer's and Families (ALFA) study. Participants were between the ages of 45-65, without cognitive impairment, though at higher risk (86% of participants in ALFA have at least one parent with AD).

Their physical activity was assessed at the beginning of the study, and again at a follow-up assessment approximately 4 years later. They were then grouped into one of 5 categories, depending on whether they were sedentary (no activity), adherent or non-adherent to WHO activity guidelines  $(\geq 150 \text{ min/week moderate or } \geq 75)$ min/week vigorous intensity), and if they maintained or changed activity levels over time. PET and MRI scans were performed at the follow-up visit to determine brain Aβ burden and cortical thickness in AD-vulnerable structures, indicators of AD risk.

The principal finding was that

maintaining sedentary behavior was related to lower cortical thickness (greater AD risk), while becoming adherent to WHO guidelines (i.e., increasing from baseline activity) was associated with a lower brain Aß burden, in comparison to becoming non-adherent. There also appeared to be a dose-dependent relationship between physical activity and lower levels of brain Aβ burden, with the data largely suggesting that increased physical activity has a protective effect. While reverse causality cannot be ruled out, i.e., that brain atrophy leads to more sedentary behavior, a protective effect of exercise is consistent with previous studies.



Ultrasound imaging revealed that cellphone exposure caused a healthy woman's blood cells to abnormally clump up, even when the cellphone was an inch away from her skin, according to a new peer-reviewed study published in **Environment: Science and Policy** for Sustainable Development.

Using ultrasound, the researchers showed that the woman's blood cells developed a rouleaux formation, an abnormal red blood cell pattern in which the cells stack together in long rows like piles of coins, according to MyHematology.com.

Dr. Robert Brown (the study's author) is a diagnostic radiologist with more than 30 years of experience and the vice president of Scientific Research and Clinical Affairs for the Environmental Health Trust (EHT). He said that although the impact of rouleaux formation on health is not well understood, it's "not without potential health consequences... Because of the impact on gas exchange and increased blood viscosity due to clumping, it is possible rouleaux could account for the unusual uptick in once-uncommon disease processes and disorders increasing in our society over the past few decades, including hypertension, obesity, diabetes, strokes, particularly in the younger population, and others."

According to Brown, the study is key to educating the medical community on how wireless radiation affects a person's biological functioning. "If we want to see a change in government regulations and a decrease in the indiscriminate usage of wireless technology, the allopathic medical community needs to become knowledgeable of the health effects of wireless communication radia-




tion," He said. "I believe this study has cracked the proverbial egg."

Devra Davis, Ph.D., MPH, a toxicologist and epidemiologist who is founder and president emerita of the EHT (a nonprofit research and education group focused on the effects of wireless radiation) said, "This finding of clumping in the blood after only five minutes of direct cellphone exposure should give pause to all who keep phones close to their bodies."

#### Researchers repeated the experiment several times

For the data in this study, Brown and his colleague, Barbara Biebrich, an ultrasound technologist, did an initial experiment including an



ultrasound scan of the leg vein of a 62-year-old asymptomatic woman with no history of allergy, blood disorder or systemic disease. Next, they placed an idle Apple iPhone XR cellphone on the back of her knee for five minutes. The phone was connected to AT&T's mobile network with its Wi-Fi, Bluetooth and cellular antennas turned on. However, the phone didn't make calls or send texts, or receive calls or texts, while placed on the back of her knee.

After five minutes, the researchers did another ultrasound. The second ultrasound showed that cellphone radiation caused the blood cells in the woman's popliteal vein (located behind the knee) to clump in rouleaux formation. Brown and Biebrich repeated their experiment with

the same woman multiple times over three months. "Each time, we encountered the same results," Brown wrote. On one occasion, the woman's blood cells were

already in rouleaux formation before having



the cellphone placed on her knee for five minutes. "Although we were initially perplexed," Brown wrote, "I asked the participant where she had kept her cellphone just before the scan, and she replied that it had been in her pocket."

The researchers also altered the experiment by placing the cellphone an inch away from the woman's skin, rather than placing it directly on her body. Again, they waited five minutes. "She went into rouleaux, even with the cellphone exposure an inch away," Brown wrote. "By demonstrating rouleaux in a deep

leg vein, the study confirms that the penetration and associated physiological effects of wireless radiation are not limited to the first few

millimeters of skin, but do, in fact, occur deeper in the body," Brown said. This finding has "significant implications for safety," he said.

The Federal Communications Commission's safety exposure limits for wireless radiation are based on the assumption that the radiation can harm human health only at levels high enough to heat human tissue. Cellphones emit radiation at levels lower than that. Many scientists (including Brown) say there's evidence that non-thermal levels of wireless radiation may negatively affect human biology.

The study provides a "visible manifestation" that cellphone radiation at non-thermal levels has biological effects. The study didn't clarify what specific range of cellphone radiation frequencies, such as 4G or 5G, caused the blood to clump. The cellphone was idle and not actively engaging a 4G or 5G network,

"handshaking" communication do with cell towers, Brown said.

In the experiment report, the researchers said they are planning a larger study to assess how prevalent cellphone radiation-induced rouleaux formation may be among the general population. "Although the incidence of rouleaux formation following cellphone exposure is unknown, I am quite certain our subject is not a unicorn," Brown said. Ultrasound imaging is relatively inexpensive and popular, so it should be easy for other researchers to do follow-up studies, too, he added.

On Feb.10th the researchers published their results using ultrasound to show that cellphone radiation induces abnormal blood clumping in a peer-reviewed article in Frontiers in Cardiovascular Medicine.

The April study in the Environment journal restates much of the February report in Frontiers. However, the report in Frontiers did not include the results from holding the cellphone an inch away from the woman's body because the researchers had not yet done that experiment. Both reports are important because they target different audiences, according to Brown. The Frontiers journal is a resource for the physician community, particularly cardiologists and cardiovascular surgeons. The Environment journal is geared for the "much broader environmental science community," Brown explained.

Although rouleaux formation is usually reversible in healthy persons, meaning the blood will return to normal over time, there are reports that rouleaux may increase one's risk for developing a larger blood clot, which could then lead to a potentially fatal pulmonary embolism or stroke.

## **How Grants Undermine Local Control**

Grants are often portrayed as benevolent tools for community improvement, providing much needed funds for public projects. However, the terms and conditions attached to these grants can erode local governmental processes, favoring external agendas over the will of residents. This article explores how grant structures can usurp local control, skew public participation, and insulate city officials from accountability through mechanisms such as biased stakeholder selection, predetermined meeting outcomes, and manipulated online surveys.

Using Rancho Cucamonga, California (specifically its General Plan Update (PlanRC) and Healthy RC programs) as a case study, we will examine how these practices distort governmental processes and favor preselected outcomes, often under the guise of community engagement.

#### Rancho Cucamonga's PlanRC and Healthy RC

Rancho Cucamonga's General Plan Update (adopted on December 15, 2021) after nearly two years of planning, is lauded as a "comprehensive community-based plan to serve as a blueprint for the next 20 years." However, the process reveals troubling patterns. The selection of stakeholders for interviews and advisory roles favored established organizations and leaders, potentially excluding grassroots voices or residents skeptical of rapid development. Online surveys and virtual workshops were vulnerable to manipulation due to their open-access nature and consultant-driven design. The Healthy



RC program, integrated into the General Plan, similarly used grant-funded initiatives to promote policies shaped by external funding priorities rather than purely local needs.

The Illusion of Local Control Cities such as Rancho Cucamonga proudly champion "local control" as a cornerstone of governance, emphasizing

that decisions reflect the will of residents. However, the influx of grant funding (often tied to federal programs or state mandates) introduces conditions that can override local priorities. Grants from agencies such as the Federal Emergency Management Agency (FEMA) or state programs come with strings attached, requiring cities to align projects with specific goals, such as diversity, equity, and inclusion (DEI), greenhouse-gas reduction, multifamily housing, and "public health" initiatives. These conditions shift decision-making power away from local voters and elected officials to external entities (including grant administrators and consultants) who may not be accountable to the community.

In Rancho Cucamonga, the Healthy RC initiative, launched in 2008 to address rising obesity and health issues, exemplifies this dynamic. The program is partially funded by grants such as a \$5,000 Let's Eat Healthy Community Grant from the Dairy Council of California. While the initiative appears community-driven, its reliance on grant funding risks tying it to predefined objectives, which may not always align with the priorities of residents.

#### Creating a Faux Constituency

One way grant-driven initiatives undermine local control is through the strategic selection of stakeholders who form a "faux constituency" to push agendas forward. In Rancho Cucamonga's General Plan Update, stakeholder interviews were conducted with 18 carefully

> selected individuals, including industry leaders, community based organizations, and elected officials. The city's own documentation notes that these interviews provided a "snap-

shot of existing conditions, trends, and public sentiment." However, the selection process for these stakeholders is opaque, and there is little evidence that it represented the broader community.

State & Local

Government

By prioritizing certain voices (often those aligned with city or grant objectives) officials can create a curated group that appears representative but is biased toward predetermined outcomes. For example, the Healthy RC program's Campeones para la Comunidad (Champions for the Community) and Youth Leaders are highlighted as community champions, yet the programs' structures indicate a controlled process that favors individuals likely to support city initiatives. This curated engagement gives the appearance of broad community support while sidelining dissenting voices, effectively diluting the influence of the broader electorate.

#### **Predetermined Outcomes**

Public meetings and workshops (often mandated by grant conditions) are framed as opportunities for community input, but can serve as tools to guide participants toward preselected outcomes. Rancho Cucamonga's PlanRC "Forum on Our Future" sessions, held in mid-2020, were designed to collect input, but summaries of these events suggest a focus on reinforcing city priorities, such as

dense urban housing diversification and climate-change sustainability, which align with state mandates and grant requirements. Live polling and virtual presentations during these meetings often frame questions in ways that limit the scope of discussion, subtly steering participants toward outcomes favored by city staff and consultants.

For instance, the "Dollars and \$ense of City Development" presentation at the January 6, 2021 City Council meeting emphasized fiscal sustainability and housing options, aligning with state housing laws and grant-funded goals. These meetings, while open to the public, often present polished narratives that downplay alternative perspectives, such as concerns about overdevelopment or displacement in low-income neighborhoods.

#### The Role of Consultants and Plausible Deniability

Consultants play a pivotal role in insulating city councils and staff from accountability. Hired to facilitate meetings, analyze data and develop plans, consultants act as intermediaries who can be blamed for controversial outcomes, providing officials with plausible deniability. In Rancho Cucamonga, the PlanRC process relied heavily on consultants to conduct stakeholder interviews, design online surveys, and draft the General Plan. These consultants (often funded by grants) are presented as neutral experts, but their work is shaped by the city's objectives and the grants' conditions. By outsourcing critical aspects of the planning process, city officials can deflect criticism, claiming that outcomes were driven by "expert" analysis or community input rather than their own directives.

Online surveys, a key component of PlanRC's engagement strategy, further exemplify this issue. These surveys, accessible to anyone worldwide via platforms such as Engage Rancho Cucamonga, lack mechanisms to verify that respondents are local residents. This global accessibility, while promoted as inclusive, risks distorting results by allowing non-residents (potentially including stakeholders with vested interests, such as developers or grant-funded organizations) to influence outcomes. The surveys themselves are often designed with leading questions or limited response options, skewing results toward city-preferred policies, such as increased housing density or specific health initiatives. This manipulation prioritizes external or elite interests over those of actual residents.

#### Go Along to Get Along

Grant terms and conditions can foster a "go along to get along" attitude among elected city-council members by creating incentives and pressures that prioritize compliance with external agendas over local priorities, as illustrated in the context of Rancho Cucamonga's Healthy RC and PlanRC initiatives. Healthy RC's focus on grant-driv-



en health metrics emphasizing reductions in childhood obesity and PlanRC's emphasis on state-mandated urban-housing goals illustrate how council members are incentivized to align with external agendas. The fear of losing funding, coupled with consultant-led processes and biased stakeholder input, fosters a culture where compliance trumps independent scrutiny, undermining local control and encouraging a passive, conformist attitude to secure grants and maintain political favor.

#### The Cost of Grant Programs

The reliance on grants and consultant-driven processes creates a system where local control is an illusion. By favoring select stakeholders, manipulating public engagement, and using consultants to insulate officials, cities such as Rancho Cucamonga can push agendas that benefit specific interests (such as developers or

nonprofit grant-funded organizations) while sidelining residents. The open-access nature of online surveys and meetings, while marketed as inclu-

sive, risks diluting local voices and allowing external actors to shape outcomes. This erodes trust, as residents may feel their votes and voices are secondary to predetermined plans.

To restore local control, cities must prioritize transparent voting over clandestine stakeholder selection and biased design surveys. Local officials must make decisions

based on impartial facts and ensure that public meetings allow for genuine debate rather than scripted outcomes. Until this happens, grant-driven initiatives will continue to undermine residents' input, favoring a system where plausible deniability and curated constituencies prevail over the will of the people.

# Things They Didn't Teach You in Church:

Recently, President Donald Trump wrapped up a momentous week in the Middle East. The trip included stops in Saudi Arabia and Qatar. The trip was mostly focused on massive investment deals secured with Riyadh, Doha and Abu Dhabi, but the president also lifted decades-long sanctions on Syria. Trump also issued another warning to Iran, who (biblically) are Persians not Arabs. During an address in Saudi Arabia Trump said, "If Iran's leadership rejects the olive branch and continues to attack their neighbors, then we will have no choice but to inflict massive maximum pressure... The choice is theirs to make." No doubt the maximum pressure will be the complete destruction of their nuclear programs.

While Trump was in Saudi Arabia, he signed a \$600 billion "strategic economic partnership" agreement with Crown Prince Mohammed bin Salman, and a whopping \$142 billion defense package. Trump suggested the deal could reach \$1 trillion in the months to come and generate up to 2 million U.S. jobs. Trump also secured a deal in Qatar worth \$1.2 trillion that included their purchase of 210 Boeing jets as well

as energy infrastructure agreements and other investments in state-of-the-art quantum technologies and workforce development.

Trump met with Syria's leader, President Ahmed Al-Sharaa, in Saudi Arabia,

where Trump took the international community by surprise, announcing the U.S. would reverse a decades-old policy of sanctions on Syria. He argued the country's new government should be given a chance to recover. Then Trump did the unthinkable: he asked Syria to join the Abraham Accords and normalize relations with Israel, for which Syria would receive sanctions relief in return. Concerning Syria's rebuilding, Trump said, "It's not going to be easy... It gives them a good, strong chance..."

Syria is reportedly willing to join the Abraham Accords, and it's president expressed openness to normalizing relations with Israel under certain conditions. All this is dependent on the US lifting economic sanctions and Syria addressing US concerns regarding their chemical weapons and counterterrorism efforts. There have recently been discussions between Israel and Syria which were mediated by the United Arab Emirates (UAE), indicating a potential shift in regional diplomacy. Syria's new leadership seems to be signaling their willingness to join the Abraham Accords.

Trump (speaking at the Saudi-US Investment Forum in Riyadh) also appealed directly to Crown Prince Mohammed bin Salman to join the Abraham Accords. The Crown Prince was seated alongside tech magnate Elon Musk when Trump made the request. "It's my fervent hope, wish and even my dream that Saudi Arabia will soon be joining the Abraham Accords," Trump said. "It will be a tremendous tribute to your country and crucial for the future of the Middle East."

The Abraham Accords Arab nations, primarily the UAE, Bahrain, and Morocco. According to Britanica the name of this agreement comes from the biblical account that both Israel and the Arabs are the descendants of Abraham and have a shared heritage. The Abraham Accords promote peace and cooperation between Israel and Arabs in the region.



24 Which things are an allegory: for these are the two covenants; the one from the mount Sinai, which gendereth to bondage, which is **Agar.** Agar is Hagar in Greek (the bondwoman and mother of the Arab nations) who were born into the bond-







age of flesh; the law. 25 For this Agar is mount Sinai in Arabia, and answereth to Jerusalem which now is, and is in bondage with her children. The children of Hagar (Agar) have not received Jesus Christ (to this day) and remain in bondage to the law. 26 But Jerusalem which is above is free, which is the mother of us all.

What a time to be alive! The descendants of these 2 brothers (the sons of Abraham) after 3000 years are coming together fulfilling prophecy. There is a piece to this physical "Biblical Puzzle" that often gets forgotten. Abraham's son Issac had twin boys; Jacob, the father of the 12 Tribes of Israel, and Esau. The lifelong struggle between Esau and Jacob led to their separation. Esau eventually married the daughter of Ismael (Genesis **28:8-9)**, connecting his descendants to the Arab tribes forever. In Genesis 36:1 Esau's name was changed to Edom (which means red) and his descendants the Edomites can be traced to the "Red Nation", Russia, as well as Syria. What are the odds of this all happening by chance? Will Trump eventually invite Russia and Ukraine to join the Abraham Accords? They are also descendants of Abraham. # Quartzsite Town Manager Receives \$1,000 Monthly Housing Allowance

I watched the May 13, 2025, Town Council meeting with disbelief. Despite public concern, the Mayor made it clear: there would be no open discussion of the \$1,000 housing allowance added to Town Manager Jim Ferguson's compensation. The interim attorney did suggest (behind closed doors) that a brief discussion might be appropriate when the item came up, which they did do. All but one Council member (Nancy Nichols) voted Yay on the pay increase.


With this addition, Mr. Ferguson's salary now nears \$200,000 annually. For many residents, this seventh amendment to his contract feels excessive. Especially puzzling is that he declined a full raise in the sixth amendment—presumably to avoid a higher tax bracket—yet accepted a tax-free housing allowance instead. Strategically done, Jim. Well played.

but I was stunned to learn that the manager of a small town of just 2,400 residents—most of them seniors living below the poverty line makes this much. My husband clearly chose the wrong profession!

What prompted me to write this letter was the Mayor's recent message in the Desert Messenger [printed in this issue on page 21]. I expected a list of Mr. Ferguson's accomplishments, but found none.

The Mayor recounted Ferguson's past experience and outlined his responsibilities—things we would have considered when he was first hired a decade ago—but failed to offer any evidence of tangible success in those roles. For example:

\* Director of Community Development: While he oversees departments like the library and community center, have we seen notable improvements under his leadership? Residents still mention limited resources in parks, with only two employees and no addi-

- \* Economic Development: What businesses has he actively brought in? At one meeting, Ferguson stated the town has no control over what businesses come in.
- \* Human Resources Director: Isn't it a conflict of interest for him to oversee HR? How can staff feel safe reporting grievances if the person in charge of HR is the one they report to?
- \* Director of Utilities: Yes, the new well is a plus, but it came with steep increases in water bills for residents.
- \* Grant Writer: The Transit Department has done well securing grants—kudos to Jan Collier for

that. Which grants, if any, has Mr. Ferguson personally written?

\* Public Information Officer: He does host monthly meetings—when he's available.

The Mayor claimed Ferguson takes on roles "beyond his job description," yet offered no proof that these roles have led to measurable improvement. What has he truly accomplished to justify such compensation? The residents deserve clear, honest answers.
