What Must Be Done for America To Survive and Prosper as a Constitutional Republic?

By definition, this article is polemic, advocating a major restructuring of government to comply with the Constitution and the laws of Economics. Two things must happen for us to remain viable. Trump's programs must work ... and I believe they will if we can defeat the Communist army's attempt to stop it ...and we must restructure our government Constitutionally. Both efforts must succeed, or we fail. I have previously written that our Constitutional Republic has been mortally wounded by the Coup of 1913, which oppressed us with Income Taxes, an Unconstitutional Federal Reserve Bank, Tax-Free Foundations, and unlawful Fiat Money. This was the beginning of the end for our Constitutional Republic. Income Taxes replaced Tariffs as the primary source of income for Federal Establishment AKA Government.

You will note that I refer to the Federal Establishment, not Government, because it is not a Sovereign Government like the states.

The primary nail in the coffin was income taxes that reversed the Constitutional roles of the States and the Federal Establishment. Basically the Federal Establishment, by using federal income taxes, denied money to the states and allowed the Federal Establishment to unlawfully usurp state functions and shift political power to Washington. There is only so much money available for taxation, and the income tax took most of it, leaving the states more or less destitute. This was an attack on "States Rights", second only to the Civil War.



To correct this disaster, we must mitigate the harm of the income tax by compelling the Federal Establishment to return to a state 50% of taxes collected in that state. This is just an estimate; it could be more or less. The Federal government will have additional revenue from Tariffs. Federal Income is about \$5 Trillion now and returns \$1.1 Trillion to the states. But the Federal Establishment will spend an estimated \$7.5 Trillion. Government must reduce other expenses, in addition to removing a THOUSAND or so departments and agencies not authorized by the Constitution, compliance being a qualifying requirement of all Oaths of Office!

I am sure that few of my numerical estimates will survive forensic analysis, but they are a realistic starting point. Returning our troops from overseas would save \$24.4 Billion. Terminating Unconstitutional Foreign Aid would save \$98.8 Billion or 1.2% of federal budget.

The Federal Establishment now unlawfully funds many usurped state programs and other unconstitutional programs. Medicaid consumes 56.8% of total funds to states, due to waste, fraud, abuse, and excessive use by illegals. We must bring our military home because we will need them desperately to control and deport the Communist army of 25 million illegals brought into our country by our Communist Traitors masquerading as public officials. The Constitution says this is Treason, with a possible death penalty (to be determined by Congress).

We should erect a permanent public gallows in Washington as a warning and deterrent. Federal Law enforcement must investigate, prosecute and convict elected officials and government employees for all infractions of the law. There must be a recognized high probability of arrest for corruption and theft. Effective Federal Law enforcement no longer exists or we would not have a mostly corrupt Congress. How many people were arrested for the waste, fraud, and abuse already uncovered by DOGE?

We also have no national security reason to have our military in a foreign country, since we can't be



The Epstein Saga: What It Is Really About

We have to decide whether the Epstein story is child rape or Mossad blackmail.

If "child" is defined as under the statutory age of female sexual consent, in the US depending on the state, a child is a female under 16 years of age, under 17 years of age, or under 18 years of age. In New York the age of female consent is 17. In Hawaii it is 16. Hawaii has a "close-in-age" exception that allows 14 year olds to consent with those up to 21 years in age. In Hawaii the goal seems to be not to prevent underaged females from sexual intercourse but to prevent overaged males (over 21) from sex with females declared underaged for them but not for younger men. There is an element here of age discrimination. In the Philippines the age of female consent is 12. In Germany the requirement is for a female to be 14 years old in order for a sexual relationship with a male over 18 to be legal.

In Mexico the age of consent is 15. In Russia it is 16. In Japan it is 13 but is being raised to 16. In England it is 16. In Italy and China the age of consent is 14. In Denmark and Poland it is 15. In Saudi Arabia sex is only legal within marriage. The legal age for marriage for males is 18, for females 16. In the 1950s the age of consent in the state of Georgia was 14. In Delaware in the late 19th century it was 7, yes 7, not a typo. During the 1880s the age of consent in many US states varied between 10 and 12. Whatever the varying legislated age, if the information provided to me is correct that some mothers have 12 year old daughters on birth control pills, the de facto

age of female sexual consent in the US is 12.

Was Virginia Giuffre a child? If she is American it depends on her state of residence. If she is British, Australian or a New York resident, she was not a child. There was no child rape of Virginia Giuffre for which she collected three million pounds according to reports.

Normally we think of a child as before puberty. I don't know if Epstein had such young kids as sex bait for his entrapment scheme. If so, it would seem to involve kidnapping in addition to illegal underage sex. Would the prominent Jewish billionaires, who Ryan Dawson [possibly the most knowledgeable Epstein historian - learn more at TPFPnews.com] says was Mossad's way of directing funds to Epstein, put themselves at risk by being complicit in kidnapping and underage sex?

Will Gazans be relocated to Europe?

What I am about to outline is quite disturbing. So much so, in fact, that I sincerely hope to be mistaken in the connections being drawn.

According to the European Commission's Migration and Home Affairs page, ethnic cleansing is defined as "Rendering an area ethnically homogeneous by using force or intimidation to remove from a given area persons of another ethnic or religious group, which is contrary to international law."

On July 24, 2025, veteran journalist and Pulitzer Prize winner Seymour Hersh published a piece suggesting that ethnic cleansing is precisely what Israeli government hardliners are planning to do with the people of Gaza. Coming just weeks after his June 19th piece, accurately outlining in advance America's June 22nd bombing of Iran, Hersh published A Future Gaza Without Gazans.

With the subheading "Israel's religious right unveils its fantasy plan for the zone after ethnic cleansing",



Hersh describes a presentation which was held in the Israeli Parliament on Tuesday July 22nd. He describes this presentation as "a formal plan for the future of Gaza—as seen by the religious right", which "was presented to a diverse group of Israeli legislators, rabbis, grieving family members of IDF soldiers lost in combat or in Hamas captivity, and security officials from Gaza."

Apparently the plan is called "The Riviera in Gaza—From Vision to Reality", and presents "a blueprint for a future in Gaza without the Palestinians who now are living and dying there." Hersh describes how the "meeting was headlined by two of Israel's most outspoken and controversial advocates for the settlement of Israeli citizens in Gaza: Finance Minister Bezalel

Smotrich and National Security Minister Itamar Ben-Gvir, a West Bank settler who has a long history of violent anti-Arab agitation and at least eight convictions for violent anti-Arab activities."

This is not some fringe meeting. Smotrich and Ben-Gvir not only hold two of the most

prominent ministerial posts in Netanyahu's government, they are leading figures holding up the coalition. As such, it is not an insignificant thing when they hold a publicised meeting outlining detailed plans for re-developing an ethnically cleansed Gaza.

Hersh outlines in detail the plans for this "Riviera in Gaza", using a report from one of the journalists at the meeting, which he then describes in no uncertain terms as "fantasy talk" that "evokes the worst of World War II." Although it may seem far-fetched to read about establishing "conference centres and high tech complexes", of building "an artificial island [...] off the coast of Gaza constructed from. . . war debris which will be used for trade and tourism", especially given Israel's economic woes, the initial process of ethnic cleansing does not seem unrealistic in the least.

In a June 16th piece for The Conversation on the UK government's decision to sanction Smotrich and Ben-Gvir, a senior lecturer in international politics at City Saint George's University of London, Leonie Fleischmann, argues that "The prominence of Ben-Gvir and Smotrich reflects a rightward shift in the Israeli electorate that has brought ultra-nationalist settler ideology into the mainstream." In a May 30th piece for The Atlantic, The Two Extremists Driving Israeli Policy, Gershom Gorenberg writes that Ben-Gvir and Smotrich "both want Israel to reoccupy all of Gaza, to renew Israeli settlement there," and to "encourage" the Palestinians who live there to emigrate. For a more expanded introduction to these two figures, one could watch the documentary published by ARTE, a public media broadcaster co-funded by the EU.

entitled Israel: Extremists
In Power.

So, the question begs: If those with an "ultra-na-

tionalist settler ideology" are successful in ethnically cleansing the native Arabs of Gaza from their homeland, where will Gazans go?

In February 2025, Israel Katz, a member of Netanyahu's Likud party and Israeli government defence minister, suggested that "Countries like Spain, Ireland, Norway, and others, which have falsely accused Israel over its actions in Gaza, are legally obligated to allow Gazans to enter their territory." This follows on from a November 2023 statement by Amichai Eliyahu, a member of Ben-Gvir's Jewish Power party and Israeli government heritage minister: "They can go to Ireland or deserts, the monsters in Gaza should find a solution by themselves."

Raw Egg Nationalist is taking such suggestions seriously. Raw Egg Nationalist is the pen name of Dr. Charles Cornish-Dale, an Oxford and Cambridge educated anthropologist. On July 23rd, the day before Hersh's article, Cornish-Dale published a piece outlining why the displaced Gazans are likely to end up in Europe.

"Since the very earliest days of the latest Israel-Hamas war," writes Cornish-Dale, "I've been warning that Israel's main objective is to displace as many of the Palestinians as possible—perhaps even all of them—from Gaza, and that the only place they'll end up, if this is allowed to happen, will be the West, most probably Europe. This remains a real risk. Actually, the risk is growing."

Cornish-Dale describes how neighbouring countries such as Egypt, Lebanon, and Jordan have no interest in taking Gazans, since previous "settlements of Palestinian refugees had radically destabilised every country in the region that had taken them". This means the Israelis needed to look further afield. In mid-July 2025, the director of Mossad visited Washington and "told White House special envoy Steve Witkoff that Ethiopia, Indonesia and Libya have expressed their willingness to take large numbers of Palestinians."

Raw Egg Nationalist isn't buying what Mossad is selling: "The real question (if Israel is going to persist in its plan) is where the Gazans will actually go. I don't believe for one second they'll go to Ethiopia, Indonesia and Libya. To me, this just looks like a clever bit of manipulation, intended to tug on the heartstrings of Western liberals and enrage the large numbers of Palestinians and Muslims who are already in the West and wield increasing political power." He reckons "Germany will probably be the first" Western government to step in, "then others will follow, chastened by her example."

Given the all-consuming Nazi guilt which seems to pathologically haunt the German establishment psyche, its unconditional support for Israel, and its anti-democratic persecution of immigration critical voices, it wouldn't be too surprising if Chancellor Merz was to channel the spirit of his predecessor and issue some redux of "Wir schaffen das" [We can do this].

Then again, France might get there first. In a July 15th piece for Brussels Signal, Anne-Laure Dufeal outlines a decision by France's National Asylum Court to allow the entire population of Gaza to apply for asylum. Soon after, in an article published the same day as Hersh's piece above, Le Monde's Jerusalem correspondent describes how the Israeli government openly aims to depopulate Gaza and how, since May, "polls have shown that between 70-80% of the Israeli Jewish population supports the idea of expelling Palestinians from Gaza". Later that day, President Macron announced that "I have decided that France will recognise the State of Palestine".

If one runs further with Cornish-Dale's line of speculation, perhaps the government of my home nation of Ireland will be among the first to assist in Gaza's ethnic cleansing. After all, in May 2024, Ireland broke ranks with most of the EU and joined Spain and Norway in formal recognition of the State of Palestine. On the surface, it may seem contradictory that they would support Palestinian

Statehood only to eventually assist in Gaza's ethnic cleansing. However, if instead of viewing their support for the Two State Solution as a sincere expression of solidarity, we were to view it as performative moralism and, by extension, as a means of distracting the Irish public from their incompetence in governing domestic affairs, such a contradiction disappears.

After all, why would the Irish government care about Palestinian political sovereignty when they don't even care about Ireland's? The choice to opt in to the EU Migration Pact, when they could have followed Denmark's example of charting a successfully independent course, epitomises their post-national inclinations. This was a despicable decision which Independent Parliamentarian Mattie McGrath described as "the single biggest transfer of sovereignty in the history of our State", and, "the greatest ever betrayal of the Irish people by their own members of parliament".

Here I question the motivations behind my government's support for Palestinian Statehood not as a post-national globalist, nor as a Zionist, but as an Irish nationalist who is appalled by Israel's ethnic cleansing and who supports the right to self-determination, on their own soil, of native Palestinian Arabs.

That said, as an Irishman loyal to his nation, I am also deeply concerned about the violent decay and social volatility evident not only here, which I've sketched elsewhere, but across our neighbours. Per capita crime statistics from places like Denmark, Sweden, Germany, and the UK are

tionately violent

To use my homeland as case study, our government has been totally ignoring the will of at least 75 per cent of the population who, for years now, have thought that immigration has gone too far – including people that feel political solutions are so hopeless they have resorted to perpetrating dozens of "arson attacks against planned, actual or rumoured" International Protection Accommodation Centres (IPAS). As dark portent of where these immigration driven tensions may escalate toward, the Irish police, the Gardaí, in order to battle totally unprecedented civil unrest, have recently purchased

water cannons.
Thanks to extremist immigration policy, we could well be witnessing, to borrow a term from Aris Roussinos over at Unherd, something akin to the "Ulsterisation" of the South.

So, despite Israeli brutality that even Brussels acknowledges,

it is fair to ask if those Europeans already reaching boiling point over reckless immigration, and over regime elites they perceive to hate them, will passively accept perhaps two million Palestinians into their dangerously fracturing societies?

Indeed Cornish-Dale, in referencing professor David Betz of Kings College London – a modern warfare expert previously interviewed in Brussels Signal by Ralph Schoellhammer – wonders if importing the population of Gaza would "help tip European societies into open civil war". Perhaps we are set to find out.

U.S. President Donald Trump said on August 1st that he has ordered two nuclear submarines to move close to Russia, citing social media comments by former Russian President Dmitry Medvedev. Trump announced the decision on his Truth Social platform, condemning Medvedev's "highly provocative" statements and claiming that "words are very important, and can often lead to unintended consequences... I have ordered two Nuclear Submarines to be positioned in the appropriate regions, just in case these foolish and inflammatory statements are more than just that." Trump has lately been locked in a bitter war of words on social media with Medvedev, who currently serves as deputy chairman of the Russian Security Council.

U.S. states and cities that boycott Israeli companies will be denied federal aid for natural disaster preparedness, the Trump administration has announced, tying routine federal funding to its political stance. The Federal Emergency Management Agency (FEMA) stated in grant notices posted on Friday that states must follow its "terms and conditions." Those conditions require they


certify they will not sever "commercial relations specifically with Israeli companies" to qualify for funding. The requirement applies to at least \$1.9 billion that states rely on to cover search-and-rescue equipment, emergency manager salaries, and backup power systems among other expenses, according to 11 agency grant notices reviewed by Reuters... In April, The Department of Homeland Security (the agency that oversees FEMA) said that boycotting Israel is prohibited for states and cities receiving its grant funds.

An orange shape was spotted on surveillance footage near Jeffrey Epstein's prison cell on the final night of his life - and forensic experts are questioning the federal government's explanation of the mysterious object. The shadowy object, seen in video obtained and reviewed by CBS News, moves up the stairs to Epstein's cell block at the Metropolitan Correctional Center around 10:40 p.m. the night before the 66-year-old convicted sex trafficker was found hanged. Federal investigators previously concluded the pixelated blob was a corrections officer "carrying linen or inmate clothing," but forensic experts who spoke to the network as part of an investigation into the jail video now suspect it may have actually been a jumpsuit clad inmate. "Based on the limited video, it's more likely a person in an [orange] uniform," Conor McCourt, a retired NYPD sergeant and forensic video expert, told CBS.

Danville, Virginia, City Councilman Lee Vogler was doused in gasoline and set on fire on July 30th. According to reports, the attacker was identified as Shotsie Michael Buck Hayes, 29, of Danville. Danville police said the attack appears to be personal and not related to Vogler's position as a city councilman... Showcase Magazine's Andrew Brooks said the attacker forced his way into the magazine's office as Vogler was visiting and poured a five-gallon container of gas on him. "Lee attempted to flee, ran to the front of the building," Brooks said in a Facebook video. "The individual followed him and set him on fire." Vogler was flown to the UNC burn unit in Chapel Hill..

A federal judge on July 28th completely blocked a provision of the Big, Beautiful Bill defunding abortion giant Planned Parenthood of taxpayer dollars through Medicaid. U.S. District Judge Indira Talwani (a President Obama appointee) granted a preliminary injunction, blocking the provision and essentially mandating Medicaid funding for all Planned Parenthood clinics as

litigation continues. Talwani released the expanded order after issuing an order last week only partially blocking the provision for a subset of clinics that did not inde-

President Trump signed an executive order July 24th calling on states and cities to end "endemic vagrancy" - and rehouse homeless people, including drug addicts and those suffering from mental problems, in "treatment centers." The order redirects federal funding to prioritize "shifting homeless individuals into long-term institutional settings for humane treatment through the appropriate use of civil commitment." On average, more than 274,000 people were sleeping on the streets each night last year under Joe Biden, the order says. "The overwhelming majority of these individuals are addicted to drugs, have a mental health disorder, or both," the document says.

On August 4th, Israel's Channel 12 correspondent Amit Segal reported,"Senior official in Netanyahu's office: The decision has been made — we're going to occupy Gaza... If we do not act now, hostages will die of starvation and Gaza will remain under Hamas control." It is clear that negotiations are off, as Prime Minister Netanyahu ordered an expanded ground incursion in central Gaza. With much of the Strip already decimated, and inhabitants on the verge of mass starvation, a big question has remained for Netanyahu: what's next? Hardline politicians in his own cabinet have called for the total removal of the Palestinian population, after President Trump months ago talked about turning the enclave into the 'Rivera of the Mediterranean'. Indeed a key question remains, will Trump back a plan of permanent Israeli military occupation? This would certainly open up the likelihood of eventual annexation of the territory.

A Firefighter's Final Alarm: How Medical Neglect and Toxic Foam

The death of a veteran exposes the dangers of PFAS, failures in healthcare, and the urgent need for safer firefighting solutions.

GOLDEN VALLEY, AZ — Anthony Loya served as a firefighter in the U.S. Air Force, bravely battling blazes with the help of a highly effective but now-infamous firefighting foam. That foam, known as AFFF (aqueous film-forming foam), contained PFAS—so-called "forever chemicals" that have been linked to a myriad of serious illnesses including multiple types of cancer. For Anthony, the cost of service was steep: just as he was nearing retirement at 64, he was diagnosed with stage 4 colorectal cancer that had metastasized to his stomach.

On January 2, 2025, too ill to drive himself, Anthony had a friend transport him to Kaiser Permanente in Ontario, California, where he had been undergoing radiation treatments in an effort to control the cancers ravaging his body. He expected to be treated for severe abdominal pain. Despite his complex medical history—firefighter, PFAS exposure, metastatic cancer, prior intestinal distress due to cancer and, now, experiencing a complete blockage - he was 'treated' with laxatives. Within 48 hours, Anthony's bowel ruptured, he became septic, and he died at 1 a.m. January 4, 2025.

"Anthony's chart was a neon sign-Firefighter, PFAS exposure, metastatic cancer, prior intestinal surgeries," said his father, George Loya. "They answered that with laxatives. It's so absurd — borderline cruel."

Kaiser typically declines to discuss specifics, citing patient-privacy law. The standard answer, "We are



reviewing the clinical course to ensure all protocols were followed," is essentially the response obtained by family

members attempting to discern how - and why — Anthony was failed by those he had trusted with his healthcare.

Medical experts say laxatives are ordinarily contraindicated for latestage colorectal cancer patients showing signs of obstruction. "In patients with cancer experiencing a bowel (intestinal obstruction) using laxatives — especially those

that stimulate peristalsis [movement throughout the system] when a tumor is present can elevate pressure and ultimately perforate the colon," noted a close relative. "With his history, immediate imaging and potential surgical decompression — NOT cathartics should have been the default."

Research shows that clinicians often underestimate how aggressive PFAS-associated cancers can behave. This can also be a determining factor in how fast they spread. "There's still a knowledge gap. Providers trained before 2015 may have never heard of AFFF or its carcinogenic profile. Of the many options available to hospital personnel, the use of laxatives were widely known to be inappropriate and unnecessarily dangerous."

George Loya's voice echoed these same concerns: "Had they utilized proper protocol, the pressure would have been relieved and I believe my son would be alive today," he stated.

Anthony's story is not an isolated tragedy. PFAS chemicals have been used for decades in firefight-





break down in the environment, leading to widespread contamination of soil and water wherever they've been used. Communities near these sites have discovered PFAS in their drinking water, and firefighters themselves face elevated risks of cancer and other diseases.

One woman, a scientist and government employee, lost her entire career

> after being tasked with researching the PFAS issue for the Minnesota Pollution Control Agency nearly 20 years ago — during the period from 1989 to 2006. Dr. Fardin Oliaei discovered what is considered to be 'common knowledge' today — that there was widespread PFAS contamination happening throughout the state of

Minnesota and beyond.

Her work came to involve the discovery of PFAS contaminated fish in Minnesota lakes and waterways, including state parks. "It was like there was more PFAS running in these fish than blood," she reported. "They didn't want to hear it. I was forced to resign my position."

Dr. Oliaei's position was ultimately 'defunded' when Chervl Corrigan took over as the MPCA Commissioner in the early 2000's and Oliaei requested \$144,000 to expand research efforts that would show where the contamination was occurring and, hopefully, how it had spread. When her initial request was denied, Oliaei asked for a mere \$14,000 to continue her research — which Corrigan also denied. Deposed in 2012, Corrigan stated that the MPCA was a 'regulatory agency' and, therefore, not a research entity.

Today, in the face of criticism by, among others, the Minnesota Attorney General for this statement, Corrigan refuses to be interviewed on the topic.

Dr. Oliaei instead found an audience in the media. One of the most widely acclaimed 'Whistleblower' lawsuits in history, the state of Minnesota ultimately paid \$325,000.00 to settle the case. Dr. Oliaei would never again work in the field of government research and the PFAS contamination remained intentionally and virtually quashed. Still, she is credited with lifting the lid on the entire PFAS issue, and her honest and ethical approach to sharing her investigations has been lauded as having brought about a monumental shift in public awareness.

3M has been sued thousands of times, including by the State of Minnesota. While the company has agreed to pay over \$14 billion dollars in settlements, they continue to manufacture PFAS chemicals — a practice that continues today in spite of readily available, similarly priced and far safer alternatives.

A breakdown showing just some of the related diseases provides additional insight into the severity of this widespread issue. These toxins in the environment are now known as 'causative agents' behind the burgeoning numbers suffering from chronic and even terminal ailments.

According to an American Cancer Society brief last year, firefighters are 9% more likely to develop colorectal and testicular cancer than the general population. For military firefighters, the risk rises to 18%,

correlating with longer PFAS exposure durations. Other cancers that appear to be PFAS related include breast, kidney, ovarian and endometrial, prostate, lymphoma and thyroid cancers as well as childhood leukemia. Further, this list is not considered to be exhaustive as new

information continues to become available.

Defense Department data released in 2024 confirm PFAS contamination at 707 U.S. bases, with groundwater readings up to

2.1 million parts per trillion—30,000 times the EPA's new 70 ppt drinking-water limit. An International Association of Fire Fighters (IAFF) survey of 29,000 members found that 66% had never been informed of PFAS hazards during training prior to 2018.

"These chemicals don't degrade. They bioaccumulate," said Linda Birnbaum, former director of the National Institute of Environmental Health Sciences. "Every gallon

of AFFF used 30 years ago is still haunting someone's water table today."

The environmental impact is staggering. In communities from Oscoda, Michigan, to Fresno, California, residents have

discovered PFAS in their wells and local waterways, often years after

the last use of firefighting foam. The contamination is not just a legacy issue; it is an ongoing crisis, with new sites being identified every year.

Despite the well-documented dangers, PFAS-containing foams are still in use in many places. This is especially troubling given that alter-

native, PFAS-free foaming agents not only exist — they are already in use in many countries and industries. These alternatives are effective and do not carry the same long-term

health and environmental risks.

Fluorine-free foams (often labeled F3) that meet international performance standards have been commercially available for a decade. Airports in Paris, Sydney, and Copenhagen switched years ago. The U.S. Department of Defense, however, long insisted on its own specifications, which until 2023 required PFAS chemistry. Congress finally ordered DOD to phase out AFFF by October 1, 2026, but budget and

testing slow-rolls have hampered uptake.

Cost is no longer a major obstacle. A 5-gallon pail of F3 retails around \$155—within \$10 of legacy AFFF. Cleanup of a single PFAS-contaminated fire-training pit, by contrast, can top \$30 million.

"Like asbestos, everyone agrees PFAS foams are bad," said Senator



Tammy Duckworth (D-IL), who sits on the Senate Armed Services Committee. "But agencies keep carving out exceptions. Each extension means more poisoned groundwater and more cases [like Anthony's]."

California banned new sales

of PFAS firefighting foam on January 1, 2024; legacy stocks must be disposed of by 2028. [Used? Destroyed?] The European Chemicals Agency (ECHA) proposes a bloc-wide prohibition by 2026, with no exemptions for airports. FAA guidance now "strongly encourages" F3 use, yet many of the nation's 500+ commercial airports still rely on AFFF because the advisory is non-binding.

As the dangers of PFAS become more widely recognized, a growing number of families like the Loyas are seeking justice in court. Across the country, hundreds of lawsuits have been filed against chemical manufacturers, foam producers, and even government agencies. Law firms specializing in toxic torts report a surge in inquiries from firefighters, military veterans, and their

families who believe PFAS exposure contributed to their cancers and other illnesses.

"Every week, we're contacted by new

families devastated by PFAS-related disease," stated an attorney whose firm represents dozens of former firefighters. "The science is clear, the industry knew the risks, yet these chemicals were allowed to poison workers and communities for decades. The legal system is now the only avenue for accountability."

The Loya family plans to file a wrongful-death claim alleging medical negligence and is considering a product-liability suit against foam manufacturers Chemours and 3M. Both firms settled similar claims last year for \$12.5 billion with public water utilities but admitted



no wrongdoing and continue selling PFAS-based products overseas. For Geoge Loya, the loss of his only son is incomprehensible. "We had great plans to spend our later years together, traveling the Arizona outback doing the things we never somehow never found the time to accomplish. I miss him every day."

Now, he fights for justice on Anthony's behalf. "It won't bring my son back," he said, "but maybe it forces two conversations: Doctors need to take PFAS histories seriously, and fire services need to ditch these chemicals yesterday."

For the Loya family, change cannot come fast enough. "It was the exposure to these chemicals and

ill-informed, misguided treatment efforts at the hands of a hospital that killed him."

The tragedy of Anthony Loya's death

is a call to action: for better medical awareness of PFAS-related risks, for the immediate transition to safer firefighting foams, and for accountability for the contamination that has already occurred. No more firefighters — or their families — should have to suffer the consequences of preventable chemical exposure and medical neglect.

"It's unconscionable that these killer chemicals are still in use today when there are alternatives readily available that could massively reduce the dangers firefighters face," George stated. "What, in God's name, are they waiting for?"

A License for That? Will online safety cost us our digital liberties?

The impacts of a two-year-old law are finally being felt in Britain and, as the United States looks to

pass its own Kids Online Safety Act (KOSA), it should watch the unfolding situation with fear.

The Online Safety Act (2023) was passed by the previous Conservative government under Prime Minister Rishi Sunak. The legislative process began in February 2022, under Sunak's predecessor-buttwo, Boris Johnson. Implementation was delayed for an extensive period of time, largely due to controversy and logistics surrounding the law. The Office for Communications (Ofcom) laid out a roadmap for enforcement in October 2024, a full year after the law was passed.

As is usually the case, a law steeped in respectable aims—protecting children from harmful content—has rapidly revealed itself as a nefarious tool of control. Nobody wants children to view pornographic content. That is hardly a controversial position. Yet so often the tools of authoritarianism are sold under the guise of protection. The echoes of Benjamin Franklin's warning against sacrificing a little liberty for a little temporary safety ring louder in the Internet era;

what was once the digital Wild West has become sanitized, watched, and regulated. Lurking behind the

existence of the law itself is the question of who is actually responsible for the content that children view online—the government, the platforms, or—as seems to have been forgotten—their parents?

The Online Safety Act began with a reasonable goal: requiring platforms to remove content that was already illegal, such as child abuse or images that glorify or encourage self-harm. However, the rationale (as explained by the government's own "Online Safety Act Explainer") was to make Britain "the safest place in the world to be online" by making platforms legally responsible for the content their users post. Even at the outset, the practicalities of forcing international corporations to police global content on behalf of a national government were pointed out as practically impossible. Yet the law quickly transformed into justifying the restraints on adults in the name of increased transparency.

When the law partly came into effect on July 24th, the immediate reaction both in the UK and abroad focused on the limits on porno-

graphic content. Major websites such as Pornhub, to the Not Safe for Work (NSFW) sections of major forums like Reddit, were affected. These restrictions digitized existing limits of content via Section 12 of the Act, through age verification procedures that now require users to upload a selfie alongside a government-issued ID, such as a driving license.

How exactly is this data to be stored, when it will be deleted, and the use of it in the meantime is not clear. This leads to significant questions over the security of these websites and how damaging a leak might be. Moreover, the timing of the implementation of this law coincided with a public relations disaster for a popular app—Tea. Designed for women to share dating advice, Tea faced a major data breach. Not only was its user base revealed (verified using the same process of a selfie paired with a government ID), but the platform also was discovered to be hosting images of other people (i.e., non-users) without their consent. It is deeply embarrassing for the government's chosen method of user verification to be shown up as dangerously insecure and unreliable in the same week.

The sinister consequences of the Online Safety Act go far beyond pornographic content. The real danger lies alongside the implications of the vagaries behind "harmful content."

Almost the exact same week as the law implementation, the UK saw widespread protests and near-riots in towns such as Epping and Diss, and even in cities like Leeds. These demonstrations, largely led by mothers and local residents over the sexual assault



and harassment of young girls by asylum seekers and refugees in nearby hotels, quickly spread, and are still bubbling away in small towns.

Not that you would know this. The Online Safety Act has enabled censorship of footage of such protests on major platforms like X, on the basis that the footage could incite harm or encourage violence. This is not without precedent—the Arab Spring was considered to be the first "digital revolution" due to the role social media played in the spread of the revolution across the MENA region.

Of course, you could always use Virtual Privacy Networks (VPNs) to circumvent these restrictions. Registrations for VPNs in Britain have skyrocketed in the last week, as citizens attempt to overcome the new law—for as long as the government will allow it. And while it might be a meme to joke about needing "a license for that" in the UK, Americans should take note of their own government's attempts to introduce similar limitations to the Internet. After all, the words of another founding father must be remembered: The price of freedom is eternal vigilance.

> The national debt is over 37 trillion dollars and rising. Yet few in Congress are serious about cutting federal spending. This puts pressure on the Fed to keep interest rates low to limit the cost of ongoing debt interest payments. So, the Fed continues monetizing the debt, pumping more money into the economy, weakening the dollar's purchasing power, and eroding the American people's standard of living. The Federal Reserve's low interest rate policy also distorts the market, leading to the bubbleboom-and-bust business cycle that has plagued the American economy since the last link between the dollar and gold was severed in 1971.

The Fed's job is also made more

difficult by a reduced demand for Treasury securities among investors, causing the Fed to increase its purchases. This pumps more money into the economy, further eroding the dollar's value.

Concerns about the national debt's effect on monetary policy are a key factor behind the recent increase in gold prices and the interest in cryptocurrencies. The danger posed by the

national debt is one reason why foreign countries are increasing their gold holdings and considering challenging the US dollar's world reserve currency status.

Instead, he could try increasing rates to limit price increases thus raising the cost of managing government (and private sector) debt to unsustainable levels, throwing the economy

into a severe downturn.

Congress members and President Trump are attacking Chairman Powell for spending over two billion dollars on Federal Reserve headquarters renovations. This is a waste of taxpayer money, but it pales in comparison to the harm suffered by the American people because of the Federal Reserve's inflationary policies.

Treasury Secretary Bessent has suggested expanding the investigation beyond the costs of renovating the Fed headquarters to examination of "the entire Federal Reserve institution" to determine if the Fed has "succeeded in its mission." This suggests Secretary Bessent would support passing the Audit the Fed legislation, which is a step toward returning to a constitutional and sound monetary policy. However, anyone who understands Austrian economics knows a fiat money system managed by a secretive central bank can never succeed in creating lasting prosperity and will eventually crash the economy.

No person or persons can know the "correct" interest rates, and the Federal Reserve's attempts to control interest rates are destructive like other central planning. The proper answer to who should be Fed chairman is — nobody.



Things They Didn't Teach You in Church: **Two Moments in History**

There are certain moments in time that ultimately define and memorialize what was happening at that time in history. I believe one of those moments occurred at 6:11 pm on July 13, 2024, in a small town in western Pennsylvania. The event not only spawned one of the most iconic pictures of all time but I believe it also cemented the result of that year's presidential election. A book was released just in time for the 1-year anniversary of that event, and I decided to read it. The book is named after the town where the event took place: Butler. The book was written by Salena Zito (a well-known Pennsylvania journalist) who has known Donald Trump for years and was standing just a few feet away from him when a bullet creased his ear. The book was good and very informative. I would recommend it, especially to any history-buffs. The most impactful part of the book for me, was the introduction. It motivated me to write this article.

There's an old saying, "history repeats itself' and we should learn from history. The Bible supports this idea, one example: 2 Peter 2:6 And turning the cities of Sodom and Gomorrah into ashes condemned them with an overthrow, making them an ensample unto those that after should live ungodly; Butler PA provides us with a striking example of history repeating itself and involves something I had never heard about before.

In 1753, French activity in the New World caught the attention of the British, who saw these French actions as a violation of treaties designating the valuable territory as part of Virginia and the Pennsylvania colonies. Robert Dinwiddie, the lieutenant governor of Virginia at the time, sent a 21-year-old major to deliver a cease-and-desist order,

demanding the French abandon their newly constructed forts in the territory. This area was known as Connoquenessing and the Butler Farm Show Grounds, where the Trump assignation attempt took place, is in the Connoquenessing Township. The Trump assassination attempt took place in the same location this young 21-year-old British major, sent to confront the French, was nearly assassinated.

Martin O'Brien, a 94-year-old Pennsylvania historian, reported that this incident represents a "gigantic step in American history.... We have a great piece of history, which is overlooked by almost everybody.... the British, when they settled Virginia, thought their claim went to the ends of the Earth." According to O'Brien, "the French laid claim to regions in Pennsylvania...So there was a dispute between England and France as to whose territory that was.... course, the Native Americans felt it was theirs, and they resented having the French and/or British there. claiming the property."



Rodney Gasch, president of Historic Harmony, said the two representatives of Britain were ".... sent through western Pennsylvania to Fort Le Boeuf — to assert the British claim." He added, "Essentially the French are saying, 'This is our land, and England needs to stay out of New France." After a contentious meeting with the French, the two British representatives took a "shortcut" back to Virginia on foot. They

were met by a Native American guide who offered to carry their supplies and lead them. "Initially," said Gasch, "they're happy to have the assistance, but they get suspicious that the guy is not leading them in the direct way,"

On December 27, 1753, over 270 years ago, at this same location, Butler PA, this British major was nearly shot by the French Indian guide, and the fate of the US dodged


a bullet as well. This British major was accompanied, on this trip to confront the French, by American colonial explorer and military scout Christopher Gist. The guide's behavior grew increasingly suspicious, causing the men to become uneasy, and as the party approached a clearing, the guide suddenly stopped, turned towards the British men, and fired his musket. The shot, taken no more than 15

steps away, narrowly missed both men. A monument now stands at the Connoquenessing Township Municipal Building dedicated to this incident. According to Martin O'Brien, the Daughters of the American Revolution pinpointed the site of the shooting and erected the monument in 1926.

What a coincidence! Two historical attempted assassinations in virtually the same place, some 270 years apart. In the spirit of full disclosure, I don't believe in coincidences. What amazes me most is the identity of this 21-year-old

British major. His name was George Washington.

According to the writings of his companion Christopher Gist, Washington was spared, by a miss of not much more than an inch, from the assassin's bullet. Otherwise, he would have laid dead on the ground that evening. This all sounds eerily familiar, had Donald Trump not slightly moved his head to look at a chart, one that reportedly



had never been used so early in a Trump rally before, he would have laid dead on that stage in Butler PA. George Washington would go on to become the 1st President of the United States, and Donald Trump would go on to become the 47th President of the United States. There has been some speculation about Trump being saved by the hand of God that day in Butler PA, I hope you'll consider the possibility that the same divine hand intervened in 1753. This country was formed on biblical ideas and principles such as unalienable rights, moral order and the rule of law. They told you it was science. They told you it was progress, but behind closed doors, the scalpel was a weapon, the syringe a poisoned Trojan horse and the test subjects expendable.

1845 Alabama, Jim Marion Sims, the so-called Father of gynecology, straps down enslaved black women, no anesthesia, no consent, 30 operations, 30 screams, muted by history. His journals admit it. "Lucy nearly died today, but we must proceed." The US Medical establishment funded his butchery then enshrined him as a hero.



Then came Tuskegee, 1932, the Public Health Service alongside the CDC, lured 600 Black Men with free treatment. 400 already had syphilis. The Cure penicillin was deliberately withheld. The 1950s, Puerto Rico became a laboratory. Poor women, some illiterate, some coerced, fed experimental birth control pills for testing by big pharma. They suffered seizures, hemorrhages. Some called it population control. Victims called it genocide. Decades later, those same players would push vaccines with catastrophic fertility, side effects. History is a spiral.

World war two ended, but the Pentagon's war on its own soldiers had just begun. At Edgewood Arsenal,



secret documents reveal that over 60,000 troops were exposed to sarin gas, VX nerve gas and LSD. One veteran's handwritten note read: "they told us it was harmless. I held my seizing friend as he vomited blood." The truth was only declassified after 80% of the victims were already dead.

In September 1950, the US Navy operated aerosolized sprayers. They hummed over San Francisco pumping saratia marcissen bacteria into the fog. Aerosolized chemtrail event later linked to fatal pneumonia. The hospitals overflowed. The whistleblower's report was buried until the 1976 Senate hearing that forced the admission.

Then there was Operation Big Buzz. 1955 the Pentagon released millions of weaponized mosquitoes in Florida, testing how quickly they could infect a population. Malaria like cases spiked, internal memos bragged: "subjects exhibited symptoms within 72 hours" no warning, no cure.

The Pentagon also turned soldiers into lab rats. Operation White Coat infected 1000s with biological agents. One veteran testified: "They told us it was harmless. Now my body's failing." It was classified as national security, no compensation, no justice.

Even vaccines became weapons. Millions of Americans were injected with SV 40, a monkey virus linked to cancer. The CDC buried the truth for 40 years. How many died? The numbers are buried under redacted reports. We'll never know. In 1977 we learned that from New York to St Louis, military planes sprayed mock bio weapons on civilian cities. The goal to study how quickly a lethal pathogen could spread by being aerosolized, dropped on the population. Who were the victims? Un-

consenting civilians.

Long before MK Ultra, before Plum Island, there were the Tuskegee syphilis experiments, the deliberate infection of hundreds of black men, the lie of free treatment, medicine was withheld, and they suffered for decades while the CDC watched and recorded their deterioration to extract medical data as they suffered and died. It was buried and classified files denied until the bodies piled too high to ignore.

Then came Operation Sea Spray, 1950. The Pentagon turned an American city into a test lab, human guinea pigs. That's what they called them. At Vanderbilt, pregnant women drank vitamin cocktails laced with radioactive iron and their babies? They were stillborn or deformed. The files were sealed for 50 years. It was all part of government research.

Then there were the Fernald School Science Club experiments. Orphans were fed radioactive milk by MIT researchers (smiling for the cameras.) Unknowingly, they signed their own death warrants, and when the truth came out, they were told there were no long term consequences, but the graves of the victims tell another story.

The 10th Amendment to the U.S. Constitution reserves all powers not delegated to the federal government to the states or the people, not to international courts or the federal government acting under UN direction. Australia Pays Women Up to \$22,000 for Aborting Their Babies After 20 Weeks

The Australian government is paying women as much as \$22,000 (US\$14,000) to abort their unborn children after 20 weeks' gestation. In a July 2 letter leaked to Australian pro-life advocate Dr. Joanna Howe, Senator Katy Gallagher, a member of Prime Minister Anthony Albanese's cabinet, confirmed that a woman who intentionally aborted her child would be eligible for a \$4,255 (US\$2,752) Stillborn Baby Payment. Additionally, that same woman could apply for up to \$22,754 (US\$14,714) in Parental Leave Pay. Both Albanese and Gallagher are members of the Labor Party.

Midwives' Tales

According to the Daily Declaration, which describes itself as "Australia's Largest Christian News Site," Howe first reported on the abortion payout in June based on information from "at least two medical personnel": "One is a South Australian hospital administrator who said midwives are "traumatized and shocked" by the rise in late-term abortions of healthy babies. She revealed staff are being effectively "forced to sign off on Centrelink [Australia's social-security agency] forms" so women can claim payments — a process adding "a double level of trauma" by co-opting them into a system that financially rewards elective abortions.

The second is a midwife who described a traumatic late-term abortion in which the mother stated she would use her aborted baby bonus to fund a holiday to Bali — a remark that left the midwife in tears after delivering the baby stillborn.

As Dr. Howe explains, her sources are forced to remain anonymous because whistle-blower protections in Australia

only apply to those exposing illegal activity. And, since both late-term abortion and claiming Centrelink payments for them are legal, medical staff who speak out about what they're witnessing risk losing their jobs."

At the time, Howe had only these anonymous reports plus inferences drawn from the website of Services Australia, the country's overarching social-services agency. Regarding the Stillborn Birth Payment, the website reads: "To be eligible for our payments, a stillbirth needs to meet our definition. A stillborn baby is one who had not

breathed since delivery and had no heartbeat after birth. To be considered stillborn, a baby also had to have a gestation period of at least 20 weeks or weighed at least 400 grams [14 ounces] at their birth."

Obviously, a baby aborted after 20 weeks would qualify as stillborn under that definition, making the baby's mother eligible for the Stillborn Baby Payment. Moreover, Services Australia says the mother of a stillborn (under the same definition) can opt for Parental Leave Pay as well.

Admission Letter

The "definitive proof" of Howe's hunch arrived, she said, in the form of the leaked letter. Written on Gallagher's behalf by Ministerial and Parliamentary Services Director Kathy Stevens, the letter stated bluntly: "The eligibility criteria for Stillborn Baby Payment do not exclude circumstances where the stillbirth was due to a medical termination, including an intentional abortion." In other words, kill your baby, and hit the tax-payer-funded jackpot.

According to Howe: "Killing a baby after 20 weeks and up until birth entails injecting the baby's heart with potassium chloride or digoxin and is followed by the early induction of labor


of that now stillborn baby."

In her letter, Stevens went on to explain that either the "mother or their partner" would be eligible for benefits "provided the child has been certified by a qualified med-

ical practitioner as having been delivered and the definition of a stillborn child is met." She then cited Services Australia's definition of stillborn.

"A woman who has an intentional abortion — or even a man who forces a woman to have an intentional abortion — the Labor government will pay them \$4,200," said Howe. "It's a dead-baby bonus for late-term abortions, paid for by all of us."

Referring to former Prime Minister John Howard, Howe wrote: "The Howard Government's



Baby Bonus was criticized because it incentivized teen pregnancies. This is far, far worse. Instead of receiving a \$5000 cash payment for birthing a baby at full term, the Albanese Government is now incentivizing late-term abortion in half the time."

That a Labor government would promote abortion is no shock. Gallagher is a member of pro-abortion activist organization EMILY's List Australia and signed a pro-abortion pledge to obtain the group's backing in her 2019 Senate run.

News Speak? No, Newspeak

Australia's mainstream media has, of course, been notably uninterested in the pay-to-abort revelations. The Daily Declaration's Kurt Mahlburg wrote last Friday: "With the exception of a single article in The Advertiser last year, the legacy press is refusing to touch this story — a curious silence given the overwhelming public interest in the scandal: an X thread I published on Wednesday [July 23rd] has almost reached 1 million views."

The Daily Declaration, however, isn't about to let it go. Columnist Mark Powell, for instance, had this to say: "In the dystopian classic 1984, George Orwell coined the term "newspeak," a fictional language for the totalitarian state of Oceania. By re-defining the meaning of words, the government could exert complete control over its citizens....

As we can all see now, Orwell was not only a brilliant novelist, but also very prescient.... But not even he could have envisioned a situation where a "baby bonus" would be paid to a mother for killing her baby or a Paid Parental Leave payment be given after one decided to not actually be a mother. And the fact that the political party responsible for this perversion is called the "Labor" Party just beggars belief."

The virus used to develop Japan's new H5N1 bird flu vaccine does not exist in nature—it was built in a lab.

According to a new study published last week in NPJ

Vaccines, Japanese researchers engineered an entirely new strain of bird flu, combining the genetic material of two separate wild viruses to create what they call Vac-3: a pathogen that is "a reassortant virus between A/ duck/Hokkaido/101/2004 (H5N3) and A/duck/Hokkaido/262/2004 (H6N1)."

This lab-built virus—A/duck/Hokkaido/Vac-3/2007 (H5N1)—was never observed in nature. It was artificially assembled, grown in eggs, concentrated, and inactivated with formalin to become the whole-particle vaccine used in long-term testing on nonhuman primates.

The new study comes after NIH-funded researchers at the University of Georgia, Mount Sinai, and Texas Biomed were caught engineering lab-made H5N1 bird flu

viruses (one of which killed 100% of exposed mammals) using synthetic DNA constructs and then deliberately infecting live dairy cows. All under the same \$59 million federal contract that has

also been tied to mammal-adapted, drug-resistant strain development.

Japan is also working with U.S. scientists on other projects to build lab-made horse-human influenza hybrids that replicate 100 times faster than natural strains using aborted fetal cells engineered with the cancer-linked SV40 virus, also under the banner of vaccine development.

All of these developments raise fears that another man-made pandemic is on the horizon, as Congress, the White House, the Department of Energy, the FBI, and the CIA have acknowledged that a lab-related incident involving gain-of-function research is most likely the origin of COVID-19.

Sex-trafficking of children in the US is far more extensive than Epstein's operation. Principally, the sex-trafficking of illegal alien children. The new Japanese paper highlights that this bird flu Frankenvirus triggered significantly stronger immune responses than existing flu vaccines. It did so by retaining its full genetic structure, including viral RNA, which stimulated toll-like receptor 7 (TLR7) and a cascade of innate immune activation.

"WPVs contain single-stranded viral RNAs that stimulate innate immune receptors such as toll-like receptor 7," the authors write. This means the lab-built virus was left fully intact so it could shock the immune system into overdrive, triggering a much stronger reaction than normal flu shots.

Unlike conventional "split" vaccines, which separate viral proteins from RNA, Japan's whole-particle vaccine (WPV) preserved the virus's full anatomy. This allowed it to activate dendritic cells, induce interferon-producing T cells, and stimulate somatic hypermutation—a powerful, but risky, rewiring of the immune system. In short, the new virus didn't just train the immune system—it reprogrammed it.

Gain-of-Function Without Calling It That

While the researchers don't use the phrase "gain-of-function" that's effectively what this is: the creation of a chimeric virus with novel immunological features. The Vac-3 strain was not isolated in the wild. It was constructed by merging influenza genes from unrelated alleged viruses, giving the final product new, enhanced abilities—especially in triggering memory immune responses.

American Academy of Pediatrics Calls for End of All **Religious Exemptions**

The ability to practice one's sincere religious beliefs is woven into the very fabric of America and its founding ethos, yet the American Academy of Pediatrics (AAP), a membership organization focusing on pediatricians, just declared war on this bedrock right.

Besides being morally objectionable, the concept is just plain unpopular in modern America. By 2023, only six U.S. states officially denied parents religious exemptions to vaccination for their children via laws that were enacted in the face of massive opposition from the public.

Since then, two of the states (Mississippi and West Virginia) have seen their religious denial laws overturned by court wins from the Informed Consent Action Network's legal team, in which judges deemed such laws to violate the First Amendment.

Meanwhile, public pushback saw Hawaii as the latest state to defeat a bill that would have removed its religious exemption option. AAP's new policy paper has stepped in with an attempt to stop the momentum of religious freedom in the medical and public health space – an idea whose time has come.

"The AAP recommends that all states, territories, and the District of Columbia eliminate all nonmedical exemptions from immunizations as a condition of school attendance."

With a flowery mission to 'attain optimal physical, mental, and social health and well-being for all infants, children, adolescents, and young adults,' AAP fashions itself more as a continuous pipeline for industry products through overreaching, anti-science edicts. The AAP recently floated a law-

suit against HHS Secretary Kennedy for his recommendation to remove pregnant women and healthy children from the COVID-19 vac-

Let's take a look at some of AAP's greatest hits over the last 5 years.

cine schedule.

In 2019, Washington D.C.'s B23-0171 (later named D.C.

Law 23-193) sought to add a new section into the existing regulations that would allow a minor child to consent to receive a vaccine. The bill, and its hearing, signaled a new high-water mark towards the removal of parents from some of their children's most important medical decisions – and AAP was there.

During the public hearing before it was signed into law, pediatrician Dr. Helene Felman, representing Washington, D.C.'s chapter of the American Academy of Pediatrics (AAP), stated: "As a pediatrician, I like the legislation as it stands

because it offers the opportunity to capture those young adults who can make informed decisions at technically any age."



ry halting D.C.'s overreach saw a D.C. district judge issue a preliminary injunction against the

act in favor of parents who brought suit. The parents filed complaints and were able to demonstrate that the act likely violates federal law.

Next up, AAP was on the wrong side of the push, against clear scientific evidence, to medically transition children. Norway, Sweden, Denmark, the U.K., and other countries officially backed off the practice. A 2025 review by HHS of the evidence and best practices found significant risks associated with gender dysphoria treatments. One of the authors of the paper stated simply: "...No reliable research indicates that these treat-

ments are beneficial to minors' mental health."

In 2023, AAP reaffirmed its stance in a policy paper arguing for youth to have open access to gender-affirming health care fully funded by health insurance.


Finally, the AAP worked to influence public policy by advocating for new injectable weight loss drugs for children. "Children struggling with obesity should be evaluated and treated early and aggressively, including with medications for kids as young as 12 and surgery for those as young as 13, according to new guidelines released Monday."

The newly discovered harms of such drugs are unfolding on a weekly basis but that didn't seem to matter to the AAP. As an industry mouthpiece that sees children as a profit margin and pipeline demographic for drugs and shots, AAP is unmatched in its corporate 'advocacy.'

The organization appears to have chosen another losing battle, siding against religious freedom in the United States of America, and with it a further loss of relevancy for the organization.

A Silent Tragedy: Genocide of Christians in the 21st Century

In 2025, the global suffering of Christians has reached harrowing proportions. Estimates suggest that over 380 million Christians now endure "high levels of persecution and discrimination" simply for their faith—equating to roughly one in every seven Christians worldwide. Among them, thousands have been systematically killed, displaced, or imprisoned in what international observers increasingly describe as acts bearing genocidal intent.

Nigeria: Heart of a Deadly Campaign

Nigeria stands at the epicenter of this crisis. Between October 2023 and September 2024, over 3,100 Christians were killed, nearly 2,830 abducted, and more than 3.3 million internally displaced, most from Christian communities. In one of the most horrific incidents, Fulani extremists and affiliated jihadist groups massacred more than 100 Christians in Yelwata on June 13-14, 2025—some burned alive, others shot (children among them) and some were internally displaced and sheltered at a Catholic mission. This wave of violence has driven commentators to a chilling designation: "a jihadist genocide" targeting Christian villagers.

Democratic Republic of Congo: Beheadings in Mata's Church On February 12, 2025, militants

from the Islamic State-aligned Allied Democratic Forces (ADF) abducted at least 70 Christian civilians in North Kivu, dragging them into a Protestant church in Kasanga and executing them by machete—women, children, elderly among the victims. Soon after, on July 30, 2025, the same group stormed a youth gathering in Komanda, killing 43 (including nine children) in another calculated attack on believers worshiping together.



Pakistan and India: Laws Used as Weapons

Christians are also under siege across South Asia. In Pakistan, forced conversions, mob violence, and legal oppression persist: Christians have been beaten or killed for resisting conversion, and girl children are especially vulnerable to rape under coercive conditions. In India, Hindu extremist mobs have orchestrated forced conversion threats and incitements to kill Christian families in states like Chhattisgarh, while church buildings in Manipur have been burned,

leaving communities displaced and traumatized.

North Korea: The Hidden Death **Camps**

Perhaps most extreme is North Korea, ranked number one in global indices of Christian persecution. Between 50,000 and 70,000 Christians remain in brutal prison camps—detained for practicing or owning religious materials. The regime regards Christianity as political treason, punishable by torture or execution, in order to preserve the regime's ideological control.

Measuring the Crisis

While not all incidents meet the strict legal definition of genocide, many of these attacks display core hallmarks:

- * 'Intentional targeting' of persons because of religious identity
- * 'Systematic and widespread violence' over months or years
- * 'Destruction of communities', including displacement and property destruction
- * 'State inaction or complicity', particularly in Nigeria and the Congo

Legal and human rights organizations increasingly urge international recognition of these atrocities as religious genocide. Yet global media and diplomatic responses remain muted, especially compared to other crises.

The Human Toll and Response

Beyond numbers lies human suffering: children torn from families, pastors executed, congregations fearful

Yet local and international faithbased organizations continue relief efforts—providing shelter, trauma care, legal advocacy, and documenting violations for future accountabil-

The moral imperative is clear: these Christians are not collateral damage in broader conflicts—they are deliberate targets in campaigns of terror. Their story deserves global attention. From Nigeria's central belt to the jungles of eastern Congo, from the forced conversions of South Asia to North Korea's hidden gulags, Christians are facing organized, identity-based violence at staggering scale. Whether or not every episode is legally defined as "genocide," the evidence of intentional destruction is undeniable. To confront this global crisis, we must bear witness, demand accountability, and uphold religious freedom as a universal human right.

A White House Executive Order from May 2025 defines "dangerous gain-of-function research" as scientific work on infectious agents that can cause disease by enhancing their pathogenicity or transmissibility. Importantly, the Order explicitly includes research that can:

1) "[disrupt] beneficial immunological response or the effectiveness of an immunization against the agent

or toxin" (meaning altering how the immune system responds to the virus), and,

2) "[enhance] the susceptibility of a human host population to the agent or toxin."

This means that gain-of-function research includes altering the virus in ways that affect the immune response—either by weakening it or by increasing the harm caused through immune interaction. So, engineering a virus to produce a stronger or

> otherwise altered immune response in hosts falls under this definition because it modifies the virus's interaction with host

immunity, which could have significant health consequences.

Biosecurity Risks Ignored

Researchers infected macagues with a human-lethal strain of H5N1 five years after vaccination with Vac-3 to test long-term immunity. The challenge virus —A/Vietnam/ UT3040/2004 (H5N1)— was said to have been isolated from a patient who died from the infection. This raises serious biosafety concerns. The experiment involves: Genetic engineering of a virus that never existed before and testing it on nonhuman primates. Challenging them with a highly lethal H5N1 strain in a BSL-3 lab. This is gain-of-function adjacent research, cloaked in vaccine development.

Why This Matters

As avian influenza out-

breaks spread across continents and headlines warn of a possible H5N1 human pandemic, it's critical to ask: How many of these outbreaks are caused by wild strains, and how many involve viruses manufactured for vaccine research? Governments and scientific institutions continue to play with viral fire, creating unnatural pathogens and injecting them into animals to test vaccines that may never see approval. The result is a growing infrastructure of high-stakes, high-risk bioengineering, all under the banner of public health—without public awareness or consent.
