Do we want a leader who sits back and hopes for the best, or a leader with the courage to take on every challenge and work through missteps rather than to take no steps at all?

The drumbeat of criticism continues, unabated: Hitler! Nazi! Fascist! Dictator! Following President Donald Trump's mobilization of the National Guard in Washington, DC, a few of his critics tossed in a comparison to Josef Stalin. Who's next? Attila the Hun? Ivan the Terrible? We've heard it all before, throughout the 2024 presidential campaign. Voters deemed it ridiculous noise and chose Trump to be our president. We're still hearing it — and it's still ridiculous.

At 79 years old already and well into his last term in office, Trump is a man in a hurry. He has an insatiable thirst for action, and he's moving at a breakneck pace to confront every threat facing the nation. Meanwhile on the sidelines, his finger-wagging critics are saying at every turn, "There he goes again, acting like he's in charge!" Of course, he is in charge. We put him in charge!

Of all the criticisms leveled at Trump, the only one that is even marginally rational is that he leans toward authoritarianism. Fair enough — he is the decider-in-chief, every time. However, instead of the usual negative connotation of that term, look at it this way: He is a leader in a position of authority who acts — fearlessly — on that authority. I think that's exactly why we hired him.

So in that context of authoritarian leadership of the Donald Trump variety, let me offer three observations:

# The Imperfect Leader



1) We like it. We knew Trump, and we chose him with eyes wide open. We want leaders who lead, and we admire Trump's willingness to take on every challenge, full speed ahead. By "we," I don't mean just Trump acolytes or just Republicans — I'm referring to the public at large and the majority of the 2024 electorate.

2) We need it, particularly now. If there were no crises staring us in the face and no storm clouds on the horizon, we might be able to get by with a caretaker president, just minding the store, but right now we have no choice but to face up to the problems at hand. Look around — economic uncertainty, rampant violence and crime, the ongoing consequences of massive illegal immigration, multiple ongoing wars, and the ever-growing risk of nuclear war. We can no longer sit back and hope for the best. We tried that. It's time for action.

3) Leaders are imperfect. They are human, and even the best make mistakes. Moreover, a leader's missteps are always easier to spot than if he had taken no steps at all. In the case of Donald Trump, countless folks are standing by to gleefully chronicle every character flaw, every misjudgment, and every real, imagined, or potential error

in judgment. How that serves the greater good is not clear, but it's the world we live in.

For example, our president's inability last Friday to wrest meaningful concessions from Russian President Vladimir Putin again opened the door to a flood of reminders that last year, candidate Trump boasted that he could stop that horrible war in a day. He was wrong, but to the critics who delight in his failure so far, we should ask: Who — in the entire world — is doing more, or having any success at all, in stopping the senseless killing?

Two hundred days into his second term, President Trump's scorecard is astonishing for its successes — illegal immigration stopped in its tracks (a previously supposed impossibility), an economy roaring despite doomsday predictions, Iran's nuclear ambitions rudely interrupted, and a long list of works in progress. On those ongoing matters (including his efforts to stop the Ukraine/Russia war) let's quit throwing rocks (literally, as in anti-ICE actions) and cheer him on.

The broader reality is that history is replete with amazing stories of leaders with both the clarity of

Last week President Trump took steps to re-name the Department of Defense the "Department of War." The President explained his rationale for the name change: "It used to be called the Department of War and it had a stronger sound. We want defense, but we want offense too ... As Department of War we won everything - and I think we - have to go back to that."

At first it sounds like a terrible idea. A "Department of War" may well make war more likely – the "stronger sound" may embolden the US government to take us into even more wars. There would no longer be any need for the pretext that we take the nation to war to defend this country and its interests – and only as a last resort.

As Clinton Administration official Madeleine Albright famously asked of Joint Chiefs Chairman Colin Powell when she was pushing for US war in the Balkans, "What's the point of having this

superb military that you're always talking about if we can't use it?"

So yes, that is a real danger. But at the same time, the US has been at war nearly constantly since the end of World War II, so it's not like the "Defense Department" has been in any way a defensive department.

With that in mind, returning the Department of Defense to the Department of War, which is how it started, may not be such a bad idea after all – as long as we can be honest about the rest of the terms around our warmaking.

If we return to a "War Department," then we should also return to the Constitutional requirement that any military activity engaged

in by that department short of defending against an imminent attack on the US requires a Congressional declaration of war. That was the practice followed when it was called the War Department and we should return to it.

Dropping the notion that we have

a "Defense Department" would free us from the charade that our massive military spending budget was anything but a war budget. No more "defense

appropriations" bills in Congress. Let's call them "war appropriations" bills. Let the American people understand what so much of their hard-earned money is being taken to support. It's not "defense." It's "war." And none of it has benefitted the American people.

Trump misunderstands one very important thing in his stated desire to return to a "War Department," however. A tougher sounding name did not win the wars. Before the name change, which happened after the infamous National Security Act of 1947 that created the CIA and the permanent national security state, we won wars because for the most part we followed the Constitution and had a Congressional declaration of war. That way the war had a beginning and end and a clear set of goals. Since World War II the United States has not declared war even though it has been in a continuous state of war. It is no coincidence that none of these "wars" have been won. From 1950 Korea to 2025 Yemen and everything in between.

So go ahead and change it back to the "Department of War." But let's also stop pretending that maintaining the global US military empire is "defense." It's not.

# RFK Jr. Fights Congress; Trump Questions Covid-19 "Vaccines"

Four years after the rollout of the most controversial and suspect "vaccine" in U.S. history, debate over its legitimacy — or lack thereof — has been reignited in the chambers of Congress.

One of President Donald Trump's most controversial Cabinet members is stirring a whirlwind of controversy over changes he's been making at the Centers for Disease Control and Prevention (CDC). Meanwhile, a social media post by Trump published earlier this week indicates he is under pressure to defend the Covid-19 injection. The message suggests he's leaving room for the possibility that it's not the benefit he said it was.

#### Kennedy Controversy

"We are the sickest country in the world, that's why we have to fire people at the CDC." That was one of the many defiant statements Health and Human Services Sec-

retary Robert F. Kennedy, Jr. made during Thursday's fiery hearing before the Senate Finance Committee. Kennedy went to Capitol Hill to answer why he fired short-tenured CDC director Susan Monarez, as well as for his "efforts to upend the nation's vaccine policies," as mainstream media put it. The Covid-19 injection was a central point of dispute during the hours-long hearing.

Democratic committee members ripped into Kennedy and asked him to resign over the changes he's making to what he considers one of the most corrupt government agencies. Kennedy became visibly flustered and pushed back. At one point he accused the committee of not being interested in the truth. Another time he called a senator "ridiculous" before accusing him of "talking gibberish" and telling him he doesn't know what he's talking about. And he told at least two senators that they were lying. He said they were "making stuff up" and they were "being dishonest."

# Trump Questions Operation Warp

Trump published a social media post demanding that Big Pharma "justify the success of their various Covid Drugs." Four years after their rollout, controversy around the injection rages. Moreover, inoculation plummets with every passing year, not only among the general public but among healthcare workers. Fewer people in the medical field are taking the jab. By the turn of this year, only 15 percent of healthcare workers took the shot. Apparently the only demographic that still fosters overwhelming support is the Democratic wing of Congress.

The CDC is the agency in charge of vaccine recommendations. While the Food and Drug Administration (FDA) approves vaccines (and other drugs), the CDC creates the guidelines that states and school districts from coast to coast follow as if they're law. In his post, Trump said the CDC was "being ripped apart over this question" of whether the Covid-19 injection is beneficial. He said he'd seen information from Pfizer and other manufacturers "that is extraordinary," but for

some reason, they don't "show those results to the public." He continued: "They show me GREAT numbers

and results, but they don't seem to be showing them to many others. I want them to show them NOW, to CDC and the public, and clear up this MESS, one way or the other!!! I hope OPERATION WARP SPEED was as "BRILLIANT" as many say it was. If not, we all want to know about it, and why???"

During Thursday's hearing, Senator Thom Tillis (R-N.C.) asked Kennedy to turn in a statement laying out his specific stance on Operation Warp Speed. Tillis said he couldn't tell where the secretary stands based on their conversation in the hearing. Pages upon pages of comments Kennedy has made, as well as a book he wrote with a focus on the matter (The Real Anthony Fauci), indicate that Kennedy sees the injections as suspect at best. On Thursday, he said there is no clinical data supporting a Covid-19 injection for healthy people. But he also said that the first-generation "vaccine" approved in the early stages saved "quite a few lives." He did not, however, acquiesce to Senator Bernie Sanders' (I-Vt.) prompt that they saved "millions of lives."

Tillis also said he was concerned that the "credibility" of the CDC was "diminishing." Kennedy has made a series of statements indicating he believes that ship sailed many moons ago. He told Senator Michael Bennet (D-Colo.) that he's working to ensure that the CDC tells people the truth "for the first time in the history of that agency." His argument is that he's trying to reverse the corruption in the CDC and restore credibility.

Based on the number of legislators, CDC employees, and medical groups who openly advocate Kennedy's firing, he's got quite the fight on his hands. Kennedy is not sorry for the people he's fired and changes he's brought about. (For a review of some of the major changes at the CDC this year, you can read our report "CDC Director Defies Firing Over COVID-19 Vaccine Stance.")

Susan Monarez's firing last week drew a lot of attention to the evolving agency. On Thursday, lawmakers grilled the secretary about what happened there. Senator Elizabeth Warren (D-Mass.) asked Kennedy if he forced Monarez to resign because she wouldn't approve changes to the childhood vaccine schedule. Kennedy said: "No, I told her she had to resign because I asked her, are you a trustworthy person? And she said, no. What if you had an employee who told you they weren't trustworthy? Would you ask them to resign?"

Monarez said she was fired because she wouldn't oblige Kennedy's order to fire "senior CDC staff and accept preapproved recom-

mendations of the CDC's vaccine advisory panel," according to mainstream reports. On Thursday, the secretary told lawmakers that she was lying about that.

Taking Money From Big Pharma

During his exchange with Warren, Kennedy accused lawmakers of shilling for Big Pharma, as he has done in other hearings. When Warren accused him of "taking away" the injection by removing its status of recommendation, the secretary said, "I never promised that I was going to recommend a product for which there is no indication — and I know you've taken \$855,000 from pharmaceutical companies, senator." According to OpenSecrets, Warren received \$818,997 from employees or political action committees affiliated with the pharmaceutical industry during the 2020 election cycle.

Warren's socialist colleague, Senator Sanders, admitted that "everybody" takes money from Big Pharma: "Just for the record, every single Republican — I don't mean to be political here, Mr. Chairman — has received PAC money from the pharmaceutical industry.... Every Republican got corporate PAC money from the pharmaceutical industry, Democrats as well." Sanders' point, astonishingly, was that because everybody receives campaign support from Big Pharma, that somehow dismantles the accusation that they're corrupt.

Kennedy vs. the Establishment Sanders also acknowledged that

the entire medical establishment, saying: "What I find a little bit

weird in this discussion ... is we got the entire medical community on one side. You got the AMA, representing hundreds of thousands of doctors, the American Academy of Pediatrics, the American Public Health Association — all of these organizations are telling us that Covid vaccines and vaccines in general are safe and effective. You are casting doubt on that.... Who are the organizations that are agreeing with you?"

Kennedy cited his primary advisors — Marty Makary, Jay Bhattacharya, and Dr. Mehmet Oz - before pointing out that there is a big difference between established science and the scientific establishment, "which has been co-opted by the pharmaceutical industry." He cited as an example the American Heart Association, which, he said, has been co-opted by the food industry.

In defense of the changes at the CDC, Kennedy repeatedly told committee members that Americans are the sickest people in the world. Chronic illness, obesity, and

mental illness are indeed rampant in America. (You can read more about that in our report "Making America Sick, One Bite at a Time.")

While he has not accomplished what those who view the Covid-19 injections as wholly destructive would like to see, Kennedy has shaken things up for sure. The fact that he's removed its recommendations for children and healthy people is a step in the right direction. It appears that he's working to delegitimize the shot without being removed.

#### The Real Solution

If America had a government that adhered to the Constitution, Kennedy would not have to defend himself. That's because there would be no CDC, as was the case for most of the country's history. There is nothing indicating that the Framers ever intended public health to be the federal government's job. Health and Human Services should be defunded and eliminated, and states should embrace the unique health challenges that plague their citizens.

generated, along with stories that have facts altered, distorted, omitted, or taken out of context. Examples of fake images can be found at https:// leadstories.com.

In the case of Gaza, the media often reports lies spewed out by Hamas, causing us to see Hamas as the hero

and Israel as the villain. "A faithful witness will not lie: but a false witness will utter lies" (Proverbs 14:5). Hamas, with its irrational propagandists and have no scruples whatsoever about twisting truth, making false claims, fake videos and uttering downright lies, to the point of totally rewriting history." (allisraelnews.com). In Islam, it is permitted (an obligation even) to lie if the goal is to advance Islam,

## Will AI Data Centers Soon Consume More Energy Than Humans?


Ever wonder how much energy it takes for the near-instant AI responses that we are increasingly encouraged to depend upon? For those curious, the amount is tremendous. In 2022, training the AI model for the first version of ChatGPT consumed a staggering amount of electricity—the same amount of electricity as 130 households consumed in one year. And that was three years ago. Last year, for the first time, the International Energy Agency (IEA) included projections for electricity consumption associated with data centers, cryptocurrency, and artificial intelligence in its forecast for global energy use over the next two years. With these energy consumers added together, the IEA noted that by 2026, usage will be roughly equal to the amount of electricity used by the entire country of Japan.

One of the areas devouring mass amounts of energy on the fastest trajectory is the form of machine learning called generative AI. As previously noted, training a model the size of ChatGPT slurps up 1,300 megawatt-hours (MWh). Again, enough to power 130 U.S. homes for a year. Even simple tasks eat power. The IEA reports that a single Google search takes 0.3 watt-hours of electricity, but a ChatGPT request needs 2.9 watt-hours. For comparison, an old-school incandescent light bulb pulls 60 watt-hours. If ChatGPT were integrated into the over 9 billion searches performed worldwide each day, the electricity demand would increase by 10 terawatt-hours a year—equal to the electricity used by 1.5 million European Union residents.

Indeed, data centers are the behindthe-scenes crew of the AI world, an

essential component of making it all happen. They are, quite literally, massive, climate-controlled, energy-guzzling warehouses jam-packed with servers, consuming energy as if there's no tomorrow. Right now, they are responsible for 0.9-1.3 percent of global energy use, with forecasts predicting a jump to 1.86 percent by

2030. Cooling systems, backup generators, and high-level security, among other things, must be in place to keep these systems running. Yet,



A closer look at plans for a new AI data center in Wyoming reveals the scale at which society (under the direction of what is undoubtedly part of the deep state's march towards transhumanism) is rapidly advancing AI. To put it bluntly, the headline of a recent article in ARS Technica reads, "AI in Wyoming may soon use more electricity than state's human residents." Calling the news a "game-changer," the state's Governor, Mark Gordon, and Cheyenne, Wyoming's mayor, Patrick Collins (where the data center will be located), declined to reveal who the tenant might be, including whether it was indeed OpenAI (the developer of ChatGPT) which has been scouring the U.S. for sites for its massive data center called Stargate.

Wyoming, the least populous state, is the nation's third-largest net energy supplier, producing 12 times more energy—mostly from natural gas and related products—than it uses. Chevenne, Wyoming, has been a hub for data centers since 2012. Thanks to its chilly climate and access to

energy, companies like Microsoft and Meta have laid claim to the area to establish their respective data centers. Still, the state's electricity supply has limits, and the recent announcement of the new AI data center, which would consume more energy than the state's residents, has many on alert.



The new facility will be a joint venture between energy infrastructure company **Tallgrass** and AI data center developer

Crusoe. It would begin at 1.8 gigawatts and amp up to 10 gigawatts of power use. One of the stakeholders at Tallgrass is Canada Pension Plan Investments, which, in 2017, is believed to have sold \$520 million in U.S. farmland assets to Microsoft founder Bill Gates. Highlighting the significant announcement. ARS Technica explained: "The initial 1.8-gigawatt phase, consuming 15.8 terawatt-hours (TWh) annually, is more than five times the electricity used by every household in the state combined. That figure represents 91 percent of the 17.3 TWh currently consumed by all of Wyoming's residential, commercial, and industrial sectors combined. At its full 10-gigawatt capacity, the proposed data center would consume 87.6 TWh of electricity annually—double the 43.2 TWh the entire state currently generates. Because drawing this much power from the public grid is untenable, the project will rely on its own dedicated gas generation and renewable energy sources, according to Collins and company officials. However, this massive local demand for electricity—even if self-generated—represents a fundamental shift for a state that currently sends nearly 60 percent of its generated power to other states."

The state of Wyoming isn't alone. The AI race is on nationwide, leaving states under mounting pressure to protect regular households and business ratepayers from the increasing costs of catering to Big Tech's mad dash to regulate our lives. At least 16 states are actively involved in building or planning AI data centers. Each is driven by the growing demand for AI infrastructure. For example, in Tennessee, Elon Musk's xAI has established the Colossus supercomputer in Memphis. The setup is described as one of the largest AI data centers in the world, running 100,000 Nvidia H100 GPUs. It is currently expanding with a second facility, Colossus 2, on a 1 million square foot site in Whitehaven.

That's not all. The U.S. Department of Energy has selected the Oak Ridge Reservation in Tennessee as one of four federal sites for potential AI data center development, leveraging its proximity to power resources like the Tennessee Valley Authority's Clinch River Small Modular Reactor site. Mark Zuckerberg's Meta has also launched a data center campus in Gallatin, which has been operational since late 2024, with plans for future expansion.

It is essential to remember that building AI infrastructure in no way resembles a loving relationship towards Mother Earth. Mining lithium, cobalt, and rare earth metals for chips and batteries leaves ecosystems tattered through deforestation, polluted water, and devastated and destroyed wildlife. Once mined, refining these minerals uses massive energy, and local communities near the mines face health risks from toxic chemicals and water shortages. The military moniker "scorched earth" comes to mind. There is no doubt that soon AI will be instructing us humans on how to integrate more solar and wind energy into its rise to global domination, but should we let it?



# **BREAKING: West Coast Governors Launch Health Alliance to Defy CDC**

This morning in Florida, Governor Ron DeSantis announced the creation of a new Make America Healthy Again (MAHA) Commission chaired by First Lady Casey DeSantis and Lt. Gov. Jay Collins. The bill simply says: if an educational institution wants federal education dollars, it must honor a parent's right to claim a religious exemption from vaccine requirements. No documentation, no loopholes, no bureaucratic hoops. Just a recognition of the First Amendment.

This matters because 46 states already respect religious exemptions. However, in four states, parents are stripped of that choice and children are punished for their family's faith. The GRACE Act corrects that injustice.

Meanwhile, on the other side of the country, governors Bob Ferguson,

Gavin Newsom, and Tina Kotek have announced the West Coast Health Alliance, claiming they are stepping in to protect "science" after what they describe as the Trump administration's undermining of the CDC.

Their press release is blunt: Joint Statement from Governors Newsom, Kotek and Ferguson "President Trump's mass firing of CDC doctors and scientists and his blatant politicization of the agency, is a direct assault on health and safety of the American people. The CDC has become a political tool that increasingly peddles ideology instead

> of science, ideology that will result in severe health consequences. California, Oregon and Washington will not allow the people of our states to be put at risk."

> Here's what this really means for families in Washington, Oregon and California: more government control, more bureaucracy, and a return to top-down mandates from unelected officials and activist

medical organizations — the same groups that often push Big Pharma's agenda. While Florida, and many other states are working to give citizens medical freedom and empower parents, the West Coast Alliance is positioning itself as the authority over yours and your child's health decisions.







# Things They Didn't Teach You in Church: Peace Through Commerce

armed with nuclear weapons, had reached a ceasefire...led talks after an intensifying military confrontation." According to the Economic Diplomacy Department of the Indian government, commerce between the countries has skyrocketed.

In June the attack on Iran's nuclear facilities took place. The Wall Street Journal headlines read: "How Trump Cajoled Iran and Israel into a Cease-Fire and Forced Them to Comply." USA Today reported the ceasefire between the two countries after the U.S. joined Israel in bombing Iran's nuclear sites.

A historic peace agreement between Rwanda and the Democratic Republic of the Congo was signed on July 27, 2025, ending 30 years of war and killing, putting the countries on a path to peace. USA Today reported, "Trump announced a treaty between the African nations, crediting Secretary of State Marco Rubio for helping to bring them together." Then the very next day, after President Trump spoke with leaders of Thailand and Cambodia, the two countries announced an "immediate and unconditional ceasefire" and again their trade relationships with the U.S. was used as incentive to



do so. USA Today reported that the leaders of the two countries agreed to a ceasefire after five deadly days of fighting, when Trump urged them to negotiate a ceasefire or else trade deals with the U.S. government would stall.

On August 8, 2025, President Trump

hosted the Azerbaijani President and the Armenian Prime Minister at the White House. The two leaders signed a historic joint declaration for peace, ending decades of bitter conflict and death. It was a landmark achievement in international diplomacy that some say only President Trump could have delivered. USA Today reported that the two former Soviet republics and Trump signed a peace agreement at the White House on August

8th, ending a decades-long war. The Washington Examiner reported that the agreement includes plans for, "a trade route through both countries dubbed the Trump Route for International Peace and Prosperity."

There is a single thread that runs through all these stories of peace. That is one of commerce and trade. Even in what seems to be the only conflict left (Russia and Ukraine) commerce is the key and is the main leverage or weapon Trump is using to broker peace. President Trump

> has imposed a 50% tariff on all imports from India in response to its continued purchase of Russian Federation oil. He also established a process for the potential imposition of similar tariffs on other countries that directly or indirectly import oil from the Russian Federation.

# Bedini Wheels and Energy from the Aether

"The term "free energy" is probably the most misused term in the world. The term that I would use is free radiant energy." ~ John Bedini - Energy from the Vacuum

Radiant energy is not a mystery. It is brought into the environment every time a magnetic wave collapses. This electrostatic burst is reactive power, unusable by conventional means, wasted and abundant. Radiant energy is available everywhere.

The trick is tapping into it. In the late 1800s, this was done by Nikola Tesla. This electrostatic effect is the primary operating principle of his wireless transmitter that he was prevented from making. He was able to harness it to power his 80 horsepower Pierce Arrow electric automobile that charged its own batteries.

During the 1920s, Thomas Henry Moray worked with this energy and demonstrated a power source he developed which would generate 50,000 watts. The U.S. Patent Office refused to grant Moray a patent. In the late 1950s, Edwin Gray built working models that could capture radiant energy from the discharge of high-voltage capacitors, and in the 1970s, he reproduced Tesla's self-charging electric car. In the 1980s, Paul Baumann started building models of his Testatika machine to power his small community in Switzerland.

While working on crystals, John Bedini took interest in radiant energy and built several machines that can generate usable energy by harnessing the electrostatic burst created by the collapse of a magnetic field. "There's no closed mo-



tor loop. There's no magnetic gaps to adjust. There's nothing. There's basically this one little circuit that fires itself through a magneto action and you capture that electrostatic moment. You transform that and you send it to the secondary battery." - John Bedini

Tom Bearden - Energy from the Vacuum: "We have our primary

battery. We are taking a little bit of energy from this battery. It is furnishing a small amount. That actually gets the system set up and begun. We're doing mechanical work with the fan. In this battery, the flash charging (taking energy from the

vacuum) is producing more energy deposited in the battery to charge it than we have drawn from this battery. In this particular system,

eight or ten times as much, depending on what speed it's working at."

An open source internet group was formed in 2004 that allowed others the ability to replicate the Bedini motor and see for themselves. For just over \$100, anyone could build their own simple Bedini wheel and observe these effects. A rapid series of magnetic field collapse produces large spikes of radiant energy, which are then collected and stored in a battery bank. The simple version shared online isn't going to power your home, but it can be scaled up to one that can. John Bedini has done this. "Okay, we're going to take one bank of semi-charged batteries and we're going to put the energy

into another bank of batteries. Then we're going to draw off the energy on this panel, 2.4 kilowatts is what we're going to take. The source batteries are pretty well up to snuff. These other batteries are low. Right now, we're going to charge these batteries." John Bedini

# DOJ Proposes Legislation to Stop Chemical, Surgical

The Justice Department has proposed legislation to Congress to stop the chemical and genital mutilation of mentally disturbed kids who falsely believe they are the "wrong sex." Pursuant to President Donald Trump's executive order to stop the barbarism, the bill would forbid socalled gender-affirming but life-altering treatment of "trans" children. Ending the mutilations was one of Trump's key campaign promises.

#### The Order

Trump signed his executive order on January 28, a week after he took office. He wrote that the victims of the fake science soon regret that they have been mutilated and begin to grasp the horrifying tragedy that they will never be able to conceive children of their own or nurture their children through breastfeeding. As well, the victims are stuck with "lifelong medical complications" and the bills to pay for treatment.

The order defines "chemical and surgical mutilation" as the use of puberty blockers, including GnRH agonists and other interventions, to delay the onset or progression of normally timed puberty in an individual who does not identify as his or her sex; the use of sex hormones, such as androgen blockers, estrogen, progesterone, or testosterone, to align an individual's physical appearance with an identity that differs from his or her sex; and surgical procedures that attempt to transform an individual's physical appearance to align with an identity that differs from his or her sex or that attempt to alter or remove an individual's sexual organs to minimize or destroy their natural biological functions. This phrase is sometimes referred to as "gender affirming care."

GnRH agonists are hormones that keep a child from going through puberty associated with his real sex. Trump called "gender-affirming" care "junk science." He further ordered agency heads to ensure that institutions that receive federal funding end the mutilations. The order called

for legislation to stop the mutilations.

Republican Rep. Bob Onder of Missouri and Senator Marsha Blackburn of Tennessee will lead Congress in passing the "Victims of Chemical or Surgical Mutilation Act."

The bill will prohibit healthcare professionals, physicians, hospitals, or clinics from participating in the chemical or surgical mutilation of a child and will provide a private right of action for children and their parents of whose healthy body parts have been damaged by medical professionals practicing chemical and surgical mutilation. In other words, when the victims of the barbarism find out what was done to them, they can sue the doctors and other "health care professionals" who mutilated them, along with the "mental health professionals" who recommend the mutilations.

The legislation's definition of chemical and surgical mutilations mirrors that of Trump's executive order.

In granting the right to sue the Frankenstein doctors who mutilate kids,

the bill offers a generous statute of limitations: "Because these decisions are often made by parents or medical providers, on a child's behalf, and because these actions often have long term effects that are not discovered until years after the medical actions have been taken, actions brought under this Act may be brought either within 25 years from the date of the eighteenth birthday of an individual subjected to chemical or surgical mutilation as a child or within 4 years from the time the cost of a detransition treatment is incurred, whichever date is later."

"The Department of Justice has heard from far too many families who have been devastated by mutilative medical procedures that fly in the face of basic biology," Attorney General Pam Bondi said: "While we continue our ongoing legal battle to protect children, we appreciate our colleagues in Congress who are working diligently alongside us to end these abusive procedures once and for all."

The forthcoming legislation won't be the first.

In August, GOP Rep. Nancy Mace of South Carolina introduced H.R. 4953, the Gender-Affirming Child Abuse Prevention Act. "Kids can't get tattoos, sign contracts or buy alcohol, so why would we let them permanently change their gender?" she wrote on X.

GOP Representative Marjorie Taylor Greene of Georgia introduced H.R. 3492, the Protect Children's Innocence Act, which passed out of the House Judiciary Committee in June. "The Left calls it 'gender-affirming care." Greene wrote on X. "It's child abuse."

#### **WPATH Discredited**

A key provision in Trump's order bans federal agencies from relying for guidance on the disgraced and discredited World Professional Association for Transgender Health's "Standards of Care 8."

Those standards include a link to the deranged Eunuch Archive. Last year, Reduxx reported that the archive is a collection of "nearly 10,000 'erotic' stories of an extreme sadomasochistic nature," 3,000 of which involve children. One story involved pedophile sex slavery.

In ending the federal government's Gadarene rush into the mutilation business, Trump's order frustrated the malevolent plans of "Rachel" Levine — real name Richard — the mentally ill man whom President Joe Biden made the No. 2 federal health official.

Levine zealously promoted the chemical and genital mutilation of kids. Even more radical than WPATH, he told the outfit to drop its age restrictions on the mutilations found in the standards of care that Trump banned.

Trump ordered Health and Human Services Secretary Robert F. Kennedy Jr. to publish material on the best treatments for kids with gender dysphoria; i.e., those confused about their sex.

or event or from credible secondhand news sources. Find journalists who are careful to verify their reports. "Journalists cite non-governmental and so-called human rights organizations like Amnesty International, treating them as beyond reproach and assuming their information is authoritative." (Honestreporting.com)

To decide whether to believe reports from the UN or human rights organizations, such as Amnesty International, consider the organization as a whole. Who funds them? What causes do they champion? Beware of outlets funded by George Soros's organizations as "Open Society Foundations" or "Project Syndicate", which feeds anti-Israel propaganda

to five hundred forty-three (543) media outlets around the world. ("MASKS OFF: George Soros Org President Channels Hamas and Cries 'GENOCIDE' at Israel", Honestreporting.com)

Do your research. Look at the whole picture—historically, and compare the words and overall actions of the players, using reputable sources with a good record of accurate reporting.

Listen to both sides of the story.



thought and sufficient courage of their convictions to take bold and controversial actions — with no guarantee of success — to achieve what needed to be achieved. Abraham Lincoln was one of those. How bold — and infuriating to many — was his Emancipation Proclamation? Who knew how the Civil War would end and whether our fledgling nation would ever recover? Lincoln very nearly presided over the collapse of our nation — instead, he is revered as its savior.

Consider also Winston Churchill, who managed to fight back from his career-ending blunder as First Lord of the Admiralty in WWI, and then years later took on the impossible task of prime minister in his country's darkest hour. Churchill may have been the only person in England willing to stand up to the Nazi menace, but it had to be done,

and his steely resolve arguably saved the world.

At this point in history, who knows if Trump's phenomenal energy, drive, and resilience will carry the day, or whether his policies and programs will lead to his promised golden age or to the critics' predictions of doom. By and large, we elected him because we admired his strengths and trusted his instincts. Now it's time to stay the course.

Right now, there are two competing and very powerful political movements in the U.S. One is taking action at a frenetic pace, doing the things its leader, Donald Trump, promised that he would do if elected. # **Epstein Victims Consider Releasing Their**

The co-sponsors of a bill that would force the government to release all available Jeffrey Epstein documents held an hour-long press conference Wednesday that included statements from Epstein's victims. One said that she and others were considering releasing their own list.

"Epstein survivors have been discussing creating our own list," Lisa

Phillips said. "We know the names. Many of us were abused by them. Now, together as survivors, we will confidentially compile the names we all know, who are regularly in the Epstein world. It will be done by survivors, and for survivors. No one else is involved. Stay tuned for more details."

Phillips spoke near the end

of the conference. She was one of eight victims (nine if you count deceased victim Virginia Giuffre's family) to make statements in support of the Epstein Files Transparency Act (EFTA), which would force the House of Representatives to vote on the complete release of everything the government has related to Jeffrey Epstein (with the exception of victim-related redactions).

#### The Discharge Petition

Since Republican leadership has been unwilling to bring the bill up for a vote, EFTA co-sponsors Ro Khanna (D-Calif.) and Thomas Massie (R-Ky.) are circulating a

discharge petition to circumvent the House speaker. If they get 218 signatures, they can force a vote. Right now, they are just two shy. Democrats, but only four Republi-Republicans are Marjorie Taylor Greene of Georgia, Nancy Mace of of Colorado.



Massie argued that despite various Epstein files being released by the government, "that does absolutely nothing." He said the public receives some information, but it's information curated by the government. On Tuesday, the House Oversight Committee released more than 33,000 pages of documents related to the Epstein investigation. Massie pointed out that everything the DOJ has released so far is either heavily redacted or information that's already been made available to the public, which, he says, accounts for 70 percent. The White House is calling Massie's attempt to have

all the Epstein information released a "hostile act," an indication that it opposes full transparency.

One of the victims' lawyers, Bradley Edwards, elaborated on why it's so important that EFTA go through. He said all the documents and evidence they've worked so hard to gather "hide behind protective orders, confidentiality agreements, and bank secrecy laws," adding: "That is why this discharge petition is so important. While we have seen the documents, you haven't. When you see the documents, you're going to be appalled."

The discharge petition, Edwards added, means that "nothing is off-limits" - from CIA documents, to FBI documents, to financial records. "Everybody knows that ... corruption flourishes in secrecy." He also said that he had filed lawsuits against JPMorgan and Deutsche Bank proving that they "knowingly provided the financial infrastructure for a sex trafficking operation."

#### A Nonpartisan Issue

Both the politicians and the victims — or survivors, as they prefer to be called — stressed that this was a nonpartisan issue. Greene said this was something that "Republicans and Democrats should never fight about," but that it instead "should bring us all together." Greene also said that she had recently heard that Epstein had ties to other countries, including Saudi Arabia, Russia, and Israel. "The only motive for opposing this bill would be to conceal wrongdoing," one of the victims observed.

Massie, who is being targeted by President Donald Trump in the 2026 primary, took issue with the president calling the Epstein saga a hoax. "This is not a hoax," he said. "This is real. There are real survivors. There are real victims to this criminal enterprise. The perpetrators are being protected because they're rich and powerful and political donors to the Establishment here in Washington, D.C."



Everyone at the press conference agreed that Epstein was a monster who played a role in the assault of hundreds, if not thousands, of underage girls, and that the only reason there is not more known about him is because he was rich and well connected. Khanna put it this way: "Americans are asking a very simple question: How is it possible that in the richest, most powerful country in the world there are corrupt special-interest forces (both foreign and domestic) that have a stranglehold on our government and are preventing the release of the full Epstein files? There is something that is rotten in Washington. Today we stand with survivors, we stand against Big Money, we stand to protect America's children. That is really what this is about."

#### Suvivors Testimonies

The survivors' testimonies were similar. They were approached when they were between 14 and 16 years old. Someone they knew asked if they wanted to make \$200 to massage "an old rich guy." However, they soon found out that they were obligated to give more than a massage. Plus, they were asked to recruit other girls as they had been recruited. Another similarity is that none of those who went to the authorities had success — until attorneys like Edwards took on their case.

Perhaps alleged victim Courtney Wild summed it up best as to what this is about: "We need transparency. It's time for us to see beyond the curtain — Why was Jeffrey Epstein so protected? Who is still being protected, and who protected them all? — so the world can understand how Jeffrey was able to abuse so many of us for so long."



# Nutrition as Cure: Reviving the Medicinal Wisdom of Food

Once upon a time, medicine to treat illness did not come from a doctor receiving kickbacks from Big Pharma or a massive chain grocery store; instead, it came directly from the soil beneath our feet. Yet, fast forward to today, and here in the United States we see a society ravaged and overtaken by chronic disease, with most medical schools providing less than twenty hours of nutrition training across four years. Thankfully, Health and Human Services Secretary Robert F. Kennedy Jr. recognizes the problem and intends to fix it.

Indeed, for centuries, the food table was the apothecary. Garlic lowered blood pressure before it became a profit-generating capsule. Bitter herbs detoxed the liver before being bottled as supplements. Our meals were the frontline of our healthcare. Then the Industrial Revolution rewrote the script. Wholesome and nutritious foods were hauled away and processed in factories, only to emerge stripped of nutritional value and instead dressed up and disguised with sugar, salt, artificial preservatives, artificial flavors, and GMOs, to name a few. Meanwhile, medicine moved into Big Pharma's lucrative labs, where single compounds were isolated, synthesized, and patented. Instead of seeing a carrot for what it is—a symphony of synergistic nutrients—it was reduced to "vitamin A" and sold as a pill. The fact that doctors aren't trained in the root causes of disease

However, the overall damage is more significant than any good that may have resulted, as the shift also secured chronic illness as a billion-dollar business model. In other words, the chronic disease epidemic became the cash cow. Think about it-why encourage prevention through diet when lifelong prescriptions for diabetes, hypertension, or high cholesterol promise guaranteed returns? It is no secret that Big Pharma thrives on customers, not cures, and the toxic American diet of ultraprocessed foods is an easy accomplice.

This gross reality must change before it's too late. And, thank God, change is in the air. Last week, Kennedy made waves when he announced he was pushing for doctors to receive more education about nutrition. He announced that a team within HHS would target "the woeful lack of nutrition education

only added to the conundrum. Why? in medicine" by making it a greater part of pre-med and medical school

> curricula, medical licensing exams, residency training, board certification, and doctors' continuing education. Kennedy's announcement is undoubtedly a

significant step in the right direction and long overdue.

By championing the importance of nutrition while highlighting the fact that regulators and curricula may often prioritize the interests of Big Pharma over public health, RFK Jr. is implicitly challenging the dominance of Big Pharma's artificial approaches in America's healthcare. Without question, a nutrition-centered approach to healthcare threatens no one—except the industries profiting from chronic illness.

Reconnecting medicine to prevention, rather than intervention, while emphasizing the power of food as medicine, positions nutrition as a core component of good health. With that in mind, meal choices become part of the prescription, thereby empowering patients seeking a healthy life to take control of the foods they eat. In an OpEd in the WSJ published on August 27, 2025, while pointing out that nutrition,


fueled by poor diets, is the root cause of the long-running chronic disease crisis in America—with little help from the medical profession to fix the problem—Kennedy wrote: "Accrediting bodies and medical organizations look the other way, declining to set clear requirements. We train physicians to wield the latest surgical tools, but not to guide patients on how to stay out of the operating room in the first place. We know that when applied properly, nutrition counseling can prevent and even reverse chronic disease."

Our society has long needed a cultural alignment with a post-industrial, holistic vision of health as its primary focus. RFK Jr.'s push aligns with the visible rise of functional medicine, integrative health, regenerative agriculture, and ancestral health paradigms that are present in each of us. Indeed, Kennedy's advocacy for nutrition in medicine is not a fringe idea by any means. It echoes voices across political lines in favor of root-cause healing over profit-driven symptom suppression. Ultimately, it is a much-needed return to common sense that invites medicine to remember its roots. empowers doctors to heal more holistically, and affirms that what we eat is inextricably linked to who we
