A helpful distinction

Back in college, I had a professor who liked to make "helpful intellectual distinctions." He was a kind man and a wonderful political scientist who specialized in the hard topics of war and escalation. He found himself later in life among policy types, who while respecting him greatly smiled at some of his formulations. When he offered a "helpful intellectual distinction" the mood lightened but people listened.

In difficult times we need to be careful with language, and keeping important distinctions in mind can help us, at the very least, from making things worse. For example, there is a difference worth noticing, and noting, between "me speech" and "free speech".

"Me speech" is a common practice among rich and influential Americans. Practitioners of "me speech" use the phrase "free speech" quite a bit. However, what they mean is free speech for themselves. They want a monopoly on it.

They believe that they are right about everything, and so they should always have giant platforms, in real life or on social media. The people with whom they disagree, however, should be called out and intimidated in an organized way on social media, or subjected to algorithmic discrimination so that their voices are not heard. These people suppress the freedom of speech. But because they repeat the phrase "free speech" quite a lot, the media will often associate them with the idea. This, of course, tends to make the notion of "free speech" meaningless.

Free speech has to be for everyone. And that means that influential and powerful people who believe

in free speech would not seek to intimidate or discriminate. They would not create difficulties for those with whom they disagree. On the contrary, they would accept that people with whom they disagree should be encouraged and supported. People who believe in free speech admit that they, personally, might be wrong. People who believe in free speech understand its ultimate purpose, which is to enable people to speak truth to power without fearing any consequences.

It helps to see the difference between me speech and free speech. If we celebrate me speech, we lose free speech. Or, more to the point, if we celebrate the me speakers, we lose the free speakers. If the term "free speech" just becomes a call to admire those who suppress the expression of others, then it means nothing, or really less than nothing.

As for me, I believe that the right concept is "freedom of speech" and, best of all, "free speakers." To become free speakers, we need to be fearless, which means that others should not be trying to intimidate, tame or harm us, be they the government or be they powerful individuals. Fearlessness has to be attached to values about which

we really care, which come from human interactions, from relationships, from friends and parents and teachers and books. To become free speakers (in other words) we all need care, time, and education.

Free speakers, I think, see the problem with me speakers. Free speakers will not need cults or oligarchs. They will want facts and ideas. They are not sure of themselves and usually wrong, but reflective and sometimes right. They are respectful, because they know they always have something to learn. They are empathetic, because they know that they will learn only from those whose lives have been different than their own.

Freedom of speech is a skeptical power: it is always a challenge. It affirms the truth: it is always a search. Without skepticism of power and affirmation of truth, we will not have freedom of speech. The me speakers push us to embrace their power and treat everything they say as truth. They will call this "free speech."

If we indulge that perversion we are asking for the tyranny we will get.

Leaked Files Reveal Netanyahu 'Predicted' Charlie Kirk Assassination: 'Lapel Mics Hacked to Explode'

Benjamin Netanyahu didn't just predict 9/11—he mapped it out in detail five years before it happened. And now, the same chilling pattern emerges with the Charlie Kirk assassination.

Years ago, Netanyahu warned America that with a single click, this nation could be brought to its knees. As Netanyahu put it, "Every system can be hacked to explode and serve Israel's political ends, even something as small as a lapel microphone." It sounds unthinkable, but the evidence we're about to show you points to a disturbing conclusion: the chaos wasn't random. It was engineered.

Benjamin Netanyahu, back in 1996, predicted the 9/11 attacks on the Twin Towers—right down to the details. Everywhere Netanyahu goes, explosions follow. Earlier this month in Qatar, he targeted a U.S. ally, attempting to wipe out an entire negotiating team. Then there's the infamous Hezbollah pager attack, planned years in advance. Then, on Monday, he appeared at the White House — and just hours before, a Secret Service SUV parked outside mysteriously exploded. Was it a message? It wouldn't be the first time. The Secret Service has caught Israeli operatives placing electronic devices on its emergency vehicles — not once, but twice.

The pattern isn't new. The U.S. government itself concluded that Israel was the most likely culprit behind bugging the White House during Netanyahu's 2017 visit. Netanyahu's own words serve as a chilling warning to America: don't think the United States can't be brought down with a few well-placed explosions. As he put it: "Every system can be



hacked..."

Ballistics experts are tearing apart the official story of Charlie Kirk's assassination. The "magic bullet" theory pushed by TPUSA insiders isn't just unlikely — it's impossible. In its place, a darker explanation is gaining traction: Kirk wasn't shot. He was taken out by an exploding lapel microphone, hacked and weaponized by hidden hands.

Frame by frame, the evidence becomes clearer. The blast originates at Kirk's DJI Mic 2. His neck and ears snap from the shockwave, his earpiece flies, and his body lifts slightly from the force. Many experts are now saying that's not a bullet — that's a detonation, and it explains the lack of an exit wound.

While the world wonders whether Israel would really dare attack the U.S. — to manipulate public perception and run psychological operations — Professor Jeffrey Sachs says this isn't hypothetical at all. According to him, it's standard practice for Israel. Sachs says Israel runs America through the CIA. Now, CIA

insiders are claiming the attempted assassination of Charlie Kirk was a federally run operation from top to bottom — just like January 6th.

From a CIA spy plane circling within striking distance that morning to fresh revelations breaking now, the pattern is impossible to ignore. Those revelations have blown the lid off a covert CIA program at Utah Valley University in the months leading up to the assassination. Investigators found that a seemingly ordinary professor was actually a CIA asset — one of seven intelligence and security specialists quietly embedded in university roles related to campus security. When this network was exposed, their online profiles vanished. Scrubbed. Memory holed, as if they'd never existed.

According to those on the inside, Charlie Kirk was surrounded by snakes in his final months. From his own security team... to the power players circling TPUSA... to university staff who began laying the groundwork for his visit months in advance. The most explosive

revelations may not come from the usual suspects at all. They may come from inside his own home — from the family of his wife, Erica Kirk. A Deep State family, tied to the military-industrial complex... and with direct links to Israel. The implications are staggering.

It wasn't just the crowd crawling with feds — it was the skies. Last week we broke the story of a CIA spy plane near the scene. Now there's even more confirmation: Aircraft N1098L — a Bombardier Global 6500 with the callsign AXEL10 — loitered within visible range of Charlie Kirk's assassination as it happened. The Global 6500 isn't a commuter jet — it's a platform for military intelligence, surveillance, and even weaponized drone operations. On that day, its flight from Biggs Army Airfield to Glacier Park International Airport mysteriously deviated at the exact critical window.

Back on the ground, Charlie Kirk's security team moved with the precision of a choreographed play — like a football offense executing a drill. Yet, when you watch closely, their actions make no sense. As Kirk lay bleeding, the team closed in around him, appearing to render aid, but no one put pressure on the wound. Then (right in the middle of the chaos) one of his security guys makes a decision. Calm. Controlled. His hand rises to his Meta glasses and taps the record button. Was he starting to film the scene... or stopping a recording he didn't want anyone else to see?

This is truly bizarre behavior — and it's not just us saying it. Hundreds of forensics, crime scene, and security experts are calling it out as "not normal" right now. Exposing the crimes

Big Pharma's Greatest Fear: The Vaccine Study They Tried to Bury

The largest childhood vaccinated vs. unvaccinated study in U.S. history was discussed in Washington, D.C., on September 9, 2025, at the U.S. Senate's Permanent Subcommittee on Investigations. Chaired by Senator Ron Johnson, the never-before-discussed study, completed in 2020, was lead-authored by Dr. Marcus Zervos of Henry Ford Health. A regular recipient of funding from Big Pharma heavyweights, Zervos embarked on the study after speaking with Aaron Siri, Esq., lead attorney for the Informed Consent Action Network (ICAN) and ICAN CEO Del Bigtree, who challenged him that, if he is right and vaccines are indeed safe, the analysis would be a way to silence the "anti-vaxxers." Sounds like a great plan, right?

Instead of publishing the results, which overwhelmingly found that children who received one or more vaccines had dramatically higher rates of chronic illness, Zervos (apparently unhappy with the outcome) instead hid the study from the public. Nevertheless, thanks to ICAN and Siri, the measures and outcomes finally saw the light of day in the U.S. Senate.

On October 12th, ICAN will premiere a documentary on the study, titled "An Inconvenient Study." The website for the documentary notes: "In 2016, journalist Del Bigtree issued a challenge to the head of infectious disease at one of the most prestigious medical institutions in the world: conduct the most thorough vaxxed vs. unvaxxed study that has ever been done. The expert took up the challenge and ran the study to prove Del wrong. What the study



revealed was so horrifying that it was locked away, hidden from the public... until now."

Make no mistake, the sworn testimony reveals incredibly damning results that should have immediately become headline news, cautioning all parents to pay attention. The study covered 18,468 children born between 2000 and 2016 in the Michigan health system insurance population, of whom roughly 1,957 were never vaccinated, and 16,511 received at least one vaccine. The devastating findings revealed that those who were vaccinated had 329% more asthma, 203% more atopic disease, 496% more autoimmune disease, 435% more neurodevelopmental disorders, including dramatic spikes in development and speech delays.

Moreover, in situations where unvaccinated children had zero cases of ailments (including ADHD, intellectual disability, tics, learning disabilities, and brain dysfunction) there were hundreds among the vaccinated children. Sadly, after ten years, the study showed that 57% of vaccinated vs. 17% of unvaccinated kids had chronic illness.

Wow, those results are massively significant and have undoubtedly played a role in the chronic disease epidemic devastating our nation's children, which HHS Secretary

Robert F. Kennedy, Jr., has vowed to stop. Yet, no mainstream news outlet in the United States has reported on the study, its results or the hearing. An article in The Guardian briefly summarized the hearing. It dismissed the study's accuracy, highlighting that parents who do not vaccinate their children are also less likely to have their children treated for health conditions in the medical system. Thus, they contend, conditions that were not diagnosed or treated would not have shown up in the study, which relied on medical records, according to hearing testimony.

Still, both The Guardian and a report published by STAT failed to connect the dots to the fact that healthy children—in this case, those not vaccinated—don't need to go to the doctor as often for the treatment of adverse "health conditions." The STAT article, written by Jake Scott, an infectious disease doctor and clinical associate at Stanford School of Medicine and curator of the Controlled Vaccine Trial Database, noted of the study: "The most glaring problem is detection bias, which occurs when one group gets examined more frequently than another, leading to more diagnoses regardless of actual disease rates.

In the Henry Ford data, vaccinated children had substantially more health care visits than unvaccinated children. Conditions requiring clinical evaluations to diagnose – ADHD, learning disorders, speech delays, ear infections – will inevitably be recorded more often in the frequently seen group."

If the study is indeed flawed, then why hasn't Zervos chimed in following the hearing to say so? Think about it. If he is so sure that these results are of no concern to the health



of our nation's children that he was OK hiding them for years, he now has the perfect opportunity to speak up and reiterate his professional findings now. Yet, he and Henry Ford Health have remained silent. Silent on a now-exposed study that he conducted showing that 57% of vaccinated vs. 17% of unvaccinated kids had chronic illness. It makes no sense.

As we witnessed throughout the pandemic related to the dangerous and deadly experimental mRNA COVID-19 jabs, when a study with controversial or disruptive findings receives little to no media coverage, that in itself is incredibly telling. Indeed, media organizations that rely heavily on Big Pharma ad revenue are incentivized not to give credibility to findings that could undermine vaccine confidence and, by extension, the financial interests of their sponsors. Likewise, the selective focus on study flaws by those who reported on the study, without calling for transparent dialogue of the data, is undoubtedly a coordinated attempt to discredit or bury inconvenient results.

The legacy media's silence is an implicit acknowledgment that the study's findings are dangerous precisely because they contain truth. For those of us already skeptical of industry influence, the absence of open engagement is a significant red flag, proving that the institutions once entrusted with protecting public health are instead now blatantly protecting their benefactors.

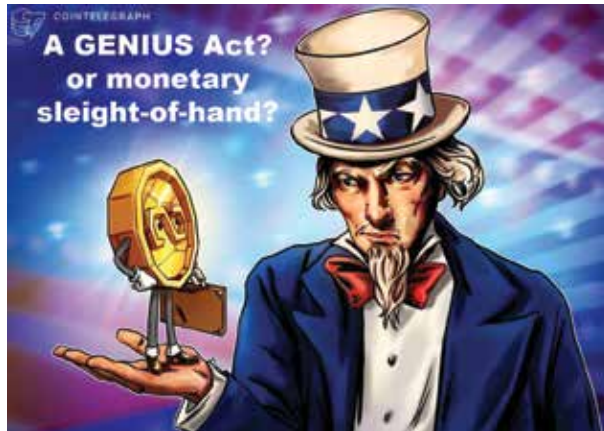

What the GENIUS Act Will Soon Bring

While Charlie Kirk's death is being used by political agents to attack freedom of speech and to further divide an already divided nation, many are wondering what happens next. Most financial analysts these days will tell you what's next, radical change in the US economy is coming.

Globalist equity firms are scooping up local energy companies across the country, and it looks like they're just getting started. The official reason is to invest in America's artificial intelligence (AI) infrastructure.

The buyouts are already triggering pushback and anxiety at the local level. The Associated Press recently reported that "private equity giants like BlackRock and Blackstone are buying local utilities to power AI-driven data centers, sparking ratepayer and regulator concerns."

Worries about rising power bills have been mounting in tandem with the buildup of AI data centers around the country. Earlier this year, the AP reported: "Rising power bills are something legislators have been hearing a lot about. ... More people are speaking out at the public utility commission in the past year than I've ever seen before," said Charlotte Shuff of the Oregon Citizens' Utility Board, a consumer

advocacy group. "There's a massive outcry... Tricia Pridemore, who sits on Georgia's Public Service Commission and is president of the National Association of Regulatory Utility Commissioners, pointed to an already tightened electricity supply and increasing costs for power lines, utility poles, transformers and generators as utilities replace aging equipment or harden it against extreme weather."

The AI race is well underway, and it's no surprise that these massive international asset firms, given their history, are eager to support a technology with unprecedented potential for surveillance, manipulation, and outright control. There's also the prospect of a great return on investment, which is the official primary goal of these equity firms. But, as history shows, these multi-trillion dollar entities are not afraid to throw around their monetary might and bully companies into incorporating into their brand political causes such as climate alarmism and the "trans" agenda.



BlackRock and Blackstone used to be the same company before separating in 1988. Together they control more than \$13 trillion in assets. The bulk of that, about \$12 trillion, is BlackRock's, while Blackstone has reported about \$1.2 trillion in assets. Only two countries have GDPs larger than \$13 trillion — the U.S. and China.

Scooping Up Utilities

The two behemoths are picking off utilities around the country. In January 2024, Blackstone bought a 20-percent stake in Northern Indiana Public Service Company for \$2.1 billion. The utility announced it planned to boost green energy production after Blackstone entered the picture.

A year later, in January of this year, Blackstone outright bought Potomac Energy Center, a natural-gas power plant in Loudoun County, Virginia, for \$1 billion. "The transaction represents Blackstone's most recent investment in the power infrastructure supporting data centers and AI revolution," Blackstone announced after the deal went through.

A few months later, in March 2025, Wisconsin's Public Service Commission approved the buyout

of Superior Water, Light and Power by Canada Pension Plan Investment Board and BlackRock subsidiary Global Infrastructure Partners. BlackRock walked away from the deal with a majority interest, a 60-percent stake of the utility. The Canada Pension Plan Investment Board, by the way, is essentially controlled by Canada's socialist government.

Just last month, Blackstone bought Hill Top Energy Center, a natural-gas power plant in Pennsylvania, for \$1 billion. Blackstone executives Bilal Khan and Mark Zhu said the buyout is all about AI. "The electricity infrastructure required to power the AI revolution requires a tremendous amount of capital. We are proud to make our latest investment in this sector," they said in a statement.

Appears to be just the beginning.

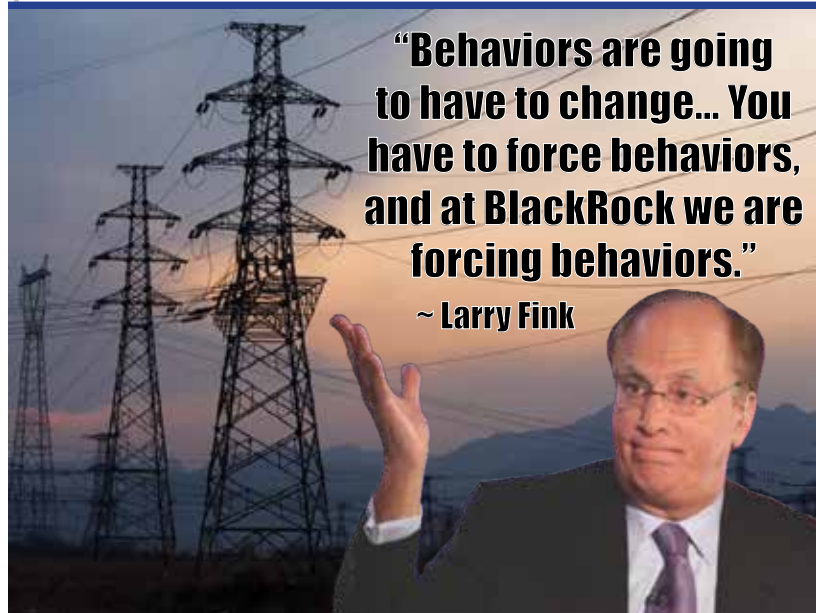

Currently, Blackstone is seeking regulatory permission to buy out a pair of utilities, “Albuquerque-based Public Service Company of New Mexico and Lewisville, Texas-based Texas New Mexico Power Co.,” according to reports. Public Service Company is the largest electricity company in New Mexico.

However, an attempt by BlackRock and the Canada Pension Plan Investment Board to buy the parent company of a Minnesota utility has run into some turbulence. The AP reports: “A fight has erupted in Minnesota over the buyout of the parent of Duluth-based Minnesota Power and the outcome could determine how such firms expand their holdings in an industry that’s a nexus between regular people, gargantuan data centers and the power sources they share.” If the Minnesota utility sale goes through, BlackRock will have the majority stake.

Valid Concerns

People who oppose these buyouts have practical, short-term concerns. They worry their energy bills will rise and the quality of service will drop. Before BlackRock bought Superior Water, Light and Power, Superior City Councilor Ruth Ludwig expressed the following concern:

“Lake Superior, the largest freshwater lake in the world by surface area, is a gift to the state of Wisconsin. I do not want a multi-

corporation whose board members know nothing about the community of Superior, Wisconsin, nor the people of the state of Wisconsin, whose main interest is making a profit for their stockholders to have control over my community’s drinking water system.”

Regarding the Minnesota deal that’s stirring up friction, Administrative Law Judge Megan J. McKenzie wrote in a report that the buyout may raise rates, reduce reliability, and, perhaps, jeopardize compliance with Minnesota’s carbon-free power standard, according to reports. BlackRock said the judge is wrong, that her report “does not even attempt to provide a meaningful discussion of the evidence, arguments and counterarguments.”

In addition to the current parent company of the Minnesota utility, labor unions and clean-energy groups also support the sale. According to reports, they argue “that deep-pocketed owners enable rather than curtail the massive investments in new energy generation, transmission and distribution infrastructure Minnesota Power needs to meet a state mandate to produce 100% of its electricity from carbon-free sources by 2040.” The transition to clean energy is the main argument advocates espouse.

Pushing ESG

BlackRock and Blackstone have already shown they are willing to force progressive values once they buy big stakes in companies. They both have infused environmental, social, and governance (ESG) factors into their investment strategies and

pushed the LGBTQ agenda.

BlackRock CEO Larry Fink has bragged multiple times that he has no problem with forcing “behavioral changes.” He said during a 2017 discussion hosted by The New York Times, “Behaviors are going to have to change, and this is one thing that we are asking companies. You have to force behaviors, and at BlackRock we are forcing behaviors.”

Globalist Agenda

Fink is a globalist caricature. He sits on the board of the globalist Council on Foreign Relations (CFR), which is essentially the Deep State’s nervous system in the U.S. He’s a member of the Trilateral Commission, a more-exclusive group of elite globalists. He also happens to be the new CEO of the World Economic Forum (WEF), an outfit of millionaires, billionaires, and political figures that has openly admitted to wanting a world in which regular people will own nothing.

The CEO of Blackstone is Stephen Schwarzman. Like Fink, he’s a CFR member and a member of the WEF.

These giant firms, along with others, have shown they have no problem with coercing the world into implementing their agenda. The more control they assume over infrastructure and institutions, the easier that becomes.

BlackRock and Blackstone are not only working toward control of the companies that power everyday homes, but they’ve invested through various subsidiaries, in real estate — lots of it. They’ve bought commercial properties, farmland, timberland, and even single-family homes. Of course they’re investing in AI, an emerging technology that promises to change the way we do nearly everything.

Based on their track record, these companies cannot be trusted to prioritize the needs and concerns of everyday people. Citizens who know the truth about these companies should help others in their community understand what they’re really about. Let's Play Double Jeopardy

"What does No Due Process in Quartzsite look like?"

Update on the saga about the abatement ("the taking") of Mike Roth's private property in Quartzsite. (See our April, May and June issues for previous reports.)

As a quick review, in late February of this year Mr. Roth was sentenced for his "crime" of having a junkyard, aka various Code violations. His sentence? No jail time because the Town stipulated at the start that there wouldn't be jail time. (A clever move by the Town to prevent Mr. Roth from being assigned a Public Defender?) Instead, the Town asked for, and was granted, 180 days to abate Mr. Roth's property.

Mr. Roth did not appeal his sentence at that time. So the abatement should have ended in late August when Mr. Roth's sentence ended, but it didn't. In late July, the Town's Hired Gun Prosecutor, Justin Petersen, filed a Motion requesting an additional 90 days to abate Mr. Roth's property. (Incidentally, Prosecutor Petersen works for the same law firm as Town Attorney Joe Estes, who took an active role in raiding Mr. Roth's property. Does Petersen have a Conflict of Interest here, acting as Estes' wingman?)

Essentially Petersen asked to add 90 days to Mr. Roth's sentence. Mr. Roth's claim is that this is Double Jeopardy. "The Double Jeopardy Clause of the Fifth Amendment of the U.S. Constitution protects against being prosecuted twice for the same crime." (https://www.law.cornell.edu/wex/double_jeopardy)

He argues that if he had been sentenced to 180 days in jail, but then, just as his sentence was ending, the State asked to extend his sentence, that would be unconstitutional. He

says the same is true adding to this sentence.

Surprisingly, the judge in this case, Judge Putz-Artrup, summarily granted Prosecutor Petersen's Motion. Without any explanation.

Roth thinks it's just one government actor granting a favor to another. More surprisingly Judge Putz-Artrup granted Petersen's Motion the day after it was received! Without waiting for Mr. Roth to respond! That's a violation of Due Process!

Mr. Roth immediately filed an Emergency Ex Parte Motion asking the judge to correct his illegal granting of Petersen's Motion. (Ex Parte means "without the other party." Here there was no need to hear from Petersen because it was the judge who violated the law.) Even though Roth specifically filed an Ex Parte Motion, this time Judge Putz-A waited ten days for Petersen to respond. (*Diff'rent Strokes for Diff'rent Folks?*)

Unsurprisingly, even though Petersen didn't respond (i.e., object) to the Motion, Judge Putz-Artrup again summarily denied Roth's Motion, again without explanation. (In the way a parent tells his children "Because I said so, that's why!" when challenged about a bad decision, according to Mr. Roth.)

according to Mr. Roth.)

After Judge Putz-Artrup refused to correct his error, Mr. Roth filed four sequential motions at once. The first was for a Stay of the Abatement while the subsequent motions were being considered. Then a Motion for

Judge Putz-Artrup to recuse himself. (For demonstrated judicial misconduct, ruling on a Motion before Mr. Roth filed a response.) Then two-like Motions to vacate the Extension of Time, the first based on the fatal error of granting the Town an extension before Mr. Roth was heard, the

second on Double Jeopardy grounds or professional misconduct by Petersen.

As for the professional misconduct claim, the Arizona Supreme Court Ethics Rules for lawyers (an Oxymoron?) says "It is professional misconduct for a lawyer to engage in conduct involving dishonesty, fraud, deceit or misrepresentation." (ER 8.4)

Now, in his Motion for an Extension of Time, Prosecutor Petersen told the judge "During its initial abatement efforts, the Town discovered the cleanup is significantly more substantial than anticipated." Never mind that the Town knew last year what it wanted to remove, per twenty photos submitted in court. "Moreover, the summer heat has compounded issues by preventing workers from being on site for the long hours needed to complete the abatement."

Doesn't it sound like Petersen is saying "the Town has been hard at work abating Mr. Roth's property, but it's a lot of work and those poor

workers can't work those long hours in the summer heat?"

This is how Mr. Roth (and other locals who know that the Town has hardly worked at all) understand it. So in his multi-motion, Mr. Roth included a public record

showing that the Town has worked only TWO days abating his property. In the early spring, well before summer!

Unsurprisingly, Judge Putz-Artrup did not recuse himself, did not uphold public confidence in the judiciary. Instead he again summarily ruled against all of Mr. Roth's Motions. Again without explanation. Mr. Roth has filed a Notice of Appeal to fight the Extension of Time given to the Town. He believes that the abatement ended a month ago when his sentence ended.

Generals Gathered in Their Masses...

On Tuesday we observed one of the strangest spectacles of our time. President Trump and his “Secretary of War,” Pete Hegseth, called a mandatory meeting of all the top brass in the US military. Some 800+ general officers, admirals, and the like gathered at Marine Corps Base Quantico in Virginia for a doubleheader talk from Hegseth and Trump. Because such an event is nearly unprecedented – at least in peacetime – the days leading up to the meeting were increasingly filled with speculation and even dread.

Tensions between the US and Russia are soaring over reports that the Trump Administration may provide and assist in the launching of Tomahawk missiles – capable of both hitting Moscow and of carrying nuclear weapons. The Putin Administration pointed out the obvious: such weapons would require the active participation of US intelligence as well as trained US or NATO personnel and should they be used would bring Russia and the US/NATO to a state of war. It is a war that, given both US and Russian nuclear doctrine, could very quickly rise to the level of an exchange of nuclear weapons and total destruction.

Likewise, media reports and observers of the movement of military equipment have been raising a red flag over the past several days on the massive movement of US fighter jets and aerial refueling

tankers from the US toward the Middle East. Observers point out the similarity to the days leading up to the US attack on Iran in late June, just over three months ago. With Israeli president Benjamin Netanyahu in town earlier this week, has President Trump been talked into again joining Israel in its war on its neighbors?

Additionally, US warships have been gathered off the coast of Venezuela for weeks and at least three speedboats accused of running



narcotics have been blown out of the water by the US military. The New York Times reported on stepped up US efforts to overthrow the Venezuelan government and install a new leader (as the Trump team attempted and failed in his first term). Media outlets are reporting that the Trump Administration is even considering military strikes deep inside Venezuela, which would of course be unprovoked acts of war.

What to expect of the gathering of the generals? Many of us waited at the edge of our seats. What we were able to see was a pair of not particularly well-prepared – and less well-received – speeches by Trump and Hegseth on transforming the US military into a “MAGA” force and the evils of late middle-aged rotundity among senior military personnel. The crass treatment of America’s top military officers (whether some deserved criticism or not) will likely have an effect opposite of what was intended.

The pauses in the pre-prepared speeches meant to allow for applause were met with stony silence. Fat-shaming and chest-pounding is not the way to go about building esprit de corps in the US military. Especially when such a dressing-down was broadcast to the rest of the country via live video hook-up.

What if some of our initial sense of dread was not misplaced? In his essential Sonar21 blog, former CIA officer Larry Johnson wonders whether there was a (very) public message delivered to conceal a secret and more dangerous message. First Johnson quotes Yves Smith of the Naked Capitalist blog: “After Charlie Kirk, perhaps I have become too fond of complicated theories, but it’s ludicrous to have called so many senior guys in for such a silly agenda. A stern memo and/or video sessions would have done the job. So the big stoopid meeting (IMHO) was to cover for a smaller gathering that had to be done in person, and



where whoever was summoned would be a big tell as to what the focus was.”

Johnson then signals his agreement with the speculation: “No, Yves... I think you nailed it. Besides the massive US naval force parked off the coast of Venezuela, we are now hearing that US tanker aircraft are flying to the Middle East via England. We saw the same phenomena in the days preceding the June 24 attack on Iran.”

If the Trump administration is planning a coordinated attack on Venezuela and Iran, the commanders of USCENTCOM and USSOUTHCOM would be involved. While the plans for such attacks could have been discussed over a SVTCS (i.e., Secure Video Teleconferences), those sessions usually have dozens of straphangers watching. If you want to keep a close hold on such planning, you do it in person. If the CENTCOM and SOUTHCOM commanders had been called to Washington alone, the odds are high that someone would have reported this. With the presence of the US naval force off the coast of Venezuela and the movement of US aircraft towards the Persian Gulf, this likely would have attracted unwanted attention... Well played Ms. Smith!

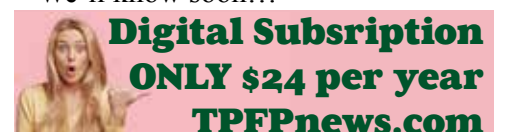
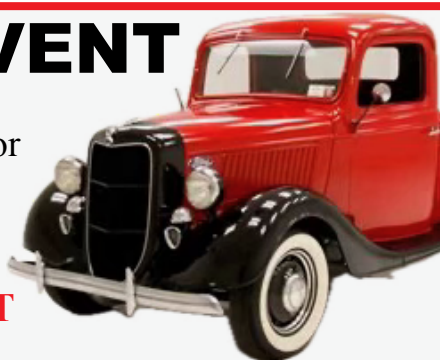

Trump Blasts UN, Then Says U.S. "Behind the United Nations 100 Percent"

banking, legal, or Jewish institutions. Kash Patel condemned previous FBI partnerships as dangerous activism.

Public figures like Elon Musk and Glenn Greenwald accuse the ADL of exerting undue influence on law enforcement and social media platforms, pushing for the removal of groups and individuals labeled extremist. The SPLC's "hate map" and the ADL's now-removed "Glossary of Extremism" contributed to controversy, particularly after TPUSA's founder Charlie Kirk was assassinated. Patel said both groups were too partisan and smeared mainstream Americans, making them unfit for partnership. Despite claims of separation, both organizations have deep, historical ties to the FBI and political actors, sparking concerns about continued behind-the-scenes influence.

UK Goes Orwellian, Pushes Mandatory Digital ID and Biometric Tracking Using Lies about Migrants

The UK government is introducing a mandatory digital ID, the "Brit Card," tied to biometric tracking via the UK One Login system. Prime Minister Keir Starmer claims it will prevent illegal migrants from working, but critics argue most migrants are legally admitted and the ID won't address mass migration. The program faces strong backlash, with concerns it expands government surveillance and control over citizens, potentially limiting access to work, services, and personal freedoms. Similar schemes in Europe have not improved immigration control. The Brit Card is criticized as a deceptive move to placate public anger while increasing state power.

Stablecoin Tether Expands Hard Asset Strategy with More Bitcoin, Gold, and Land

Tether has boosted its hard asset strategy, acquiring 8,888 more Bitcoin to hold over 86,000 BTC (worth over \$9.7 billion), with claims of owning more than 100,000 BTC plus 50 tons of gold. It has also bought a majority stake in South American

agribusiness Adecoagro, gaining control of 210,000 hectares of farmland in Argentina, Brazil, and Uruguay. Beyond US Treasuries, Tether is investing heavily in Bitcoin, gold, and land as diversification and inflation hedges. This approach sets it apart from stablecoin rivals and positions Tether as a major, resource-backed player in the \$300 billion stablecoin sector.

Pfizer Strikes \$70 Billion Deal with US to Expand Its mRNA Empire, Lower Drug Prices

Pfizer reached a \$70 billion deal with the Trump administration to lower drug prices, revive U.S. manufacturing, and secure "most-favored-nation" pricing for new medicines. In return for tariff relief, Pfizer will focus on expanding gene-based injectable products for cancer, obesity, and chronic diseases, along with broader mRNA vaccine development. Critics argue this entrenches Pfizer's controversial gene-transfer platforms, which have been linked to widespread injuries and deaths. The agreement grants Pfizer regulatory protection and government support, raising concerns about lack of accountability and the company's continued influence over U.S. healthcare policy.

Trump's Gaza Plan: Peace as Control, Not Accountability

Trump's Gaza peace plan proposes a transitional governance led by a "Board of Peace" chaired by Trump and Tony Blair, focusing on deradicalization, redevelopment, and international control rather than Palestinian accountability or self-determination. The plan includes staged withdrawals, prisoner and hostage exchanges, aid through international agencies, and security forces directed by the U.S. Critics argue it treats Gaza as an administrative project managed externally, prioritizing investment and stability over justice, and ignores Palestinian rights and legal accountability for war crimes. The proposal is widely viewed as a framework for indefinite foreign oversight, not genuine resolution or autonomy.

Government Education is Unconstitutional, Says Top US

Law Professor

Liberty University Law Professor Jeffrey Tuomala argues that government-funded education is unconstitutional, claiming it serves as an establishment of religion and violates the First Amendment. He contends public schools impose secular or even pagan values on children as if they are the only truth, mirroring prohibited state-sponsored religion. Tuomala cites Founding Fathers Jefferson and Madison, who supported religious freedom and defined religion broadly. He urges replacing public schools with privately funded institutions, arguing only such a system respects constitutional boundaries. Other legal experts, including former Attorney General Bill Barr, have echoed that government education poses a threat to religious liberty.

New CBS owner David Ellison met with top Israeli general in scheme to spy on Americans

Leaked emails reveal new Paramount owner David Ellison met with Israeli officials, including ex-Defense Minister Benny Gantz, to support a covert Israeli scheme—dubbed "12 Tribes"—to surveil and suppress pro-Palestine activism in the US. The operation sought funding from Jewish billionaires like Ellison's father, Oracle founder Larry Ellison, and others, aiming to use Israeli intelligence-linked firms to spy on Americans involved with the BDS movement. Ultra-wealthy pro-Israel donors now try to control alternative media and US public opinion, especially after the assassination of Charlie Kirk—revealing waning US youth support for Israel.

Israeli strategy now emphasizes dominance, demanding submission internally and abroad, with war seen as a means of subjugation. The ultimate goal is to prevent rivals like Russia and China from regaining influence in the Middle East.

What Happened to America First?

A skilled national security team, as with Bush, doesn't ensure wise policy: experienced advisers led America into disastrous wars. Journalists criticize Trump's current team for inexperience, but the real issue is policy direction. US foreign policy is dominated by neoconservatism and liberal interventionism—both favor military intervention, sometimes under the guise of humanitarianism. Realism, which prioritizes core interests and stability, is often missing. Despite the rhetoric, Trump's "America First" largely maintains neoconservative policies. Familiar interventionist strategies persist under Trump, especially in Ukraine and elsewhere. Ultimately, Trump's decision—not his team's experience—will shape US involvement in future wars.

GOP Obamacare Surrender

Despite years of pledging to repeal Obamacare, Republicans have now effectively accepted Biden-era expanded Obamacare subsidies, marking a major shift in the party's position. Instead of repealing the law, GOP leaders now focus on negotiating extension terms and ensuring illegal immigrants are barred from benefits. Ron Paul argues this is a historic surrender: Republicans have gradually moved from repeal, to partial changes, to de facto support. He blames government intervention for healthcare's problems and contends that real reform requires embracing free-market solutions like health savings accounts to truly advance liberty and reduce government control.





Agenda 2030 Exposed

Film review: *The Agenda: Their Vision, Your Future*, by Oracle Films, 1 hour, 52 minutes, 2025.

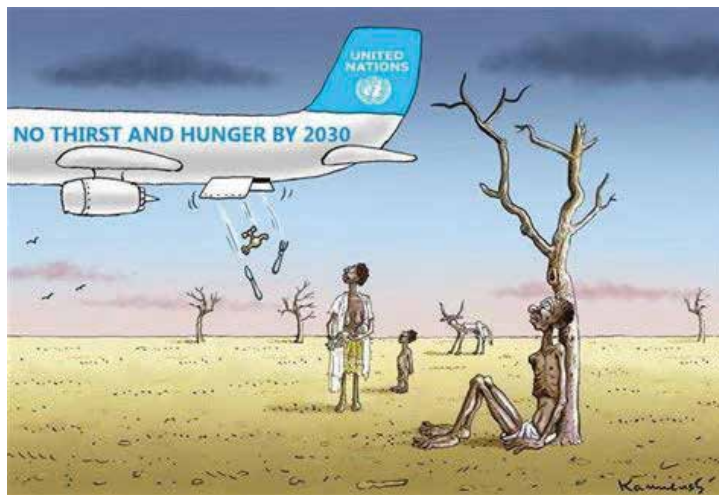

The Agenda: Their Vision, Your Future is a two-hour crash course in how globalist oligarchs and international bankers are now implementing totalitarian world government. With merciless precision, the film reveals that absolute control of humankind is well within the reach of those who strive for the technologically advanced dystopia envisioned in Aldous Huxley's Brave New World. But this is no futuristic sci-fi or theoretical dissertation; it is a warning that we will only have our apathy to blame if we do not push back now. Time is alarmingly short.

Narrated by British actress Badria Timimi and produced by British media executive Mark Sharman, the documentary pulls no punches. Everything that should be said, is said: No climate emergency exists; "sustainable development" is a ruse for implementing a surveillance state; and social engineers, or "technocrats," are stealthily enacting their plans right under our noses. In fact, for the most part, we welcome their shackles for the sake of convenience and a false sense of security.

Though Sharman self-funded his work, his extensive experience in television news and sports coverage

shows in the film's high-quality production and creative storytelling. Interviews with experts such as Patrick Wood, author of Technocracy Rising: The Trojan Horse of Global Transformation; Solari Report investment banker Catherine Austin Fitts; and The New American senior editor Alex Newman bring credence to a presentation that scoffers might otherwise dismiss as "conspiracy theory." The documentary answers that charge head on, exposing globalists who proudly proclaim their intentions.



From the Horse's Mouth

One such bold admission came during the World Government Summit 2022 in Dubai, during a session entitled "Are We Ready for a New World Order?"

"We are on the brink of a dramatic change where we are about to — and I'll say this boldly — we're about to abandon the traditional system of money and accounting and introduce a new one ... what we call blockchain," stated an exuberant Dr. Pippa Malmgren, former economic

advisor to U.S. President George W. Bush and daughter of a senior aide to Presidents John F. Kennedy, Lyndon Johnson, Richard Nixon, and Gerald Ford. The significance of this digital currency, she said, is that governments can more easily track their citizens.

Other proponents of a central bank digital currency (CBDC) agree. Bo Li, deputy managing director of the International Monetary Fund, bragged in 2023 that a programmable CBDC allows for dictating how, when, where, and why money is spent. Digital expiration dates make it impossible to save for a rainy day; money can be turned "on" or "off" at the whim of the issuing bank; and taxes, fees, fines, and garnishments could be involuntarily withdrawn. Lest there be any delusions of independence, Agustín Carstens, general manager of the Bank for International Settlements, announced in 2020 that, regarding CBDCs, the "central bank will have absolute control."

Bravo to The Agenda for broadcasting quotes such as these, largely ignored by major media, where a central bank digital currency is often heralded as a safer, more secure, convenient, and reliable system than cash or unregulated, decentralized cryptocurrency.

Meanwhile, the digital public infrastructure for a CBDC is quickly falling into place. Wireless networks, smart meters, Ring cameras, and GPS systems already track us in our homes, at work, and on the road. Naturally, these measures are touted to "help" by improving safety, better managing resources, and paving the way for "sustainable development." Consider Elon Musk's driverless Tesla Robotaxis, now available in Atlanta, Austin, Phoenix, San Francisco, and Los Angeles. Each city has "geofencing" set up to contain the automated vehicles. Central banks could just as easily use this invisible barrier to control where and how you spend your CBDCs.

Geofencing can also pair with digital IDs to demarcate the boundaries

of your open-air prison, otherwise known as a 15-minute city. For now, REAL ID — enforced by the Trump administration earlier this year despite ongoing bipartisan pushback — is the only requisite for boarding domestic flights and entering federal facilities. However, the legislation enacting this federal ID system, which Congress passed supposedly to protect us from international terrorists, provides for future expansion of "official purposes" for its privacy infringing digital shackles. (The REAL ID Act also authorizes the government to collect biometric data for facial recognition and citizen surveillance.)

Could REAL ID "official purposes" one day include things such as healthcare, education, employment, and banking? Covid lockdowns answer that question, as does the haunting parallel between the yellow star now emblazoned on all REAL ID-compliant state driver's licenses, and the yellow-star badges that Jews in Germany wore during World War II.

17 Steps to Dystopia

Through technology, our modern slave masters have the ability to add a more personalized touch to today's branding. The 17 goals seem to describe a veritable utopia, with aims such as “no poverty,” “zero hunger,” and “affordable and clean energy.” The Agenda masterfully explains, with painstaking documentation, that each SDG is Orwellian double-speak for its opposite. Water management really means water rationing; the same goes for energy management. “Gender equality” actually stands for obliteration of the nuclear family. “Responsible consumption” indicates destruction of farming in favor of food fabricated in labs. “Net Zero” portends scarcity for all but the elite, who will impose their tyranny through advanced technology and artificial intelligence (AI).

“We’ve developed the camera into a sensor,” boasts a spokesman for Axis Communications, a Japanese manufacturer of AI optical surveillance products, in an advertisement replayed in *The Agenda*. The sensor he’s plugging not only captures video, but “with deep learning capability, the camera is able to generate accurate and trustworthy data and send notifications in order to take action.” What action? The spokesman doesn’t say, but he does point out that “since our cameras have open technology, we can work with different analytic partners from all over the world. And together, we can do just about anything we want.” Could “anything we want” mean rationing meat, eggs, fish, and dairy? The UN acknowledges rising demand for these nutrient-dense foods, but warned in July that “direct greenhouse gas (GHG) emissions” from cultivating them “are set to rise by six percent by 2034.” Its beef is with rich nations. The UN Food and Agriculture Organization has long called for ag production to be scaled back in wealthy countries, which it blames for the so-called threats to climate that these GHGs allegedly pose.

Maybe “anything we want” also includes “putting water management at the center of the climate change

fight,” the theme of the 35th annual World Water Week in Stockholm this past August. Predictably, world leaders recommend that “rich” nations help the less fortunate in “building resilience against climate change” and finding “collaborative solutions to water and sanitation financing gaps.”



This is, of course, an example of using so-called climate change as an excuse to demand ever more foreign aid, which enriches oligarchs on the backs of taxpayers. Indeed, foreign subsidies more often end up lining the pockets of corrupt regimes rather than promoting economic development or alleviating suffering. In 1989, a House Foreign Affairs Committee report noted that U.S. aid programs “no longer either advance U.S. interests abroad or promote economic development.” Later, the Clinton administration agreed that, despite “decades of foreign assistance, most of Africa and parts of Latin America, Asia, and the Middle East are economically worse off today than they were 20 years ago.”

Nothing has changed since. Former World Bank economist William Easterly exposed the disastrous consequences of Western aid in his 2006 book *The White Man’s Burden: Why the West’s Efforts to Aid the Rest Have Done So Much Ill and So Little Good*. Baroness Dambisa Moyo followed in 2010 with *Dead Aid*, which revealed that the more than \$1 trillion sent to Africa since the 1960s has only fueled corruption and economic stagnation. More recently, the Trump administration has uncovered the waste, fraud, and abuse rampant in USAID (the U.S. Agency for Inter-

national Development), leading to such scandals as hundreds of millions of dollars being diverted to the Taliban, and additional millions to EcoHealth Alliance, the non-profit with Covid ties to the Wuhan Institute of Virology in China.

The Fake Crisis

Just as “foreign aid” is a scam to trick U.S. taxpayers into financing their own destruction, “sustainable development” is a hoax intended to silence dissent while international oligarchs siphon away our constitutionally protected rights under the banner of saving Mother Earth.

The second half of *The Agenda* exposes this hoax. Climate change is a fabricated crisis, Net Zero is both physically and fiscally impossible, and pursuing it spells doom for energy production and agriculture, and, therefore, our very lives. We can thank a well-funded climate lobby for perpetuating the alarmist narrative by brainwashing youth and propelling us toward the true, anti-human end goal of Agenda 2030.

“I think these ideas have spread like bad viruses, and there’s been a lot of investment in promoting some extraordinarily weak ideas,” says Nick Hudson, a private equity investor interviewed in *The Agenda*. He chairs the independent think tank PANDA (Pandemics Data & Analytics), established in April 2020 by “professionals who perceived the global pandemic reactions as overwrought and damaging,” according to the group’s

LinkedIn page.

“Sitting at the top of all of these very bad ideas is one giant one which we can call anti-humanism,” Hudson explains. “Transhumanism, the ‘trans’ phenomenon, Net Zero, lockdowns, population reduction — all of these ideas are basically the ugly stepchildren of anti-humanism.”

Hudson goes on to describe two competing camps in today’s world. One sees humans as the “best feature of the observable universe,” creative, ingenious, and worthy of being revered and cherished. “We should plan for their flourishing,” he says, and “for the flourishing of as many people as possible.”

One-worlders, on the other hand, disrespect life and civil liberties, and seek to impose destructive “top-down, one-size-fits-all policies on humanity.” This camp, Hudson says, is made up of “people who regard humans as the scum on the surface of the little blue dot — people who regard humanity as some kind of blight — people who believe that the Earth needs rights to protect it from these horrible humans... I think it is a deeply sad reflection of the state of our societies that so many people live in the latter camp,” he adds, “I’m definitely not one of them.”

Nor are those who produced *The Agenda*, the latest documentary from Oracle Films. Conclusion

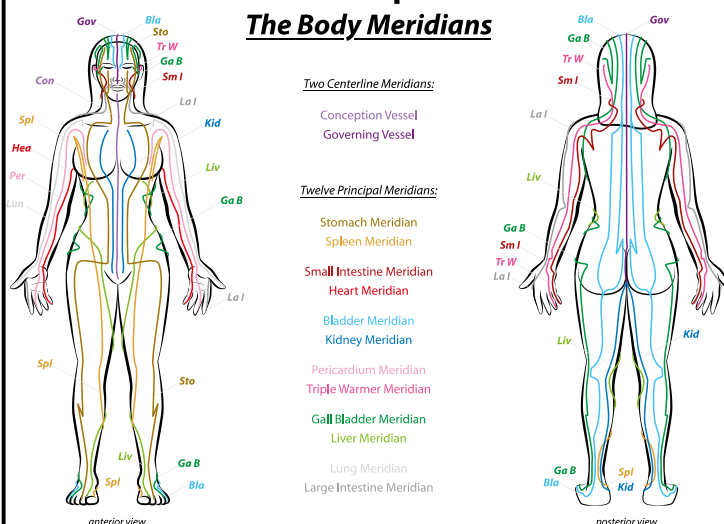

Israel Attacked 6 Countries!

In the past 72 hours, Israel has expanded its military campaign across six countries—Palestine, Lebanon, Syria, Tunisia, Qatar, and Yemen—marking one of its widest regional offensives in recent years. The strikes collectively signal a significant escalation of hostilities beyond Gaza, drawing widespread condemnation and fears of broader regional instability.

The most unprecedented attack occurred in Qatar's capital, Doha, when Israeli warplanes targeted a Hamas leadership compound during a ceasefire negotiation meeting. Six people were killed, including the son

of senior Hamas leader Khalil al-Hayya and a Qatari security officer, though top Hamas figures reportedly survived. This marked Israel's first-ever strike inside Qatar, a nation that hosts U.S.-brokered mediation efforts and the American CENTCOM base.

In Gaza, Israeli bombardment has continued relentlessly, killing at least 150 people and wounding more than 540 since Monday. Airstrikes have targeted high-rise buildings, displaced thousands, and worsened famine conditions. Since the war began in October 2023, more than 64,000 Palestinians have been killed, including hundreds from starvation.



Despite a ceasefire agreement signed in November, Israel has also resumed attacks in Lebanon.

Airstrikes in the Bekaa and Hermel districts killed at least five people, with Israel claiming to hit Hezbollah weapons depots. A drone later struck near the village of Barja, south of Beirut, injuring a Hezbollah member. These operations violate the truce and highlight escalating border tensions.

In Syria, Israel bombed military installations in Homs and Latakia, targeting a Syrian air force base and a barracks. The Syrian Ministry of Foreign Affairs condemned the raids as a "blatant violation" of sovereignty. Monitoring groups report Israel has conducted nearly 100

attacks in Syria this year alone, destroying more than 130 sites.

In Tunisia, two ships belonging to the Gaza-bound Global Sumud Flotilla were attacked by suspected Israeli drones near the port of Sidi Bou Said. Though no casualties were reported, fires damaged both vessels, continuing Israel's history of intercepting pro-Gaza flotillas.

Finally, in Yemen, Israeli jets struck Houthi positions at Sanaa airport, the second such attack this month. The ongoing regional strikes underscore Israel's expanding military reach and growing confrontation with armed groups across the Middle East.





REAL ID, Real Idiocracy

Walk through any major U.S. airport, and you'll see Homeland Security Secretary Kristi Noem's daytime soap face beaming down at you from an overhead monitor. "If you plan on traveling, we need your help to prevent delays and to prove your identity," she cajoles. "These IDs keep our country safe, because they help prevent fraud, and they enhance security." Lest anyone object, she adds the resistance-stifling appeal, "Please do your part to protect our country!"

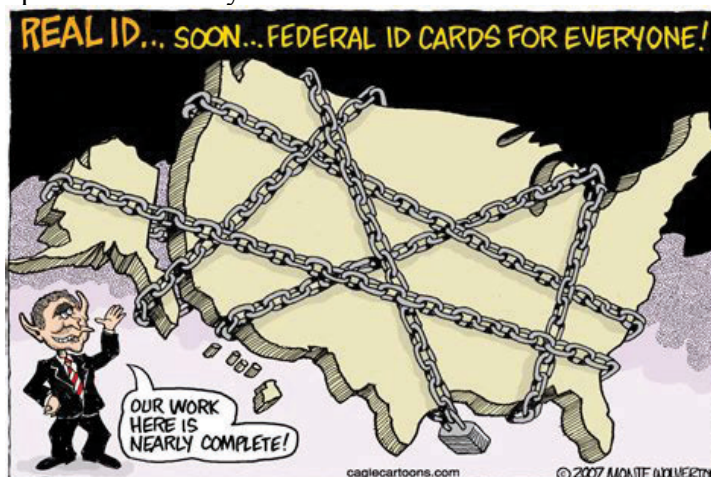
Noem is stumping for REAL ID, a high-tech form of federally compliant state-issued identification that's reputedly more secure than a standard-issue driver's license. Former U.S. President George W. Bush signed the REAL ID Act in 2005 in answer to recommendations from his 9/11 Commission. The law was to have been implemented in 2008, but political resistance and logistical challenges stood in the way.

Not anymore! Noem, the former South Dakota governor who infamously told her state's landowners, "I can't fight all your battles!" when they begged for her help against eminent domain for carbon-capture pipelines, is once again showing her penchant for tyranny. The illegal-alien crisis is her excuse for imposing REAL ID as mandatory for domestic air travel.

"Under Biden, illegal aliens used non-compliant IDs from sanctuary cities to board flights, but REAL ID's higher security standards

make it nearly impossible to forge legitimate documents, ensuring only verified travelers can fly," reads a Department of Homeland Security (DHS) memo cited by Fox News. "This closes the gaping vulnerabilities Biden's policies created, preventing criminals and potential terrorists from exploiting our aviation system, as seen during 9/11 when fraudulent IDs enabled attacks."

Like Noem's airport announcement, these lines are extraordinary in that there is not a shred of truth in them. Until this past January, the Transportation Security Administration



(TSA) accepted the "CBP One" app as ID for illegals on domestic flights. U.S. Customs and Border Protection (CBP) launched the app in 2020 to collect migrants' self-reported information. The Trump administration wisely pulled the plug on that ludicrous security breach, so the gap is finally closed.

Why are our state-issued driver's licenses now considered inferior? Because they're more easily faked than REAL ID? That's what DHS claims, but it's not true. Cyber Defense Magazine reported in June that

IDScan.net, an AI-powered identity verification and security platform, tested 170 million credentials and "found that REAL IDs were actually 36% more likely to be flagged as fraudulent. This means that while the process for obtaining a legitimate REAL ID is more rigorous, fraudsters are having no trouble faking identity documents claiming to be REAL ID compliant."

TSA still accepts foreign government-issued passports in lieu of REAL ID, but those do not reveal an individual's legal status in this country. "Can an undocumented immigrant fly within the U.S. in

2025?" asks EMPLawFirm.com, where attorneys offer legal services to illegal aliens. "If you are an undocumented immigrant with a valid passport from your home country," answers the site, "there is a good chance you can get on a plane without issues."

It worked for the 9/11 terrorists. "None of the 9/11 hijackers used fake IDs or pretended to be someone else when they checked in and boarded their flights," explains Connor O'Keeffe of the Mises Institute. "All of the hijackers who were asked to show ID presented legitimate forms of identification — mostly foreign passports." Looks like Noem's agency is woefully uninformed.

As for the DHS claim of "non-compliant IDs from sanctuary cities," locally issued credentials have always been "non-compliant" for TSA airport checkpoints. Alternatively, if unscrupulous clerks in sanctuary cities issued fraudulent state IDs, shouldn't Noem's beef be with them? Why is she instead tightening the noose on the rest of us? Isn't that similar to quarantining healthy people during a pandemic?

What Noem doesn't explain in her airport PR spiel is why REAL ID is still necessary after 24 years of unmolested air travel. Bush's 9/11

Commission claimed that such Patriot Act-style violations of Americans' constitutionally protected rights were the only thing standing between us and repeated terrorist attacks. Yet the traditional system has been working well since publication of the commission's Chicken Little assessment.

Could Noem have another motive? The thinking traveler, watching her talking head on the airport's Oceanic telescreen, may ponder her reasons for trying to sell Americans on something Congress passed into law 20 years ago. "The lady doth protest too much, methinks."

The REAL Reason

As Congress debated the REAL ID Act in 2005, strange bedfellows united in opposition: from the American Civil Liberties Union to the American Conservative Union; from the National Organization for Women to Gun Owners of America and The John Birch Society. Republican Senator Lamar Alexander of Tennessee spoke against it: "This really is a national identification card for the United States of America for the first time in our history." His colleague, Democratic Senator Patty Murray of Washington, called it a gross federal overreach and a violation of privacy.

After passage, 40 states answered with laws prohibiting compliance or resolutions rejecting the measure. In response, the Department of Homeland Security continued to issue compliance deadline extensions but never reneged. In 2017, 116 Pennsylvania legislators petitioned President Donald Trump, noting that "by federalizing driver licensing, the REAL ID Act usurps this power which has been reserved to the states."

REAL ID, Real Idiocracy!

So much for the 10th Amendment, but REAL ID doesn't stop there. It also violates the Fourth Amendment and promises further privacy abuses. "Federal law allows future expansion of the 'official purposes' of the REAL ID," explains the Citizens' Council for Health Freedom (CCHF). "Beyond boarding flights and entering federal buildings, these purposes could include banking, employment or health care."

CCHF explains that the REAL ID Act allows states to collect biometric data (fingerprints, facial geometry, triangulated body measurements), or "the building blocks of a total surveillance state."

"REAL ID provides the digital and biometric infrastructure to implement a China-like control grid, where your access to services could depend on behavior, beliefs or

health status." This type of digital identity system is also pushed by international organizations such as the United Nations, the World Health Organization, and the World Economic Forum. It could easily be merged with "expanding global control frameworks."

President Trump is working toward that end. He signed an executive order in March calling for data-sharing of personal information on Americans across federal agencies. Since then, the administration's contracts with Peter Thiel's data analytics company, Palantir, have exploded. (Even the name Palantir is foreboding, as it refers to one of the seeing stones in J.R.R. Tolkien's The Lord of the Rings.)

In May, The New York Times reported that Trump has awarded more than \$900 million in contracts to Palantir, with plans for more in the coming months. Palantir denies

the claims of a unified database as "blatantly untrue," but even current and former Palantir employees have formally petitioned the company to pull out of the plans.

Palantir's denials are implausible. TSA brags on its website about its biometric overhaul. CBP crows about its AI surveillance towers, which are being erected along highways nationwide, and in July, Health and Human Services Secretary Robert F. Kennedy, Jr. announced

the launch of a digital health ID initiative in conjunction with Amazon, Apple, Google, OpenAI, and Anthropic, an AI startup that received most of its \$580 million seed funding from the now-bankrupt FTX under convicted fraudster Sam Bankman-Fried.

Unless Congress steps in to prevent this unprecedented surveillance infrastructure, it is only a matter of time before REAL ID becomes a prerequisite for living life.
