actually sent the first "valentine" greeting himself after he fell in love with a young girl-possibly his jailor's daughter-who visited him during his confinement. Before his death, it is alleged that he wrote her a letter signed "From your Valentine," an expression that is still in use today. Although the truth behind the Valentine legends is murky, the stories all emphasize his appeal as a sympathetic, heroic and-most importantly-romantic figure. By the Middle Ages, perhaps thanks to this reputation, Valentine would become one of the most popular saints in England and France.

#### Origins of Valentine's Day: A Pagan Festival in February

While some believe that Valentine's Day is celebrated in the middle of February to commemorate the anniversary of Valentine's death or burial-which probably occurred around A.D. 270-others claim that the Christian church may have decided to place St. Valentine's feast day in the middle of February in an effort to "Christianize" the pagan celebration of Lupercalia. Celebrated at the ides of February, or February 15, Lupercalia was a fertility festival dedicated to Faunus, the Roman god of agriculture, as well as to the Roman founders Romulus and Remus.

To begin the festival, members of the Luperci, an order of Roman priests, would gather at a sacred cave where the infants Romulus and Remus, the founders of Rome, were believed to have been cared for by a she-wolf or lupa. The priests would sacrifice a goat, for fertility, and a dog, for purification. They would then strip the goat's hide into strips, dip them into the sacrificial blood and take to the streets, gently slapping both women and crop fields with the goat hide. Far from being fearful, Roman women welcomed the touch of the hides because it was believed to make them more fertile in the coming year. Later in the day, according to legend, all the young women in the city would place their names in a big urn. The city's bachelors would each choose a name and become paired for the year with his chosen woman. These matches often ended in marriage.

### Valentine's Day Meaning: A Day of Romance and Love

Lupercalia survived the initial rise of Christianity but was outlawed as it was deemed "un-Christian" at the end of the 5th century, when Pope Gelasius declared February 14 St. Valentine's Day. 

It is also strikingly similar to Hillary Clinton's mishandling of







## Canada buys Ukraine \$400M Air-Defense System that Canadian Army has been Waiting for Since 2012

The Liberal government is spending more than \$400 million to buy air-defense systems for Ukraine even though the Canadian Forces has been without such equipment for more than a decade. partners, to address Ukraine's defense priorities in the short and long term — including with high-capability equipment such as the NASAMS."

But her office added in a statement, "We continue to work towards the procurement of Ground-Based Air Defence Equipment for the

#### The liberal Canadian government spends >\$400 million to buy an air-defence system for Ukraine but has no money to buy one for the Canadian Army.



Defence Minister Anita Anand announced Tuesday that Canada would purchase a "National Advanced Surface-to-Air Missile System" and associated munitions from the United States to donate to Ukraine. A NASAMS is a shortto medium-range ground-based air-defense system that protects against drone, missile and aircraft attacks. The donation will cost Canadian taxpayers approximately \$406 million.

"Canada stands in solidarity with Ukrainians as they fight heroically against Russia's illegal and unjustifiable invasion," Anand said. "We have committed over \$1 billion in military assistance to Ukraine, and today we are moving forward with the first Canadian donation of an air defense system to Ukraine. Canada will continue to collaborate with the United States, as well as other Allies and Canadian Armed Forces — and Minister Anand is committed to getting this done, as outlined in our defense policy."

The Canadian Army has been without an air-defense capability since 2012 and has tried over the past decade to convince governments to purchase such equipment. The Canadian Army was outfitted in 1989 with a then state-of-the art air-defense antitank system known as ADATS. It was purchased to protect bases in Germany against attack by the Russians, but, shortly after ADATS was delivered, the Cold War ended and the systems were shipped back to Canada. ADATS was occasionally used for domestic security, including protection from potential air threats during the G8 summit in Alberta in 2002. But, faced with budget cuts ordered by the Conservative government, the

army announced it was removing ADATS from service in 2012.

That move left the Canadian Forces without a primary airdefense system. Army officers acknowledged

then that the decision was risky, but the service had determined it was acceptable in the short term. The army had plans to introduce a new air-defense system around 2017, but that project never went forward. The Liberal government outlined its proposed purchase of an air-defense system in its 2018 defense capability plan, but that acquisition is still being examined.

Army commander Lt. Gen. Joe Paul told The Canadian Press in December that the army was moving forward on purchasing air-defense equipment, but he did not provide timelines. In 2020, then-Army commander Lt.-Gen. Wayne Eyre also told Esprit de Corps military magazine that ground-based air defense was a priority for the service. "We see the evolving threat from drones, from rockets, and other forms of indirect fire," said Eyre, who has since been promoted to Chief of the Defence Staff. "We have to be able to protect ourselves."

between \$500 million and \$1 billion, according to records obtained by this newspaper. A contract was expected to be awarded in 2026 and the first systems would be in place a year later, industry officials were told. Army officers said then that the new system would be used to deal with drones, rockets, artillery and mortar munitions, air-to-surface missiles and bombs.

The National Advanced Surface to Air Missile System being sent to Ukraine is designed and developed jointly by Raytheon of the U.S. and Kongsberg Defence of Norway, according to the Congressional Research Service.

Ukrainian President Volodymyr Zelenskyy thanked Prime Minister Justin Trudeau for the donation in a tweet on Tuesday. "Dear JustinTrudeau, your true leadership in standing for democracy and human rights has been vividly proven again," Zelenskyy stated. "Thank you for helping us to protect our sky. NASAMS procured for us by Canada will be a strong shield for our cities and citizens."



## Jan 6 Was the Worst Incident of Police Brutality Since Civil Rights Era

One might be inclined to apply Hanlon's razor—never attribute to malice that which is adequately explained by stupidity—to the actions of law enforcement on January 6, 2021. One might even be inclined to replace "stupidity" with "incompetence" to explain why police behaved the way they did that afternoon.

But a growing body of evidence suggests neither stupidity nor incompetence can justify what now appears to be the worst incident of police brutality against political protesters since the civil rights era. After two years of watching cherry-picked video clips produced by the Department of Justice and the news media to depict Trump supporters as the violent aggressors on January 6, the public now has an opportunity to see what really happened thanks to police body camera footage released at trial. It's uglyand clearly malicious.

As American Greatness has reported for nearly two years, members of the Capitol Police and D.C. Metropolitan Police Departments were involved in egregious acts of excessive force during the Capitol protest. Some use of force, obviously, was necessary. But police officers initiated most of the confrontations with otherwise peaceful protesters lawfully exercising their First Amendment rights in the nation's capital.



Protesters by and large were not attempting to commit any crime and did not know the entire lawn surrounding the Capitol building had been declared off-limits. After all, police officials have since admitted that by the time people who attended Donald Trump's speech arrived at the Capitol, signage and fencing indicating the campus was closed had been torn down.

The conclusion of Trump's speech at around 1:10 p.m. coincided nearly to the minute with law enforcement's first use of munitions on protesters assembled on the west side of the Capitol. Roughly 20 minutes earlier, a police barricade of metal racks on the far exterior of the grounds had been breached. But footage captured by the body camera of a D.C. Metro police of-

ficer showed that law enforcement had successfully pushed a growing crowd away from the building by 1:15 p.m.

Officer Daniel Thau, however, was on a mission. Sounding alternatively like a mad man or a bully, Thau desperately pleaded with other officers to give him munitions to use against the crowd despite a relatively controlled atmosphere outside. "Over the more than 75 minutes that Thau was behind the police lines at ground level, he was like a one-man strike force," Epoch Times reporter Joe Hanneman observed in a detailed analysis of Thau's footage. "He felled at least four protesters with a Taser, tossed countless explosives into the crowd, and fired a munition launcher with a 40-millimeter shell at point-blank range over the barricade."

By 2:15 p.m., Thau recognized it was a pointless exercise. "It's useless. We're just fucking shooting zombies, man. We're shooting zombies. That's it." Further, Thau admitted, the unwarranted attacks were backfiring. "We're taking out one and 10 are getting angrier [sic]. We're multiplying them by hitting them." Even worse, police misused chemical gas munitions, resulting in injuries to fellow officers who then retreated from the reinforced line. People inside the building didn't fare much better. Whether they climbed in through broken windows or walked through open doors, protesters eventually filled various areas of the Capitol including the Rotunda—and were met by police officers in full riot gear including helmets, ballistic vests, eye shades, gas masks, and metal batons. And again, despite no attempts to commit violence or vandalism there, protesters were subjected to harsh punishment by the police. Cops shoved and punched people who were seemingly trapped inside the Rotunda, unsure how to exit. "Do you feel big and strong now?" one woman is heard saying on body camera footage from D.C. Metro Police Officer Terrence Craig. "Does that get you off pushing around a bunch of women? A bunch of fucking unarmed women?"

Men witnessed an officer shove another woman without provocation. "Sergeant, take care of that officer right now!" one protester yelled at the police. "She's gonna cause real problems." People can be heard screaming in pain; one unidentified officer is seen repeatedly punching someone on the floor. It's important to note that lawmakers and Vice President Mike Pence had been evacuated by that point. Police could have easily escorted people outside, locked the doors, and instructed those remaining outside it was time to leave. Instead, protesters were used as human punching bags and target practice.

Four Trump supporters lost their lives. Capitol Police Lieutenant Michael Byrd shot and killed Ashli Babbitt, an unarmed female veteran, at 2:44 p.m. Prior to her execution, two men on the west side of the Capitol grounds—the location where Officer Thau and his colleagues had launched an assault on protesters—suffered fatal heart attacks at the same time.

Independent journalist Tayler Hansen documented the circum-



stances of the deaths of Benjamin Phillips and Kevin Greeson around 2:00 p.m. on January 6. "The first grenade was thrown deep into the peaceful protesters," Hansen wrote in an analysis. "Following the initial crowd munition exploding, four of the first grenades can be seen and heard on video in under 30 seconds." "Both Greeson and Phillips died in the initial grenade barrage," Hansen concluded. His account appears to be supported by first responders called to the scene. "We started hearing explosions that later turned out to be flashbangs or smoke grenades," one D.C. firefighter explained in a video produced by the city's Emergency Medical Services in 2021.

"The tension in the crowd was getting higher and higher as the flashbang grenades were going off around us," Gary Dziekan, a D.C. emergency medical technician, said in the video. Police continued throwing grenades as paramedics attempted to reach the two stricken men. "It was just unexplained - why

was he in cardiac arrest?" paramedic Glenn Hanna said. "Nobody knew so they were thinking maybe he got injured, maybe it was a stun grenade, maybe he tased himself." Tased himself?

Other calls flooded in to report injuries. While conveniently leaving out the identity of the responsible party, one dispatcher told first responders someone "shot a grenade at the patient's face, his teeth are out, mouth bleeding." Some protesters were set on fire from the impact of the flash-

bangs.

day shows people attempting to resuscitate Boyland near the lower west terrace tunnel, the scene of the most violent clashes between police and protesters. This is where officers viciously beat another female Trump supporter, as I reported here in 2021. Boyland likely suffocated after being hit with noxious chemical gas in the enclosed area then trampled as police forcefully pushed people outside the tunnel, even though the building had been empty for nearly two hours.

> unconcerned with her condition. One officer identified as Lila Morris reportedly beat Boyland's dead body with a metal baton as she laid face up on the

ground. As Boyland's body is finally dragged away by police, protesters confront officers. "She's fucking dead! This is on you, motherfuckers!" (The D.C. coroner claimed Boyland died of a drug overdose.)

The Biden regime and news media continue to describe January 6 as a "deadly insurrection" based on the falsehood that five officers died. Meanwhile, the names of the Americans who did die that day are never mentioned. Political protests in Washington, D.C., are nothing new. Since 2016, numerous, heavily attended protests-the Women's March, the March for Science, anti-Brett Kavanaugh events, to name a few-went off without a single flashbang or sting ball filled with rubber bullets or canisters filled with chemical powder.

My (frequently re-scheduled) hearing for my lawsuit against the Orange County Board of Supervisors was set for January 30, 2023. This is when the attorneys for the County were ordered to demonstrate to the judge

(it's called an "Order to TheHealthyAmeri Show Cause") that the Board of Supervisors were following the law – or, why they did not have to follow the law (LOL!).

Here are the facts of my case:

California Health and Safety Code 101080 states that a local county

health officer can proclaim a LOCAL health emergency (for up to seven days) in the event of a toxic spill, hazardous waste - or at the BEGINNING of an outbreak of an infectious disease.

#### After 7 days, the Board of Supervisors must either ratify (approve) or terminate the LOCAL health emergency.

At least every 30 days thereafter, the Board must continue to receive updates and information to either EXTEND the emergency or TERMINATE the emergency at "the earliest possible date that conditions warrant the

termination."

The Board was NOT "reviewing the conditions" publicly (required by the California Brown Act) until I informed the county attorney of this violation. After I brought this to the attention of the county attorney, the Board began to receive updates from the health officer, Clayton Chau, during the Board's public meetings (as required by law). Thousands of people showed up at these meetings over the next year, voicing their strong opposition to the "emergency" and the unnecessary shut-down measures harming businesses, jobs, schools, medical settings, and people.

At one particularly jam-packed board meeting on June 22, 2021, then Chairman Andrew Do, visibly exasperated, looked around at the other board members and said: "If we end the emergency, we won't get any more covid money. We are not going to end the emergency until the governor tells us to, and we are not going to discuss this at any further meeting." Then he took a vote, and ALL board members agreed to NOT DISCUSS the "emergency" any further. ### The Pathas Free P Suspicious Timing: Pelosi Sold \$3 Million of Google Stock Weeks Before Justice Department Launched Antitrust Probe

Former House Speaker and Rep. Nancy Pelosi and her husband Paul Pelosi conveniently sold around \$3 million in shares of Google just before the Biden DOJ under Merrick Garland launched an antitrust investigation into the company.

Via Chuck Ross at the Washington Free Beacon: "Paul Pelosi sold 30,000 shares of Google from Dec. 20 to Dec. 28, according to a financial disclosure filing the former House speaker submitted to the House Ethics Committee. The Pelosis made an undisclosed profit from the investments, according to the filing.

The trade proved timely. On Monday, the Justice Department and attorneys general from eight states, including California sued Google over its monopoly on the digital ad market. The lawsuit could force Google to break up its online ad business, which generated nearly \$55 billion in revenue for the company in the most recent quarter. Google's stock has dropped around 6 percent since the Justice Department announced the lawsuit.

The trades are the latest in a string of questionable transactions for Paul and Nancy. They saved roughly \$600,000 in June by selling shares of microchip maker Nvidia weeks before the U.S. government placed restrictions on the company's business in China and Russia. The Pelosis have seen their fortune grow \$140 million since 2008, thanks largely to Paul Pelosi's stock trades, according to a Washington Free Beacon analysis."



During the Middle Ages, it was commonly believed in France and England that February 14 was the beginning of birds' mating season, which added to the idea that the middle of Valentine's Day should be a day for romance. The English poet Geoffrey Chaucer was the first to record St. Valentine's Day as a day of romantic celebration in his 1375 poem "Parliament of Foules," writing, "For this was sent on Seynt Valentyne's day / Whan every foul cometh ther to choose his mate."

Valentine greetings were popular as far back as the Middle Ages, though written Valentine's didn't begin to appear until after 1400. The oldest known valentine still in existence today was a poem written in 1415 by Charles, Duke of Orleans, to his wife while he was imprisoned in the Tower of London following his capture at the Battle of Agincourt. (The greeting is now part of the manuscript collection of the British Library in London, England.) Several years later, it is believed that King Henry V hired a writer named John

Lydgate to compose a valentine note to Catherine of Valois.

Who Is Cupid? Cupid is often portrayed on Valentine's Day cards as a naked cherub launching arrows of love at unsuspecting lovers. But the Roman God Cupid has his roots in Greek mythology as the Greek god of love, Eros. Accounts of his

birth vary; some say he is the son of Nyx and Erebus; others, of Aphrodite and Ares; still others suggest he is the son of Iris and Zephyrus or even Aphrodite and Zeus (who would have been both his father and grandfather). According to the Greek Archaic poets, Eros was a handsome immortal whe played with the emotions of Gods and men, using golden arrows to incite love and leaden ones to sow aversion. It wasn't until the Hellenistic period that he began to be portrayed as the mischievous, chubby child he'd become on Valentine's Day cards.

Typical Valentine's Day Greetings and Gifts. In addition to the United States, Valentine's Day is celebrated in Canada, Mexico, the United Kingdom, France and Australia. In Great Britain, Valentine's Day began to be popularly celebrated around the 17th century.

By the middle of the 18th, it was common for friends and lovers of all social classes to exchange small tokens of affection or handwritten notes, and by 1900 printed cards began to replace written letters due to improvements in printing technology. Ready-made cards were an easy way for people to express their emotions in a time when direct expression of one's feelings was discouraged. Cheaper postage rates also contribut-

> ed to an increase in the popularity of sending Valentine's Day greetings.

Americans probably began exchanging handmade valentines in the early 1700s. In the 1840s, Esther A. Howland began selling the first mass-produced valentines in America. Howland, known as the "Mother of the Valentine," made elaborate creations with real lace, ribbons and colorful pictures known as "scrap." Today, according to the Greeting Card Association, an estimated







The Great Cholesterol Myth

There are many common & accepted understandings within modern culture that have no true scientific basis, but have just merely been accepted as fact. One of the major issues has to do with the pathogenesis of various common diseases including heart disease and cancer. This article will go into the cholesterol myth and how exactly it came to be.


The New Science of Heart Disease: Close to 90% of all well-planned, properly documented studies investigating the lipid hypothesis do not support the claim that "arteryclogging" saturated fats and dietary cholesterol cause heart disease.

In a 1994 study in the British medical journal Lancet, London researchers analyzed the fat they found in clogged arteries. It turns out only 26% of it was saturated animal fat. The other 74% was unsaturated. That's the same type of fat you find in "heart healthy" canola oil.

So the majority of the fat within a clogged artery is not saturated fat and cholesterol. Additionally, calcium is a major player in arterial plaque and yet very rarely is this discussed.

### The Benefits of Saturated Fat & Cholesterol

Most doctors are uneducated on this topic and continue to teach the cholesterol myth. But according


When a commercial bank makes a loan contract with a borrower, the bank CREATES the deposit in the

Up to World War II, the taxexempt foundations were the leading force in medical center, technological medicine. "By 1940 the Rockefeller philanthropies alone had contributed more than \$161 million to medical education and medical research." After the war, the federal spigots opened.

"Roosevelt, addicted as he is to verbal castigation of the wealthy, was supported in 1932 and again in 1936 by some of the richest

families of the country."



In the 1950's Congress approved construction and traineeships grants for medical schools. The Rockefeller Foundation had begun the grant model of research support. After 1945, the federal government became the major funder of

When Saudi Arabia comes to town & buys all your water!



Oil is not the only issue: the Kingdom is getting Arizona resources for a steal, and it's leaving citizens with little to nothing.

Over the past several years, Saudi Arabia has added eight new wells, increasing production to new heights and even leading to accusations of over-pumping. No, not at the Ghawar oil field, but in the groundwater of rural Arizona.

Since 2014, the Saudi company Fondomonte has been pumping unlimited amounts of groundwater in the desert west of Phoenix to harvest thousands of acres of alfalfa crops. The alfalfa is then shipped back to Saudi Arabia to feed their cattle.

A recent investigation from Arizona Central has revealed that Fondomonte, a subsidiary of Riyadh-based Almarai, has the bargain of a lifetime: for only \$25 per acre annually, it can pump as much water as it wants. Nearby farmers pay six times more than



the Saudi company.

This modern day watergate has become a campaign issue ahead of the contentious midterms but candidates across the ballot appear to agree that this is bad. Democratic candidate Katie Hobbs tweeted that "Our water should be for Arizonans, not for sweetheart deals to foreign corporations to grow crops to then send back to their country." Republican candidate Kari Lake has even gone a step further, calling to terminate the Fondomonte lease



Eastern California. The Arizona State Land Department, which leased the land to Fondomonte, refuses to disclose how much water Fondomonte is

pumping, or whether the state would consider charging more for agricultural leases. According to one estimate, the company could be pumping as much as 18,000 acre-feet per year — enough to supply 54,000 single-family homes - raising concerns that the groundwater


will disappear faster than it can be replenished. Alfalfa is one of the most water-intensive crops there is, and the current breakneck pace of production is threatening to stop the flow of the Colorado River entirely.

To Arizonans, the one-sided deal with the Saudi company has become a hot-button issue, particularly since Saudi Arabia dictates global oil prices. "We're not getting oil for free, so why are we giving our water away for free?" asked La Paz County **Board of Supervisors** Chairman Holly Irwin, who represents Butler Valley. "Saudi Arabia has stated their intention to rob Airzonans at the gas pump, but they are already stealing our water," said

Rep. Ruben Gallego (D-Ariz.).

Ironically, lawmakers should look to none other than Saudi Arabia to learn from their mistakes. Saudi Arabia has almost completely exhausted its own groundwater through unrestricted pumping. A 2004 investigation found that the kingdom's water sources were nearly depleted because "wealthy farmers had been allowed to drain the aquifers unchecked for three decades." As the wells dried up, Saudi Arabia has been forced to take conservation much more seriously, even outlawing the production of alfalfa in 2016. Today, around 50 percent of water consumed in Saudi Arabia comes from desalination plants, a costly, high-energy process.

Having depleted their own water resources back home, Saudi Arabia knows the dangerous consequences of unsustainable agricultural practices. Why should they - or any other company for that matter — be allowed to do the same in the American Southwest?



### Follow the money... which got paid?

Saudi owned Fondomonte pays \$25 per acre for unlimited water, US Farmers pay \$

> and "examine all existing leases to ensure Arizona's water and natural resources primarily benefit Arizonans, not overseas corporations."

Other companies are taking advantage of this fire sale on precious water resources in rural Arizona too, including alfalfa farms affiliated with the UAE and plenty of domestic companies. But Fondomonte is among the largest and most controversial because it is actually depleting the groundwater of the Butler Valley, a valuable transfer basin that is seen as a potential water supply for Phoenix.

Fondomonte's Butler Valley property is part of a larger strategy of buying up land across the Southwest for alfalfa production. The Saudi company owns thousands of acres across Arizona and has expanded operations in

### **Buckeye Approves Spending \$80 Million for Water Rights** the making," said Buckeye Mayor



The sale is the latest step the city of Buckeye, which has experienced substantial growth in the past two decades, is taking to build up its water supply over time. The city of Buckeye approved purchasing \$80 million worth of groundwater rights to support the growth of its water

portfolio.

In a special session on Tuesday, Buckeye approved an agreement for the purchase and sale of a one-acre

property owned by Harquahala Valley Landowners LLC in the far West Valley for its water rights. These rights will allow Buckeye to withdraw 5,926 acre-feet of groundwater annually for 100 years. chased water rights from this area, including the town of Queen Creek. Last year, Queen Creek signed a contract to purchase 5,000 acre-feet of Harquahala water for its supply, the Queen Creek Tribune reported. News of the purchase, which will take up to 180 days to complete, comes as Buckeye and other West Valley cities work to build their water supplies for future growth and development. The sale was also approved on the heels of a groundwater analysis of the far West Valley that was released in January.

The report found that there's not enough groundwater to support development over a 100-year period in areas west of the White Tank Mountains and in the northwest Valley, where developers have made plans for new master-planned communities and commercial centers. This

could delay plans for thousands of homes needed as the region experiences a significant undersupply of units.

As of 2021, the city of Buckeye's water demand was 10,316 acre-feet, the city said in a recent statement. adding that Buckeye has adequate water resources to sustain projected growth for the next 15 to 20 years. Buckeye relies mostly on groundwater and said it is aware of the need for additional resources.

In 2021, the city also approved acquiring 2,786 acre-feet annually of Non-Indian Agricultural Colorado River water. Delivery of this water started in 2022. New developments such as neighborhoods that are subdivided by six lots or more are required to obtain a certificate of assured water supply with an exception to built-to-rent communities.



### **'Died Suddenly'?** More Than 1-in-4 Think Someone They Know Died From COVID-19 Vaccines

Nearly half of Americans think COVID-19 vaccines may be to blame for many unexplained deaths, and more than a quarter say someone they know could be among the victims.

The latest Rasmussen Reports national telephone and online survey finds that (49%) of American Adults believe it is likely that side effects of COVID-19 vaccines have caused a significant number of unexplained deaths, including 28% who think it's Very Likely. Thirty-seven percent (37%) don't say a significant number of deaths have been caused by vaccine side effects, including 17% who believe it's Not At All Likely. Another 14% are not sure.


Twenty-eight percent (28%) of adults say they personally know someone whose death they think may have been caused by side effects of COVID-19 vaccines, while 61% don't and another 10% are not sure. The documentary "Died Suddenly" has been criticized as promoting "debunked" anti-vaccine conspiracy theories but has been seen by some 15 million people. Fortyeight percent (48%) of Americans believe there are legitimate reasons to be concerned about the safety of COVID-19 vaccines, while 37% think

people who worry about vaccine safety are spreading conspiracy theories. Another 15% are not sure.

The survey of 1,000 American Adults was conducted on December 28-30, 2022 by

Rasmussen Reports. The margin of sampling error is +/- 3 percentage points with a 95% level of confidence. Field work for all Rasmussen Reports surveys is conducted by Pulse Opinion Research, LLC. Seventy-one percent (71%) say they have received a COVID-19 vaccination, while 26% have not. Concerns about vaccine safety are much higher among the unvaccinated.

Seventy-seven percent (77%) of adults who

have not gotten COVID-19 vaccinations believe it's at least somewhat likely that side effects of COVID-19 vaccines have caused a significant number of unexplained deaths. Among those who have gotten the vaccine, just 38% consider unexplained deaths from the vaccine at least somewhat likely. Similarly, while 45% of those who have not been vaccinated against COVID-19 think someone they know personally might have died from vaccine side effects, only 22% of vaccinated adults think so.

Forty-six percent (46%) of adults who have gotten vaccinated against COVID-19 believe people who worry about vaccine safety are spreading conspiracy theories, but just 15% of the unvaccinated share that belief. Sixty-nine percent (69%) of those who haven't gotten the

> COVID-19 vaccine think there are legitimate reasons to be concerned about the safety of COVID-19 vaccines, as do 40% of those who have gotten vaccinated against the virus.

More Democrats (85%) than Republicans (63%) or those not affiliated with either major party (64%) have been vaccinated against COVID-19. More Republicans (60%) than Democrats (44%) or the unaffiliated (43%) think there are legitimate reasons to be concerned about the safety of COVID-19 vaccines. However, there is less political difference in the number who suspect someone they know might have died from vaccine side effects – 33% of Democrats

Forty-six percent (46%) of whites, 48% of blacks and 57% of other minorities believe it is at least somewhat likely that side effects of COVID-19 vaccines have caused a significant number of unexplained deaths. Younger Americans are less likely to be vaccinated against COVID-19, and 35% of adults under 40 believe someone they know personally might have died from vaccine side effects, compared to 28% of those 40-64 and just 14% of Americans 65 and older.

and 26% of both Republicans and the unaffiliated.

Slightly more men (52%) than women (47%) think it is at least somewhat likely that a significant number of unexplained deaths may have been caused by side effects of COVID-19 vaccines. Married adults are more likely to be vaccinated against COVID-19 than their unmarried peers, but more married (33%) than unmarried (23%) Americans think someone they know personally might have died from vaccine side effects.

Voters with annual incomes below \$30,000 are most likely to think there are legitimate reasons to be concerned about the safety of COVID-19 vaccines, while those with incomes above \$200,000 are most likely to believe people who worry about vaccine safety are spreading conspiracy theories.

A majority of Americans think COVID-19 vaccines are effective, but have concerns about side effects. Although few Americans think 2022 was one of the best years ever, they rated it better than last year, and they have higher expectations for 2023.

Jordan Peterson recently sounded an alarm during his three hour interview with Joe Rogan. A longtime target set to be canceled, Peterson is now being threatened by the Ontario College of Psychologists with the loss of his clinical license to practice psychology.




