Political Shenanigans in Quartzsite

Summary Complaint filed with Attorney General's Office – Election Integrity Unit & Civil Rights Unit

On April 7, 2022, Quartzsite Town Council voted to disqualify Mike Roth, Sam Saxton and Dennis Vosper as candidates for Council seats based on Town Code 30.09, instated in 2009 as Code 2-1-20.

We believe this action is interference in the election process and is against the civil rights of these 3 candidates who chose to run for seats on the Town Council. We believe that sitting Town Council members should NOT be involved in this elimination process. It seems to be a clear conflict of interest as well as a violation of these individual's rights. So in essence, via this code, sitting Council members—several of whom are currently up for re-election--are voting to disqualify their potential opponents.

This should not be taking place in our election process! We consider this action to be obstruction in free and fair elections and it should be stopped!

This same process was also used in 2012 to oust a town leader from their duly elected position. It was challenged in court and on October 15, 2012 LaPaz County Superior Court, Judge Michael Burke, ruled the action "unlawful" and the individual was reinstated to their elected position. (See Attached Ruling)

[As we have learned, only the Supreme Court can rule something as "unconstitutional".]

Attorney Julie LaBenz, who handled that case, said that with their action the Town Council was trying to turn democracy "upside down."

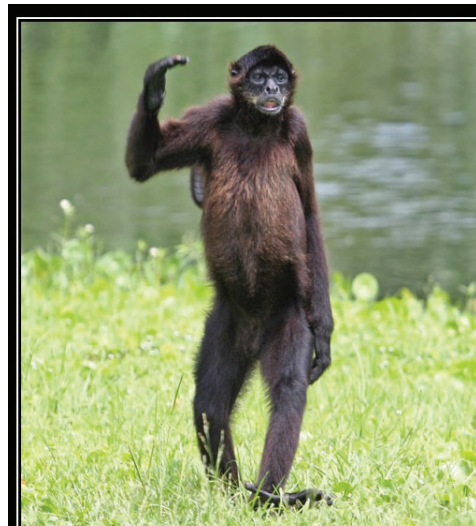
Question: Even though this case was 10 years ago, why didn't the town attorney disclose this "unlawful" ruling to Council prior to their vote to disqualify? Why was this code pulled off the shelf,

dusted off and used again against these

candidates? Others would have known about and likely remembered this case because the local paper, the Desert Messenger, wrote several articles on the case and the ruling. A sitting Council member is the partner of the editor of that publication.

On April 27, 2022 Town Council met again and did NOT repeal the Code 30.09 -- only to make some adjustments in paperwork, etc. This item was once again on the Council agenda for May 17, 2022 in order to disqualify sitting council member Steve Schue, who has served several years on council and is up for re-election for another 2-year term.

On May 24, 2022 this code item was once again on the agenda and Council once again tabled any action on the code until after the 2022 elections.

The disqualification of these 4 candidates should never have happened. The action based on this code was previously ruled an unlawful action and should now be REPEALED.

We respectfully request that this action be looked into by the Attorney General's office. Thank you for your attention to this matter.

[This information was passed to Congressman Paul Gosar for assistance in getting this matter addressed by the Attorney General. We look forward to learning of the outcome and will keep you up to date on the progress. He will be in Q 6/26.]

Judge Burke orders Ed Foster to be seated as Quartzsite mayor

Today, La Paz County Superior Court Judge Michael Burke ordered Quartzsite Town Council seat Ed Foster as mayor no later than Tuesday, October 23rd, 2012.

At today's hearing in Parker, Ed Foster was seeking a Writ of Mandamus asking the court to demand the town council swear him in as mayor. Foster won the majority of votes in the May 15th election. On June 4th council members declared him unqualified to be seated as mayor. In question was a Quartzsite Town Code 2-1-20 which stated persons who owed delinquent taxes, fines or fees to the town could not serve in elected office.

Foster's attorney, Julie LaBenz, gave a slide presentation to the packed courtroom. She argued the town exceeded their authority to add qualifications above and beyond those set by the state of Arizona. Foster owes the town attorney fees issued by the same judge in May, 2011 and has publicly vowed never to pay the \$2200.

Today, La Benz asked and was awarded attorney fees of \$2200.00. Not Secure — desertmessenger.blogspot.com

Foster ran for Mayor again in 2012, and defeated Jerry Lukkasson in the election held May 15, 401 voted to 315. However, on June 4, the Town Council declared him ineligible for elected office in the town because he still owed a court settlement to the Town. The Town Code stated that individuals who owed money to the Town could not hold elected office.

Months of legal wrangling followed. Foster's Attorney, Julie La Benz, argued in court that the town ordinance was unconstitutional as it went beyond the state's qualifications for public office.

On Oct. 15, 2012, La Paz County Superior Court Judge Michael Burke ruled in Foster's favor. He said the town's ordinance went beyond the state's qualifications, and, even if it didn't, the type of funds Foster owed were not covered in the ordinance.

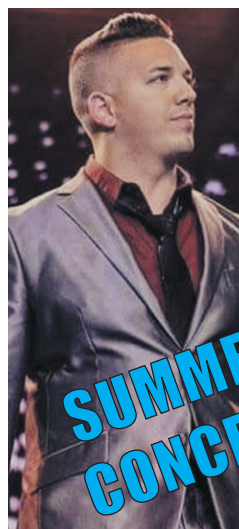

Some of Washington's Advice - and more

Most of our political arguments would be avoided if people understood our government's constitutional design—what it should be doing and not doing. Because of this, the political arena has created an atmosphere where many people vote for benefits instead of prudence, charisma instead of competence, and party politics instead of constitutional principles. Our nation is sinking into debt because of these deviations, and our intense disagreements reveal the lapse in education.

One of the best lessons left for our nation was George Washington's Farewell Address, which was printed in several newspapers, it was not delivered in person. It is a brilliant essay that implored the citizens to stay on a constitutional course and not fall for the tricks, pitfalls, and swindles created by the crafty political machines.

Washington was greatly concerned with the problems created by groups that were energized by political or geographical concerns—party politics—especially those created by lying politicians that seek to divide our nation.

From paragraph 15 of the Address we find this: "One of the expedients of party to acquire influence within particular districts is to misrepresent the opinions and aims of other districts. You cannot shield yourselves too much against the jealousies and heartburnings which spring from these misrepresentations; they tend to render alien to each other those who ought to be bound together by fraternal affection."

In other words, politicians can lie about themselves and each other in order to divide the people to gain power and income!

Here we call attention to the

enterprising politician who seeks empowerment and financial gain by deviously misrepresenting himself and others. The old trick of "vote for me and I'll give you this" is a powerful vote-getter for the politician, who then claims that he is caring, fair, friendly and ethical, despite his willingness to enslave the future citizens with debt. Meanwhile, the truly prudent politician is cast off as an uncaring person.

comprehensive view, and warn you in the most solemn manner against the baneful effects of the spirit of party generally. This spirit, unfortunately, is inseparable from our nature, having its root in the strongest passions of the human mind. It exists under different shapes in all governments, more or less stifled, controlled, or repressed; but, in those of the popular form, it is seen in its greatest rankness, and is truly their

absolute power of an individual; and sooner or later the chief of some prevailing faction, more able or more fortunate than his competitors, turns this disposition to the purposes of his own elevation, on the ruins of public liberty."

In the first of these paragraphs Washington uses the term "popular form" to refer to democracies, or a popular movement within a government of another form. Another way of putting it is "the power of the mob."

Washington continues to describe what is happening in our nation right now!

"It serves always to distract the public councils and enfeeble the public administration. It agitates the community with ill-founded jealousies and false alarms, kindles the animosity of one part against another, foments occasionally riot and insurrection. It opens the door to foreign influence and corruption, which finds a facilitated access to the government itself through the channels of party passions. Thus the policy and the will of one country are subjected to the policy and will of another."

These are warnings we should take seriously. The Founding Fathers were devoted to their studies of history. They learned what would cause governments to succeed and what would cause them to fail; they passed that knowledge on to us in hopes we would listen. We should, if we care for our families and this nation.

I will cover more from the Address in a later issue. If you decide to read the Address on your own, you will be impressed with the style and wording of President Washington. JOINT STATEMENT BY THE ARIZONA STATE SENATE MAJORITY TEAM

Extremist Biden Agenda Threatens School Lunches for Arizona's Poorest Kids Unless Boys Are Let into Girls' Bathrooms

PHOENIX ARIZONA – The Biden Administration is attacking low-income students in the K-12 school system with a new set of radical rules aimed to withhold federal funds for school meal programs unless districts embrace transgender ideology.

Redefining womanhood is part of a grand demonic scheme!

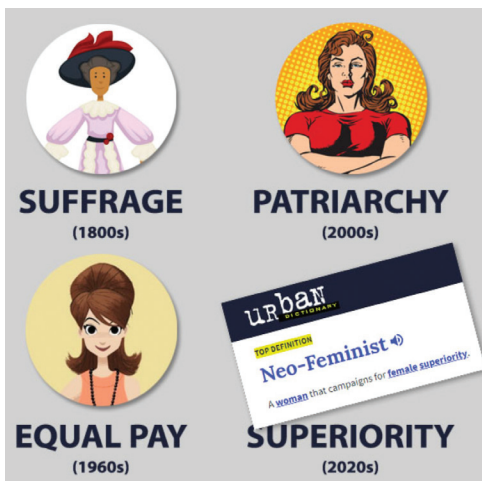

Take the 1619 Project, Nikole Hannah-Jones's 2019 New York Times series-turned-grade school curriculum. It might never have seen the light of day if not for the MacArthur Foundation. In 2014, MacArthur awarded a \$1 million, three-year grant to ProPublica, a left-wing nonprofit news outlet for which Hannah-Jones wrote about race. In 2017, MacArthur awarded Hannah-Jones a "\$625,000, no-

strings-attached grant." In "How the 1619 Project Came Together," the Times explained that Hannah-Jones consulted with "Kellie Jones, a Columbia University art historian and 2016 MacArthur Fellow." Matthew Desmond, who contributed an article about the "brutality of American capitalism" to the series, was a 2015 MacArthur fellow.



The nonprofit that pushed curriculum based on the 1619 Project into schools is also funded by MacArthur. In 2021, MacArthur secured a position for Hannah-Jones as a professor at Howard University, where she would teach her racial ideas and continue the 1619 Project, by donating \$5 million to the school.

The Kellogg Foundation bankrolls the group behind the Zinn Education Project (named after anti-American author Howard Zinn), which is relied on by a company that produces content for 90 percent of K-12 schools. In one lesson plan, the teacher stages a "tribunal" to decide who should be held "accountable" for Covid-19, tells students it should not be China, and leads them to order that "all members of the [U.S.] federal government [be put] in jail" to "end, or lower the amount of, capitalism so no secrets are present."

Even groups that exist to get

government officials on the same page, such as the National School Boards Association (which likened parents to "domestic terrorists"), receive private funds from foundations like Ford, Gates, and Carnegie.

Making it even creepier, far-left foundations have converged through a group called Arabella, a for-profit company that brings them together alongside groups like the American Federation of Teachers union. Teachers union honcho Randi Weingarten said of one Arabella initiative, fittingly called "The

Hub Project": "It essentially creates a place to have a shared strategy on issues with groups that might seem disparate."

Arabella is the same group that The New York Times conceded in January has led Democrats to dwarf Republicans with the "dark money" leftists publicly denounce.

One tentacle of Arabella, the Sixteen Thirty Fund, spent more in 2020 than the Democratic National Committee.

You likely don't know the name Arabella, or the names of its main nonprofits like the Sixteen Thirty Fund, because they specialize in creating pop-up astroturf fronts, which operate with little financial disclosure and with scant public recognition of where they're coming from.

But these groups have been sowing the seeds of critical race theory in obscure educational bureaucracies since long before you even heard the term. In 2013, New Venture Fund, one of Arabella's most important arms, outright paid for the creation of a federal government entity, the "Equity and Excellence Commission," which pushed for a return to 1970s-style bussing.

Savvy activists strategically fund force-multipliers: behind-the-scenes groups that shape others who go on to shape others. For those seeking to efficiently spread fringe ideas, there is no better bang for the buck than conscripting schoolchildren. But once I saw who was behind the curtain, it became clear why they hid.

The Drug Story

In the 30's, Morris A. Bealle, a former city editor of the old Washington Times and Herald, was running a county seat newspaper, in which the local power company bought a large advertisement every week. This account took quite a lot of worry off Bealle's shoulders when the bills came due. But according to Bealle's own story, one day the paper took up the cudgels for some of its readers that were being given poor service from the power company, and Morris Bealle received the dressing down of his life from the advertising agency which handled the power company's account. They told him that any more such "stepping out of line" would result in the immediate cancellation not only of the advertising contract, but also of the gas company and the telephone company.

That's when Bealle's eyes were opened to the meaning of a "free press", and he decided to get out of the newspaper business. He could afford to do that because he belonged to the landed gentry of Maryland, but not all newspaper editors are that lucky.

Bealle used his professional experience to do some deep digging into the freedom-of-the-press situation and came up with two shattering exposes - "The Drug Story", and "The House of Rockefeller." The fact that in spite of his familiarity with the editorial world and many important personal contacts he couldn't get his revelations into print until he founded his own company, The Columbia Publishing House, Washington D.C., in 1949, was just a prime example of the silent but adamant censorship in force in "the Land of the

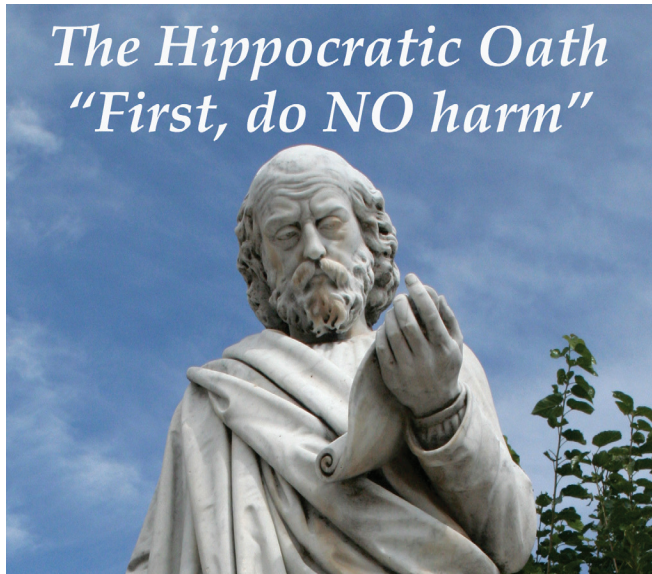
Free and the Home of the Brave". Although The Drug Story is one of the most important books on health and politics ever to appear in the USA, it has never been admitted to a major bookstore nor reviewed by any establishment paper, and was sold exclusively by mail. Nevertheless, when we first got to read it, in the 1970s, it was already in its 33rd printing, under a different label - Biworld Publishers, Orem, Utah.

Examples:

As Bealle pointed out, a business which makes 6% on its invested capital is considered a sound money maker. Sterling Drug, Inc., the main cog and largest holding company in the Rockefeller Drug Empire and its 68 subsidiaries, showed operating profits in 1961 of \$23,463,719 after taxes, on net assets of \$43,108,106 - a 54% profit. Squibb, another Rockefeller-controlled company, in 1945 made not 6% but **576%** on the actual value of its property.

That was during the luscious war years when the Army Surgeon General's Office and the Navy Bureau of Medicine and Surgery were not only acting as promoters for the Drug Trust, but were actually forcing drug trust poisons into the blood streams of American soldiers, sailors and marines, to the tune of over 200 million 'shots'. Is it any wonder, asked Bealle, that the Rockefellers, and their stooges in the Food and Drug Administration, the U.S. Public Health Service, the Federal Trade Commission, the Better Business Bureau, the Army Medical Corps,

the Navy Bureau of Medicine, and thousands of health officers all over the country, should combine to put out of business all forms of therapy that discourage the use of drugs.



"The last annual report of the Rockefeller Foundation," reported Bealle, "itemizes the gifts it has made to colleges and public agencies in the past 44 years, and they total somewhat over half a billion dollars. These colleges, of course, teach their students all the drug lore the Rockefeller pharmaceutical houses want taught. Otherwise there would be no more gifts, just as there are no gifts to any of the 30 odd colleges in the United States that don't use therapies based on drugs.

"Harvard, with its well-publicized medical school, has received \$8,764,433 of Rockefeller's Drug Trust money, Yale got \$7,927,800, Johns Hopkins \$10,418,531, Washington University in St. Louis \$2,842,132, New York's Columbia University \$5,424,371, Cornell University \$1,709,072, etc., etc."

And while "giving away" those huge sums to drug-propagandizing colleges, the Rockefeller interests were growing to a world-wide web that no one could entirely explore. Already well over 30 years ago it was large enough for Bealle to demonstrate that the Rockefeller interests had created, built up and developed the most far reaching industrial empire ever conceived in the mind of man. Standard Oil was of course the foundation upon which all of the other Rockefeller industries have been built. The story of Old John D., as ruthless

an industrial pirate as ever came down the pike, is well known, but is being today conveniently ignored. The keystone of this mammoth industrial empire was the Chase National Bank, now renamed the Chase Manhattan Bank.

Not the least of its holdings are in the drug business. The Rockefellers own the largest drug manufacturing combine in the world, and use all of their other interests to bring pressure to increase the sale of drugs. The fact that most of the 12,000 separate drug items on the market are harmful is of no concern to the Drug Trust...

The Rockefeller Foundation was first set up in 1904 and called the General Education

Fund. An organization called the Rockefeller Foundation, ostensibly to supplement the General Education Fund, was formed in 1910 and through long finagling and lots of Rockefeller money got the New York legislature to issue a charter on May 14, 1913.

It is therefore not surprising that the House of Rockefeller has had its own "nominees" planted in all Federal agencies that have to do with health. So the stage was set for the "education" of the American public, with a view to turning it into a population of drug and medico dependents, with the early help of the parents and the schools, then with direct advertising and, last but not least, the influence the advertising revenues had on the media-makers. A compilation of the magazine Advertising Age showed that as far back as 1948 the larger companies in America spent just on advertising, the sum total of \$1,104,224,374.

That was when the dollar was still worth a dollar and not half a zloty. Of this staggering sum the interlocking Rockefeller-Morgan interests (gone over entirely to Rockefeller after Morgan's death) controlled about 80 percent, and utilized it to manipulate public information on health and drug matters - then and even more recklessly now.

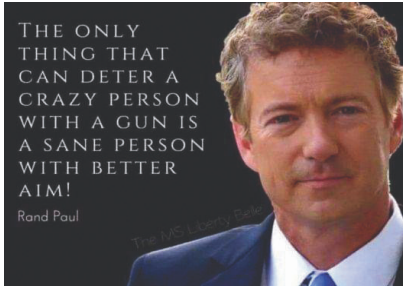

The WHO, Monkeypox & the Continued War on Freedom
