U.S. Government Has Paid \$0 in COVID Vaccine-Injury Claims Despite \$11 Trillion in Spending on Pandemic Response



The Counter Measures Injury Compensation Program (CICP) is a string of words most Americans have never heard of. A program described as a 'black hole' where people disappear, alternatively called 'the payer of last resort.' Its existence, and its negligence, are the biggest story left to be told throughout the failed

COVID response. A 'safety net' is only activated during emergencies to compensate Americans for injuries and deaths experienced from the use of countermeasures such as vaccines and anti-virals.

A broken promise of transparency from federal agencies during a rushed vaccine development and rollout sans any real semblance of safety testing gave way to a billion-dollar full-court pressure campaign from every conceivable angle. Get the shots in arms at any cost, double down on mistakes along the way was the unofficial motto of agencies like the CDC and FDA. "Take the shot" commanded Biden through his trademark whisper and distressed face struggling to read his loaded teleprompter. 262,908,216 Americans have walked blindly into another medical experiment unlikely to ever have full knowledge or informed consent to the medical procedure they agreed to.

Their only redress is at the mercy of an admittedly antiquated Vaccine Adverse Event Reporting System (VAERS) well-known for over a decade to vastly underreport true injuries and deaths from vaccination. In fact, HHS has known from an analysis by Harvard Pilgrim that less than 1% of adverse events occurring after vaccination are reported to VAERS. The statute of limitations to file an injury or death claim is one year for CICP. Harms from the vaccines are still being discovered years after the first shot went into



an American arm. Doesn't matter in the CICP. Another barrier to claim fulfillment is stated on HRSA's website:

"Temporal association between the administration or use of the covered countermeasure and onset of the injury (i.e., the injury occurs a certain time after the administration or use) is not sufficient, by itself, to prove that an injury is the direct result of a covered countermeasure." You read that right. Having an injury after the shot isn't enough. What other obstacle is one up against when filing a claim? Aaron Siri, lead lawyer for the Informed Consent Action Network told Reuters: "The CICP is not a court," he said, noting that it's part of the "same federal health department that licensed, recommended, and mandated COVID-19 vaccines, and then sits as an investigator and 'judge' of any CICP claim. That is a mockery of the term justice." Simply put, it's a place you don't want to find yourself. You versus the government – no courts, no public attention, and no transparency. Up against the very same well-funded bureaucratic apparatus that has only doubled down on warp-speeding shots into bodies as the science to justify it evaporates and the safety signal compound.

Now let's investigate CICP's funding. Keep in mind that a total of \$11 trillion has been distributed in the form of federal spending, tax cuts, loans, grants, and subsidies authorized in the wake of the coronavi-

rus pandemic and economic crisis. A Freedom of Information Act Request (FOIA) from author and researcher Wavne Rohde uncovered these numbers regarding CICP's funding: 1. Total annual amount budgeted for compensation under the CICP. Fiscal Year 2020 = \$400,188

Fiscal Year 2021 = \$931,735 Fiscal Year 2022 = \$931,936 Fiscal Year 2023 = \$5,000,000 **2.** The total annual amount budgeted for the overall CICP.

Fiscal Year 2020 = \$3,542,810 Fiscal Year 2021 = \$5,952,064 Fiscal Year 2022 = \$7,192,729 Fiscal Year 2023 = \$15,000,000

A total of \$20M was set aside for claim compensation and budget when it was all said and done for the fiscal year 2023 or 0.00018% of government spending during the failed COVID response. For an unproven product rushed through safety testing and aggressively targeting, often through unconstitutional mandates, every adult, adolescent, child, and infant.

Rohde's FOIA also uncovered that the CICP estimated that the allotted \$15M would "be used to initiate the review of an estimated 1.500 medical reviews of claims and provide compensation to eligible individuals for injuries and deaths directly resulting from the use of covered countermeasures." In other words, they expected 1,500 injury claims. What did they actually receive? The latest update from the U.S. Health Resources & Services Administration, which administers the CICP, shows the following numbers: Total COVID-19 CACP claims filed = 11,196; Pending Review or In Review = 10,653; Decisions = 543; Eligible for Compensation

and Pending Benefits Determination = 19; **Paid Out = 0**

Expected 1,500 claims...received 11,196...in an underreported system. Yet that's not the most shocking piece of information. For nearly 3 years, HRSA has paid out zero claims. Not a penny to COVID vaccine-injured Americans waiting for assistance. To get an idea of the potential backlog we are talking about, we go to VAERS where the first records of possible vaccine injuries are recorded before potentially moving onto a CICP claim. Here are the most recent number and types of reports filed after COVID shots: Deaths = 34,478 (more deaths than the in the last 30 years from all vaccines combined) Hospitalizations = 192,755 Urgent Care = 146,706Doctors Office VIsits = 225,633 Anaphylaxis = 10,411Bell's Palsy = 16,755Miscarriages = 4,930Heart Attacks = 18,649 Myocarditis / Pericarditis = 26,504 Permanently Disabled = 63,660 Thrombocytopenia / Low Platelet Count = 8.526

From past behavior and current trajectory, the U.S. government will try at all costs to avoid taking accountability, financially, ethically, and legally, for the vast amounts and types of injuries caused by the rushed COVID shots. It is up to the media, politicians, and people everywhere to keep this story front and center in an effort to seek justice for those harmed.

Intergovernmental Negotiating Body will meet from February 27 through March 3 to finalize this proposal.

Additionally, the WHO's International Health Regulations Review

Committee (IHRRC) met in January to finalize the proposed IHR amendments, which will further enable Covid medical tyranny (including vaccine passports) and empower international bureaucracy at the expense of American sovereignty. The

World Health Assembly would then consider these amendments at its next meeting in late May. Already, the WHO recently considered recommending travel checks in response to a new strain of Covid.

State legislators have a key role in stopping these schemes — they have a duty to nullify it (i.e., prevent its enforcement within their state's borders), along with every unconstitutional treaty, law, or edict. This is not just "a federal issue," and state legislators have no excuse for not acting. Contact your state legislators and urge them to enforce the U.S. Constitution through nullification.

The Threat

On December 1, 2021, the World Health Assembly agreed to begin "a global process to draft and negotiate" an agreement "to strengthen pandemic prevention, preparedness and response."

The WHO released a working draft of its proposed "pandemic treaty." This draft would be a major step toward world government; it emphasizes "solidarity," meaning "ntensified international cooperation," and it floats increased "collaboration and cooperation across the United Nations system and other international and regional intergovernmental organizations and non-State actors and bodies as a means of strengthening the [agreement's] implementation." Furthermore, it promotes "universal health coverage" and could threaten free speech. Last, but not least, the WHO stated that it could expand the agreement's scope to go beyond pandemics, and be implemented at the UN level. This treaty threatens our God-given freedoms protected by the Constitution.

Any "pandemic treaty" is a threat for the following reasons:

* It will further erode U.S. national sovereignty, giving foreign bureaucrats greater control over domestic policy. It would also amount to yet another step toward a tyrannical one-world government.

* It will further expand the WHO's ability to dictate health policy worldwide, making it easier for the Deep State to impose its tyrannical "health" measures on the global populace.

* It will enable the creation of


global "health passes," thereby restricting travel and certain activities to only those who have been vaccinated or who are in compliance with the WHO's "health" dictates. These so-called "health passes" will further compromise individuals' medical privacy and lay the groundwork for a biomedical security regime.

* Enable "global coordinated actions" to censor those who dissent from the Deep State's narratives — all in the name of "public health." * American taxpayer money would likely be diverted to enable the implementation of the treaty's dictates.

This is not the only WHO threat to liberty. Additionally, the U.S. proposed amendments to the WHO's **International Health Regulations** (IHR). These amendments would also strengthen the WHO's ability to take unilateral actions and meddle in countries' internal affairs, and they could lead to an expansion of the CDC's power to detain Americans for medical reasons. Although the WHO temporarily withdrew most of the amendments, it is still planning on amending the IHR and submitting similar amendments to be voted on in May 2023. Additionally, the WHO continues to work on its proposed pandemic treaty and could potentially merge the IHR amendments into it. These amendments, combined with the proposed pandemic treaty, constitute a massive threat to liberty by the WHO.

time already. For example, in an April 3, 2020 op-ed, former Secretary of State Henry Kissinger stated that, "Addressing the necessities of the moment must ultimately be coupled with a global collaborative vision and program." Additionally, Bill Gates has called for strengthening the WHO, while the organization's own director-gener-

al, Tedros Adhanom must also be subject to, and bound by, the limitations of the Constitution.

In a letter, dated

September 7, 1803, then President Thomas Jefferson wrote: "I say the same as to the opinion of those who consider the grant of the treaty making power as boundless, if it is, then we have no constitution." This was further affirmed by the Supreme Court of the United

States, in Reid v. Covert (1957), in which the Court correctly ruled: It would be manifestly contrary to the objectives of those who created the Constitution, as well as those who were responsible for the Bill of Rights – let alone alien to our entire constitutional history and tradition – to construe Article VI as permitting the United States to exercise power under an international agreement without observing

> constitutional prohibitions. The Court

that must conform to that instrument." Even the most constitutionally-egregious pandemic treaty would be powerless under Article VI. If the U.S. Senate ratifies the

WHO's proposed treaty, states must nullify its enforcement.





#FluorideLawsuit: Censored Review On Fluoride's Toxicity Will Soon Be Made Public

Attorneys with the Fluoride Action Network and the U.S. government have agreed to the release of a censored report on the toxicity of fluoride, the latest development in the ongoing Fluoride lawsuit.

After numerous delays, and intervention by Assistant Health Secretary Rachel Levine, the U.S. National Toxicology Program's review of Fluoride's toxicity will soon be released to the public. The move is the latest development in the nearly decade-long legal battle between the Fluoride Action Network, Food and Water Watch, Organic Consumers Association, and the U.S. Environmental Protection Agency (EPA).

Attorneys with the Fluoride Action Network and the National Institute for Environmental Health Sciences (NIEHS), parent agency for the National Toxicology Program, have agreed to the release of the long-delayed NTP review on fluoride's toxicity. The release of the documents will play a major role in the next phase of the ongoing lawsuit against the EPA.

The decision to release the documents was made at a February 3rd meeting between counsel for the Fluoride Action Network and the NIEHS following a subpoena requesting comments from the agency, the NTP's responses, and additional documents relevant to the decision not published in the NTP's completed fluoride monograph in May 2022.



The NIEHS agreed to publicly post the NTP monograph to the NTP website, as well as comments provided by a little known bureaucracy known as the Board of Scientific Counselors, and the NTP's subsequent responses. In addition to the NTP monograph they will also publish a related meta-analysis that has been a subject of debate in recent hearings.

In a hearing on January 10th, Michael Connett, representing the Fluoride Action Network and other plaintiffs, expressed interest in obtaining comments from officials within the Department of Health and Human Services. In a declaration to the court, Dr. Richard Woychik, Director of the NIEHS, claimed it is these comments from unknown officials at the HHS which lead to the monograph being put on hold.

The EPA told Judge Edward Chen these comments should be privileged and not allowed as evidence in court or made public. Ultimately, Judge Chen ordered the two parties to meet and come to an agreement about which documents would be made public. The NIEHS agreed to post the documents on or before March 15th, before the next scheduled court hearing on April 11th. Judge Chen

has previously said he is likely to set a new trial date at the April hearing. The release of the NTP monograph, a related meta-analysis and interagency comments are likely to play a major role in

the second trial phase of the nearly decade-long legal battle.

The Fluoride Emails Reveal Corruption of Science

The discussion around the comments related to the NTP's unreleased monograph stem from revelations contained within internal CDC emails which were obtained via Freedom of Information Act requests by Connett. The emails indicate the NTP report was not made public due to interference from Assistant Health Secretary Ra-

chel Levine and National Institute of Health Director Lawrence A. Tabak. One email from the CDC dated June 3, 2022, specifically stated, "ASH Levine has put the report on hold until further notice."

Connett outlined the findings of the emails in several exhibits submitted to Judge Chen. "These emails confirm that the NTP considered the May 2022 monograph to be the NTP's final report," Connett writes. "They also confirm that the CDC was opposed to the NTP releasing the report, and that leadership at the top levels of the Department of Health Human Services intervened to stop the report from being released."

As Connett notes, on April 28, 2022, Dr. Mary Wolfe, the Director of NTP's Office of Policy, Review and Outreach, emailed Casey Hannan, the Director of CDC's Division of Oral Health, and stated that the NTP's "analysis and conclusions are set". Dr. Wolfe also let Hannan know that the NTP had reviewed the CDC's submitted comments, but still planned to release the review "mid/late May" 2022. In a May 11, 2022 email, Wolfe again notifies Hannan and the CDC that the NTP has "set May 18, 2022



for publication of the monograph. The monograph will be posted to the NTP website, and we will email a notice of the posting to NTP list-serv subscribers." However, later that day and the following day, Dr. Karen Hacker, the Director of CDC's National Center for Chronic Disease Prevention and Health Promotion (NCCDPHP), tells Dr. Wolfe that there is concern within the CDC about publishing the NTP review without an additional review by "NIH leadership". Hacker also asked about the potential of a

"interagency review" by the Department of Health and Human Services (HHS).

Dr. Wolfe subsequently

told the CDC that "we (the NTP) believe the current findings, as stated in the monograph, reflect the scope of our evaluation and the available scientific literature and no revision is needed".

Meanwhile, another study on the toxicity of fluoride has been published by scientists from Toronto's York University in the journal Science of the Total Environment. The study, Fluoride Exposure And Hypothyroidism In A Canadian Pregnancy Cohort, linked fluoride exposure with an increased risk of hypothyroidism in pregnant women. "The findings are concerning because hypothyroidism is a known cause of brain-based disorders in children," stated Christine Till, PhD, clinical neuropsychologist and one of the study's authors.

Introduction

"When a commercial bank makes a loan contract with a borrower, the bank CRE-



ATES the deposit in the borrower's account." Have you repeated this fact 15,000 times yet? Private banks CREATE what we use as money. This 'money power' can also be called Finance Capitalism or Wall Street, or just the Banks. Those who control this 'money power,' have powerfully influenced our entire society. This control of the banks by wealthy elites goes back to the end of the 19th century, when financial-industrial cartels, run by names like J.P. Morgan, John D. Rockefeller, Andrew Carnegie, etc., used the 'money power' to take over the American economy. These financiers created tax-exempt foundations to shield their wealth from taxes but, more importantly, to allow it to grow and grow.

What We Learned in Part 6:

Wealthy capitalists funded the germ theory of disease and "scientific" medicine. They did not want to bring attention to the unhealthy effects of their huge industrial systems. The tax-exempt foundations, Carnegie and Rockefeller, stepped in. From 1910-1930s the foundations gave an unprecedented \$300 million for medical education/research.

What We Learned in Part 7:

After the war, the federal government opened its spigot to the medical industry. However, federal health research continued the focus on the narrowly technical components of disease and death rather than on the broader economic and

physical environments so central to the population's health status."

The History of the Early Pharmaceutical Industry

The first medicinal drugs came from natural sources – herbs, plants, roots, etc. – starting with the juice of the opium poppy (morphine) used to kill pain, around 3000 BC. However, that all started to change in the middle of the 19th century when German scientists began to dominate the field of analytic and organic chemistry with chemical discoveries. The first synthetic drug, chloral hydrate, was discovered in 1869 and introduced as a sedative-hypnotic.

The first synthetic drugs and the entire pharmaceutical industry can be traced to the manufacture of textiles and synthetic dyes. In this process, the black sticky mass (tar) remaining after distillation of coal under a vacuum provided a rich source of aromatic chemicals. The Friedrich Bayer Co., founded in 1863 in Germany, was one of the first firms to show an interest in pharmaceuticals. It developed and

marketed acetanilide from coal-tar as the first fever-reducing drug, Antifebrin. It was a market success. Bayer looked for other chemicals in the waste products from dyeworks. In 1897 the company marketed the first wonder drug, Aspirin, and filed a patent for the discovery - in 1899 in Germany and in 1900 in the U.S.

German Dye Company Cartel & American Business: 1916-1925

In 1916 the six largest German chemical companies (several of whom produced pharmaceutical products from coal-tar and other chemical bases) became a combination called I.G. Dves. Germany lost the war, but her cartel continued to plan ahead. One of the war-time seizures of Germany property was the American Bayer Co, with the Bayer Aspirin trademark as its most valuable asset. The company was offered at public sale in 1918 by the Alien Property Custodian, and was bought for \$5,310,000 by Sterling Products. In the fall of 1919, the president of Sterling was in Germany reaching an agreement between the German and American Bayer companies for marketing in South America.

In 1925 and 1926, the huge I.G. Farben succeeded I.G. Dyes, adding five of the larger chemical companies of Germany. A new agreement was made between Farben and Sterling, after Sterling had set up Winthrop Chemical Company to handle Bayer's drugs in the U.S. market. Farben got 50% of Winthrop's stock.

Farben and Rockefeller

Between 1924 and 1931, Germany borrowed abroad, mainly in the

U.S. bond market, about 33 billion marks. These Germany bonds were issued by Wall Street banks and financial houses. These loans from the pockets of the American public allowed Germany to pay its reparations under the Dawes Plan and later the Young Plan. It

also brought huge profits for the financiers.



In April, 1929, a new company, American I.G. Farben, was launched by a Wall Street syndicate headed by National City Bank (Rockefeller controlled). The syndicate sold \$30 million of 5 ½ percent convertible debentures, oversubscribed in an hour. The prospectus announced the principal, interest, and premium were guaranteed by I.G. Farben. "It was evident that the American I.G. was to be a Farben holding company for its manufacturing subsidiaries in the United States." The four American directors included:

- * Walter Teagle: NY Federal Reserve Bank; Standard Oil of N.J. (Rockefeller controlled)
- * *Edsel Ford:* President, Ford Motor Company
- * *Paul M. Warburg:* Chairman, Bank of Manhattan; founder, Federal Reserve System
- * Charles E. Mitchell: Chairman, National City Bank (Rockefeller controlled)

FDA Asks Companies to Recall Diabetes Medication Metformin

The FDA has announced that the common diabetes drug metformin may have unacceptably high levels of a cancer-causing drug. NDMA is a cancer- causing contaminant called N-Nitrosodimethylamine. If you currently take metformin, it's crucial to talk with your doctor about other

of a carcinogen called N-Nitrosodimenthylamine (NDMA).

According to the Food and Drug Administration (FDA), the tablets — Metformin HCl Extended Release Tablets, USP 750 mg — contain unacceptably high levels of NDMA that exceed the FDA's limit of 96 ng/day. The tablets' lot number is **MET200501** and they have an expiration date of July 2022. The drugs were distributed to wholesalers nationwide.

The recall expands a previous recall issued November 2020. Several other generic drugmakers were also asked to recall metformin products due to similar NDMA concerns last May. The FDA has been investigating the presence of NDMA in

metformin drugs in the U.S. market since late 2010 after multiple batches of the diabetes drug sold outside the United States were found to contain low levels of the substance. NDMA was also detected in multiple other prescription and over-the-counter (OTC) medications, including ranitidine and certain blood pressure drugs,

earlier this year. The drugs have since been recalled.

The overall risk of developing cancer from medications contaminated with small amounts of NDMA is low. However, if you currently take metformin, it's crucial to talk with your doctor about other treatment options.

"While hearing that our medicines, agents essential for our health and well-being, could be compromised in any way is certainly alarming, it is important to understand the magnitude of the risk, which is extremely low," Dr. Amir Masoud, a Yale Medicine gastroenterologist and assistant professor of internal medicine,

What is NDMA and why is it harmful?

NDMA is classified as a probable human carcinogen, meaning it could potentially cause cancer. We've all been exposed to low levels of the substance. NDMA has been detected in meat, vegetables, dairy products, soil, air, and water. NDMA is all around us, Masoud explained. The acceptable intake limit for NDMA in medications is 96 nanograms a day. "The FDA does not expect to cause harm at levels below this cutoff. The risk of cancer is increased if people are exposed to it at higher levels at prolonged periods of time," said Dr. Guy Mintz, the director of cardiovascular health & lipidology at Northwell Health's Sandra Atlas Bass Heart Hospital in New York. In high doses, NDMA may cause liver, lung, and kidney problems, according to studies conducted on animals.

The World Health Organization (WHO) says it can also lead to gastric or colorectal cancer. "NDMA has been shown to increase the incidence of cancer in animals as well as cause liver fibrosis and tumors in rats," says Mintz. No human cancer cases have been directly linked to NDMA at this time. It's not entirely clear how NDMA gets into medications.

According to the U.S. Environmental Protection Agency (EPA), NDMA forms during natural and industrial processes involving chemical reactions. NDMA may form during the drug's manufacturing process or when they are packaged and stored, the FDA stated. Our bodies may also produce NDMA as a byproduct when digesting certain food and drugs. "It appears that a perfect storm of sorts has to take place: The compounds that form NDMA may be present in the drug and, under certain conditions, may form after formulation of the drug," says Masoud.

What to do if you take metformin
The FDA says patients who take



extended-release metformin tablets shouldn't stop taking the medication abruptly. According to Mintz, doing so could negatively impact blood sugar levels and potentially lead to hospitalizations for hyperglycemia and keto-acidosis. There is no short-term risk in continuing to take the medication until you talk to your doctor about other options. "Immediately stopping any medication without the direct supervision and direction of your clinician is never the right answer," Masoud said.

Mintz said there are many alternative options, including short-acting versions of metformin and other types of diabetes medications — SGLT2 inhibitors and GLP1 medications. Your doctor will likely carefully change your treatment plan to mitigate any health risks. "It's essential to understand that independently stopping or changing your medications without input from your doctor can lead to direct and immediate risks far outweighing those posed by the possible contaminants discussed here," Masoud said.

The bottom line

A new batch of metformin extended release tablets used to treat type 2 diabetes has been voluntarily recalled due to high levels of a carcinogen called N-Nitrosodimenthylamine (NDMA). Health experts warn that abruptly stopping the medication could have negative health consequences. There's no short-term risk, so stick with it until you talk with your doctor about alternative treatment options.




Acupuncture for Diabetes



What Giordano is selling is the exciting means of controlling minds with deniable technologies. This includes bioweapons and nano-technology to allow for the remote implantation and extraction of thoughts. Transcranial electronic

He revels in these cascades of jargon, showing with the prolixity of the peacock an effective means of safely uttering atrocious ideas. This is unsurprising, as he proudly announces he has also been tasked with: "creating a lexicon, a nomenclature that would be able to define these [things] in more precise ways." By "more precise ways" he means "making the hellish attractive." He is doing the Devil's work, and has written a diabolic dictionary to describe it. Let us see what he means by means: "Transcranial electronic stimulation by means of aerosolized nanoparticles." This means they are making clouds of tiny mind control machines for you to inhale without knowing.

who sees ethics as a weapon of the enemy, and in fact says so himself, before going on to explain how "Neurovascular haemorrhagic agents..." - things that cause internal bleeding - can be used for "inclose and population use as 'stroke epidemic' induction agents." Saudi Arabia's Quandary: The End of the Petrodollar

In 1971 Richard Nixon took the US off the last feeble vestiges of the gold standard, otherwise known as the Bretton Woods Agreement. That system had been a bizarre gold-dollar hybrid where the dollar was the world reserve currency but the US agreed to keep the dollar backed by gold. Henry Hazlitt's book From Bretton Woods to World Inflation explains the consequences of this situation well.

The end of this system left a vacuum at the heart of world financial affairs, one that needed to be filled quickly. The dollar, now unmoored by gold, remained the default currency for international trade, but without the confidence derived from its former gold backing, the US needed to bolster its credibility lest other more enticing options appeared to displace the dollar's hegemony.

During the 1973 Arab-Israeli war, the Organization of the Petroleum Exporting Countries (OPEC) had gained leverage by imposing an oil embargo, which caused serious disruptions in the global economy. In 1974 Henry Kissinger brokered a deal: Israel would back off its territorial ambitions, the Arab states would end the embargo, and oil would be traded in dollars. Thus, the petrodollar was born.

Every economy needs energy, and Saudi Arabia supplies plenty of oil, meaning that the dollar was backed up by a valuable commodity that would always be the recipient of demand. Everyone wants oil, and the Saudis would only trade it for dollars, so the dollar became unavoidable in international trade, reaffirming its status as the world reserve currency.



Even if others would have preferred a neutral, market-based currency not subject to manipulation, the opportunity cost of foregoing oil was far higher than the cost of having to use the dollar. A global medium of exchange selected by the market would have been more economically efficient, but given that the US and the Saudis possessed the ability to impose a politically motivated system, nobody was willing to bear the costs to create an alternative as long as the dollar was managed fairly sensibly.

Washington and the Gulf States benefit enormously from this situation. The petrodollar gives the Fed extreme license to print currency and export its inflation. If other countries are forced to use your currency, that gives you a lot more room to debase it. Imports are made cheaper with the high purchasing power of the dollar, and exports are propped up because the easiest way to spend dollars is to buy American products.

All this amounts to Washington essentially taxing world trade. The Gulf States benefit in the same ways by having enhanced access to the

world reserve currency. Their oil is given priority in world markets compared to competitors opposed by Washington, such as Iran. They are also just simply given financial aid by Washington for participating in this scheme.

However, there are consequences for the countries involved. Even if the US has largely avoided extreme domestic consumer price inflation by circulating dollars around the world, the business cycle consequences of inflation are unavoidable. For example, the 2008 recession was severe yet unaccompanied by extreme inflation before or after. Holding the world reserve currency has also given the US a free ride with far less need to produce valuable goods and services. The dollar holds its value because there has always been global demand for it, so it has been possible to print money to prop

up the US economy by consumer spending without an extreme loss of value in the dollar. But there is now very little worth in the underlying US economy.

The dollar is backed up as the world reserve currency by a series of secondary institutions: the International Monetary Fund, the World Bank, etc. On top of this, though unspoken, there exists a military and intelligence enforcement mechanism. Oppose the dollar and either Washington will invade you, or agents from the Central Intelligence Agency will appear and ask domestic radicals what color they would like their revolution.

Iraq persistently attempted to abandon the dollar, making a particularly assertive move in October 2000. Then they were invaded in 2003 without having attacked America or any other country. Libya's Muammar Gaddafi attempted to create an Africa-wide gold-backed dinar and was assassinated in 2011. Of course, US involvement in these countries is not monocausal, and other factors like security guarantees for Israel and progressive crusading play a role. But securing the hegemony of the dollar is a critical issue in Washington's foreign policy.

The corollary of the power granted by possession of the world reserve currency is the ability to break the rules of your self-proclaimed rulesbased order. Saudi Arabia funds radical mosques around the world, and we have already mentioned the recent American invasions.

> ize that Washington has abrogated its responsibilities, and the second and third world cannot ever allow what has transpired with the covid inflathe ruble to a semi-gold standard. China has also made moves regarding gold and is far ahead of the US in the race for an all-impor-

Other states must acquiesce to this behavior because ending up on the wrong side of the dollar would be disastrous for their economies, and it could potentially mark them as a target for invasion or subterfuge. But it seems like recent actions have been too extreme for other world powers to accept. The printing of more dollars in 2020–21 than in the entirety

of the currency's history up to that point destabilized the global financial system by creating mass inflation. And the sanctions imposed on Russia exacerbated the situation even further.

In the past thirty years there have been many post-Communist wars involving many deaths and frequently involving Russia (not that I am necessarily blaming Russia for these wars). Think of Chechnya and Georgia: nothing like the current sanctions were imposed on Russia for what were essentially parallel conflicts to the current stramash in Ukraine. The West's reaction against Russia in 2022 was unprecedented. The fact that the West has turned a regional conflict into a proxy war and destabilized the world economy, seemingly due to ideological frenzy and a desire for one world government, has disturbed many other powers. They have suffered from the economic chaos and may encounter similar regional conflicts in their own future. They are concerned the West could leap into these disputes in the same way they have attempted to crush the Russians.

tion and the Russia sanctions to happen again. Russia has already linked



tant central bank digital currency. Previous solid allies like India are backing away from the increasingly deranged Washington establishment. As countries refuse to go along with the bizarre social agenda and utopian eschatology of Washington, they will also have to seek alternative economic arrangements.

For Washington both the political and economic systems are nonnegotiable. It has hardly been trumpeted by the Western press, but if you have been paying attention this past year, you will have noticed stories of major countries agreeing to trade in currencies other than the dollar. Decoupling is a tricky proposition as these countries' economies have been tied up with the dollar for decades. There is also the risk of Washington violently lashing out to maintain its hegemonic status. Thus, the transition away from the dollar is likely a medium- to long-term trend.

But the first decisive moves have occurred, and there is no turning back short of serious self-reflection on the part of Washington (which I would bet against).

However, much hinges on Saudi Arabia's actions. As we discussed earlier, they made the petrodollar, and they will be the ones to break

> it if that is what transpires. Since it is their oil that underpins the value of the dollar, the more they trade oil in other currencies, the less value the dollar possesses. And in a momentous story, the Saudi minister of finance stated that they are open to trading oil in currencies other than the dollar. The Chinese and Saudi leader-

ship have discussed this issue, and securing bilateral trade without the involvement of the dollar appears to be a top Chinese priority.

A failing dollar will have disastrous consequences for the US as there are not enough manufacturing or nonfinancial services in its economy. Imports will suddenly be expensive,

and the quality of life will drop. Much of the establishment isn't as hard headed as those who came before and doesn't conceive of the possibility of Washington losing. How

could they? Russia is mildly antigay, and they don't believe in climate change. They're the bad guys, and the bad guys always lose. Other quarters of the establishment seem to have retained a dose of realism and appear to be looting the government and the economy while the dollar still has value (think Biden's gigantic crony-laden spending bills).

The good news is that Washington's plans for world domination are bound to fail as China and Russia have a revived alliance, which also appeals to and is open to other powers. The bad news is that this will lead to the drawn-out collapse of the dollar, which Washington will attempt to parlay into a new central bank digital currency to accompany an increased crackdown on opposition within the dwindling empire. But ultimately, with visibly successful alternative systems elsewhere and less material comfort at home, more people will begin to question the first principles, foreign policy, and economic doctrines of the post-World War II order.



The Problems with Disney and Florida

The core of the problems with Disney and Florida is the American addiction to corporatism. This is the use of government power for the benefit of the government's patrons. Stated differently, it is a symbiotic relationship between the government and a private business that gives government officials corporate largesse and the private business a near monopoly. It is capturing the power of the state to increase private wealth at the expense of others.

Corporatism is immoral because it bribes the state to give government power to a patron. It is economically counterproductive because it stifles competition. It is unconstitutional

because it violates equal protection and, in the Florida dispute with Disney, free speech.

In the 1960s, when Walt Disney came upon 25,000 acres of land outside Orlando, Florida, for his theme park, he crafted a deal with the state that gave his company extraordinary control over the land in return for building the park. For Florida, it was a win in terms of tourism dollars and employment opportunities. For Disney, it was a win in terms of relief

from local regulatory constraints and certain state and local taxes.

Last week, after much public dispute between Disney personnel and Florida officials over a new Florida statute prohibiting government school teachers from teaching about sexual orientation and gender identity to 5-, 6- and 7-year-olds, Florida enacted legislation abrogating the contract between itself and Disney. It appears that the abrogating legislation was in retaliation for Disney's public opposition to the school curriculum legislation.

Can the government constitutionally favor one business over others that are similarly situated by granting relief from legal obligations to the one and not to the others? Can the government constitutionally punish a corporation for the exercise of free speech by its officers and employees? The short answer to both questions is: No.

Here is the backstory.

The Fourteenth Amendment was written to compel the states to treat similarly situated persons and entities in a similar manner. By isolating Disney and giving it special privileges that other theme parks did not receive, Florida has been in violation of the amendment's Equal Protection Clause. It has also put its thumb on the scales of free enterprise by making it easier and cheaper for Disney to operate its theme park than is the case for its competition.

Clause arguably requires. This is an economic argument in favor of no regulation, and hence no corporatism. In that environment, competition will flourish, products and services will be improved, the costs to consumers will be reduced and the choices to consumers will be enhanced.

Florida's state constitution requires the state to operate a school system. This has produced in Florida and elsewhere a grossly expensive, highly inefficient and intellectually dangerous educational program. Government schools have guaranteed customers — the students; guaranteed income — from the taxpayers and no effective competition. That is a recipe for failure. It is also a recipe for ideological indoctri-

nation — like,
"Government is
here to help you"
or, "Lincoln was
a great president"
or, "All patriots
support the nation's wars" and
— today — "You
can be any gender
you want, or no
gender."

Florida had an illicit contract with Disney that it impaired for unconstitutional purposes — pun-

ishing speech. The First Amendment nullifies the government's power to regulate, reward or punish speech. It presumes that the listener, not the government, can decide what speech to accept and what to reject. Moreover, the amendment's purpose is to encourage open, wide, robust, even caustic debate about the policies and personnel of the government. Government interference with contracts for punitive purposes and government punishment of speech because of its content are always unconstitutional.

All of this happened because of corporatism. Corporatism was born shortly after the 13 colonies seceded from Great Britain and began to



Whenever the government favors one competitor over another, economic and constitutional issues arise. Economically, the consumer suffers by having fewer choices and — in this case — by having a behemoth with little competition. The absence of meaningful competition enables Disney to impose a "take it or leave it" price structure and product offering upon its customers. As well, by enabling Disney to pay lower taxes, Florida has shifted Disney's tax burden to other taxpayers, thereby treating them in a manner that is inconsistent with equal protection.

I am not making an economic argument in favor of equal regulation; that's what the Equal Protection



charter corporations, often to those who had loaned money to the colonies to fight the revolution. At the time, corporations were viewed as agents of the state, which gave them freedom from competition. One of the purposes of the Commerce Clause in the Constitution is to prevent states from impairing commerce via monopolies and tariffs. It would take 100 years before the Supreme Court dropped its "recipient of privileges" theory of corporations and viewed corporations as "voluntary aggregates of investors" — the latter recognizing that corporations have only the rights and powers that their incorporators gave them.

In the case of Florida and Disney, the symbiotic relationship between the two is dangerous because Disney exercises the power of the state without its constitutional restraints, and Florida politicians expect public pliancy and political contributions from Disney as a matter of course.

Add to all this the government schools' violation of the parent/child relationship — partially remedied by the new legislation — by intruding into an area of moral learning that the Supreme Court has left to parents, and you have the constitutional monstrosity that is the offspring of a government that recognizes no restraints.

Thomas Jefferson, who wrote that our rights come from God, and James Madison, who wrote that individuals are sovereign, would not recognize government in America today. It is force without reason. It is power without restraint. And it views our natural rights as privileges that it can deny us. Why do we permit this?







Trudeau Foundation Returns CCP-linked Donation Amid

After a report surfaced that \$200,000 given to the Trudeau Foundation in 2016 was alleged to be connected to the Chinese Communist Party (CCP), the foundation says it is now returning the money.

"The Pierre Elliott Trudeau Foundation has learned in recent days through the media that there was a potential connection between the Chinese government and a 2016 pledge of \$200,000 to be received by the Foundation," reads a press release from the Foundation sent out yesterday, signed by its President and CEO Pascale Fournier.

"In light of these recent allegations, the Foundation has refunded to the donor all amounts received with respect to the donation pledge." The sudden return of the money comes as Prime Minister Justin Trudeau is plagued with accusations that the CCP interfered in his favor in his last two successful

reelection campaigns.

The return of funds also comes in light of a Globe and Mail report from Tuesday exposing a connection between the CCP and the cash gift. As reported by The Globe, Chinese donors with close connections to the CCP wanted a

statue of former Prime Minister Pierre Elliot Trudeau – Justin's father - and infamous Chinese dictator Mao Zedong erected in front of the University of Montreal, which is where the elder Trudeau studied law. This was to be in return for the donation to both the Trudeau Foundation and the University of Montreal. According to the report by The Globe, Chinese billionaire Zhang Bin was the person who would act as the intermediary in charge of supplying the



\$1 million total sum, and that he would be reimbursed afterward. "They suggested one of Trudeau and Mao together," Geneviève

O'Meara, a spokeswoman for the University of Montreal, told The Globe. According to The Globe, a source told them Canada's spy agency, the Canadian Security Intelligence (CSIS) Service, had intercepted conversions regarding the donation.

The University of Montreal eventually decided not to erect the statue.

The Pierre Elliott Trudeau Foundation labels itself as "an independent and non-partisan charity established in 2001 as a living memorial to the former prime minister."

The Foundation's decision to give back the funds also comes after a series of bombshell reports from The Globe & Mail and Global News which show that CSIS has long been documenting allegations that Canada's 2019 and 2021 elections

Election Interference Allegations were interfered with by the CCP. The reports also show that there The reports also show that there was alleged meddling in the candidate nomination races as well. Many have pointed to the fact that it seems Justin is merely following in the footsteps of his father when it comes to his close ties with China.



The Law That Never Was: The Fraud of Income & Social Security Tax

The Premise

The federal government rests its authority to collect income tax on the 16th Amendment to the U.S. Constitution—the federal income tax amendment—which was allegedly ratified in 1913.

"The Congress shall have power to lay and collect taxes on incomes, from whatever source derived, without apportionment among the several States, and without regard to any census or enumeration."


The 16th Amendment to the Constitution of the United States of America

After an extensive year-long nationwide research project, William J. Benson discovered that the 16th Amendment was not ratified by the requisite three-fourths of the states and that nevertheless Secretary of State Philander Knox had fraudulently declared ratification.

It was a shocking revelation; it reached deep to the core of our American system of governance.

The Discovery

Article V of the U.S. Constitution defines the ratification process and requires three-fourths of the states to ratify any amendment proposed by Congress. There were forty-eight states in the American Union in 1913, meaning that affirmative action of thirty-six was necessary for ratification. In February 1913,



Secretary of State Philander Knox proclaimed that thirty-eight had ratified the Amendment.

In 1984 Bill Benson began a research project, never before performed, to investigate the process of ratification of the 16th Amendment. After traveling to the capitals of the New England states and reviewing the journals of the state legislative bodies, he saw that many states had not ratified. He continued his research at the National Archives in Washington, D.C.; it was here that Bill found his Golden Key.

This damning piece of evidence is a sixteen-page memorandum from the Solicitor of the Department of State, among whose duties is the provision of legal opinions for the Secretary of State. In this memorandum, the Solicitor lists the many errors he found in the ratification process.

These four states are among the thirty-eight from which Philander Knox claimed ratification:

* California: The legislature never recorded any vote on any proposal to adopt the amendment proposed by Congress.

* **Kentucky:** The Senate voted on the resolution, but rejected it by a vote of nine in favor and twenty-two opposed.

* Minnesota: The State sent nothing to the Secretary of State in Washington.

* Oklahoma: The Senate amended the language of the 16th Amendment to have a precisely opposite meaning.

Bill Benson would like to thank all those who've contributed or shown support in the fight against fraudulent taxation. When his project was finished at the end of 1984, Bill had visited the capital of every state from 1913 and knew that not a single one had actually and legally ratified the proposal to amend the U.S. Constitution. Thirty-three states engaged in the unauthorized activity of altering the language of an amendment proposed by Congress, a power that the states do not possess.

Since thirty-six states were needed for ratification, the failure of thirteen to ratify was fatal to the Amendment. This occurs within the major (first three) defects tabulated in Defects in Ratification of the 16th Amendment. Even if we were to ignore defects of spelling, capitalization and punctuation, we would still have only two states which successfully ratified.
