Signed in 1787, the US Constitution states that no state shall make anything but gold and silver coin a tender in payment of debts. In 1791, to help pay for the revolution, Congress established the First National Bank of the United States. Within a decade it became evident that taxes were being sent to the Crown and the bank was not renewed.

A political battle ensued which resulted in the formation of America's first two political parties, the Federalists and the Democratic Republicans. In 1933, the US government declared bankruptcy and the Fed shifted to a debt based economy. And after the US Dollar was made the world reserve currency, the

entire world became dependent upon debt. A currency backed by nothing but debt and IOUs was doomed to eventually fail from the start. And that day appears to be coming soon.

These big banks have funded wars and criminally profited off human suffering for decades. Credit Suisse alone has been fined over 50 times for over \$10 billion for money laundering, fraud, espionage, drug trafficking, and stealing money from the people. Every person in the civilized world is now feeling the same financial pressure being subjected by the US Federal Reserve Bank.

## HUGE: Arizona House Joins Senate In Passing Resolution To Ban Foreign Voting Machines, Require Source Code, Ballot Images, Chain Of Custody Documents, And Log Files To Be Made Public

The Arizona House voted yesterday to pass Senate Concurrent Resolution 1037, setting official requirements for the use of electronic voting machines in the state and banning the use of some.

The resolution passed in the Ari-

zona Senate on March 6 by a vote of 16-13. On Thursday, March 30, The Arizona House joined the Senate and voted 31-27 in favor.

This resolution will bypass the Governor and go directly to the Secretary of State's office. If the Secretary of State does not comply with this order, the Legislature can and likely will sue.

The Gateway Pundit previously reported that the Arizona Senate Elections Committee, chaired by State Senator Wendy Rogers, passed the amended resolution introduced by State Senator Anthony Kern.

State Senator **Sonny Borrelli's** strike everything amendment set official requirements for the voting machines to ensure all levels of production occur in the United States, source code is made publicly available, and directing the Secretary of State to post ballot images, chain of custody documents, and log files on their website within 24 hours after polls close.

It states:  
Page 1, strike everything after the resolving clause and insert:  
"That no voting system or component or subcomponent of a voting system or component, including

firmware software or hardware, assemblies and subassemblies with integrated circuits or on which any firmware or software operates, may be used or purchased as the primary method for casting, recording and tabulating ballots used in any election held in this state for federal office unless:

1. All components have been designed, manufactured, integrated and assembled in the United States from trusted suppliers, using trusted processes accredited by the Defense Microelectronics Activity as prescribed by the United States Department of Defense; and
  2. The source code used in any computerized voting machine for federal elections is made available to the public; and
  3. The ballot images and system log files from each tabulator are

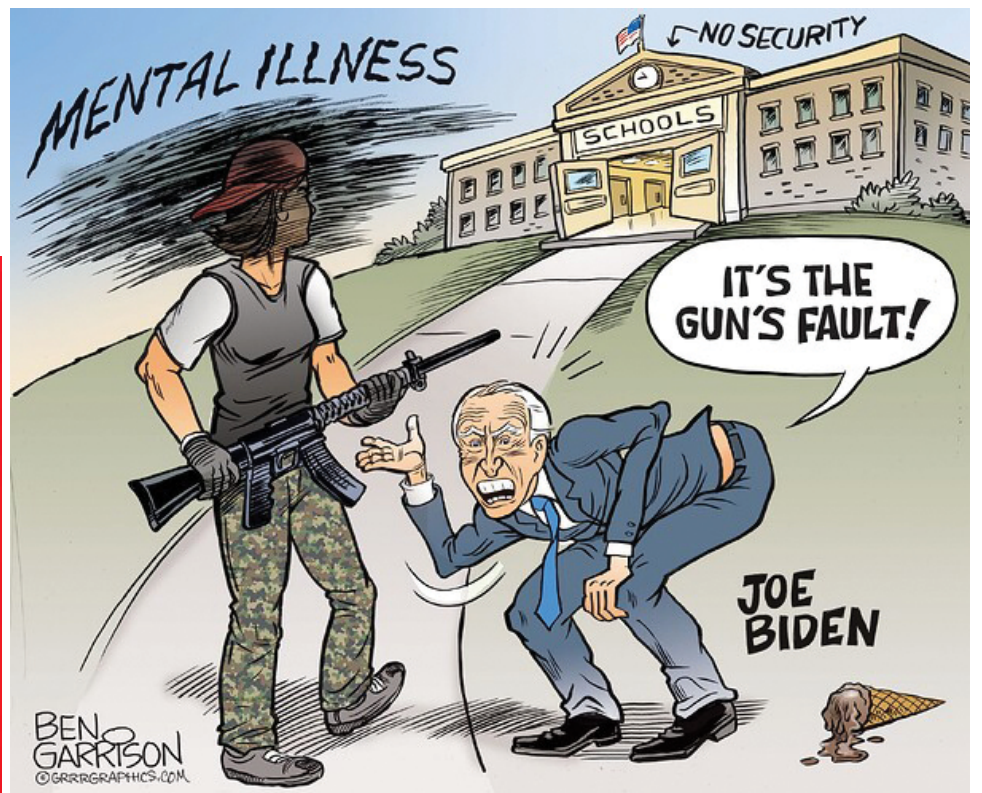

Christian baker's right to not bake a "transgender transition celebration" cake in Colorado. They said nothing when the NFL, the NHL, and the NBA started lacing professional sports coverage with industrial strength "gay pride" with mandatory jerseys for the players and mandatory celebrations for the crowd. pressure, about 35% had diabetes and a third suffered from heart disease.”

“The average age of those who’ve died from the virus in Italy is 79.5 [!!!]. As of March 17, 17 people under 50 had died from the disease.

All of Italy’s victims under 40 have been males with serious existing medical conditions.” BANG.

Average age of those who’ve died: 79.5. Are you kidding? Lots of prior medical conditions, weakened immune

## Arizona: Nullify Unconstitutional Wars With Arizona

URGENT: On March 21, the Arizona Senate passed SB 1367, the Defend the Guard Act, by a 16-13 vote. The bill has now been transmitted to the House. However, House Speaker Ben Toma has refused to assign the bill to a committee. Contact your state representative, along with Speaker Toma, and urge them to support and pass SB 1367.

**Arizona lawmakers are seeking to enact legislation nullifying unconstitutional federal deployments of the Arizona National Guard.**

House Bill 2320 (HB 2320), titled the "Defend the Guard Act," is sponsored by Representative Alexander Kolodin (R-Scottsdale) and cosponsored by nine other representatives and one senator. A companion bill, Senate Bill 1367 (SB 1367) has also been introduced; it is sponsored by Senator Wendy Rogers (R-Tempe) and cosponsored by three other senators. On March 21, 2023, the Senate approved SB 1367 by a 16-13 vote. HB 2320 and SB 1367 would prevent combat deployments of the Arizona National Guard by the federal government in the absence of a congressional declaration of war or another constitutional reason in accordance with Article I, Section 8, Clause 15, of the U.S. Constitution.

In HB 2320's legislative findings, it declares: Although the United States Congress has not declared war in over seventy years, the United States has since gone to war repeatedly at the whim of the executive branch. When unconstitutional actions are taken by the federal government, it is the proper role of the states themselves to take action to remedy the situation as outlined in the Kentucky and Virginia Resolutions of 1798.

According to the Tenth Amendment Center, over 650,000 National Guard troops have been sent to foreign

conflicts since 2001, and 45% of the total U.S. forces sent to Iraq and Afghanistan have been National Guard or Reserve troops. If Arizona and other states prohibit unconstitutional National Guard deployments, the federal government's participation in these foreign conflicts would be severely hampered, therefore limiting the federal government's ability to further entangle the U.S. in any undeclared wars overseas.

Such a limitation on the federal government's ability to carry out an internationalist and interventionist foreign policy would be consistent with the wisdom of the Founding Fathers. In his 1796 Farewell Address, President George Washington affirmed, "It is our true policy to steer clear of permanent alliances with any portion of the foreign world." President Thomas Jefferson reiterated the same policy in his first inaugural address, advocating for "peace, commerce, and honest friendship with all nations, entangling alliances with none."

### Importance

HB 2320 and SB 1367 are an excellent application of Article VI of the U.S. Constitution, which states "this Constitution, and the Laws of the United States which shall be made in Pursuance thereof ... shall be the supreme Law of the Land."

Since the federal government's engagement in endless, undeclared wars — subversion going back decades — violates the U.S. Constitution, it cannot be considered "in Pursuance thereof" and, thus, is not "the supreme Law of the Land." Unfortunately, over the last several

decades, thousands of unconstitutional laws on the federal, state, and even local levels have been created and enforced.

Because of this, state legislatures have a duty to rein in unconstitutional wars and robustly enforce the Constitution and only those laws and actions "in Pursuance thereof." HB 2320 and SB 1367 are an excellent model for other states to follow.

Urge your state representative and senator to stop unconstitutional foreign wars and defend the Arizona National Guard by supporting and

passing the "Defend the Guard Act" (HB 2320 and SB 1367). Additionally, urge them to push back against all other unconstitutional laws at every level of government.

When proposed legislation infringes on our personal rights, security, or prosperity or on our constitutional republic's independence or security, be among the first to find out and act on it. ## Why is it in your Best Interest to Avoid the Following Items?

Occasionally, a serious researcher comes along who has worked very hard to find valuable truths that benefit you and I rather than generating greater profits for corporations. The information presented below was gathered from such a diligent researcher named Morley M. Robbins. Remember: our bodies are efficient at converting clean water, fresh air, sunshine, and real food into its needed requirements, but because of unhealthy farming practices, the processing of food for increased shelf life, and the ever-expanding nutritional supplement industry, we have unknowingly created patterns within our bodies, that if not corrected, guarantee our bodies to age and develop degenerative disease. There is a delicate balance within our body chemistry between copper, iron, magnesium, oxygen, and ceruloplasmin (the major copper-carrying protein in the blood). The following items disrupt this delicate balance and help to cause inflammation and the free radical damage that parallels degeneration.

**1. Iron supplements:** Too much dietary and supplemental iron is the single most toxic factor contributing to poor health and fatigue. Our bodies can retain 95% of the iron from recycled blood cells. The other 5%, which is 1mg. of iron per day, is to be obtained from our diet. Excess iron is the key nutritional element required for the growth of almost all bacteria. Iron is the metal that ages us. Iron is the master pro-oxidant element on Earth and is the principal element behind oxidative stress. Iron triggers the loss of magnesium, that leads to chronic inflammation.

**2. Vitamin D3 supplements:** Vitamin D3 is the storage form of Vitamin D.

The body requires the bioactive form that our bodies develop from sunshine, or that we get from liver and fish oil. Researchers at Yale Medical School found that this supplemental, storage form of Vitamin D causes kidney potassium wasting. It also creates a metabolic demand on the liver that triggers the synthesis of a protein that binds our copper a thousand times stronger than it binds zinc, and without copper we cannot produce energy in the body.

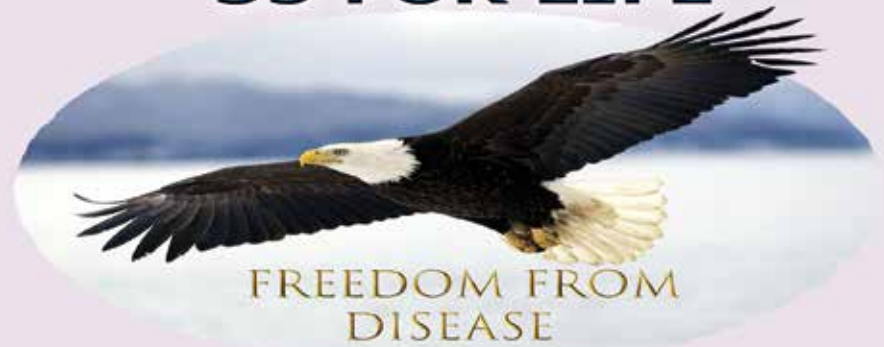
**3. Calcium supplements:** Calcium carbonate supplements are essentially poison to the body's vital bone-building process, and more importantly poison to the metabolic processes to make energy. Calcium is suggested to slow bone loss, but it is the excess of iron activating oxidative stress and the loss of magnesium which causes inflammation which stresses the body and activates it to sedate the stress by drawing calcium from the bones to be used as a sedative, thereby causing osteoporosis.

**4. Zinc:** Unlike dietary zinc, zinc supplements trigger the production of metallothionein in the liver. Metallothionein is the protein that binds up copper a thousand times greater than it binds up zinc. Supplemental zinc, like several other supplemental minerals perform actions that have a negative influence on nutritional copper and thereby create copper deficiencies.

**5. Molybdenum:** Molybdenum deficiencies are virtually nonexistent, so there is really no reason to supplement this mineral. Like supplemental zinc, molybdenum's negative influence on copper is as

a chelator. With too much molybdenum in the body, it chelates the nutritional copper out, causing

a copper deficiency.

**6. Drugstore once-a-day multivitamins, Multimineral, and Prenatal Vitamins:** None of these products are designed to enhance the bioavailable copper in the body. These products are made from a chemical mixture of ingredients including iron, synthetic vitamin C, synthetic vitamin D3, etc. and stress the body rather than help it.

**7. B vitamins:** Most of the B vitamins being sold are synthetic and are produced as byproducts from the petroleum industry. The best way to get your B vitamins is from Beef liver, bee pollen, and other foods rich in the B vitamins.

**8. Ascorbic acid, Citrate, and Citric acid:** these synthetic chemicals are the most widely used supplements in the world and are one of the main culprits in the epidemic of chronic fatigue and all other diseases in the US. element. The fluoride in water, toothpaste, etc., not only displaces magnesium, but in the presence of the oxygen in water, this makes a perfect recipe for creating oxidative stress. It has also been established that fluoride is responsible for the pineal gland becoming calcified.

**12. Colloidal silver as a supplement:** Silver is a time proven way of killing unwanted pathogens within our bodies. Short-term treatment works very well to clear up many unwanted bacterial infections. Yet, there are two important reasons to not use silver long-term. First, silver displaces copper, causing the copper to not be assimilated. Secondly, if silver does the daily work for your immune system, this will slowly weaken your immune response.

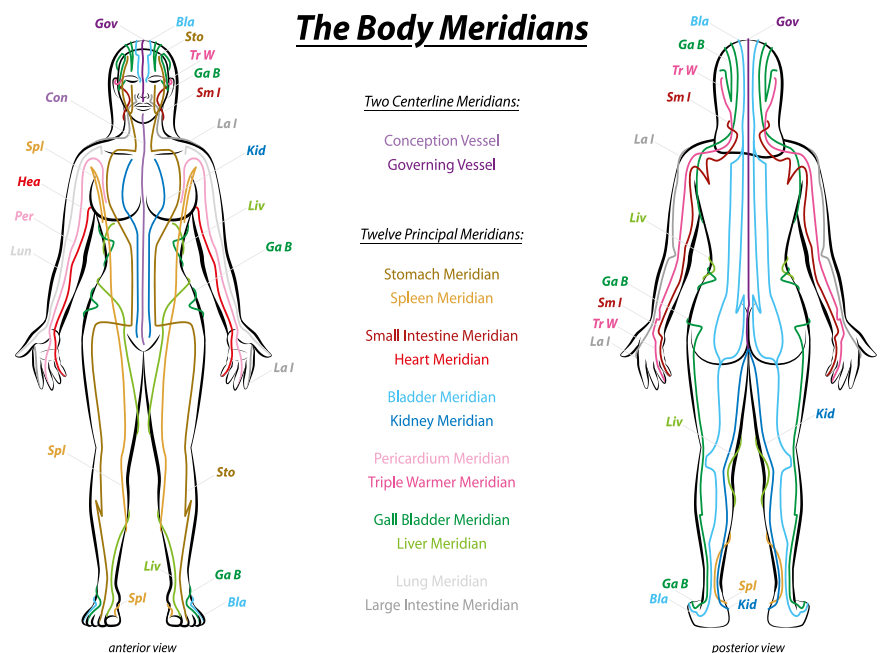

## The Money Matrix: Part 9 Media Control of the News, 1900-1939

### Introduction

“When a commercial bank makes a loan contract with a borrower, the bank CREATES the deposit in the borrower’s account.”  
Have you repeated this fact 15,000 times yet? Private banks CREATE what we use as money. This ‘money power’ can also be called Finance Capitalism or Wall Street. Those who control this ‘money power,’ have power over the entire society – they decide who gets loans – new bankmoney.

Private banks should not have the power to create our money and decide who gets it. When the banks create bankmoney (bank credit) out of debt, they are concentrating wealth in their hands and the hands of the elites. This power should be in the hands of Congress. Congress should issue sovereign money, like the Greenbacks of Abraham Lincoln. When the Congress authorizes sovereign money as an asset, wealth is fairly distributed to the citizens. Here is Edward Kellogg in 1883: “The most fundamental law in any nation is that which institutes money; for money governs the distribution of property, and thus affects in a thousand ways the relations of man to man.”

### Background

This essay will begin to share information about the control of our media by the financial elites from 1900 to 1940. Their control has only gotten exponentially stronger today.

Towards the end of the 19th century, wealthy elites took over control of the economy, by creating financial-industrial cartels. Bankers and industrialists like J.P. Morgan, John D. Rockefeller, Andrew Carnegie, etc., used the ‘money power’ – the private banking system CREATING bankmoney in the account of a borrower – to do this. Here are the words of author William Engdahl: “At the dawn of the 20th century, some sixty ultra-rich families, through dynastic intermarriage and corporate, interconnected shareholdings, had gained control of American industry and banking institutions.” The most powerful of the investment banks was J.P. Morgan and Company, who formed cartel alliances with other investment banks and commercial banks.



### Analysis by Ferdinand Lundberg of Media and Banking Control

In 1937, this well-respected journalist and author published the book, *America’s 60 Families*. In it, he gives an overview of the status of the U.S. press:

\* The rural and small-town press:

“Practically 75% of the county press – the smaller papers of the country, are straight Republican. The remaining 25 % are Democratic... which derives a decisive portion of its revenue from the state and national political committees, and is attentive to the prejudices of the ruling families which finance the political parties...”

\* The middle layer of “independent” newspaper: “...neither very independent nor very numerous... has been the only socially wholesome feature of the American press.” In this division belonged Joseph Pulitzer, the only successful metropolitan newspaper publisher who consistently criticized the powerful and wealthy figures of all camps. “...Since the World War... more and more newspapers from this “independent” stratum have gone out of business, nearly one thousand newspapers.”

\* Biggest metropolitan newspapers and great national magazines are owned or secretly controlled by the 60 families.

On January 20, 1925, *The Wall Street Journal*, central organ of finance capital, wrote: “A newspaper is a private enterprise, owing nothing what so ever to the public, which grants it no franchise” The author Lundberg comments: “The newspaper, in short, reflect actuality as does a convex mirror at Coney Island. The freedom of the press constitutes merely the freedom

to distort and to suppress news.”

### Example of the ‘Money Power’ Suppressing the News - U.S. Entrance into World War/The PageMemo

During the U.S. period of “neutrality” (August, 1914–April, 1917), Morgan had shipped \$5 billion worth of war materials, the economy was booming, and the U.S. had become the leader of world finance. Morgan himself loaned a half billion dollars to the Allies. By the beginning of 1917, the Allies were desperate for more loans, but Morgan had reached his limit. On March 5, 1917, the U.S. Ambassador to Great Britain informed President Wilson that the Allies would lose the war unless they got more loans. Ambassador Page wrote: “If the U.S declared war on Germany, our government could extend such loans and the U.S. could continue to supply war materials. Our prosperity and trade would continue.”

On April 2, 1917, President Wilson asked congress for a declaration of war since “The world must be made safe for democracy.”

From Lundberg: “On October 14, 1934, the *New York World-Telegram* published the text of the cable sent by Ambassador Page to President Wilson in 1917. Although the sensational message had never previously appeared in the press, only three out of twenty leading metropolitan newspapers copied it. The *United Press* carried the text of the Page message in its dispatches of the day, but newspapers struck it out. The *Associated Press*, the *International News Service* (Hearst), and the *Universal Service* (Hearst) ignored the Page cable. Most newspaper readers today [1937] are still unaware that such a cable message exists.”

### Example of the ‘Money Power’ Suppressing the News -- Controlling Book Reviews

In 1922, Thomas Lamont, a Morgan partner, privately financed Henry Canby to found *The Saturday Review of Literature*, a weekly magazine reviewing books and containing editorials “which has for nearly two decades given J.P. Morgan and

Company a strategic foothold in the book-publishing business.” “The *New York World-Telegram* (April 7, 1936) revealed that Canby had admitted turning over to Lamont the proofs” of a book that discussed war preparations and criticized J.P. Morgan and Company. Canby said he wished Lamont would suggest a reviewer. Lamont suggested Charles Seymour, a Yale professor and an associate with Lamont at the Versailles Peace Conference. Seymour attacked the book, and “has since promulgated far and wide the Morgan thesis that the [U.S.] was brought into the war by the German submarine warfare.”

### Concluding Thoughts

There are many, many other examples, in the first third of the 20th century, of the control of the press by the Money Power. The Money Power has only gotten more powerful today. Do you really think we have a ‘free press’ today? My high school history text taught me that a major reason the U.S. entered World War I was the German submarine warfare.

## Connecting the Dots – The True Cost of Electric Vehicles Global Salvation or Idiotic Fantasy?

Battery powered Electric Vehicles (EV) have been touted by the mainstream media, public officials and the Biden administration as a “zero emission” solution that can reduce the effects of climate change. Many states, including California and New York are mandating the phasing out of Internal Combustion Engines (ICE), gasoline powered cars buses and trucks in favor of EVs by 2035.

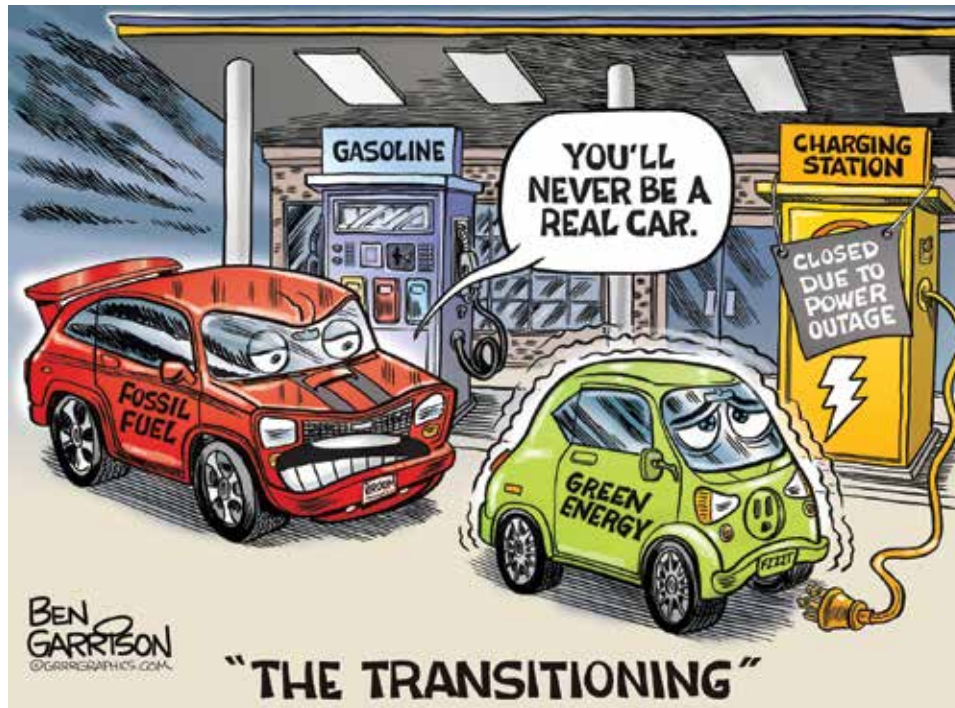
### EV Forecast

Electric vehicle (EV) sales are growing rapidly. EV sales for 2018 were 4.0% of total vehicles sold in the USA with 225,000 vehicles, in 2022 EVs were about 11% of car sales at 670,000 vehicles. The Morgan Stanley analysis forecast that by 2027 EV sales will represent 17% of new car sales at 2,500,000 vehicles. Several forecasts project sales of EVs up to 53% of the global fleet by 2035.

### The Battery is the Issue

At the heart of every EV is a high-performance rechargeable battery. The lithium-ion battery has emerged as the clear favorite for performance and durability. So, with the rapidly increasing demand for EVs comes an equal demand for batteries – and therefore the lithium and other metals required to produce them. As this article will show, when the total “Life Cycle Costs” are considered, the energy required to manufacture and power electric vehicles will leave a sizable environmental footprint. The cradle to grave analysis must factor in the excavating / mining / drilling, industrial processing, embodied energy, refining, transporting, manufacturing, recycling and the electricity generation requirements for recharging the batteries.

Since the intent of EVs is to manufacture a vehicle that is “emissions



free”, one needs to consider not just the mining realities but also the hidden ‘embodied energy’ costs of mining the materials. The embodied energy comes from the cost of the mining equipment, the fuel used to dig up and move earth, grind and chemically separate minerals from the ores, refine the elements to purify, and fabricate the final product.

Embodied energy use starts with the diesel fuel used by giant mining machines. A Cat 994H loader weighs 431,00 pounds empty, has a 38-ton bucket capacity, 1,463 horsepower, a 1,013-gallon fuel tank, and burns 1,800 gallons of diesel fuel in a 12-hour shift.

This is a CAT 994H. It burns 1800 gallons of fuel in a 12 hour shift. This machine is required to move 500,000 pounds of earth in order to get the minerals needed for ONE SINGLE Telsa car battery. In whose world does this type of math and green new deal make sense?



A Cat 797F mining truck with 400-ton capacity, has 4000 horsepower, with a loaded weight of 1,375,000 pounds, a 1,200-gallon fuel tank and gets 0.3 miles per gallon.

These huge earth moving vehicles are examples of how more greenhouse gasses and environmental pollution are created in manufacturing an EV than a gasoline powered vehicle. The energy equivalent of 100 barrels (4000 gallons) of oil is used in the processing of a single EV battery that can store the equivalent of one barrel (40 gallons) of oil.

Lithium battery technology offers many advantages over lead acid and AGM technology including high-capacity storage, delivery of consistently high power, longer cycle life, less weight, longer shelf life and rapid efficient charging. Lithium batteries are used to power EVs, electric bikes, solar panel energy storage and a lot of other electronic devices, such as: computers, cell phones, flashlights, and any portable electronic device that

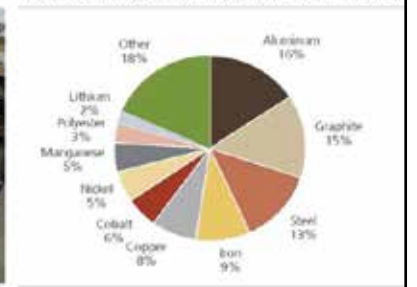
has a battery. All of this lithium and other rare earth metals needs to be mined and processed. Lithium is only one of the rare earth metals that are required to manufacture a battery for an EV.

The refined metal needed to fabricate a Lithium EV battery requires the mining, moving, and processing of more than 500,000 pounds of materials, most from overseas to fabricate a 1,000-pound Tesla EV battery. The breakdown of the commodities in battery pack by weight and percentage include: Aluminum 160 pounds 16%, Graphite 150 pounds 15%, Steel 130 pounds 13%, Iron 90 pounds 9%, Copper 80 pounds 8%, Cobalt 60 pounds 6%, Nickel 50 pounds 5%, Polyester 30 pounds 3%, Lithium 20 pounds 2%, and other material 180 pounds 18%. Notice that Lithium is only 2% of the battery weight. All these metals require

mining and have similar mining and environmental problems. The 30 pounds of polyester is produced from petroleum. It is unclear what comprises the “other 18%.”

The top producers of each rare earth mineral used in the EV batteries are all overseas. The US is only third in producing copper and not a major supplier of the other metals. China is in the top 5 producers of all the minerals and produces 89% of all the rare earth elements produced worldwide. The transportation costs vary depending on the location of the mines and processing plant, the transportation mode (e.g., truck, train, ship), the distance traveled, and the energy source used to power the transportation. The transportation energy

and pollution cost can be significant, especially for materials that are sourced from halfway around the world.

We have not counted other materials used when compared with a conventional car, such as replacing the steel frame with aluminum to offset the weight penalty of the battery or the supply chain for rare earth elements used in the electric motors, (e.g. neodymium, dysprosium). Also not included are the non-battery electrical systems such as the copper wire in the motors which use 300% more copper compared with a conventional automobile.

### Mining causes severe environmental problems

Lithium is present as a constituent of salts or other compounds. Commercial lithium comes from two major sources: underground salt brine deposits and mineral ore deposits. Lithium brine recovery mining involves drilling holes in salt flats and pumping out salty mineral rich brine that is pumped to the surface and distributed to evaporation ponds. The brine remains in the evaporation pond for a period of months or years until most of the liquid water content has been removed through solar evaporation. Once the brine has reached an ideal lithium concentrate, the brine is pumped to a lithium recovery facility for extraction where it undergoes multiple steps of chemical processing. Once the lithium extraction is complete, the remaining brine solution is returned to the underground reservoir, which can contaminate the water aquifer. Mining and processing 2,000 pounds of lithium (enough for only 100 batteries), consumes an astounding 500,000 gallons of water (weighing 4.15 million pounds), which can provide water for 3,500 people for one year!

Mineral ore deposits are often richer in content than brine solutions, however they are costly to access since they must be mined from hard rock formations. Over 500,000 pounds of dirt and overburden are removed for every battery produced. Due to the added energy consumption of the huge diesel-powered mining and earth moving equipment, chemicals, and materials involved in extracting lithium from mineral ore, the process can run twice the cost of brine recovery.

The recovery process involves removing the mineral material from the earth then heating and pulverizing it. The crushed material powder is combined with chemical reactants, such as sulfuric acid, then the slurry is heated, filtered, and concentrated through an evaporation process to form saleable lithium carbonate. The resulting wastewater is treated for reuse or disposal in evaporation ponds. The toxic chemicals and acids used in the separation process can leak

from the evaporation pools into local water supplies and also affect air quality.

Mining adversely affects the environment by causing loss of biodiversity, soil erosion, air pollution and contamination of surface water, groundwater and soil. The leakage of chemicals from mining

sites also has detrimental effects on the health of the population living at or around the mining site. It is very difficult to put an accurate number as to the overall impact and economic costs of environmental pollution.

The following four paragraphs are from an article from [www.worldatlas.com](http://www.worldatlas.com) titled 'What is the Environmental Impact of the Mining Industry?'

Air quality is adversely affected by mining operations. Unrefined materials are released when mineral deposits are exposed on the surface through mining. Wind erosion and nearby vehicular traffic causes materials to become airborne. Lead, arsenic cadmium and other toxic elements are often present. Diseases of the respiratory system and allergies can be triggered by the inhalation of such airborne particles.

Water pollution is caused by metal contamination, increased sediment levels in streams and acid mine drainage. Pollutants released from processing plants, tailing ponds, evaporation ponds, underground mines, waste-disposal areas, active or abandoned surface or haulage roads, act as the top sources of water pollution. Sediments released through soil erosion cause siltation or the smothering of stream beds. It adversely impacts irrigation, swim-

ming, fishing, domestic water supplies and other activities dependent on such water bodies. High concentrations of toxic chemicals in water bodies pose a survival threat to aquatic flora and fauna and terrestrial species dependent on them for food. The highly acidic water released from metal mines or salt brine evaporation ponds can have a pH of 2 (pure water has a neutral pH of 7) also drains into surface water or seeps below ground to acidify ground water. Securing just one ton of rare earth elements produces 2,000 tons of toxic waste. The loss of normal pH of the water can have disastrous effects on life sustained by such water.

Damage to the land is caused by the open pits and piles of waste rock that led to the physical destruction of the land at the mining site. Evaporation pools can cover hundreds of acres and often leak hazardous chemicals into the soil, groundwater, aquifers and streams. Such disruptions contribute to the deterioration of the area's flora and fauna. There is also a huge probability that many of the surface features of the land will not be restored after the process has ended. The removal of soil layers and deep underground digging can destabilize the ground which threatens the future of roads and buildings in the area.

The loss of biodiversity is one of the worst impacts of mining activities. The destruction or drastic modification of the pre-mined landscape can have a catastrophic impact on the biodiversity of that area. Mining leads to a massive habitat loss for the diversity of the plants and animals ranging from soil microorganisms to large mammals. Local native species are the most seriously impacted since the slightest disruption in their habitat can result in extinction. Toxins released through mining can wipe out entire populations of sensitive

species.

Lithium battery charging requirements – energy consumption, electric grid requirements Where is all the electricity going to come from to charge all the new EVs? There are already electric infrastructure problems plaguing multiple states at certain times of the year because the present electric grid capacity is inadequate. Brown outs, grid failures and mandates to not charge their EV at certain times of the day are becoming more frequent. How will the current generating capacity and the overloaded power distribution grid support the increased electrical load for EV use?

Only a few, small, new power generation plants are being planned. What fuel; coal, natural gas, or nuclear power will be used to create the electric power at these plants? There is a major new effort which will spend hundreds of billions of your tax dollars to improve the power distribution grid.

### EV battery operating mileage capacity

Range anxiety remains one of the biggest mental hurdles preventing car buyers from going electric. The driving range varies from model to model, the size of the battery bank, and the temperature environment in which it is being driven. EV manufacturers typically recommend charging only 80 to 90 percent to maintain battery health. So, an EPA estimate of 350 miles could translate to 280 miles of usable range.

There is a lot of disagreement about the battery longevity as to when it needs to be replaced. Different

studies/analysis/propaganda give ranges between 100,000 to 200,000 miles. When the battery no longer holds a charge to attain



the required driving range, the buyers are left with two choices. Buy a new battery for \$15,000 to \$20,000 (not including installation labor) or buy a new car.

Importantly, extreme temperatures, especially bitter cold, can hamper both a battery's performance and its ability to accept a charge. Using the heater or air conditioning also draws battery power at a greater than average clip. A study conducted by the AAA found that when the ambient temperature dips to or below 20°F and the vehicle's heater is in use, the average electric car's operating range drops by 41 percent. When the mercury hits 95°F and air conditioning is in use, an owner can expect the range to fall by an average of 17 percent.

### EV charging efficiency

The people who are touting the efficiency of EVs are looking only at the energy consumed while driving. They are totally ignoring the energy inefficiencies and generator losses required to generate power and transmit it through the power grid. That process, depending on the fuel used for the generation, is about 60% efficient plus powerline

transmission losses of 35% (65% efficient) for  $0.60 \times 0.65 = 39\%$  total efficiency for electricity provided to the charger. The EV Lithium-ion batteries only recover 76% of the energy put into it, the EV motor is about 90% efficient, and the charger is only 90% efficient. These efficiencies are multiplied to get the overall systemic efficiency of the EV system of  $0.39 \times 0.76 \times 0.90 \times .90 =$  approximately 24% (76% loss) overall thermodynamic efficiency. Yet again, we are reminded there are no free lunches in energy transfer.

### EV Charging stations

EV chargers are classified into three categories: Level 1, Level 2 and Direct Current (DC) fast chargers.

**Level 1** charger is for residential use, uses a 110-volt charging unit that plugs into standard three prong electric outlet. The cost of the charger is between \$600 to \$800. It is the smallest, least expensive, slowest charger and estimated to deliver 3.5 to 6.5 miles of range per hour of charging. It can take between 8 to 24 hours to obtain a full charge for the EV battery.

**Level 2** chargers require 220 or 240 volt service. The average cost of the charger is about \$3,000 plus about \$500 for an electrician to install. An Electric Service Equipment (EVSE) for plug-in or hard-wired varieties between \$300 and \$1,200 is required. The total cost is between \$3,800 and \$4,700. Level 2 chargers are available with a variety of power outputs from 3 kW to 19 kW.

\* A 24-amp 240v charger at 6 kW power output would provide 200 miles of charge in 11 hours for  $6 \text{ kw} \times 11 \text{ hours} = 66 \text{ kWh}$ .

\* A 48-amp 240v charger at 12 kW power output would provide 200 miles of charge in 5.5 hours, also at 66 kWh, so for 66 kwh 200

miles = 0.33 kWh per mile.

\* At California's \$0.30/ kWh electric rate the cost for either scenario would be  $0.33 \text{ kwh/mile} \times \$0.30 / \text{kWh} = \$0.10$  per mile.

Driving 10,000 miles per year on average would cost \$1,000 and consume  $0.33 \text{ kWh/mile} \times 10,000 \text{ miles} = 3,300 \text{ kWh}$  per year of electrical grid load per EV vehicle. However, because of the 24% efficiency of the delivered electricity (76% efficiency losses) in the electricity generation, transmission lines, charging the battery and the losses in the charger, the total electricity that needs to be generated by the power plant to get 3,300 kWh in the battery by the charger is actually  $3300 \text{ kWh} \div 0.24\% \text{ efficiency} = 13,750 \text{ kWh!}$

**Level 3** are Direct Current (DC) fast chargers. They can produce a 10 to 80% charge for a 300-mile range battery in approximately 30 minutes. New chargers are capable of up to 1000 volt and 500 amps (up to 360 kW). A CALeVIP Cost Data analysis found that the unit cost per charging station ranged from a minimum of \$18,000 to a maximum of \$72,500. The average unit cost per charger was \$29,135.

In addition to higher equipment costs, DC fast charger installations require a commercial electrician from the initial planning phase due to the electrical load and wiring requirements. Most of the commercial EV charging stations are DC Fast Chargers. The picture is of a Tesla Fast Charging station just off I-10 in Quartzsite Arizona, next to several fast-food outlets. There

are 36 charging stations in this location. If all the chargers were in use at one time, would that cause a brownout or electric grid failure in this small town?

### EV U.S. Market Forecast

Deloitte Consulting EV forecast is for a compound U.S. annual EV growth rate of 29% achieved over the next ten years:

\* The total number of EV cars on the road in 2020 in the U.S. was 1.5 million.

\* In 2022, the EV cars on the road are 3.0 million.

\* It is estimated that in 2025 there will be sales of 7.6 million EVs, then reaching 25.2 million annual EV sales by 2030.

\* In 2050 the forecast annual sales number is 62 million EVs sold with 300 million EVs on U.S roads.

### EV vehicle U.S. Electrical grid impact

As of February 2022, America generates more than 4,116 billion kWh (4.12 trillion kWh) of electricity from utility-scale generation capacity. EIA estimates that an additional 49.03 billion kWh (or about 0.05 trillion kWh) were generated with small-scale solar photovoltaic (PV) systems for a total U.S. power generation of 4.17 trillion kWh.

In 2021, about 61% of U.S. utility-scale electricity generation was produced from fossil fuels (coal 22%, natural gas 38%, petroleum 0.5%), and 19% was from nuclear energy. About 20% was from renewable energy sources which consisted of wind 9.2%, hydro 6.3%, solar 2.8%, biomass 1.3% (burning timber), and geothermal 0.4%.

However, because of the 76% efficiency losses in the electricity generation, transmission lines, and the losses in the charger, the total electricity that needs to be generated by the power plants to get 3,300 kWh in the battery by the charger is actually 13,750 kWh!

\* In 2022 with the 3.0 million EV cars on the road, with each vehicle using approximately 13,750 kWh per year of electricity to drive an

average of 10,000 miles per year means that 3,000,000 EVs x 13,750 kWh = 41,250,000,000 kWh or 41.250 billion kWh, which is 0.1% of the generated power.

\* In 2025, there will be an estimated 7.6 million EVs on the road, each one using 13,750 kWh = 104.5 billion kWh which is 2.5% of the generated power at the power plants.

\* In 2030 there will be an estimated 25.2 million EV vehicles on the road each using 13,750 kWh = 346.5 billion kWh which is 8.4% of the generated power at the power plants.

\* If California's 2035 target were adopted and implemented nationally, in 2050, the forecast is U.S. sales of 62 million EV vehicles with 300 million electric vehicles on the road. The total kWh electric load for EVs is 300 million vehicles x 13,750 kWh = 4.125 trillion kWh. The percentage of the generation capacity is 4.125 trillion kWh 4.17 trillion kwh of generation capacity = 98% of the current total electric generating capacity of the U.S.

This is only the power to operate the EVs and does not include the energy required for the embodied energy, excavating / mining / drilling, industrial processing, refining, transporting, manufacturing, and recycling. It is ONLY the electricity generation requirements for recharging the batteries.

There are currently several small new natural gas fired electric generating plants totaling 32.3 million kWh capacity that are supposed to be online producing energy by 2025. The Biden administration is relying on renewable energy from wind and solar to increase the generating capacity. Renewable energy sources which consisted of wind 9.2%, and solar 2.8%, only provided a total

of 12% of our electricity needs in 2020. The Biden administration just announced spending \$13 billion of taxpayer money to "modernize and expand America's Power Grid".

Renewable energy sources will not solve our energy problem. Their power generation varies greatly based on the available wind and solar and cannot be depended on for constant use as "base" load. The power grid in the US is already overloaded and brownouts are occurring throughout the country. The increased power demand of millions of new EVs will dramatically increase the stress on the power grid causing more brownouts and power failures. Where is all the additional electricity going to come from?

### Do we have enough mineral resources to support the EV growth forecasts?

In the opening paragraphs, the quantities of the 10 metals required for each battery were listed. Many of them are called "rare earth" for a reason. The quantities are in low concentrations and spread around the world, are difficult and expensive

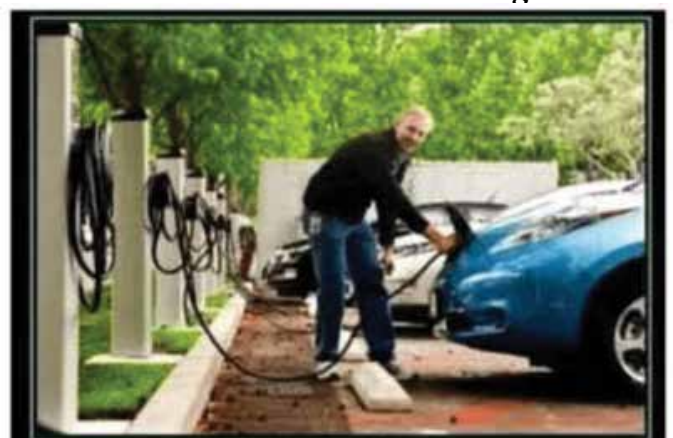
to mine, and cause severe and extensive environmental damage. The forecasts for the sales of EVs are predicting the demand for EVs will go up 11.9% by 2030, which is only seven years from now. Developing new sources and mines requires 5 to 7 years before they are productive. The forecasted growth of EVs does not consider the availability of the materials to build the entire vehicles as well as the battery packs. The forecasted growth of 53% by 2030 is in jeopardy due to the mineral availability as well as whether the electrical grid system can supply the energy for manufacturing and charging the vehicles reliably.

An electric car requires six times the mineral inputs of a conventional car, and a wind plant requires nine times more minerals than a gas-fired power plant. With current estimates, demand for Rare Earth Elements could increase six-fold by 2040. Lithium and cobalt demand could increase ten to twenty times by 2050 because of electric cars. Demand for dysprosium and neodymium is estimated to increase seven to twenty-six times over the next 25 years as a result of electric vehicles and wind turbines. It is not certain there are sufficient reserves of rare earth elements to supply the future demand.

### Recycling requirements

One of the big unknowns is when EV batteries will have to be replaced. Currently, only 2% of the

batteries are recycled. The batteries have a lifetime of about 10 years or 100,000 miles. Millions of used batteries will soon be scrapped that will need to be recycled. While the EV industry says battery technology is improving so that degradation is limited, if that assurance proves overly optimistic and auto warranties must replace expensive battery packs, the new battery will create a second carbon footprint that the EV would have to work off over time, partially erasing the promised greenhouse-gas benefits.

Recycling these batteries is still a complex, costly process. The collection and transportation of spent batteries make up nearly half of the cost of recycling - which is an obstacle UC Davis professor Alissa Kendall, who sat on California's advisory council on EV battery recycling, expects to become more challenging around 2025, when millions of EV batteries will start to reach the end of their lifespan.

Right now, the last stop in the US for many of the lithium batteries that power electric and plug-in hybrid vehicles is a plant near Phoenix, Arizona. There, the Toronto-based company Li-Cycle breaks the batteries down into "black mass" - a dark, shredded mess of copper, cobalt, nickel, and lithium that without further chemical separation processing is as useful as shiny dirt. That is, until most of it is shipped to overseas factories in other countries to separate it into the valuable raw materials that both auto and electronics manufacturers need to build new batteries. The recycling process itself is highly toxic and all of the waste from the process is hazardous. Often the toxic waste slurry is pumped into deep wells which can impact the water aquifer or is left in evaporation ponds.

Recycling is often an overlooked but critical piece of the total life cycle cost. The challenge is that each vehicle needs its own battery, complete with copper, cobalt,



nickel, manganese, graphite, and lithium. And because supplies of these materials are limited, it's not at all clear how auto manufacturers will get their hands on enough for their EV batteries.

Part of the answer will depend on how countries handle their old EV batteries. By the end of this decade, close to 25 million electric vehicles are expected to be on the road domestically. After 2030, the Biden administration aims for half of all new car sales to be electric.

### Summary / Conclusion

The entire EV push is driven by ideology rather than practicality so on a "Total Life Cycle Cost," the internal combustion engine is much less expensive. In 2021 a New York Times article titled "Electric cars and renewables may not be as green as they appear" noted "Production of raw materials like lithium, cobalt and nickel that are essential to these technologies are often ruinous to land, water, wildlife and people." The materials needed for the EV batteries are limited and are insufficient to build the number of batteries forecast. The Times also warned that with global demand for electric vehicles projected to grow eightfold by 2030, "the dirty origins of this otherwise promising green industry have become a looming crisis".

But public demand is lagging, and until it changes, governments will

have to incentivize consumers to buy electric cars. Currently, EVs appeal to a narrow demographic: affluent, educated, coastal, and liberal, with the highest enthusiasm among 35- to 45-year-olds, according to research by James Archsmith, who researches energy and environmental economics at the University of Maryland. His data concludes that under some scenarios, achieving a 50% market share for EVs in 2030 would require cash payments in excess of \$30,000 per electric car, totaling in the trillions of dollars, paid for by U.S. taxpayers. The lower priced EVs sell for \$55,000, mid-priced from \$80,000 and higher priced EVs are \$100,000 to \$180,000.

When the total impact of EVs, starting with the environmental hazards and damage to the environment by mining the materials, through the impact on the environment due to the high demand put on the electrical infrastructure, to the hazardous waste generated by

recycling the batteries, the damage to the environment is clear. The conclusion is that "Zero Emission" vehicles are anything but "green" and horrible for the environment worldwide.

Over the past fifty years of my engineering life, I have been very involved in renewable resources and the environment. This includes developing computer control systems for wind turbine generators and founding companies that installed solar thermal panels and photovoltaic (PV electric) panels for residences and commercial buildings. I have patents on a solar thermal panel that uses linear parabolic mirrors to track the sun and have patents on a water purification system that removes virtually all contaminants. As a result, I have a deep understanding of the issues presented in this article. My experiences and research studying this for the past 30+ years, tell me that the present push for electric vehicles, providing the energy through renewable energy sources and having enough mined materials is an unattainable objective and an idiotic fantasy.



## Meet the Couple Revolutionizing Education in America

Highlights from the Highwire interview of Leila and David Centner

“I’m not born in this world right now to be neutral. I am here to make a stand for what I truly believe is the right path for our kids.” (All of the quotes in this article are from Leila Centner)

The Centner Academy isn’t just taking the “standard” approach to education and doing it in a loving and safe environment. They are literally revolutionizing education. Test results show that the students thrive in this environment.

One of the reasons Leila started the academy was because of all of the craziness going on in the public schools. Many schools are encouraging Kindergarteners to “choose their gender”. They teach the children that their parents don’t know what they are talking about and to not listen to them. They are teaching our children about Critical Race Theory and to hate themselves based on the color of their skin.

**“Don’t get angry about what is happening in the world. Do something. Build your own system; build your own community. We are building our community; we are building our tribe.”**

The school is all about a holistic way of life. Their cafeteria lunch menus are gluten free, organic, non-processed foods. They are teaching the kids proper nutrition, as well. Unfortunately, schools all over the country feed the children processed foods and foods that are filled with pesticides. “You can’t focus if your body is being filled with contaminants.” The students have classes where the children learn about nutrition and healthy choices.

When the food shortages started



to happen, Leila realized that they needed to build a sustainable community. They bought a 40-acre lot and started growing 100% organic foods, using no pesticides or chemicals. The farm provides a lot of the food used in the school lunches.

The students take field trips to the farm and learn about food production. They get to participate in some farm activities such as harvesting carrots or transplanting young pineapples. The farm has a traveling chicken coop that has 200 chickens, and they provide 750 eggs each week to the school cafeteria. Every two months they move the chicken coop so the chickens have new areas to graze the weeds, grasses and bugs.

Centner Academy’s Be Happy Marketplace is another innovative idea. This is an outgrowth of the school’s entrepreneur initiative. Third graders learn how to start and run a business. They learn to do business projections, PowerPoint presentations and they raise money in a Shark Tank type of environment for funding their ventures. Then they sell their wares at an outdoor marketplace that is set up on the property. This program gives the kids the opportunity to apply their math and other skills in a real-world situation. When you have a business, you are forced to

critically think. You are forced to problem solve and think outside of the box. These are valuable skills they are giving the kids. How many 12-year-olds understand ROI (Return on Investment), revenue and gross profits? These kids are being empowered. These kids are learning how to navigate the world when they become adults. They are not just learning these concepts from a book or from a classroom lecture, they are applying them to a real-life situation. They can be anything they want to be, and Centner Academy is starting these skills at a very young age. It is fun and the kids love it. They are empowering these kids with knowledge.

**“We believe at Centner Academy that when a child is happy and stress free, the sky’s the limit, so it is a lot easier for them to achieve academic excellence in a calm and peaceful state.”**

The Academy teaches stress and anger management. The students learn what type of thoughts and breathing techniques they need to do to bring stress down. Leila learned these skills when she was 41 and she thought to herself, “how more powerful would I have been as a leader if I learned this as a child? How to pull tools out of my own pocket and say, ‘Okay, I’m very anxious right now, I’m going to take myself to a calm and peaceful place and I’m going to breathe through this.’” They teach the

kids that happiness is attainable right now and it is their choice.

“We want our kids when they graduate from high school to be ready, prepared, critical thinkers. Kids who aren’t going to be sheep. We want them to be our future lions and be able to look at things that aren’t right and say, ‘Wait a minute, that’s not right. I know that I am here to question everything and not just do as I am told.’” We tell our kids to question everything. They are already taking classes on public speaking. “We are training the next generation of leaders.”

“Parents need to do what their kids need to be successful, happy, future adults. We want our kids to be emotional ninjas. We don’t want them to be what this generation is right now, which is, ‘He called me a name so I’m going to go in a corner and cry.’ This is not how we build a strong country. With people who are so fragile, that they break with the smallest word they are called. We need strong people to sustain a strong country.”

Leila’s recommendation to parents: “Form a pod with other parents, even if it’s only 5 other parents. You want to protect your child’s soul. They are living once in this world. They are fragile, delicate and they are very easily influenced. If you have a five-year-old in kindergarten and a drag-queen is reading to your five-year old, which unfortunately is happening in schools all across the country, that child is going to think that is real life and that child is going to question their own gender and that is not what you want your five-year-old doing. You want your five-year-old learning how to read, learning ABC’s. I tell parents, ‘I know it is difficult, I know it is not easy but do anything and everything you can to look for and explore options.’”

## In Moscow, Xi and Putin bury Pax Americana

What has just taken place in Moscow is nothing less than a new Yalta, which, incidentally, is in Crimea. But unlike the momentous meeting of US President Franklin Roosevelt, Soviet Leader Joseph Stalin, and British Prime Minister Winston Churchill in USSR-run Crimea in 1945, this is the first time in arguably five centuries that no political leader from the west is setting the global agenda.

It's Chinese President Xi Jinping and Russian President Vladimir Putin that are now running the multilateral, multipolar show. Western exceptionalists may deploy their crybaby routines as much as they want: nothing will change the spectacular optics, and the underlying substance of this developing world order, especially for the Global South.

What Xi and Putin are setting out to do was explained in detail before their summit, in two Op-Eds penned by the presidents themselves. Like a highly-synchronized Russian ballet, Putin's vision was laid out in the People's Daily in China, focusing on a "future-bound partnership," while Xi's was published in the Russian Gazette and the RIA Novosti website, focusing on a new chapter in cooperation and common development.

Right from the start of the summit, the speeches by both Xi and Putin drove the NATO crowd into a hysterical frenzy of anger and envy: Russian Foreign Ministry Spokeswoman Maria Zakharova perfectly captured the mood when she remarked that the west was "foaming at the mouth."

The front page of the Russian Gazette on Monday was iconic: Putin touring Nazi-free Mariupol, chatting with residents, side by side with Xi's Op-Ed. That was, in a nutshell, Moscow's terse response to Washington's MQ-9 Reaper stunt and the International Criminal Court (ICC) kangaroo court shenanigans. "Foam at the mouth" as much as you like; NATO is in the process of being thoroughly humiliated in Ukraine. During their first "informal" meeting, Xi and Putin talked for no less than four and a half hours. At the end, Putin personally escorted Xi to his limo. This conversation was the real deal: mapping

out the lineaments of multipolarity – which starts with a solution for Ukraine.

Predictably, there were very few leaks from the sherpas, but there was quite a significant one on their "in-depth exchange" on Ukraine. Putin politely stressed he respects China's position – expressed in Beijing's 12-point conflict resolution plan, which has been completely rejected by Washington. But the Russian position remains ironclad: demilitari-



zation, Ukrainian neutrality, and enshrining the new facts on the ground. In parallel, the Russian Foreign Ministry completely ruled out a role for the US, UK, France, and Germany in future Ukraine negotiations: they are not considered neutral mediators.

### A multipolar patchwork quilt

The next day was all about business: everything from energy and "military-technical" cooperation to improving the efficacy of trade and economic corridors running through Eurasia.

Russia already ranks first as a natural gas supplier to China – surpassing Turkmenistan and Qatar – most of it via the 3,000 km Power of Siberia pipeline that runs from Siberia to China's northeastern Heilongjiang province, launched in December 2019. Negotiations on the Power of Siberia II pipeline via Mongolia are advancing fast.

Sino-Russian cooperation in high-tech will go through the roof: 79 projects at over \$165 billion. Everything from liquified natural gas (LNG) to aircraft construction, machine tool construction, space research, agro-industry, and upgraded economic corridors.

The Chinese president explicitly said he wants to link the New Silk Road projects to the Eurasia Economic Union (EAEU). This BRI-EAEU interpolation is a natural evolution. China has already signed an economic cooperation deal with the EAEU. Russian macroeconomic uber-strategist Sergey Glazyev's ideas are finally bearing fruit.

And last but not least, there will be a new drive towards mutual settlements in national currencies – and between

Asia and Africa, and Latin America. For all practical purposes, Putin endorsed the role of the Chinese yuan as the new trade currency of choice while the complex discussions on a new reserve currency backed by gold and/or commodities proceed.

This joint economic/business offensive ties in with the concerted Russia-China diplomatic offensive to remake vast swathes of West Asia and Africa. Chinese diplomacy works like the matryoshka (Russian stacking dolls) in terms of delivering subtle messages. It's far from coincidental that Xi's trip to Moscow exactly coincides with the 20th anniversary of American 'Shock and Awe' and the illegal invasion, occupation, and destruction of Iraq.

In parallel, over 40 delegations from Africa arrived in Moscow a day before Xi to take part in a "Russia-Africa in the Multipolar World" parliamentary conference – a run-up to the second Russia-Africa summit next July. The area surrounding the Duma looked just like the old Non-Aligned Movement (NAM) days when most of Africa kept very close anti-imperialist relations with the USSR.

Putin chose this exact moment to write off more than \$20B in African debt.

In West Asia, Russia-China are acting totally in sync. The Saudi-Iran rapprochement was actually jump-started by Russia in Baghdad and Oman: it was these negotiations that led to the signing of the deal in Beijing. Moscow is also coordinating the Syria-Turkey rapprochement discussions. Russian diplomacy with Iran – now under strategic partnership status – is kept on a separate track.

Diplomatic sources confirm that Chinese intelligence, via its own investigations, is now fully assured of Putin's vast popularity across Russia, and even within the country's political elites. That means conspiracies of the regime-change variety are out of the question. This was fundamental for Xi and the Zhongnanhai's (China's central HQ for party and state officials) decision to "bet" on Putin as a trusted partner in the coming years, considering he may run and win the next presidential elections. China is always about continuity.

So the Xi-Putin summit definitively sealed China-Russia as comprehensive strategic partners for the long haul, committed to developing serious geopolitical and geoeconomic competition with declining western hegemon. This is the new world born in Moscow this week. Putin previously defined it as a new anti-colonial policy. It's now laid out as a multipolar patchwork quilt. There's no turning back on the demolition of the remnants of Pax Americana.

### 'Changes that haven't happened in 100 years'

In Before European Hegemony: The World System A.D. 1250-1350, Janet Abu-Lughod built a carefully constructed narrative showing the prevailing multipolar order when the West "lagged behind the 'Orient.'" Later, the West only "pulled ahead because the 'Orient' was temporarily in disarray."

We may be witnessing a similarly historic shift in the making, trespassed by a revival of Confucianism (respect for authority, emphasis on social harmony), the equilibrium inherent to the Tao, and the spiritual power of Eastern Orthodoxy. This is, indeed, a civilizational fight.

Mr. Barrett was so intrigued that he contacted the CSPOA and was turned over to Steve Tuminello Media Relations for the CSPOA.

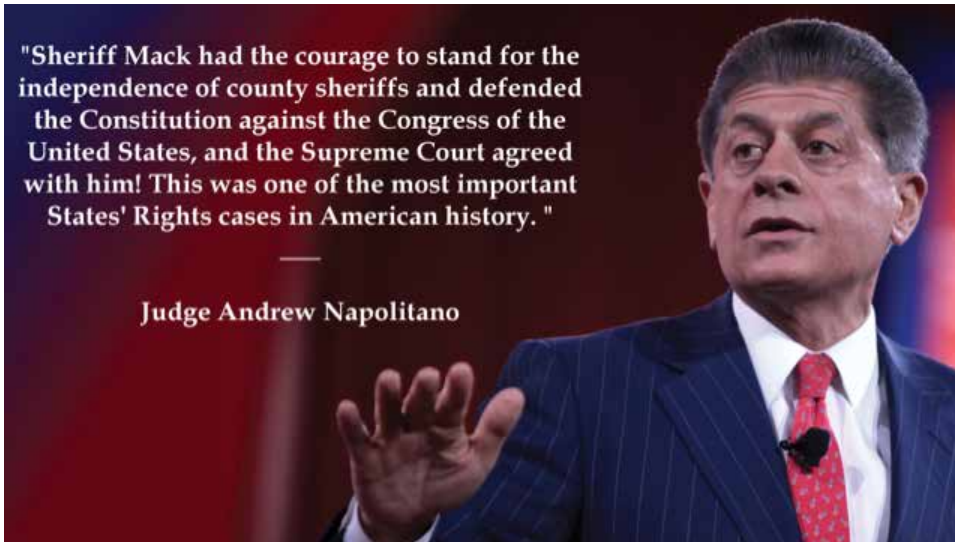

## Why Most of the World Isn't on Board with the NATO-Russia War

As the war in Ukraine drags on into its second year, protest demonstrations have been taking place in major European cities. They express the growing sentiment that the people are tired of the protracted conflict and fearful of what could come should the war continue even longer. Memories of the catastrophic world wars that ravaged Europe in the first half of the last century and the terrible threat of nuclear annihilation that divided the continent in the second half of the century form the traumatic foundation from which Europeans are voicing their aversion to this conflict, which has the potential to spiral out of control and bring a major war to Europe and the world again.

### Broad Opposition to War

There have been protest demonstrations occurring in Germany, France, the Czech Republic, Greece, Spain, Great Britain, Belgium, Austria, Italy, Albania, Moldova, and others. European protests surrounding the anniversary of the start of the conflict notably span the Left-Right spectrum in opposing US-led North Atlantic Treaty Organization (NATO) imperialism as well as the economic hardships that have befallen ordinary Europeans against the backdrop of sanctions on Russia and the funding of Ukraine.

Italian port workers aligned with the Left protested in Genoa specifically to resist the use of Italian ports to supply arms deliveries to Ukraine. Meanwhile in France, demonstrations organized by the right-wing Les Patriotes party in various locations across the country called for France's withdrawal from both NATO and the European Union.

In all cases, the people on the streets at these events identify involvement in the war as harmful to general economic well-being and have been expressing frustration with their countries' acquiescence to these intergovernmental and supranational organizations in fueling the violence while simultaneously discouraging dialogue. Feelings of skepticism toward NATO, the European Union, and the United States have become increasingly vocal in Europe due to the way that western countries are handling the war. In the minds of many Europeans, their governments are recklessly following the will of Washington, which could lead them into a serious escalation to a wider war.

### German Memory

Germany suffered tremendously during the two World Wars and continued to endure the pressures of division and foreign occupation during the Cold War. A century of pain and turmoil brought about by militarism and intervention still informs the collective consciousness of the country. As part of the anniversary protests, thousands of people gathered around the iconic Brandenburg Gate in Berlin for an event called the "Uprising for Peace," organized by prominent Left party member Sahra Wagenknecht and the feminist journalist Alice Schwarzer. The rally was a show of support for

a "manifesto for peace," which had already received well over half a million signatures by the time of the rally. It calls for the end of military exports to Ukraine and for negotiations between Kyiv and Moscow.

Demonstrations have also taken place in Nuremberg (in response to the German government's plan to send tanks to Ukraine), in Munich (during the Munich Security Conference), and outside of the prominent US air base in Ramstein where important matters regarding the Ukraine conflict are discussed among Western leaders.



At the rally in Nuremberg, one demonstrator recalled the historical record, explaining that if Germany gets involved in another war with Russia, then "based on history, it is the worst sign that we can send." He emphasized that "no war must go through Germany, neither with arms deliveries nor

anything else, because otherwise, Germany will be in the middle of it again."

The last time war broke out in Europe between the two countries, it was one of the most catastrophic events in human history. This view echoes the glimmer of hope from just a few months before the start of Russia's invasion that the completion of the Nord Stream 2 pipeline could have strengthened ties and prevented conflict in Europe, especially with regard to Russia and Germany. Of course, the mysterious destruction of Nord Stream a year later and the report by Seymour Hersh identifying US and allied hands in the sabotage mission completely turned that hope on its head. Those who strive for peace and an end to the bloodshed are understandably disheartened, yet they are motivated to vocally speak out to European leaders



to push for peace.

Across the Atlantic and Beyond These gatherings have run parallel to the Rage Against the War Machine rally in Washington, DC, where Americans protested against the US's funding and arming of Ukraine as well as the diplomatic negligence in preventing the negotiation of an end to the fighting. Those speaking and demonstrating against US involvement in Ukraine have parallel grievances toward their government and echo those in Europe.

Voices spanning the political spectrum from socialists to libertarians have found common ground in opposing the many rounds of weapons packages and financial aid to Ukraine, as well as the lack of diplomatic responsibility on the part of Secretary of State Antony Blinken in communicating with his counterpart, Russian foreign minister Sergey Lavrov. Since the rally, President Joe Biden has included \$6 billion in Ukraine and NATO funding as part of his \$842 billion defense-budget request for 2024. Meanwhile, Blinken met briefly with Lavrov on the sidelines of a G20 meeting in New Delhi with no tangible progress on the subject of ending hostilities in Ukraine. While hopes from the American side remain dim, perhaps the protests in Europe may influence decisions at the levels of leadership in their respective countries.

The West's commitment to Ukraine has also struck opposition from other regions. At this year's Munich Security Conference, leaders from non-Western countries expressed the necessity of finding peaceful solutions. Brazil's foreign minister Mauro Viera called upon the world to "build the possibility of a solution," while Colombia's vice president Francia Marquez said, "We don't want to go on discussing

recorded on a secure write-once, read-many media with clear chain of custody and posted on the Secretary of State's website free of charge to the public within twenty-four hours after the close of the polls; and 4. The legislature transmits this resolution to the secretary of state." [Read full resolution AzLeg.org.]

The House Bill Summary states, "the Secretary of State is charged with appointing a committee to investigate and test the various types of vote tabulating machines. The

committee submits its recommendations to the Secretary of State who will then decide the make or model to be certified for use in the state."

Following its passage in the Elections Committee, Senator Wendy Rogers tweeted, SCR 1037 is AZ legislature resolved to reclaim its plenary power to oversee FEDERAL elections per the US Constitution, irrespective of the governor.

Katie Hobbs cannot veto this legislation as she has done with an overwhelming majority of the bills sent to her desk.

## SB 1291 hopes to add more protections for those placed in conservatorships

A bill moving through the Arizona legislature hopes to add more protections for people in the probate court system who find themselves placed into guardianships or conservatorships.

State Senator John Kavanagh introduced Senate Bill 1291, which would add several changes to the law including making sure that those who are placed under the care of another know all their rights [defend themselves, trial by jury, choose a lawyer & conservator, etc. Judges and lawyers held accountable for informing the person of their rights.]

A conservatorship is appointed through a court system where a

person will be in control of another's financial, healthcare, and personal decisions. However, at the hearing, several families spoke about what they call "outrageous overreach" by those who end up in control of another. Sherry Lund spoke with ABC15 about how her family was victims of the probate court system. "They wanted us out of his life," she said, referring to her son. Lund's son is the grandson of Walt Disney, and in his forties, he was almost placed into conservatorship. Her family spent nearly \$10 million fighting that from happening. "How people can be so heartless to separate families and do the things they do for the sake of money, it's the root of all evil, it truly is," said Lund. Another key part of the bill would

make sure those in the system see their loved ones. "It lets people see their relatives. In most situations the person who is in charge of them, or the conservator, will let them, but sometimes they will say no for sometimes good reasons, but sometimes for bad reasons," said State Senator Kavanagh.

Yvette Banker spoke against the bill as it is written at a House hearing on Wednesday, saying there are protections already in place. "As a court-appointed attorney, I provide a letter to my clients, in that letter it indicates what your rights are, that is sent within 48 hours of being appointed as a court-appointed attorney," she said to lawmakers. "It says you have a right to a jury trial, it says you have a right

to object to who is serving." The bill has passed a committee in the House, and will now have to go before the House for a vote.

Kavanagh said that there could be more changes added when it goes back to the Senate.

One speaker [Anna Camacho] at the hearing told lawmakers that a conservatorship cut off all communication with a friend of hers. She left lawmakers with a warning. "I beg you to please pay attention, it could happen to any one of your family members." Have you been impacted by a conservatorship? Email Nicole Grigg at nicole.grigg@abc15.com.

of a CBDC. Florida's governor Ron DeSantis is calling on other state governors to do the same and fight back against CBDC nationwide.

who will be the winner or the loser of a war. We are all losers, and, in the end, it is humankind that loses everything."

Namibia's prime minister Saara Kuu-gongelwa-Amadhila stressed the waste of money and resources in the name of hostility which "could be better utilized to promote development in Ukraine, in Africa, in Asia, in other places, in



Europe itself, where many people are experiencing hardships." China went so far as to outline a political settlement to the Ukraine crisis on the anniversary of the invasion.

These statements and efforts show their acknowledgment of the much poorer state of affairs the world finds itself in as the war drags on. The Russian war in Ukraine must come to an end one day, and more people around the world are demanding a solution now.

Moscow, finally welcoming the first sunny days of Spring, provided this week a larger-than-life illustration of "weeks where decades happen" compared to "decades where nothing happens."

## Radical Muslim 'Operation Warp Speed' Architect Hanged at GITMO

"Allahu Akbar," convicted felon Moncef Slaoui shouted Monday morning as he stood atop the gallows at Guantanamo Bay and leered menacingly at the man he held responsible for ordering his imminent death.

Below him, Vice Adm. Darse E. Crandall and a few high-ranking officers watched in silence while the hangman standing beside Slaoui slipped a braided rope around his neck. Slaoui struggled but was no match for the towering soldier who effortlessly pinned Slaoui's wrists to his back, then bound them with a zip tie. Slaoui spat in the soldier's face.

"Bag the prisoner," Adm. Crandall ordered, and the soldier put a black hood over Slaoui's head. "How's that appeal coming along?" Adm. Crandall bellowed.

At the end of Slaoui's tribunal last Thursday, his lawyer, Omar Akbar, promised to appeal the verdict to an unspecified authority. He caught the first flight leaving GITMO Thursday afternoon and hadn't been heard from since; Slaoui's calls to Akbar's office in D.C. went unanswered.

"It once amazed me, Mr. Slaoui, how little regard you people have for human life. Like others who stood where you are now, you were consumed by greed, which has led to this ineluctable fate. "I didn't put



you on gallows; you put yourself there," Adm. Crandall said, and motioned at the soldier to push the

button.

But the hinged door beneath Slaoui's feet did not swing open.

"It's broken, sir," the soldier said.

"Allah speaks," Slaoui muttered from underneath his hood. "He's not ready to receive me yet."

Adm. Crandall said, "He'll be ready as soon as I can get an electrician here, so don't get your hopes up."

While they awaited the arrival of a U.S. Army Corps of Engineers electrician, Slaoui hurled Arabic curses at the admiral, calling him an impious infidel, a blasphemer, and an enemy of Allah. He said Allah and His Messenger would avenge him.

The electrician arrived 30 minutes later and tested the box, pushing the green and red buttons after the soldier had moved Slaoui aside.

He removed the cover and began fiddling with the wires, commenting that his visit marked the second time in two years a connection had come loose. He fixed it in five minutes, then tested the circuit, pressing the green button to open the door and the red one to close it. "All done, Admiral," he said, and left the platform. The soldier positioned Slaoui, who hadn't shut his mouth, over the door.

Admiral Crandall had fitting final words for the Operation Warp Speed architect. "May you reach your next destination at warp 9."

"Allah is gre—" Slaoui began, but his neck snapped before he had a chance to finish his sentence.

A U.S. Navy physician pronounced Slaoui dead at 10:47 a.m. EST.

## If chemical spill gets into water supply, we won't be able to boil our way out of it, says Rutgers-Camden chemist

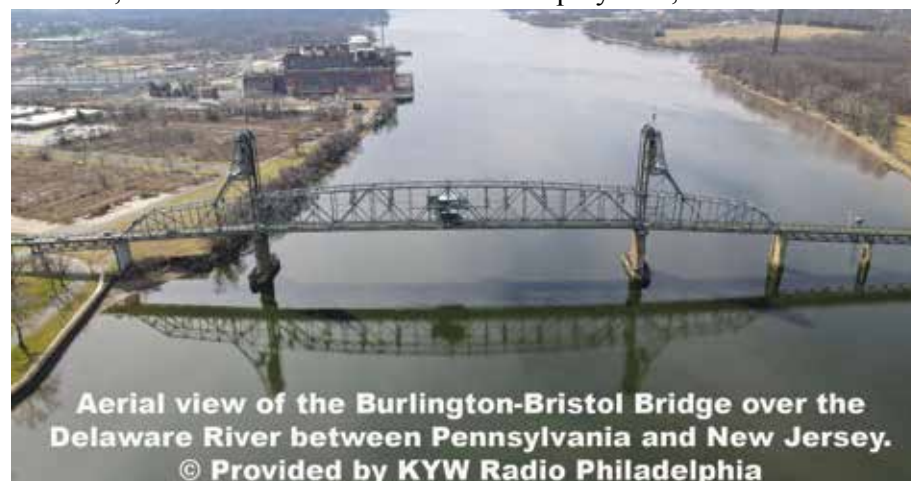

SOUTH JERSEY (KYW Newsradio) — More than 8,000 gallons of chemicals used to make latex paint spilled into the Delaware River on Friday, including butyl acrylate and ethyl acrylate. A chemist from Rutgers-Camden explains the risk this presents.

Chemistry professor David Salas-De la Cruz says they are synthetic polymers, soluble in water, that are fatal if ingested in large quantities. And boiling water contaminated with those chemicals will not make it safe to drink — for the same reason boiling paint doesn't make it any

safer to drink. It won't remove the chemicals. It will just evaporate the water and leave the chemicals.

"When you leave paint outside, the water evaporates, you still have paint in the bin," Salas-De la Cruz said.

"Would you drink paint? Absolutely not. It's very dangerous."

He says at-home filtration products, like a Brita filter or a refrigerator filter, aren't designed to filter out these polymers, but a seasoned filter

would be more effective than a brand-new one, because there's more material to catch the contamination. "That butyl acrylate actually will attach to those particles and drop and then you can filter through membranes or a sand membrane to remove it." He says sand-based filtration systems will remove most of the contaminants.

So far, officials from New Jersey's Department of Environmental Protection and American Water say this spill isn't affecting the water supply. There are no current advisories in New Jersey for this spill. Officials will continue to test and monitor. In the meantime, they ask residents to conserve as much as possible.

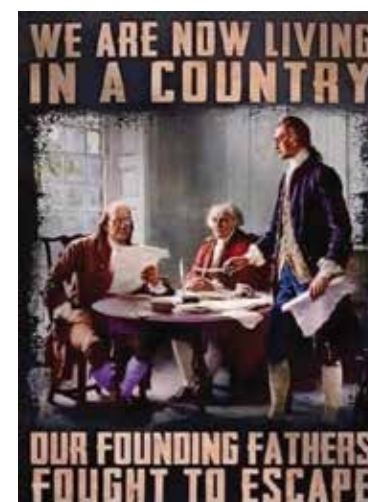
downs, forced vaccine mandates, forced quarantines, and mandatory vaccine passports in Western countries immediately.

## Turley, Dershowitz: Trump Indictment Political, Prosecutorial Abuse

The ham sandwich was indicted and it's an indictment that the top two liberal legal scholars in the United States say is garbage. But that didn't matter to hate-Trump Manhattan District Attorney Alvin Bragg, who persuaded an obviously brain-dead grand jury in Blue New York City to charge Donald Trump yesterday. The goal: Cripple Trump's likely presidential candidacy in 2024. The reaction from people who know something about the law: It's a nakedly political prosecution.

### Turley: It's "Legally Pathetic."

At this writing, Bragg is keeping the indictment a secret, but news reports say the grand jury charged Trump with 34 counts of fraud in connection with \$130,000 that Trump's disgraced former attorney, Michel Cohen, paid to porn star Stormy Daniels. A letter from Cohen's former attorney says he made the payments on his own initiative and Daniels recanted her claim that she had an affair with the 45th president.

Be that as it may, Bragg foolishly forged ahead, liberal law professor Jonathan Turley avers "History in this case — and in this country — is not on Bragg's side," Turley wrote.

The only crime that has been discussed in this case is an unprecedented attempt to revive a misdemeanor for falsifying business documents that expired years ago. If that is still the basis of Thursday's indictment, Bragg could not have raised a weaker basis to prosecute a former president. If reports are

accurate, he may attempt to "bootstrap" the misdemeanor into a felony (and longer statute of limitations) by alleging an effort to evade federal election charges.

While Trump will be the first former president indicted, he will not be the last if that is the standard for prosecution. The federal election charges would be related to using campaign money to pay Daniels via Cohen.

Turley noted that the Justice Department refused to prosecute the federal claim because it had tried a similar prosecution of failed Democrat presidential candidate John Edwards, whose aides were involved in payoffs to cover up a love child conceived in an adulterous affair. "At the time, Edwards' wife was suffering from cancer," Turley explained.

The prosecution still collapsed. The reason is that you need to show the sole purpose for paying hush money in such a scandal. For any married man, let alone a celebrity, there are various reasons to want to bury a sexual scandal. At first, Bragg refused to prosecute the case, but then, Turley observed, two lawyers in his office quit over the decision and attacked him in a book. Bragg caved.



The two renegades "did something that some of us view as a highly unprofessional and improper act," Turley continued, one of them "published a book on the case against Trump — a person who was still under investigation and not charged, let alone convicted, of any crime" It worked. Bragg ran on his pledge to bag Trump. It really did not matter what that crime might be. It's a "raw political prosecution," Turley said on Fox News's Special Report. "The indictment may come out with a crime that none of us have heard of." It's "legally pathetic."

### Dershowitz: Fake Crime

Amusingly, Dershowitz told Fox's Morning with Maria that the only felony Bragg should investigate is the grand jury leak about the indictment. "The most likely felony that's been committed in this case, and that is, if somebody on the grand jury leaked the fact that there was a vote to indict, that is a one- to five-year, Class E felony. So Bragg now has a prima facie case that a crime has been committed right in his building." That's the crime, Dershowitz continued, the very "opposite of the Trump case."

Dershowitz observed that the prosecutor ran on a campaign pledge to "get Trump" and would "figure out what crimes there might be" after the election. Dershowitz said Bragg made up a "fake misdemeanor" that he wants to "piggyback" with a federal felony. "In 60 years of practice, this is the worst case of prosecutorial abuse I have ever seen," Dershowitz

told The Epoch Times. Dershowitz also said Trump couldn't get a fair trial in leftist Manhattan. "There's no possibility he can get a fair trial in Manhattan, a borough that went, you know, over 80 close to 90% against Trump," he said. The case has to be moved to a place like Staten Island or upstate New York, where judges and jurors won't come home to their family and be worried that their family will never talk to them again because they're responsible for letting Trump run for president.

It happened to me when I represented Trump in front of the Senate [on impeachment]. Lost many, many of my friends, associates. My wife lost her friends, just because I was perceived as being on Trump's side. (I was not on his side politically.) Imagine if a judge has to face that kind of a pushback - or jurors - so you're never going to get a fair trial in New York City and Manhattan.

### McCarthy: Bragg Will Be Held Accountable

U.S. House Speaker Kevin McCarthy, considered by many a weak GOP sister, vowed vengeance. "Alvin Bragg has irreparably damaged our country in an attempt to interfere in our Presidential election," McCarthy tweeted: As he routinely frees violent criminals to terrorize the public, he weaponized our sacred system of justice against President Donald Trump. The American people will not tolerate this injustice, and the House of Representatives will hold Alvin Bragg and his unprecedented abuse of power to account.

### DeSantis: No Extradition

Florida Governor Ron DeSantis said Florida will not permit Bragg's hate-Trump Gestapo to extradite Trump, although extradition is highly unlikely. Trump will surrender voluntarily for his arraignment next week. "When Trump turns himself in, he'll be booked mostly like anyone else facing charges, mugshot and all," the Associated Press reported. "But he isn't expected to be put in handcuffs, he'll have Secret Service protection and will almost certainly be released that day."
