### ***Applicants:***

"I hereby declare, on oath, that I absolutely and entirely renounce and abjure all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, of whom or which I have heretofore been a subject or citizen; that I will support and defend the Constitution and laws of the United States of America against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I will bear arms on behalf of the United States when required by the law; that I will perform noncombatant service in the Armed Forces of the United States when required by the law; that I will perform work of national importance under civilian direction when required by the law; and that I take this obligation freely, without any mental reservation or purpose of evasion; so help me God."

### ***Oath of Office:***

"I do solemnly swear (or affirm) that I will support and defend the Constitution of the United States

against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office on which I am about to enter: So help me God."

### ***Oath for Enlistment and Oath for Commissioned Officers:***

"I, (name of enlistee), do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; and that I will obey the orders of the President of the United States and the orders of the officers appointed over me, according to regulations and the Uniform Code of Military Justice. So help me God."

"I, [officer], do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true

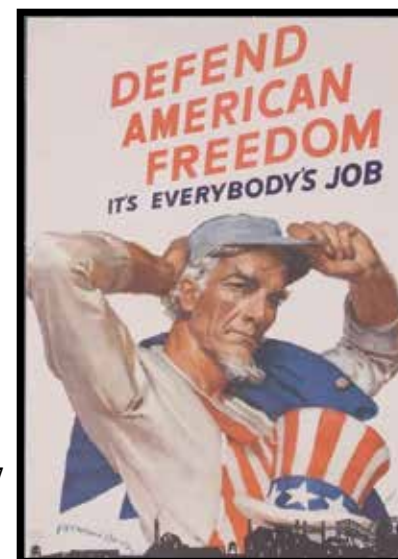

large-scale voting irregularities that marred the 2020

[The New American] magazine, its predecessor publications, and its parent organization The John Birch Society have been warning for generations that the blessings of liberty that we've enjoyed as Americans are increasingly endangered by the growth of government beyond its constitutional restraints and the corresponding erosion of responsibility.

America's drift away from fundamental principles of good governance, we've further warned, has been by design and is not inevitable. Bad policies have caused America to go off course, and those policies can be changed.

At the founding meeting of the JBS in 1958, founder Robert Welch warned of the direction the policymakers of his time were taking us:

- "Greatly expanded government spending, for missiles, for so-called defense generally, for foreign aid, for every conceivable means of getting rid of ever larger sums of American money — as wastefully as possible."
- "Higher and then much higher taxes."
- "An increasingly unbalanced budget, despite the higher taxes."
- "Wild inflation of our currency, leading rapidly towards its ultimate repudiation."
- "Government controls of prices,

wages, and materials, supposedly to combat inflation."

• "Greatly increased socialistic controls over every operation of our economy and every activity of our daily lives."

• "Far more centralization of power in Washington, and the practical elimination of our state lines."

• "The steady advance of federal aid to and control over our educational system, leading to complete federalization of our public education."

Welch also warned about other plans to take America off course, including "the gradual surrender of American sovereignty, piece by piece and step by step, to various international organizations — of which the United Nations is the outstanding but far from the only example."

Those warnings were issued more than six decades ago, and they have, unfortunately, held up well against the test of time. Yet even though many

have detected the ominous signposts to tyranny as America has increasingly gone off course, many others have dismissed the continuing warnings of The John Birch Society and its publications, including The New American,



as alarmist or conspiracy theory. But since 2020, there has been a seismic shift in the understanding of the

American people that something is seriously wrong. In 2020, government authorities used the Covid pandemic to require Americans to wear masks, to compel them to take experimental vaccines, and to prohibit them from going to church or to work. The same year also witnessed widespread rioting that the Left justified as a natural response to our supposedly racist system in the wake of the death of George Floyd.

The pandemic was also used as a rationale for the unprecedented ramp-up of mail-in voting and the use of drop boxes that contributed to the

presidential election.

Then there was January 6, 2021, and the arrest and imprisonment of hundreds of J6ers who went to Washington to protest the flawed election results. The fact that J6ers are being treated differently than left-wing rioters has not been lost on the American people.

In this issue, our cover story sheds much-needed light on the ordeal of the J6ers by telling the story of one prisoner, Kelly Meggs. Also, a companion piece reports on Louisiana Republican Congressman Clay Higgins' conclusion, based on his investigation of the evidence, that hundreds of FBI assets were implanted among the J6ers to lead them astray.

The ordeal of the J6ers is another powerful wake-up call that our freedoms are receding. Yet, while this awakening is leading many to become involved in the freedom movement, others are fearful to speak out because of the prospect of government retribution. For those who may fall in the latter camp, please consider a warning attributed to Hiram Mann: "No man escapes when freedom fails, the best men rot in filthy jails. And those who cry 'appease, appease' are hanged by those they tried to please."

## Gates-Funded “Organic Coating” Is Anything But

It would be hilarious if it were not so alarming.

Apeel (and its supposedly “organic” version, “Organipeel”) is a Gates/WEF-

backed artificial coating that is being applied to fruits and vegetables (and likely more), often without your knowledge or being clearly marked, under the claim that it will allow the products to last longer, thereby making it easier to feed those in need. Ignoring for the moment that this is a problem that has been solvable for decades, should we as a society simply be utilizing the massive amount of perfectly edible



food that is wasted due to ascetics or other superficial rationale. There are countless reasons to question the intentions behind such a product as well as its safety.

It was when I discovered that the supposedly organic version, Organipeel, was in fact registered as a pesticide under the Federal Insecticide, Fungicide and Rodenticide Act that I realized just how openly dishonest this product was, especially in light of the recent attack on Berkey water filters.

The U.S. EPA is attempting to label Berkey water filters as a pesticide, due to silver used in the filter process (that does not pass into the water itself) in order to regulate the product under the Federal Insecticide, Fungicide, and Rodenticide

This is unjustified, and appears to be either a corporate attack on a competitor or a more nefarious attempt to stop people from being able to filter certain things out of their water supply — likely both. What makes this all the more insulting is that this is the exact same act under which Organipeel was registered as a pesticide. Yet Organipeel and Apeel are being sold as harmless (which is not accurate by a long shot) and fit for human consumption while we are being told the Berkey water filter is not, for the exact same reason. There is clearly some monumental hypocrisy going on here, but follow-

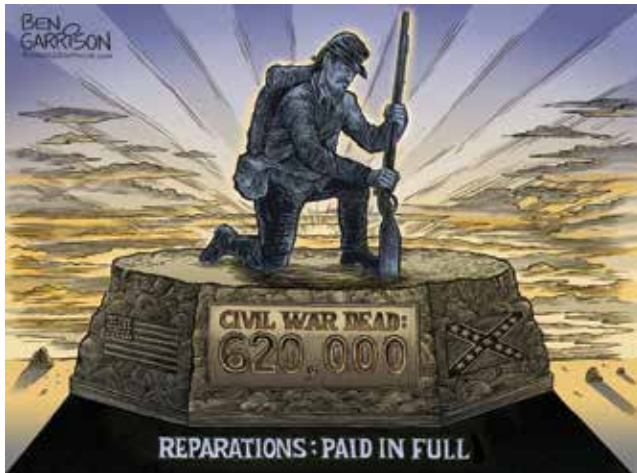
## California Becomes First State to Introduce Reparations Legislation

California has won the race to be the first state in the nation to formally introduce legislation that would pay slavery reparations to black Americans with a series of bills — including one that claims to restore property that was seized in “race-based” eminent domain cases and one constitutionally problematic proposal for giving public funds to only specific groups.

As Politico reports, the new legislative push comes on the heels of 111 pages of recommendations published last year by California’s state-sanctioned reparations task force. Based on these recommendations, the California Legislative Black Caucus in the state Legislature introduced 14 measures that tackle the issue, not with cash payments, but in a number of spheres that include criminal justice, civil rights, and education.

For example, one bill would restrict solitary confinement in the Golden State, a perpetual effort that was killed in the statehouse just last year. In excluding outright direct monetary payments to black Americans, Democrats are tacitly accepting the unviability of such a proposal which,



while highly demanded among the black community, would be difficult to pass even in liberal California given the state’s high proportion of nonblack minorities, including Latinos and Asians.

Assemblywoman Lori Wilson, chair of the black caucus, defended the suite of bills by arguing that reparations are not only about cash, but about a holistic approach to undoing the alleged effects of racism. “While many only associate direct cash payments with reparations, the true meaning of the word, to repair, involves much more,” Wilson said. “We need a comprehensive approach to dismantling the legacy of slavery and systemic racism.”

Nevertheless, the legislative package does have some monetary assistance.

In the bill dealing with “property takings,” blacks who had their property taken away by “race-based” eminent domain must have it restored to them. In situations where giving back the property itself is not appropriate, the original owner is to be financially compensated.

Politico reports that the suite’s proponents expect a tough battle to get it passed and anticipate running into legal challenges. The outlet notes: Democratic

Assemblymember Corey Jackson, who represents a district north of San Diego, is proposing asking voters to change California’s Constitution to allow the state to fund programs aimed at “increasing the life expectancy of, improving educational outcomes for, or lifting out of poverty specific groups based on race, color, ethnicity, national origin, or marginalized genders, sexes, or sexual orientations.”

That plan could face a similar constitutional challenge like the one that ultimately dismantled affirmative action. The reparations plan includes an assortment of other proposals, such as protections for “natural and protective” hair stylings in competitive sports and even a requirement that the governor and state Legislature offer the black community a formal apology for their alleged participation in human rights violations against African slaves and their descendants.

Colorado, New York, and Massachusetts are other states that have created task forces or funded studies to look into reparations, but California is the first to actually move toward codifying the longtime progressive talking point into law.

Even if the current measures are passed and signed, will the cultural Marxists be satiated, or merely take it as blood in the water, proof that they can squeeze extreme left-wing policies from the state if they apply enough pressure?

Amid the deliberations of California’s reparations task force, black activists demanded cash payments of up to \$800,000 per person, along with grants to black-owned businesses and 15-20 acres of land per person. The task force itself at one point

recommended giving out \$223,000 per person, calling for a total of \$569 billion to be allocated to the black community.

The hope of California’s Democrat-controlled government is that the state’s reparations program will inspire the federal government to launch a similar plan nationwide.

California state Sen. Steven Bradford, a member of the task force, admitted on Thursday that the implementation of the proposed measures could be impacted by the state’s budget deficit. “We have to have at least a placeholder in the budget for reparations,” said Bradford, adding that the state could designate funds from its reserves to bankroll the reparations.

And the black caucus has declared that this won’t be a one-and-done, but rather “a multi-year effort to implement the legislative recommendations in the report.”

As with other race-based programs, such as affirmative action, the proponents of reparations sell short those they claim to champion by essentially arguing that these communities are perpetually unable to prosper by their own effort and can only find success if given enormous handouts by others.

In the end, the reparations push is nothing more than a manifestation of cultural Marxism aimed at dividing the citizenry on the basis of race and keeping blacks in the Democratic tent through otherism, demagoguery, and the bribing of the electorate.

If California Democrats get their way, it could create an unfortunate storm that would give impetus to further racial pandering in blue states across the nation — to the detriment of true constitutional republicanism.

## Don't Tax the Rich. End the Fed!

Select politicians, government officials, economic elites, and experts arriving at the annual World Economic Forum meeting in Davos, Switzerland were greeted with an open letter signed by more than 250 billionaires and millionaires. The signers request their respective governments raise their taxes.

The letter signers are concerned about “inequality” that they say “has reached a tipping point.” The cost of this inequality “to our economic, societal and ecological stability risk,” the letter continues, “is severe — and growing every day.” They may have a point. Since the 2008 market meltdown, resentment against those at the top of the income ladder has been growing. However, this is not because people are envious of those able to profit in a free market. Rather, the resentment is rooted in the corporatist system that rewards those who manipulate the political process.

If the signatories to the letter want to truly end the type of inequality that fuels populist rage, they should stop calling for tax increases and instead call for an end to government programs and policies that benefit the rich and powerful. Included are

programs like the Export-Import Bank that subsidize large corporations, health and safety regulations that cartelize markets while failing to protect consumers, and interventionist foreign policy that enriches the military-industrial complex while making the rest of us poorer and more vulnerable to terrorist attacks.



The Federal Reserve is the leading cause of inequality. This is not surprising considering it was created at the behest of bankers and rushed through Congress just before Christmas when few Americans were paying attention. Many Americans became aware of how the central bank tailors its policies to benefit the financial elites following the 2008 meltdown. Then, the US government, enabled by Fed money printing, bailed out large financial institutions while

average Americans suffered.

The Fed had been helping big firms for many years. In the 1990s it was common for the Federal Reserve, then under the leadership of Alan Greenspan, to pump money into the market in response to apparent crises. This was named the “Greenspan put” by the financial press. The new money would help some companies and their wealthy owners, while reducing most Americans’ purchasing power.

Middle- and working-class Americans suffer the brunt of inflation, which is properly defined as the central bank pumping money into the economy thus reducing the dollar’s purchasing power.

In a free market, most people will be able to have a satisfactory standard of living and recognize that the “super rich” earned their fortunes by offering goods and services that served the needs and wants of consumers while providing good jobs at good wages to fellow citizens. In contrast, in a “mixed economy” supported by a fiat money system, the average person will suffer a steady erosion of his standard of living thanks to the central bank’s inflationary policies, while the crony capitalists prosper. This is a recipe for social instability.

Those concerned with the detrimental effects of rising resentment of income inequality should support repealing all

## ATF Investigating Firebombing of Conservative Organizations

The president of TakeCharge, Kendall Qualls, told The New American that the organization continues to grow, gaining traction with over 50 volunteers from black communities in Minnesota. “When I say volunteers, I’m talking about people that were former gangbangers, drug dealers. Most of these people come from broken homes, but they fixed their lives, and they’ve been prospering in the America that we know today, not the ‘systemic racism’ false narrative America, the real one,” he said. He also noted how TakeCharge is leading the conversation with its extensive media library, saying, “We have the largest multi-

media ... library of black Americans that denounce Black Lives Matter, denounce critical race theory and DEI, and call for a need to get back to our roots of faith, family, and education.”



The attackers started fires on the first and third floors of the building where the three conservative organizations are located. The second floor was

not targeted. As a result of the attack, though, the entire building has been declared uninhabitable, thereby impacting all occupants of the office building. While some of the businesses have been able to function remotely, not all are able to do so.

Golden Valley Assistant Fire Chief Dominique Guzman told The New American they received a business alarm at 2:11 a.m. Golden Valley Police

Department officers arrived at the scene first and found an active fire. Guzman described it as a “ventilation-limited fire” and said it was fairly short, and stated

there were no victims or suspects at the scene. Hennepin County fire investigators determined on the scene that the fire was a result of arson, and the investigation was referred to state fire investigators, who then referred the investigation to the ATF.

ATF public information officer Ashlee J. L. Sherrill confirmed the arson investigation, telling The New American, “The fire is being investigated as an act of arson. We are investigating alongside the Golden Valley Fire Department, the Hennepin County Fire Investigative Team, the Minnesota State Fire Marshal Division and the FBI. Since it is still an ongoing investigation, we are limited [in] what we can add for detail.”



## Javier Milei's "Anarcho-Capitalist" Presidency: The Rundown So Far

Amidst rampant peso inflation and his scathing pro-free market speech at Davos, new Argentine president Javier Milei has taken office with radical proposals to overhaul the country. While his brief month and a half in Argentina's Casa Rosada isn't long enough to know if his



bark will really match his bite, here's a summary of some of his biggest actions so far: Among his first moves after taking office was slashing the number of government ministries from 18 to just 9. These make up the presidential cabinet. Milei consolidated the Ministries of Culture, Education, Health, Labor, Social Development, Public Works, Transportation, Telecommunications, and Energy and Mining. Their functions are now contained under 3 different umbrellas: the Ministries of Health, Human Capital, and Infrastructure.

In a controversial move, he also appointed his sister Karina Milei as General Secretary of the Presidency. Given their relationship and the importance of the role, helping determine everything from policy to public relations messaging, her performance will be watched closely by critics. Argentinians are used to political families (two of their last four presidents shared a last name), but it still raises eyebrows when a

president appoints a direct relative to one of the highest ministerial offices.

The pressure is on Milei and his team to rein in runaway inflation, which has roughly doubled since November and threatens to spiral further out of control. To his credit, Milei doesn't expect a magic wand without pain, calling his reforms "shock therapy" for the country. Peter Schiff and other libertarian commentators have said this for decades — central banks are great at kicking the can down the road, but it only feeds an even bigger crisis later. Despite the pain, the only way is to rip off the proverbial band-aid and let free markets sort themselves out: "Politicians promise the world, but they can't deliver. Milei knows that free markets, not government handouts, fulfill needs."

To that end, perhaps the most-watched development since Milei took office is his sweeping reform bill enacting everything from higher export taxes to ending subsidies for energy and media companies. It

also privatizes dozens of public companies, shifting public works projects away from government management.

Among the many questions for Argentinians is what will happen to the affordability of fuel and other essentials

when subsidies are removed by this "Mega-Reform" bill. As Argentine Minister of Economy Luis Caputo explained, for years the government has stepped in to help its citizens with their energy costs: "Today the state artificially maintains very low prices in energy and transportation rates through subsidies."

When a government gives subsidies it can't afford to give, they do long-term economic damage. But the pain Argentines will feel in the short term from having those subsidies and other artificial comforts ripped away may create a public relations backlash against his policies. Unfortunately, when the failures of artificial monetary expansion lead to rampant inflation, mainstream economists don't take it as a lesson against the dangers of money printing — but the same can't be said for the reverse.

Perhaps the most alarming part of the bill shifts some legislative powers from Congress to the president, stoking concern that Milei plans to grant himself increasing levels of authoritarian control. Either way, the bill is expected to meet heavy opposition from Congress, where the strong pro-Milei faction is small. In fact, Milei has repeatedly altered aspects of the bill to try to increase

its chances of passing, including diluting some of its clauses increasing presidential powers. With the concessions, analysts expect some version of the bill to pass.

A separate decree to deregulate the government was put into effect in December, but parts of it have already been struck down in one of Argentina's highest courts. It will be among many challenges to Milei's heavy-handed style of reform, which will test the country's checks and balances as it falls under the scrutiny of the legislative and judicial systems.

One of the biggest unanswered questions of Mileiconomics is how it will begin to dig Argentina out of its immense dependence on loans from China, historically financed through rounds of money printing, and billions in IMF loans. The country has defaulted on its sovereign debt multiple times. Whatever the measures, undoing a long history of economic damage in Argentina will take years, along with coordination beyond a single administration.

Perhaps more importantly, Milei's results are likely to serve as a global PR campaign for (or against) the policies and worldview that Milei promotes leading to political and economic implications far beyond Argentina's borders.

## New DOI Rules Erasing Native Americans From Society

New rules by the Department of the Interior (DOI) meant to strengthen nation-to-nation relationships, ensure that progress in "Indian Country" endures for years to come, and protect Native American culture are having the opposite effect, with museums across the country shuttering Native American exhibits.

The DOI issued new rules in December to bolster the Native American Graves Protection and Repatriation Act (NAGPRA), which became law in 1990 to provide for the protection and return of Native American human remains, including funerary objects, sacred objects, and more. The rules require museums and federal agencies to seek informed consent from lineal descendants and/or tribes before allowing any exhibition, and to identify and send back stolen sacred items to their respective tribes.

"The Native American Graves Protection and Repatriation Act is an essential tool for the safe return of sacred objects to the communities from which they were stolen. Among the updates we are implementing are critical steps to strengthen the authority and role

of Indigenous communities in the repatriation process," said Interior Secretary Deb Haaland in a press release. "Finalizing these changes is an important part of laying the groundwork for the healing of our people."

In response to the new rules, the American Museum of Natural History in New York reportedly closed two halls dedicated to Native Americans this week, and "the Cleveland Museum of Art and the Field Museum in Chicago have both covered up several displays while they figure out if they are complying with the regulations."

According to The Washington Post, the president of New York's American Museum of Natural History, Sean

Decatur, announced in an email last week: "While the actions we are taking this week may seem sudden, they reflect a growing urgency among all museums to change their relationships to, and representation of, Indigenous cultures. The Halls we are closing are vestiges of an era when museums such as ours did not respect the values, perspectives, and indeed shared humanity of Indigenous peoples. Actions that may feel sudden to some may seem long overdue to others."

The new DOI rules, however, as the Washington Examiner shared, are "both inconsistent and tedious. They do not apply to the Smithsonian, which is also lagging behind in its compliance with the law. It helped employ even more bureaucrats at Harvard University, which has doubled the size of its staff dedicated to complying with the law. But



most notably of all, these rules that are supposed to benefit Native Americans are actually completely erasing them from museums, where people go to learn about history and would presumably be able to understand those cultures and what happened to those tribes better."

While museums struggle to adhere to the whims of government bureaucrats bent on enforcing their new woke rules, battle lines are forming across the country as Native American groups seek to reclaim their heritage from acts of cancel culture. The renaming of sports teams such as the Washington Redskins and Cleveland Indians, as well as the removal of Native

American images, nicknames, and tributes nationwide, has sparked the ire of activists who are in rebellion against wokeness.

One pro-Native American activist, Lisa Davis in Cedar City, Utah, told Fox News Digital, "We're actually fighting an anti-American movement. The people trying to erase Native American culture are the same people trying to remove Thomas Jefferson and bashing American heritage."

Davis and a number of other Cedar City residents, according to Fox, "formed the grassroots organization VOICE (Voices of Iron County Education) after the school board voted to eliminate the high school's traditional

Redmen name and logo in 2019." Fox further shared: "It was an honor to be called the Redmen," Julia Casuse, a "full-blooded Navajo" and graduate of Cedar City High School, told Fox News Digital. The silversmith said she tells visitors at the family's shop, Navajo Crafting Co., "I'm a Redmen through and through." The school's nickname is now the Reds.

In addition to imposing the new rules to supposedly protect Native American culture, the DOI has been on the wokeness warpath for two years seeking to whitewash away long-standing names, according to a 2022 press release, of

"more than 660 geographic features with the name 'squaw,' which was officially declared a derogatory term as a result of Secretary's Order 3404.

"Words matter, particularly in our work to make our nation's public lands and waters accessible and welcoming to people of all backgrounds. Consideration of these replacements is a big step forward in our efforts to remove derogatory terms whose expiration dates are long overdue," said Secretary Haaland. "Throughout this process, broad engagement with Tribes, stakeholders and the general public will help us advance our goals of equity and inclusion."

It now appears as though the truth of the federal government's woke policies in the name of "inclusion" have been exposed. As the Examiner stated regarding the rules affecting museums: This obsession with racism, racial categorization, and racial grievances is counterproductive in many ways, dividing people by race and pitting them against one another based on what people did hundreds of years ago. In this case, this obsession is isolating Native Americans and erasing them from our shared society and history while claiming that this is how to respect or honor them. You couldn't come up with a more backward "logic" than this.

Regarding the Cedar City High School name change, Davis lamented, "We went from honoring centuries of American and Native American history to honoring communism."

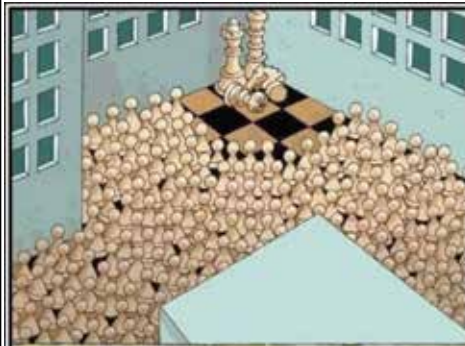

## Federally Driven Invasion Must be Ended by State Laws and Enforcement

Governors are taking temporary actions, but invasion is an enduring problem. State legislators need to take permanent actions.

Texas Governor Greg Abbott formally stated on January 24, 2024 that more than 6 million illegal immigrants have crossed Texas's southern border in just 3 years, and Texas's constitutional authority to defend and protect itself from this invasion is the supreme law of the land.

Florida Governor Ron DeSantis agreed that Texas has every right to enforce federal law to defend itself, and he had already started sending people to help years ago. Similar or narrower support was quickly expressed by several state representatives in South Carolina, and in total by the governors of 25 states.

Invasion and Constitutional Powers

State legislators have the duty to pass rules-of-engagement cards that are clear enough to protect their people in situations in which the legislators place their people in harms' way. They have the duty to declare that an invasion is present and will be repelled.

State legislators and governors together have the duty to pass bills that would establish laws, consisting rules and associated sanctions, which would not violate constitutional national laws and which would have sufficient force to make state residents secure. They can do this by replicating in state laws a minimal set of the rules and sanctions that are in the existing national



laws. Ideally, they should instead develop better laws that are exemplary models, that will soon be proven practical in use.

Governors, and any other state executives in whom some of the state executive powers are vested, have the duty to execute the constitutional laws. Especially in the wake of the recent experience of covid-rationalized power grabs, executives should resolutely forswear any use of emergency powers—powers that they should not have been delegated, and if these are delegated, that they should never ac-

cept. They may find it expedient at the start to execute existing national laws, using state courts and prisons.

### Steps to Freedom

The national government unduly deprives state residents of life, liberty, and property through invasion, but this is in just one of many policy areas. It is critical to respond by supporting the Constitution: by legislatively passing constitutional bills consisting solely of rules and sanctions, and by executive-ly signing those bills and accepting full accountability for executing constitutional laws.

The Constitution, above all, defines processes. Supporting the Constitution demands carrying out those processes. Each right step in any area trains a person in the way he should go in all areas.

The current invasion, which its architects intend to bring about tyranny, can—and should—instead be a catalyst that increases freedom.

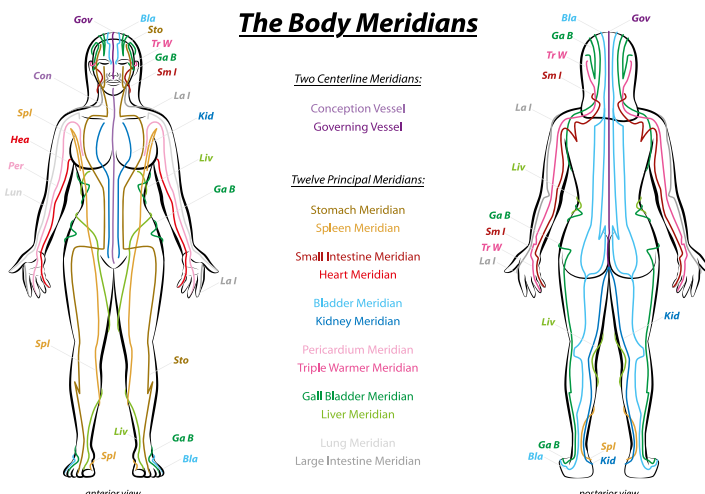
are supposed to be able to protect the border better when there is no fence to assist them? We all know the Biden administration really objects to the fence because it wants more migrants to come in, not fewer.

## Senate Agrees to Spend Three Times More Money on Ukraine as on U.S. Border Security

The Ukraine funding and immigration bill to which Stupid Party Senate Republicans agreed will fund subversive refugee assistance groups to the tune of more than \$2 billion. The bill would permit almost 5,000 illegal aliens a week to enter the country before requiring the secretary of homeland security to declare an emergency. Asylum applicants (almost all of whom are bogus) would be authorized to work here. It would spend just one third of the money on the border that it will waste on Ukraine's unwinnable war against Russia. More than \$24 billion goes to Israel and Gaza. Upshot: The bill does little to nothing for Americans, and everything for foreigners.

### The Details

The devil, as they say, is in the details of the 370-page monstrosity that few if any congressmen will read or understand. Those who do will find that it amounts to an illegal-alien amnesty, and a bonanza for "refugee assistance" groups that collect tax money to undermine the country.

The bill would spend **\$2.33 billion for "refugee and entrant assistance,"** - money that will "remain available" until September next year. The money will go for "grants or contracts with qualified organizations (including nonprofit entities) to provide culturally and linguistically appropriate services, including wraparound 16 services, housing assistance, medical assistance, legal assistance, and case management assistance."



Aside from pouring money into leftist refugee groups that are helping Traitor Joe Biden flood the country with penniless Third World vagrants, the bill also permits almost 2 million to enter the country before the homeland security secretary does anything about it.

"The Secretary shall activate the border emergency authority if during a period of consecutive 7 calendar days, there is an average of 5,000 or more aliens who are encountered each day; or on any 1 calendar day, a combined total of 8,500 or more aliens are encountered." Theoretically, if Border Patrol agents encountered an average of 4,900 illegal migrants every seven days, then 1.79 million illegals annually could try to cross the border before the secretary declared an emergency.

A section of the bill called "promoting legal immigration" contains a blanket work authorization not only for approved asylum applicants but also their "fiance's, fiancee's, spouses and children."

The secretary of homeland security also has blanket authorization to

approve work authorization for aliens not otherwise entitled to work. In other words, the bill will take even more jobs from Americans and give them to foreigners.

As for Ukraine, Republicans agreed to spend three times as much money on President Volodymyr Zelensky's corrupt regime as it did on closing the southwest border of the United States.

Just **\$20 billion goes to the border.** Meanwhile, **Zelensky will get \$60 billion.** Where that money goes no one will know. As The New American reported last week, five Ukrainians are charged with stealing \$40 million of U.S. aid, and the country has repeatedly dealt with corrupt officials. Additionally, Zelensky's corrupt regime recently supervised the murder by neglect of Gonzalo Lira, an American commentator who exposed the folly of Ukraine's continuing fight with Russia. Also, he canceled elections scheduled for next month before he landed in Washington, D.C., in December to beg for more money.

Another **\$14.1 billion will go to Israel,** and another **\$10 billion goes to Gaza** to help civilians caught up in the Hamas-Israel war.

**Total spending, including the rest of the waste, fraud, and abuse: \$118.28 billion.**

### Reaction

The GOP's surrender on the border deep-sixed the deal as soon as it was

released. GOP conservative Josh Hawley of Missouri and Tommy Tuberville of Alabama denounced it as an open-borders amnesty. "This is an open-borders bill if I've ever seen one," Hawley wrote on X. "The Democrats are celebrating already." Said Tuberville: "I can't believe this is the 'border security bill' that's been 'negotiated'. This bill DESTROYS American sovereignty. It will weaken immigration laws for decades and handcuff the next President that actually wants to secure our borders and defend our country. This bill has been crafted to solidify the invasion of illegals into the United States of America. **I'm an immovable NO.**"

Indeed, House leaders say it won't get a vote. "I've seen enough," said GOP Speaker Mike Johnson. This bill is even worse than we expected, and won't come close to ending the border catastrophe the President has created. As the lead Democrat negotiator proclaimed: Under this legislation, "the border never closes." If this bill reaches the House, it will be dead on arrival. "Let me be clear," House Majority Leader Steve Scalie Louisiana said, "The Senate Border Bill will NOT receive a vote in the House."

Louisiana Congressman Clay Higgins understands and can explain with the best of them — likely better — what happened on January 6, 2021. He has fearlessly followed the evidence.

On the three-year anniversary of J6, Tucker Carlson published a 38-minute interview with Higgins about what his investigations into that fateful day have yielded. It won't surprise TNA readers to learn that Higgins discovered a "conspiracy at the highest levels," a conspiracy designed to entrap Trump supporters and destroy MAGA altogether on J6. "You ask, who planned this?" Higgins told Carlson. "This would be a combination of several of the most extreme, liberal, anti-Trump, anti-America First factions that were in positions of authority within our law-enforcement organizations and the Democrat Party across the country. To find that level of conspiratorial corruption at the highest levels of the FBI has been very troubling to me as a man, as a cop."

In November, Higgins had an intense exchange with FBI Director Christopher Wray during a House Homeland Security Committee hearing. "Your day is coming," Higgins famously told Wray after revealing that the FBI bussed in hordes of agents dressed as Trump supporters on J6 weekend. Because Higgins is, in fact, still a cop. Higgins said the FBI and elements within the Democratic Party had been staging the J6 setup for 10 months before it happened. He said FBI agents burrowed into MAGA circles: "The FBI had embedded themselves into various groups online across the country of Americans... The FBI worked undercover to infiltrate those conversations."

Why do something so subversive, so un-American? According to Higgins, their objective was to destroy the entire MAGA movement, to forever stain the patriotic fervor that was associated with the America First MAGA movement that had won in 2016 and we believe won again in 2020. The establishment on both sides of both major parties were determined to smash that out of existence, not just by defeating Trump, but by destroying the reputations of the movement itself by creating this narrative that... America First Republicans were somehow a

danger to our Republic and a domestic threat.

The Louisiana congressman's office had been investigating J6 before Republicans won the House of Representatives in the 2022 midterm elections. Afterward, he joined his findings and investigatory efforts with those of the Homeland Security Committee. Higgins believes that FBI agents not only infiltrated online MAGA groups and embedded themselves on the ground on January 4, 5, and 6, but went so far as to instigate the violence, a notion the FBI director has denied. Nonetheless, according to Higgins, "Some of that evidence shockingly reveals that the FBI agents that were operating undercover within the online groups were the first ones to plant the seeds of suggestions of a more radical occupation of the Capitol."



On January 9, 2024, Ray Epps, a man caught on video telling people numerous times to storm the Capitol, received a sentence of probation. Even the folks at the establishment political news outlet The Hill couldn't help but notice that justice was off-balance when considering the sentences of other J6ers. One of their news anchors pointed out that, by contrast, Proud Boys leader Enrique Tarrio, who wasn't even physically present at the Capitol, received a 22-year prison sentence. Epps, to all rational observers, looks every part a federal asset. He is a military veteran (a very common attribute among federal assets), he consistently urged people to storm the Capitol and then, unlike the others, he got away with it. Epps and prosecutors involved in his case have denied that he's a federal agent. James Howard Kunstler discussed in

his weekly column why he believed the Deep State was willing to risk its propaganda optics with Epps: "I'll tell you one reason Ray didn't get, like, twenty years, nor two years of pre-trial detention in the reeking, roach-infested DC lockup, or massive fines, like other J-6 defendants: Because he told his handlers in no uncertain terms that he would blow their cover and vivisect them publicly on the whole fed J-6 operation if they so much as made him show up in person for any proceeding — and, of course, he "attended" his sentencing by phone, in a Zoom meeting from a remote location."

Higgins believes FBI assets were not only pushing people to storm the Capitol, but were waiting inside to give the "insurrectionists" a tour: "On the inside, you had FBI assets dressed as Trump supporters that knew their way


around the Capitol ... before the doors opened, otherwise how are you going to get around the Capitol? It's just not possible. You have to have a guide, and on January 6, the guides were FBI assets and they were dressed as Trump supporters and they were positioned inside the Capitol prior to the doors being open."

Fed? Ray Epps was caught on video telling people multiple times to storm the Capitol. For his actions, he was sentenced to a year probation, a sentence many believe is unjust, considering that other J6ers are serving years in prison for less egregious actions.

So how many FBI assets were involved in the J6 conspiracy? According to Higgins, "based upon some very conservative

but hard investigative effort evaluation of the numbers, from putting together eyewitnesses and videos and affidavit statements and whistleblower statements and court records that have been revealed through individual criminal cases where J6 defendants have been prosecuted and smart attorneys have forced admissions by the DOJ and the FBI ... conservative estimates would put the number of FBI assets in the crowd outside and working inside at well over two hundred." He said he believes there were more, but two hundred is a number he's very comfortable with. He said the conspiracists' ultimate goal was to set "the stage for arrest and prosecution." Furthermore, Higgins believes, "There's no daylight between the compromised election cycle of November 2020 and ultimately what happened on J6." J6 and the stolen election are part of the same conspiratorial package.

After hearing all this, Carlson soberly acknowledged that we have a major problem. "What you're describing," the popular news host said, "is a government within a government." He asked Higgins what recourse patriotic Americans have to deal with such a corrupt and illegal situation. Higgins' answer: "Well, in America, a question becomes reasonable when we face a crisis like this: Who investigates the investigators? The answer in America is Congress. So we have the responsibility to investigate through the appropriate committees, which we're certainly doing now that we have a Republican majority in control of the committees, but we don't have the power to arrest. We can give criminal referrals based upon our efforts, but we have to have a DOJ that's receptive to the criminal referrals. So we've hit quite a brick wall, have we not?" How do we get over that wall? "Until you have a president running the executive branch that will clean house at the DOJ and FBI at the highest levels and put American patriots in place that will act upon the criminal referrals that Congress provides, then none of those guys are going to get arrested because they're not going to arrest themselves," Higgins says.

### Exclusive: Survey Reveals Extreme Bias Toward Jan. 6 Defendants Among Potential DC Jurors

*'Nearly 50 percent ... believe that a fair punishment for Jan. 6ers is life in prison or the death penalty.'*

For fear of being judged by biased jurors, Jan. 6 defendants have been trying to have their trials moved to venues other than the District of Columbia for three years. Government prosecutors and judges insist there is no evidence to prove that they can't get a fair trial in Washington. There is now!

A survey conducted by Triton Polling and Research between Jan. 1-8 and obtained exclusively by The Epoch Times reveals an extreme level of bias among potential jurors living in Washington toward anyone who participated in the protests at the Capitol on Jan. 6, 2021.

Of the 422 "jury eligible residents" surveyed, 27.5% describe Jan. 6 protestors as "insurrectionists." Others describe them as "criminals" (13%), "domestic terrorists" (14.9%), or "traitors" (11.6%).

The overwhelming majority also "strongly" (75% or "somewhat agree" (14.%) that former President Donald

Trump is to blame for what happened, and 76.6 percent "strongly agree" that Mr. Trump's supporters are racists.

Asked if they thought Jan. 6 was "an act of terrorism," 63.6% said they "strongly agree." Just 8% said they "strongly disagree."

After informing survey participants that "the penalty for insurrection, treason, or committing an act of domestic terrorism is life imprisonment or death," 26.9% said they "strongly agree" and 21.1% said they "somewhat agree" that those penalties would "be a fair punishment for anyone who participated in any of the events of January 6."

"Regardless of what they did," participants were asked if "anyone who participated in the events at the Capitol on January 6 should serve prison time." Most (51.4%) said they "strongly agree" and 17.4% said they "somewhat agree." Just 10.9% said they "strongly disagree" and 11.3% said they "somewhat disagree."

Asked if "Donald Trump and his supporters should be stopped at all costs," 47.5% said they "strongly agree" and 21.1% said they "somewhat agree."

"America is a safer place with them in prison" (40.1%).

The overwhelming majority (80.1%) said they would serve as a juror if called, and most said they "strongly" (26.1%) or "somewhat" agree (13%) that they "want to be on that jury to make sure the defendant is found guilty and held accountable for the events of that day."

However, when asked if they would "do anything" in their power, "including lying or cheating, to stop racists, domestic terrorists, or insurrectionists," only 7% said, "definitely, yes," while 54.8% said, "definitely no."

In addition, 78.6% have a "very unfavorable" opinion of Mr. Trump. Only 12% said the same about President Joe Biden.

#### Three-Year Detainee [Jake Lang] Commissioned Survey

Edward Jacob "Jake" Lang, a Jan. 6 defendant from Newburgh, New York, who has been incarcerated in the D.C. jail for three years without a trial, is the one who commissioned the survey. It was paid for through donations to the January 6th Legal Fund to support Jan. 6 defendants.

In an interview with The Epoch Times from prison, Mr. Lang, who faces 11 criminal counts and one count of obstruction, said the questions and participants for the survey were strategically chosen to provide "irrefutable facts" using "the highest standards possible" because the results are "going to be used in court for a change of venue motion" being prepared by his attorney.

"It's going to be scrutinized by the judges and prosecutors very heavily," Mr. Lang said. "This data will be used by hundreds of Jan. 6ers to possibly overturn their convictions," he said. "We must get to our home states to have a shot at justice. We must leave the District."

An analysis published on Jan. 5 by the Associated Press shows that 1,241 people have been charged so far for their participation in the protests, which took place at the U.S. Capitol on Jan. 6, 2021. Of those, 905 have been convicted, 768 have been sentenced, and 322 are pending. Only one has been acquitted.

An analysis published Jan. 5 by the Washington Post shows that 714 defendants pleaded guilty as of early December. Of the 131 trials that have taken place so far, over half of the defendants chose to have a judge decide their case rather than face a jury of Washington residents. Of the 74 defendants who opted for a bench trial, 72 were convicted. Of the 57 who faced a Washington jury, every one of them has been found guilty of at least one charge.

"The amount of bias in Washington, DC is so insurmountable that jurors can't possibly be impartial because of their inherent fears," Mr. Lang explained. "I mean, 60% thought their life was in danger on Jan. 6. The most egregious is that nearly 50% of potential DC jurors believe that a fair punishment for Jan. 6ers is life in prison or the death penalty. How can I go to trial where 86% of the people think I'm an insurrectionist and 50% believe I deserve the death penalty or life in prison?"

But God is still good & we will make it through this with His grace. I love you, please have everyone call the US Marshals and see what's going on!! My cell is like a dungeon!!"

Jake Lang called The Gateway Pundit earlier this year. After more than three years of injustice and government prosecution, Jake told us, "The Bible tells us, 'Eyes haven't seen, nor ears have heard, what God has planned for those who love Him'. I wear that scripture as a shield, knowing God is more than able to deliver the January 6ers out to a wide open space when His timing comes. America now has a better sense of how vulnerable and precious Liberty really is, and new sentinels have been forged through the fire of persecution to ensure the next generation never has to suffer through these grave tyrannical injustices." ## Biden Says The US “Does Not Seek Conflict In The Middle East” While Actively Dropping Bombs There

The Biden administration has begun its latest bombing campaign in the middle east, reportedly dropping over 125 munitions on more than 85 Iranian and Shia militia targets in Iraq and Syria on Friday.

The mainstream press have been falling all over themselves to describe the strikes as “retaliatory” in nature, framing it as a provoked response to a drone attack which killed three US troops at a base on the border of Jordan and Syria. Which is a bit odd, given that this supposed “retaliation” is being directed at a nation which the US government itself admits is not known to have been involved in said drone attack at all.

While US Central Command says the strikes targeted “Iran’s Islamic Revolutionary Guards Corps (IRGC) Quds Force and affiliated militia groups,” the US has already openly admitted that it has no evidence Iran was behind the drone attack. On Monday Pentagon spokesperson Sabrina Singh admitted that there was no information showing that Iran had actually ordered or orchestrated the attack, saying only that Iran “bears responsibility” for the strike because it has been supporting such groups in the region. This position was later confirmed by Defense Secretary Lloyd Austin and by President Biden himself.

Asked by the press on Thursday how much Iran knew in advance about the drone attack by Iraqi militants, Austin said “we don’t know, but it really



doesn’t matter because Iran sponsors these groups.”

Austin was almost telling the truth. Yes, it’s true the US has no knowledge of any Iranian involvement in the deaths of those three US troops, and yes, it is true that it doesn’t matter to the US whether it did or didn’t. But the real reason it “doesn’t matter” has nothing to do with Iran sponsoring militia groups which align with its interests. In reality, “it really doesn’t matter” whether Iran was behind the attack because Iran is the most powerful non-US-aligned state in the middle east, and for that reason the US has spent generations seizing every opportunity to harm and subvert it and its interests in the region. This is just one more opportunity for the US empire to do what it always does in the middle east.

It is a bit odd, then, that the US president announced the beginning of this new series of airstrikes with a statement which claims “The United States does not seek conflict in the

Middle East or anywhere else in the world.” Conflict in the middle east is what the US empire does. The entire US empire is held together by endless conflict, especially in resource-rich regions where strategic control is necessary to retain planetary hegemony. The US empire is conflict.

Saying the US does not seek conflict

in the middle east is like saying the Kardashians do not seek attention. It’s like saying Jeff Bezos doesn’t seek money. It’s like saying the Hamburglar doesn’t seek hamburgers. It’s kind of their thing. To make such a ridiculous claim while actively raining military explosives upon the middle east, in “retaliation” for an attack which the people you’re bombing didn’t even commit, is just extra icing on the cake of ridiculousness.

From Gaza to Iraq to Syria to Iran to Yemen, conflict in the middle east is the US empire’s bread and butter. The VFW and Auxiliary promotes patriotism, assists students in furthering their education, and helps students reach their full potential through scholarships and contests. ## More Corruption in Arizona Politics

Just when you think things can't get any crazier in Arizona politics something else happens that pushes the craziness to a new level. After enduring the obvious election interference nationally in the last two elections and then the brazen election corruption which took place in Arizona during the same periods, (which has never been rectified) the new revelation bombshell Kari Lake dropped is not all that surprising. I admired Kari long before she went into politics and saw her as a role model when she was on local television in the Phoenix area. I always thought she brought integrity to the news business in Phoenix. Now I guess the swamps in Arizona and DC know it too.

I heard an interview with Kari Lake on Tuesday (01-16-24) concerning a bribery attempt and the next morning Jeff DeWit, (the Arizona GOP Chair) resigned. According to CNN, the taped conversation between Lake and DeWit revealed the GOP Chair said "...he was asked by 'very powerful people' from 'back east' if there are companies that could put Lake on their payroll and keep her from running. He also said he would like to see a "fresh face" in the Senate race."

DeWit continues, "Is there a number at which." At that point Lake interrupts DeWit saying, "I can be bought? "That's what it's about." DeWit responded, "Not be bought, you can take a pause for a couple of years. Then go right back to what you're doing." Lake's response was, "No! \$10 million, \$20 million, \$30, no. \$1 billion, no. This is not about money; this is about our country." In a livestream campaign event on Wednesday, January 17th, Lake called DeWit's conduct disgusting.

DeWit was also having problems with other issues concerning the AZ-GOP faithful. The former Chairman of the AZGOP (DeWit) had filed a lawsuit in the Superior Court of Arizona (Maricopa County) in front of the Honorable Frank W. Moskowitz alleging misconduct by the Repub-



lican Party Legislative District 3 (LD3) when he said an illegal election of officers was held. Evidently, this all is a result of LD3's replacing the former Chairwoman, Candace Czarny.

LD3 covers a large geographic area and with nearly 500 Precinct Committeepersons, it is the largest district in the state. It encompasses North Scottsdale, Anthem, Cave Creek, Carefree, Fountain Hills, Rio Verde, New River and the Fort McDowell Yavapai Community. It also covers unincorporated areas of Northeast Metropolitan Phoenix, making LD3 a powerful force in the Arizona Republican Party. According to a ruling by Judge Moskowitz, the elections the Republican Party LD3 held in March of 2023 "Did Not Violate any Arizona Controlling Statutes."

The story is complicated but thanks to reports by BrianFERENCE.com and Telegram contributors, I will try to simplify the facts leading up to DeWit's filing of the lawsuit.

**December 1, 2022** - LD3 held its Organizational Meeting to elect Officers and State Committeemen. There was evidence of both proxy and election fraud. The chain of custody had been broken with the credential sign-in sheets, proxy forms, and proxy sign-in sheets.

**December 4, 2022** - All 5 LD3 Board Members voted unanimously to file a motion with the MCRC requesting a hand recount of the Officer's election and to canvas and verify the proxies.

**December 6, 2022** - A Timely Challenge was filed with the MCRC asking for a hand recount of the ballots

and to canvas the proxies because of violation of the Election Rules and Bylaws. On the same day all 5 LD3 Board members agreed on an action plan to basically have the body vote on a recount of the proxies, officers, and state committeeman.

**December 17, 2022** - The LD3 Board voted 3 to 2 for a credentialed Special Meeting to be held on December 28, 2022, for the body to vote for a redo of the officers and state committeeman and then hold the revote election immediately following. That evening Kelly Ward extended the deadline for LD11 and

LD3 to submit their election challenge results until January 14, 2023.

**December 18, 2022** - Notice of Special Meeting Call Letter was sent out to the LD3 PCs.

**December 20, 2022** - Czarny (LD3 Chairperson) sent an official district email to all PCs in LD3 stating "The Dec 28th meeting is NOT a sanctioned meeting. Bylaws were not adhered to in the calling of this meeting. ATTENDANCE IS NOT REQUIRED OR ENCOURAGED." Czarny gave no evidence to support her statement. December 27 2022 - The LD3 Board sent an email to all the LD3 PCs notifying them the December 28 Special Meeting to revote had been canceled.

**February 7, 2023** - The new MCRC board met for the first time. The board requested Candace Czarny to provide the ballots and proxies from the December 1st Organizational Meeting for auditing. She never did.

**March 30, 2023** - LD3 held a credentialed meeting facilitated by the MCRC to first put before the body the question "Do you want a new election of officers based on the

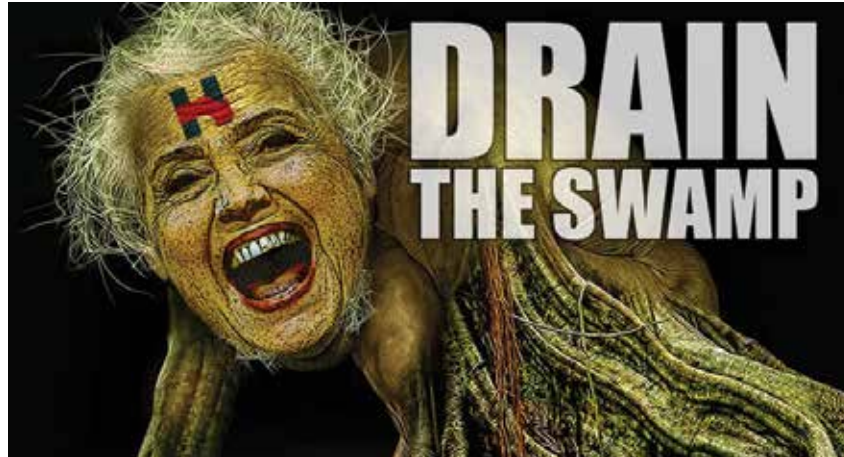

\*\*\*Continued from Page 24\*\*\* findings that the 12-1-2022 election was ruled to be in violation of the election procedures and bylaws by the 2022 MCRC and 2023 MCRC governing boards?" The body passed by majority to have a new election and an election was held bringing in the new board for LD3.

Sometime after this, AZGOP Chairperson Jeff DeWit got involved and subsequently allegedly committed a felony; bribery of a public servant or party officer. According to documents furnished at Brian-Ference.com it seems DeWit and others attempted to create two different LD3 Boards operating independently of each other. On December 19th 2023 (in a letter written by Merissa Hamilton, AZGOP Member-at-Large) and from call recordings, it appears Jeff DeWit illegally proposed two official Legislative District 3s. During these recordings DeWit reportedly said "I'm trying to sweeten the pot for everybody." Then, "Upon the execution of this, We will give you each a \$1,000 check also." Additionally, "You both end up much better because we are going to kick in what could be 4 or 5 grand. Make it sweeten the pot for everyone financially." At Brian-Ference.com there is a copy of the draft of the Agreement DeWit was wanting signed. The four signatures needed were Bob Gomez, LD3 (Co-Chairman), Candace Czarny (LD3 Co-Chairman), Craig Berland (MCRC Chairman) and Jeff DeWit (AZGOP Chairman).

Chairman DeWit was offering monetary compensation in order to

keep Candace Czarny in control of at least part of LD3. In an email dated January 9th, 2024 from Candace Czarny, an agreement to a "Peace Accord" is referenced which states; "It was our understanding that the agreement would be complete by Christmas. To date, we have not heard anything back on this proposal." Now, we have the Keri Lake accusation of bribery against Jeff DeWit.



According to an Arizona Republican PC close to the Maricopa County Republican Committee (MCRC) LD3 situation; "I see what Dewit has done...debasement of the Republican party... He used to be a Trump supporter but there was a tape that came out in 2020 where he said he was off the "Trump train". His actions prove that he does not support many of the Republican principles which include Law and Order/Rule of Law, Individual Independence, the 1st and 2nd Amendments, Border Security, Election Integrity, and Pro-life. Upholding these principles are honor, honesty, and integrity which he has shown he doesn't have. I was a Dewit supporter until I saw his actions."

THE EPOCH TIMES reported; "DeWit suggests that he might be killed if

the powerful figures behind him offering the bribe were to be exposed." DeWit also accused Kari Lake and her team of secretly recording their controversial conversation and leaking it to the media. I say, thank goodness she did! THE EPOCH TIMES also reported "The Arizona Republican Party selected a new Trump-endorsed chair on Jan. 27th, 2024 after the former party leader resigned following a bribery controversy."

On January 27th, Gina Swoboda was elected the new AZGOP Chairwoman at a meeting attended by more than 1,000 people. Chairwoman Swoboda acknowledged her support for former President Donald Trump, who also gave his support to her in the race. Kari Lake (candidate for the U.S. Senate) called Chairwoman Swoboda's win a "massive victory." Lake went on to say "Gina is a national leader in election law. She is a grassroots hero and is loved by Republicans of ALL stripes. Gina is battle-tested and a woman of great integrity she understands that the White House and Senate Majority (and frankly, the survival of our Republic) runs right through State 48."

Hold on a minute, not everyone in the AZGOP is on board with Swoboda's "massive victory" and there may be a challenge to Swoboda's

election. An Arizona Republican PC well-versed in the Arizona Bylaws (Dr. Christina Dumlal) says, "Gina Swoboda was an appointed PC, who (according to AZGOP bylaws) could not legally be a state committeeman. Further, only a state committeeman can run for an elected position such as Chairman - according to AZGOP bylaws."

Judge for yourself. Article II section C (Filling Vacancies of the AZGOP Bylaws) reads: "All state committeeman vacancies shall be filled by an elected precinct committee person who resides in that district or county where the vacancy occurred." Article IV - Officers of the AZGOP Bylaws section B (Qualifications for Elective Office) reads: "Elected officers of the State Committee and elected members of the Executive Committee from the congressional districts shall, at the time of their election, be members of the State Committee."

In my opinion, playing loose with election rules and laws is what got this country into the mess we find it in today. We saw elected and unelected state officials in states like Wisconsin, Pennsylvania, Michigan and others changing elections procedures and laws right before the election of 2020, then refusing to reverse them for the 2022 election. Here in Arizona we witnessed this fiasco in Maricopa County during the last two elections. All of this has led the public to mistrust elections on the state and federal levels. The election of Swoboda (as much as some Republicans like it) seems like just more of the same old "Swamp Stuff!"

## Things They Didn't Teach You in Church: Do Pets Go to Heaven?

If you have ever had an animal such as a dog, cat, or any other domesticated animal and have cared for it as a pet, then you know that they are more than just some life organism that inhabits this fleshly earth. You may have also pondered what place this animal has in God's creation. Where do they fit into the whole scheme of things? You may have asked yourself whether this animal has a soul and wondered if this animal will be in that dimension we call "Heaven" or "Paradise" someday. In the Book of Isaiah God speaks of

that time when this Earth Age (the time of flesh we are living in right now) comes to an end and eternity begins. God is speaking of that time after Jesus returns to set up His eternal Kingdom right here on earth.

Isaiah 11:

**6 "The wolf also shall dwell with the lamb, and the leopard shall lie down with the kid; and the calf and the young lion and the fatling together; and a little child shall lead them."**

This is after Christ has returned and brings God's children a perfect peaceful existence here on earth.

**7 "And the cow and the bear shall feed; their young ones shall lie down together: and the lion shall eat straw like the ox."**

**"...And every creature which is in heaven, and on the earth, and under the earth, and such**

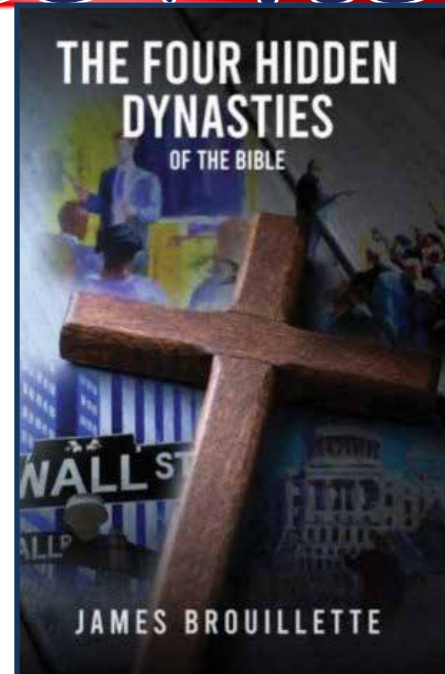
**as are in the sea, and all that are in them, heard I saying, Blessing, and honour, and glory, and power, be unto him that sitteth upon the throne, and unto the Lamb for ever and ever."**

This is talking about creatures on the earth and under the earth, and even creatures that live in water! These are God's creations and they will be in the Eternity. I believe all intelligent life God has created will be in that dimension we call "Heaven" and will have a chance of obtaining eternal salvation. Let me explain: It is a biblical fact that we know almost nothing about the dimension we call "Heaven" or "Paradise" and have no idea of what is going on or how things work there.

Mark 12:25 that man does not marry in the Eternity but are as the angels which are also in heaven.
